FIG. 2 is a top view of the bedding accessory for article storage of FIG. 1.

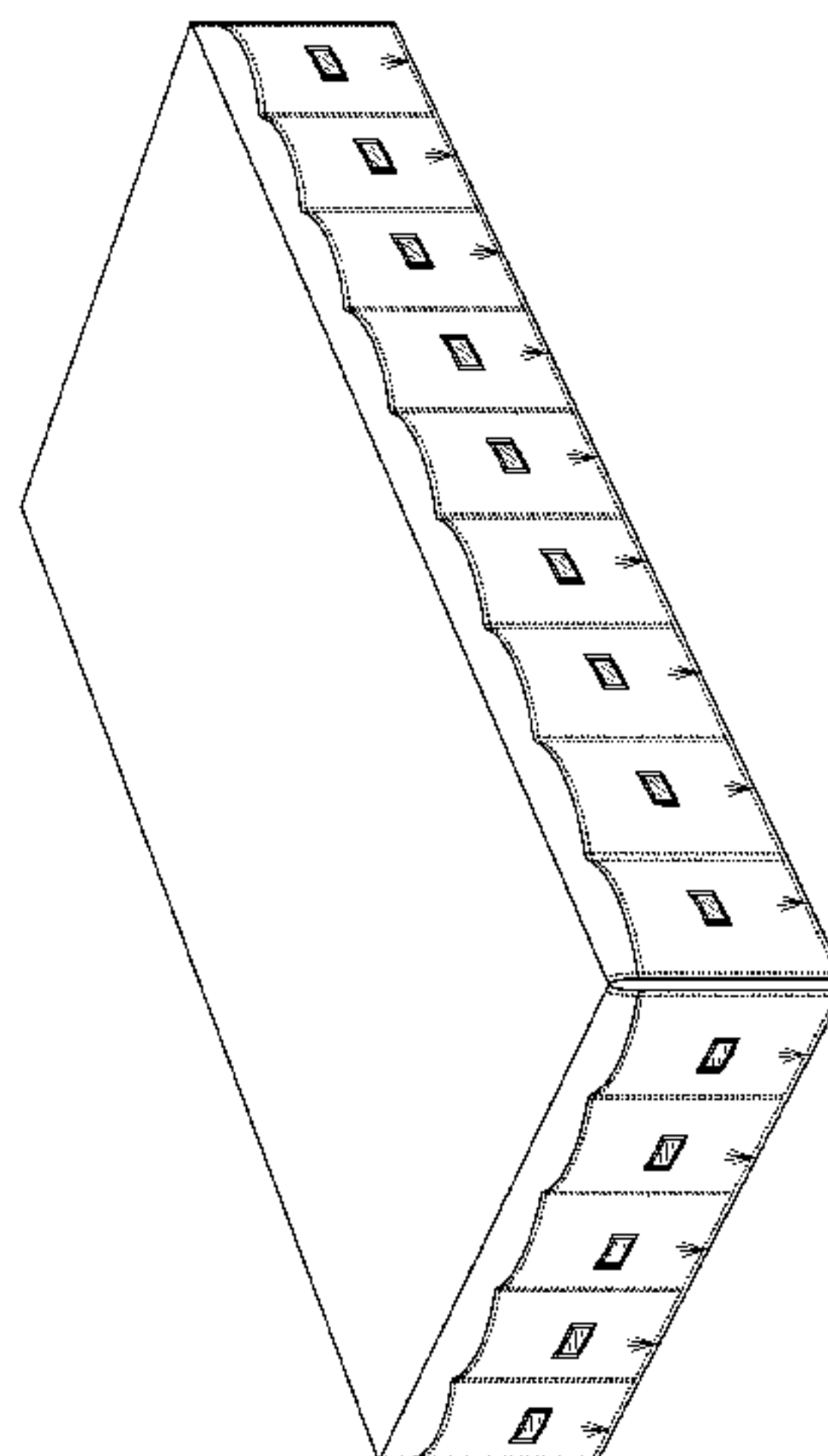
FIG. 3 is a front view of the bedding accessory for article storage of FIG. 1.

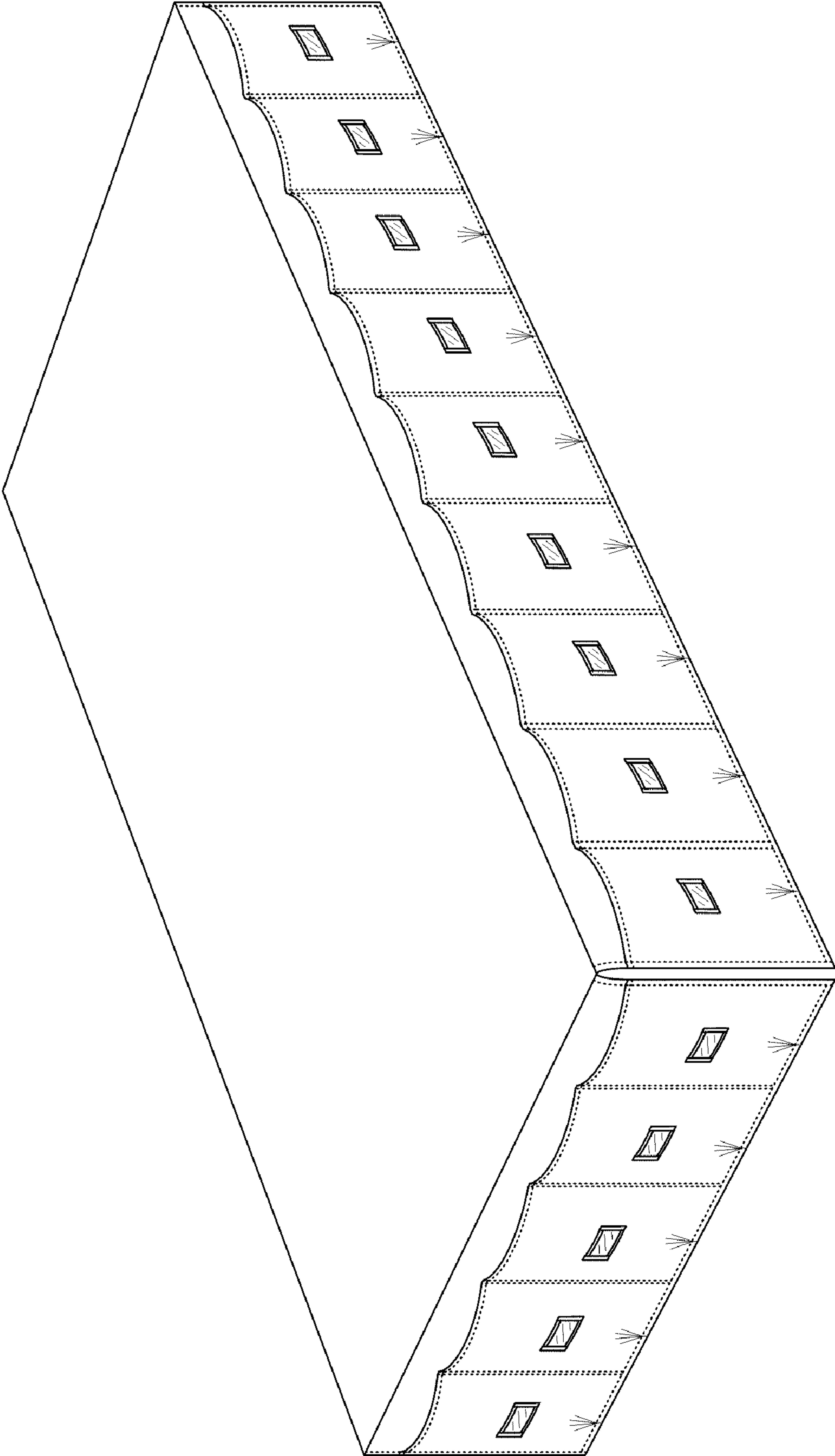

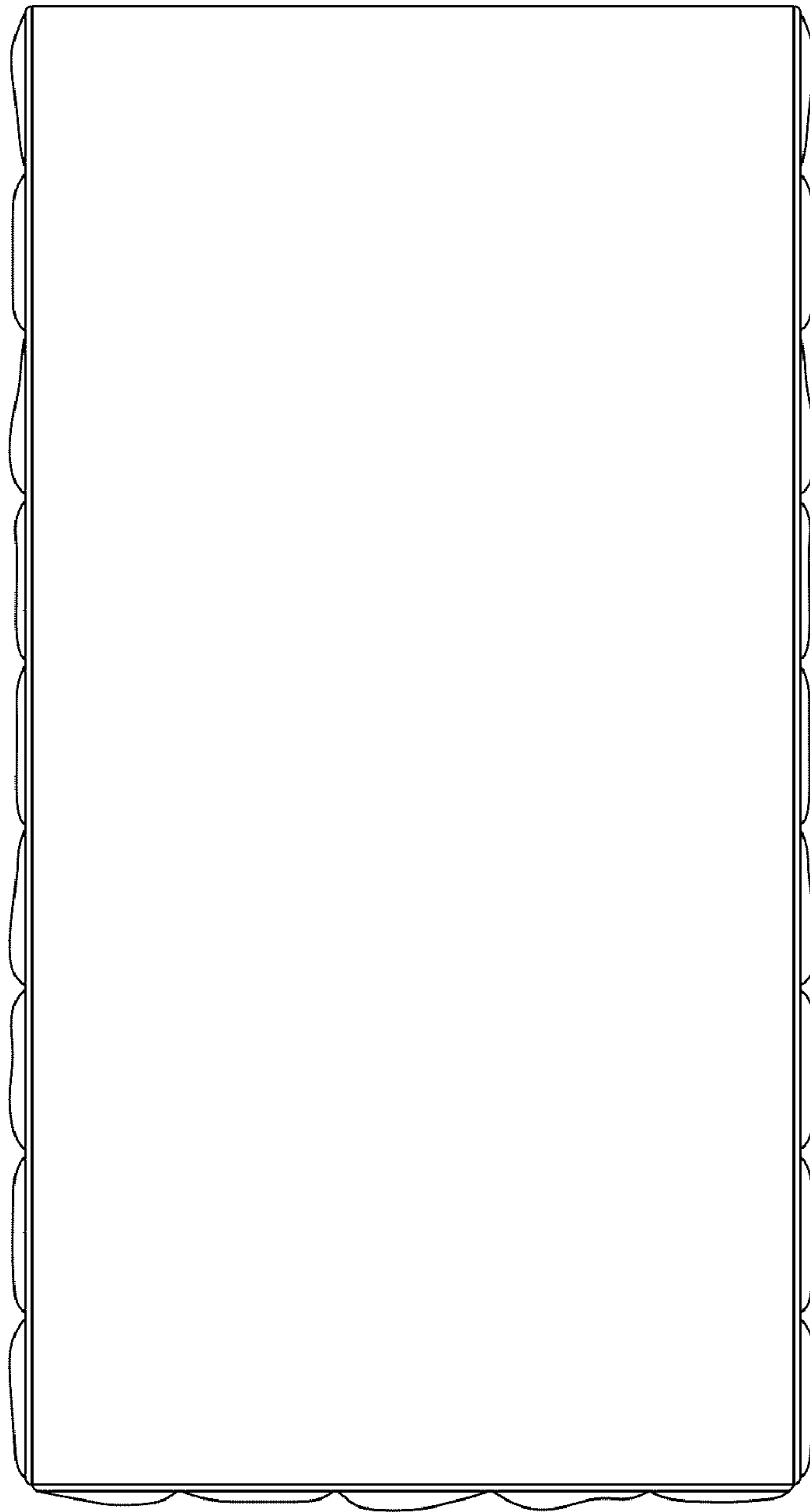

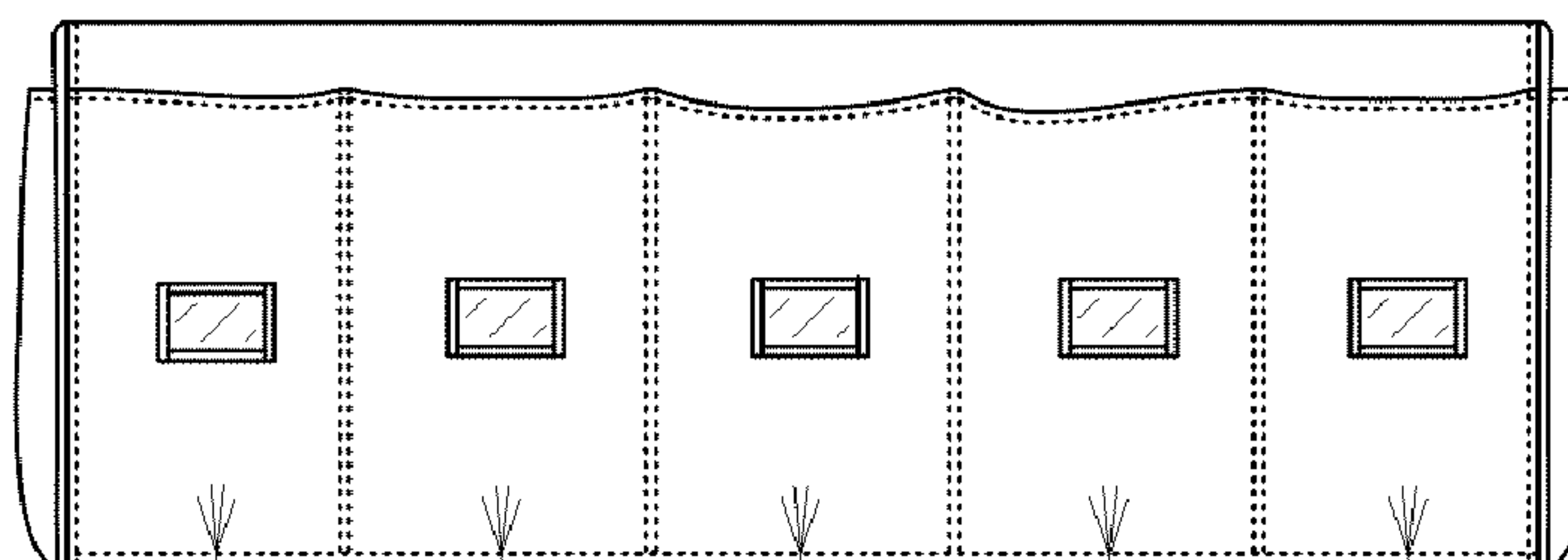

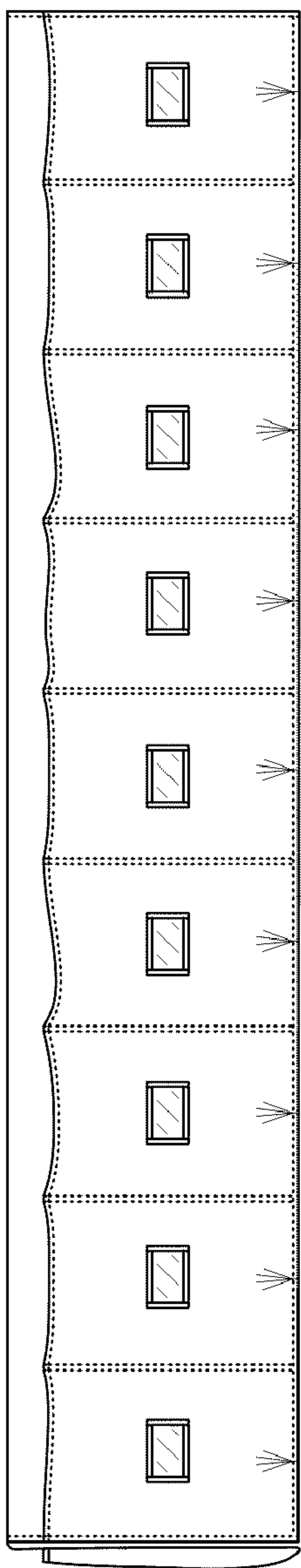

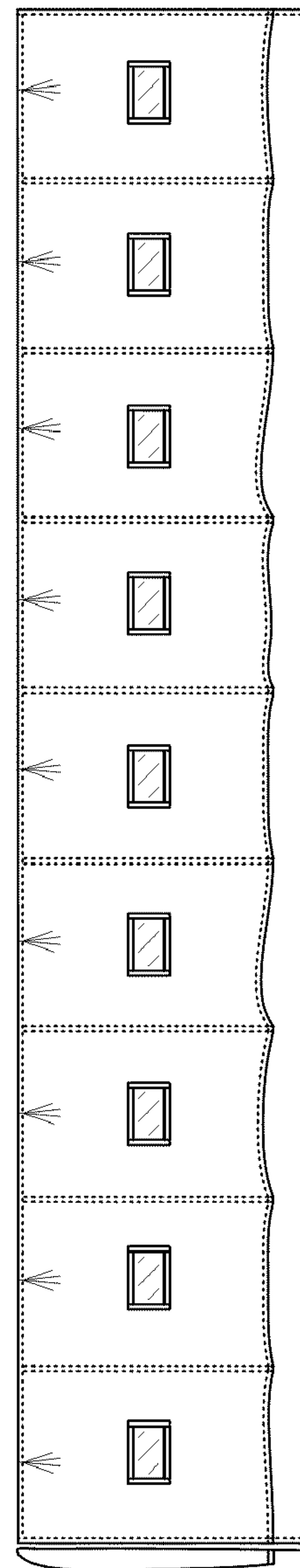
