The ornamental design for a coaster, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of one embodiment of the coaster.

FIG. 2 is a front view of the coaster illustrated in FIG. 1.

FIG. 3 is a back view of the coaster illustrated in FIG. 1.

FIG. 4 is a left side view of the coaster illustrated in FIG. 1.

FIG. 5 is a right side view of the coaster illustrated in FIG. 1.

FIG. 6 is a top view of the coaster illustrated in FIG. 1.

FIG. 7 is a bottom view of the coaster illustrated in FIG. 1.

FIG. 8 is a perspective view of a second embodiment of the
coaster.

FIG. 9 is a front view of the coaster illustrated in FIG. 8.

FIG. 10 is a back view of the coaster illustrated in FIG. 8.

FIG. 11 is a left side view of the coaster illustrated in FIG. 8.

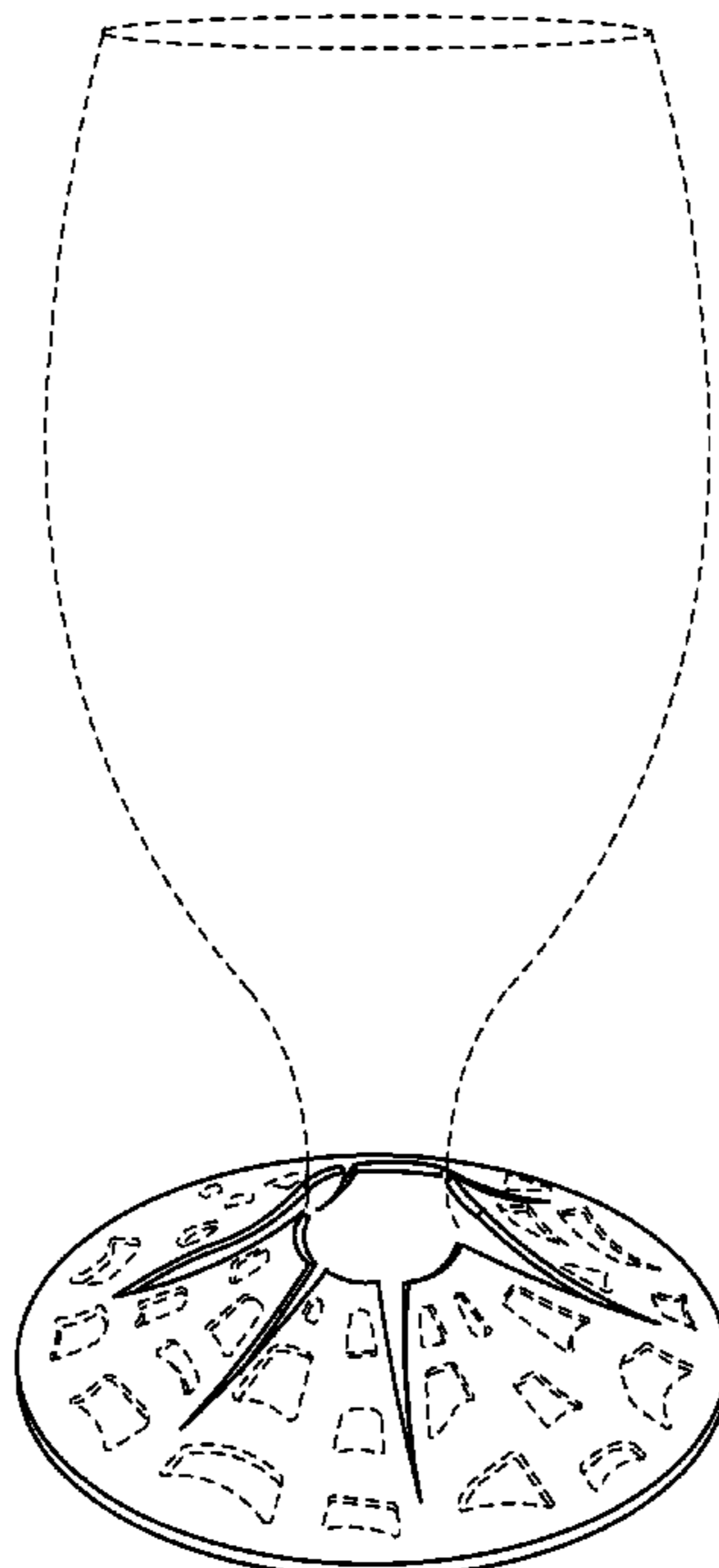
FIG. 12 is a right side view of the coaster illustrated in FIG. 8.

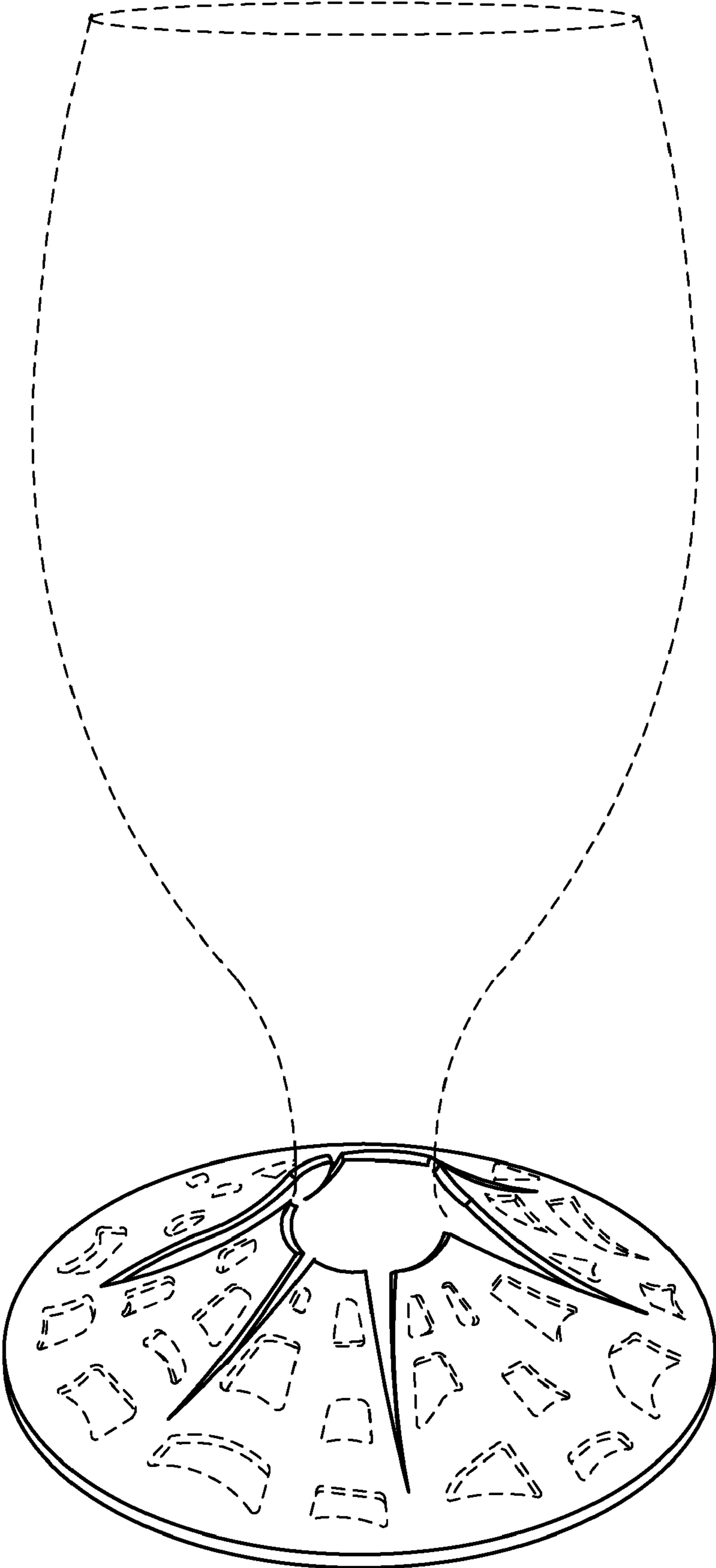

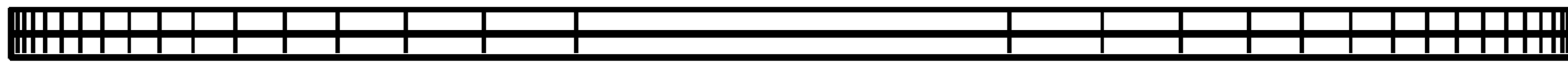

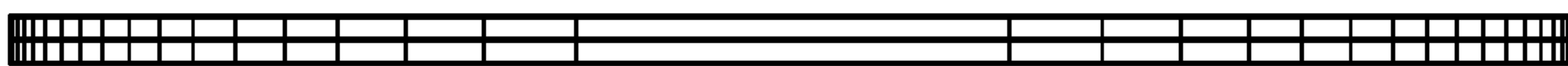

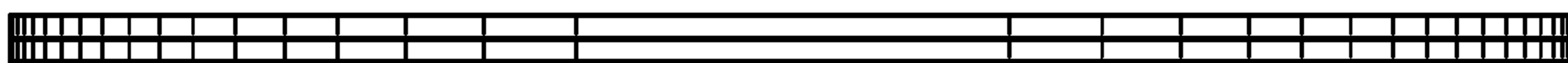

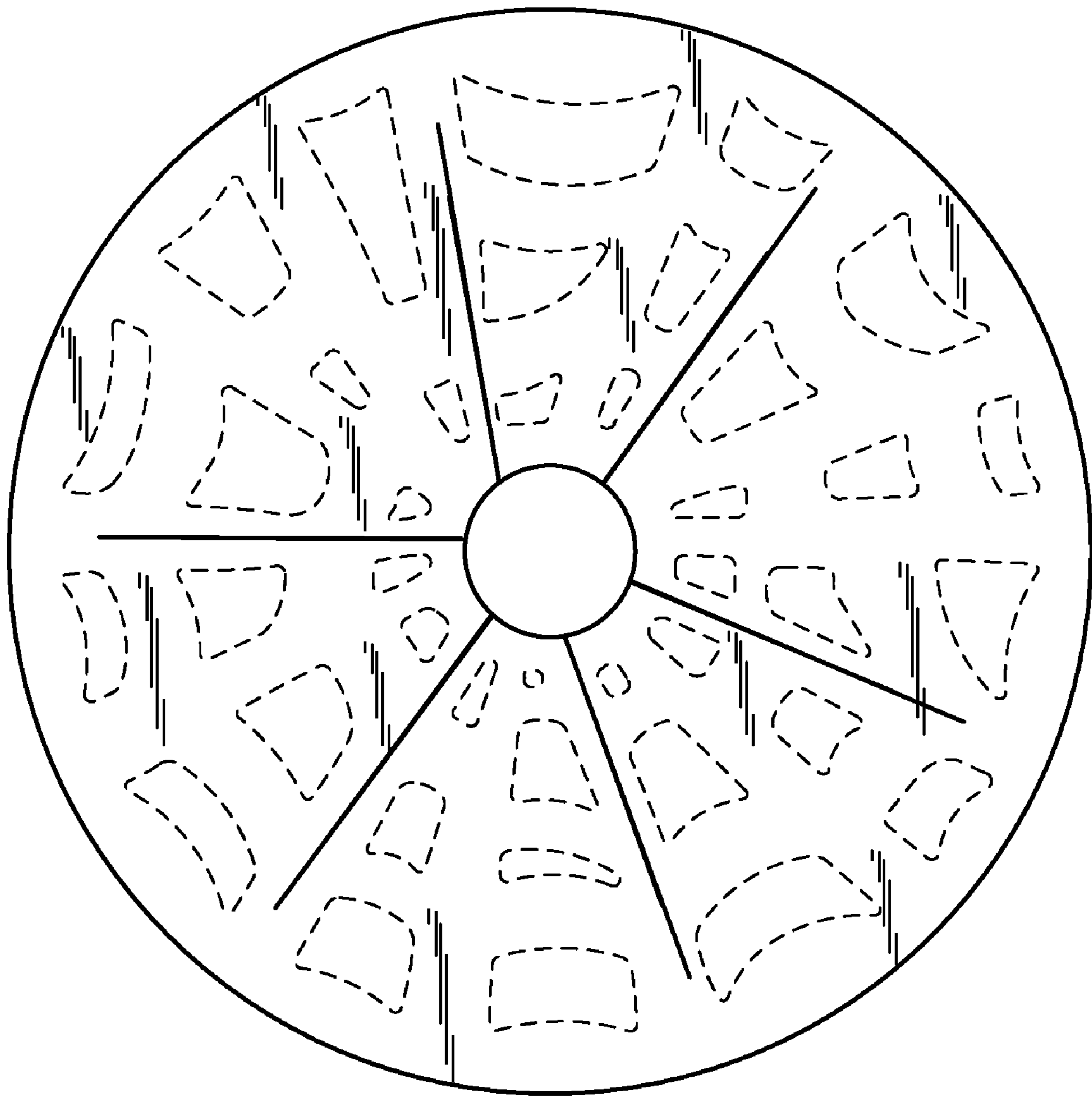

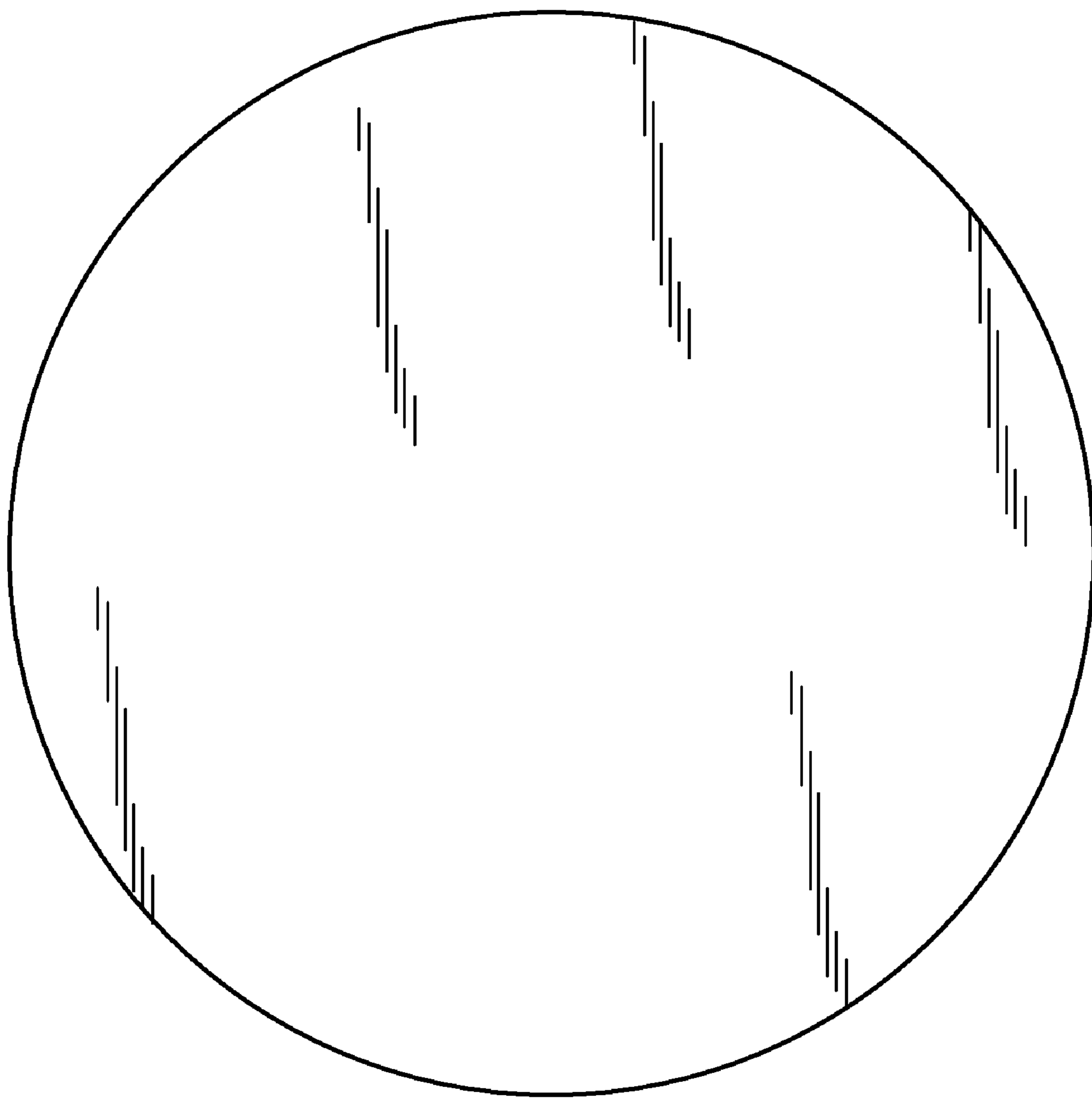

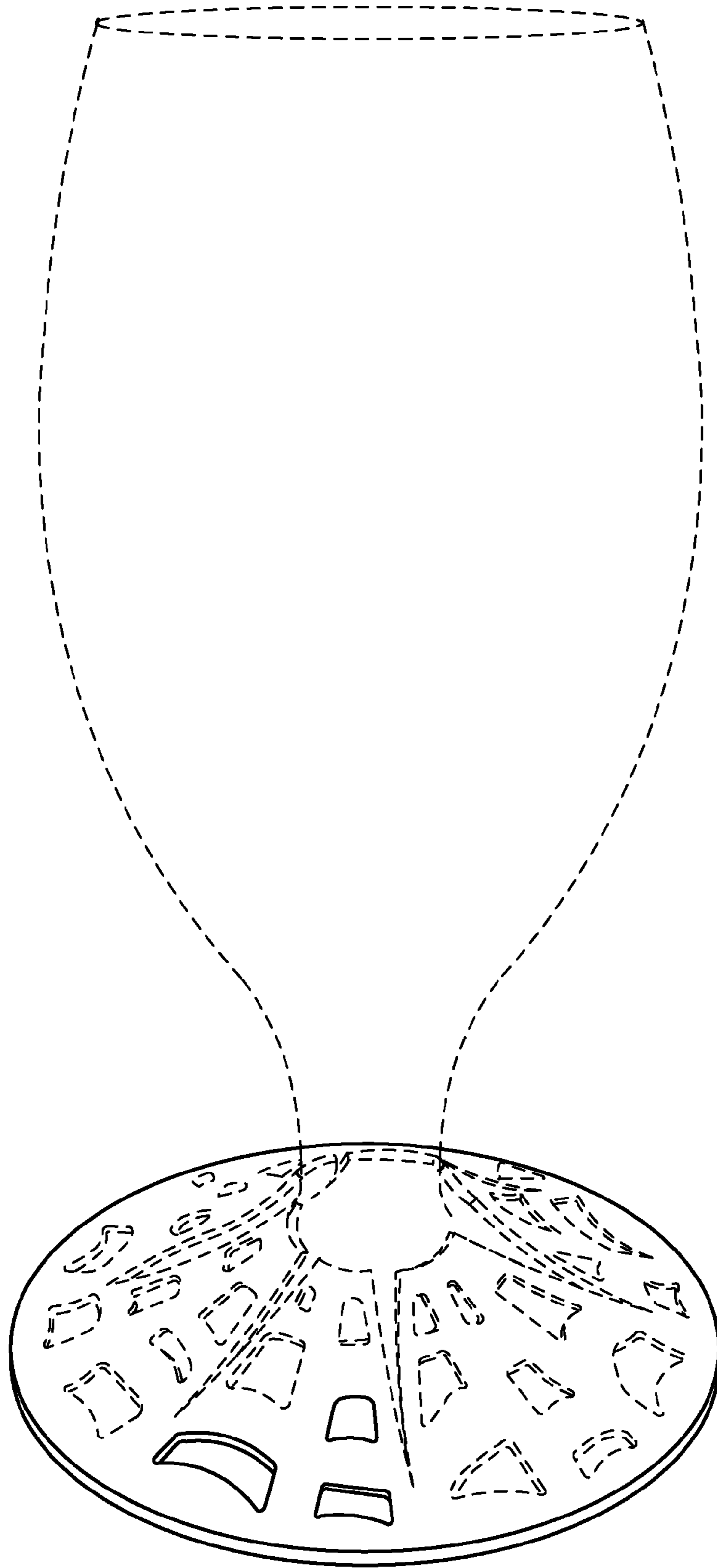

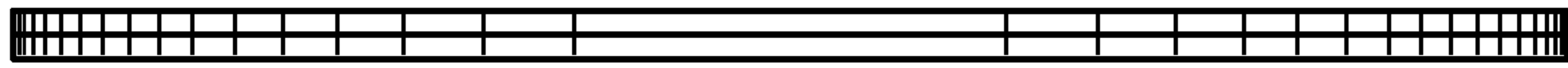

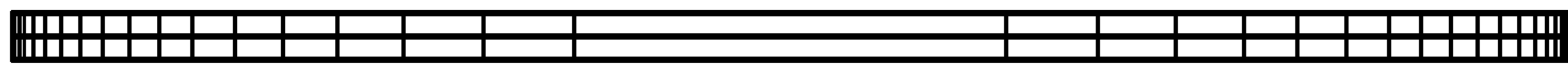

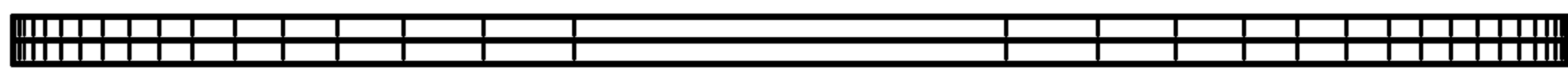

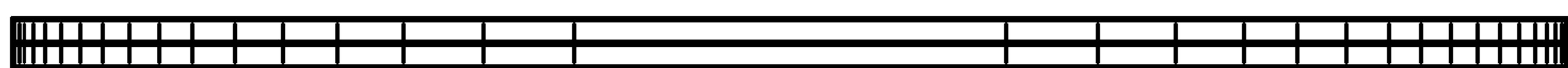

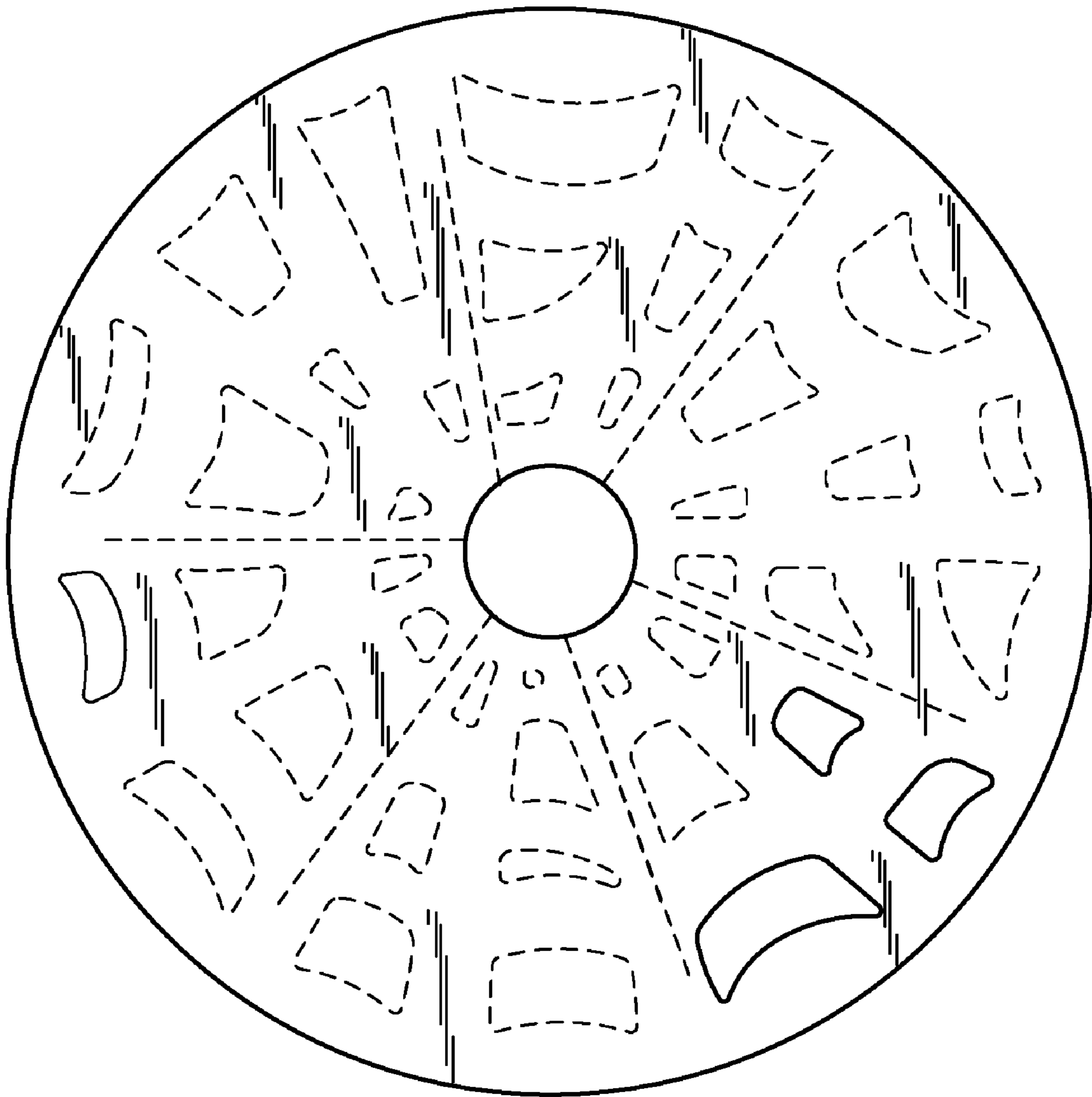

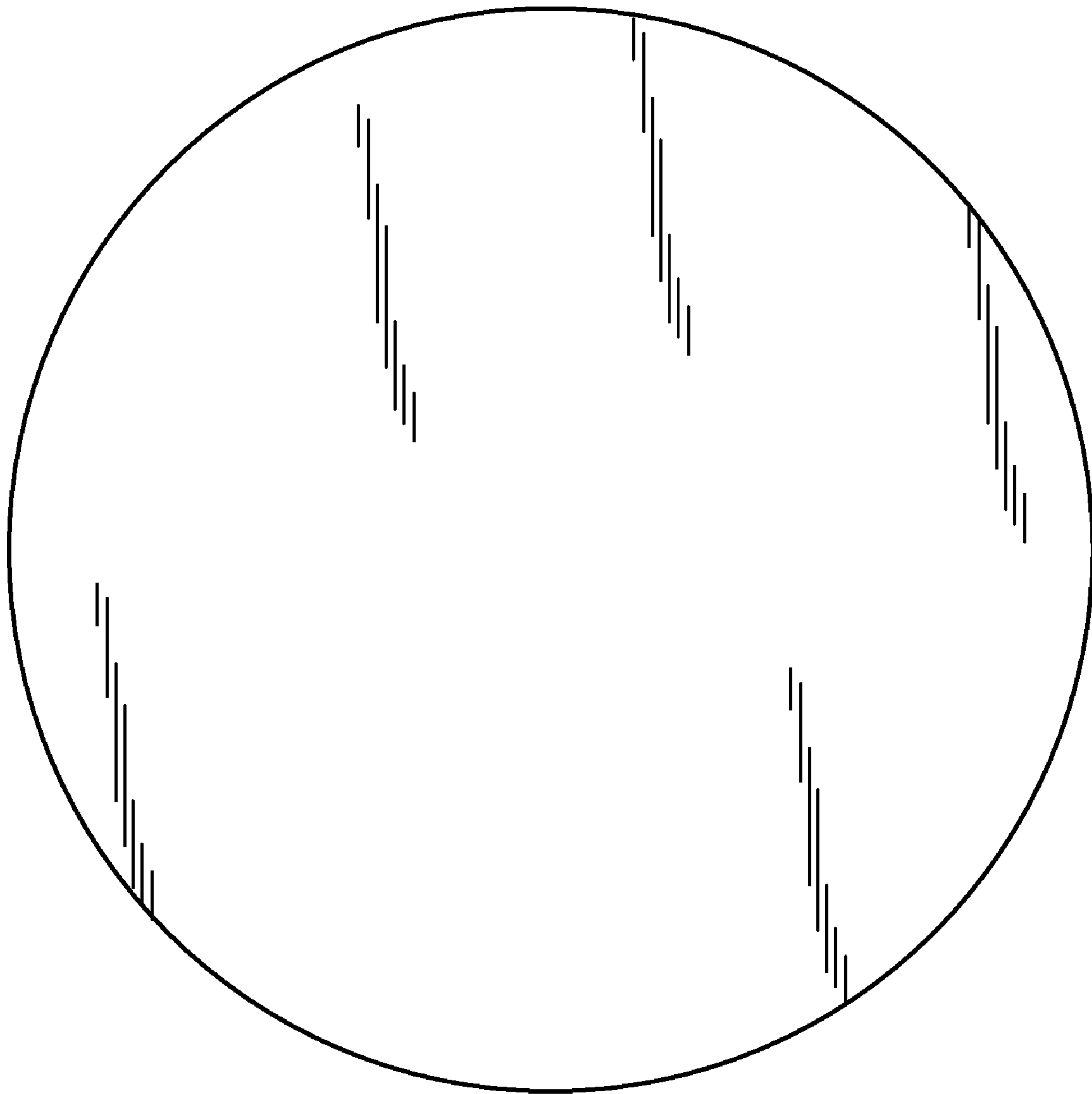
