(57) **CLAIM**

The ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a top, perspective view of a bottle showing my new design;

FIG. 2 is a side elevational view thereof, the opposite sides being a mirror image thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

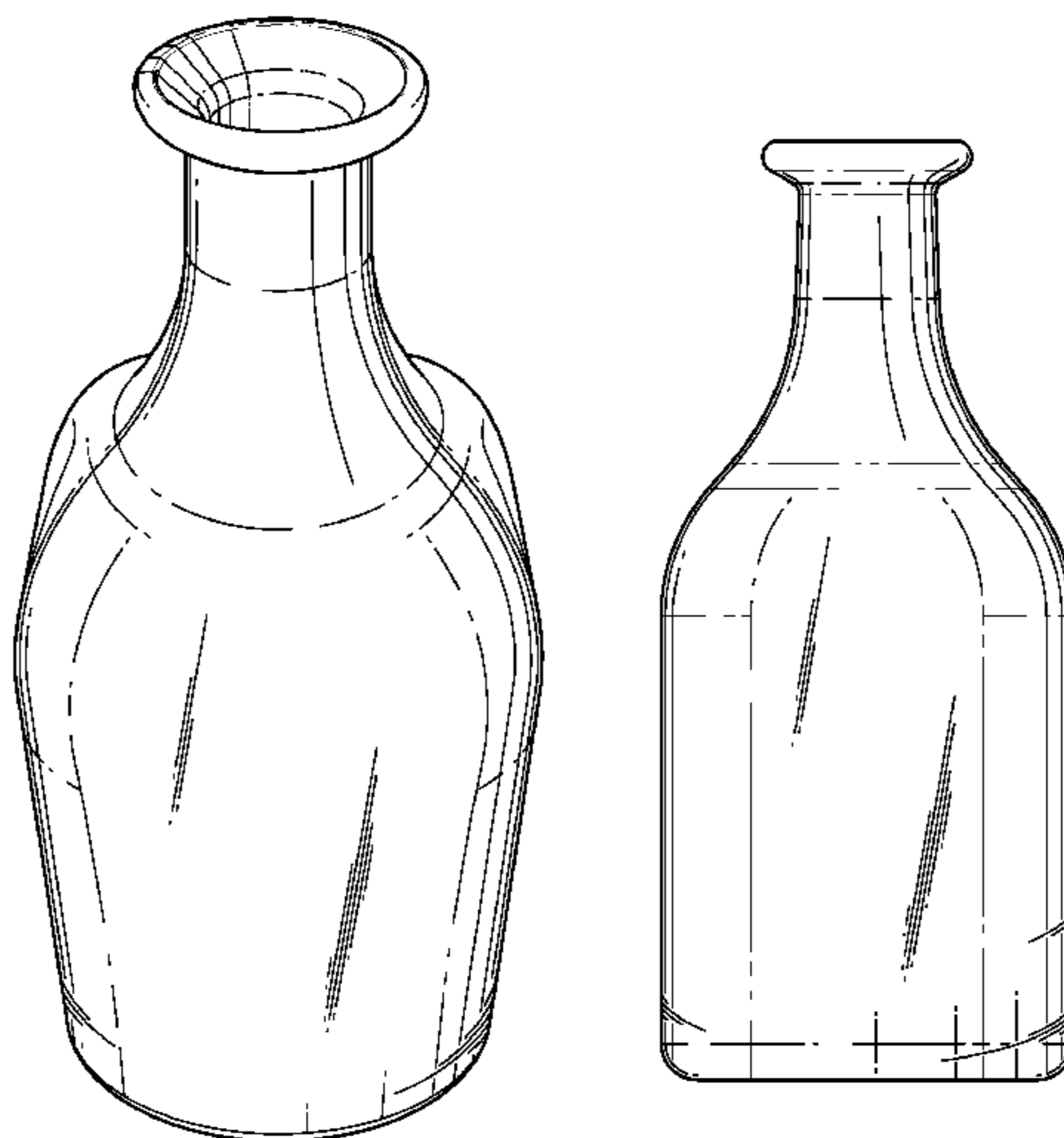
FIG. 5 is a bottom, perspective view thereof;

FIG. 6 is a cross-sectional view of a bottle taken along line 6—6 in FIG. 3, the opposite side being a mirror image thereof; and,

FIG. 7 is a cross sectional view of a bottle taken along line 7—7 in FIG. 3, the opposite side being a mirror image thereof.

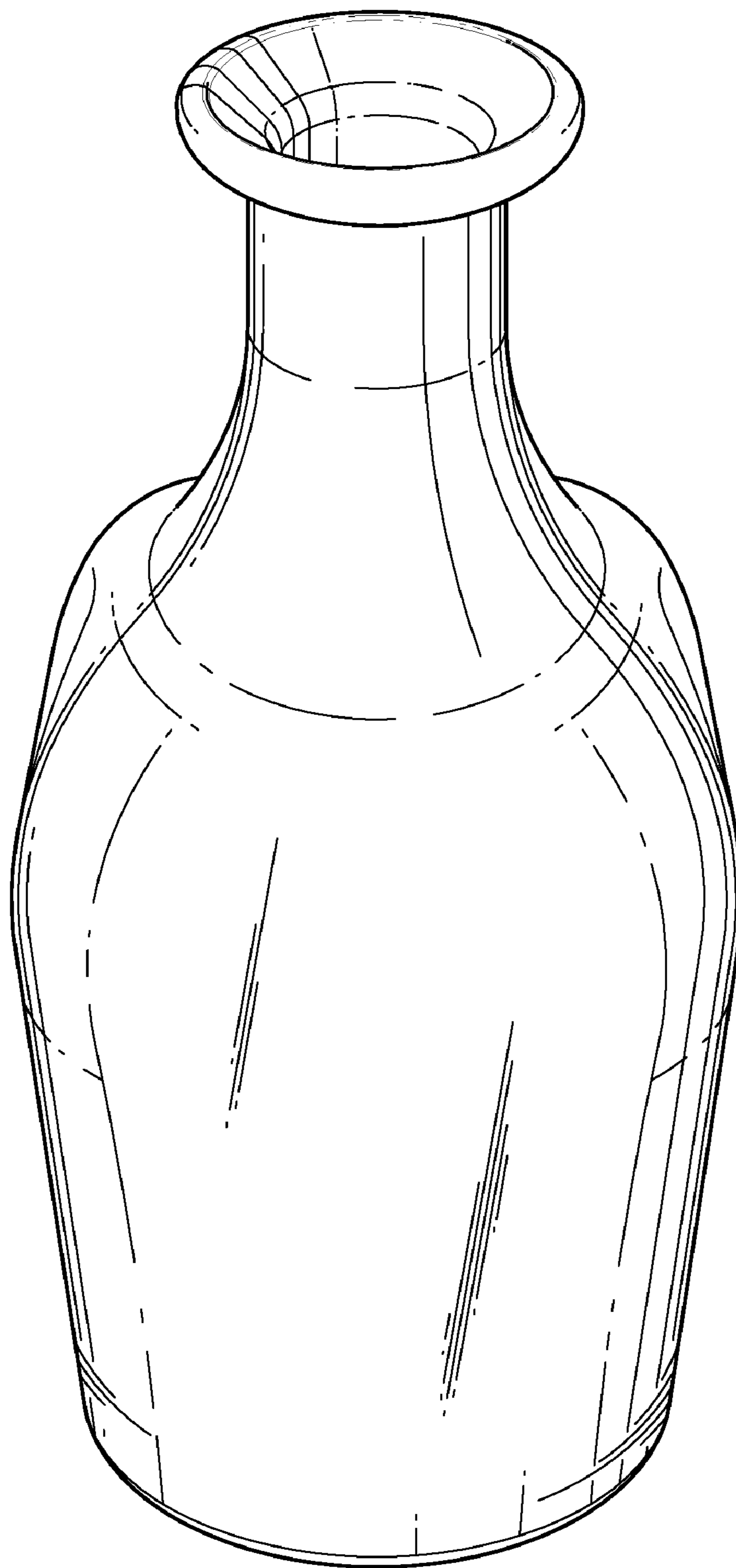

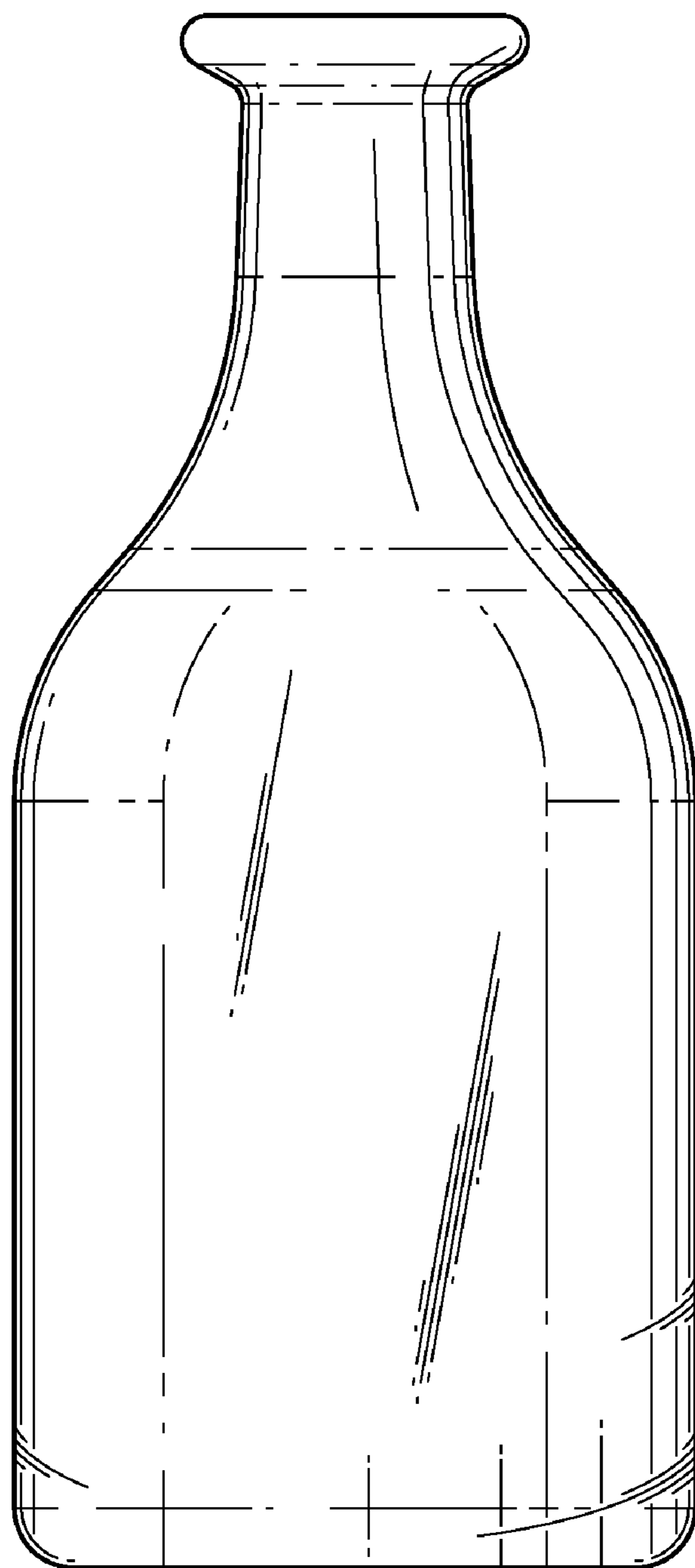

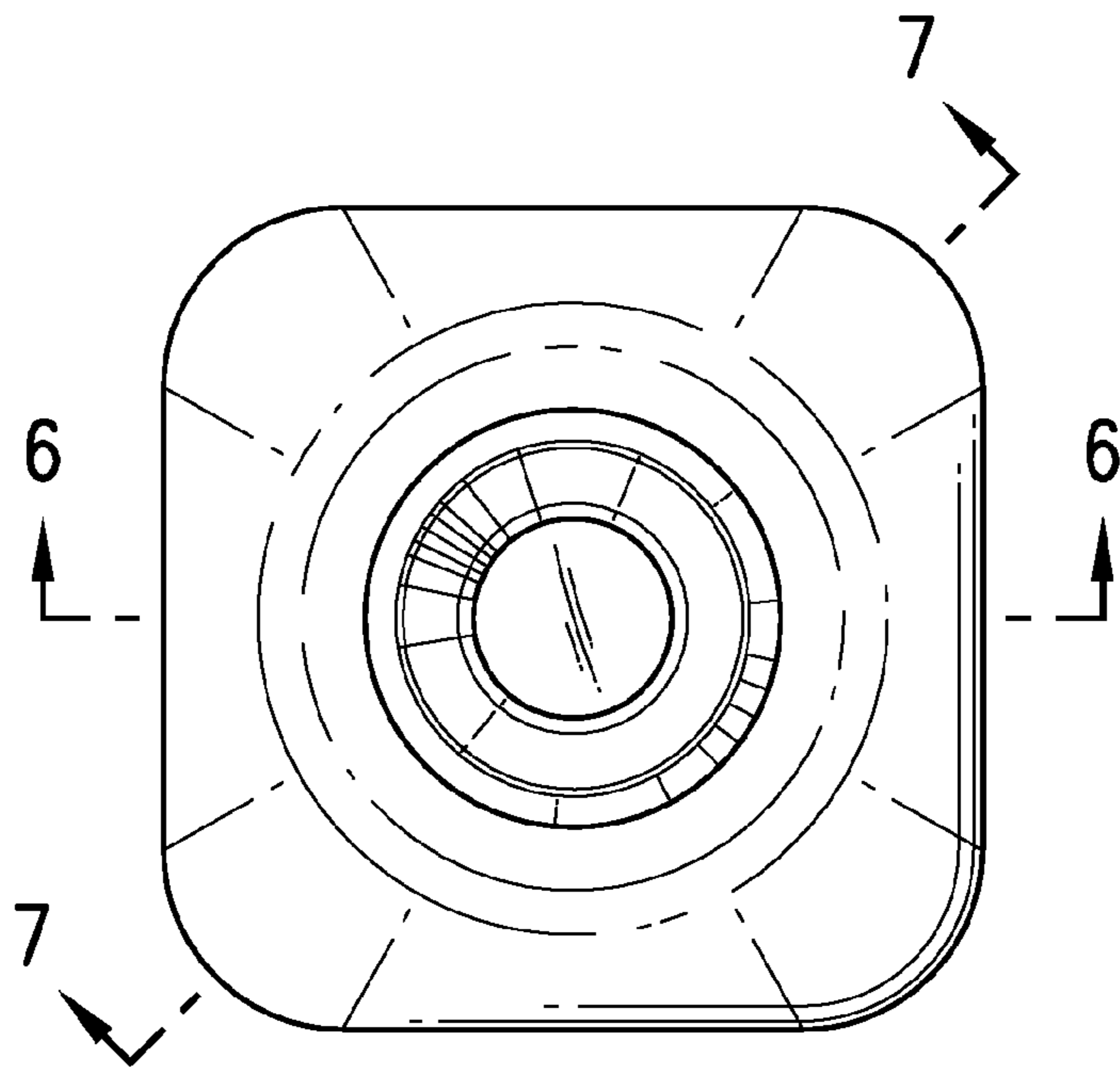

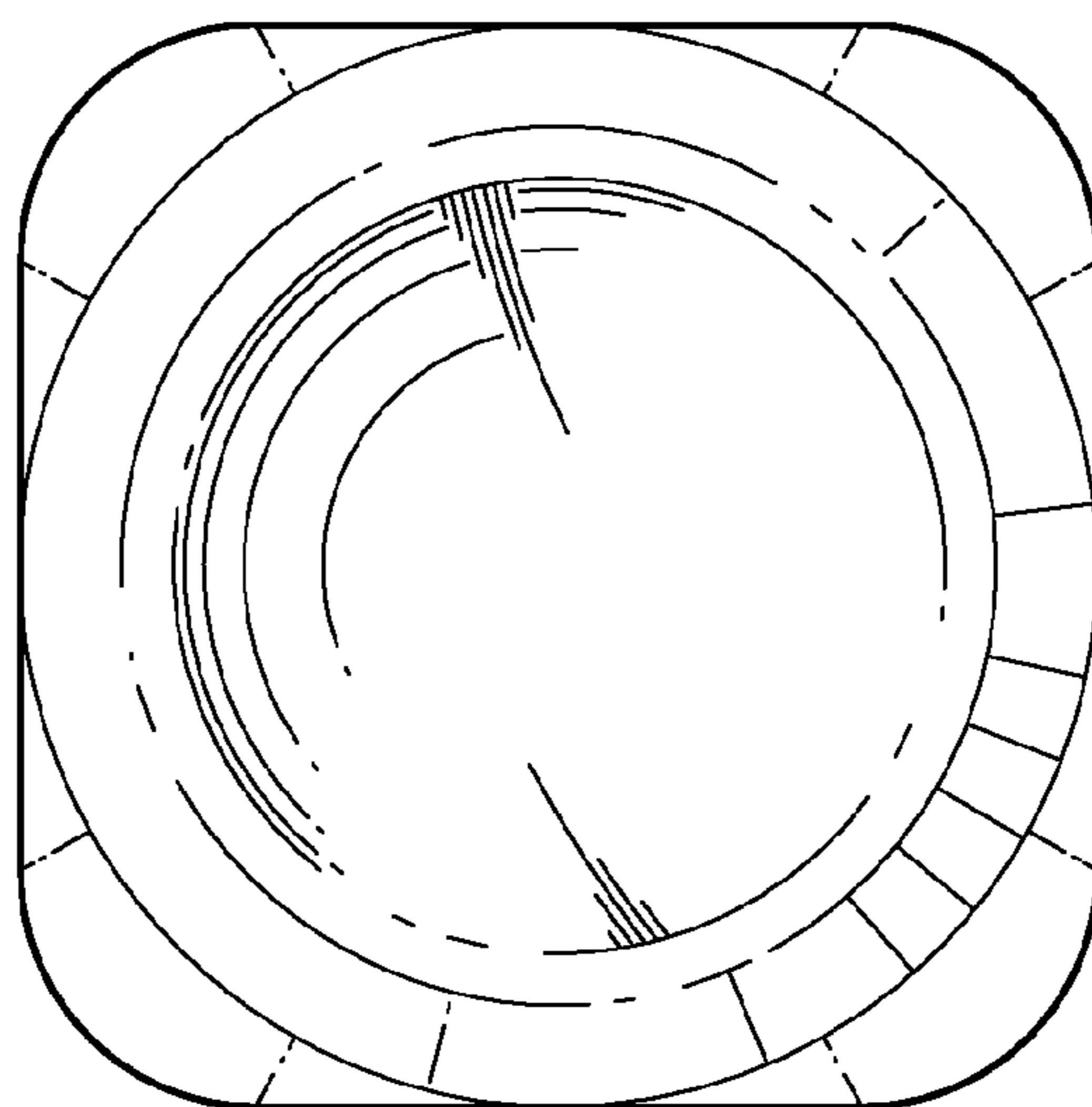

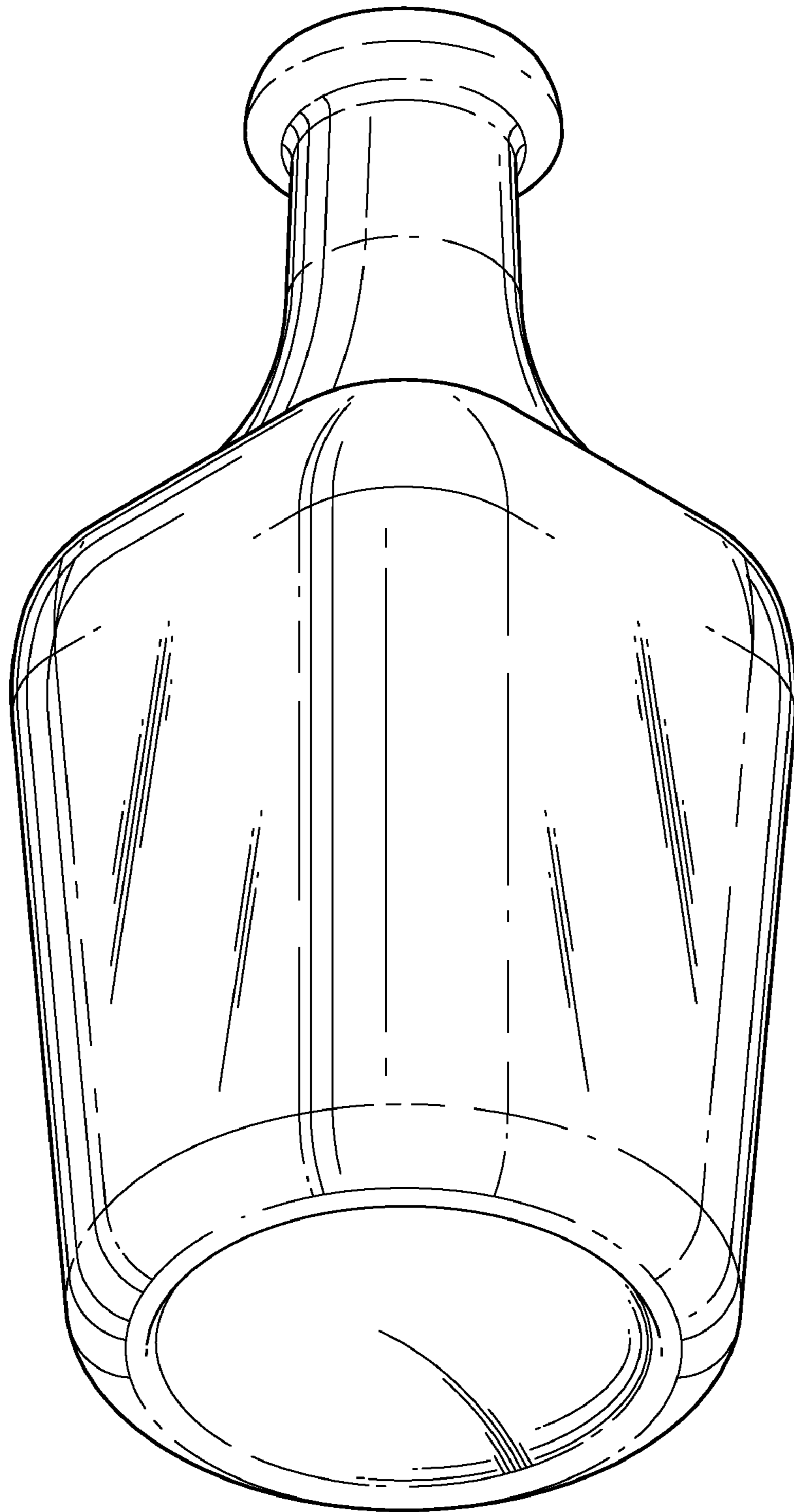

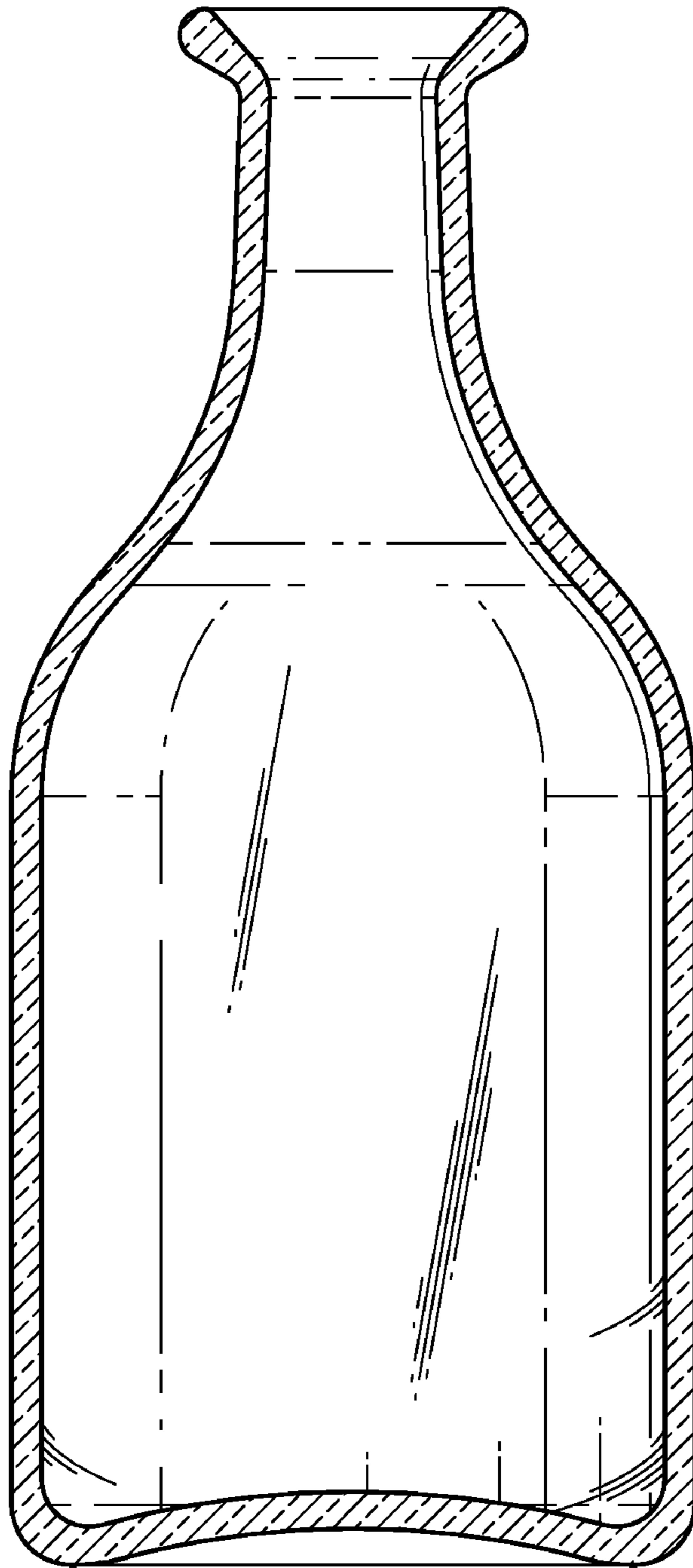

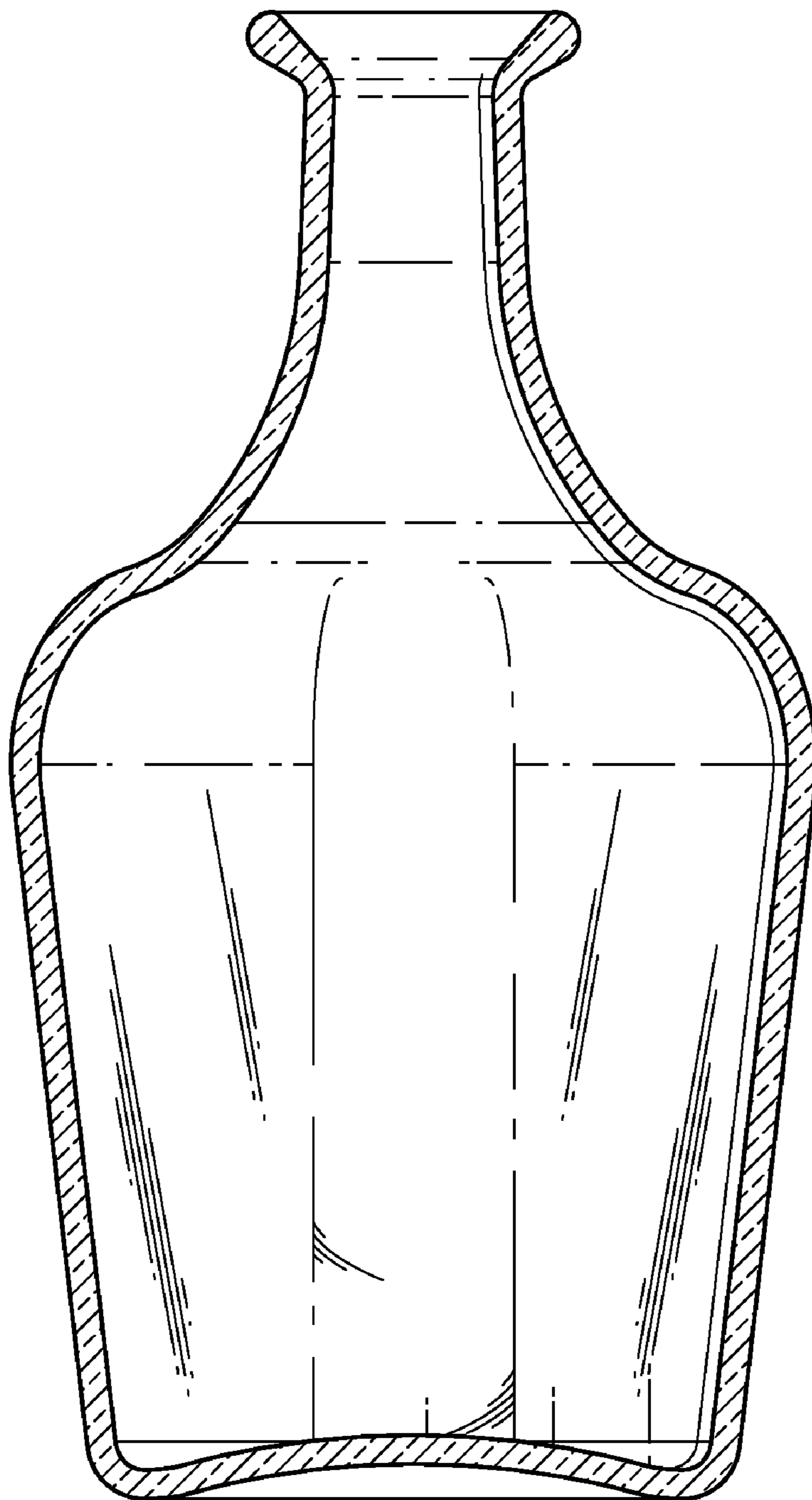
