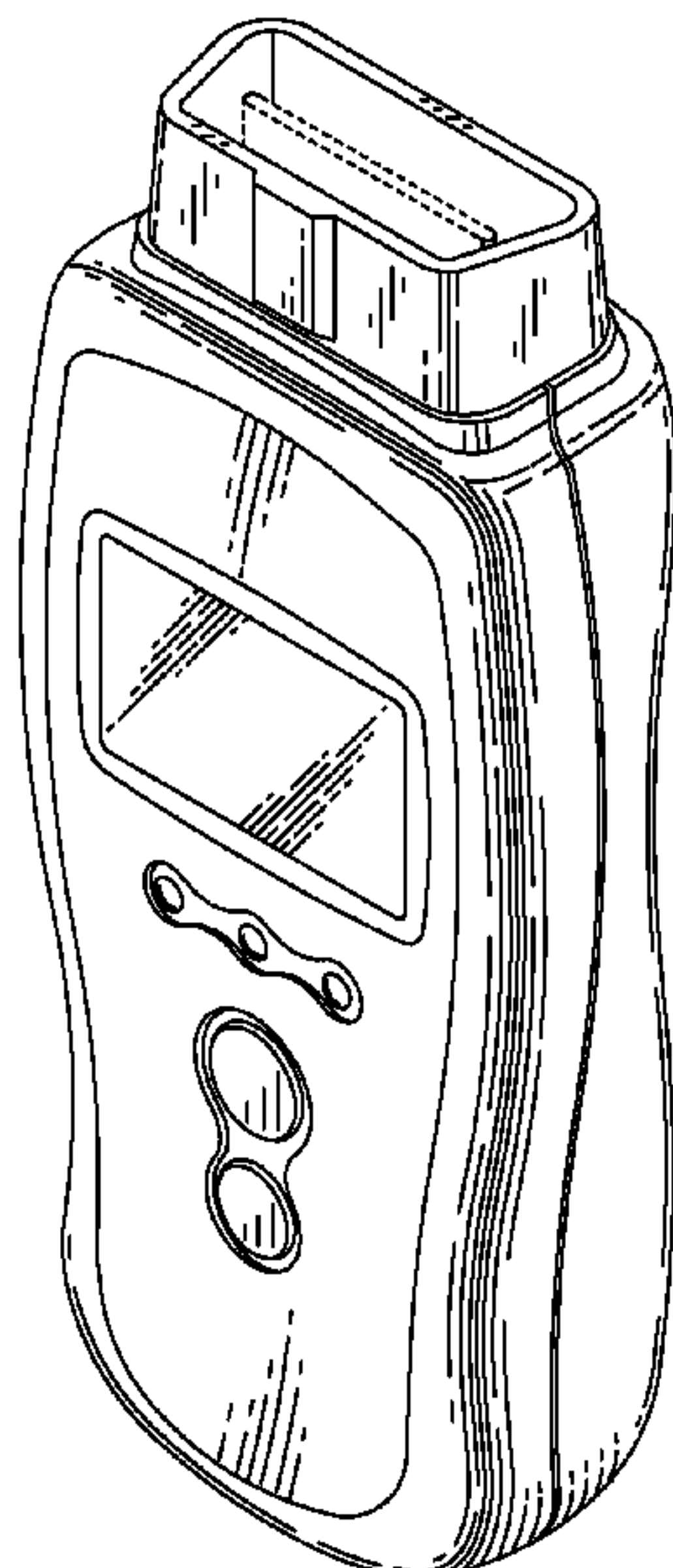
The ornamental design for a scan tool, as shown and described.

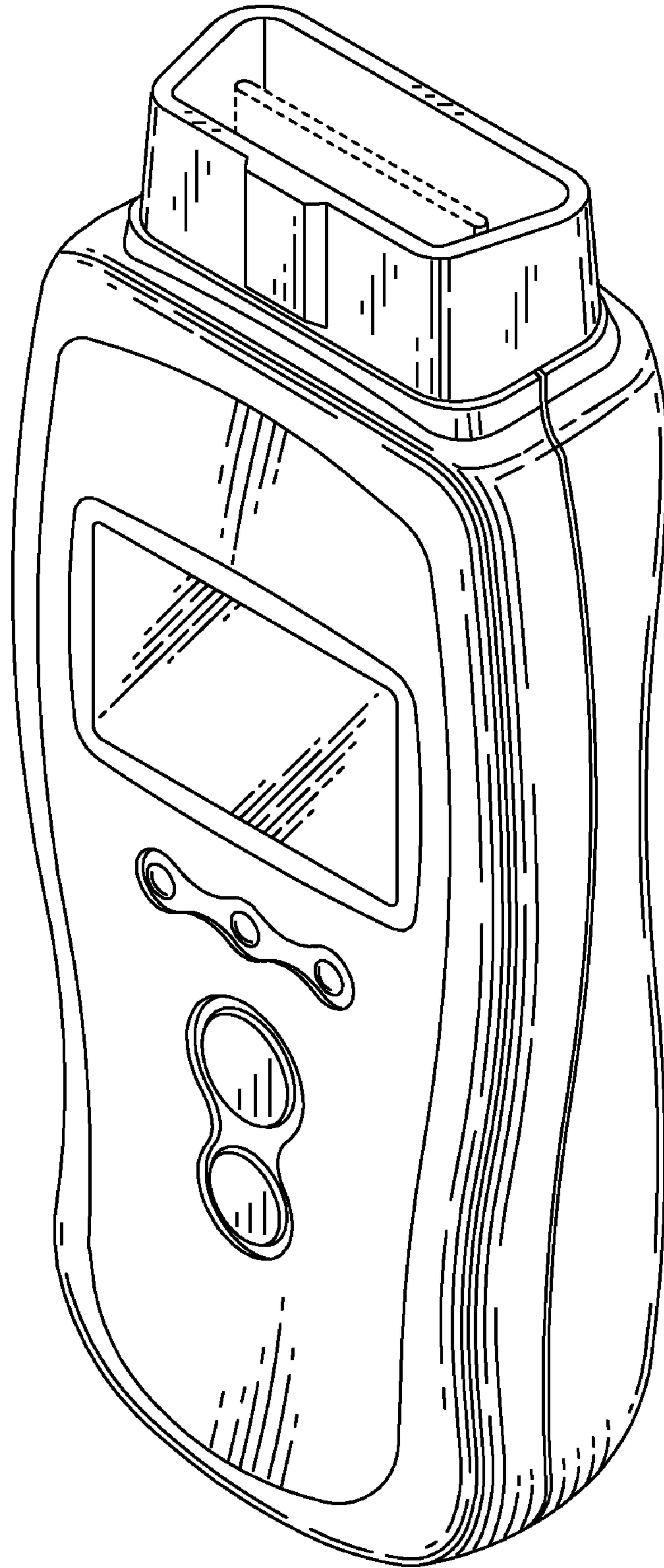

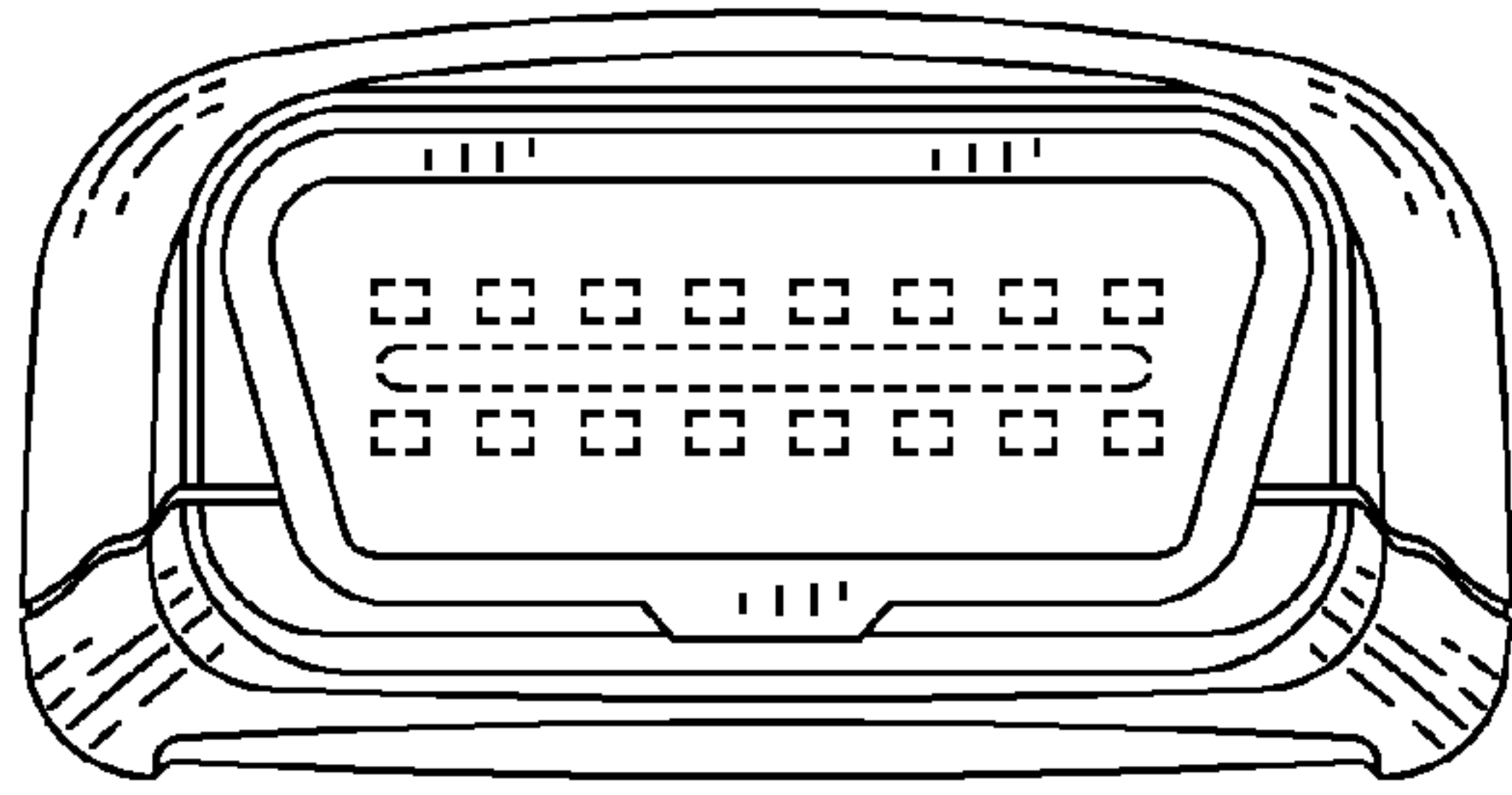

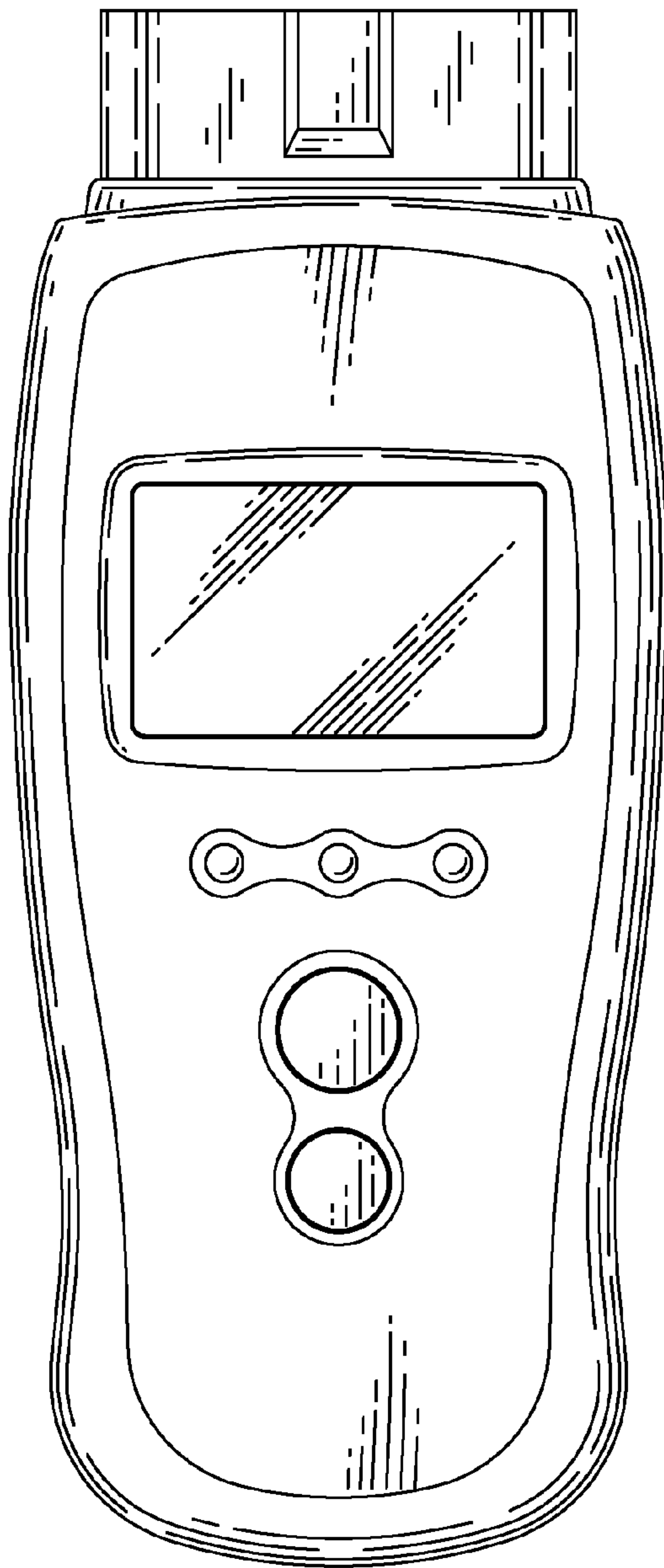

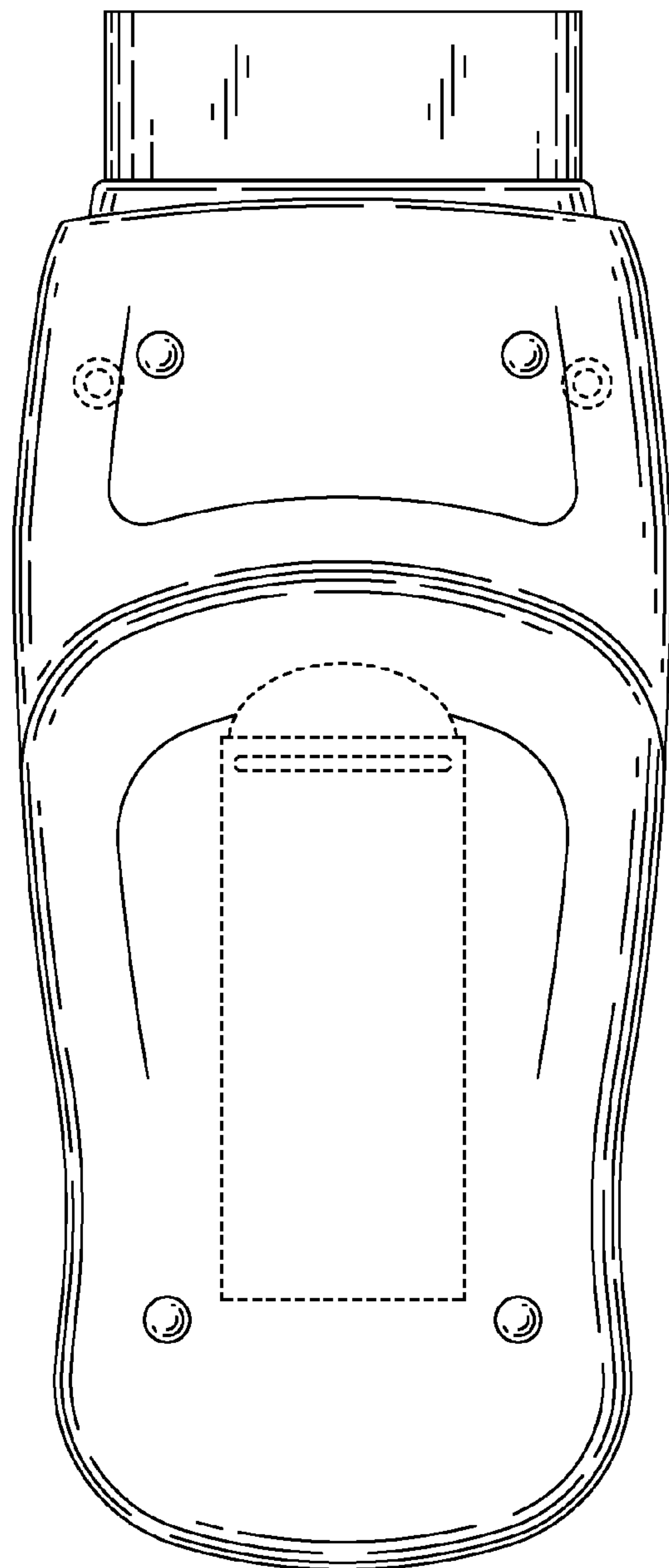

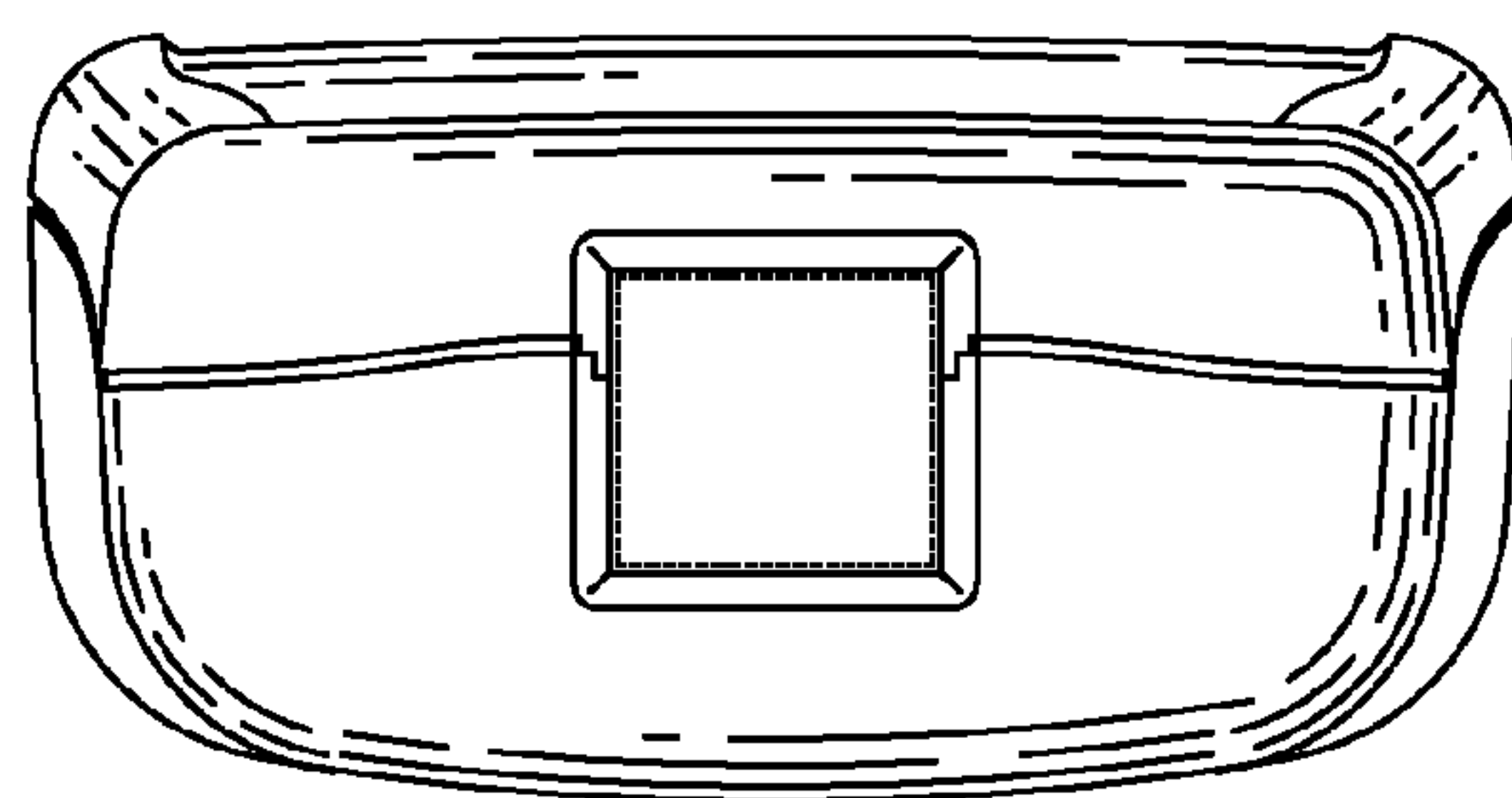
