DESCRIPTION

FIG. 1 is a front perspective view of a stored-value card showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a top view thereof, the bottom view being a mirror image of the top view; and,

FIG. 5 is a right side view thereof, the right side view being a mirror image of the left side view.

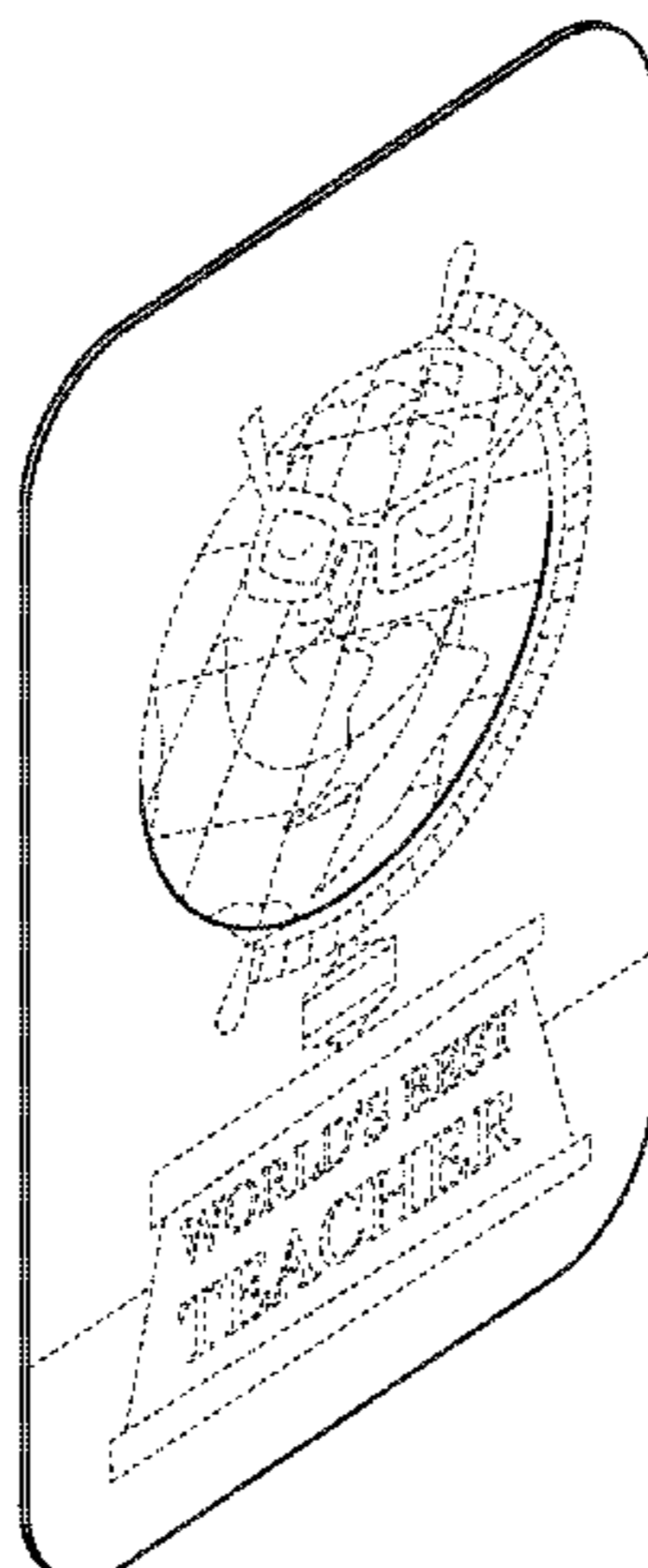

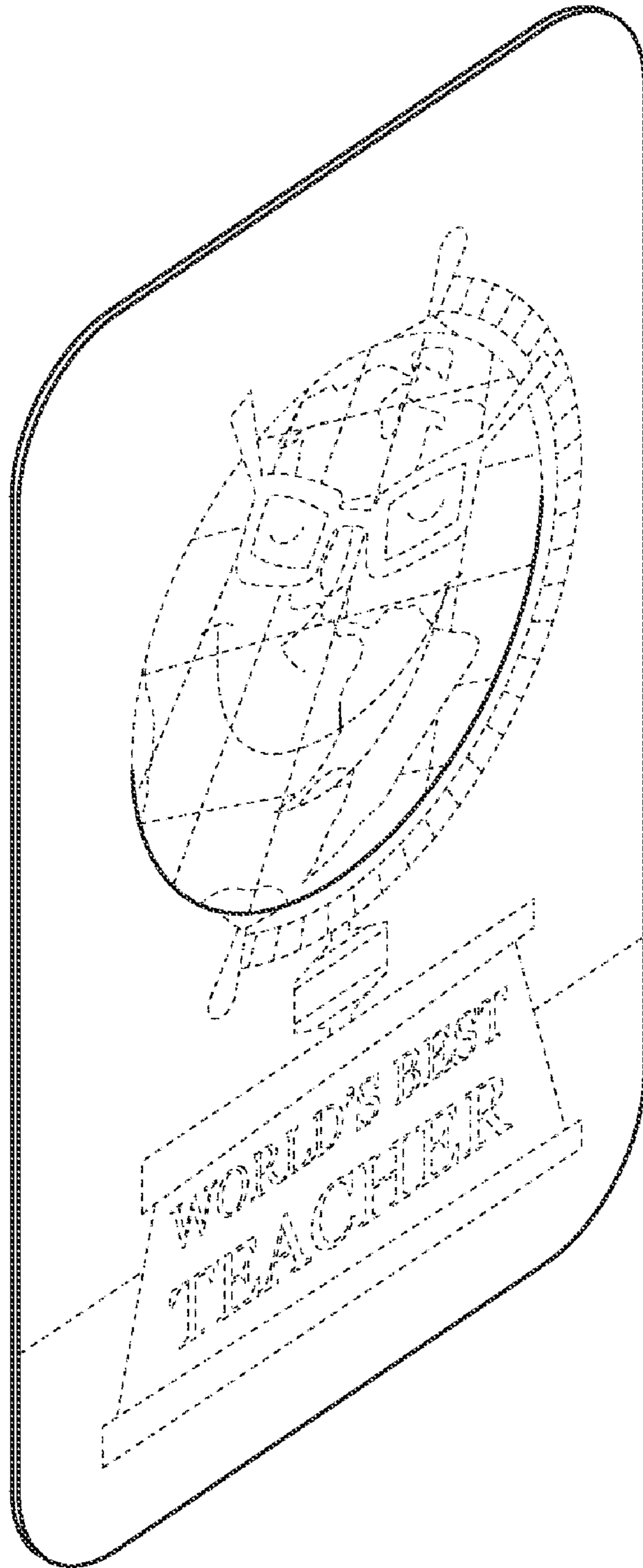

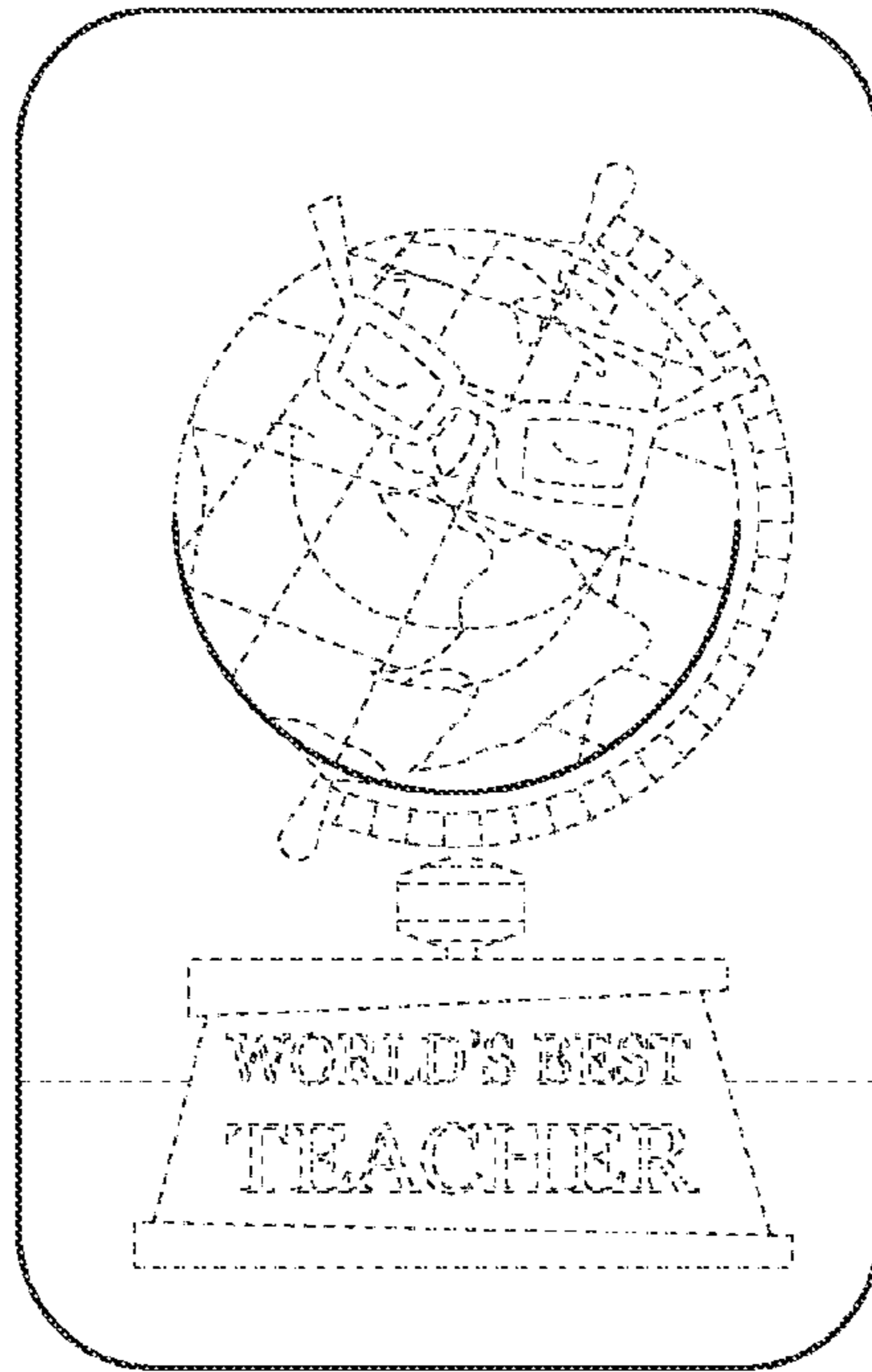

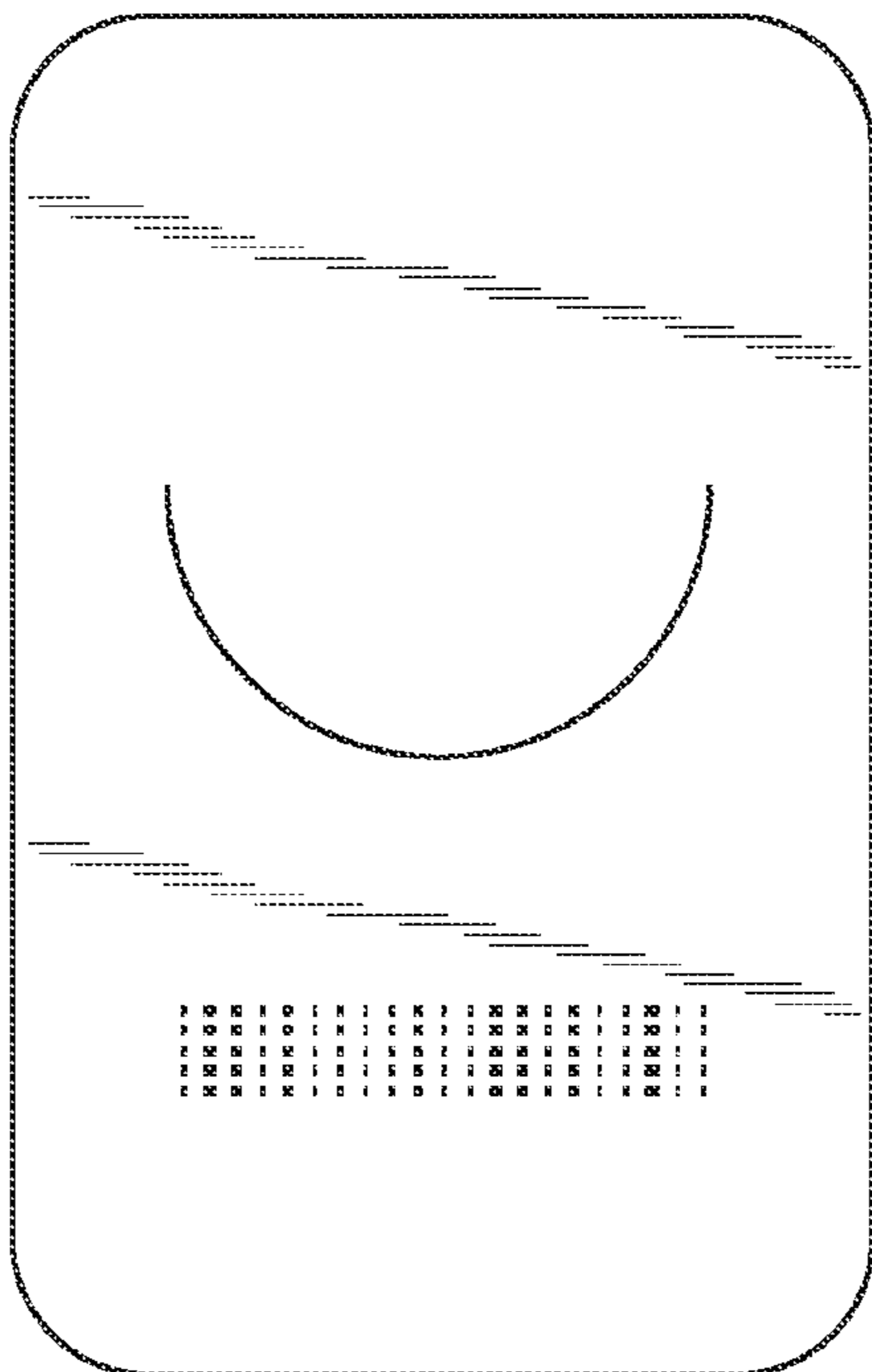
