FIG. 4 is a front view thereof;

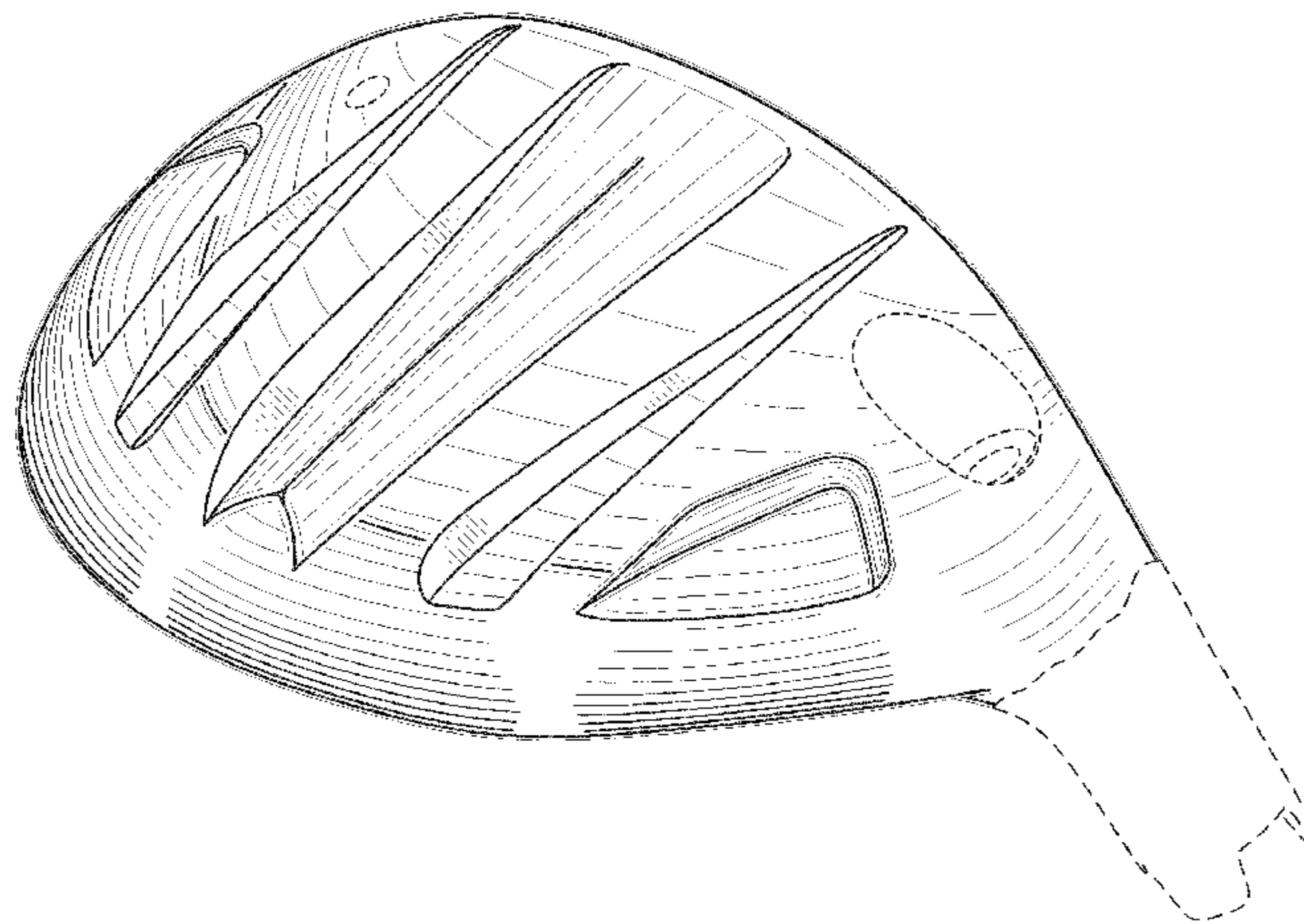
FIG. 5 is a heel side view thereof;

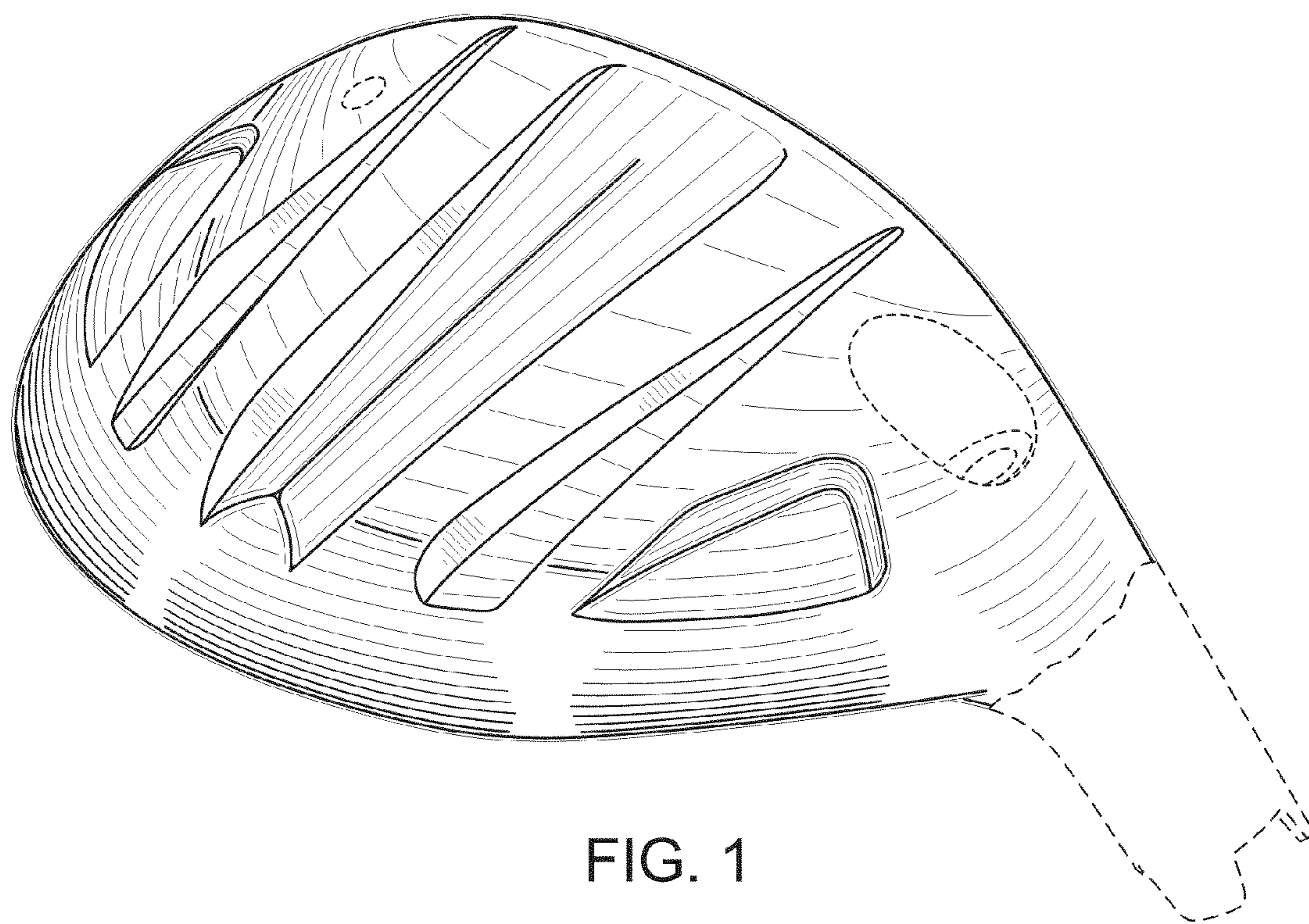

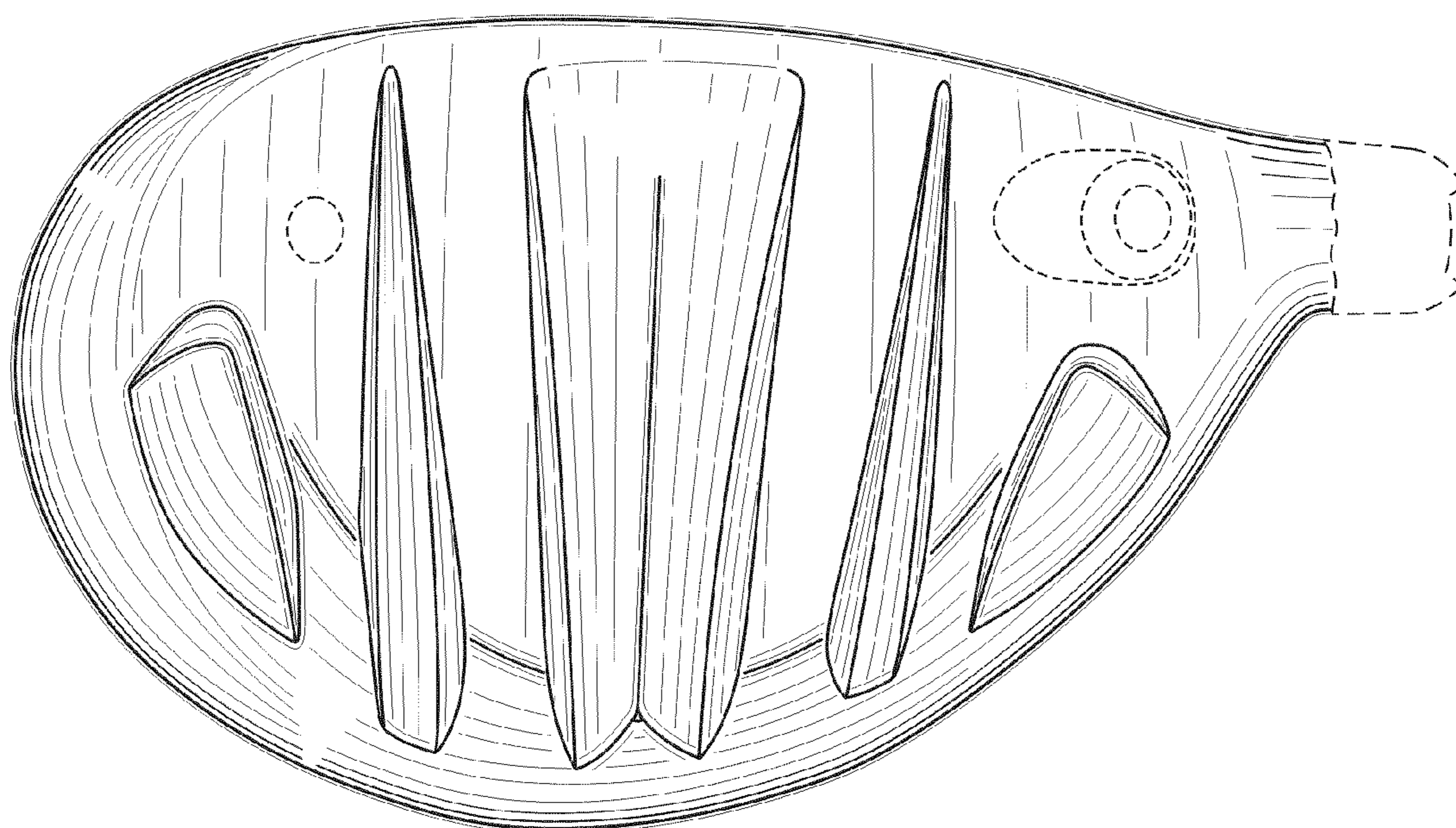

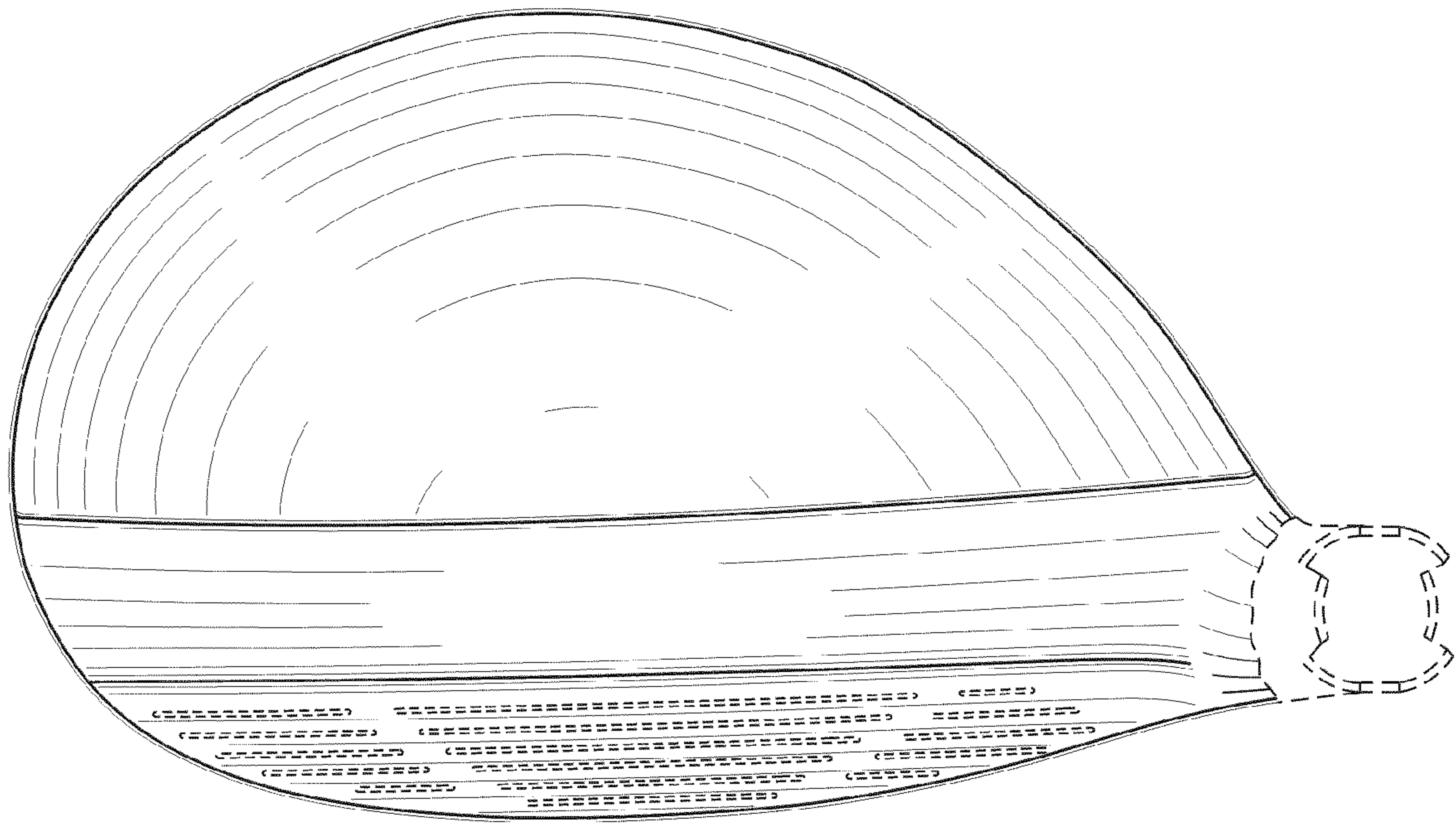

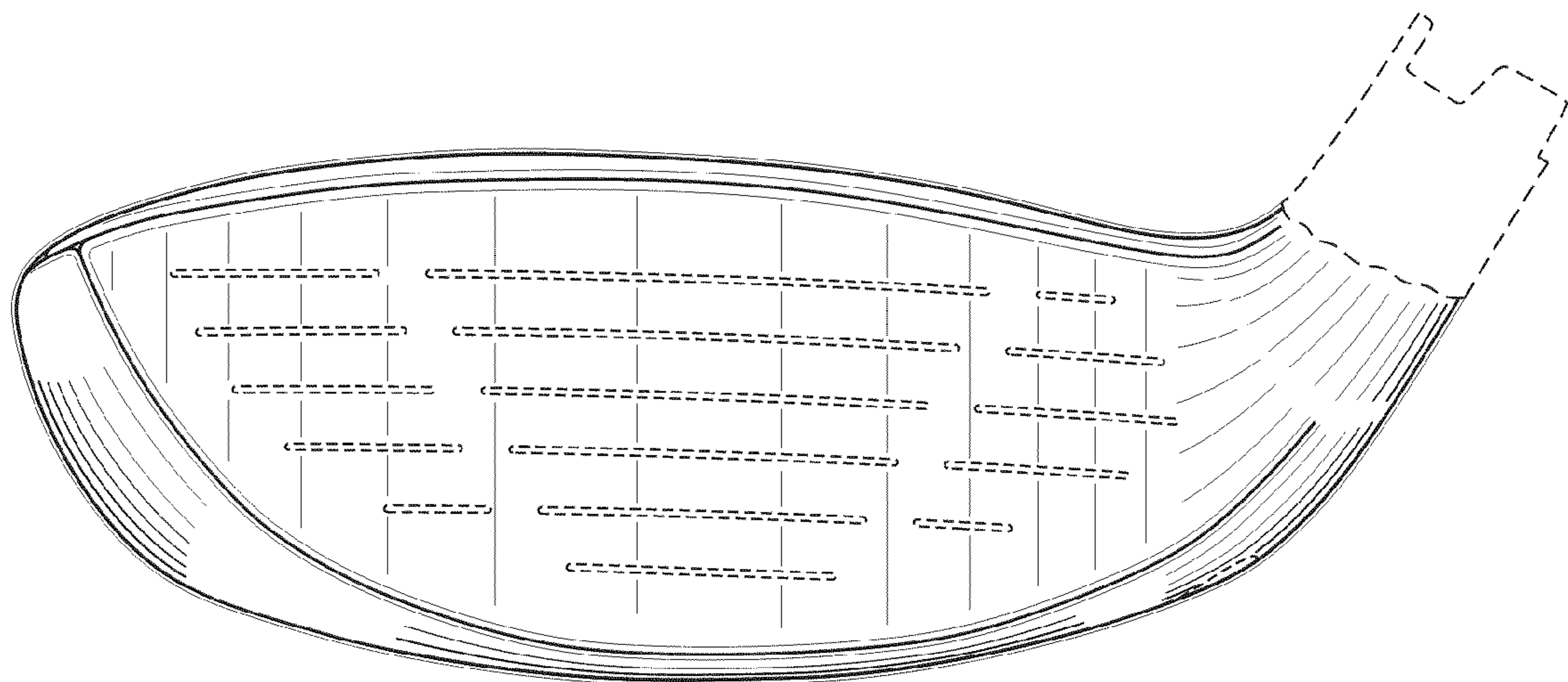

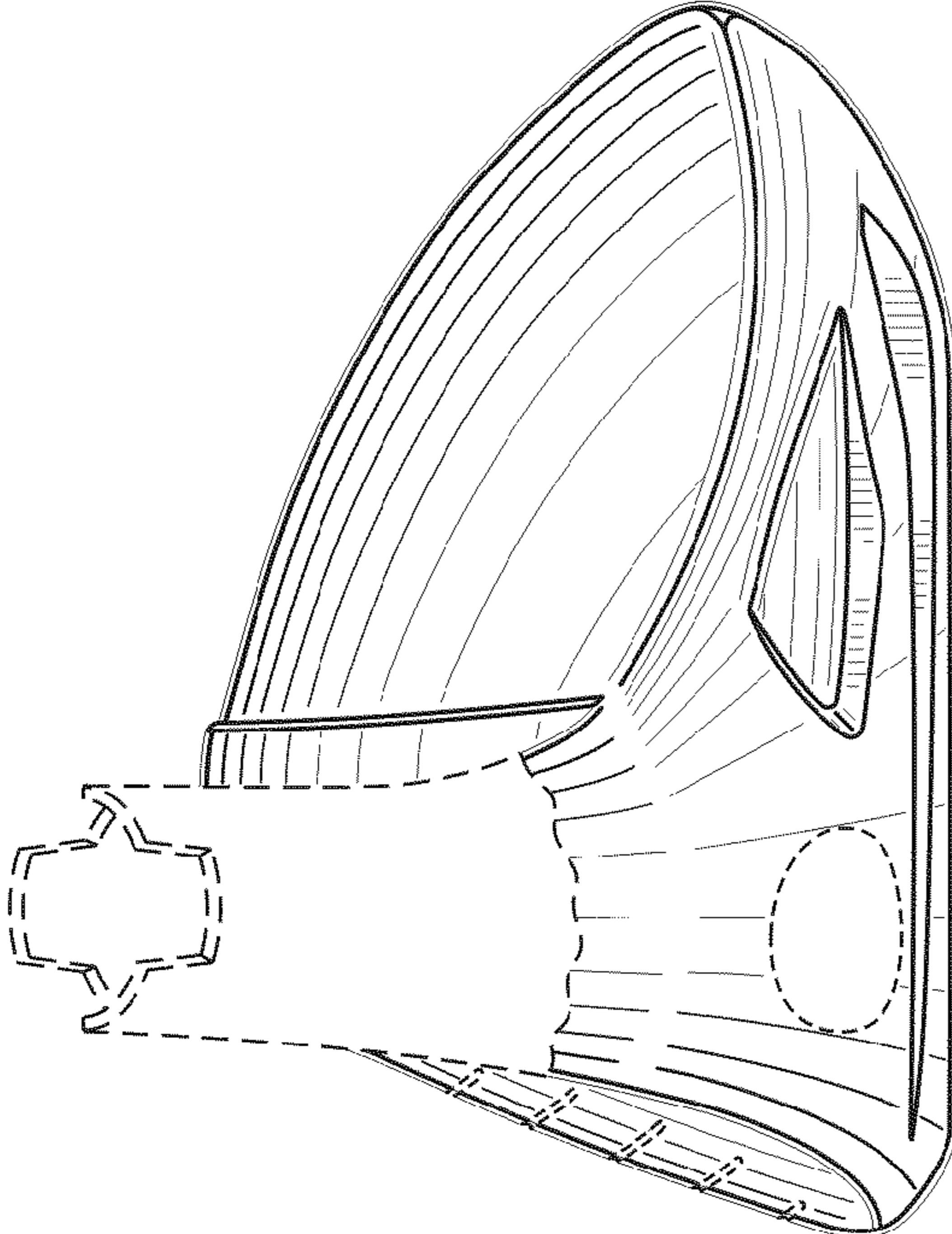
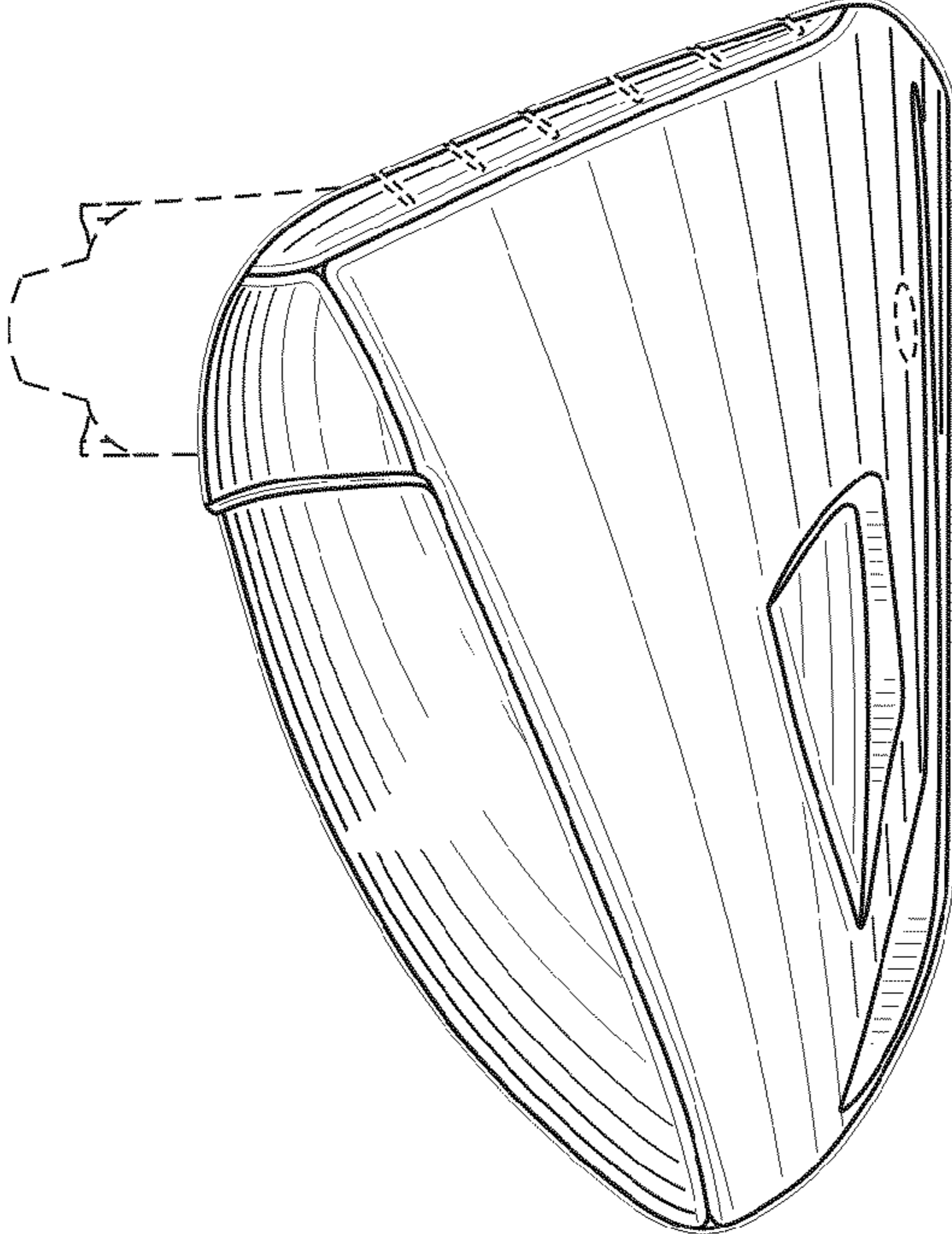

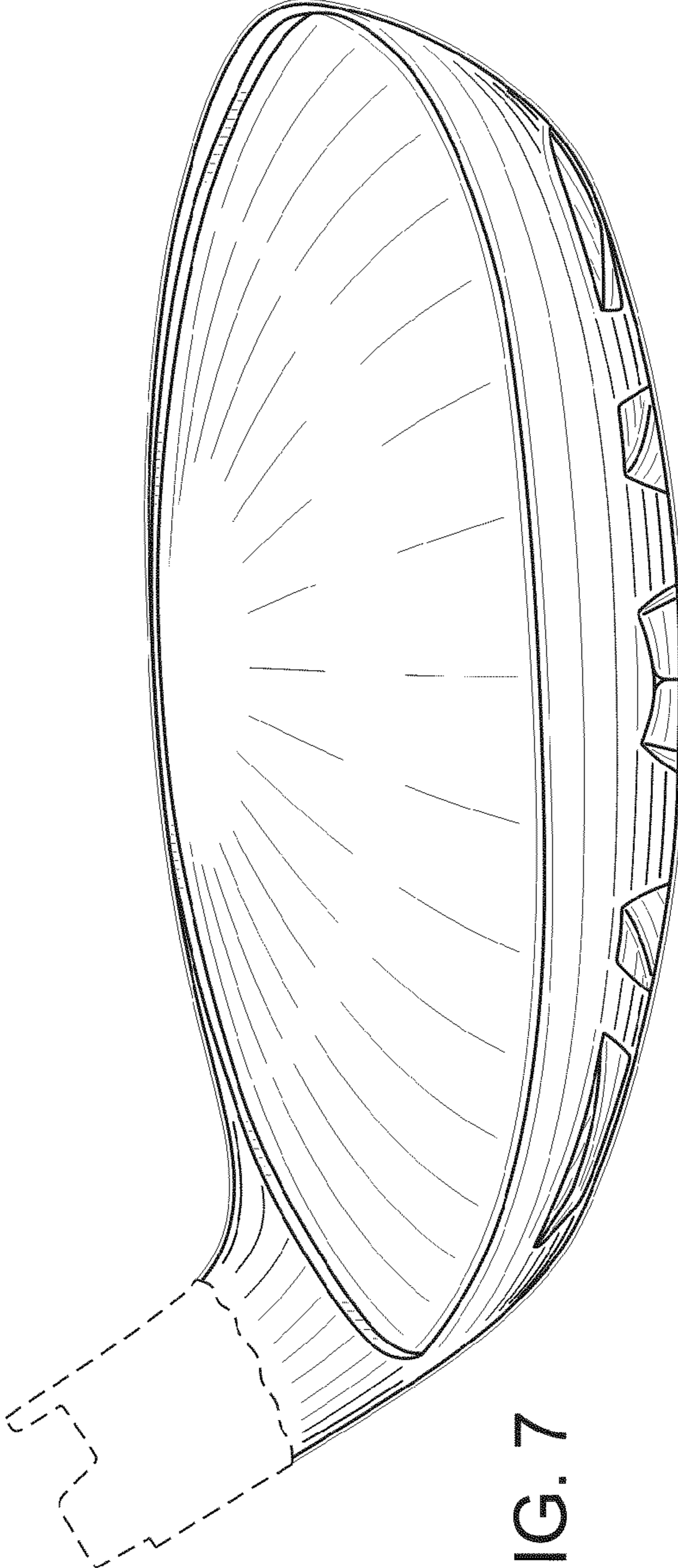
