FIG. 2 is a bottom perspective view of the glove shown in FIG. 1;

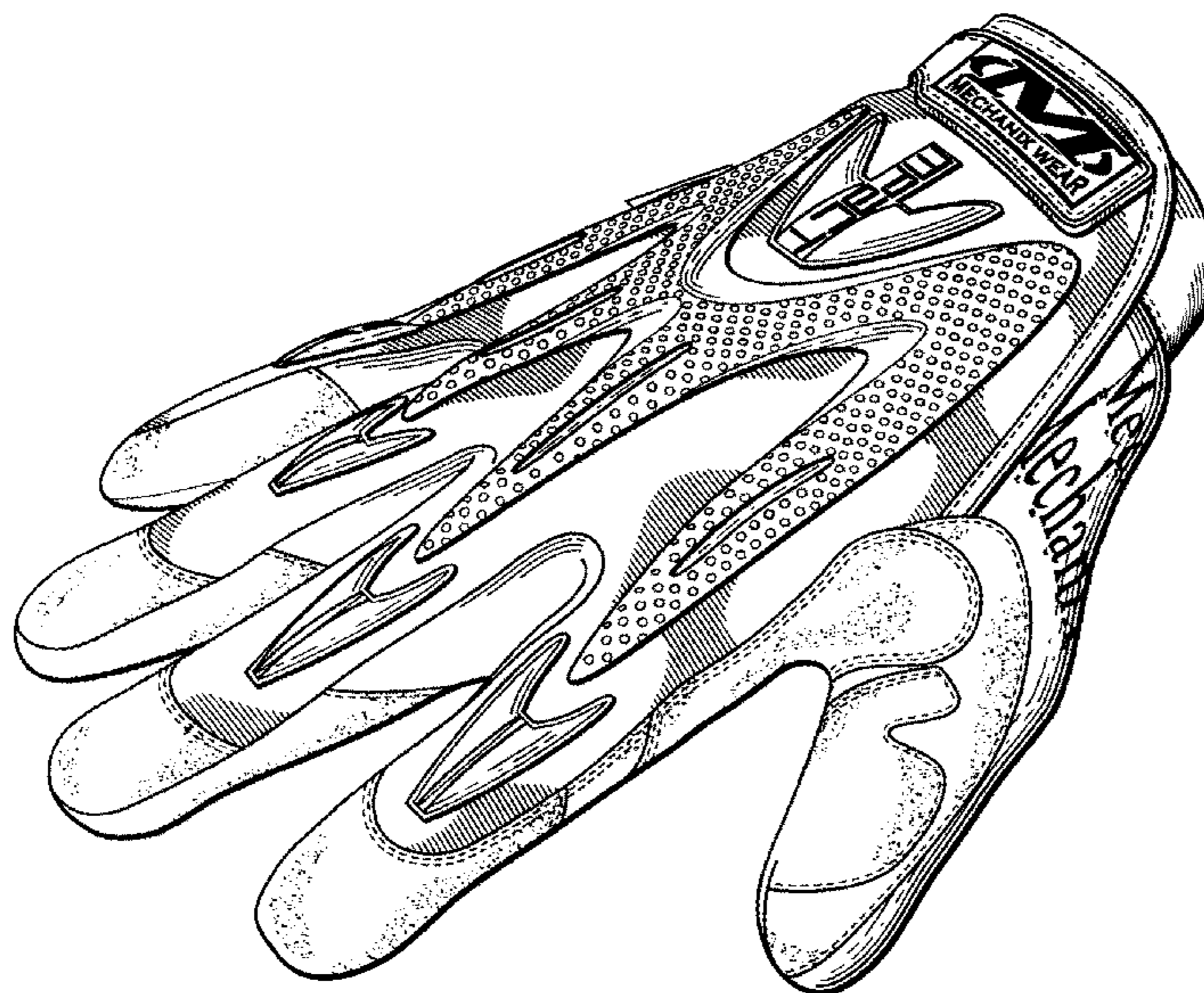
FIG. 3 is a top view of the glove shown in FIG. 1; and,

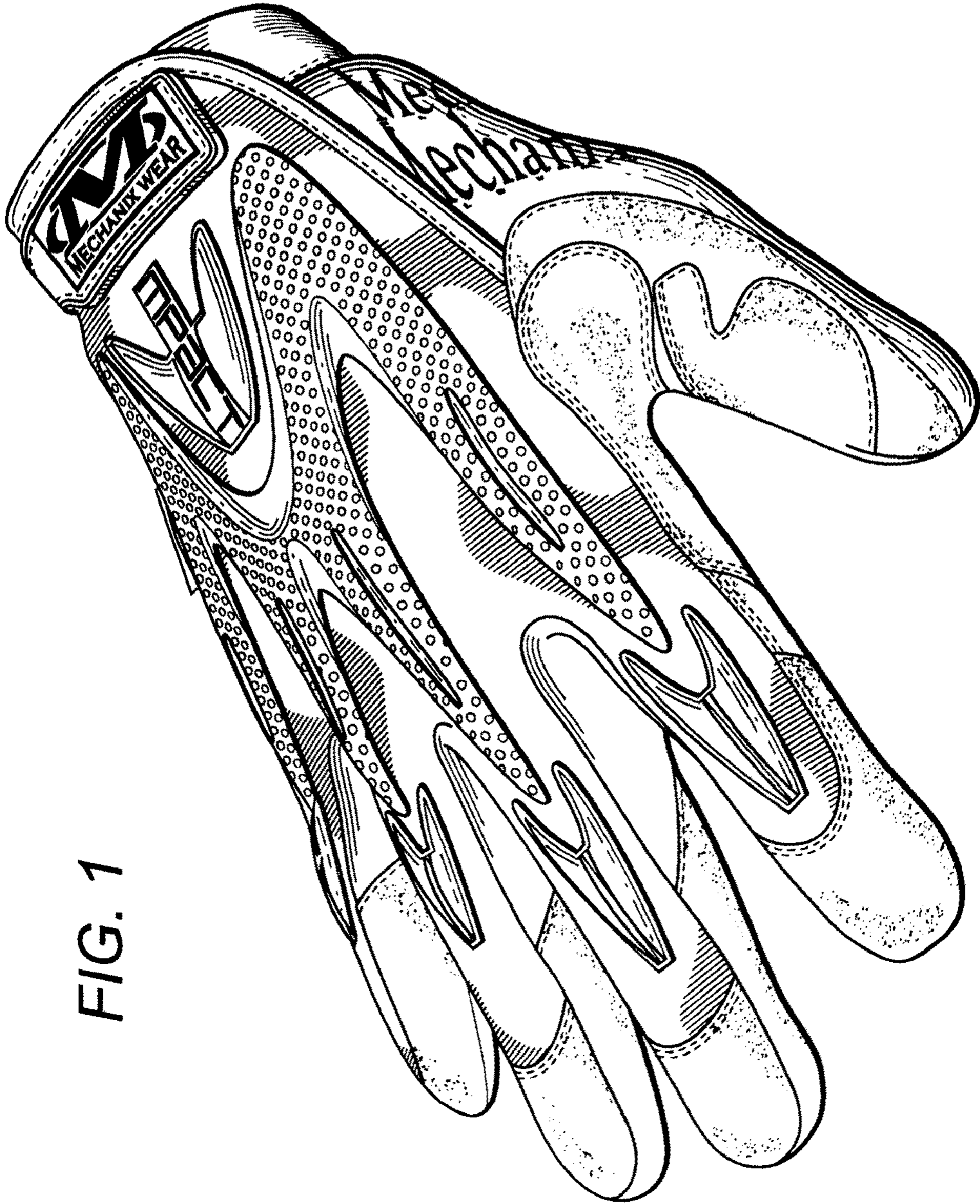

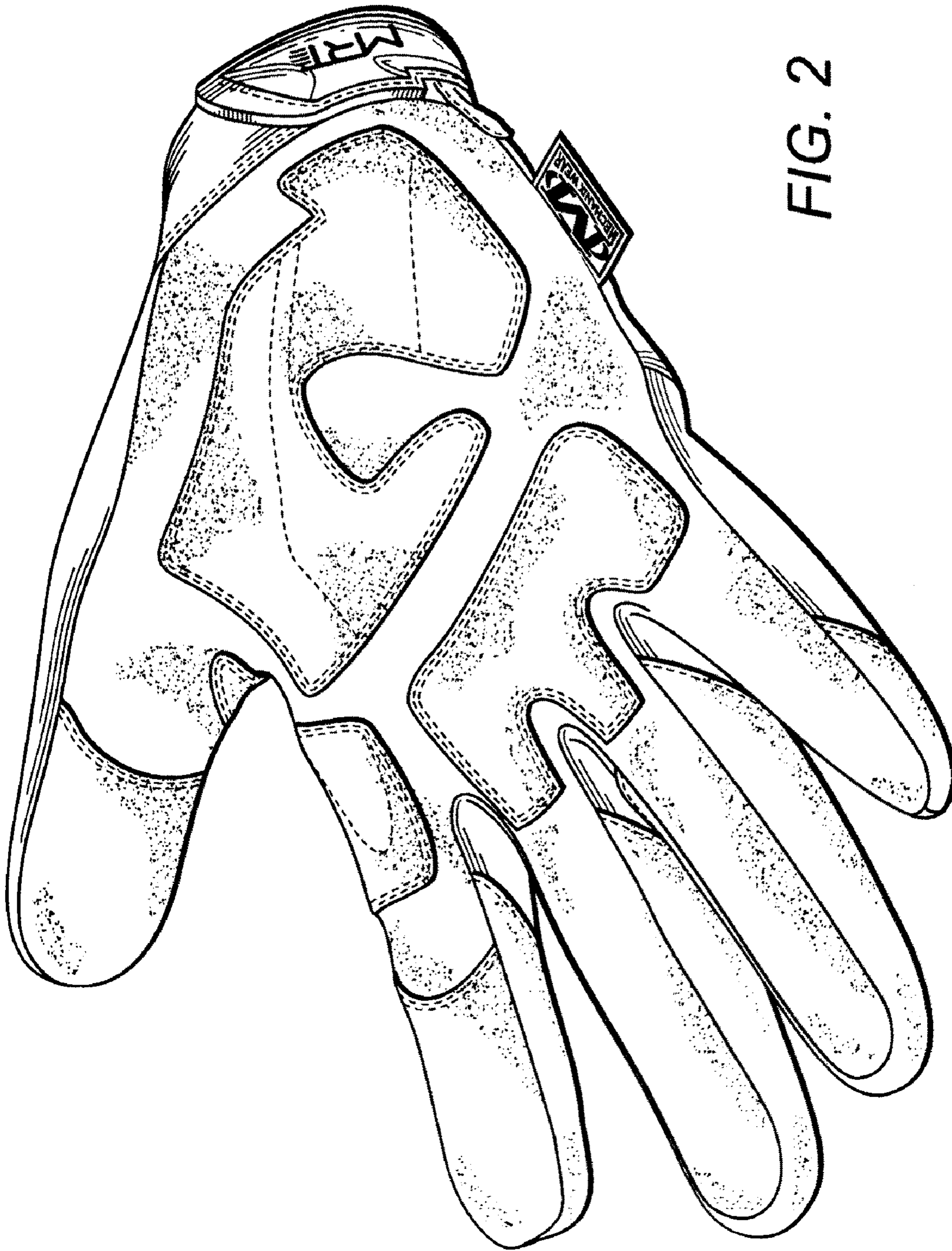

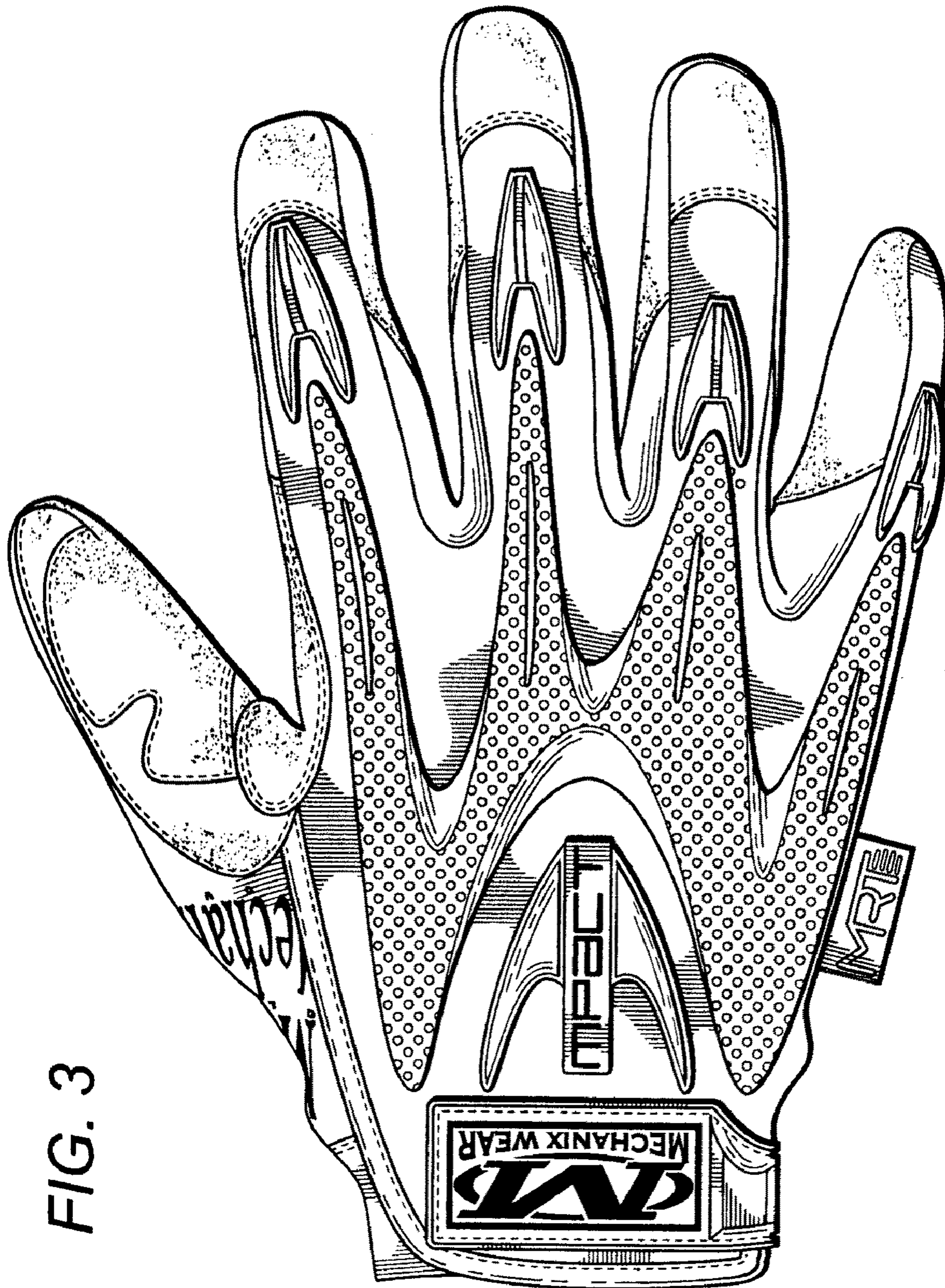
