**DESCRIPTION**

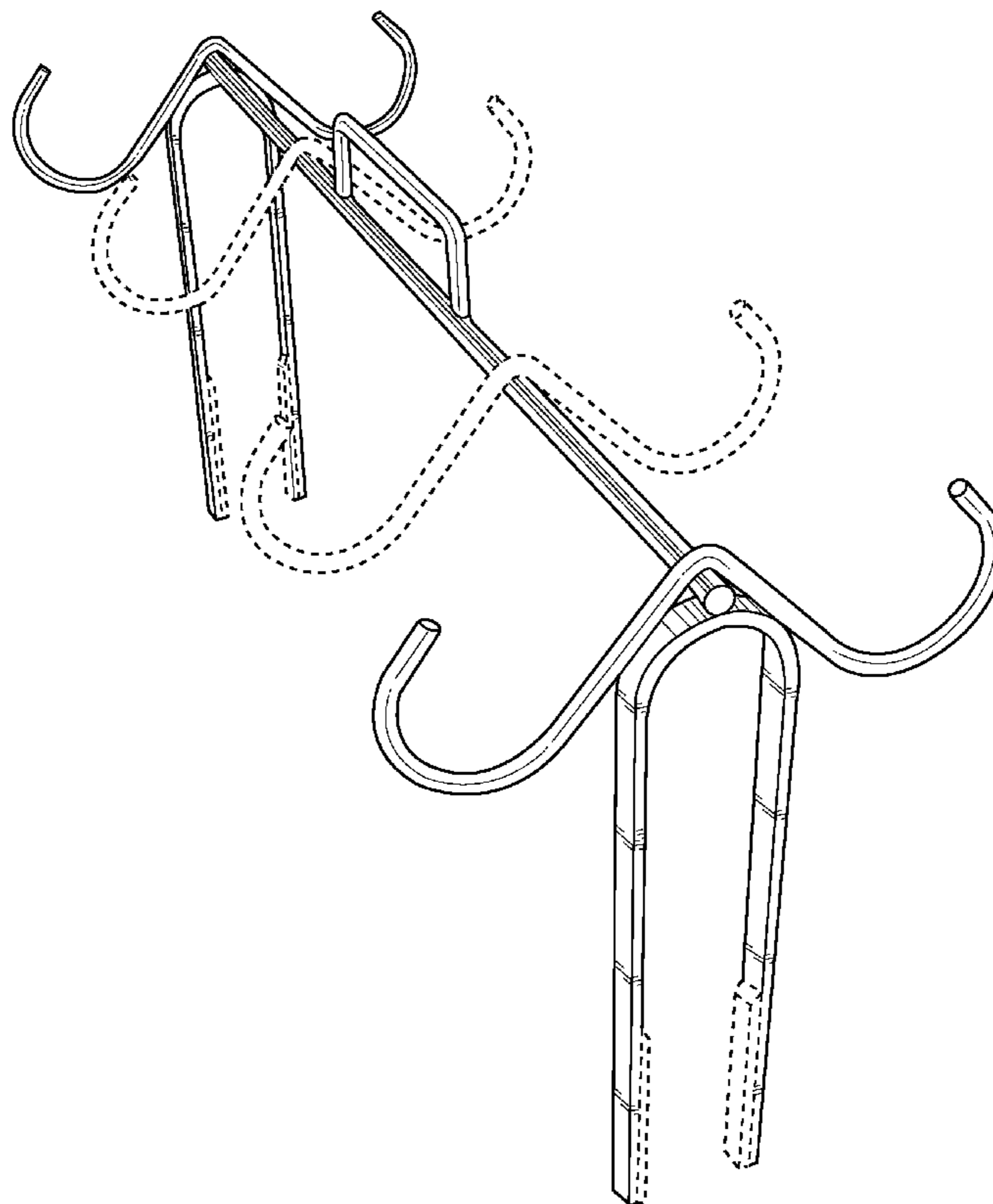
FIG. 1 is a perspective view of one side and the front of the support rack for equestrian tack according to one embodiment of my new design;

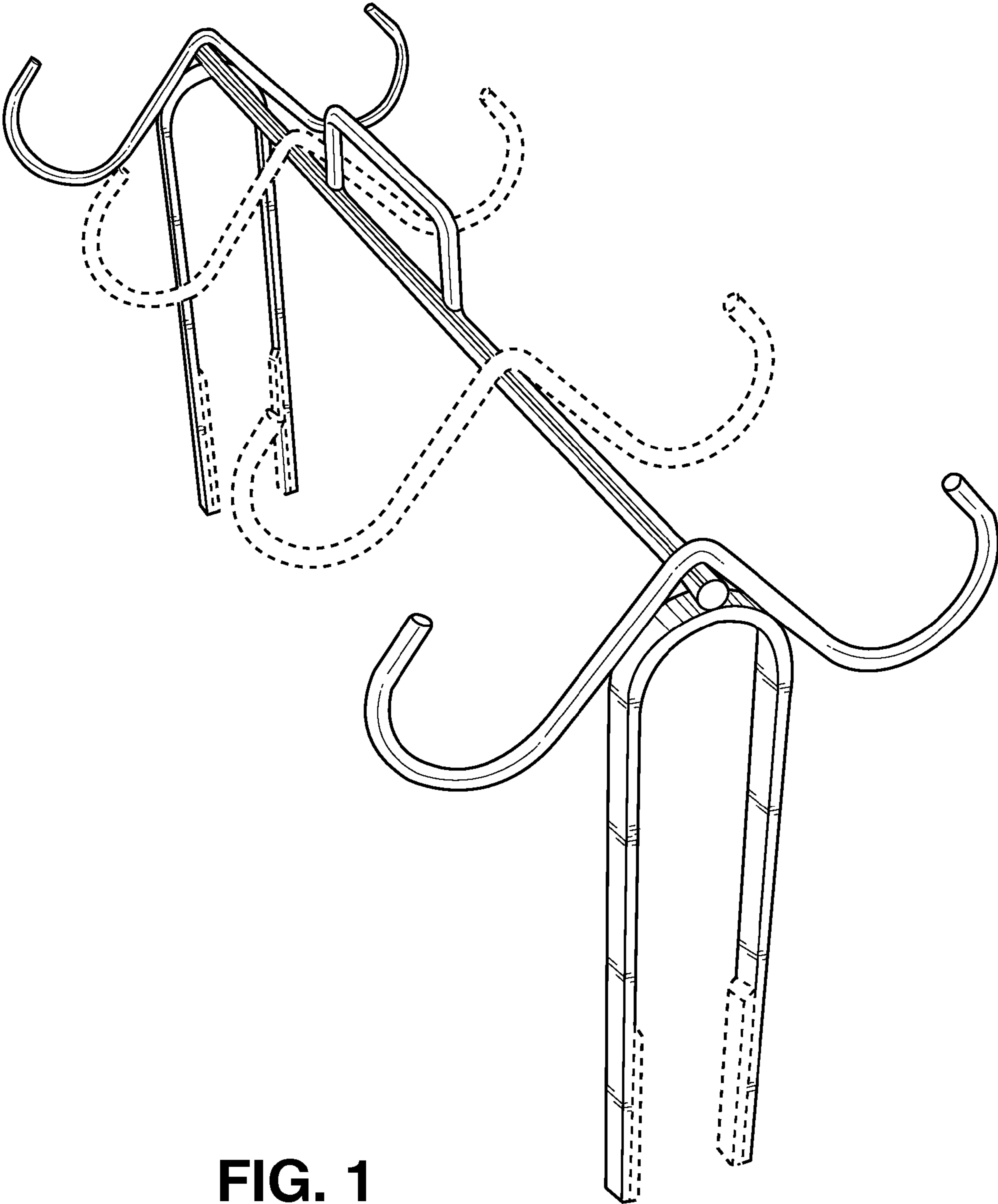

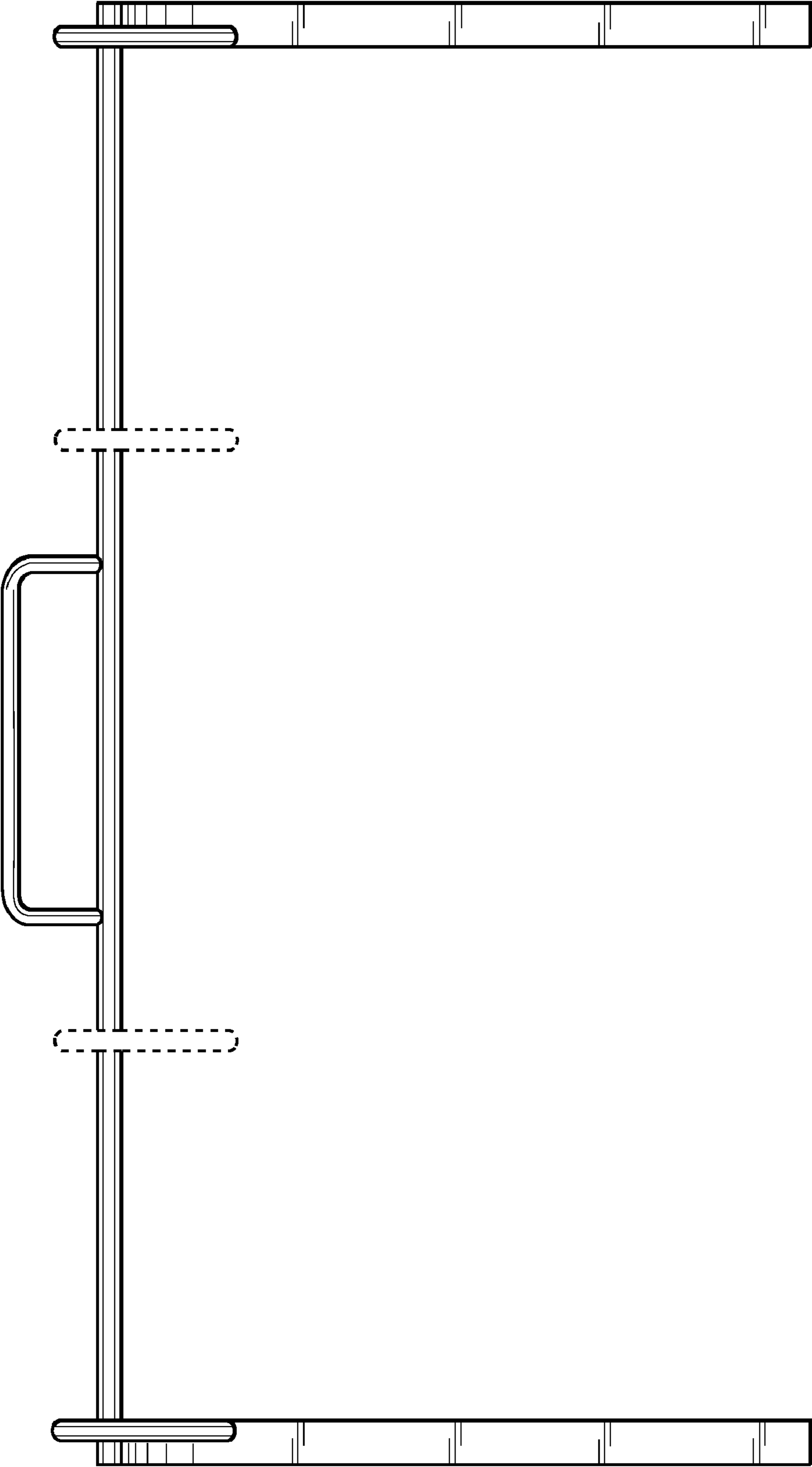

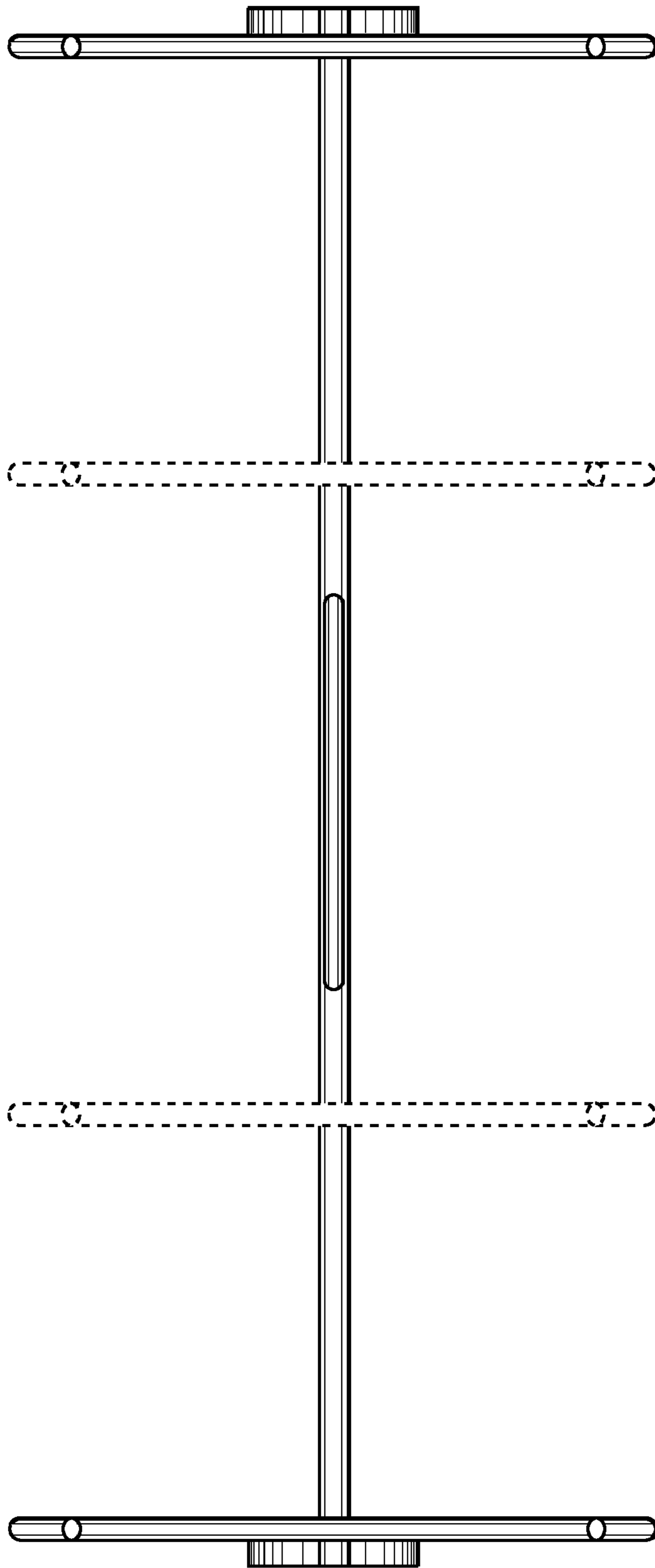
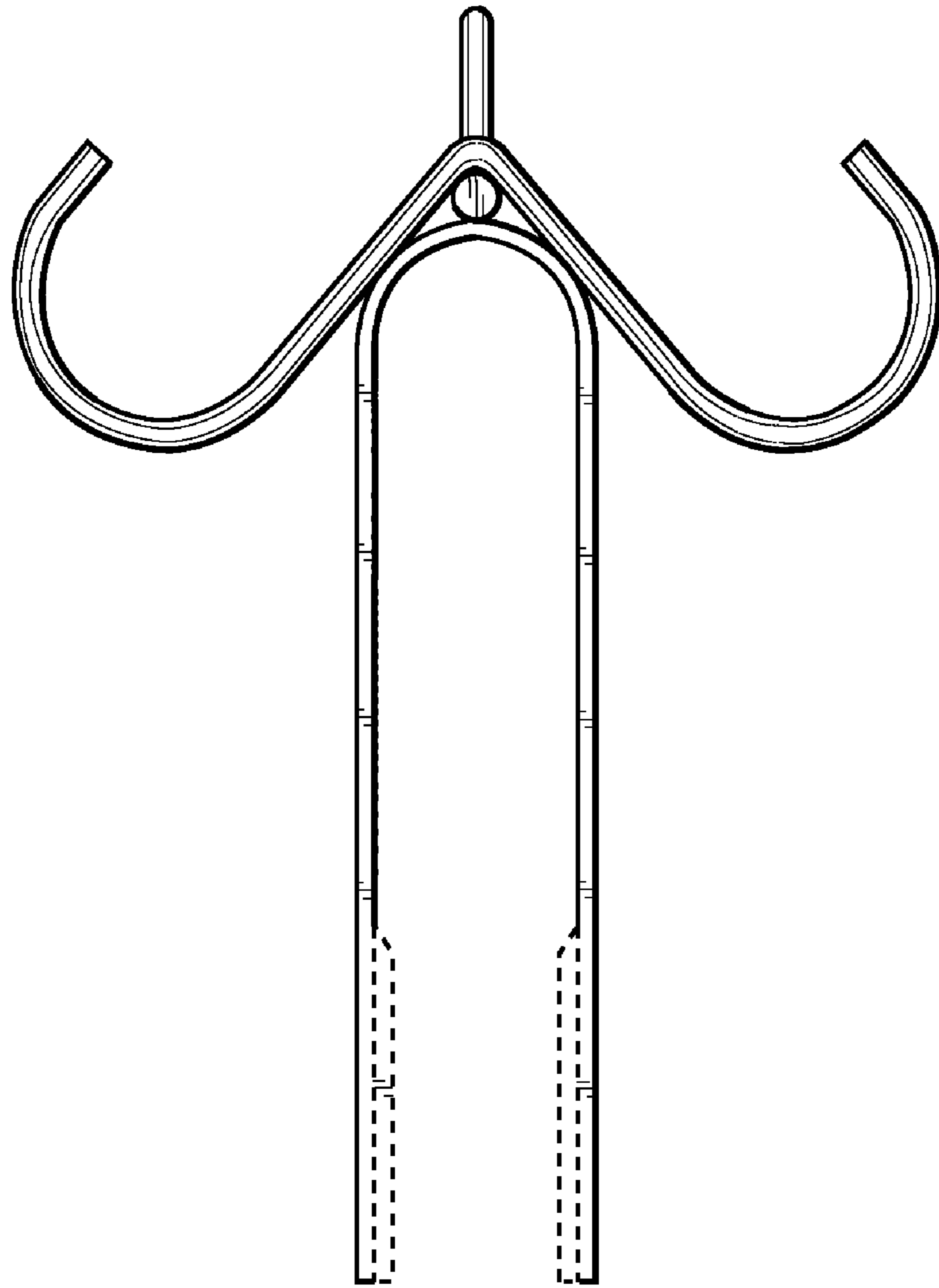
