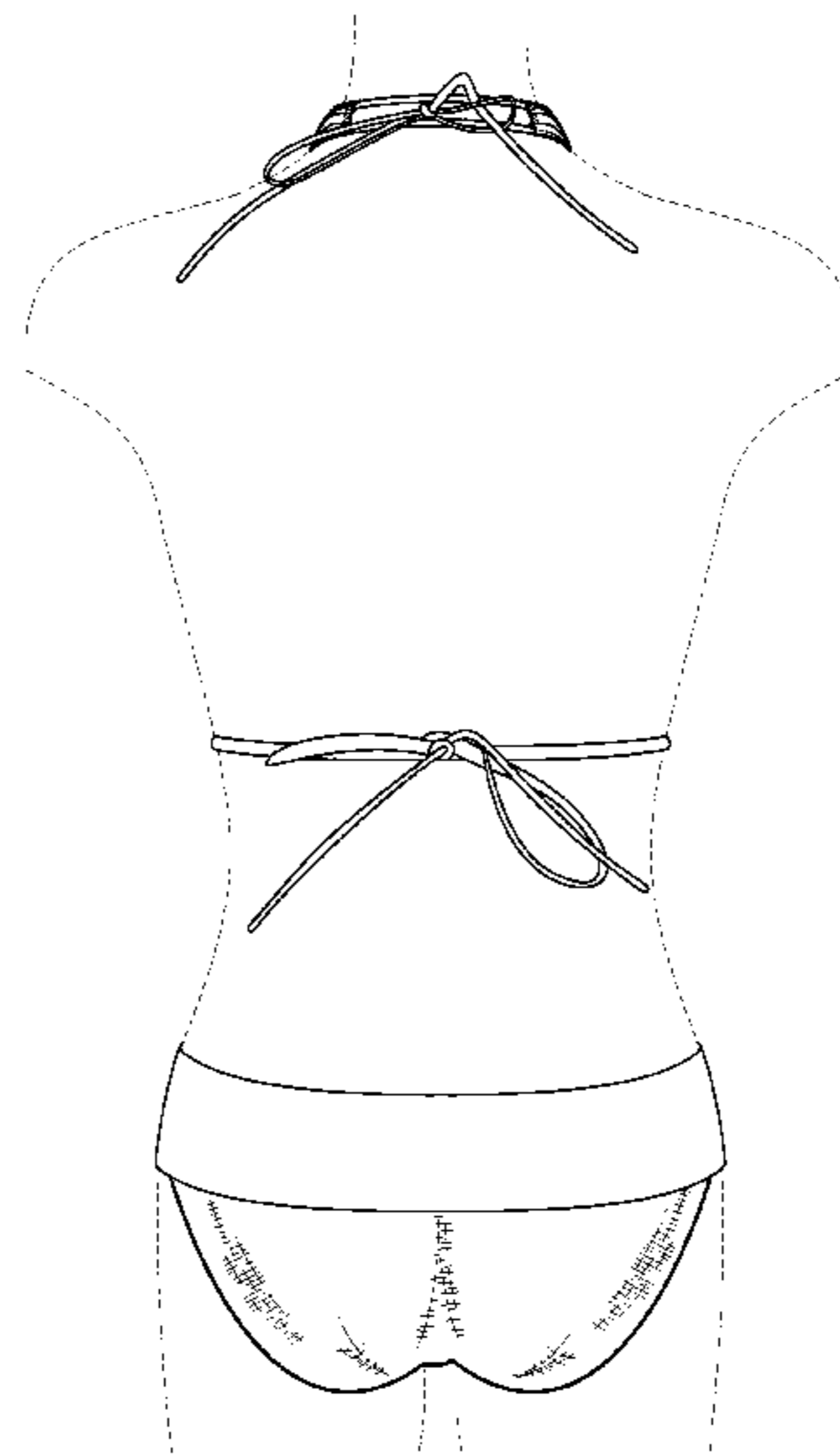
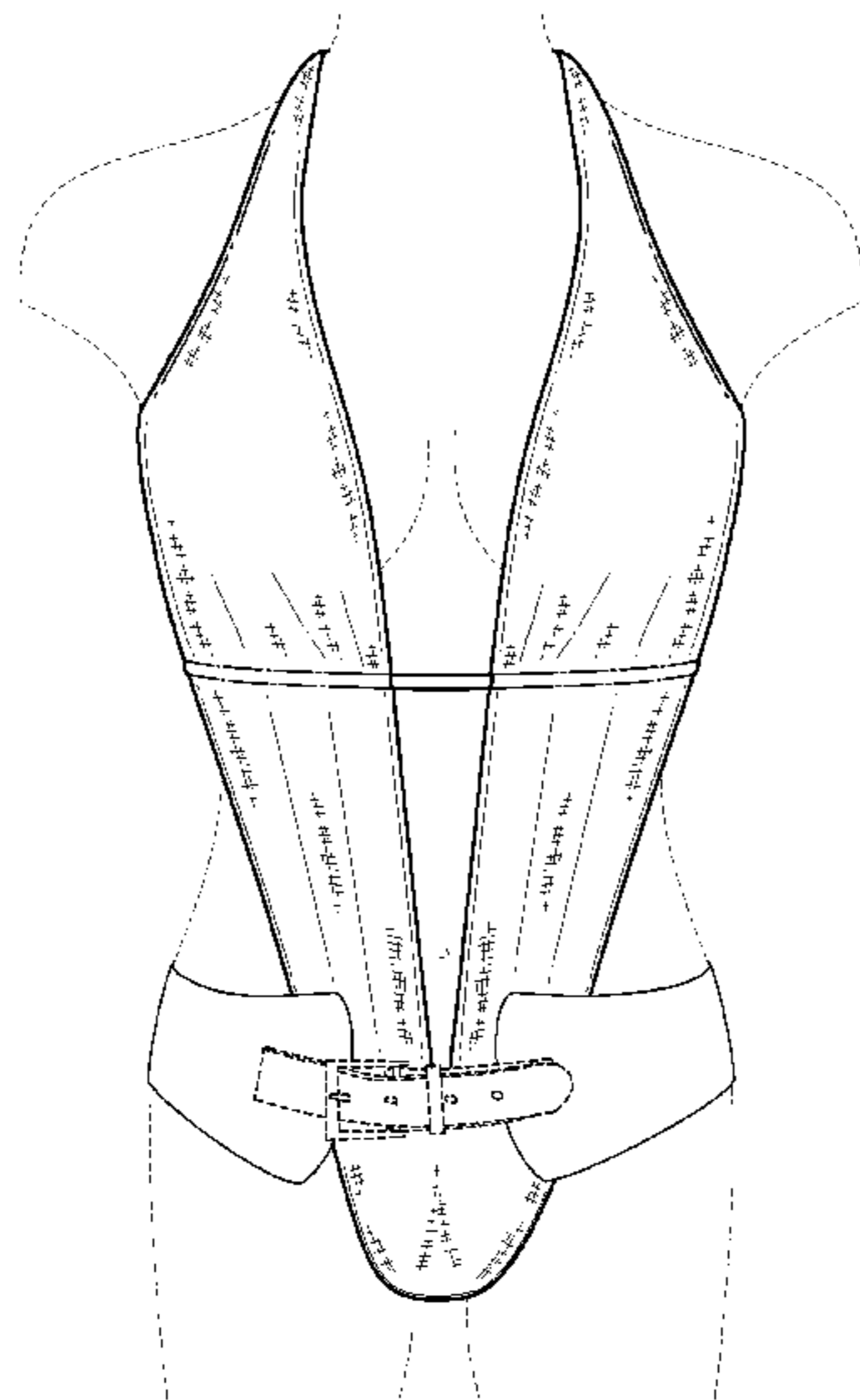
The ornamental design for a belted women's swimsuit, as shown and described.

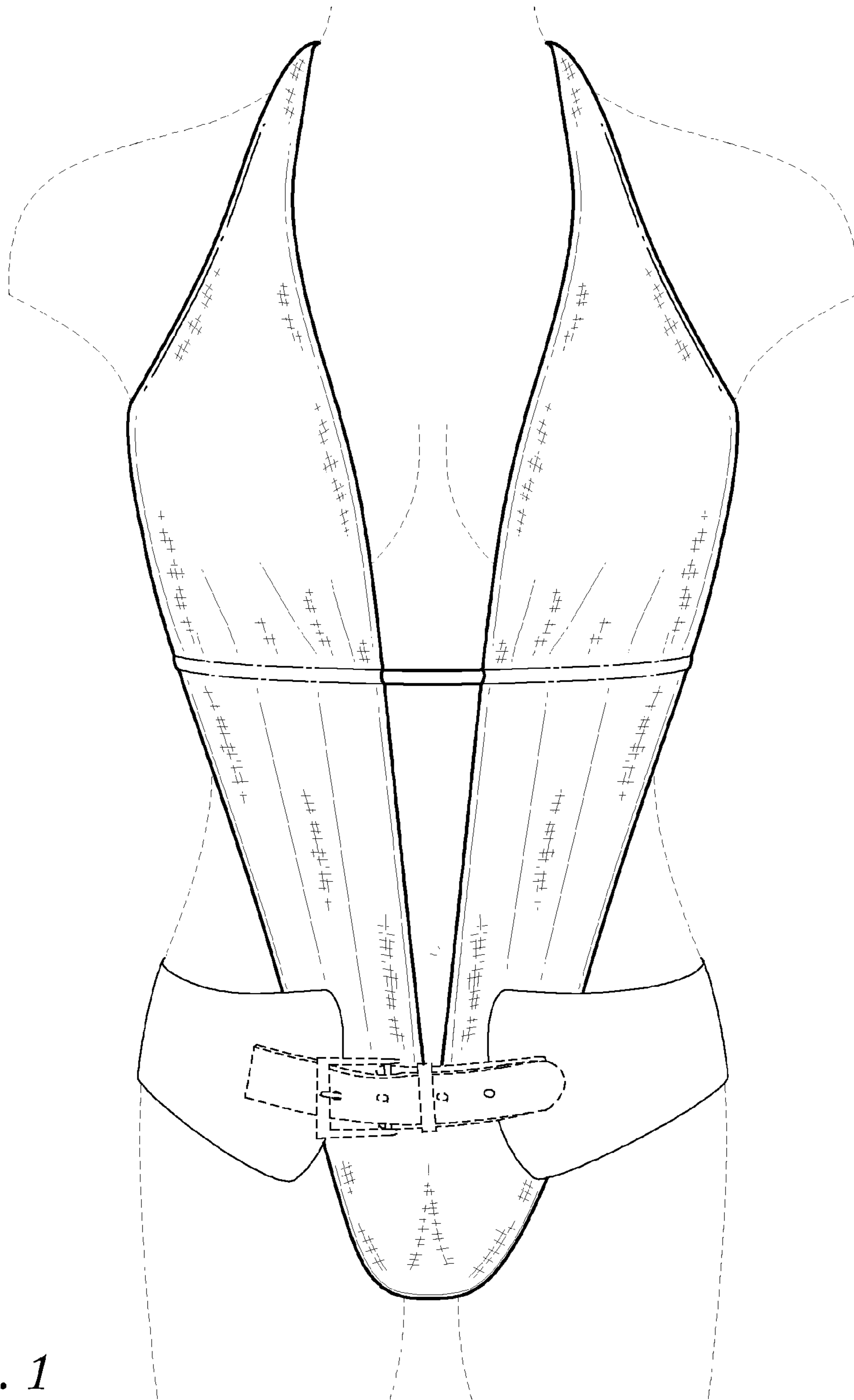
**DESCRIPTION**

FIG. 4 is an opposite side view of the belted women's swimsuit.

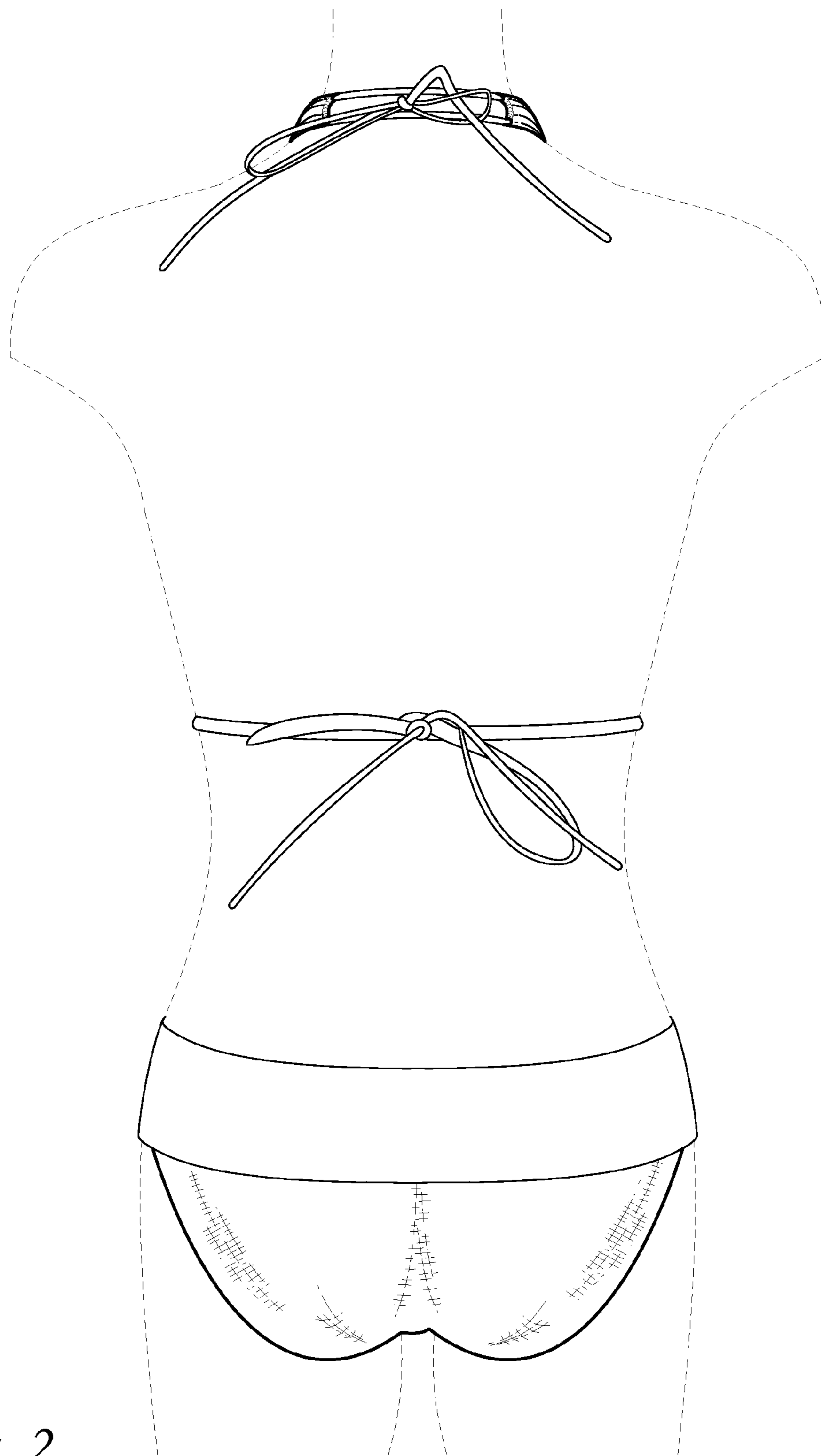

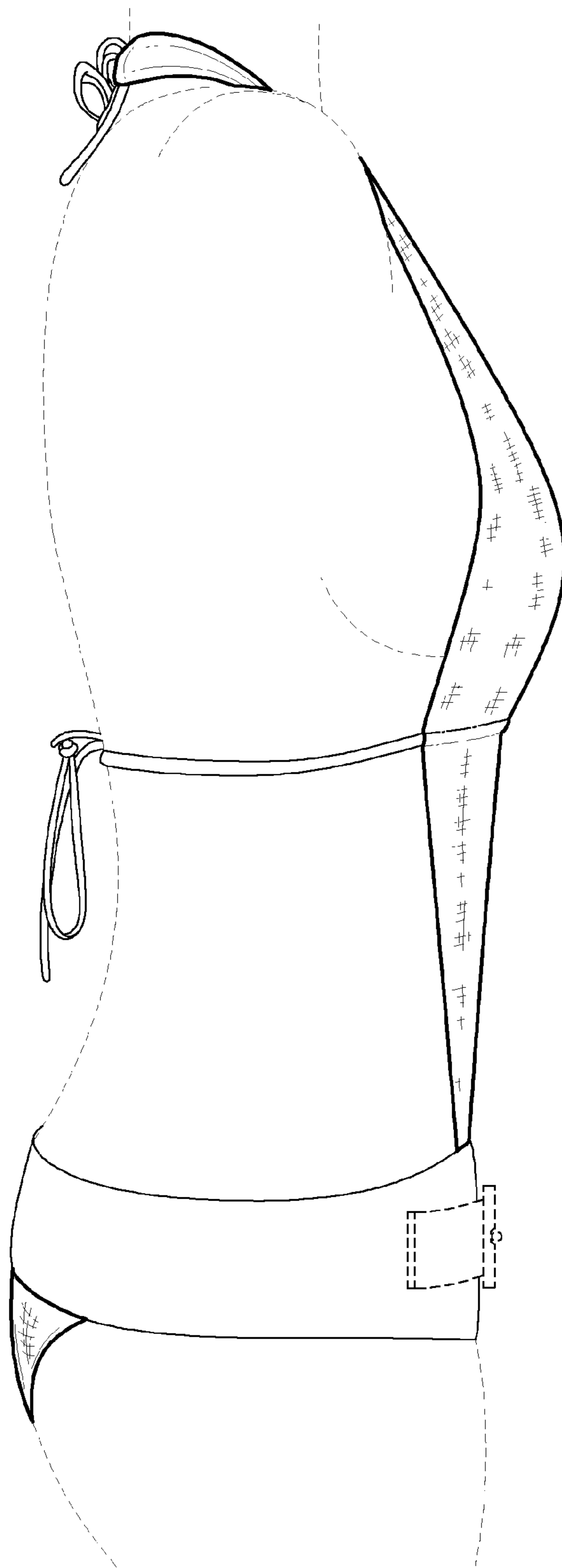
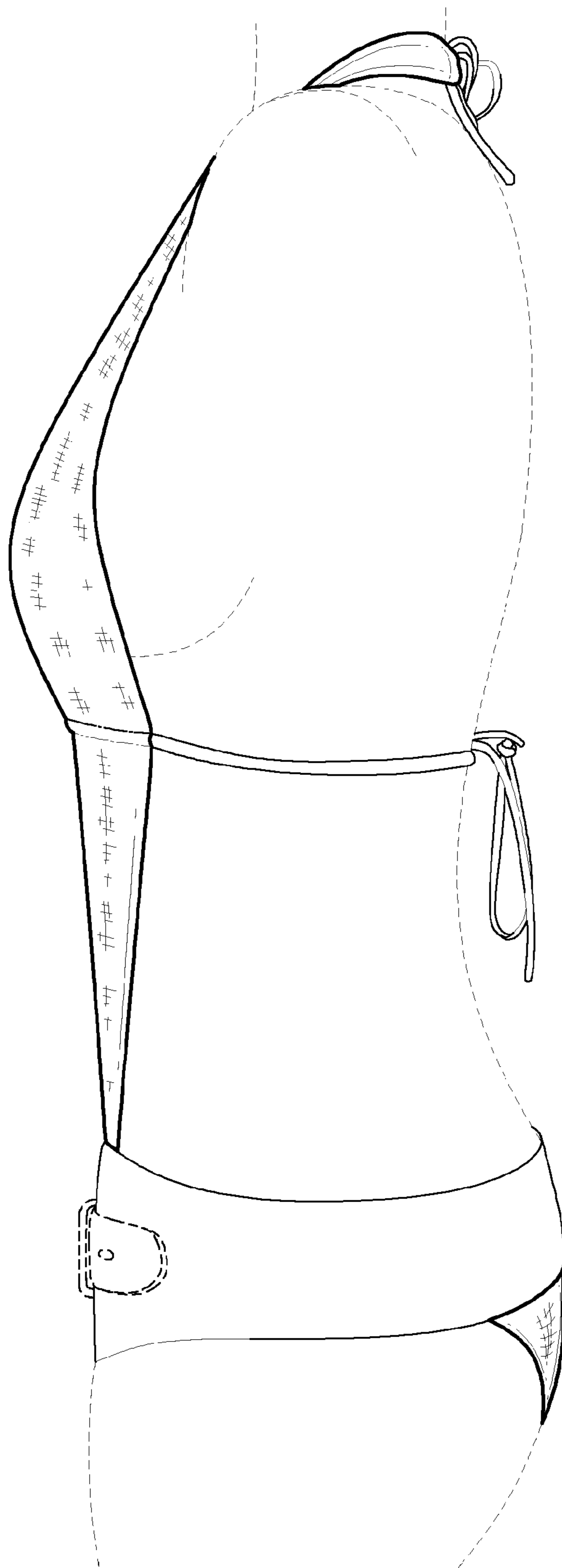
