(57) **CLAIM**

What is claimed is the ornamental design for a football sweater, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a football sweater, showing the new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left-side elevational view thereof;

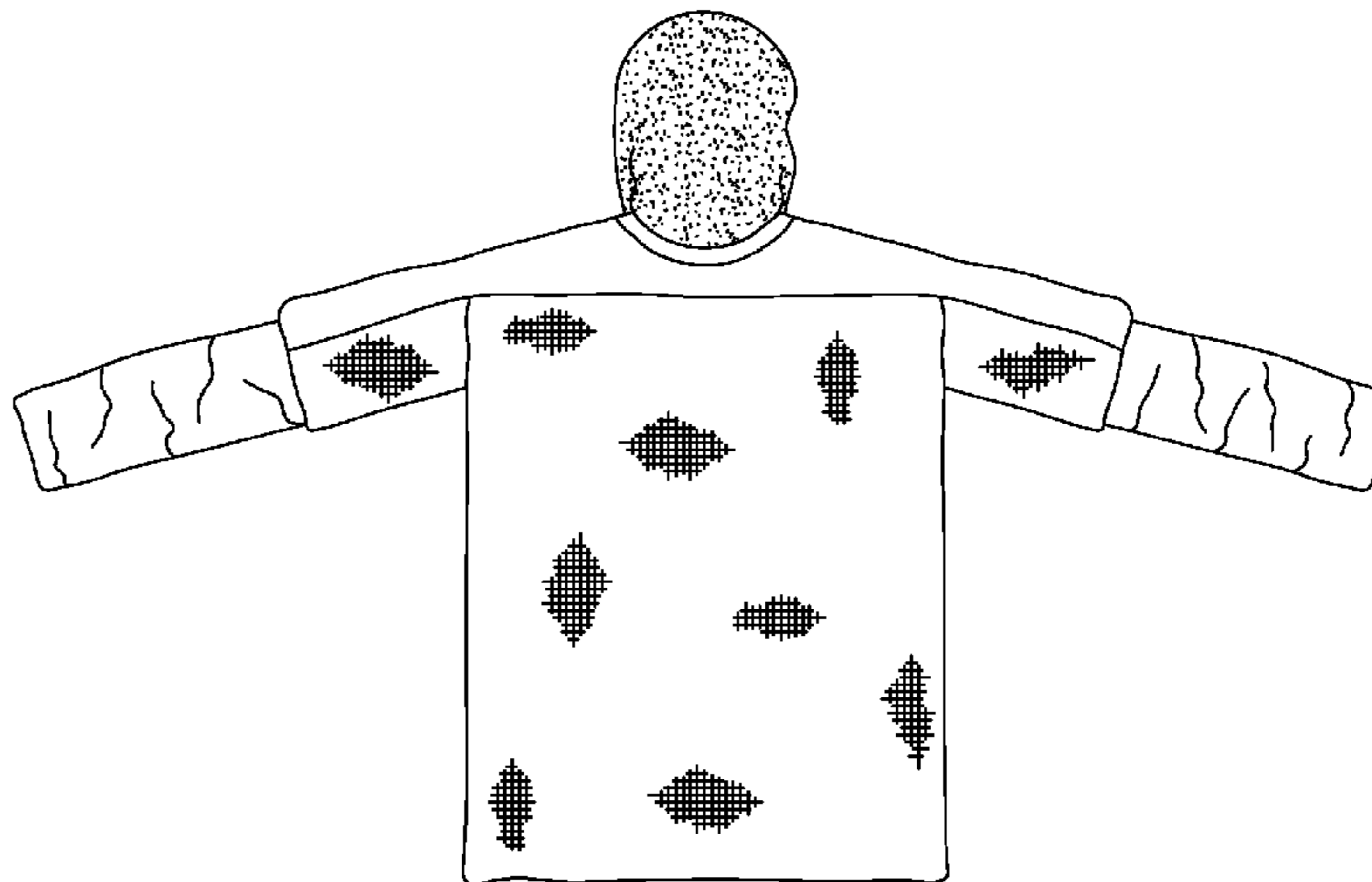
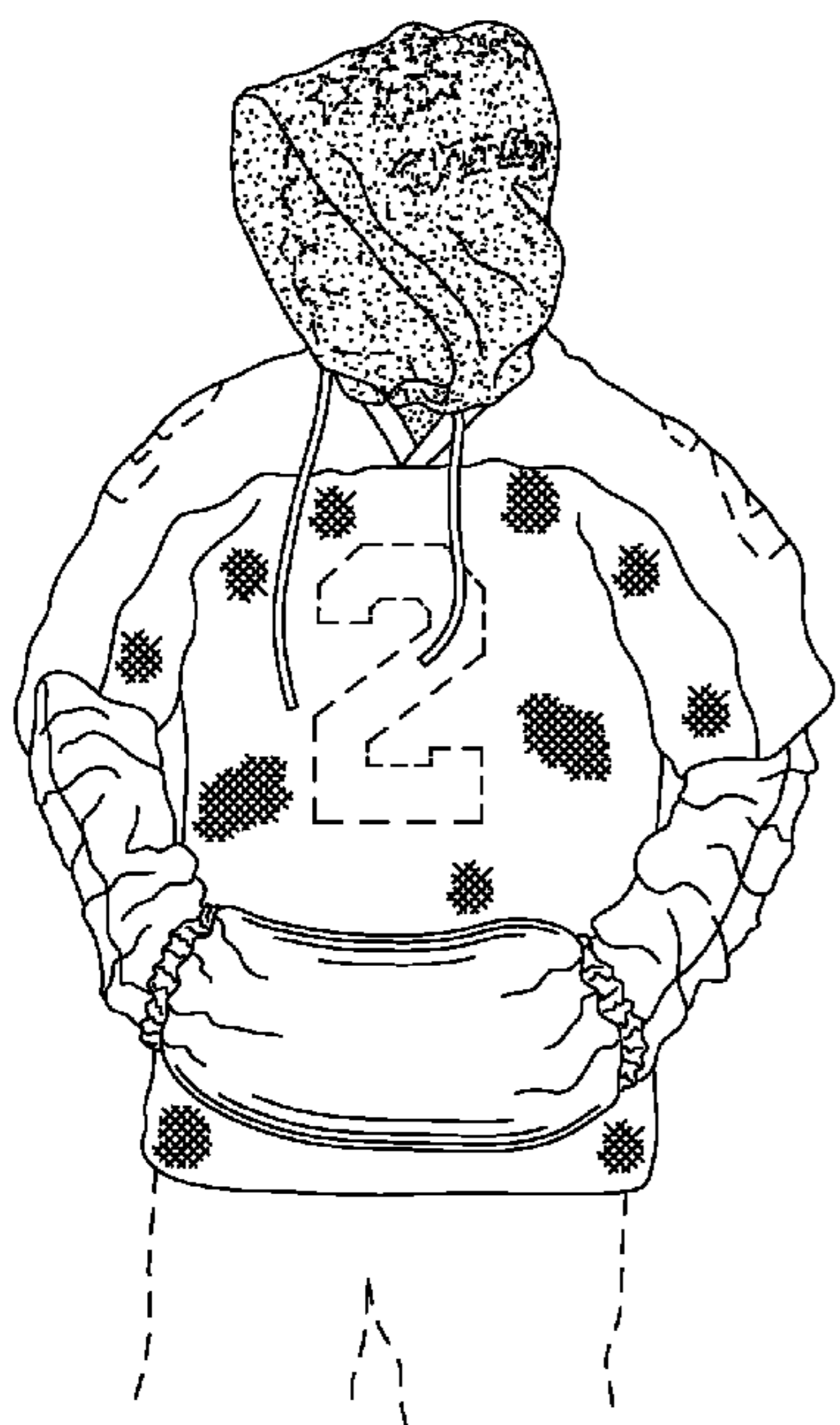
FIG. 5 is a left-side elevational view thereof;

The shading on a hood portion, a jersey portion, and a sweater portion of the design are illustrated to show contrasting colors of the design.

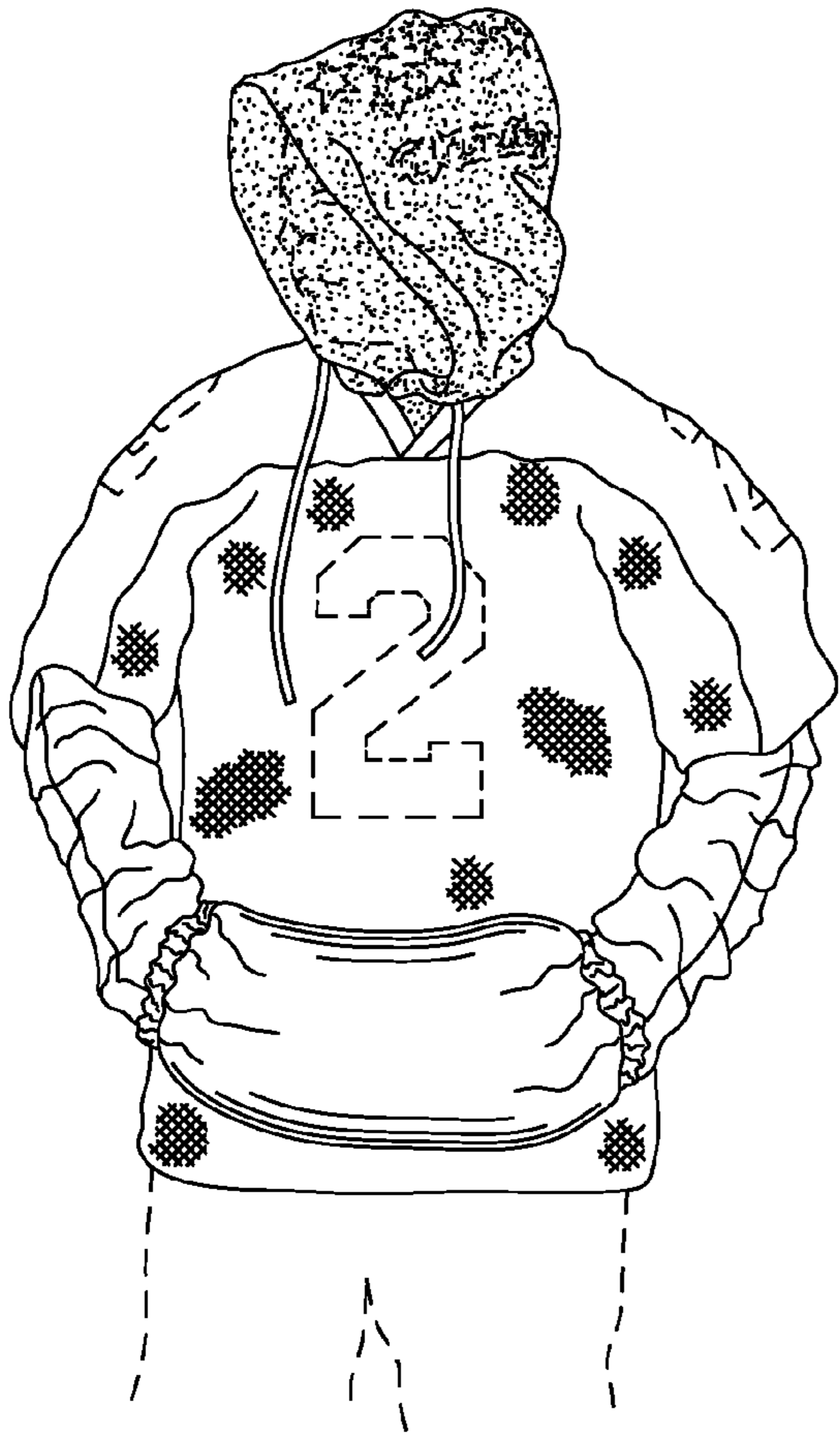

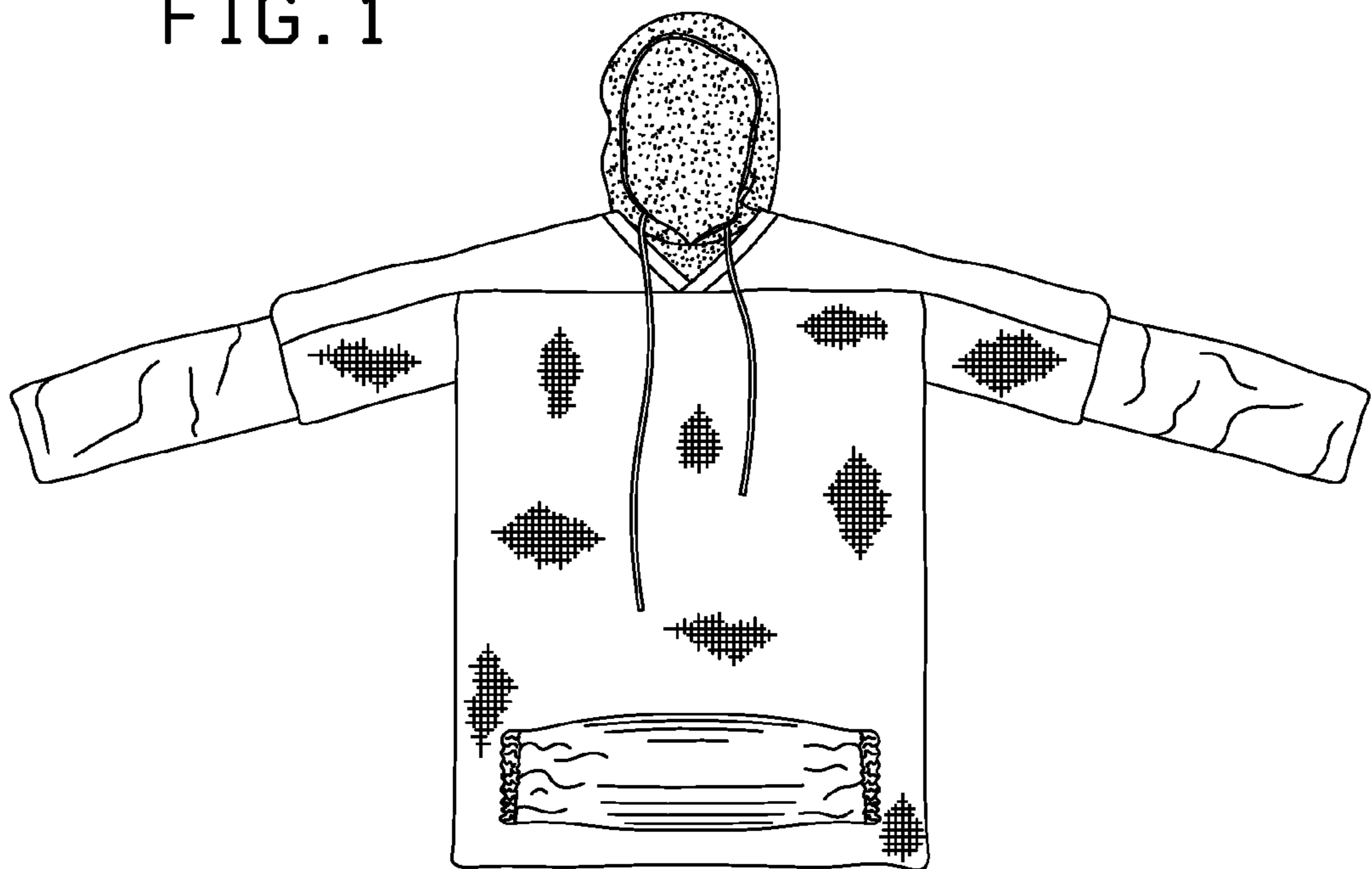

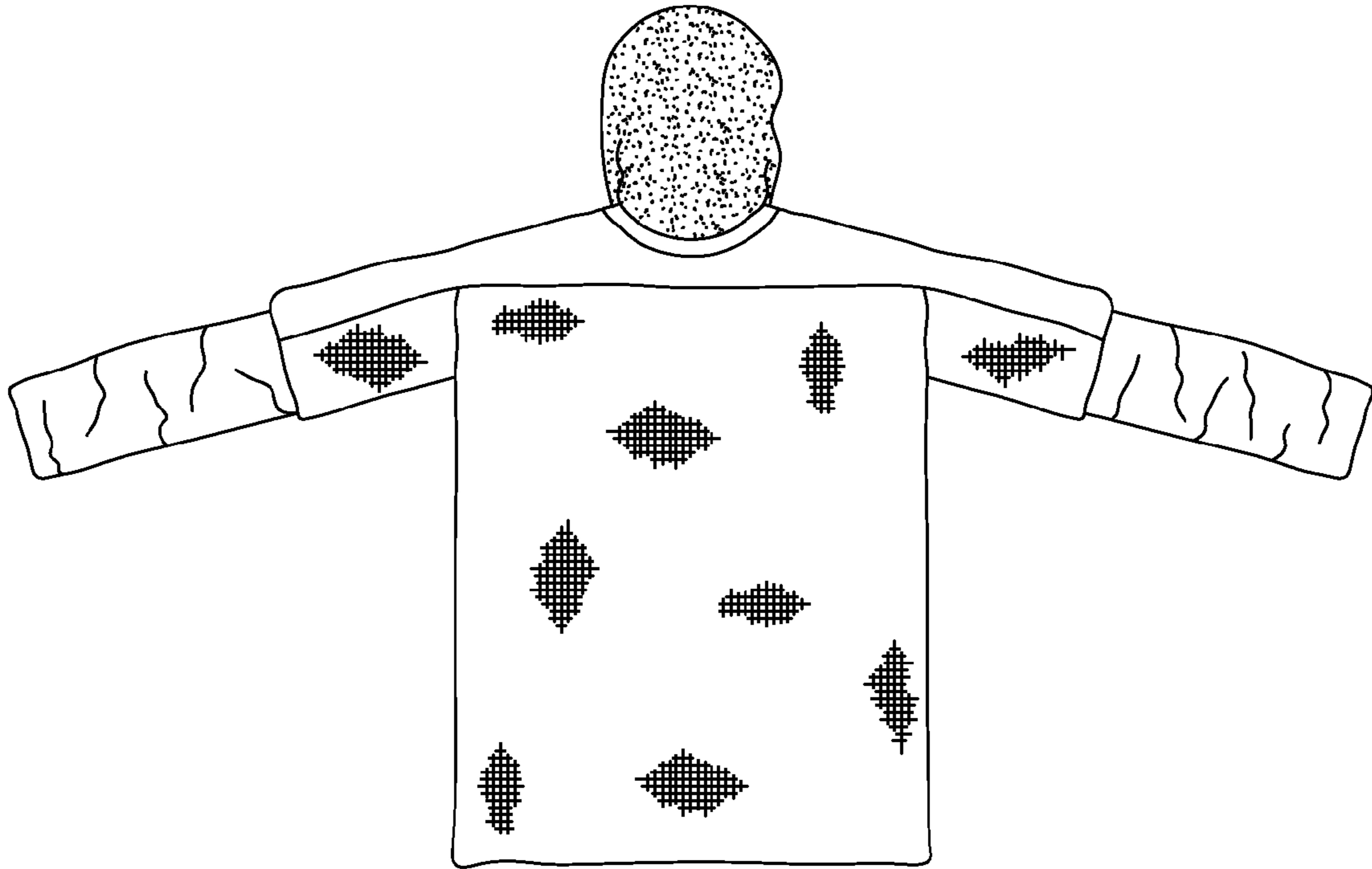

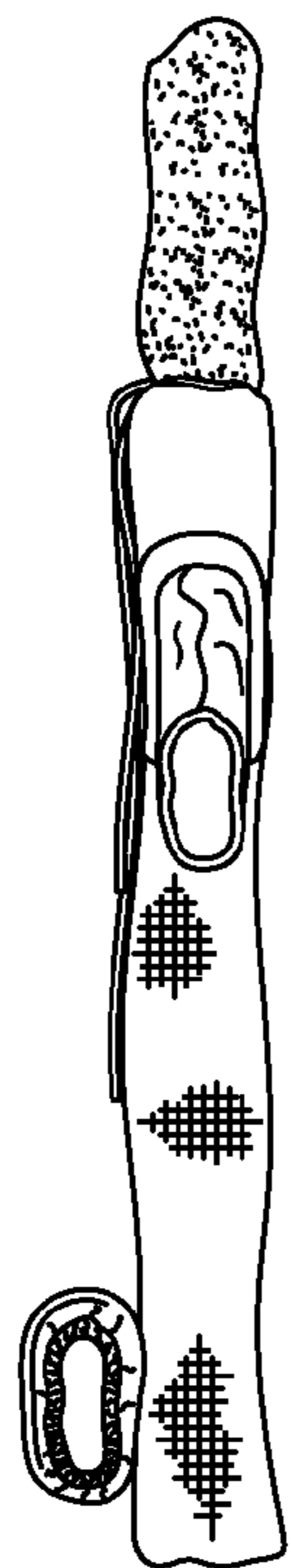

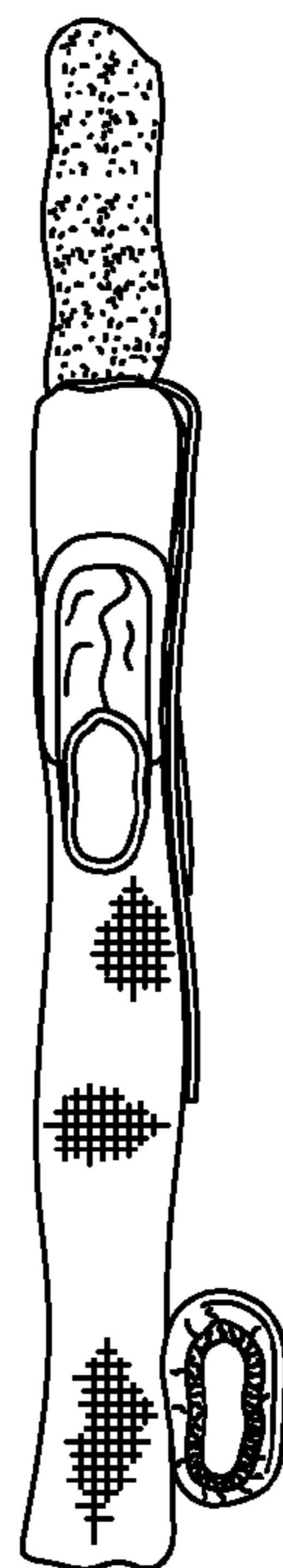

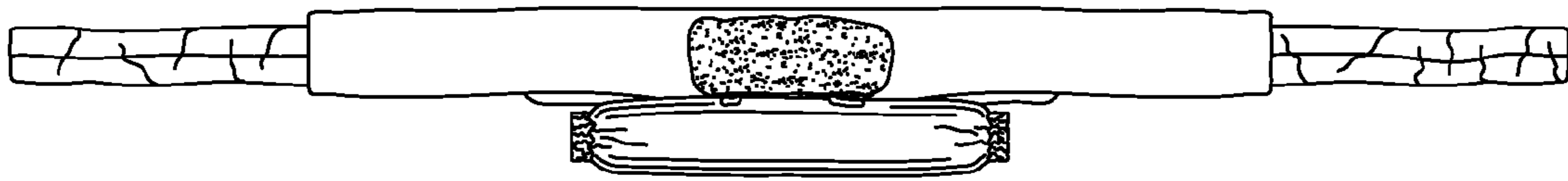

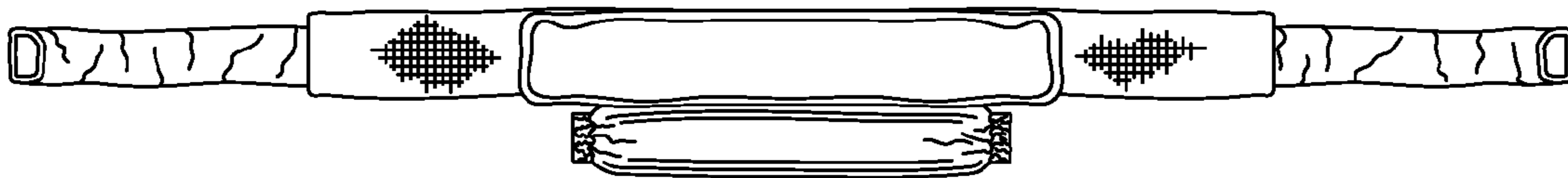
