(57) **CLAIM**

The ornamental design for a crown front portion, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a crown front portion having one outer sheet and two inner sheets according to my new design with its shade in a spread position;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is another front perspective view of a crown front portion; and,

FIG. 6 is another rear perspective view of a crown front portion.

The broken lines in FIG. 1 through FIG. 4 are for the purpose of illustrating the stitching and form no part of the claimed design.

The long-segmented broken lines in FIGS. 5 and 6 are for the purpose of illustrating the environment in which the design is associated and form no part of the claimed design. The short-segmented broken lines illustrate stitching and form no part of the claimed design.

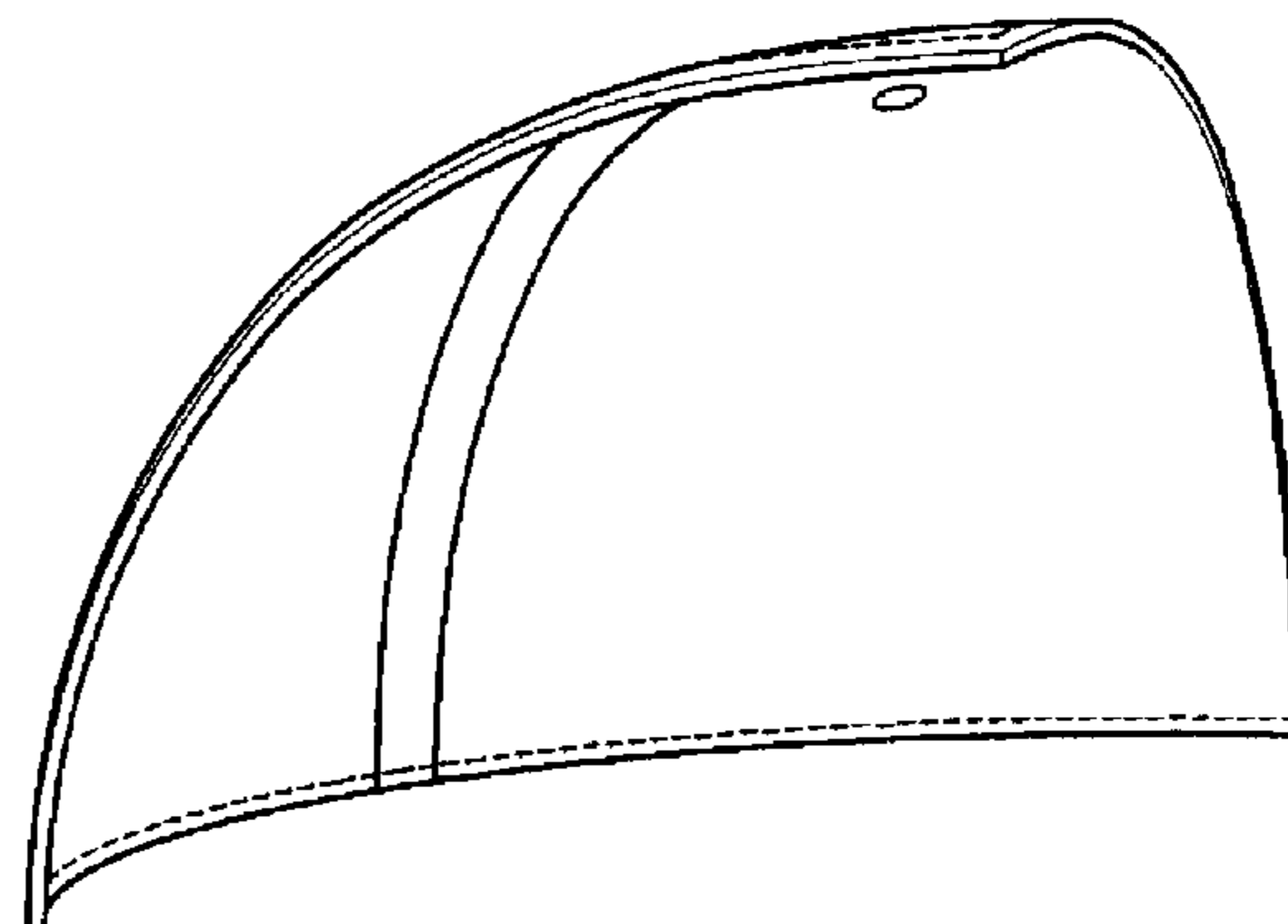
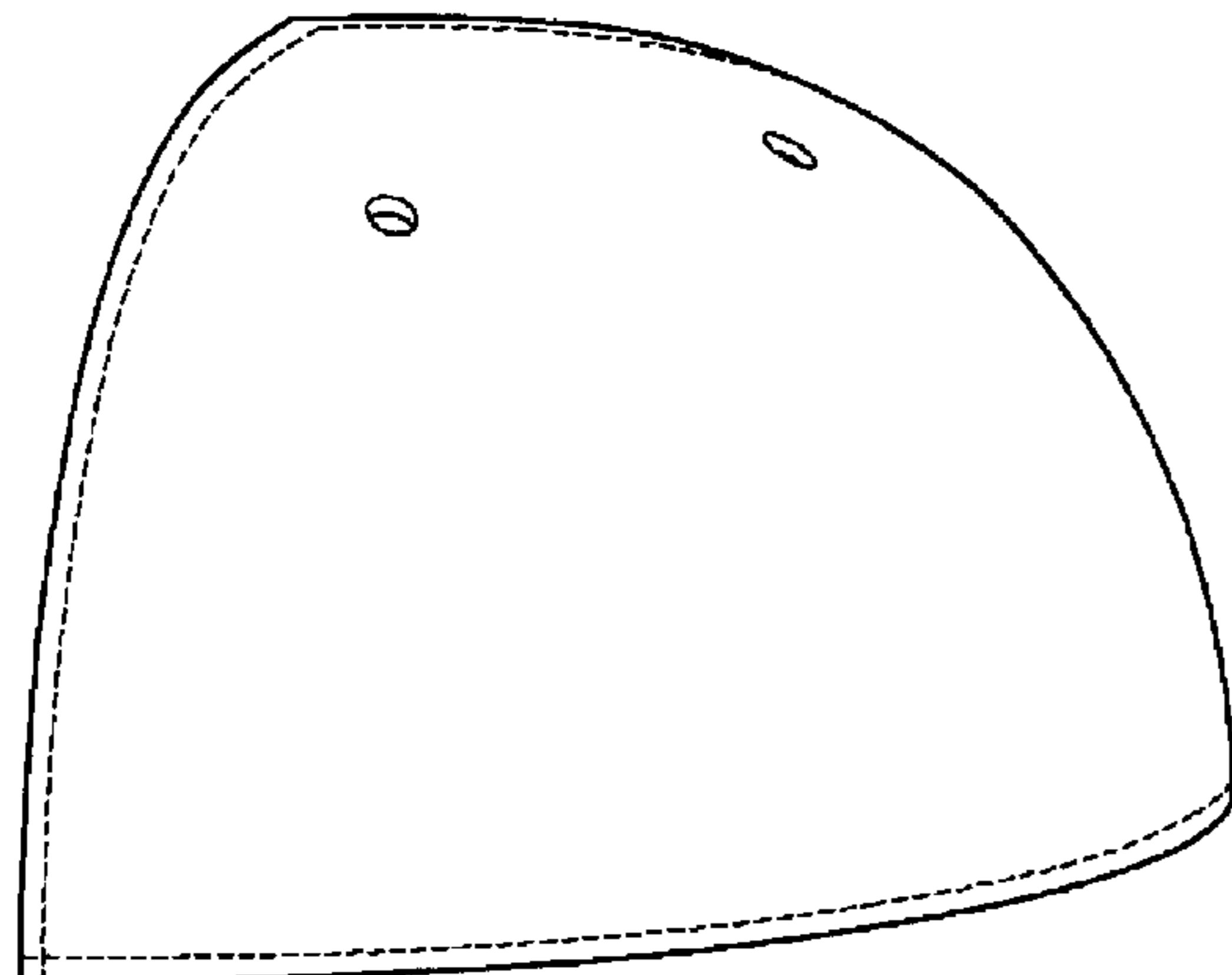

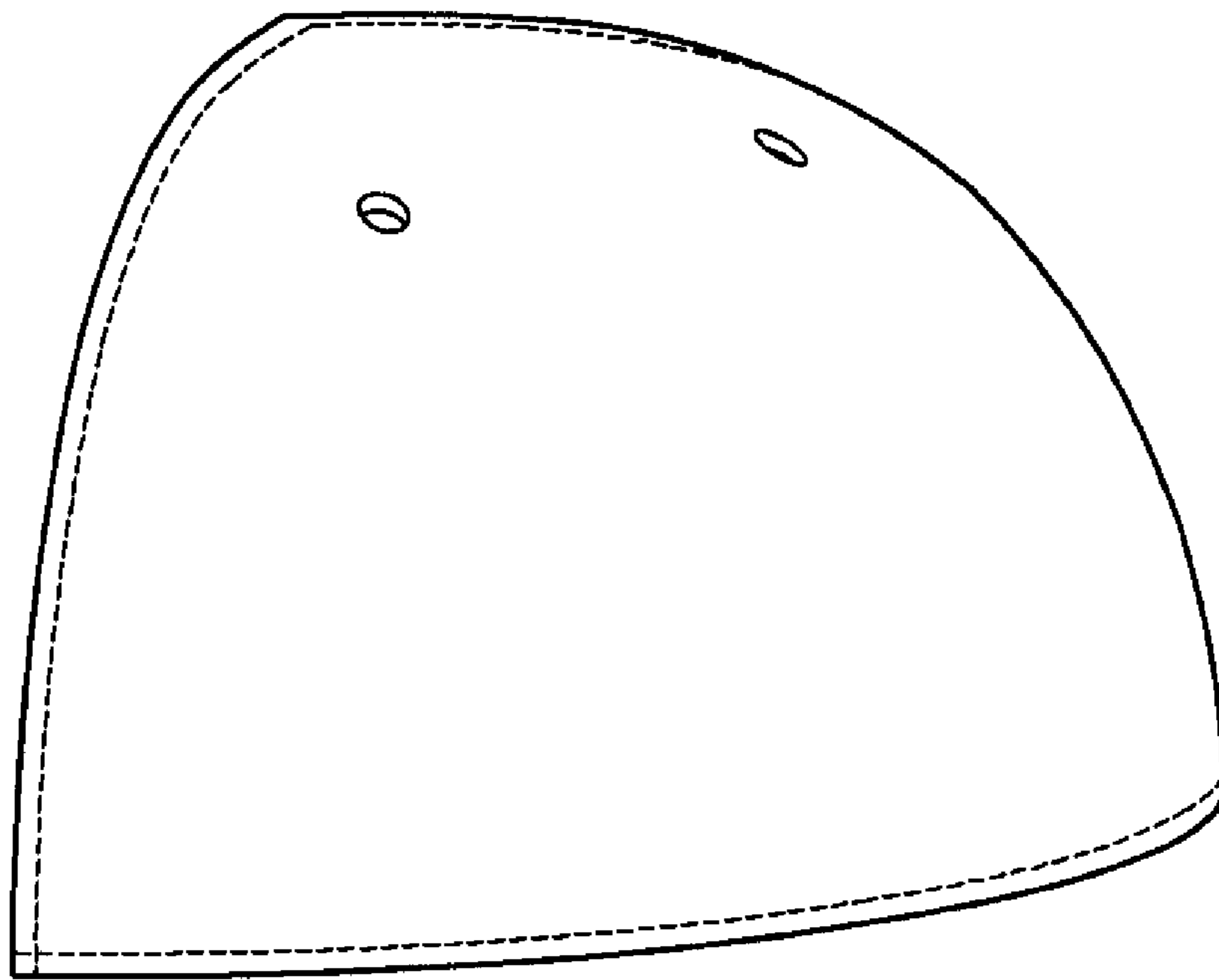

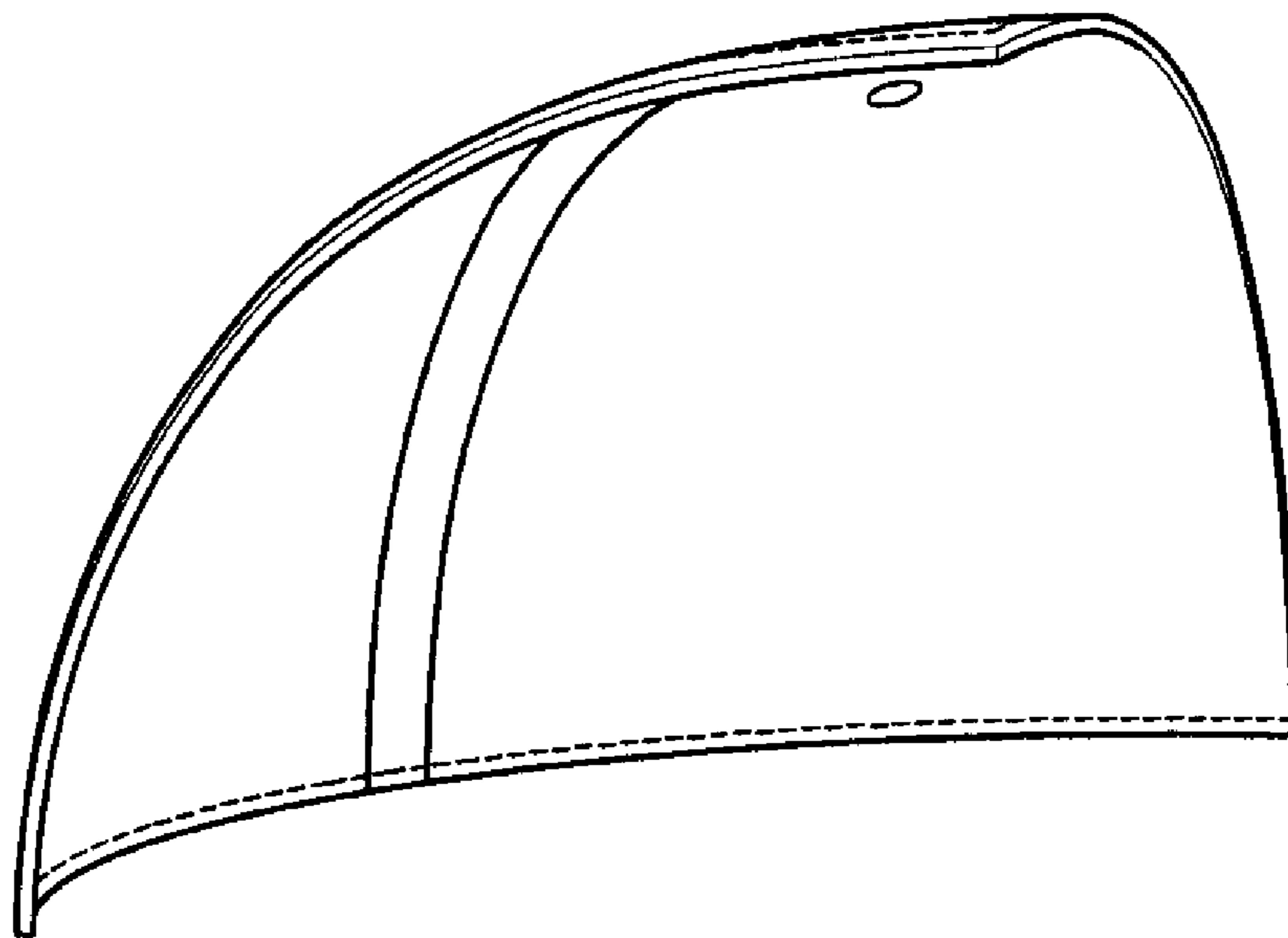

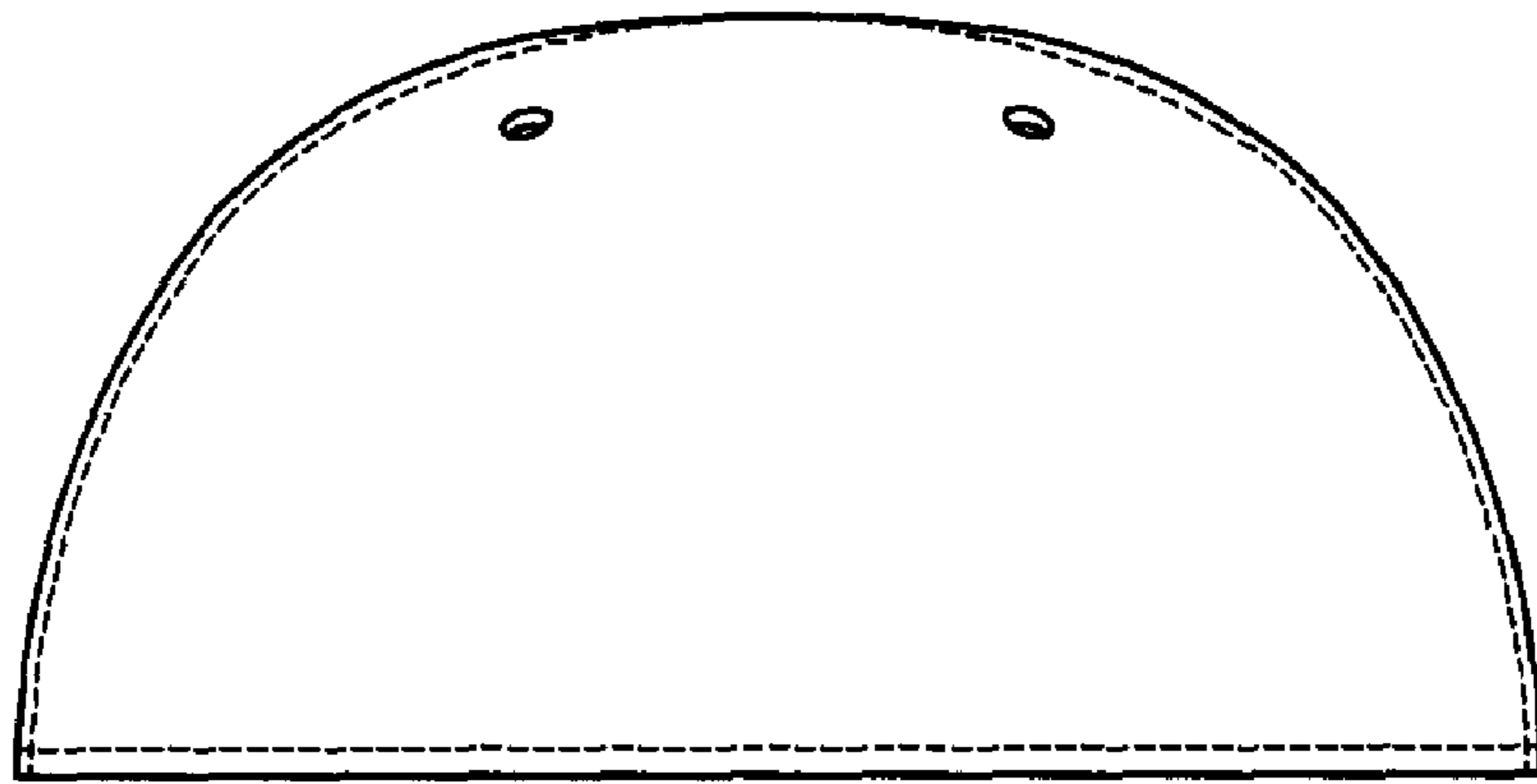

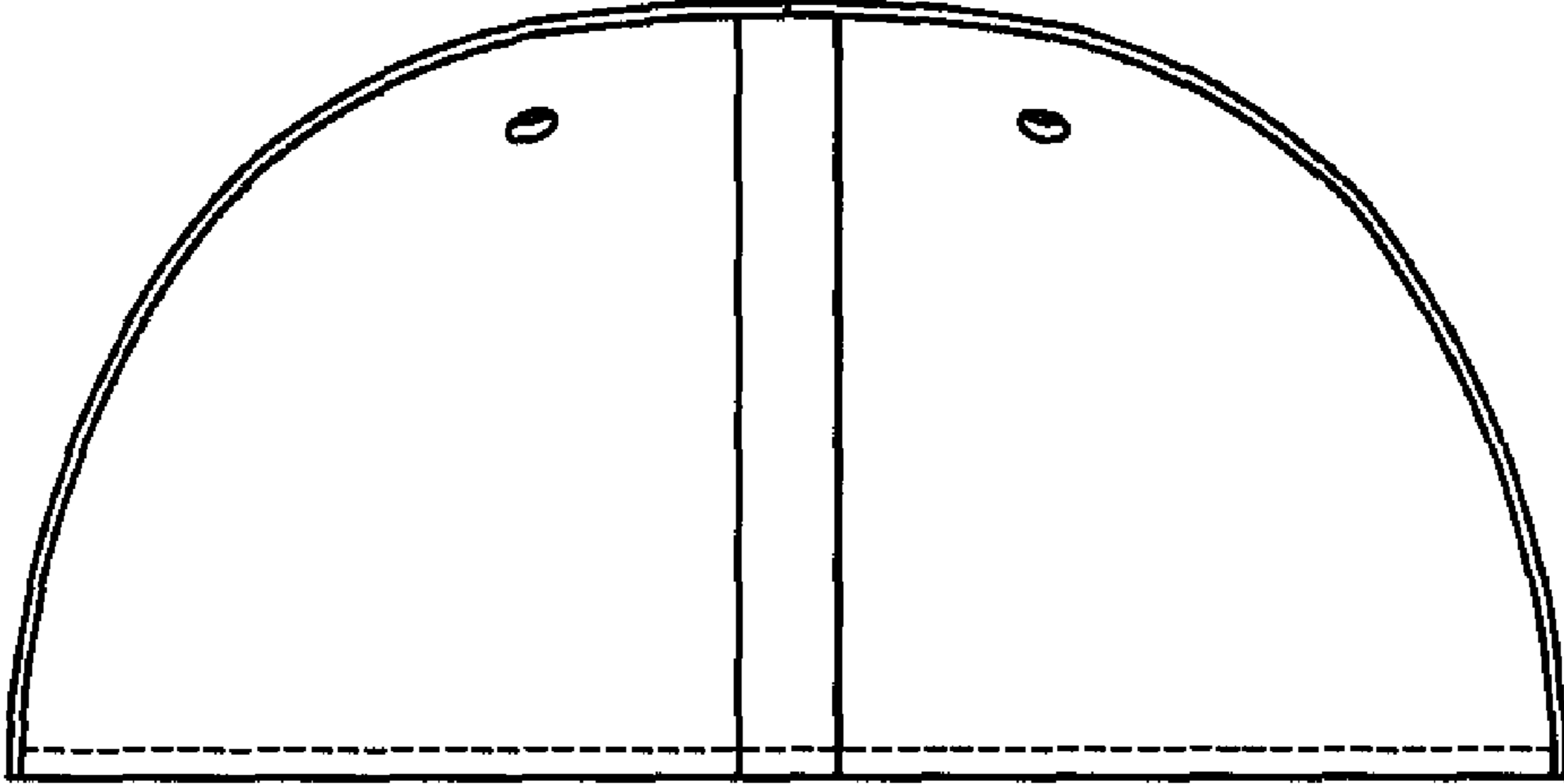

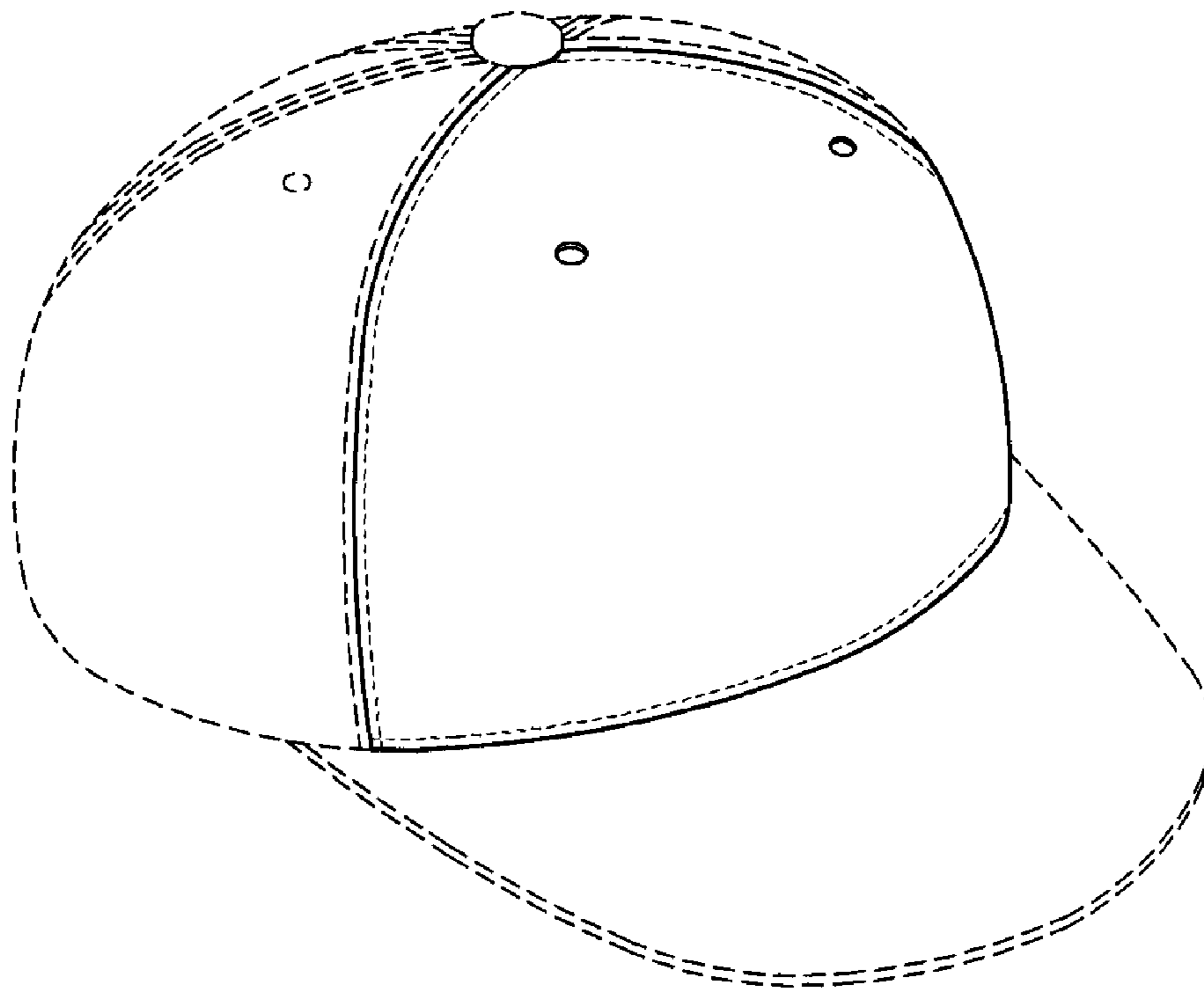
