(57) **CLAIM**

The ornamental design for a portion of a toothbrush handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the embodiment of a portion of a toothbrush handle, showing my new design;

FIG. 4 is a left-side view thereof;

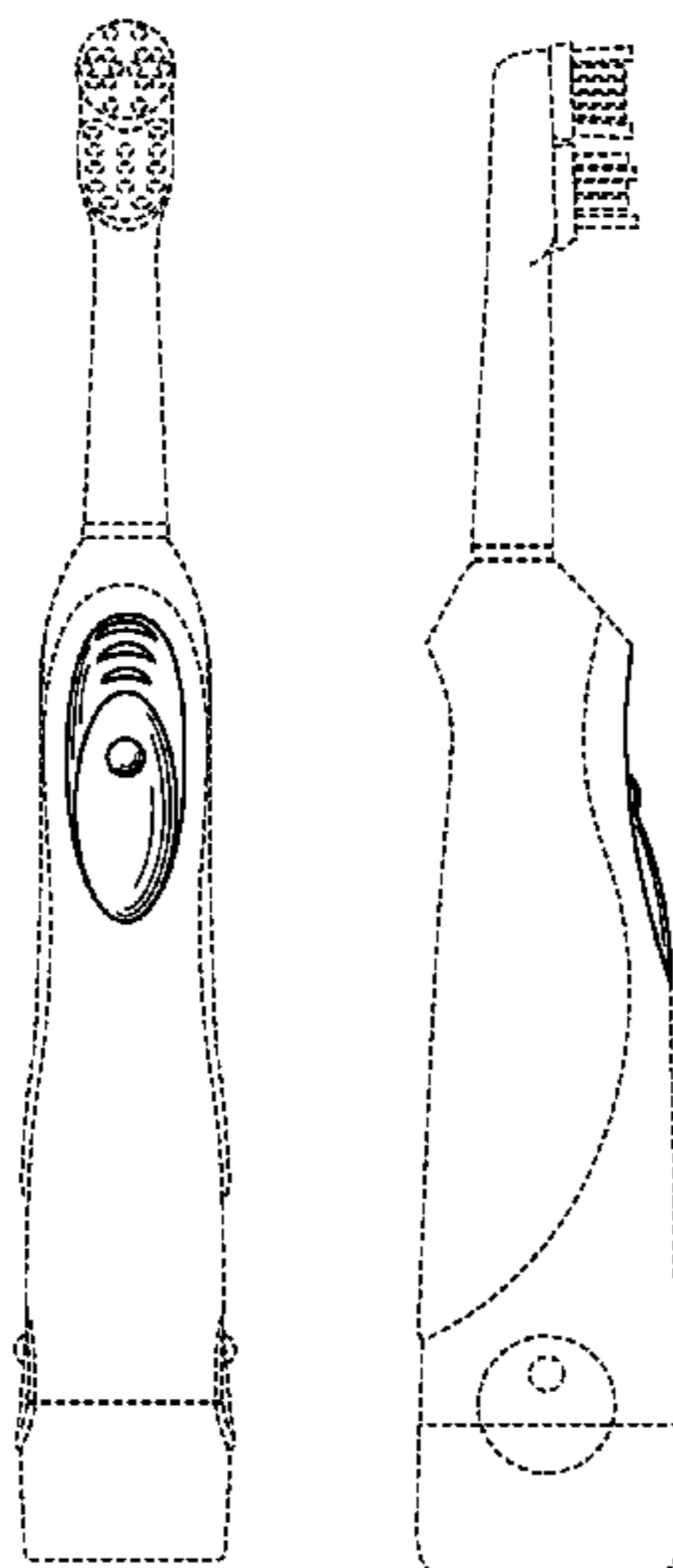
FIG. 5 is a right-side view thereof;

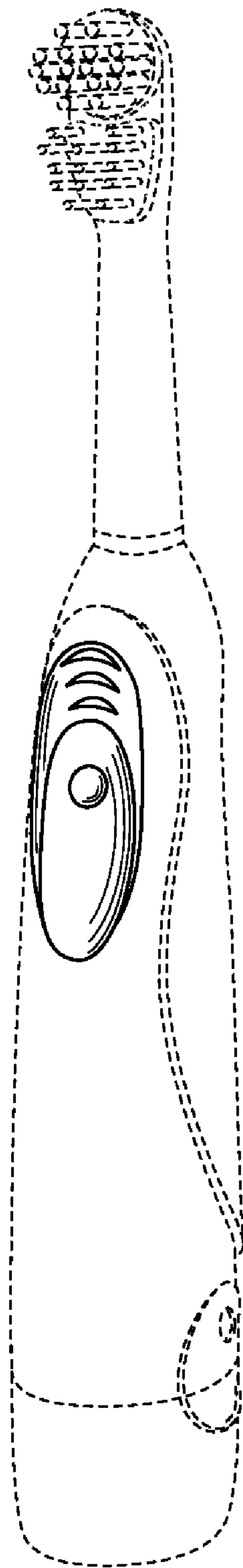

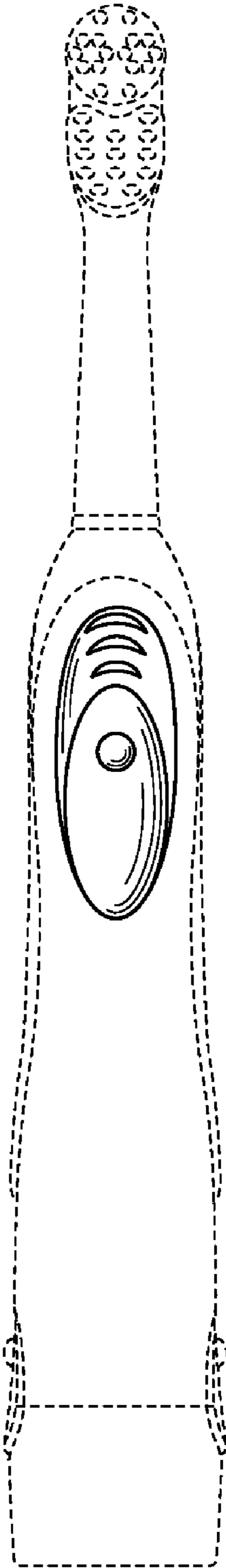

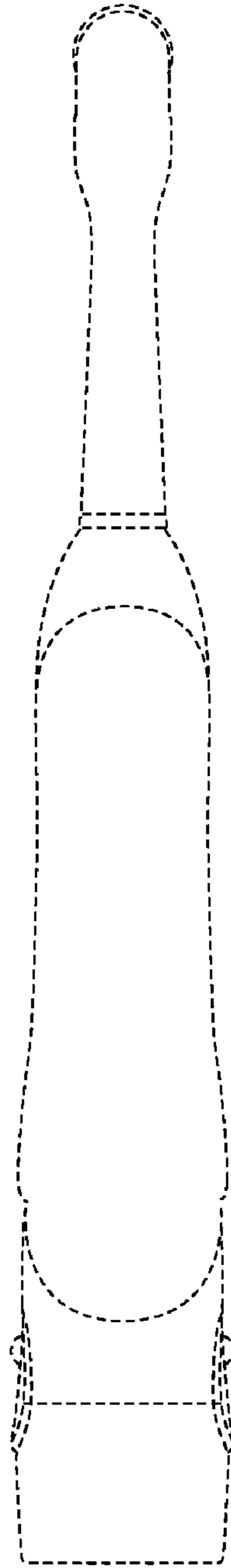

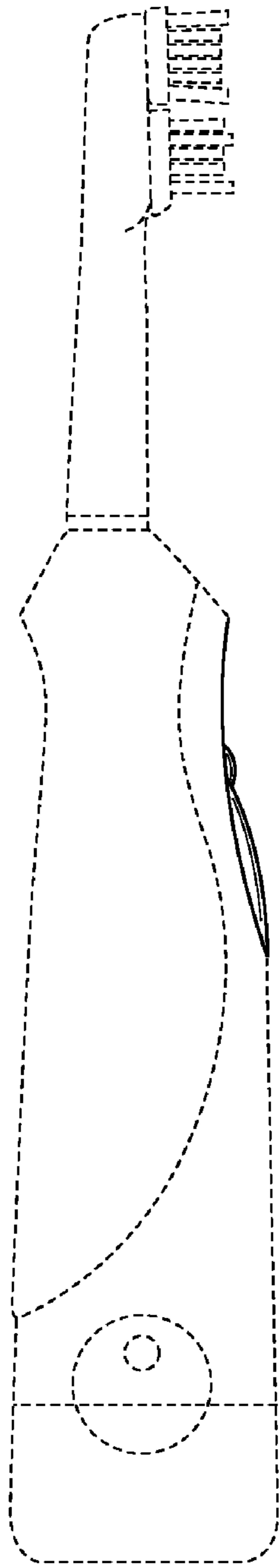

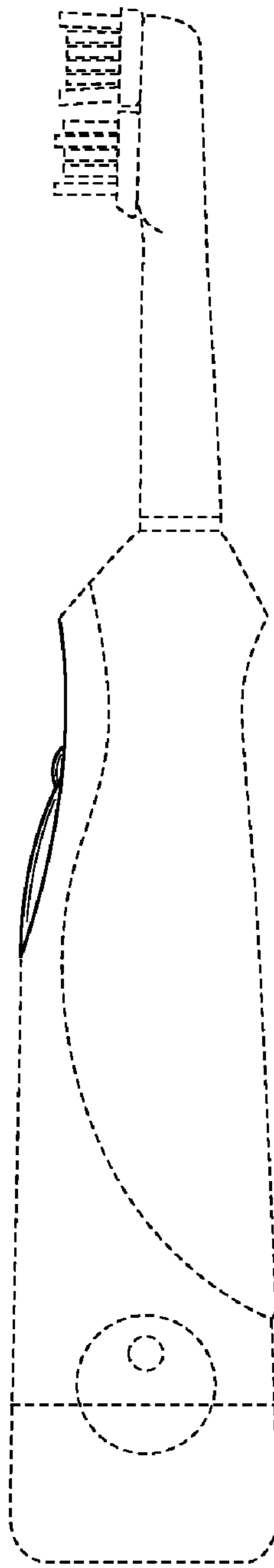

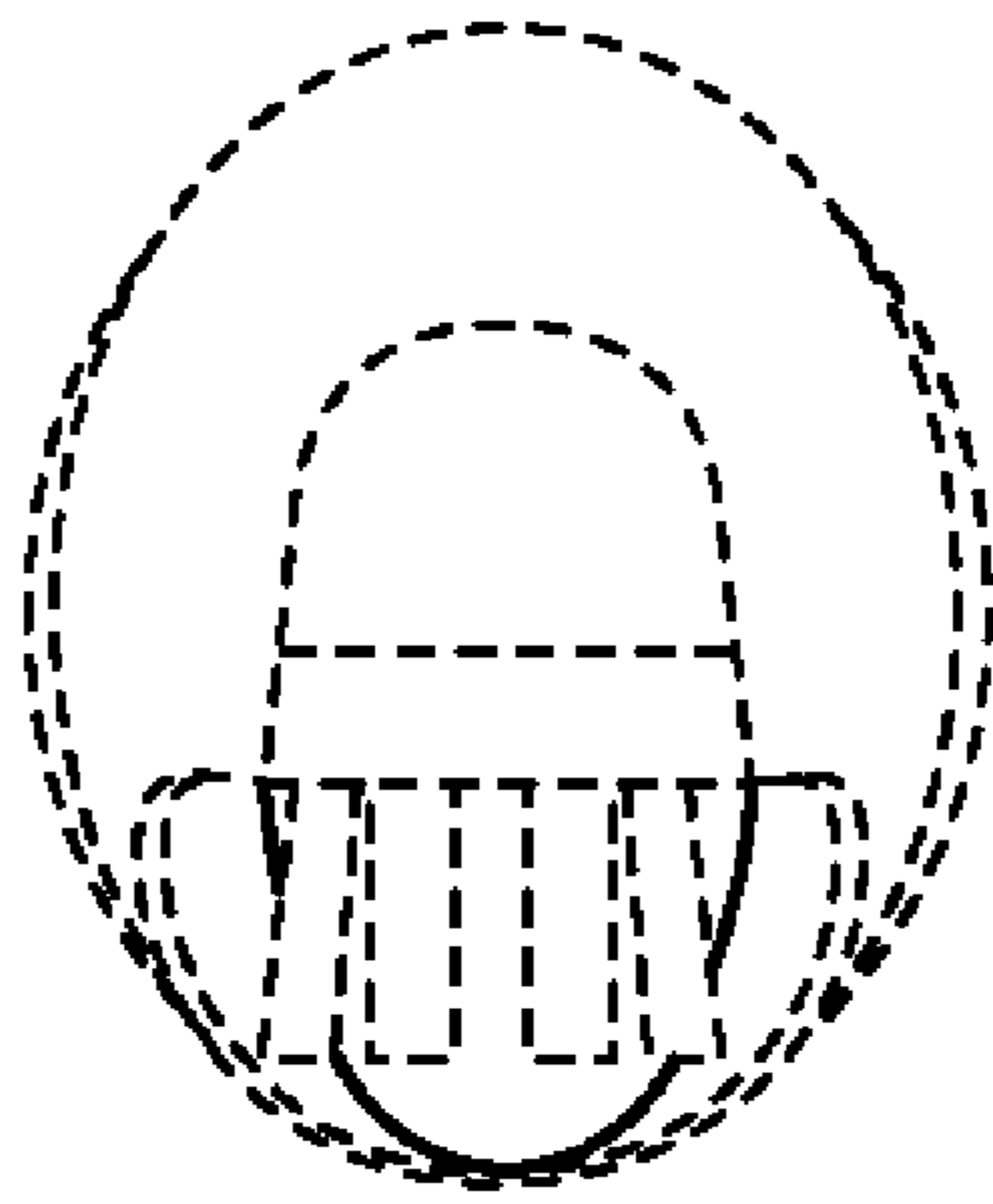

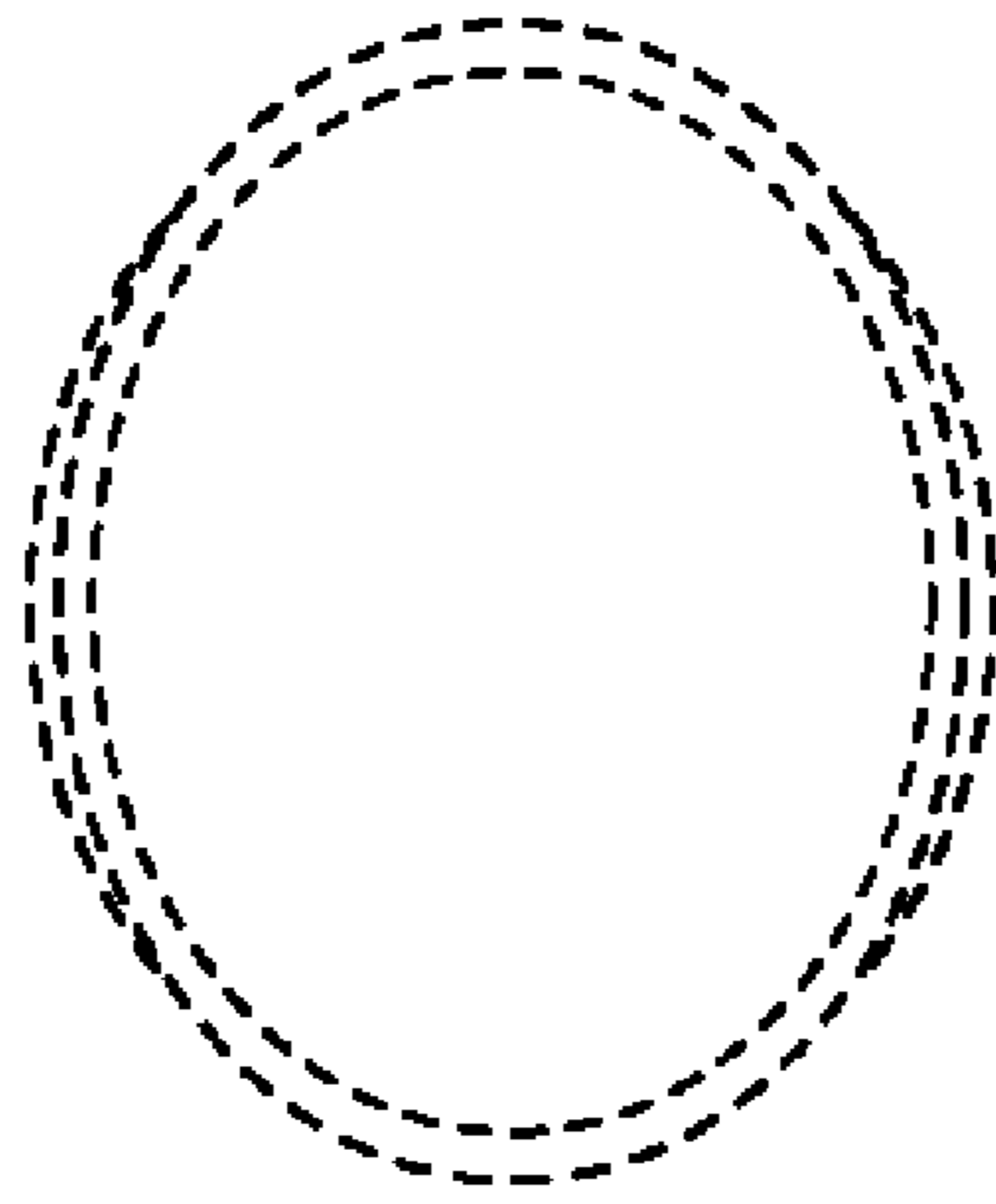
