FIG. 5 is a bottom view thereof;

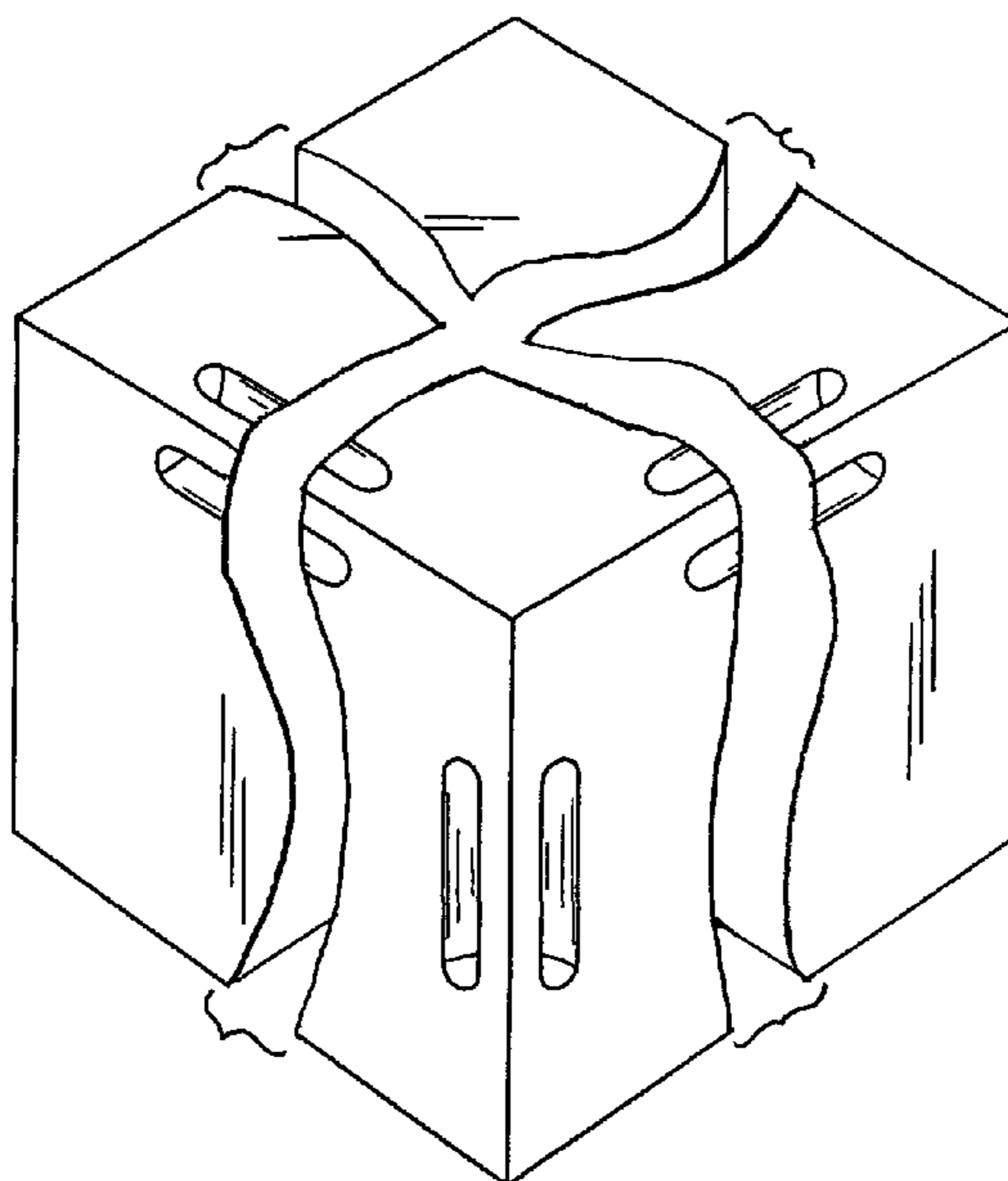
FIG. 6 is a left side view thereof;

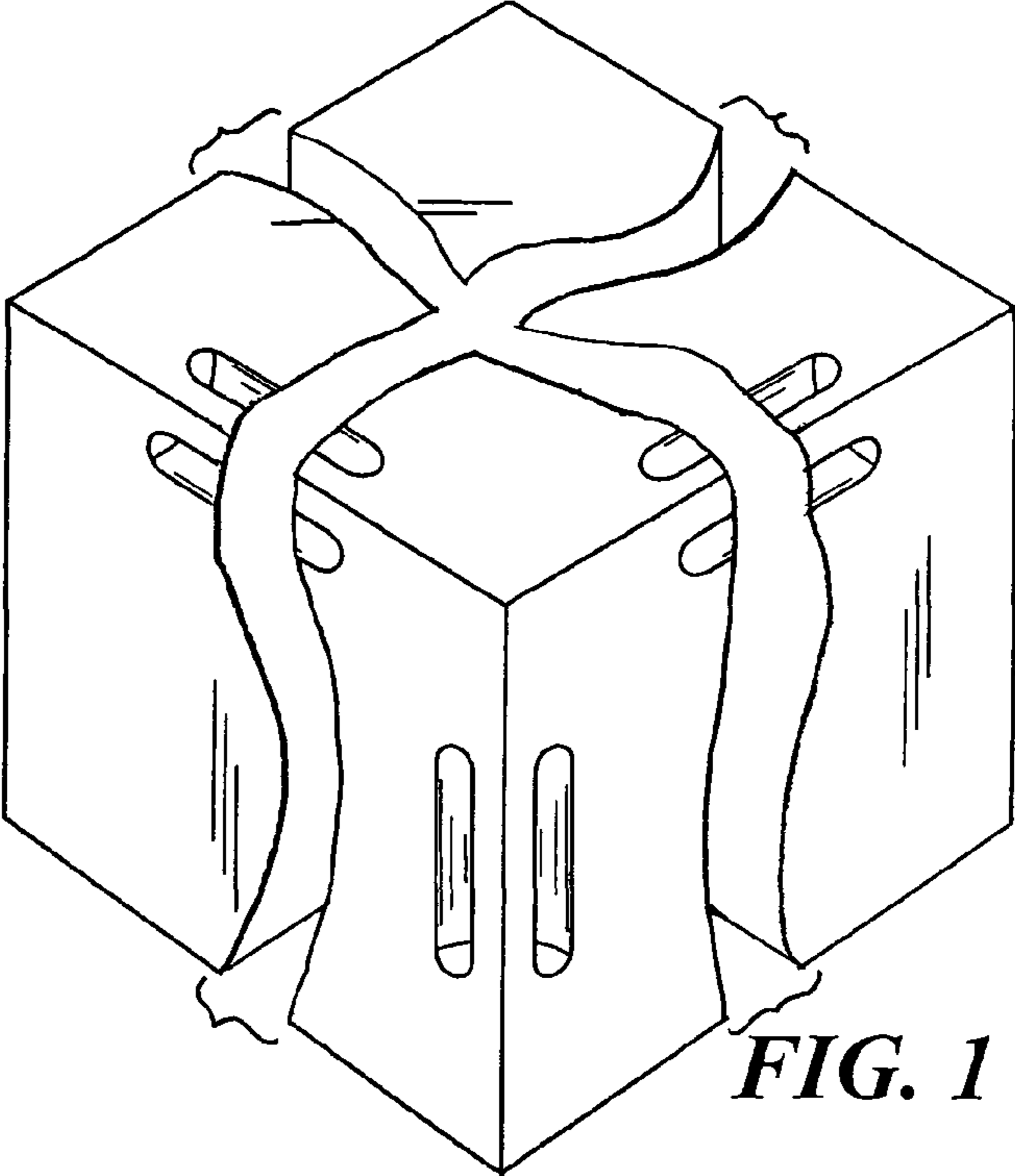
FIG. 7 is a right side view thereof; and,

FIG. 8 is a rear view thereof.

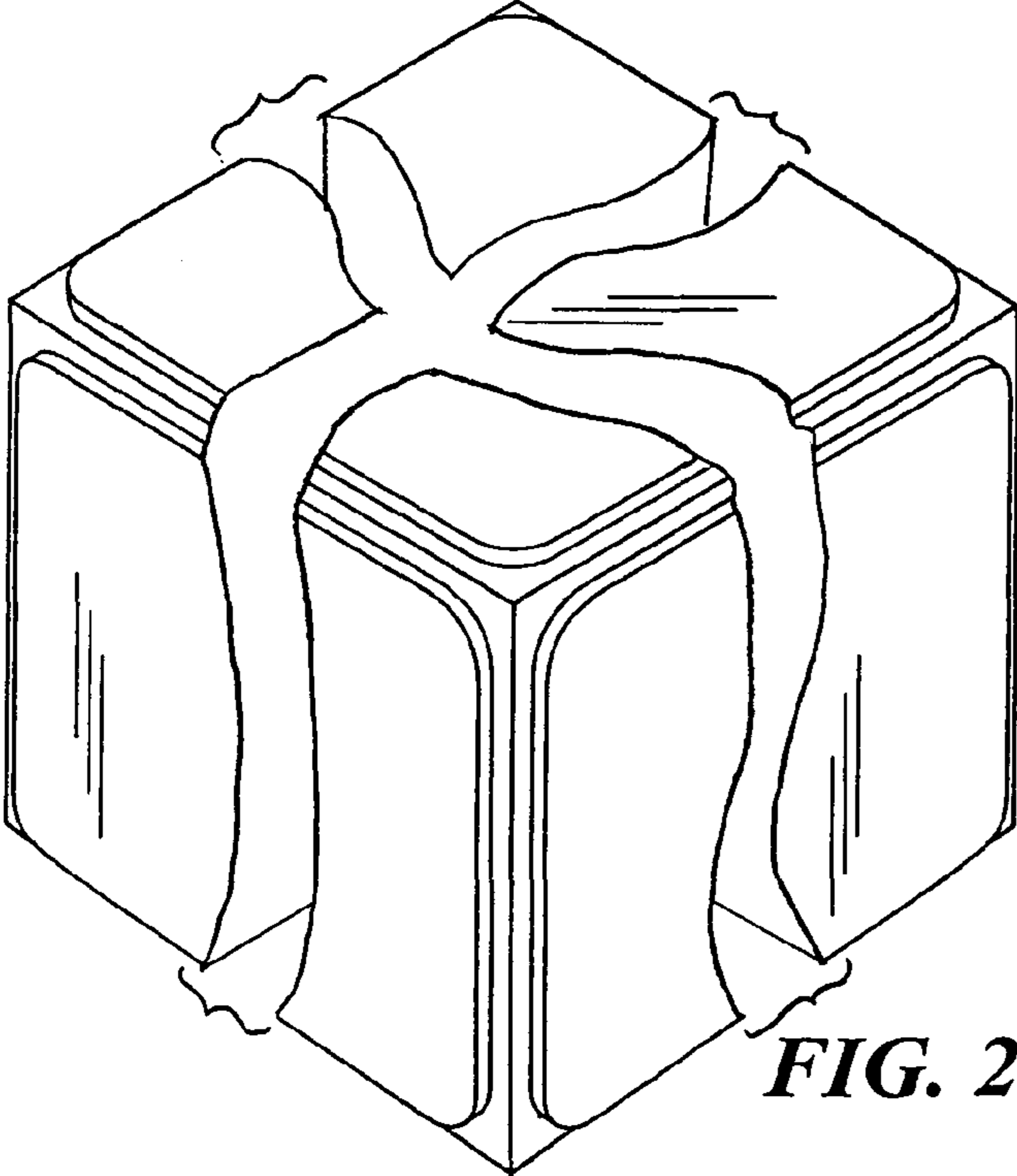
It is understood that the broken-away portions shown in the drawings represent indeterminate length/width/height.

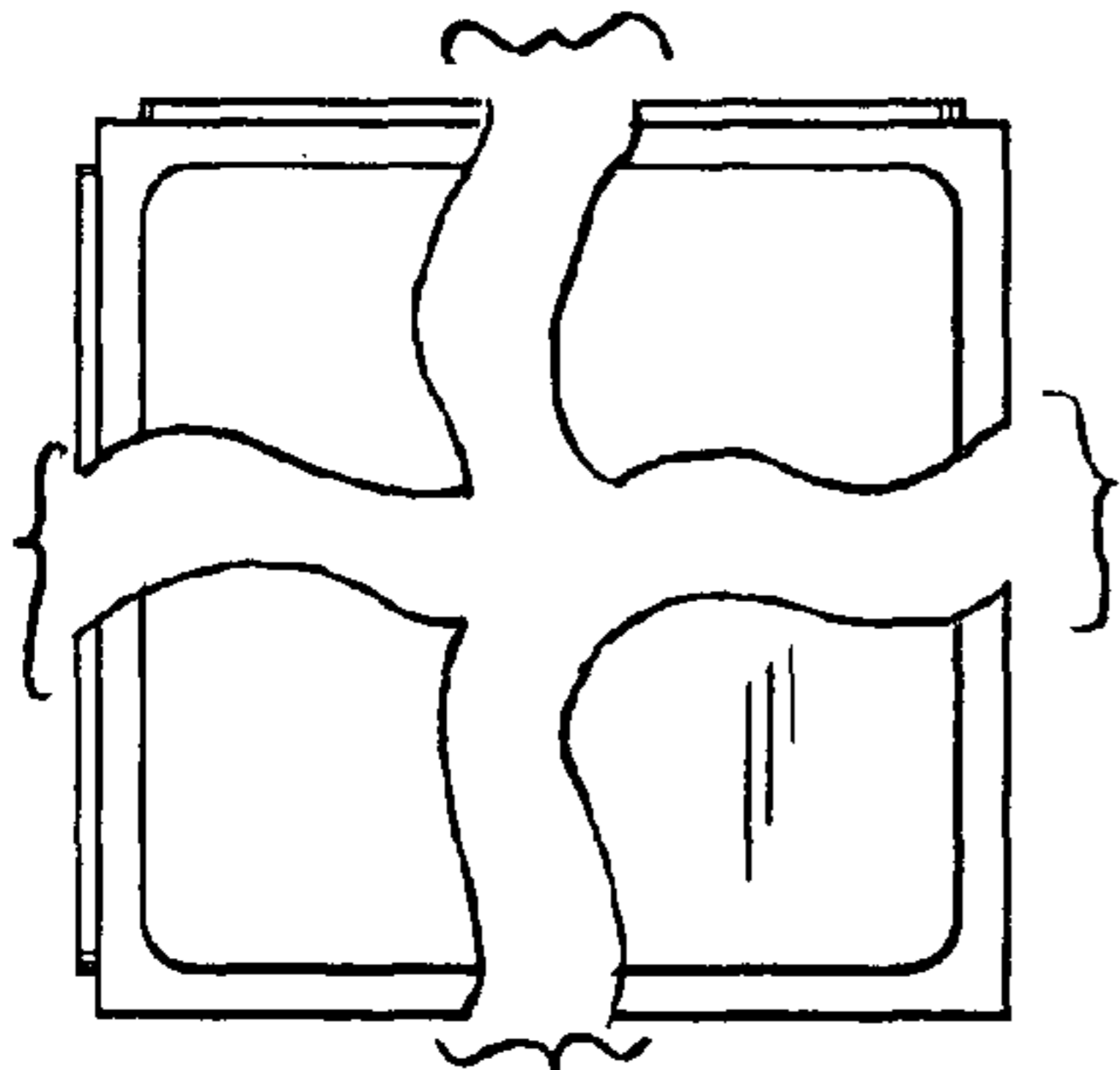




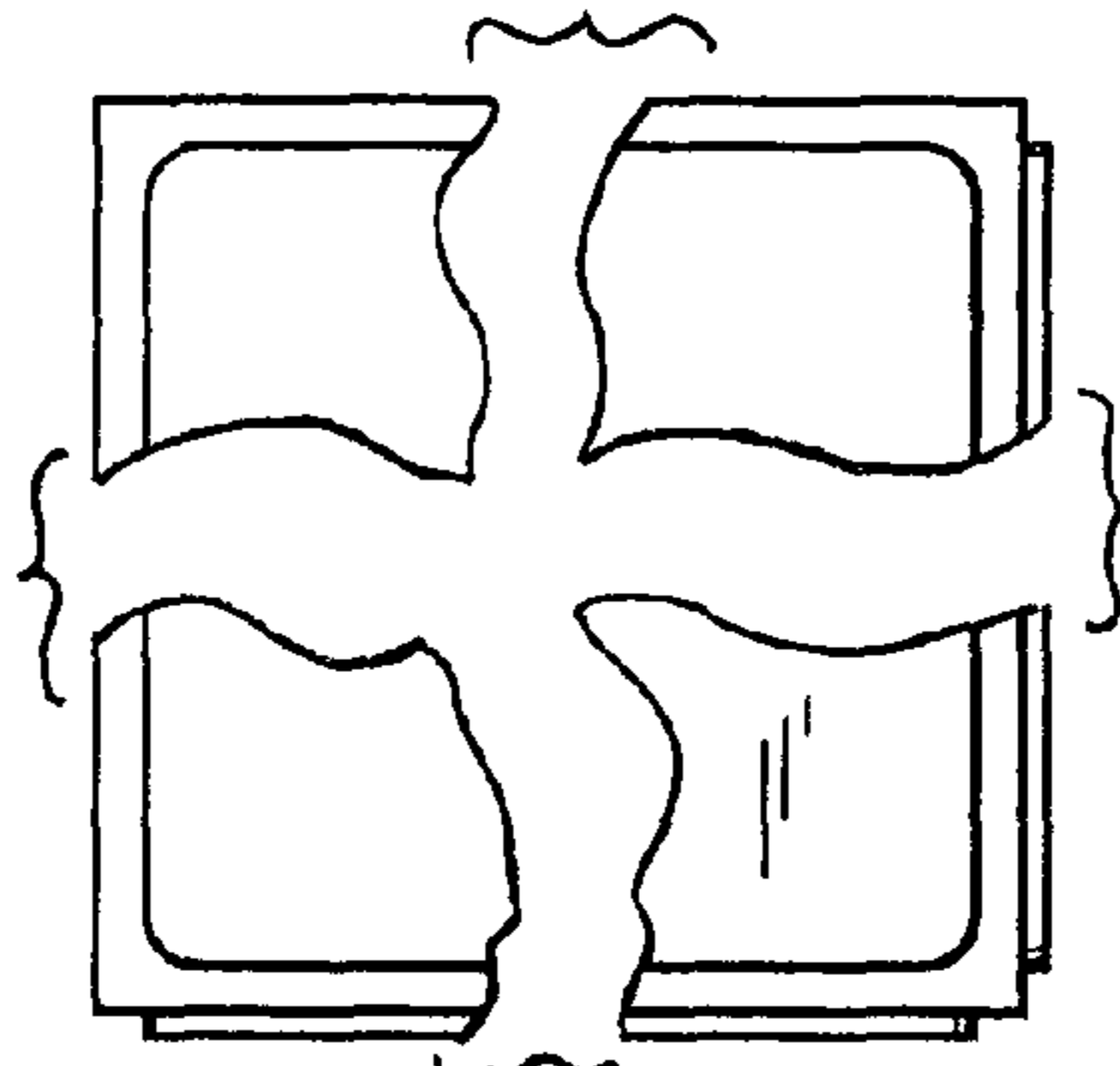

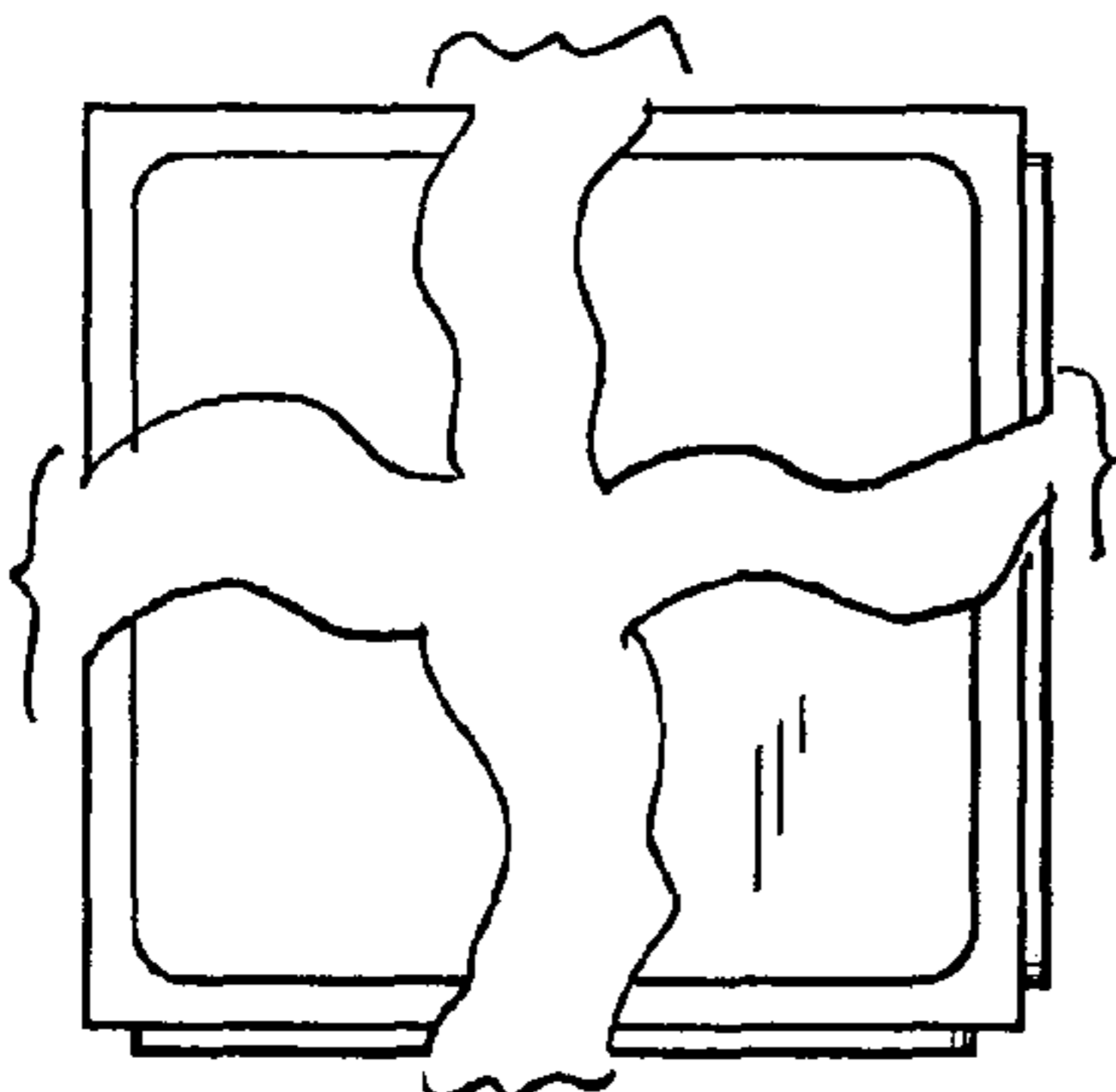

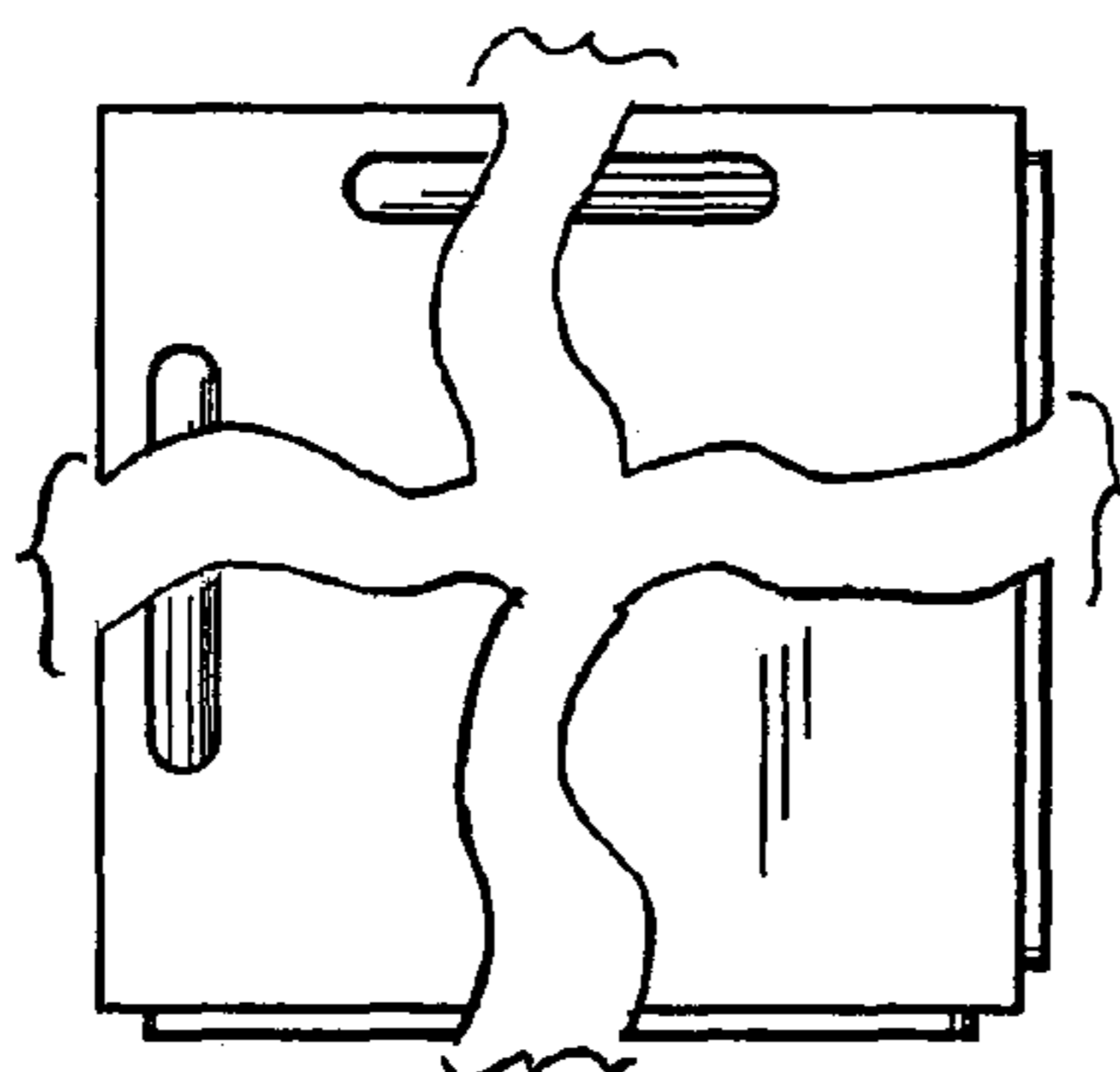

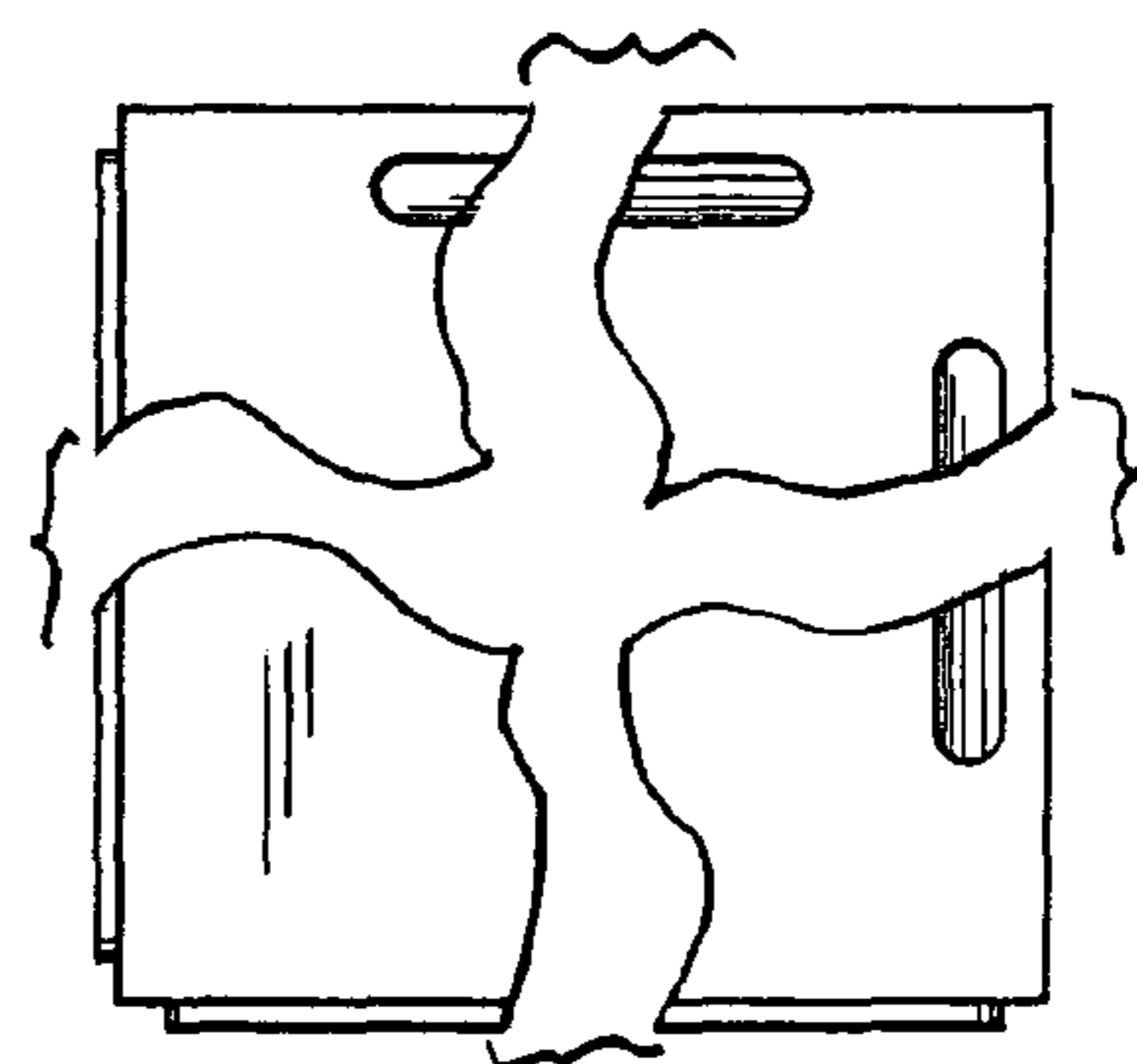

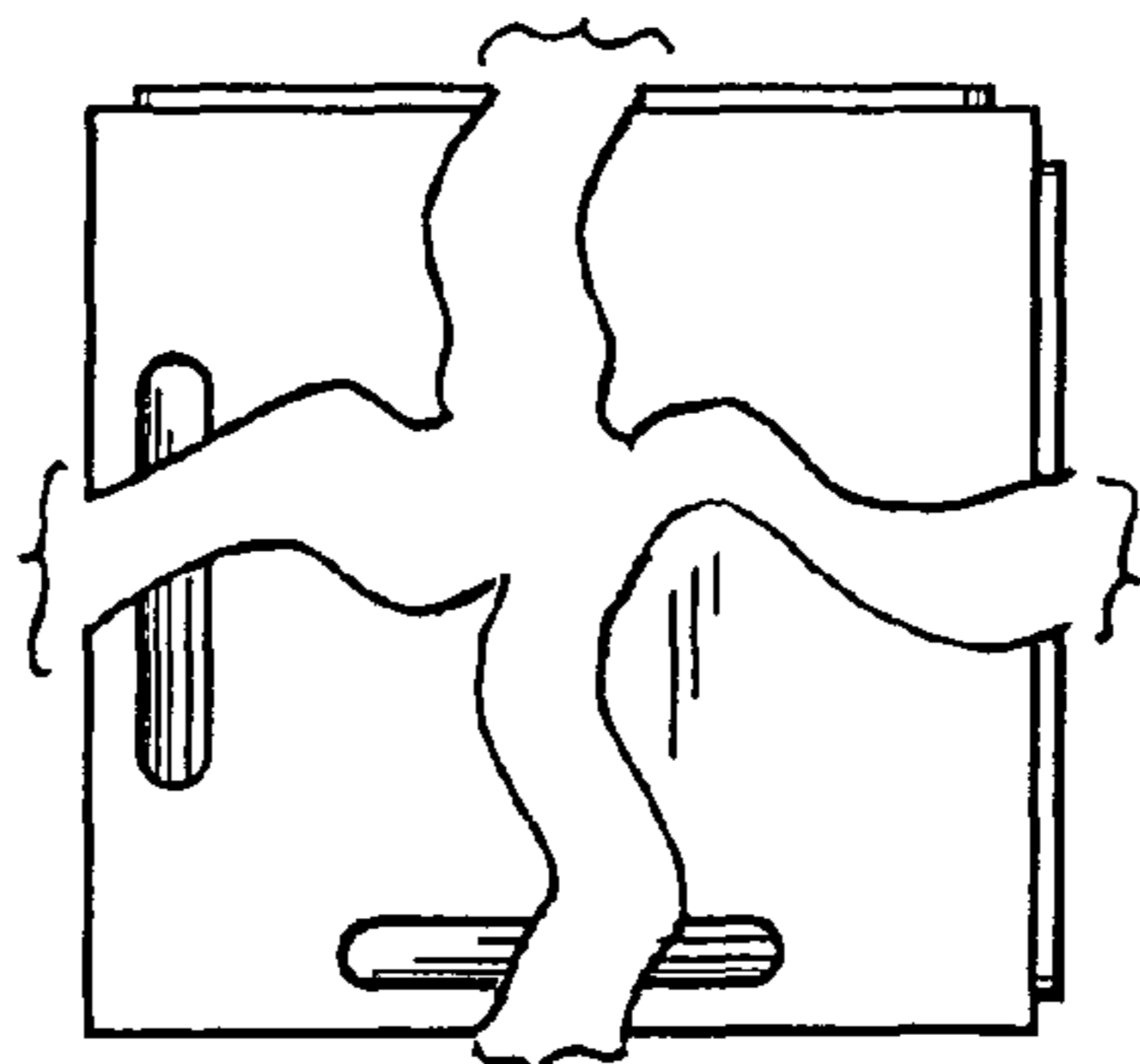
