opener;

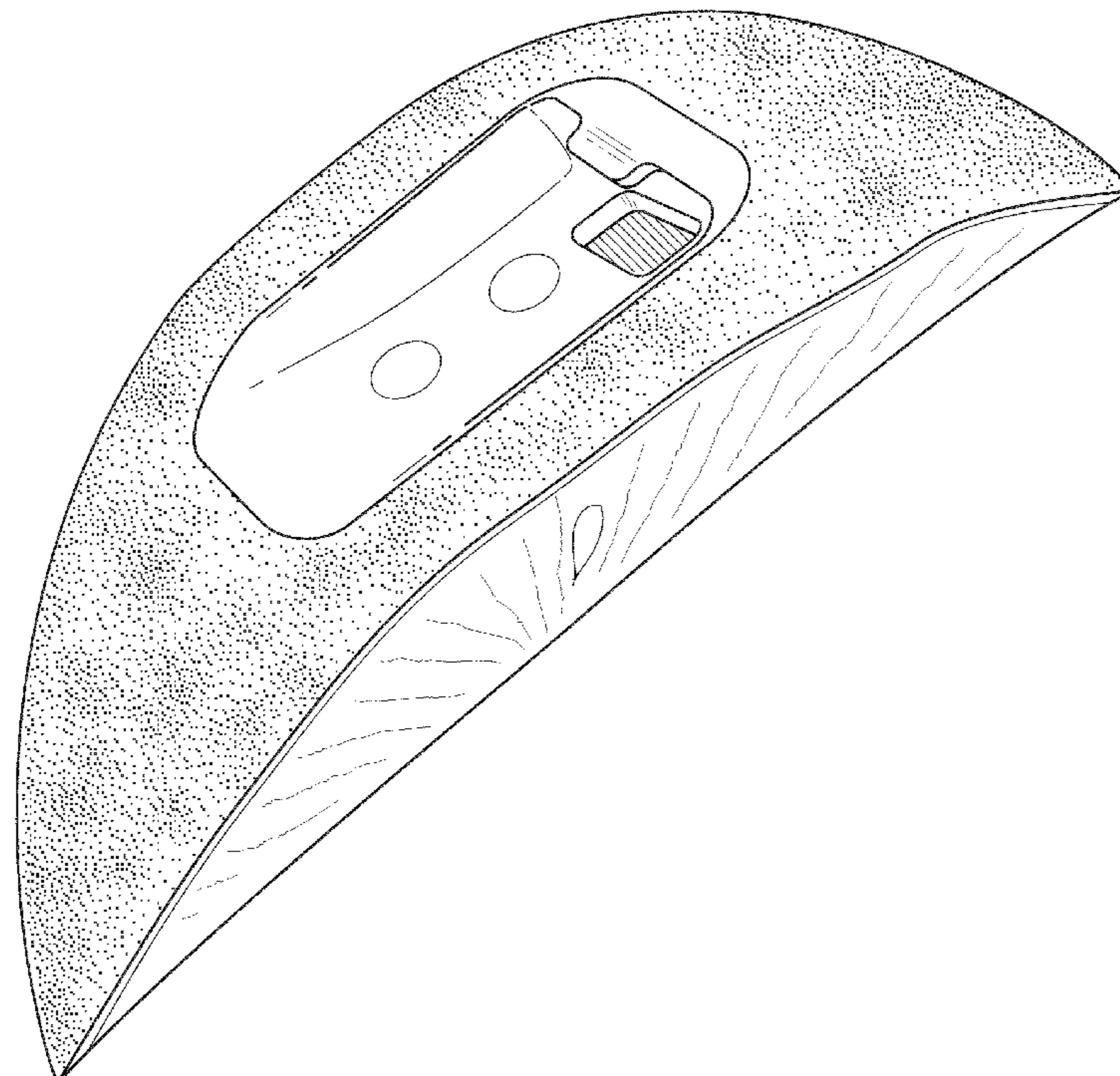
FIG. 4 is a right side view of the fruit wedge shaped bottle

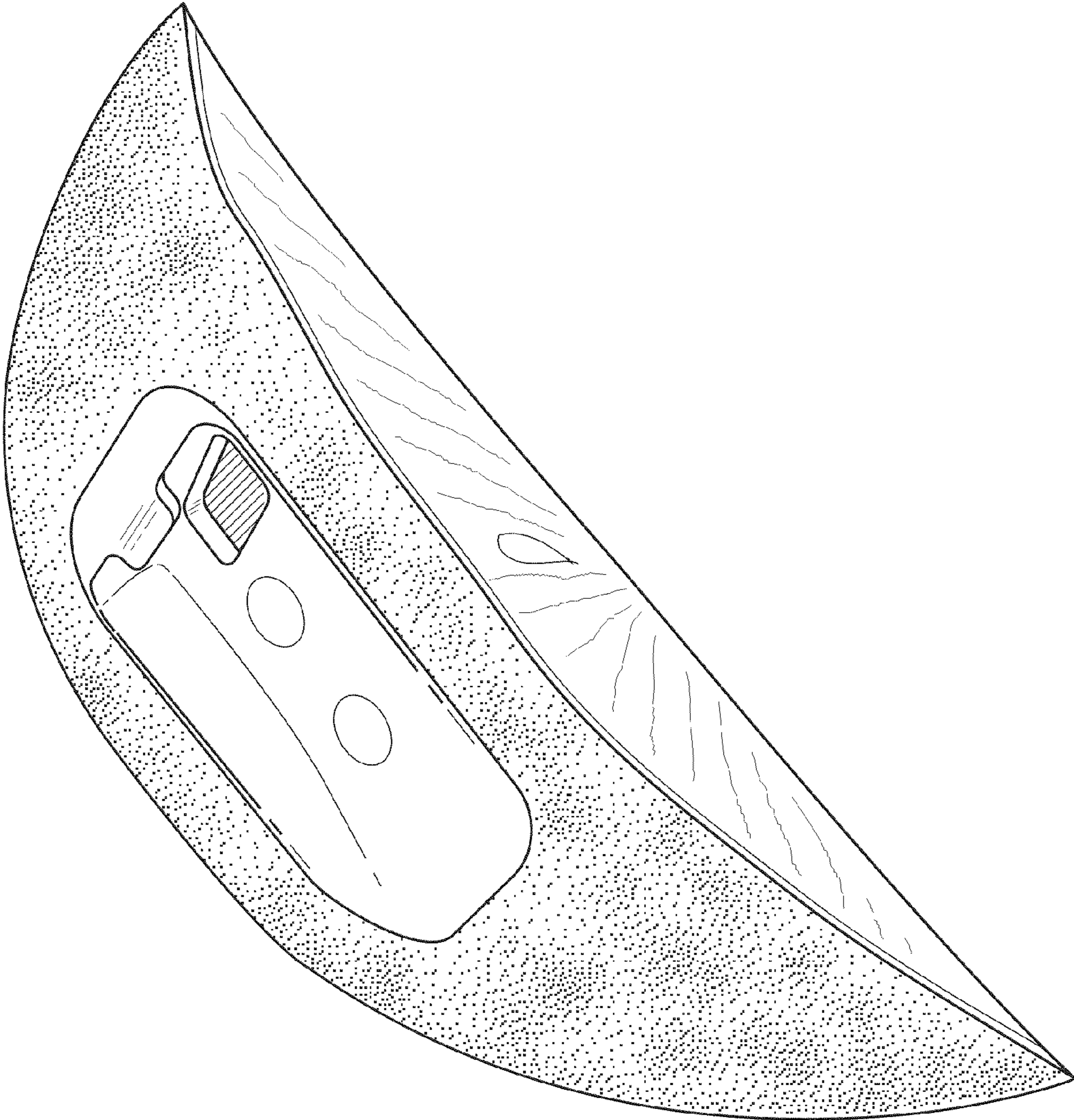

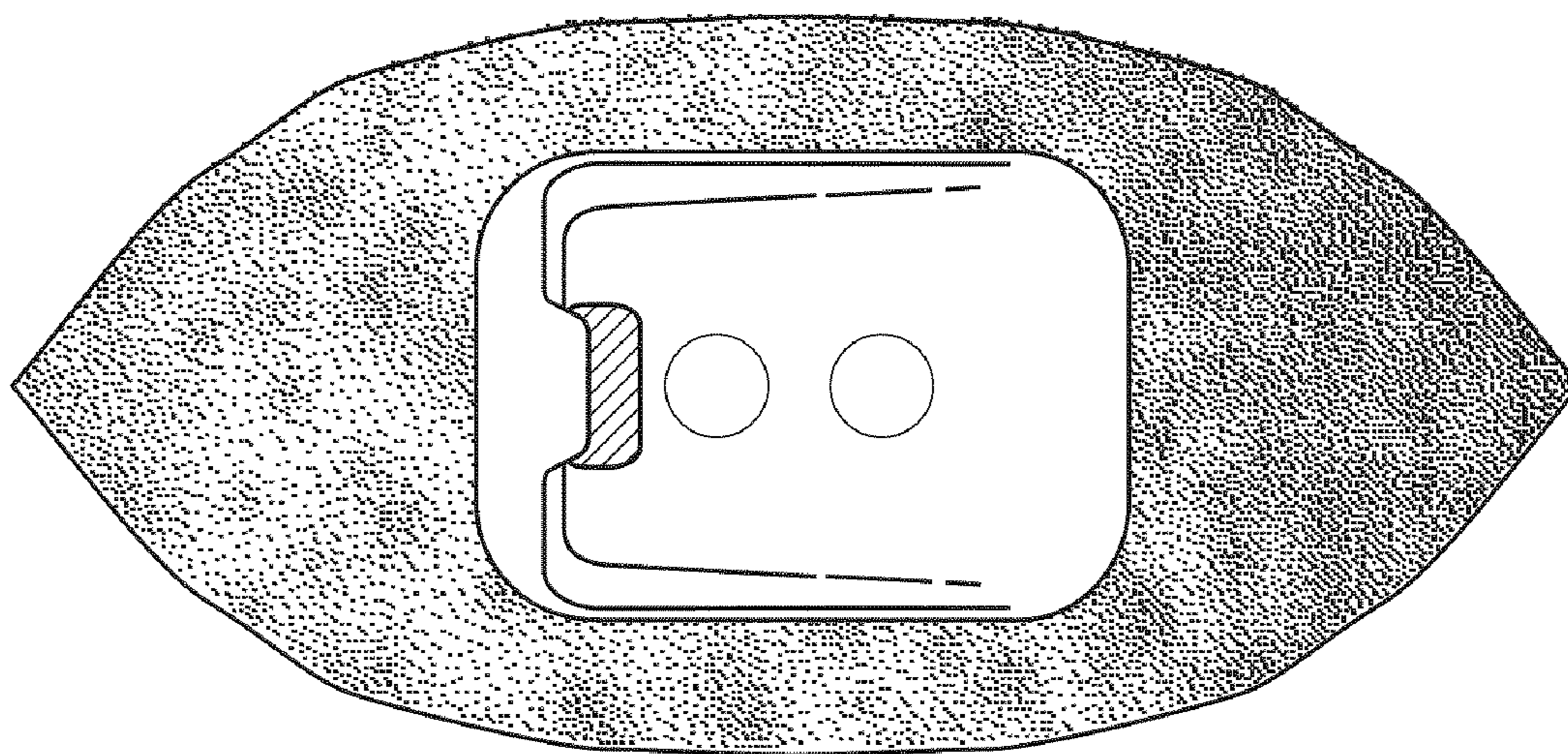

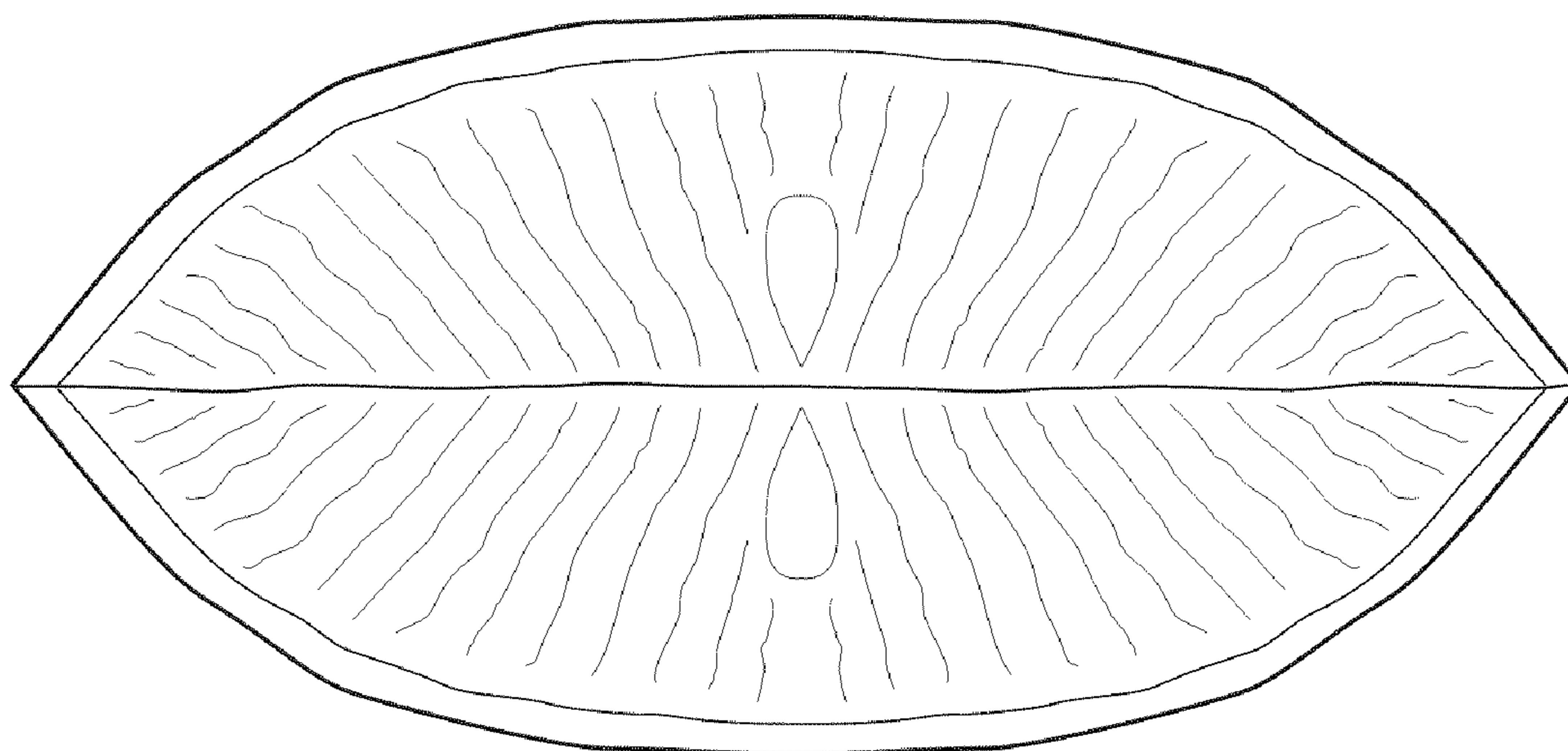

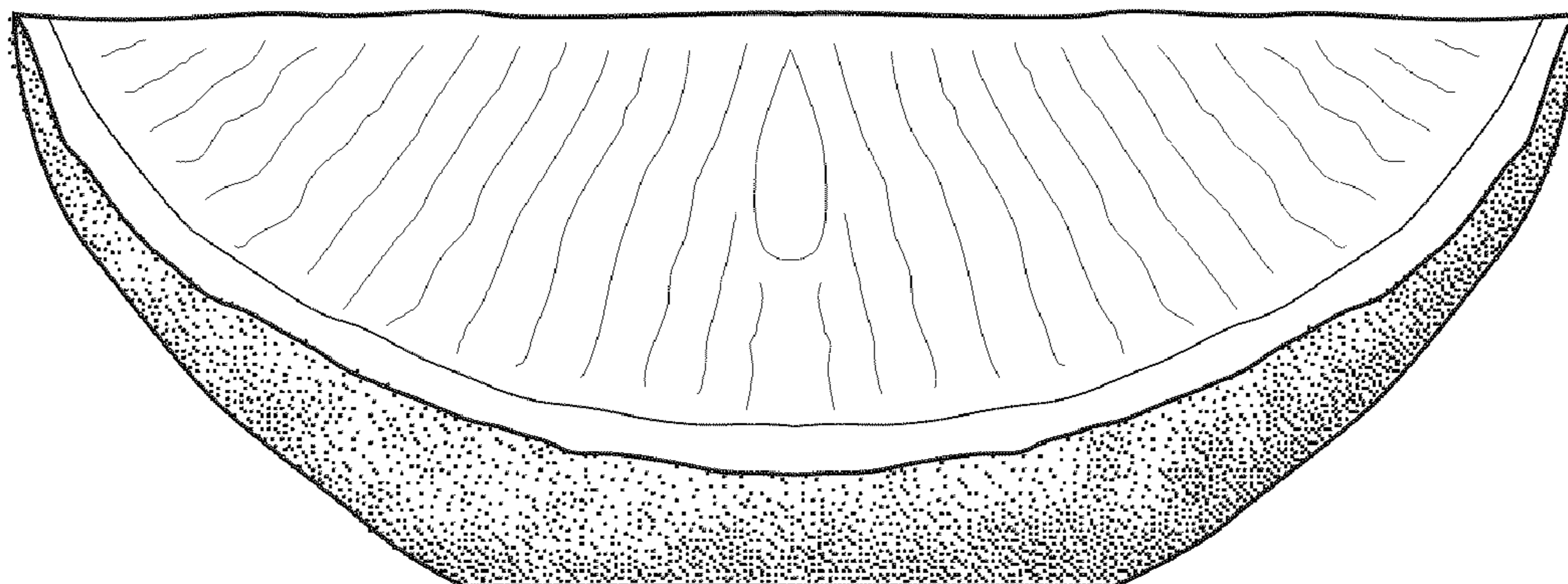

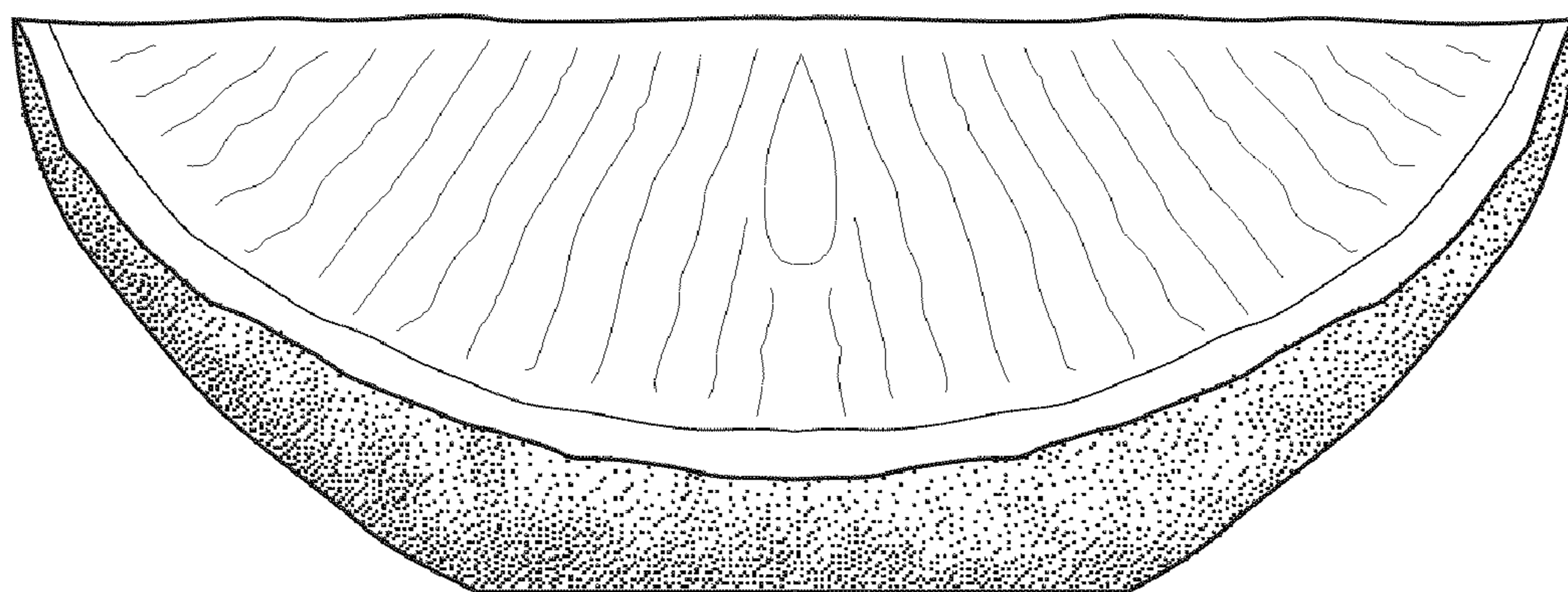

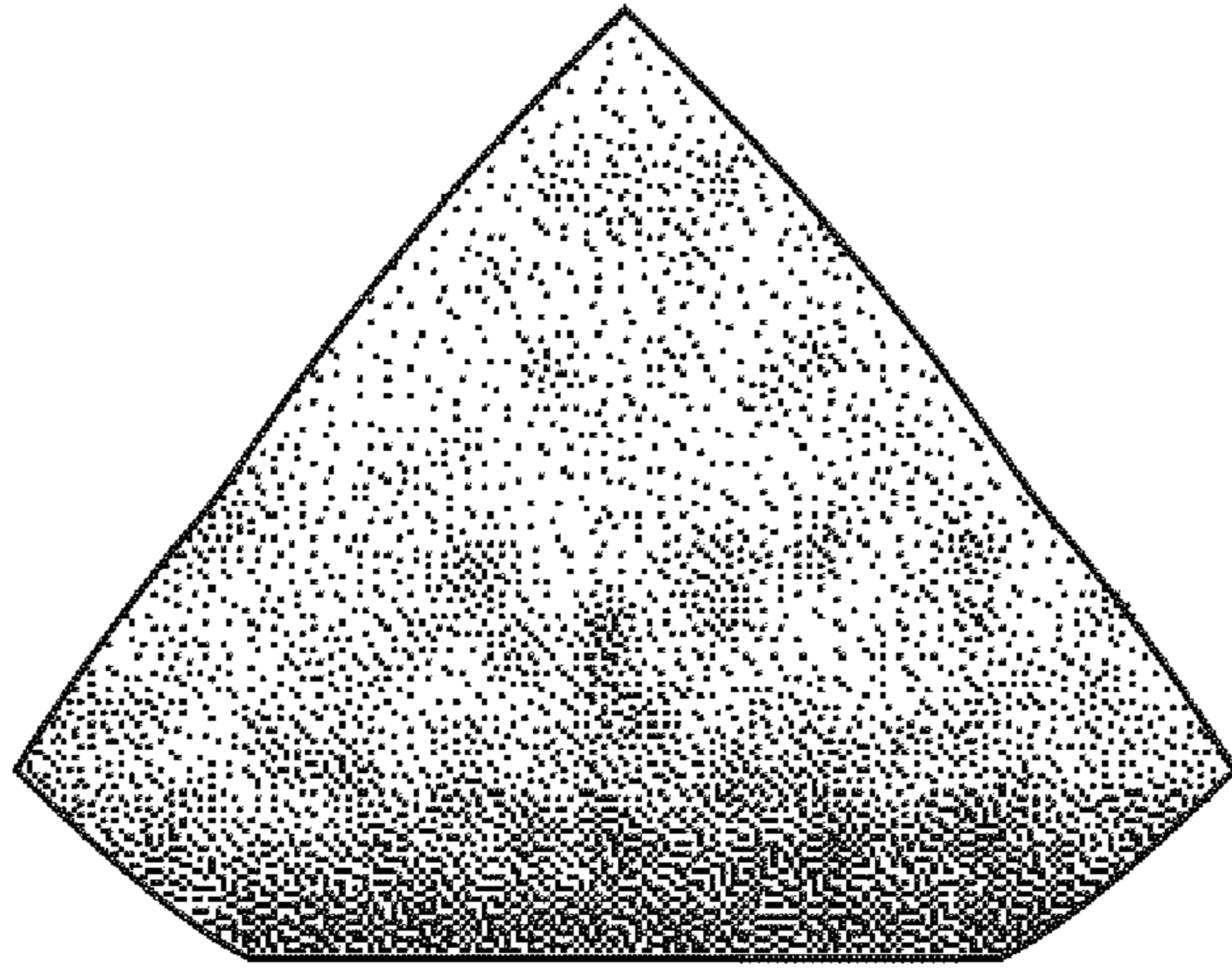

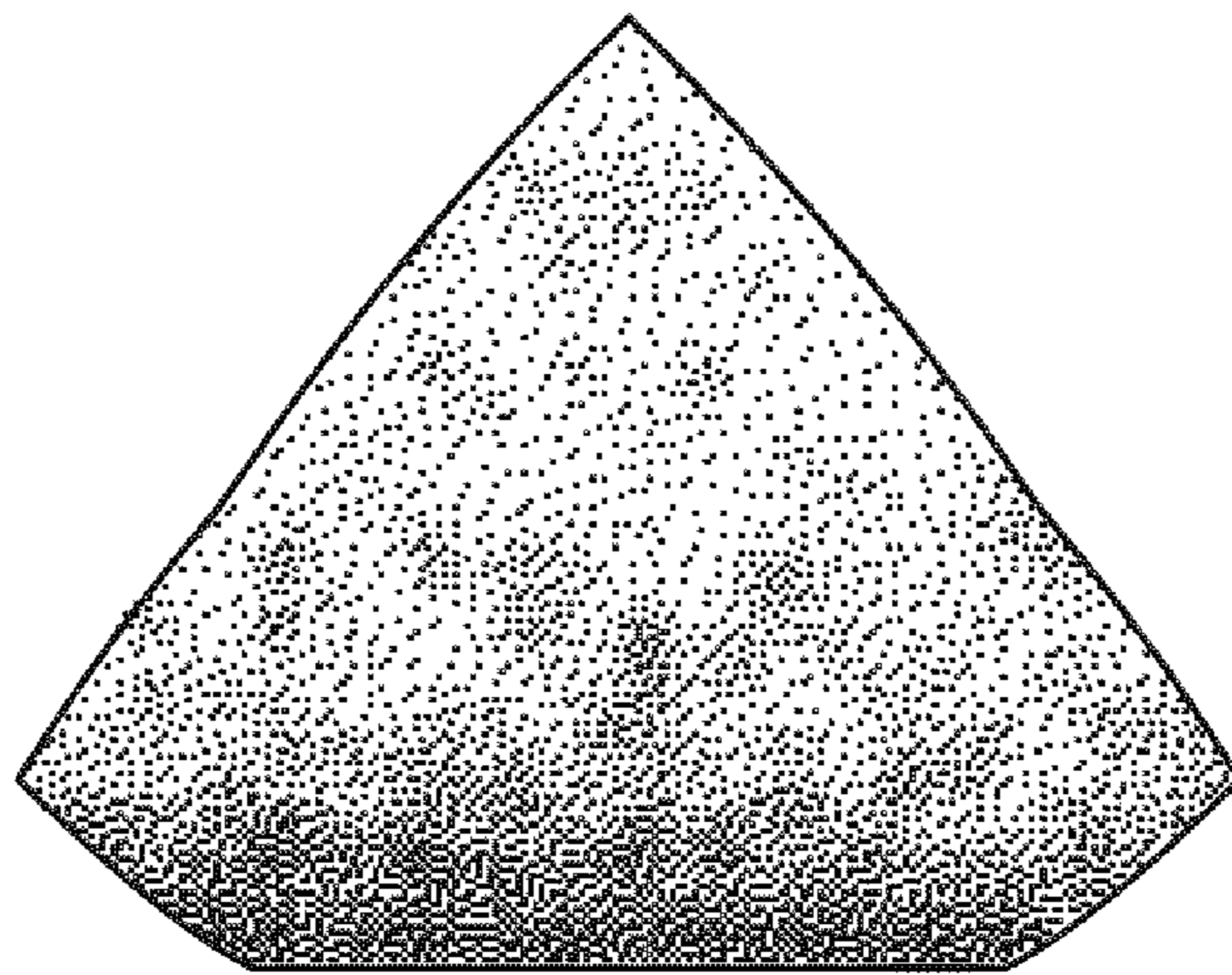
