The ornamental design for an over the counter medicinal container with surface ornamentation, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an over the counter medicinal container with surface ornamentation showing our new design;

FIG. 6 is a top plan view thereof;

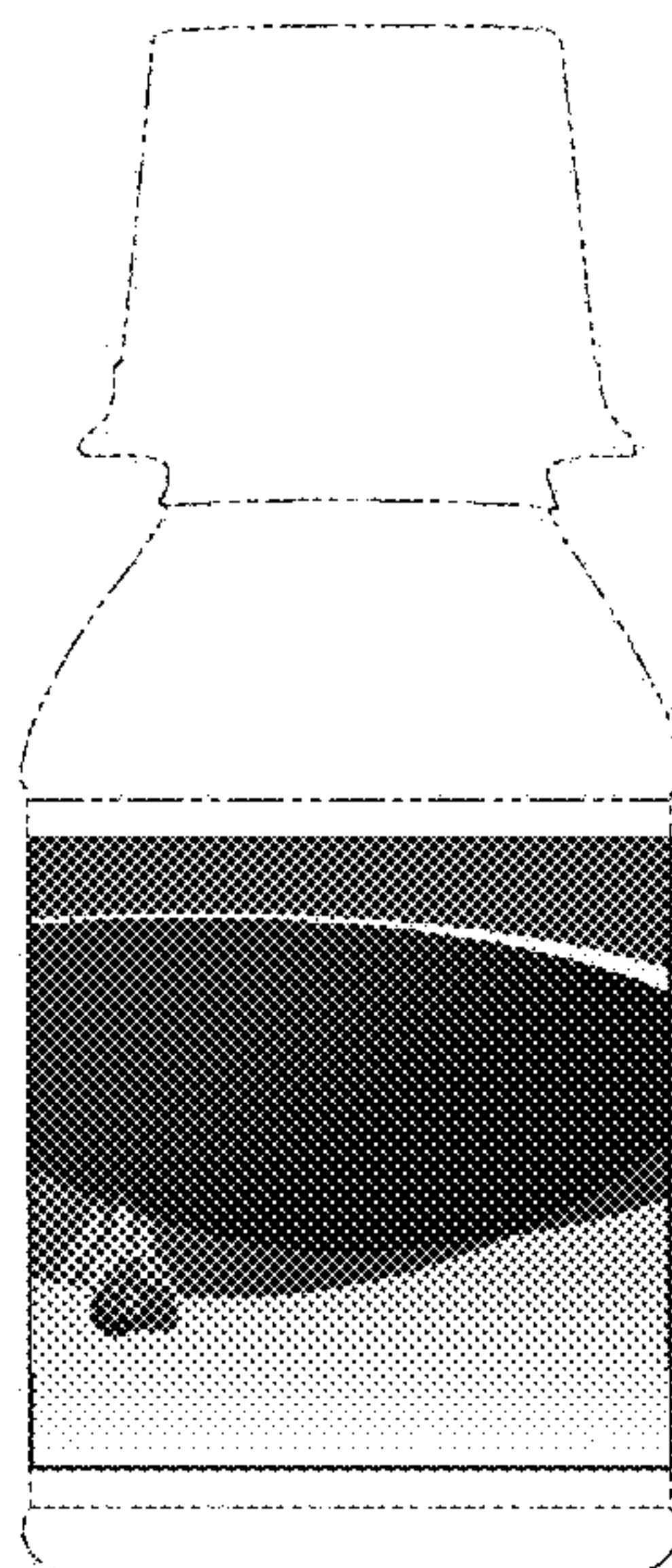
FIG. 7 is a bottom plan view thereof;

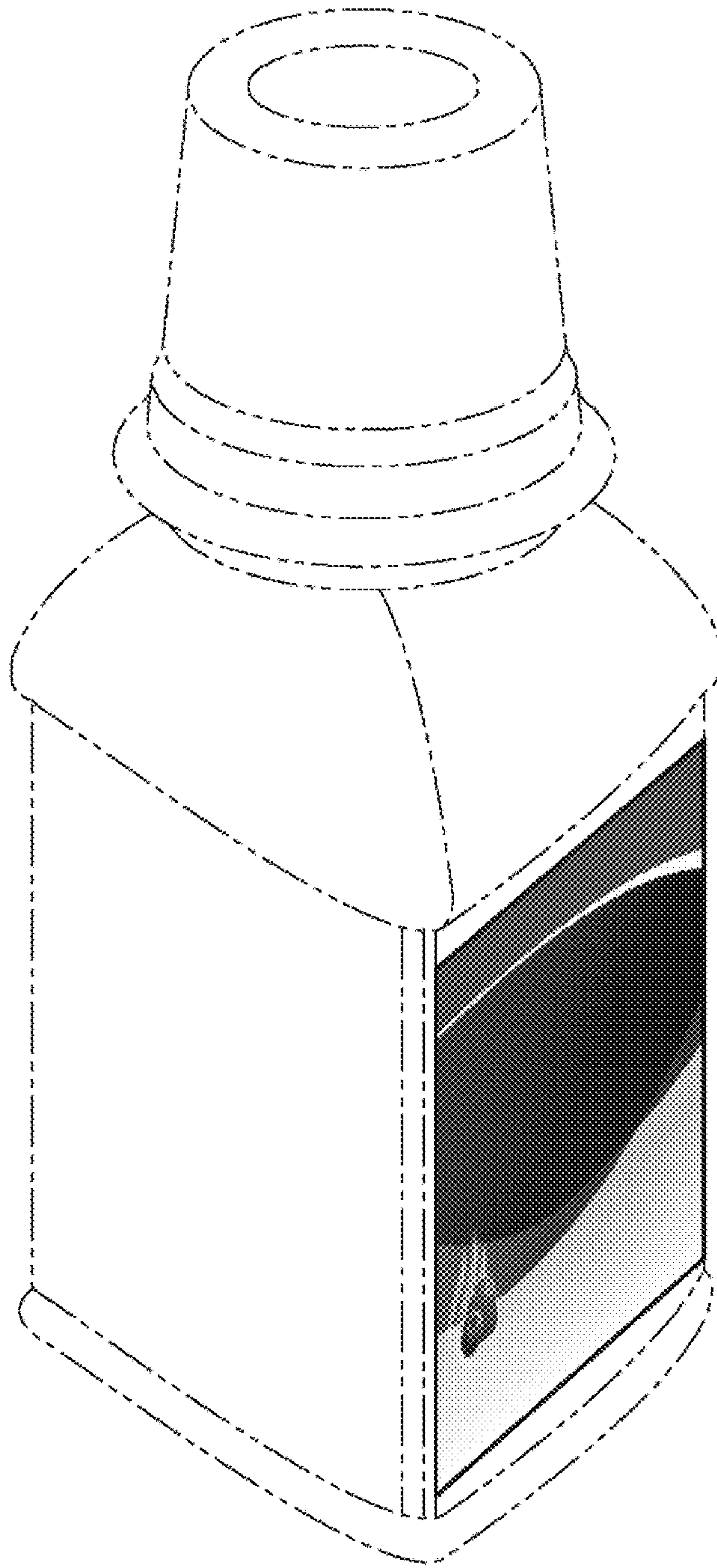

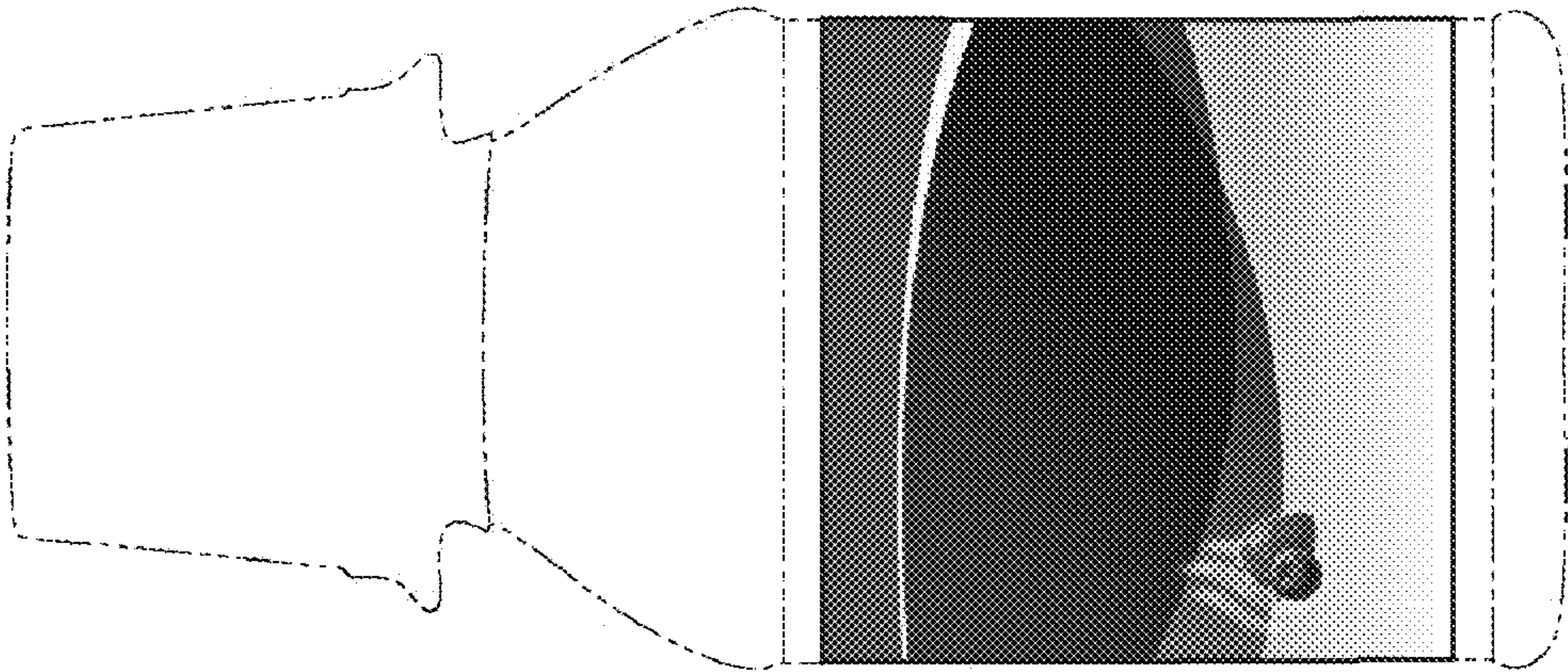

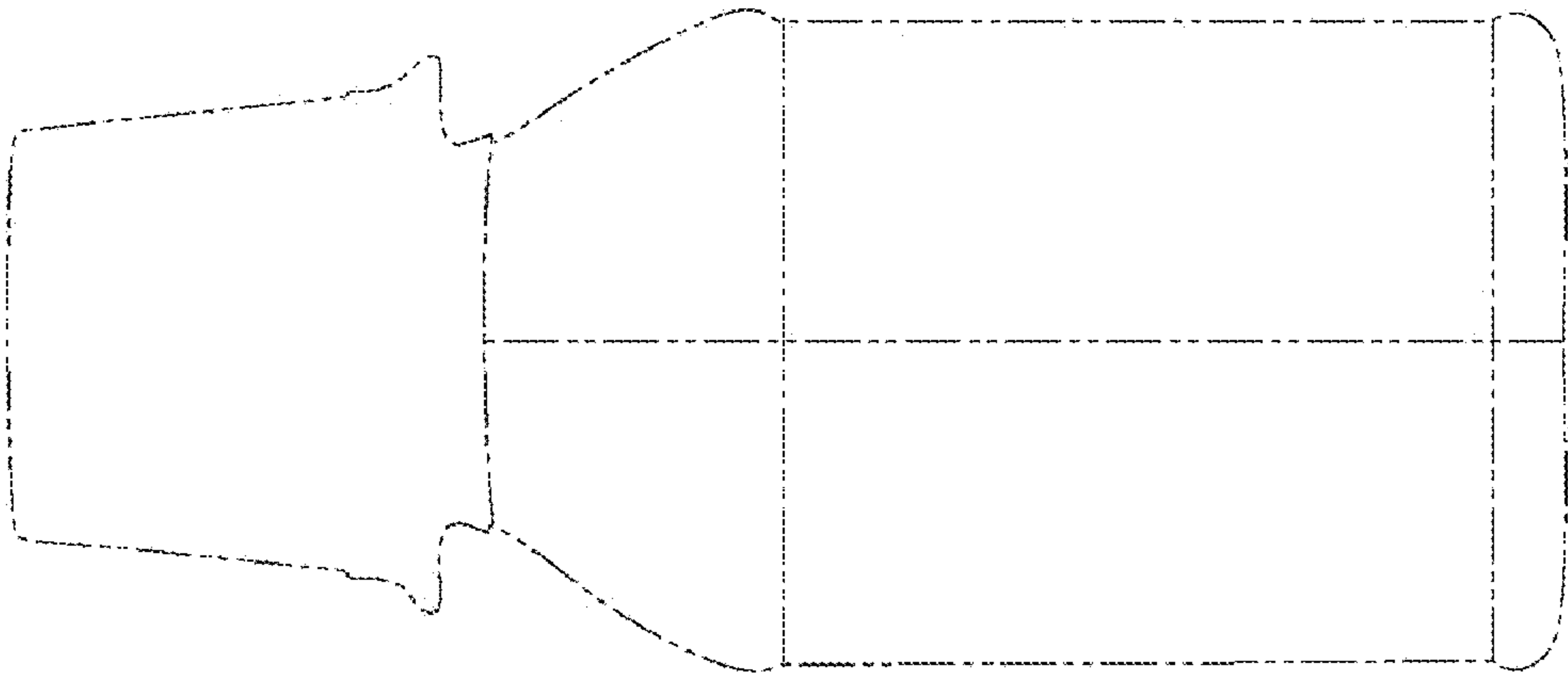

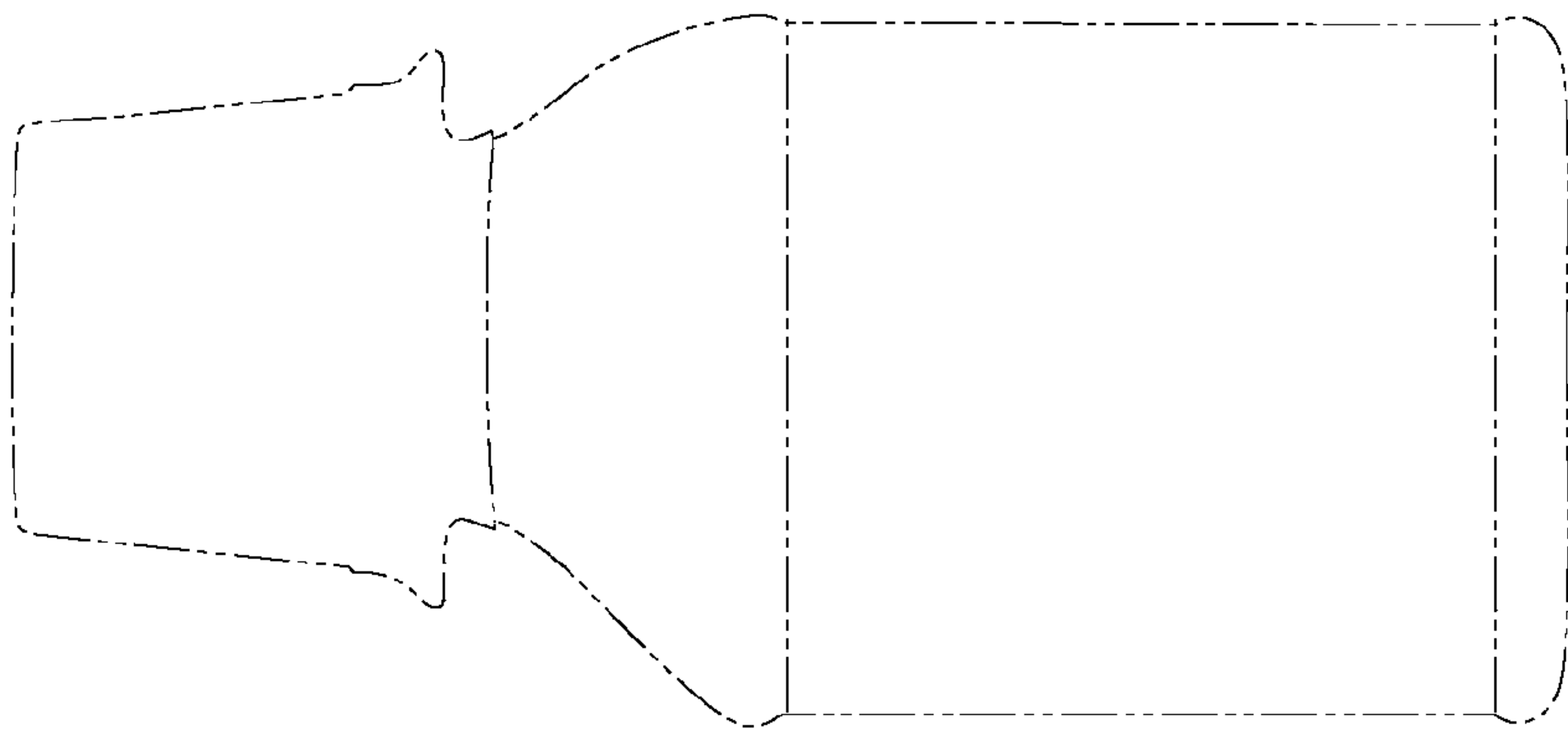

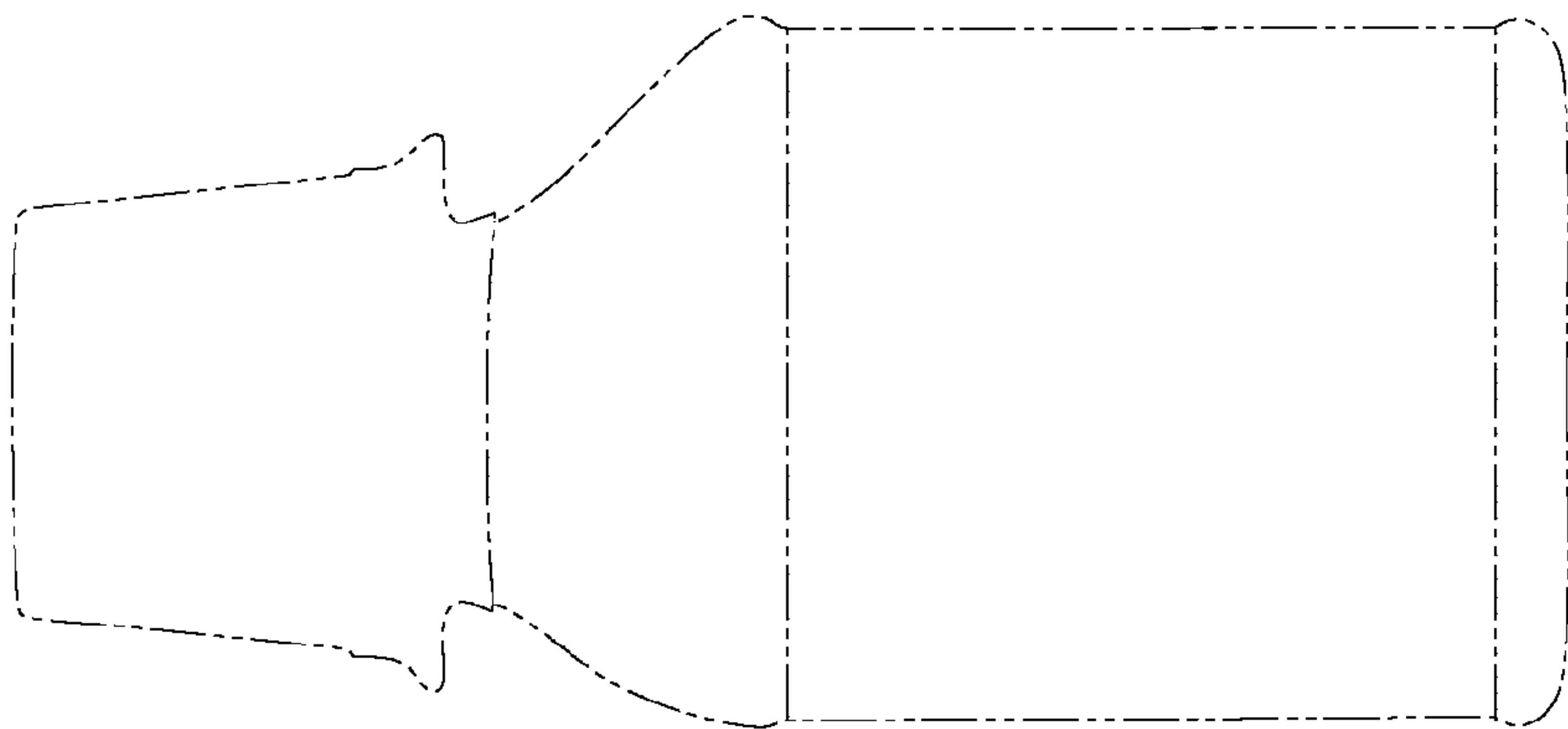

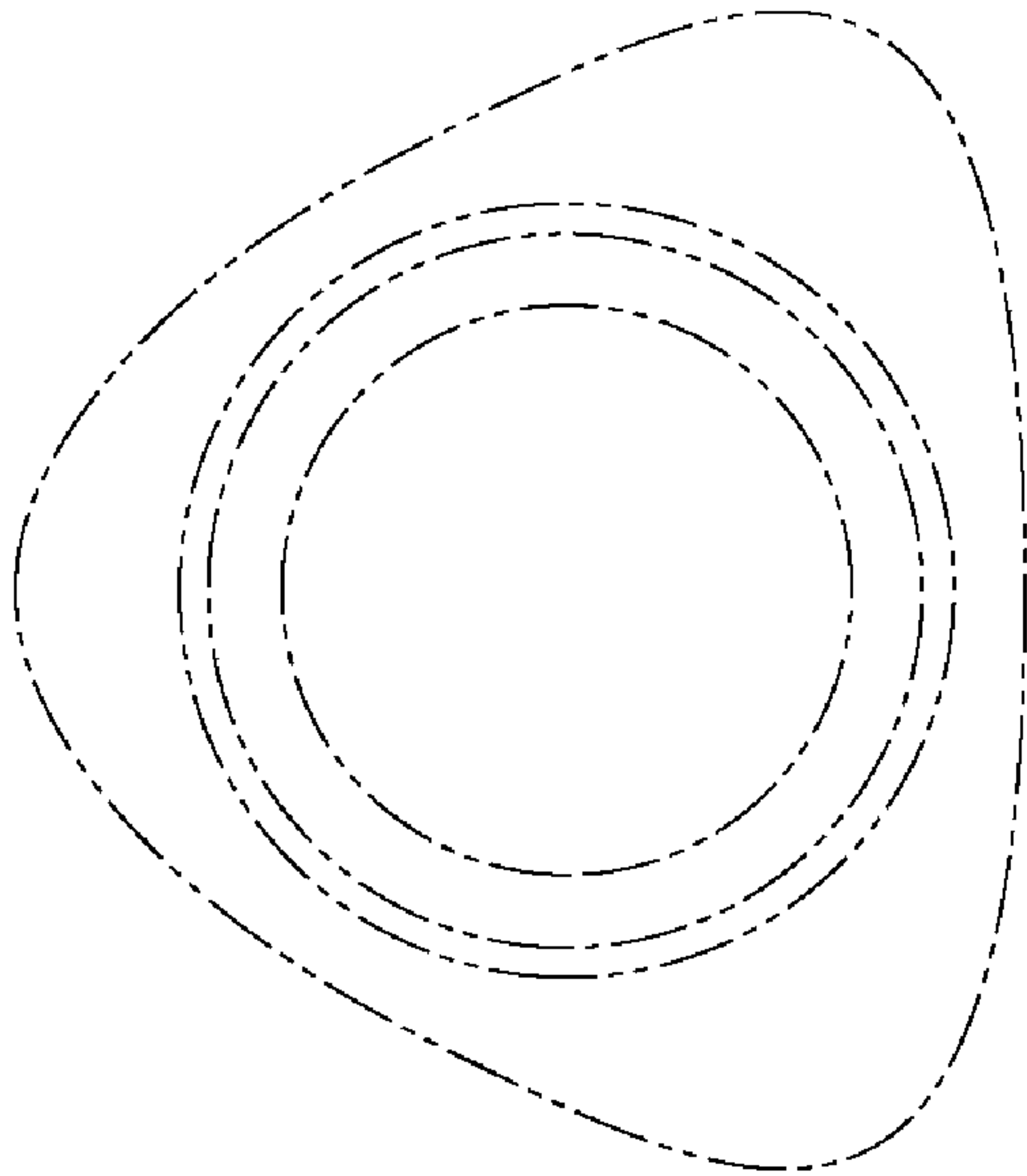

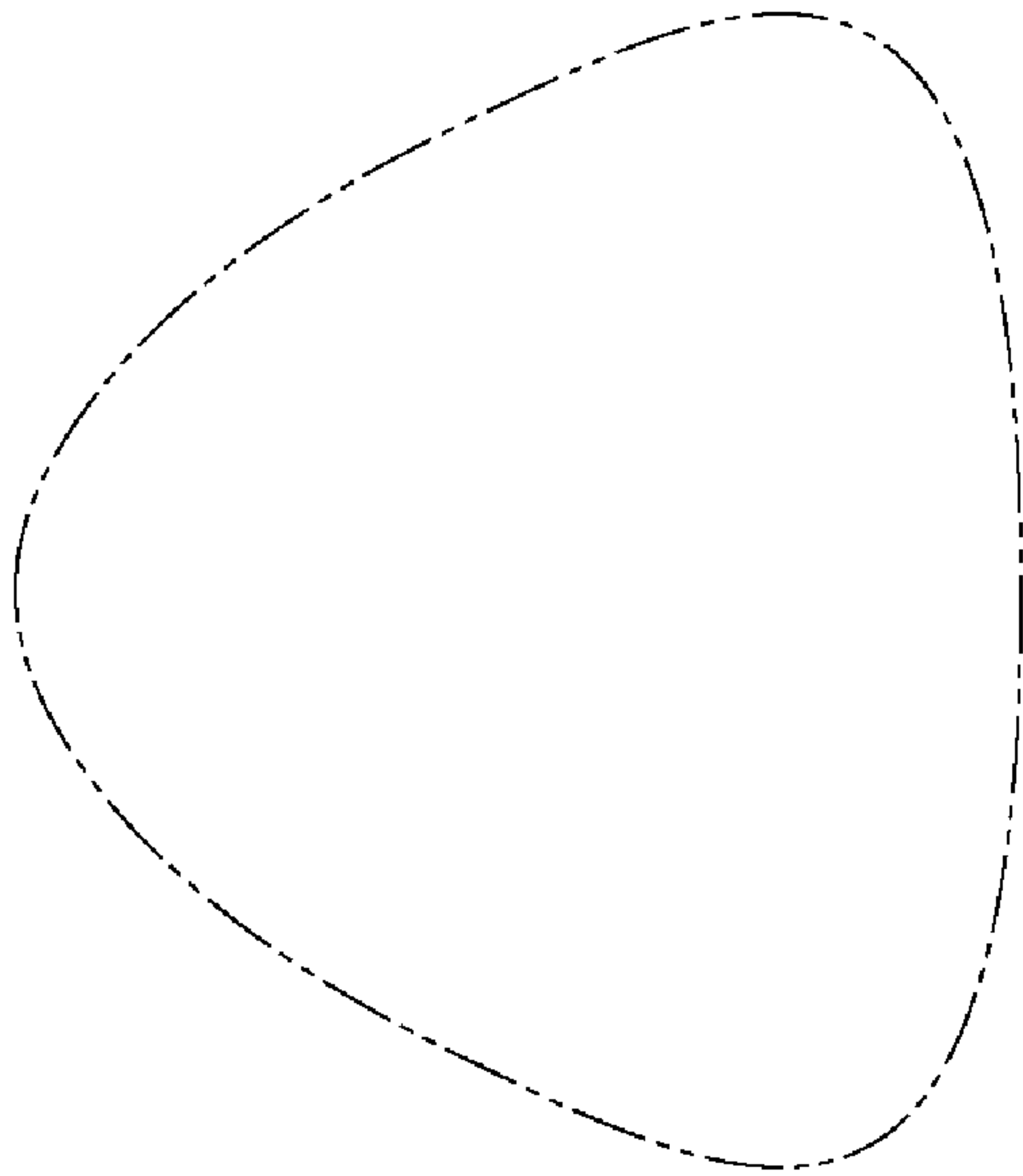

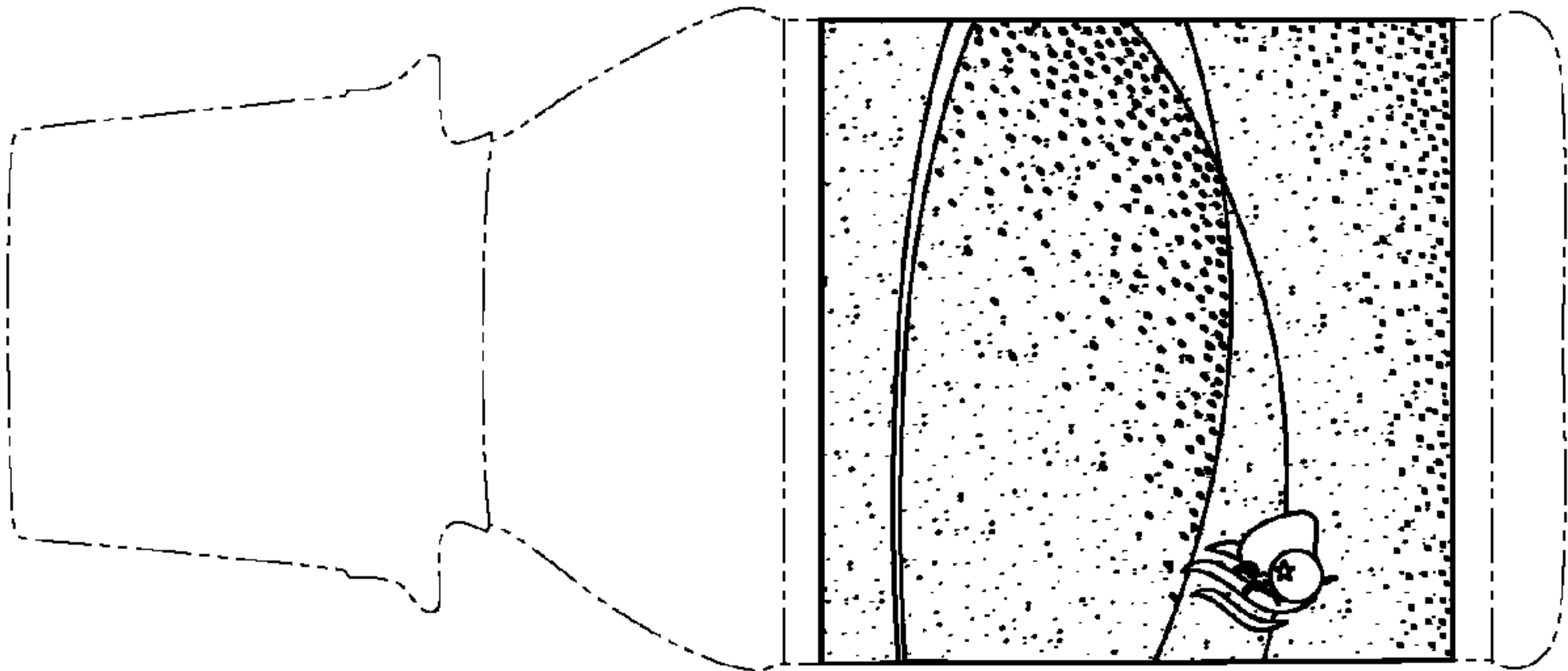

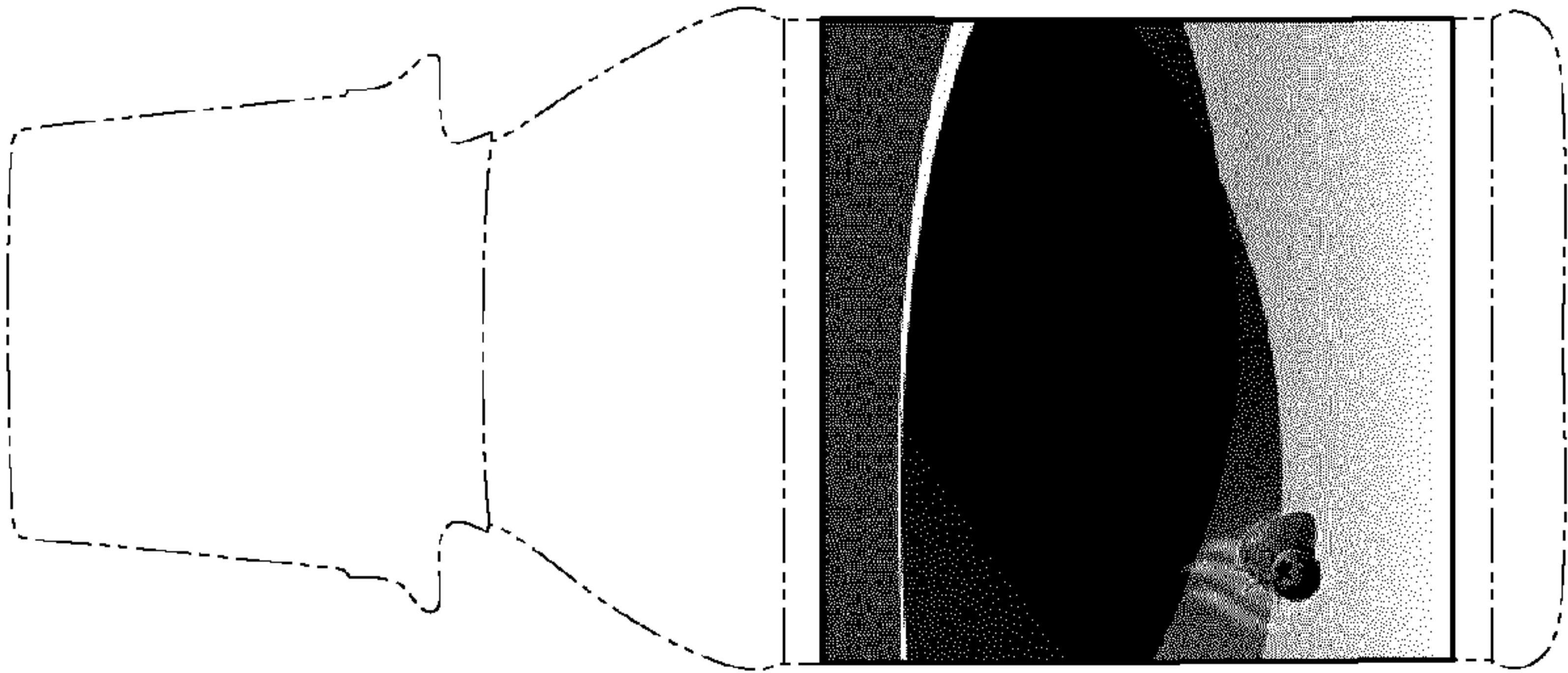
