FIG. 1 illustrates a front view of the surf sculpture showing my new and ornamental design;

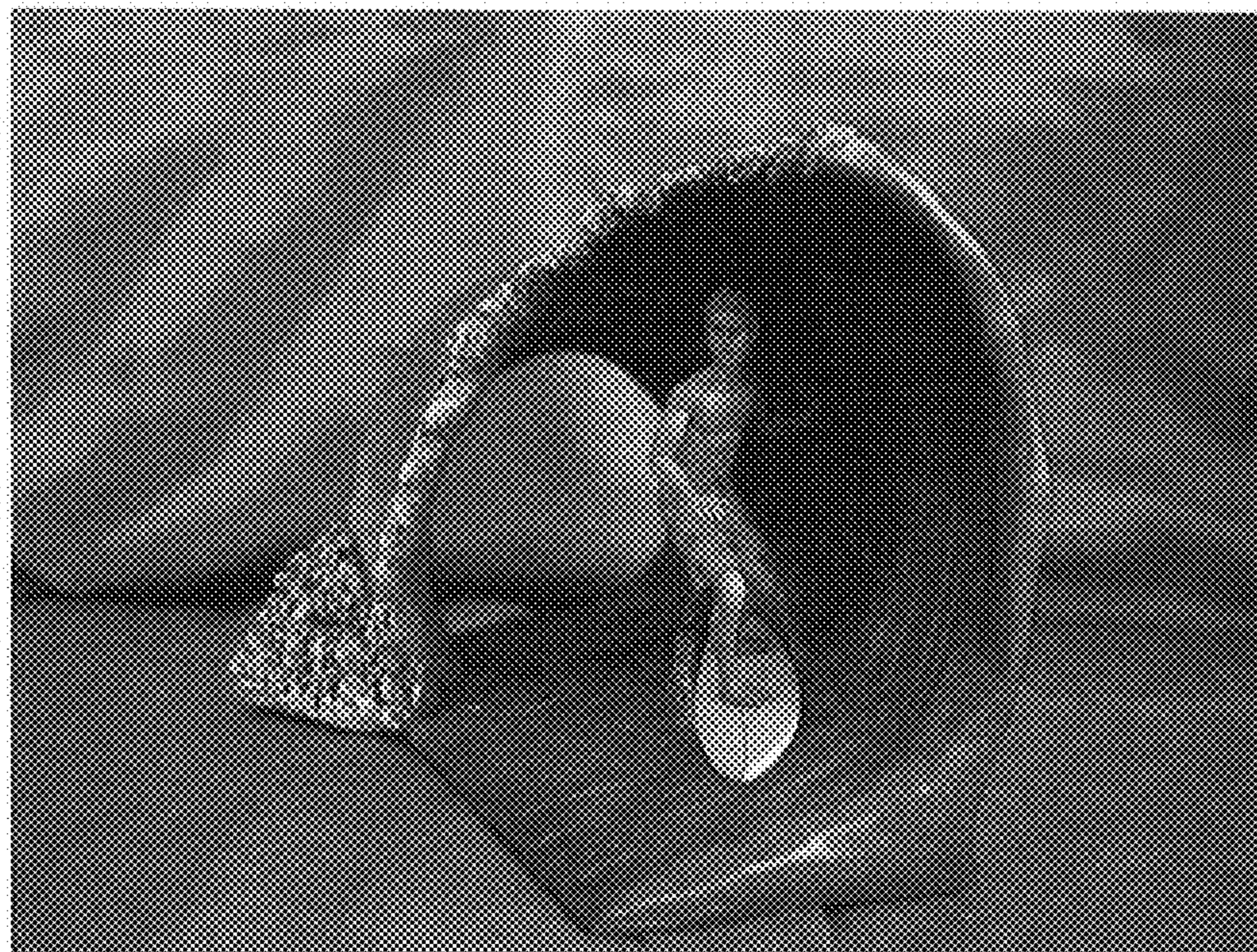
FIG. 2 illustrates a rear view thereof;

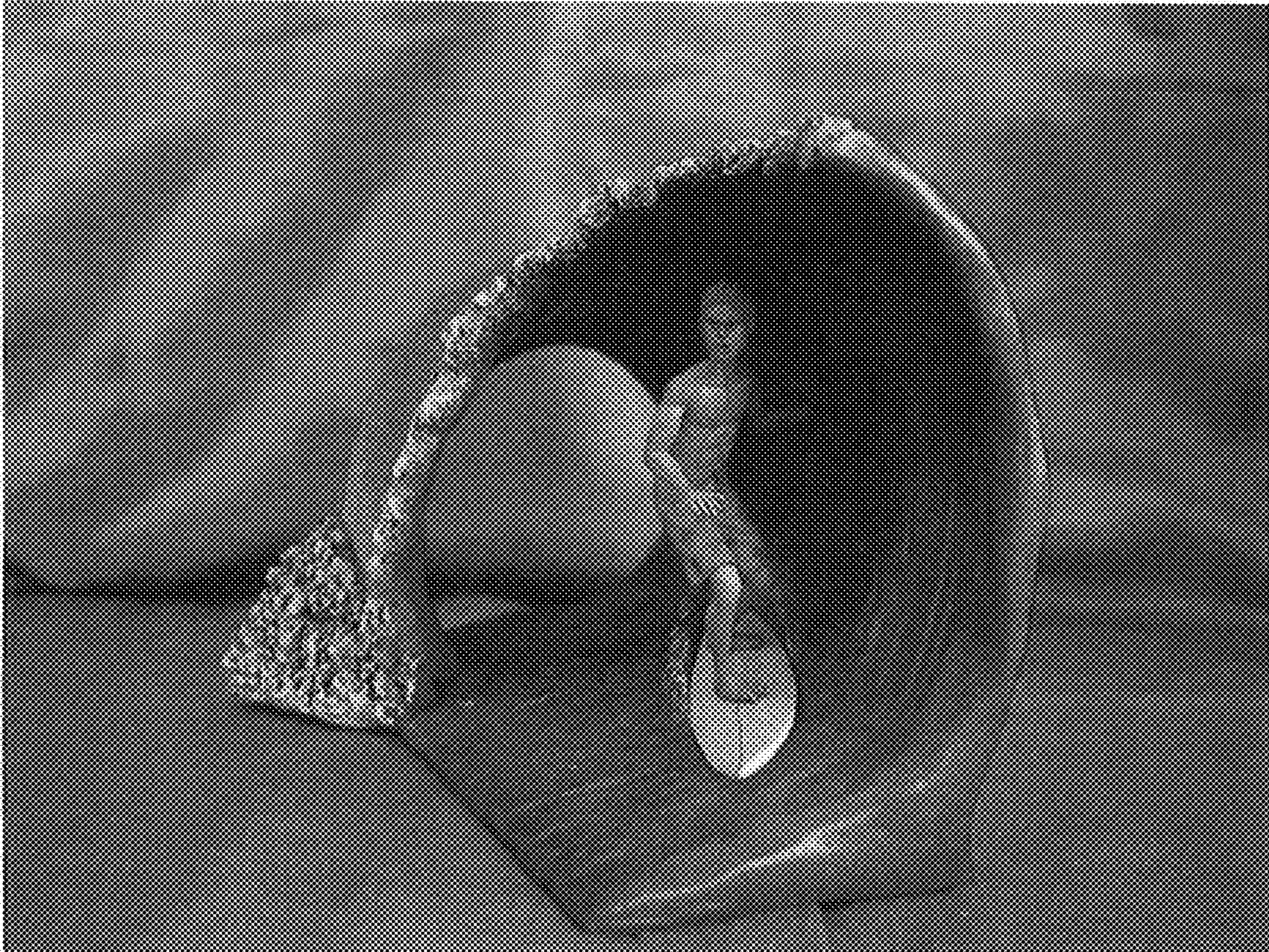

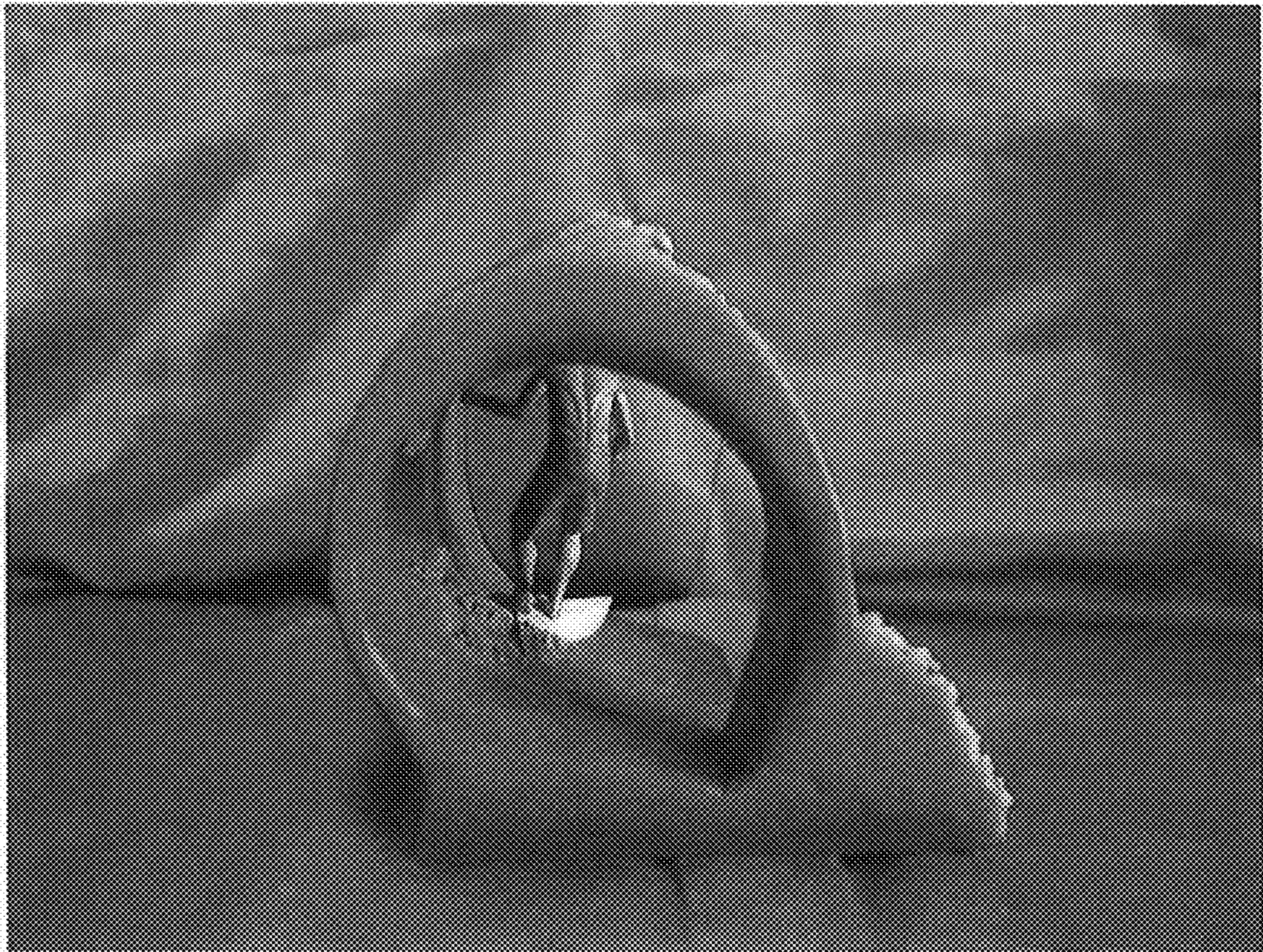

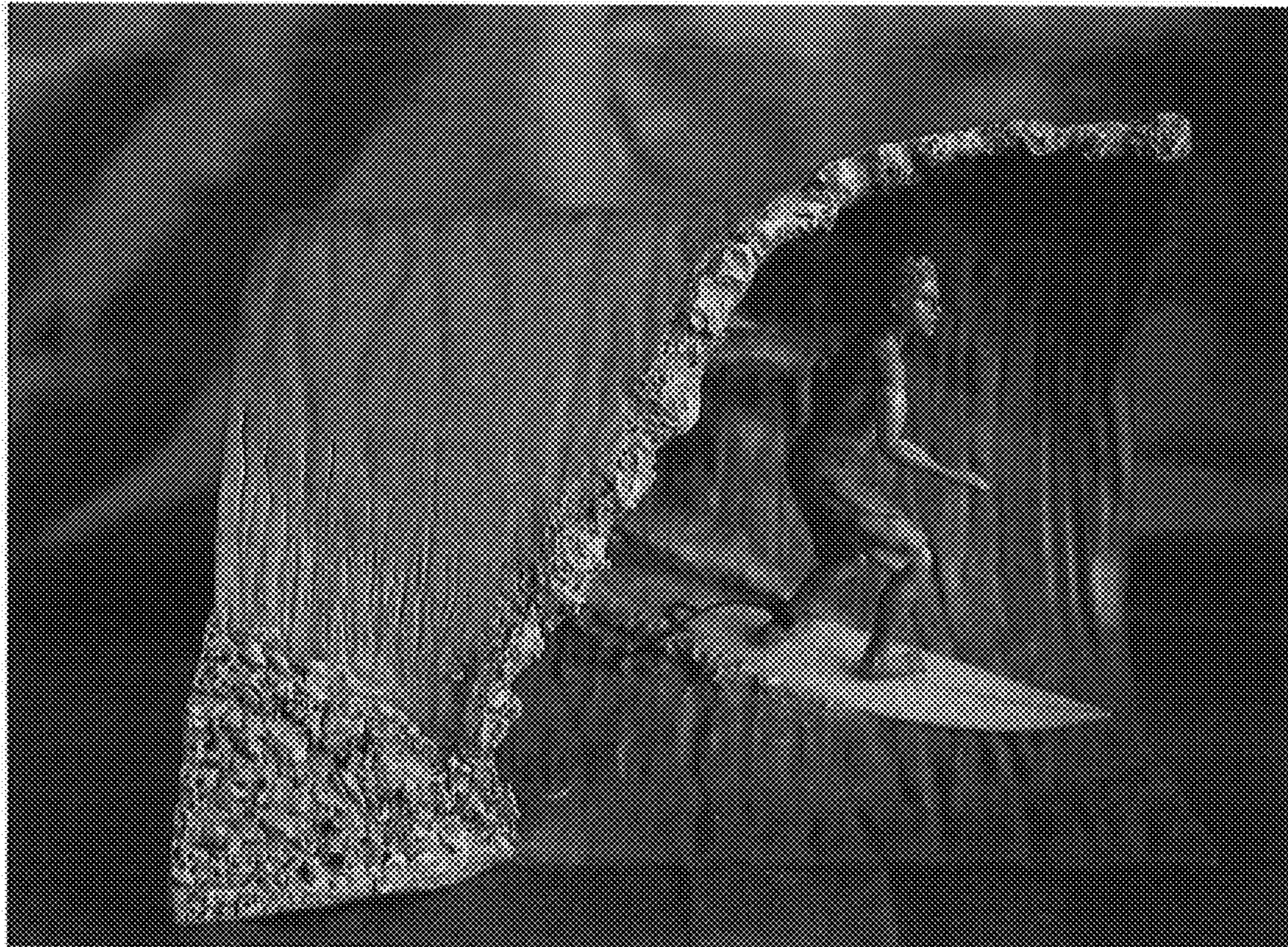

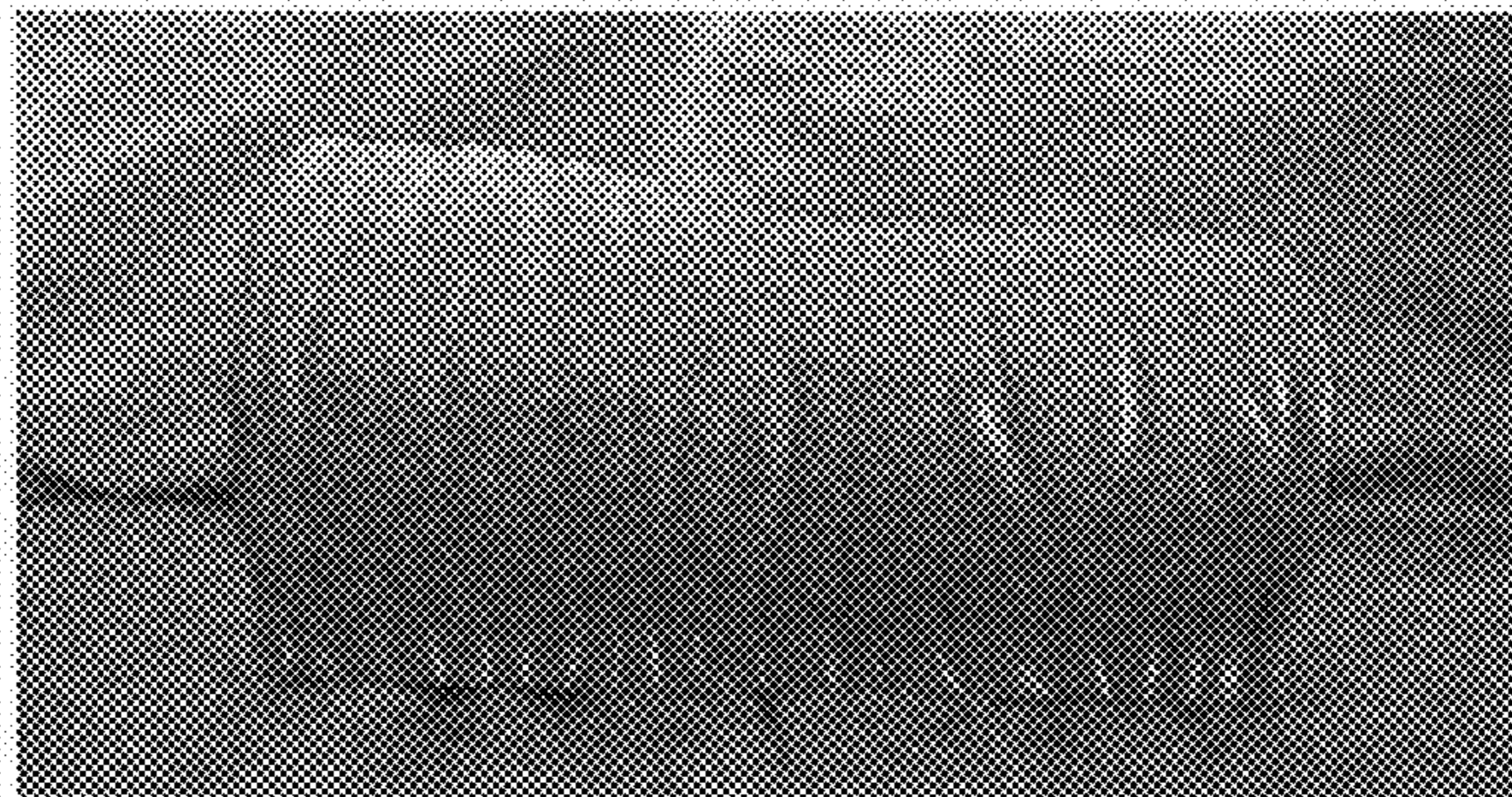

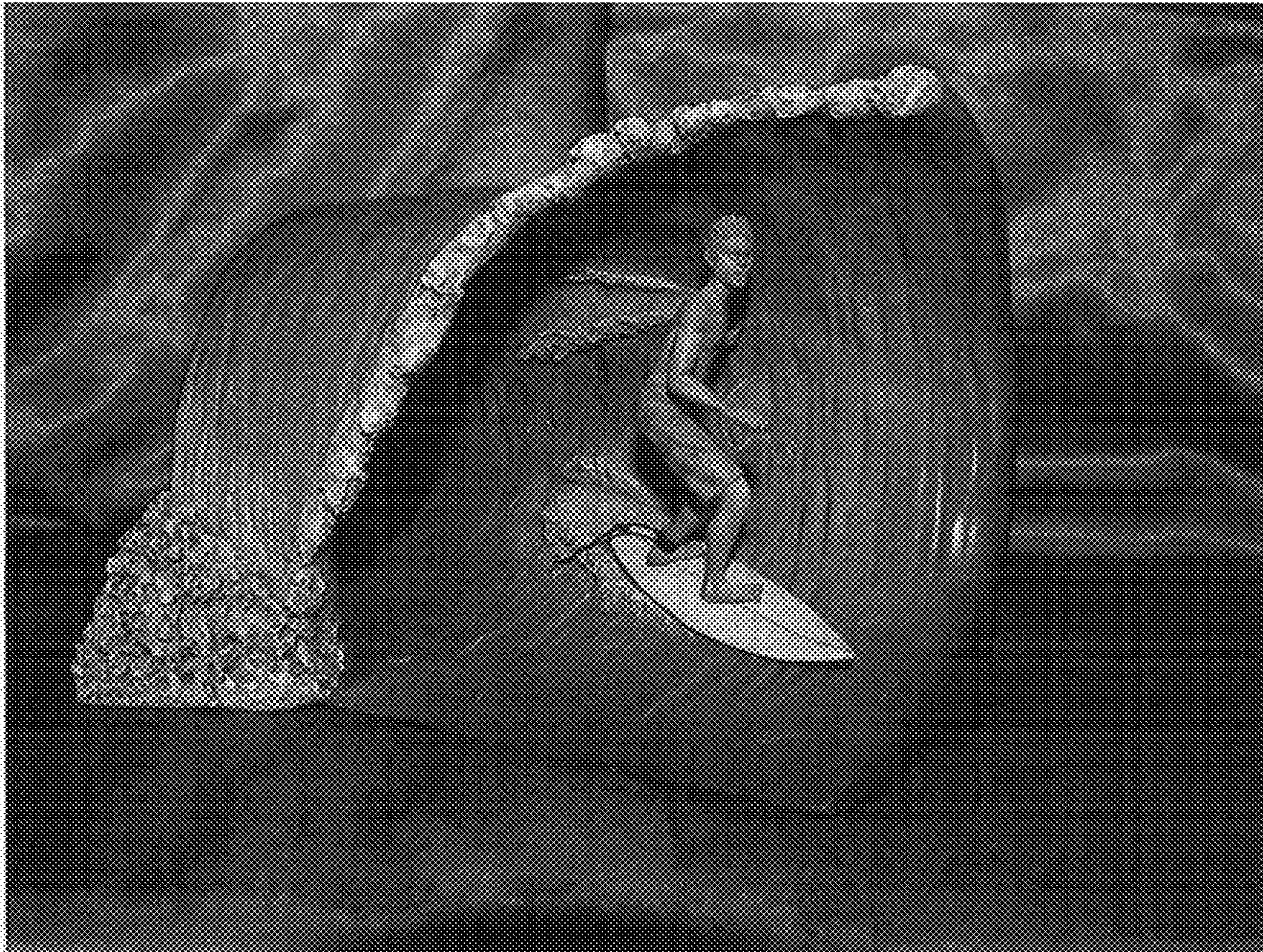
