The ornamental design for a remote controller, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, left perspective view of a remote controller showing my new design;

FIG. 2 is a rear, bottom, left perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a right side elevational view thereof;

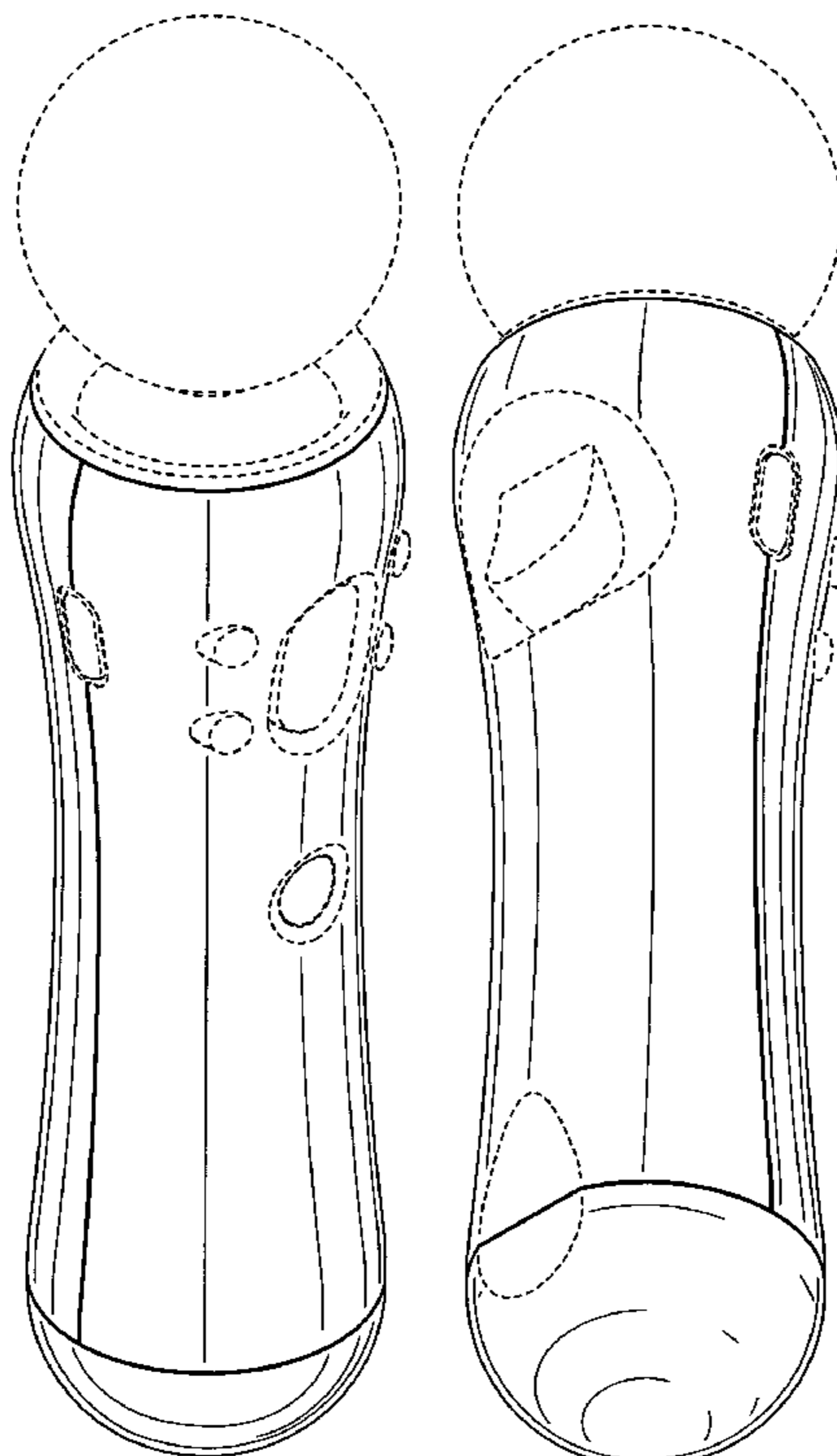

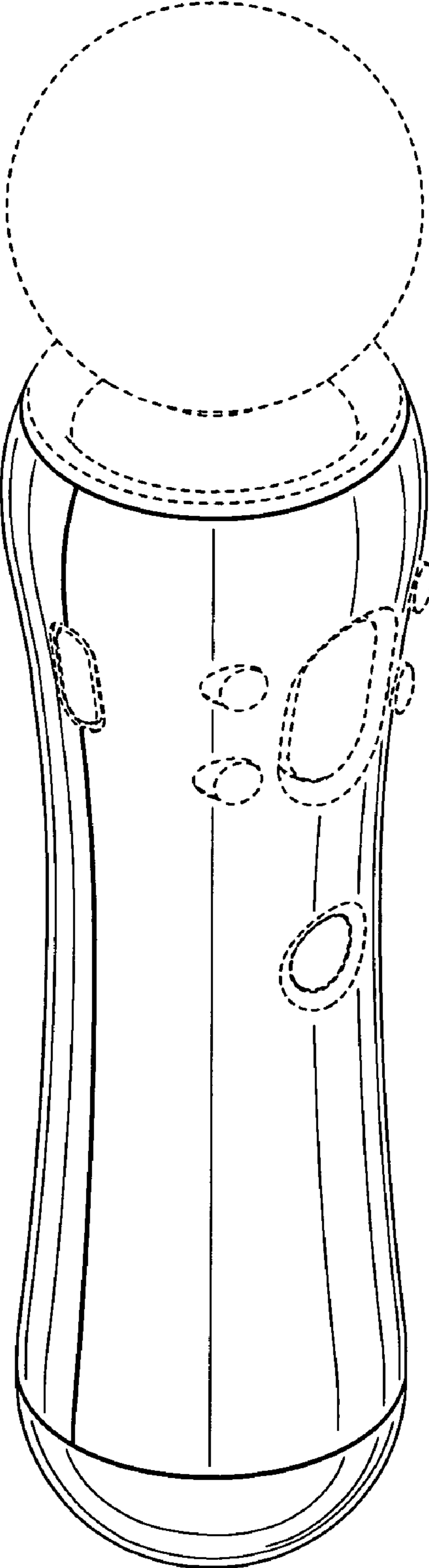

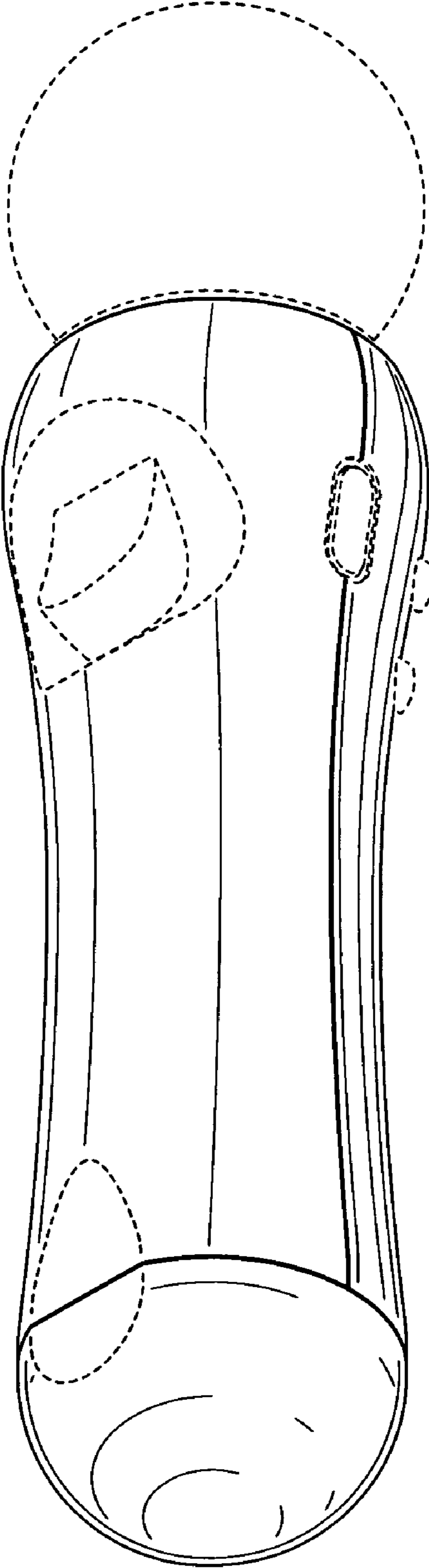

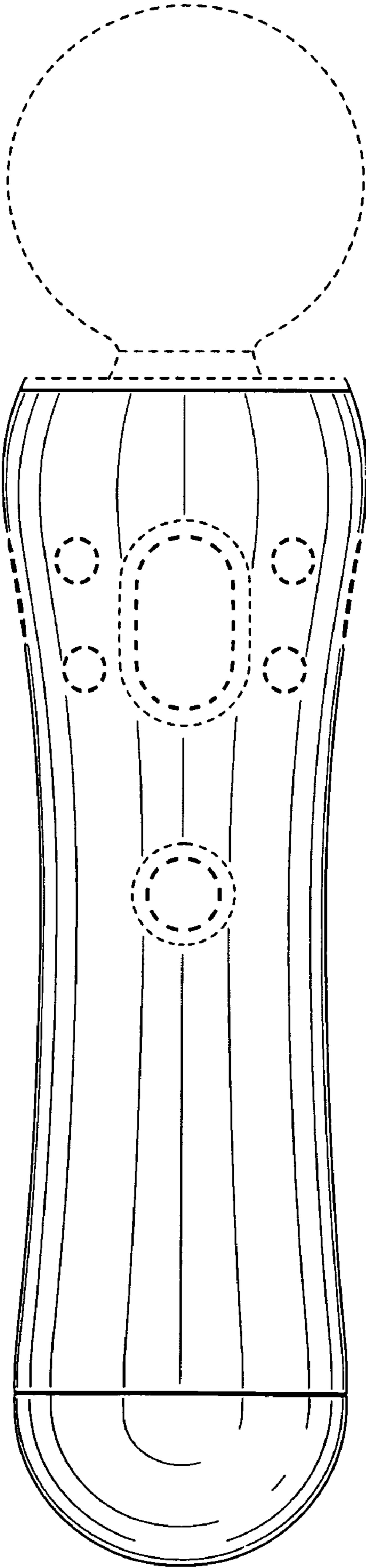

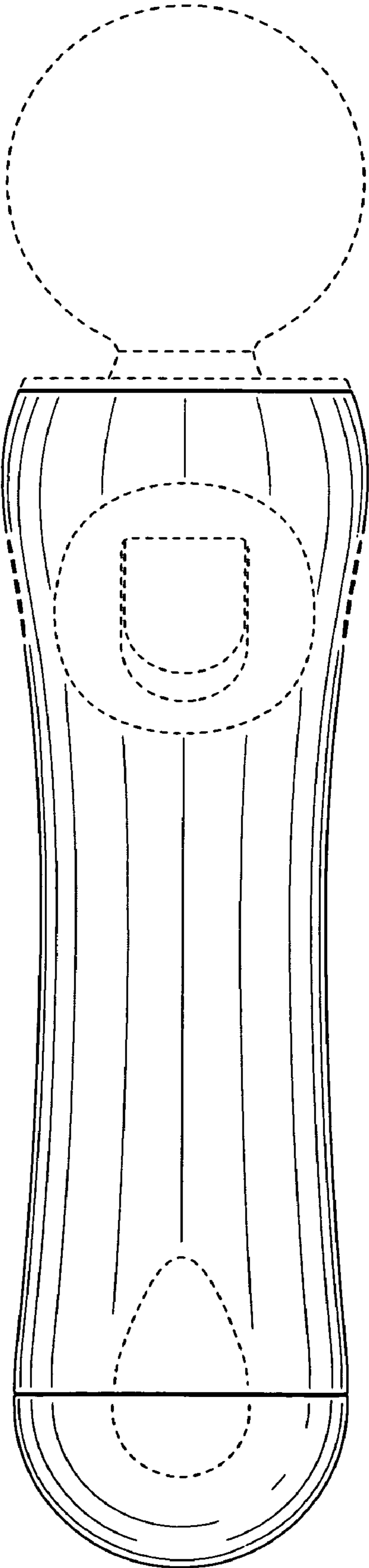

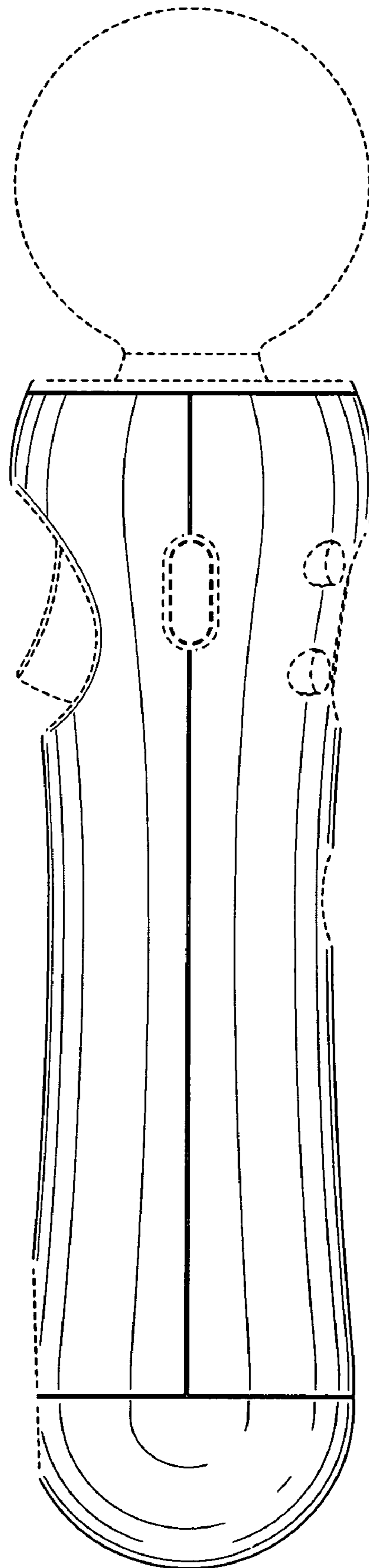

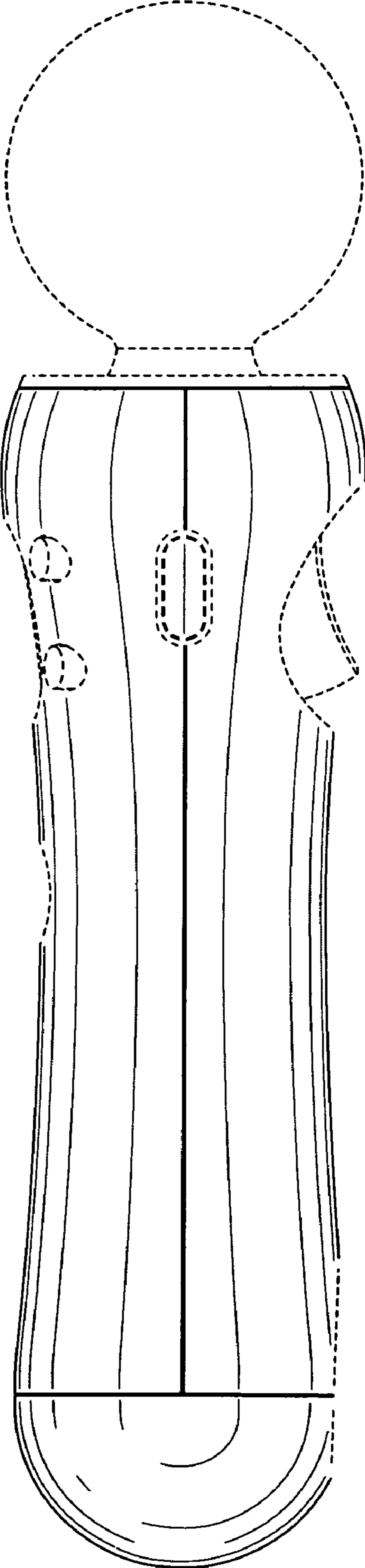

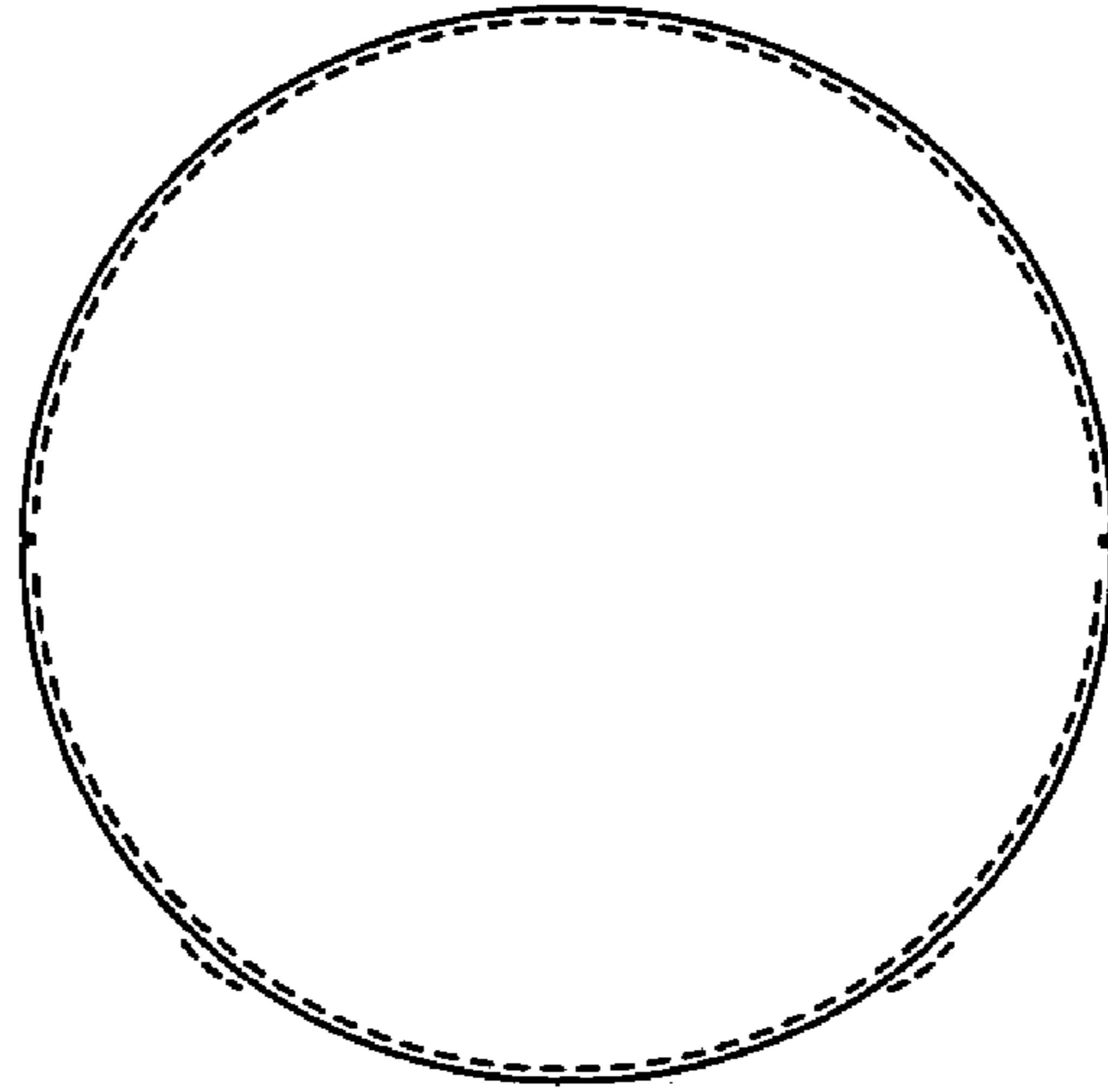
