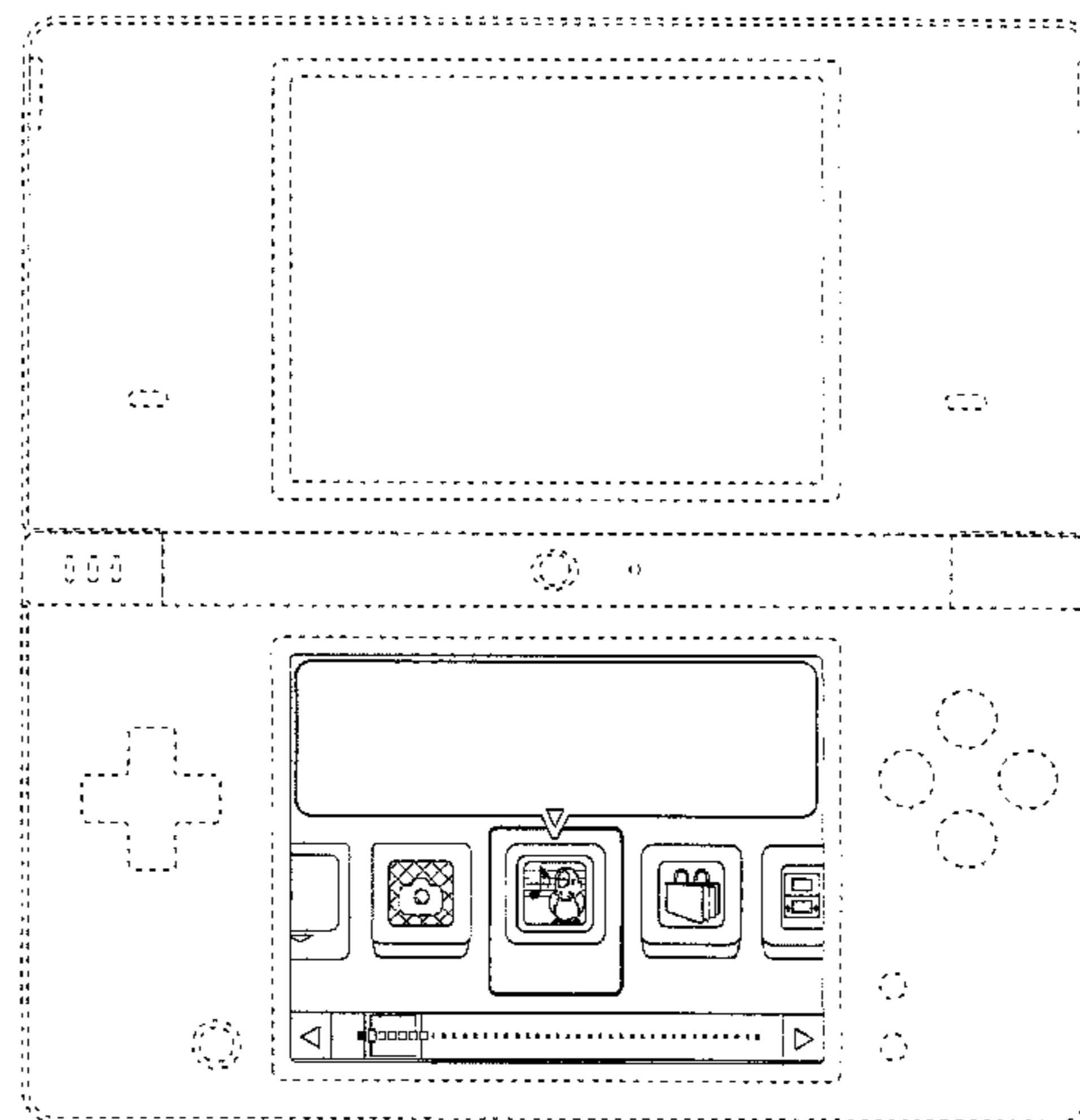
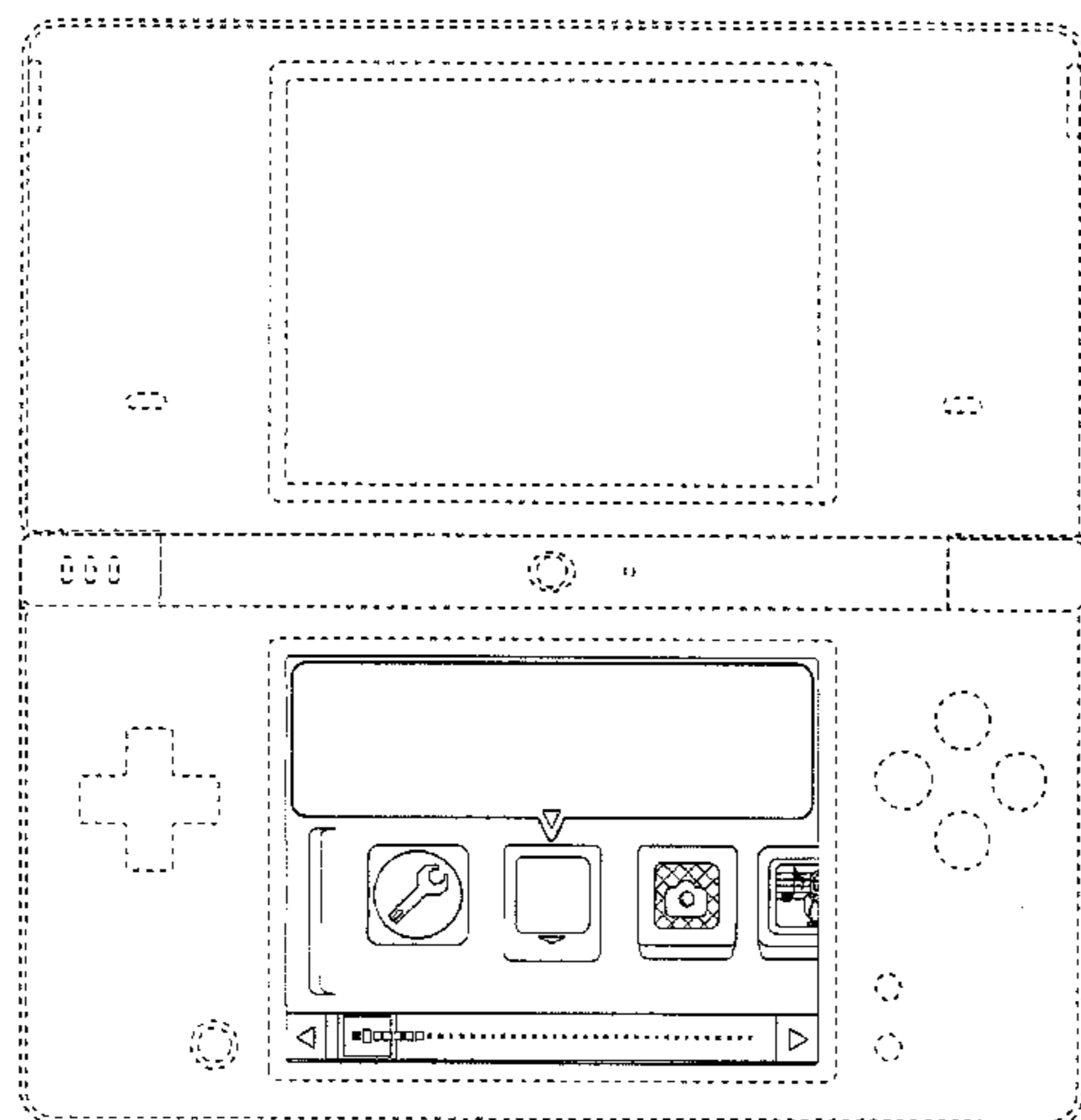
The ornamental design for a display with changeable computer-generated icons, as shown and described.

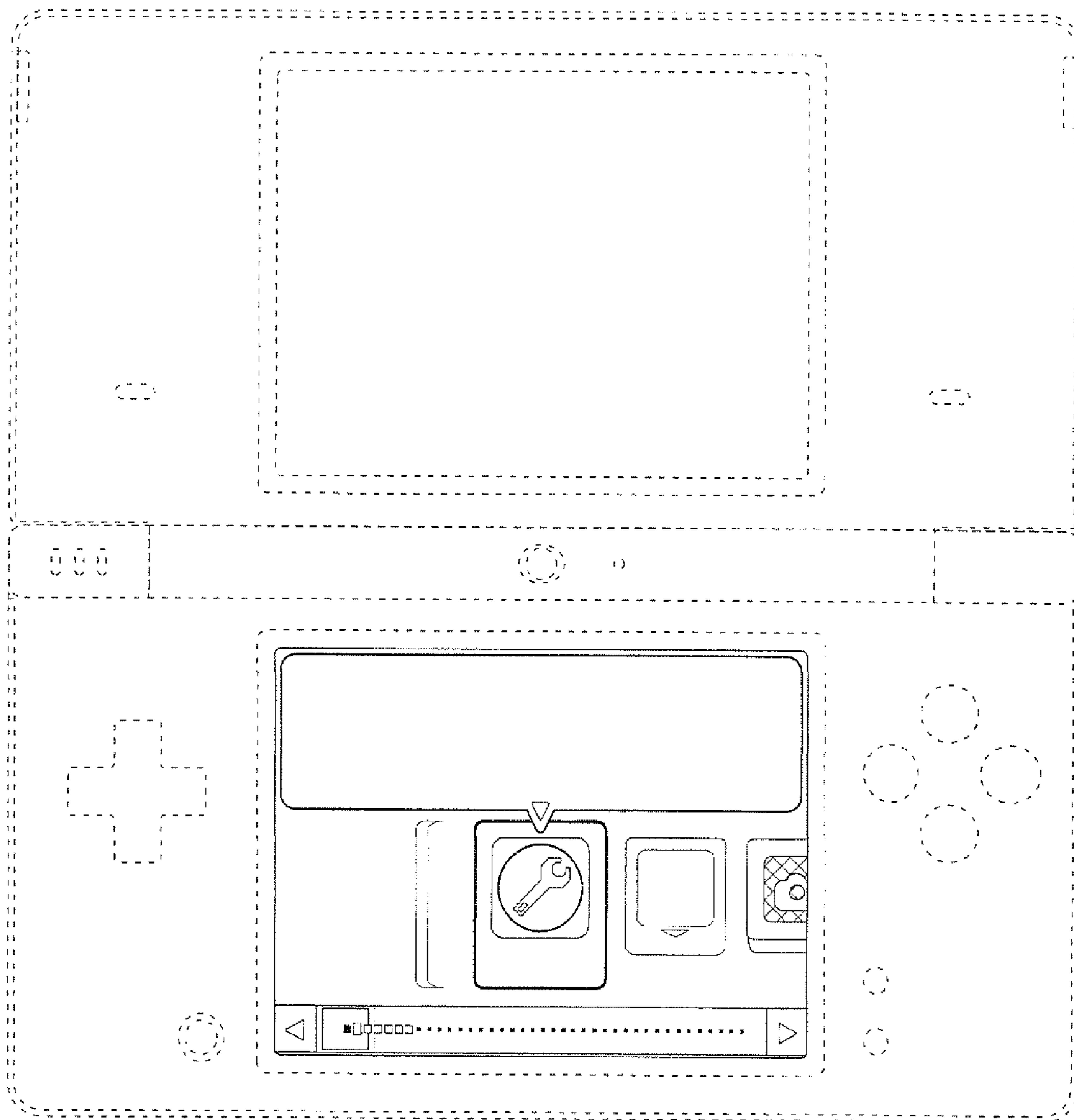

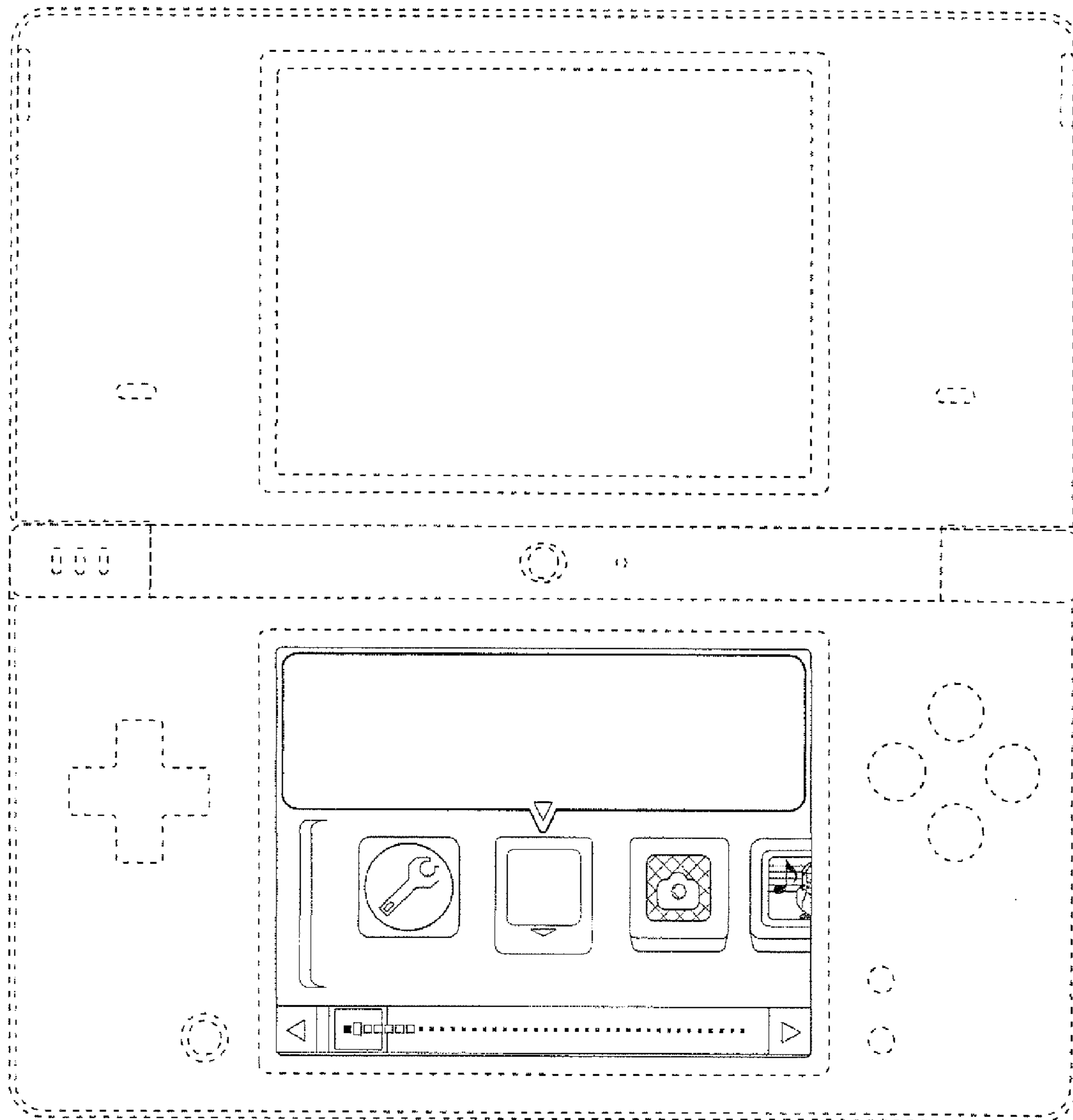

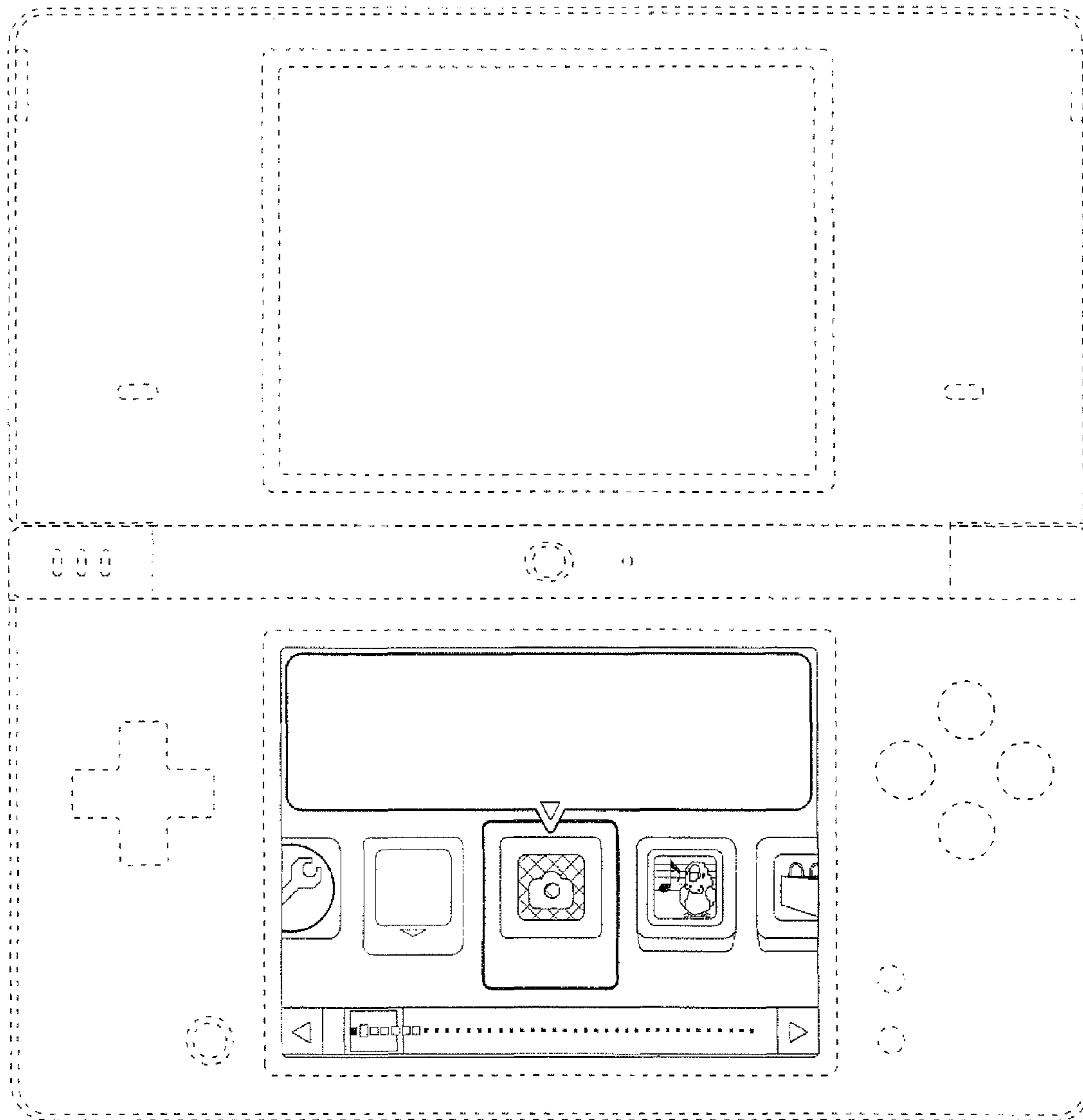

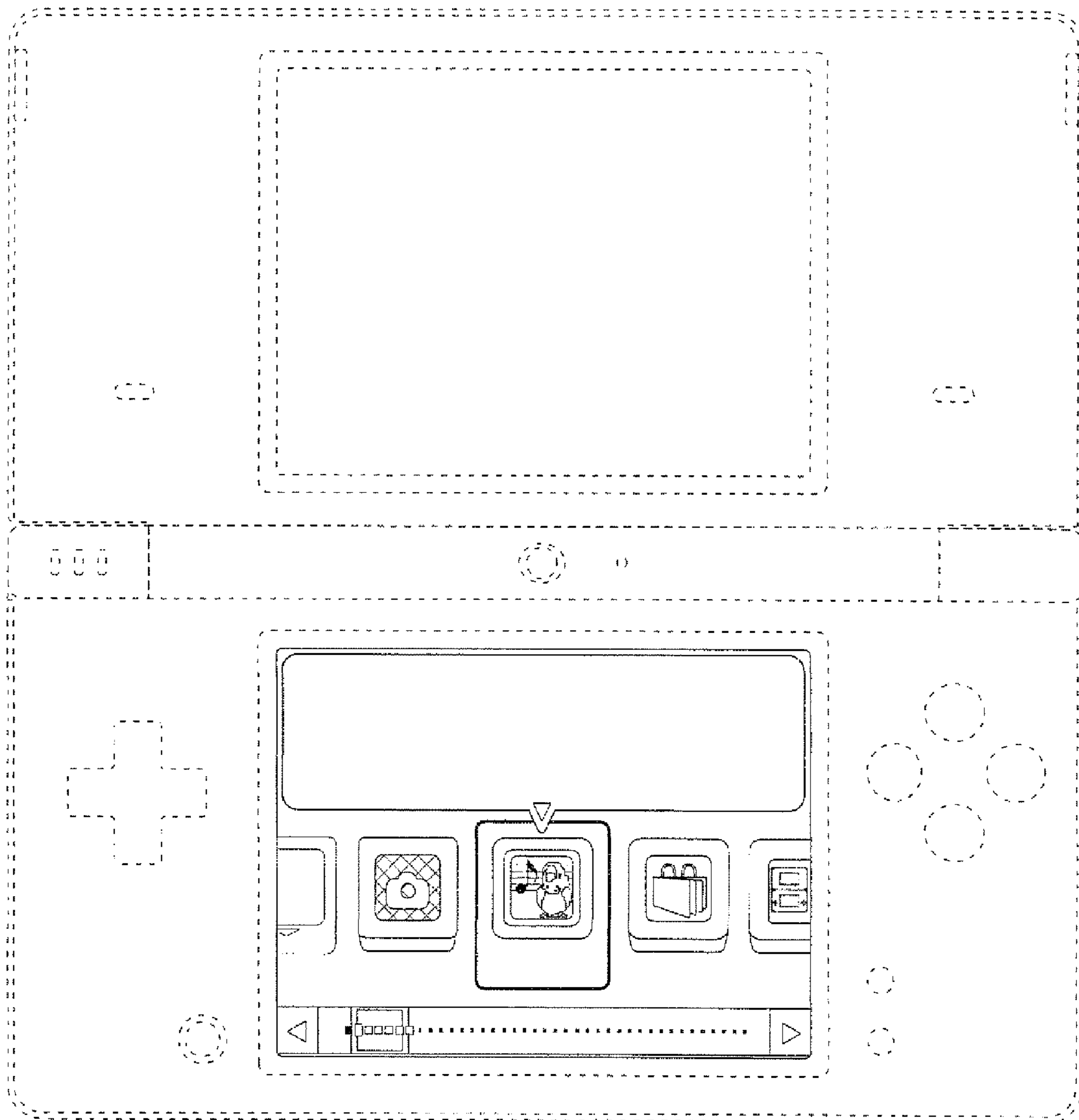

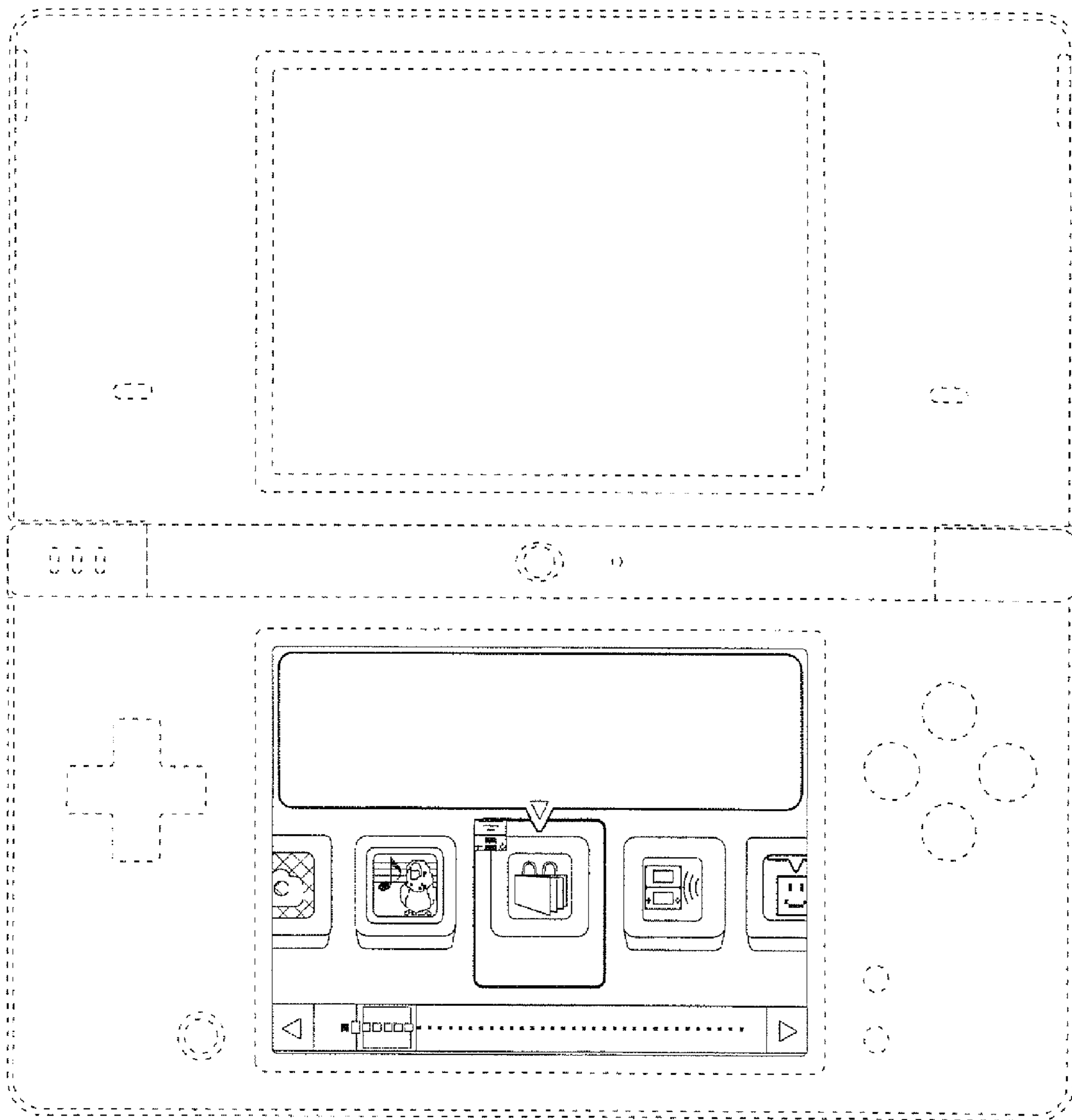

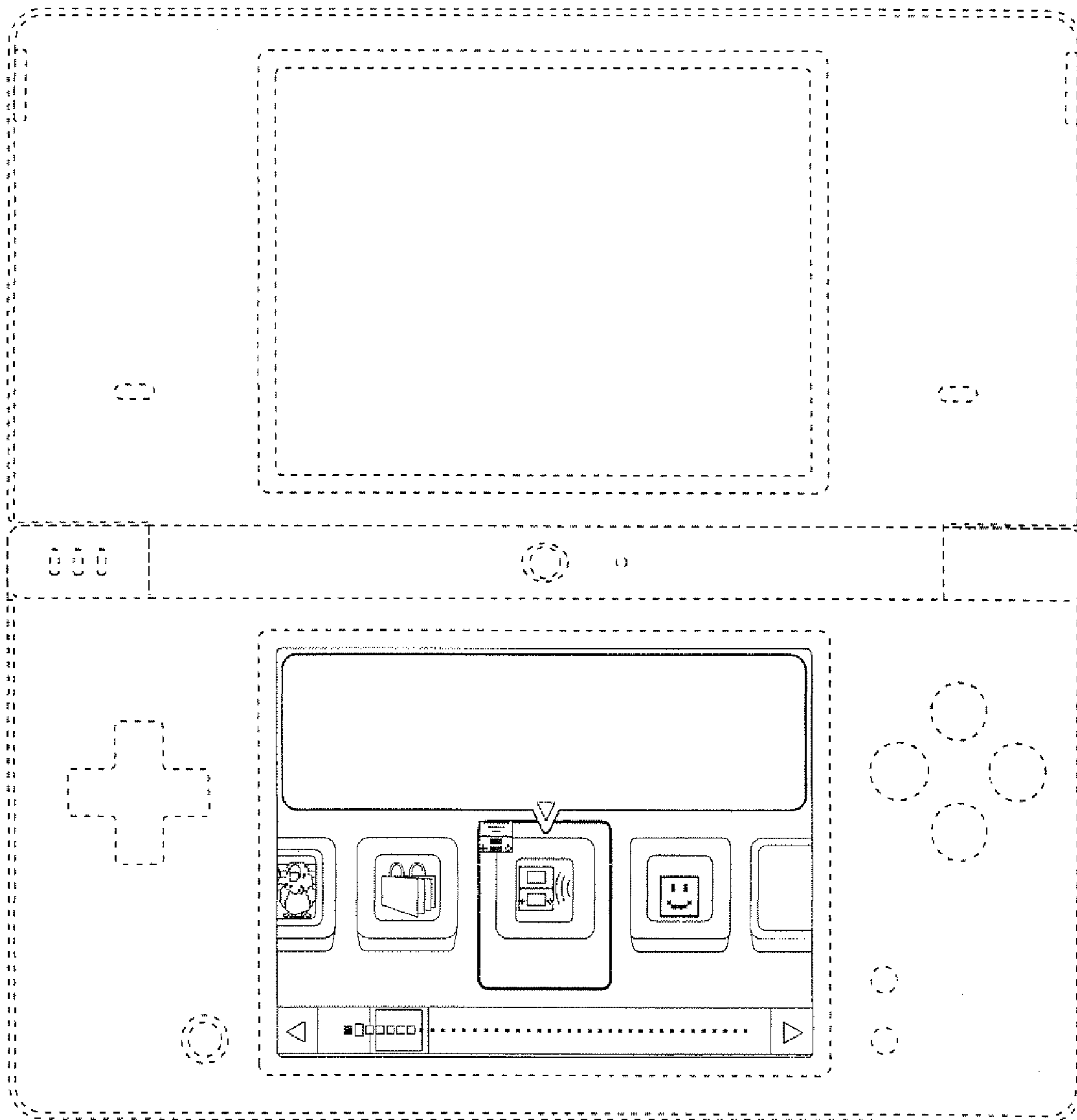
