We claim the ornamental design for a refrigerator, as shown and described.

**DESCRIPTION**

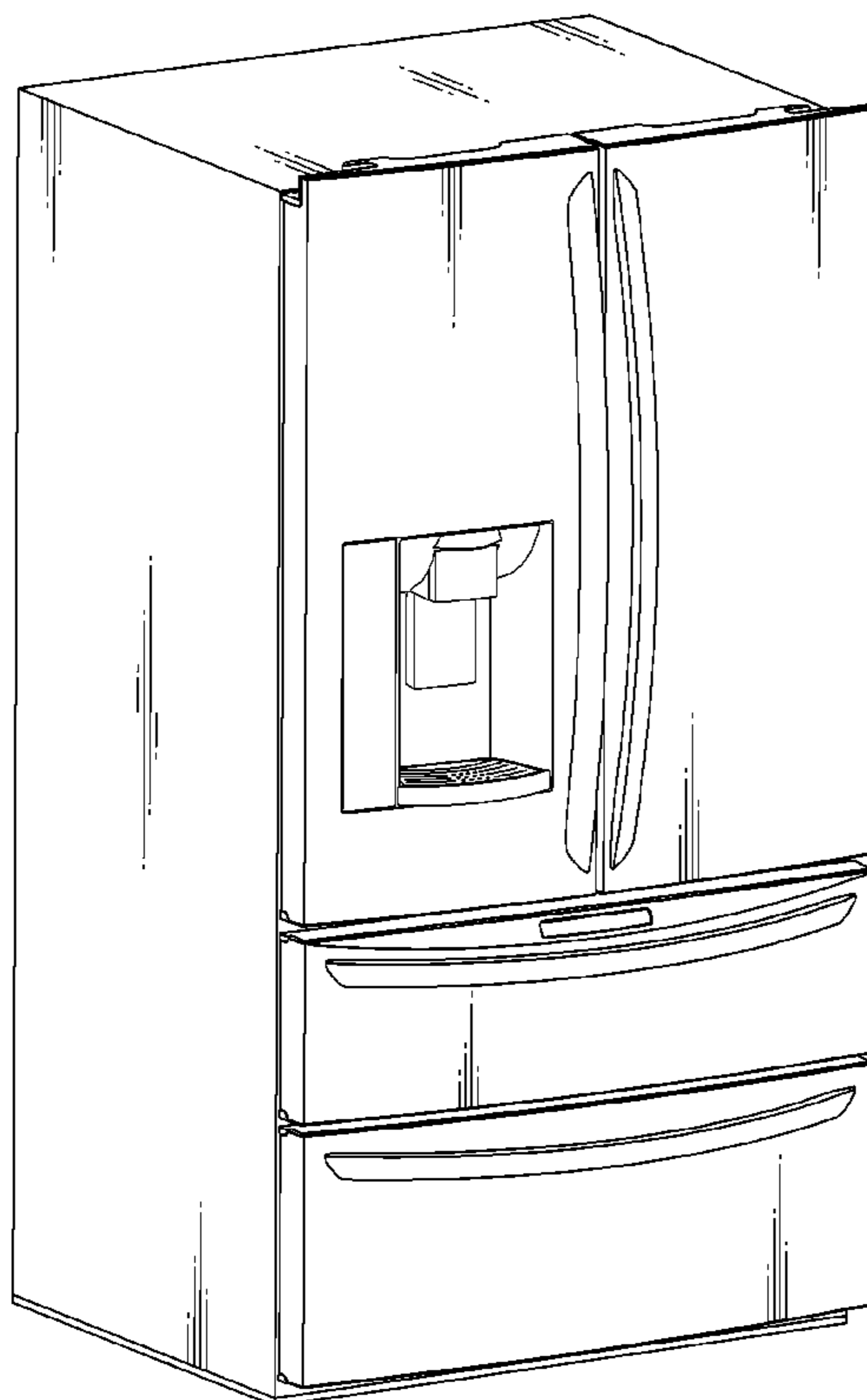

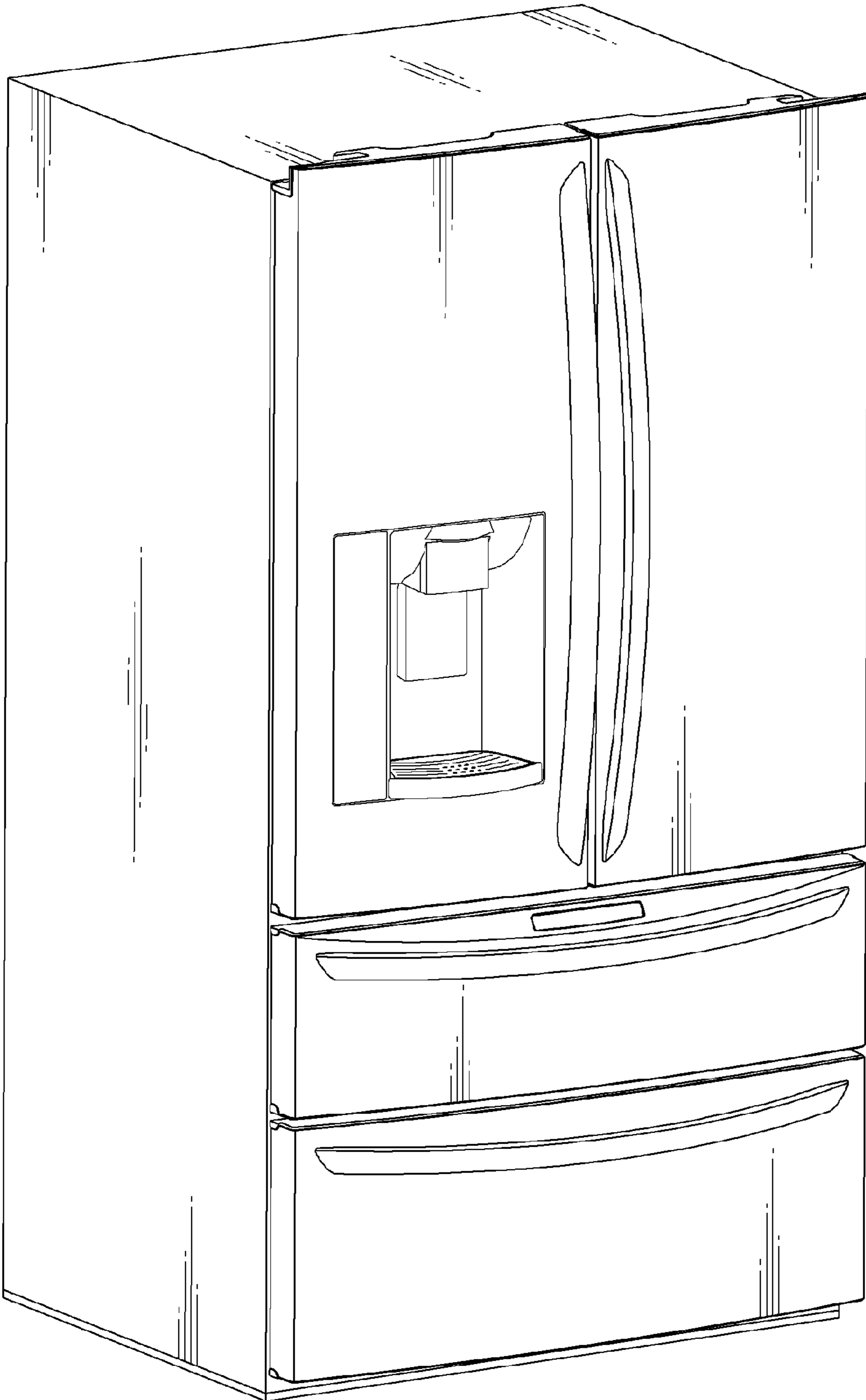

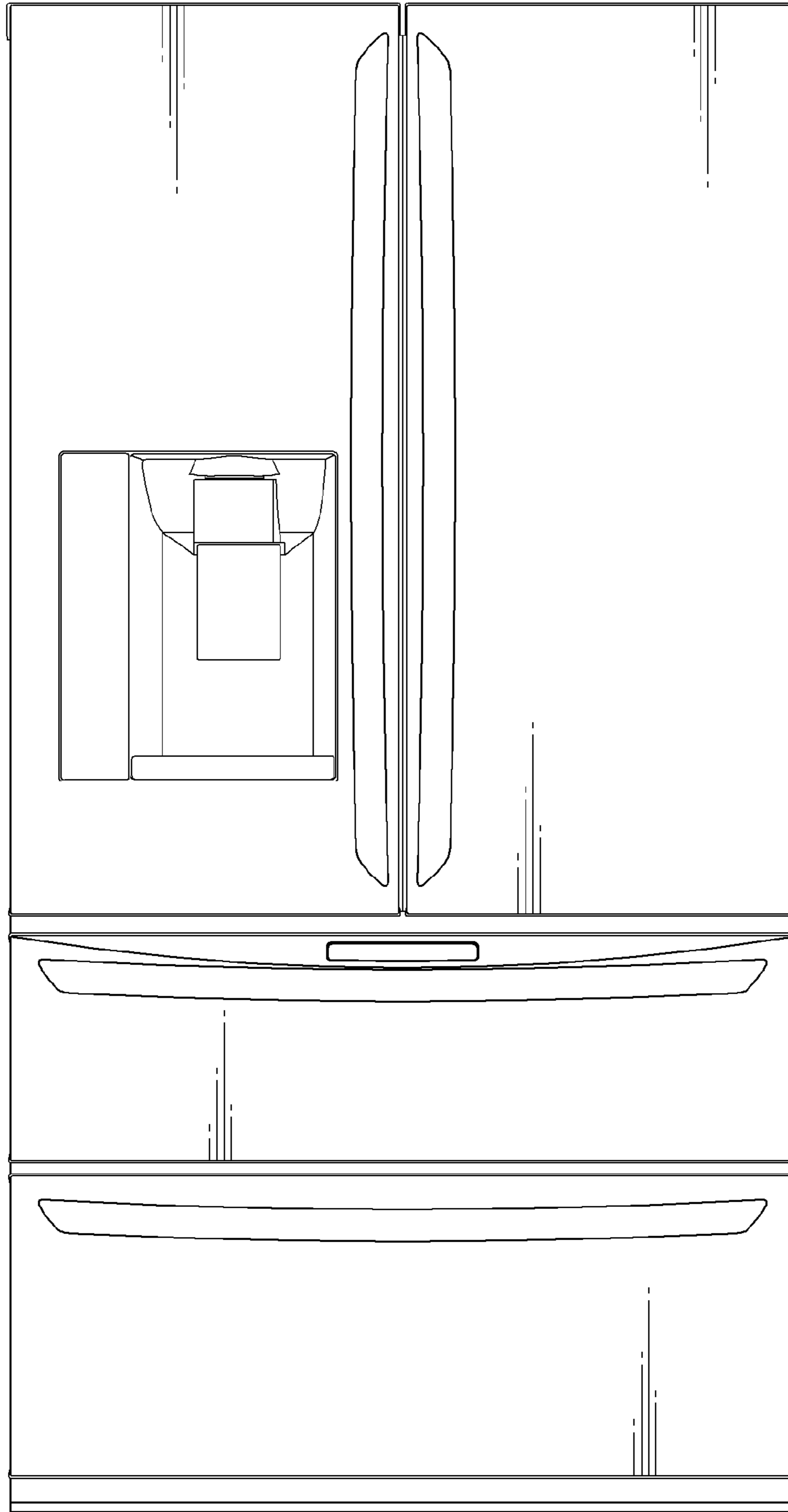

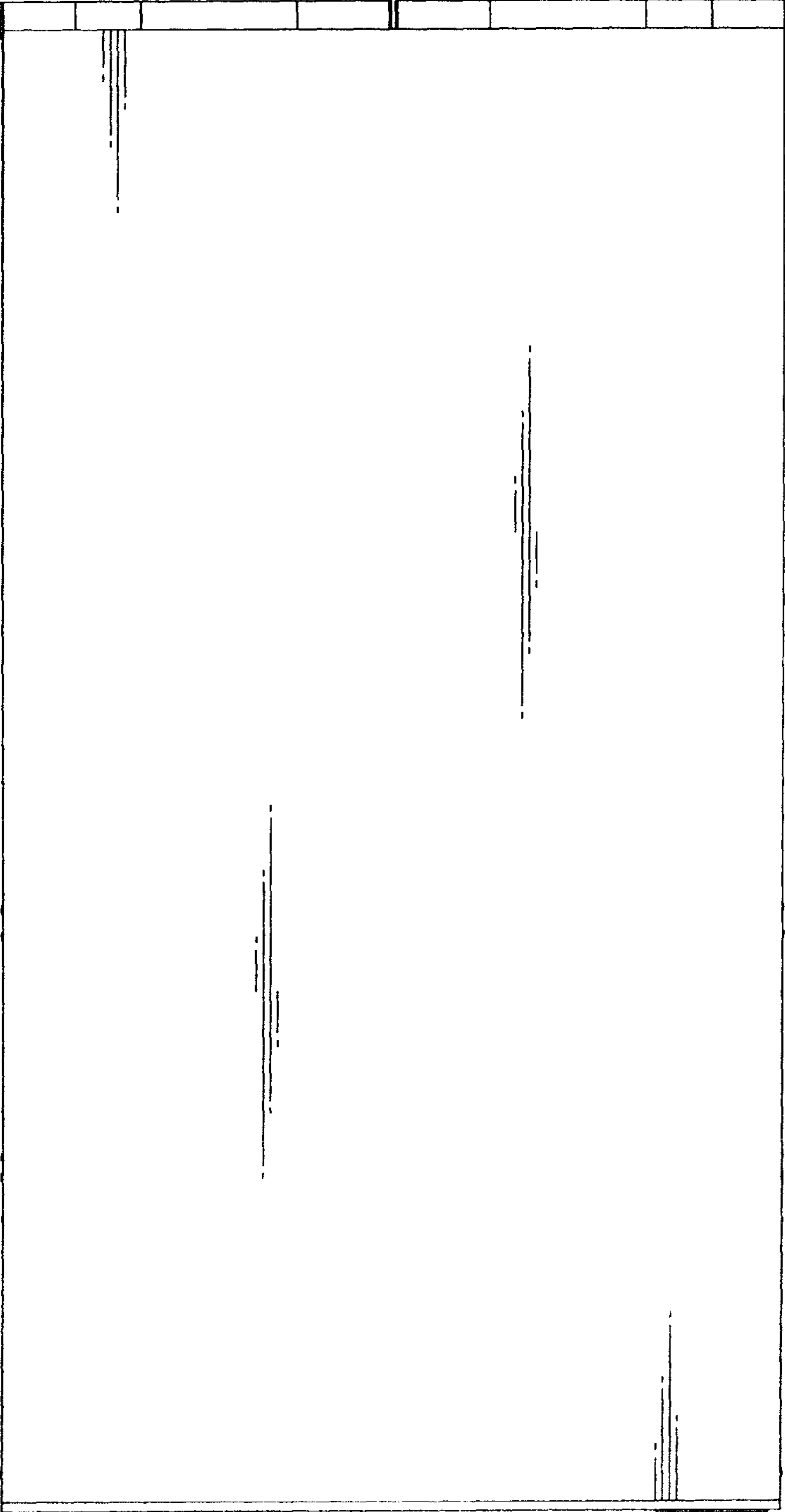

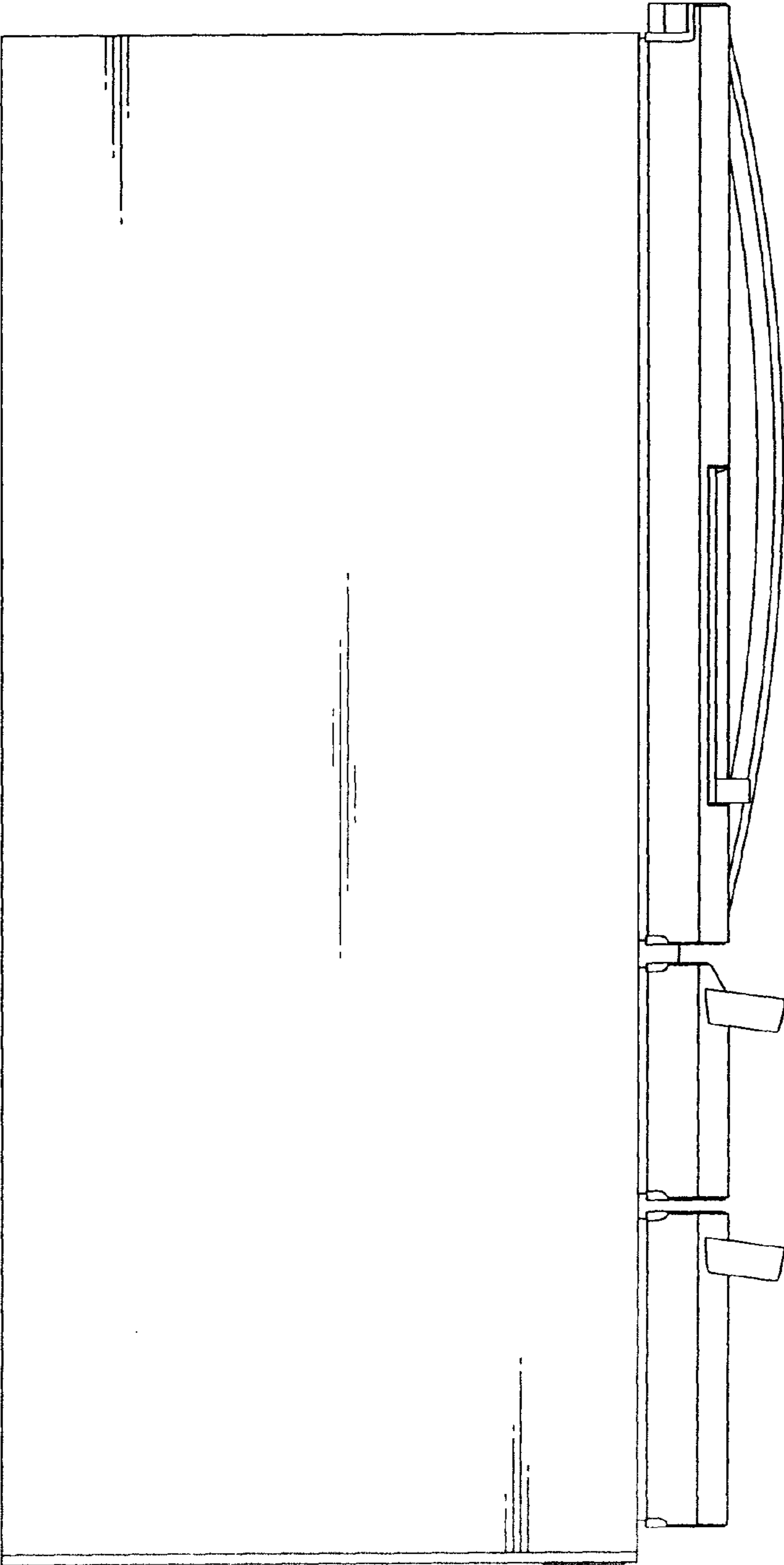

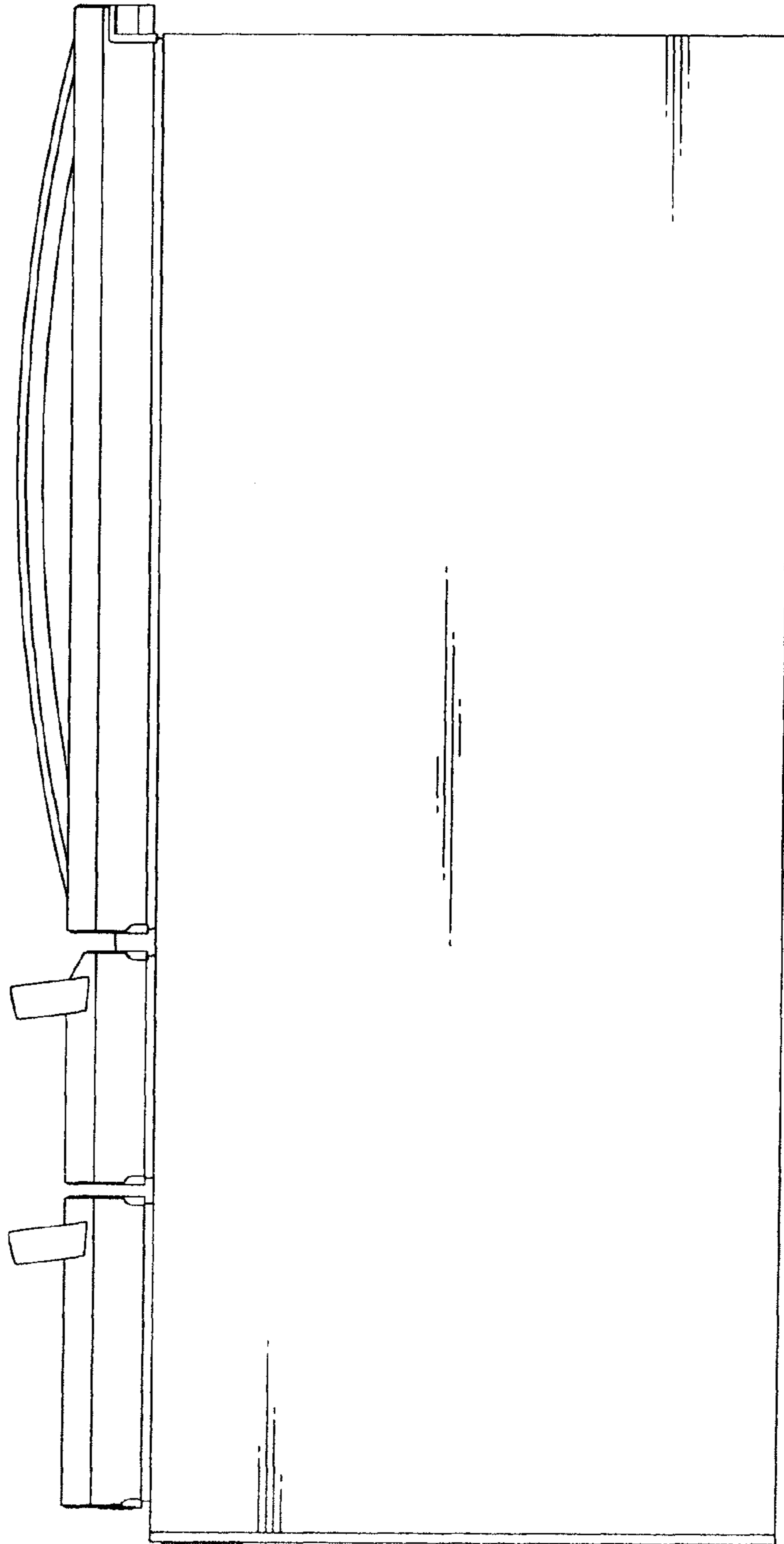

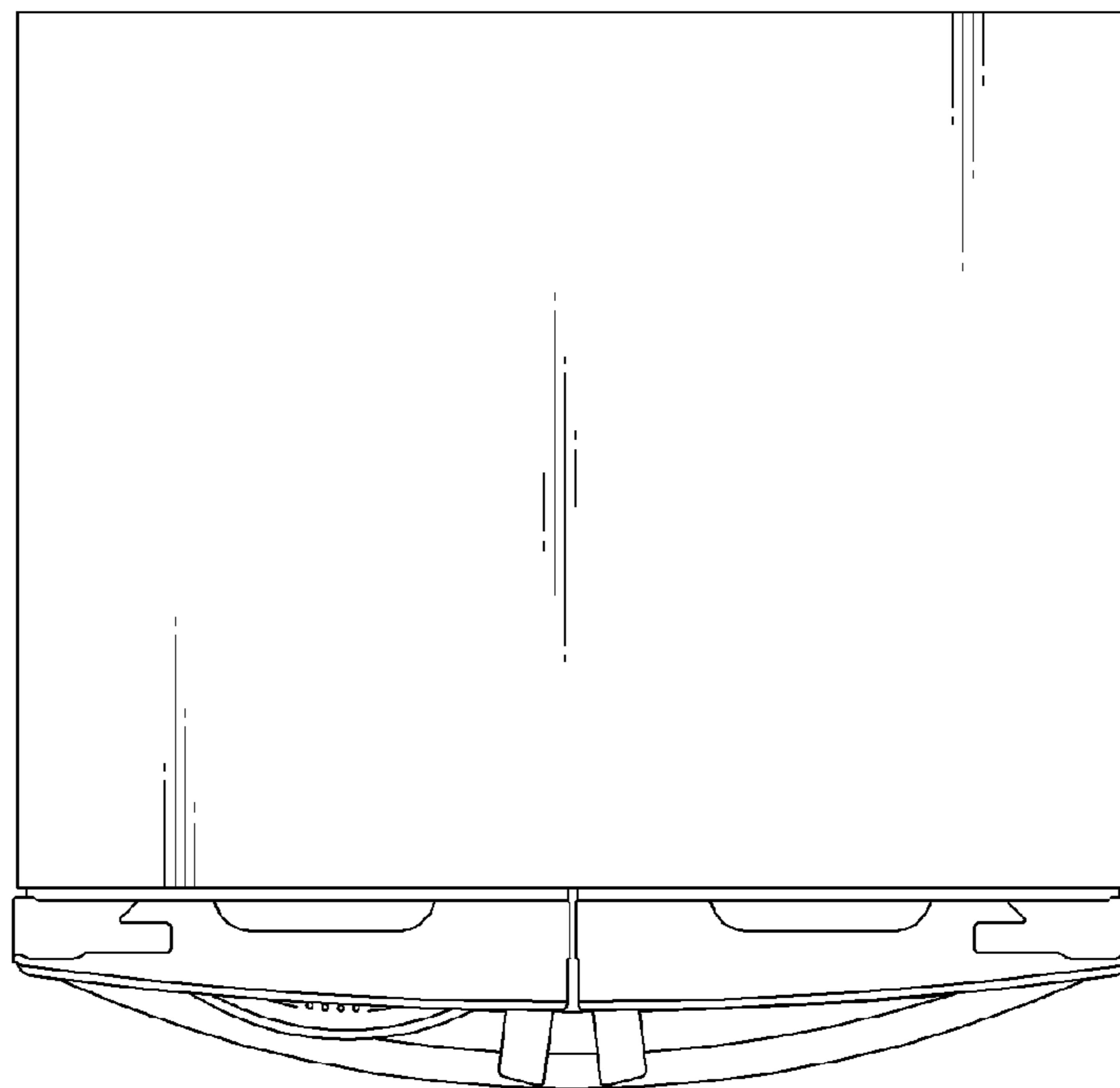
