FIG. 3 is a left side view thereof,

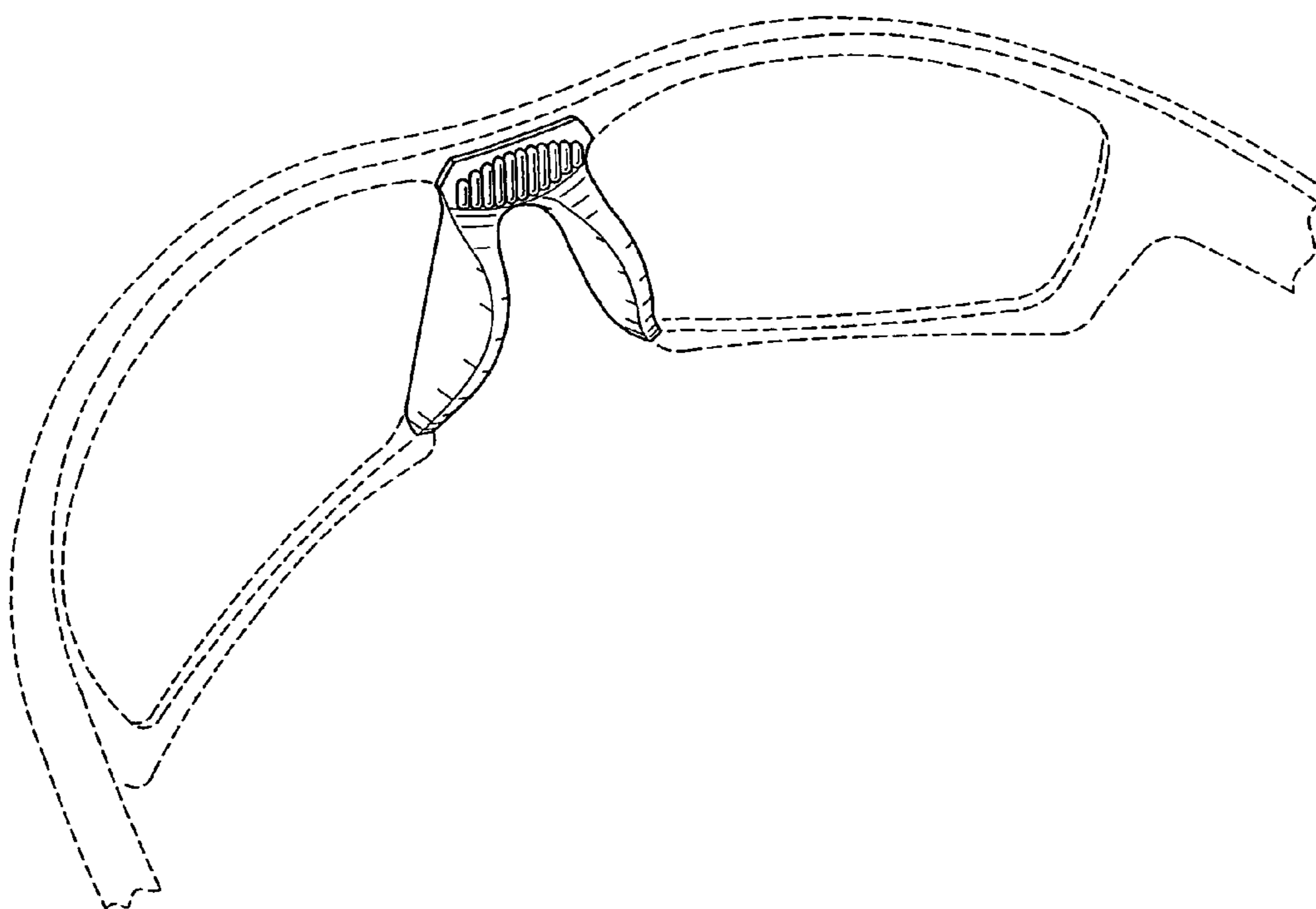
FIG. 4 is a right side view thereof,

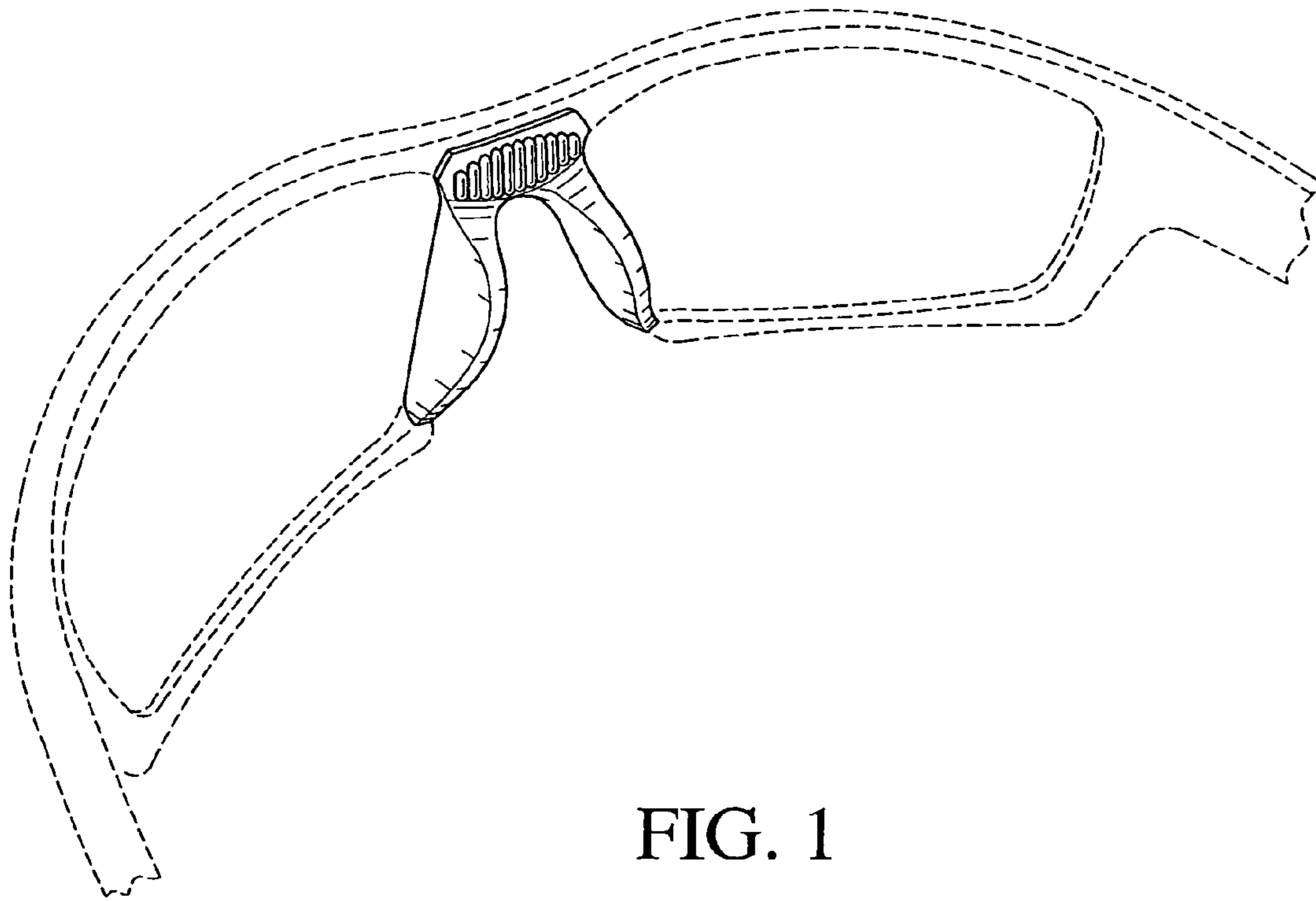

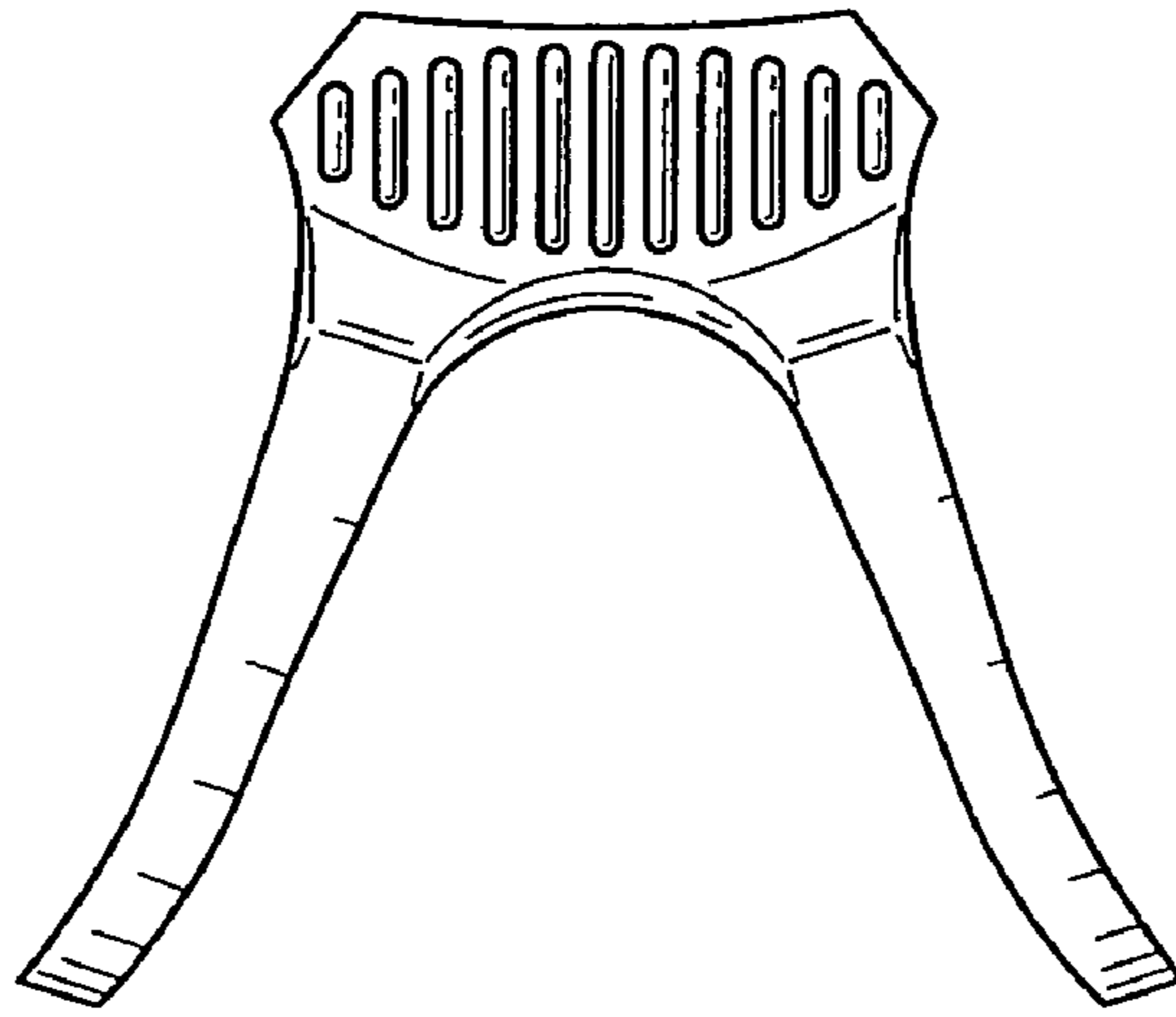

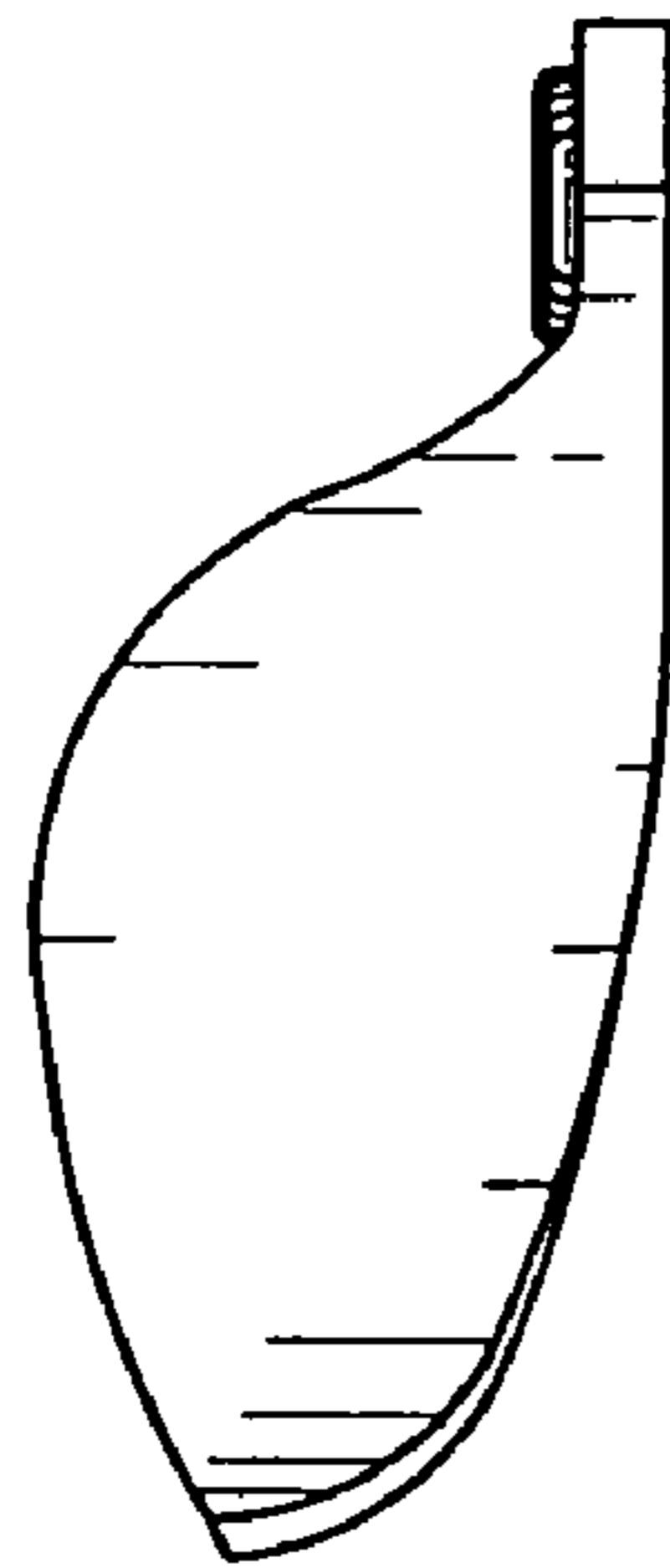

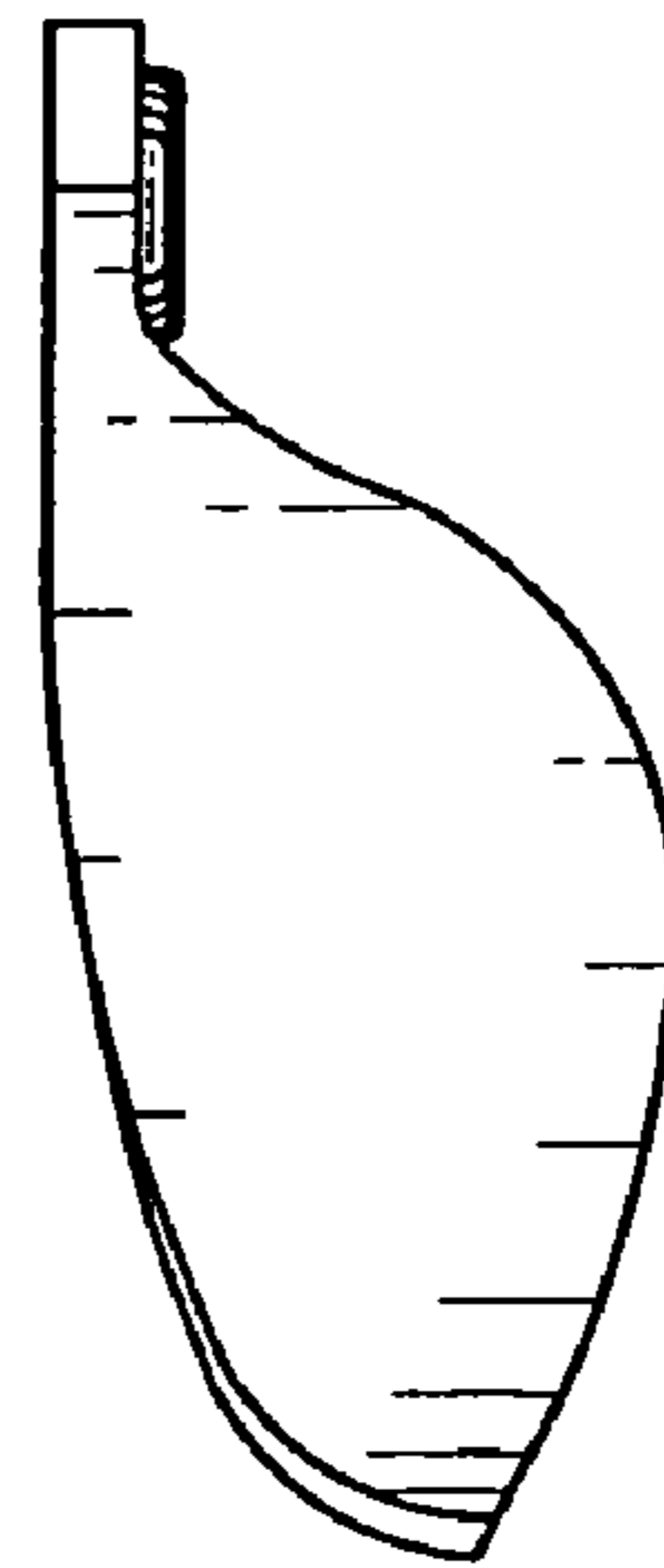

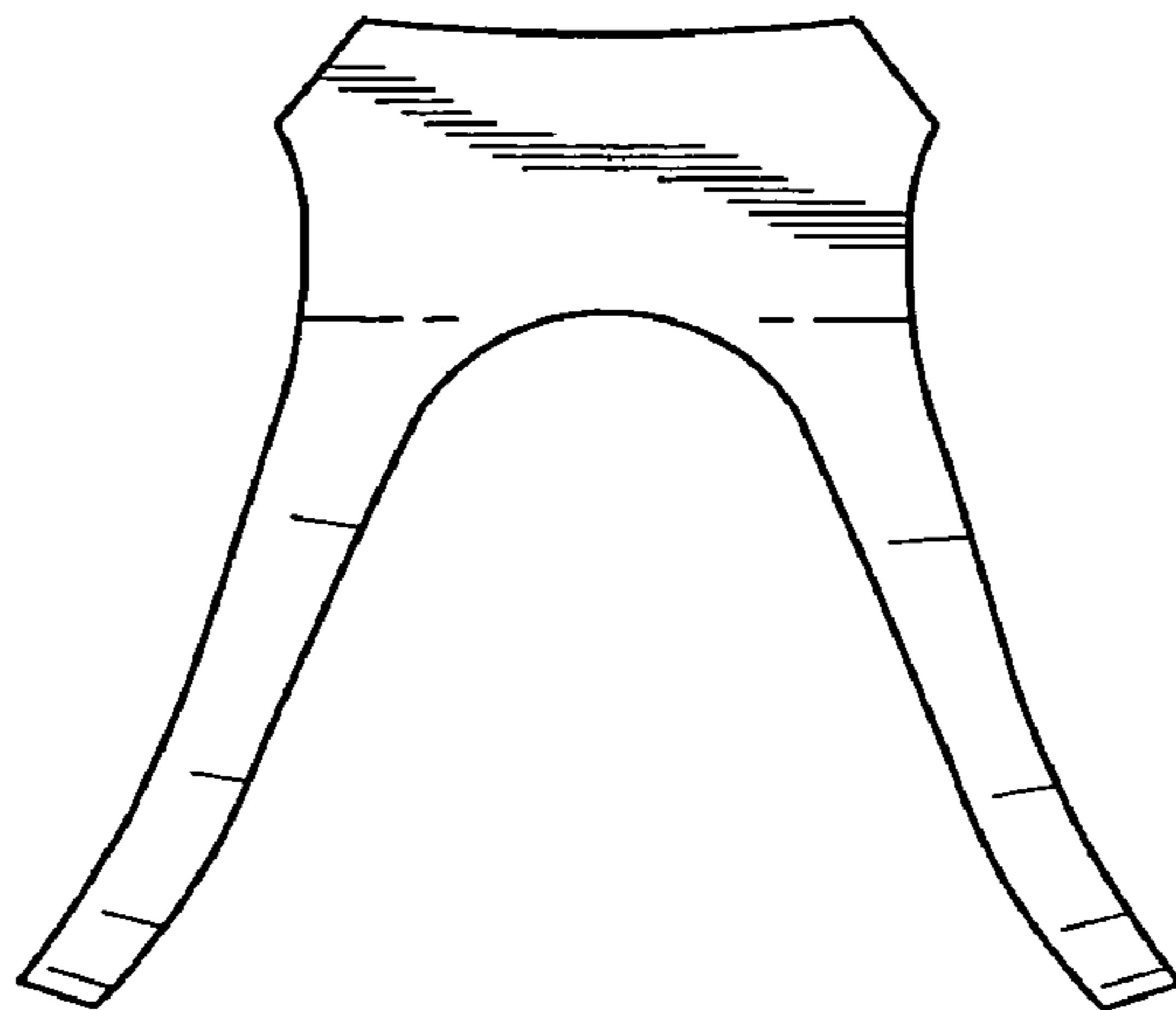

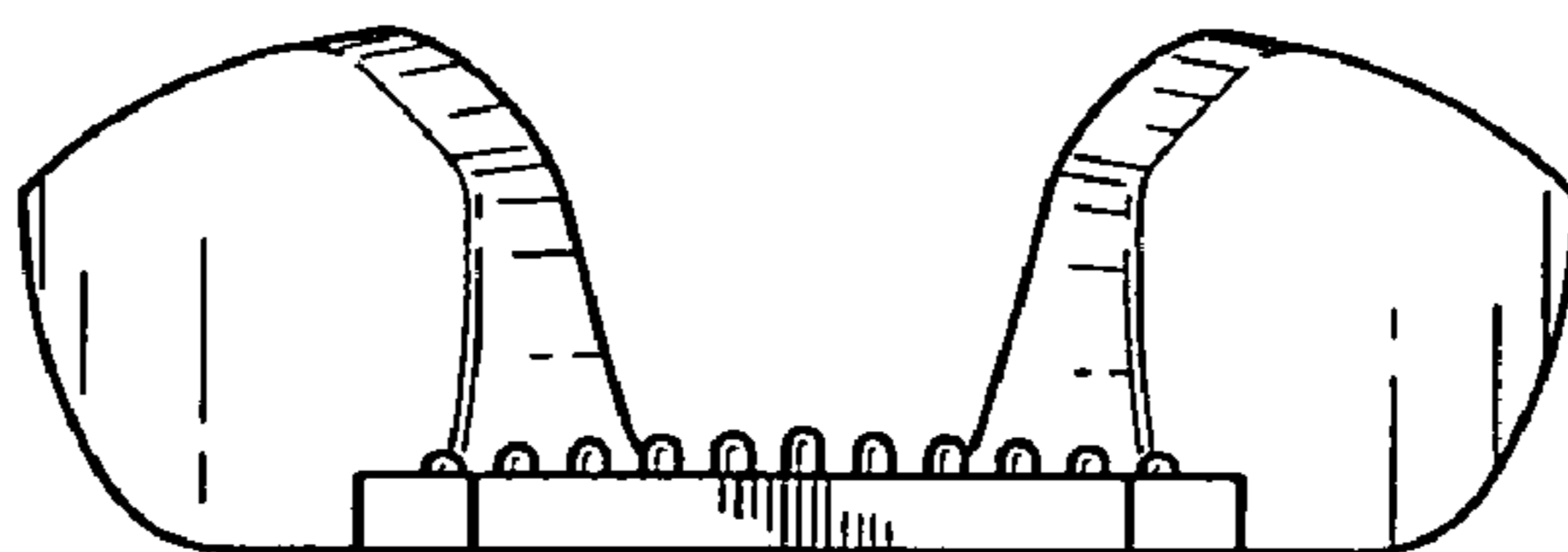

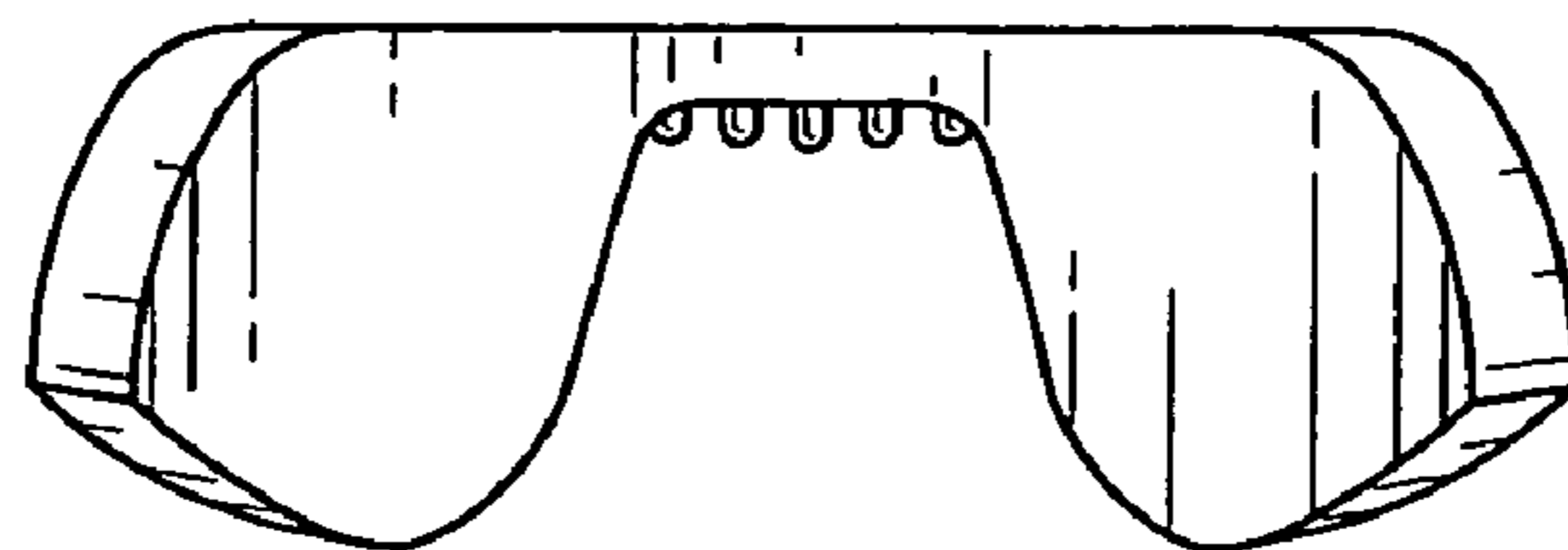
