FIG. 6 is the top plan view thereof; and,

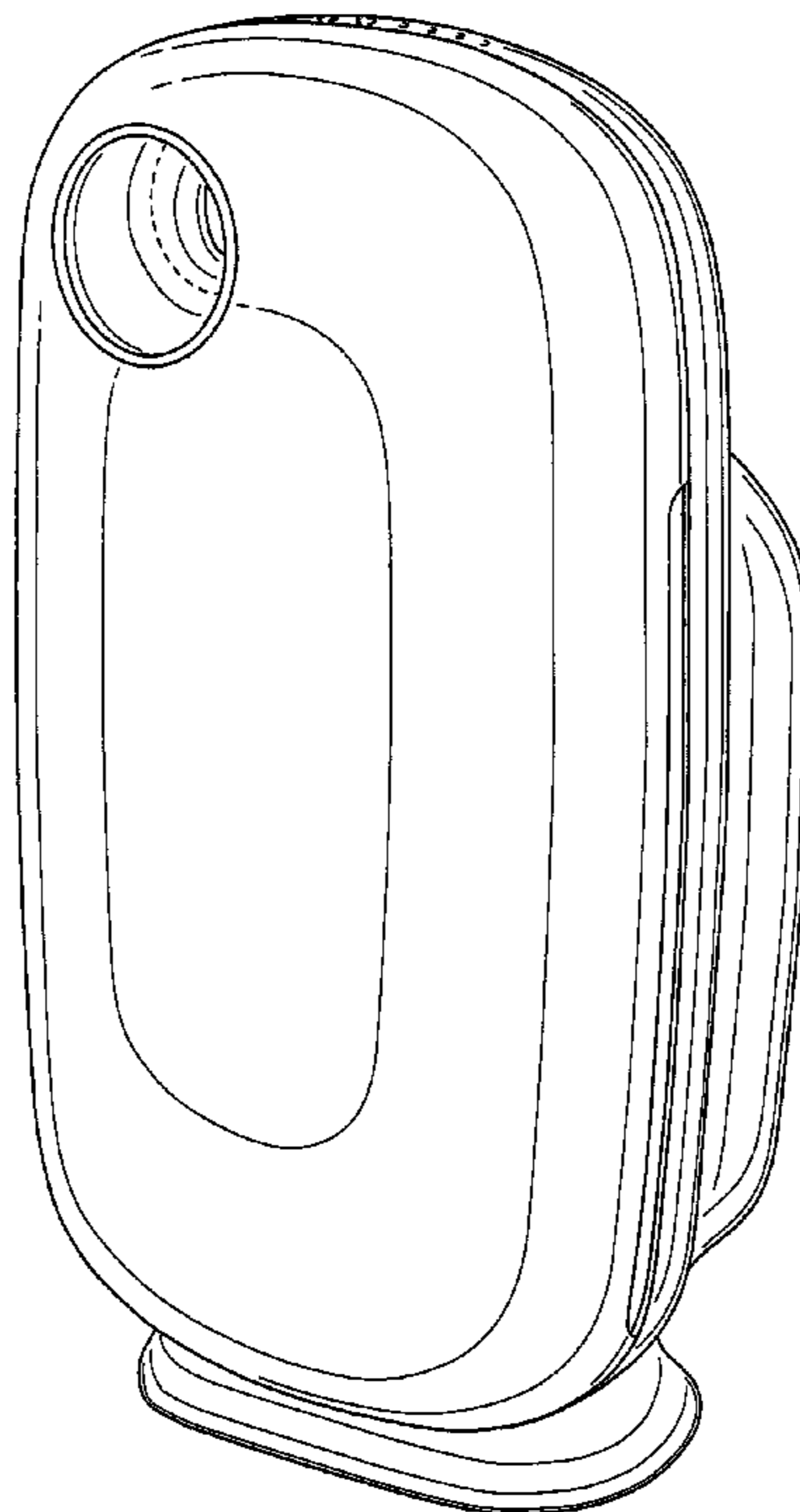
FIG. 7 is the bottom view thereof.

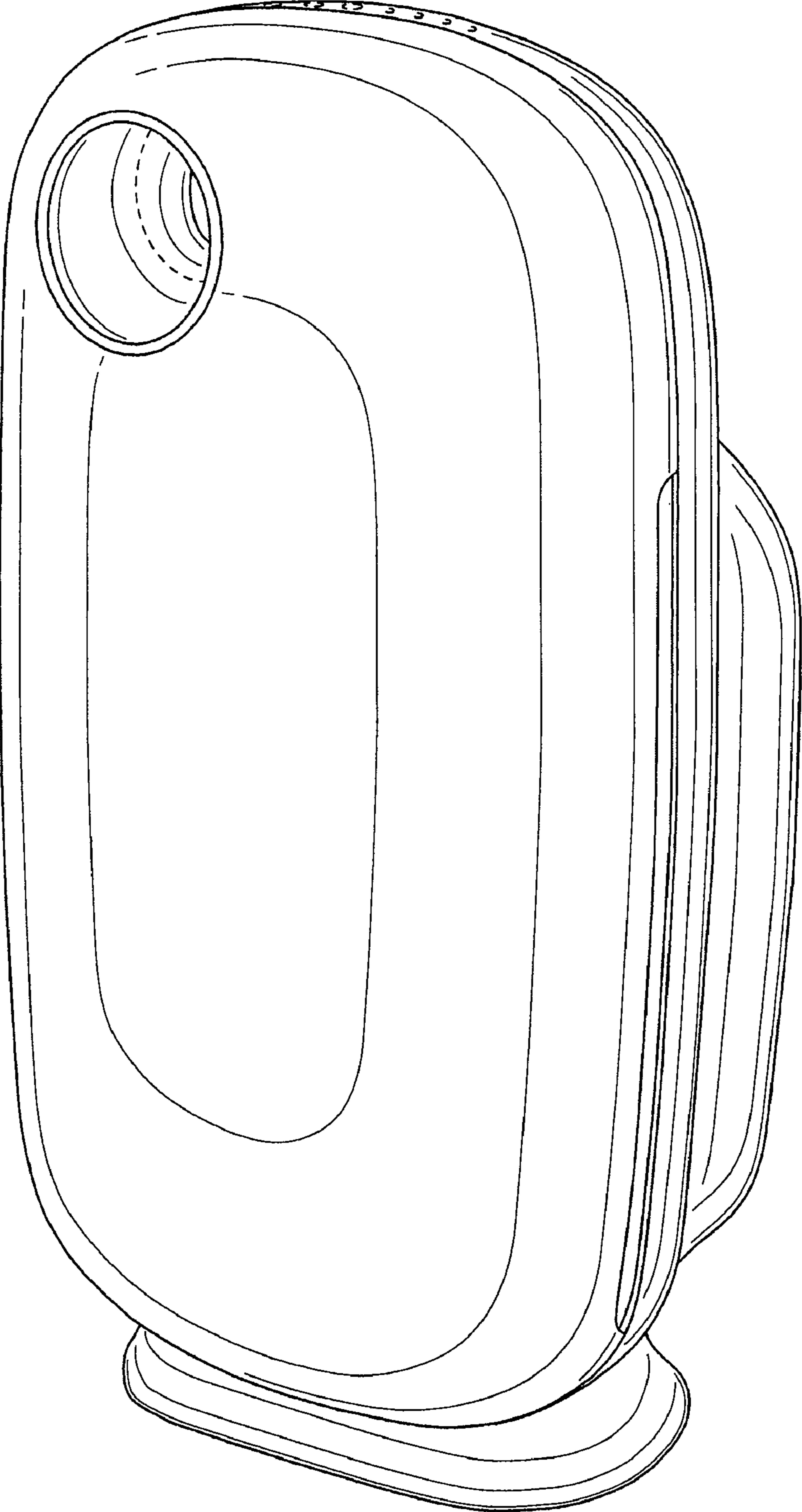

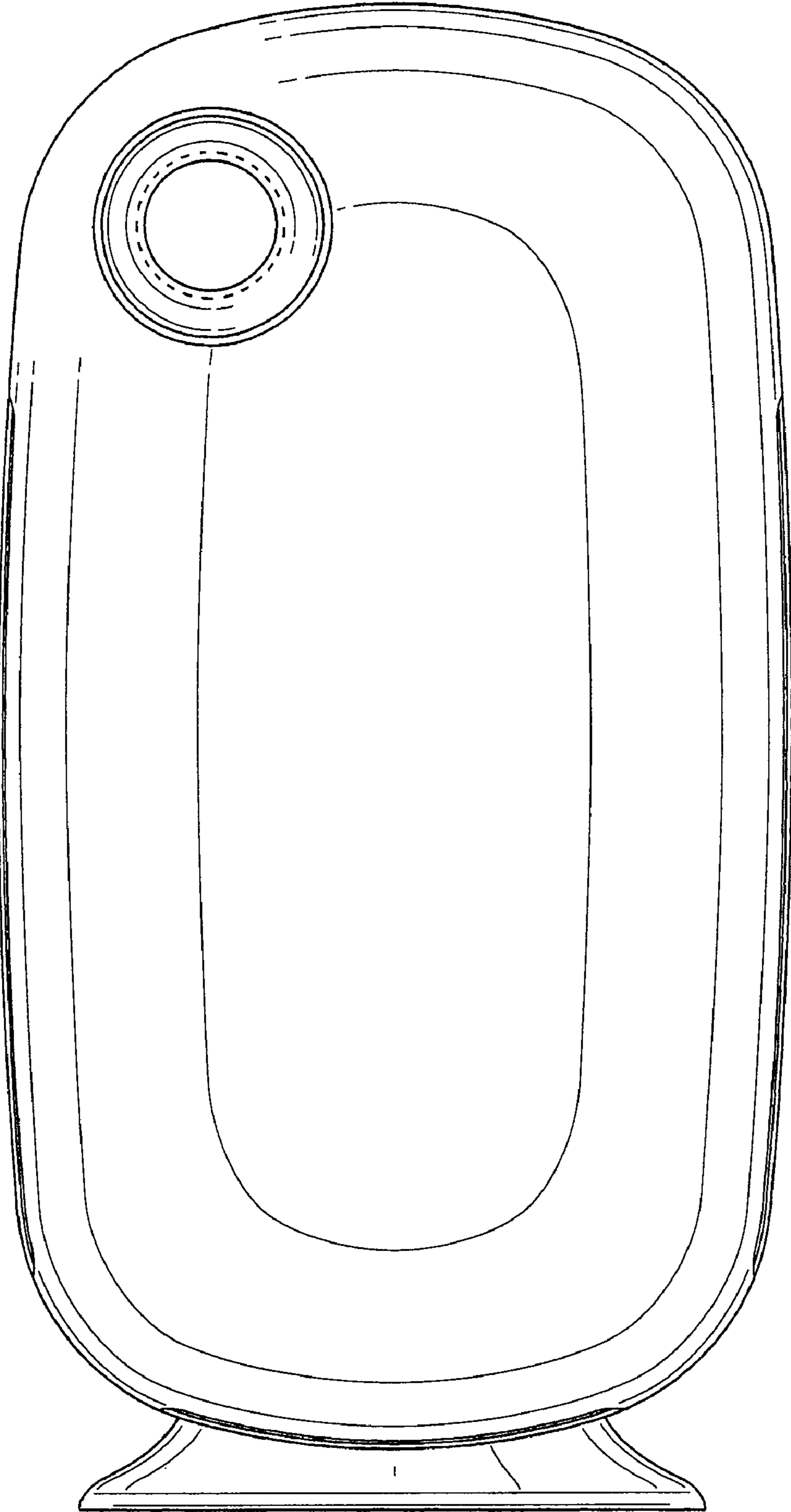

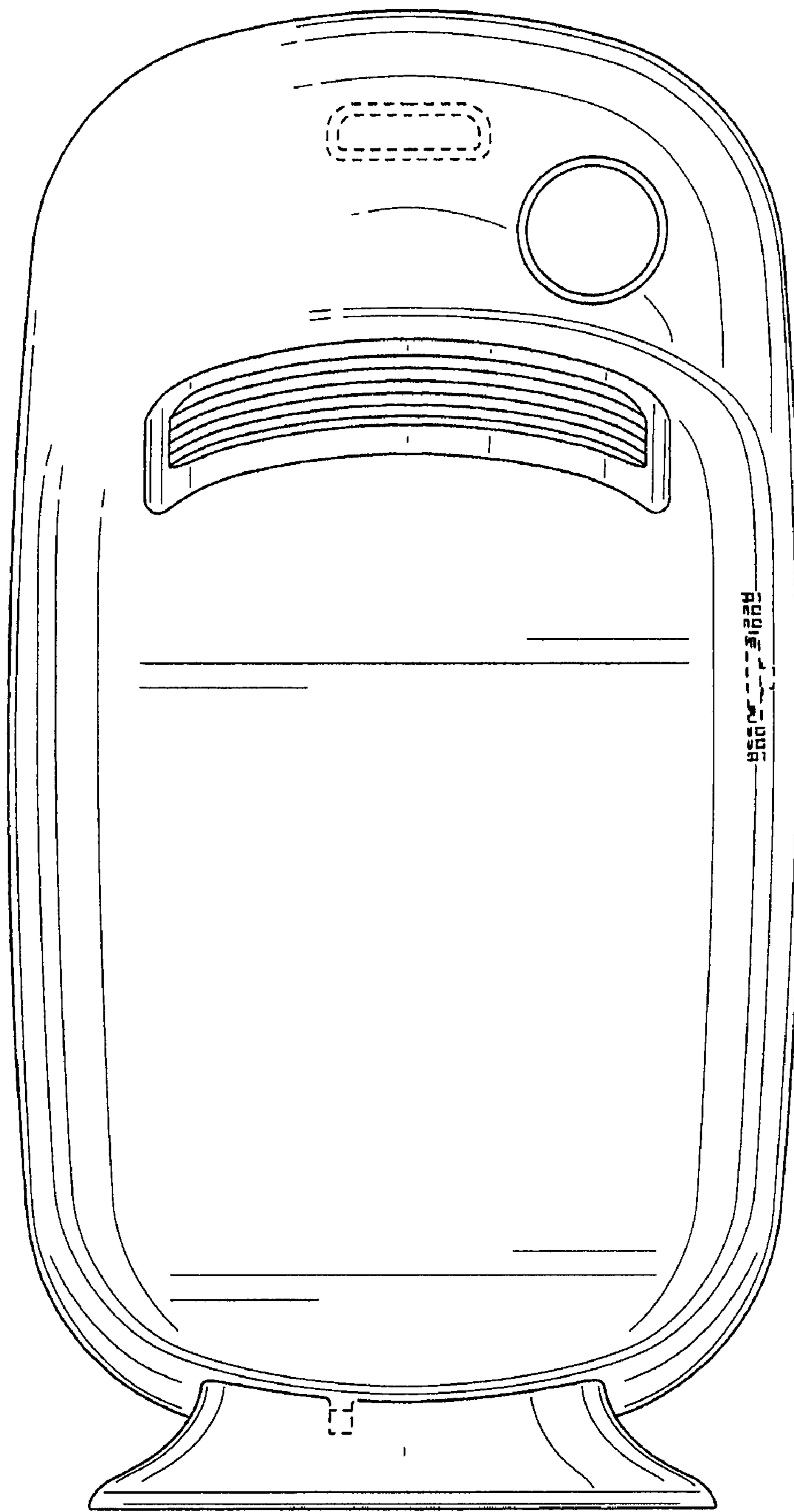

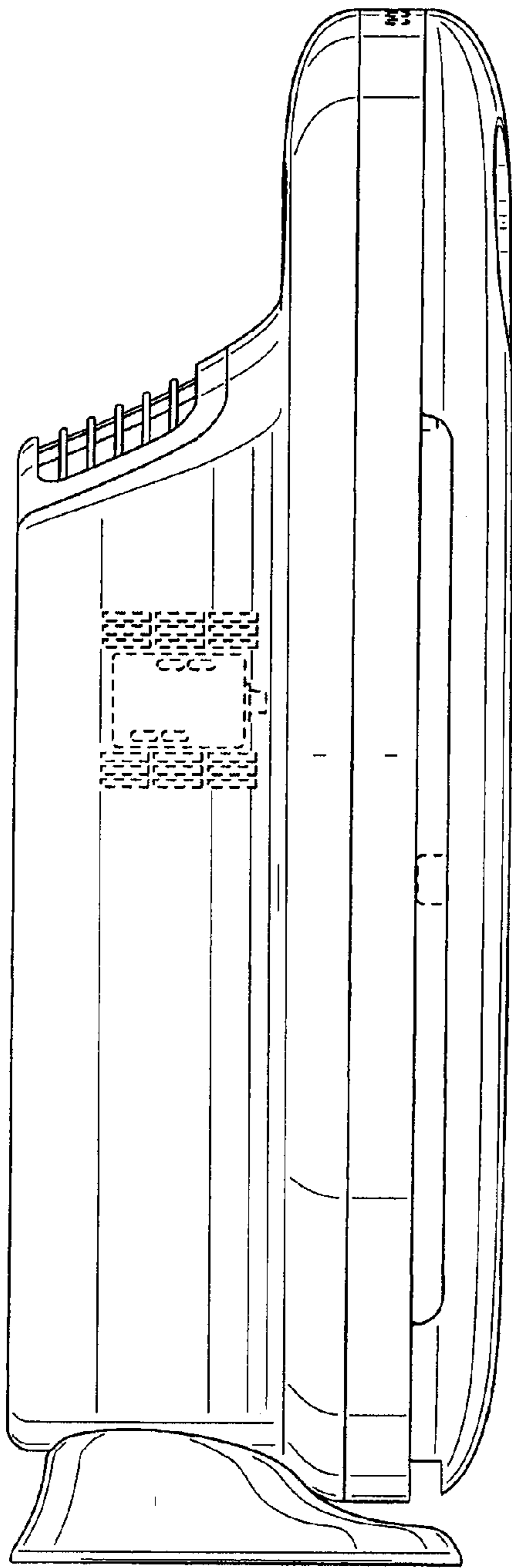

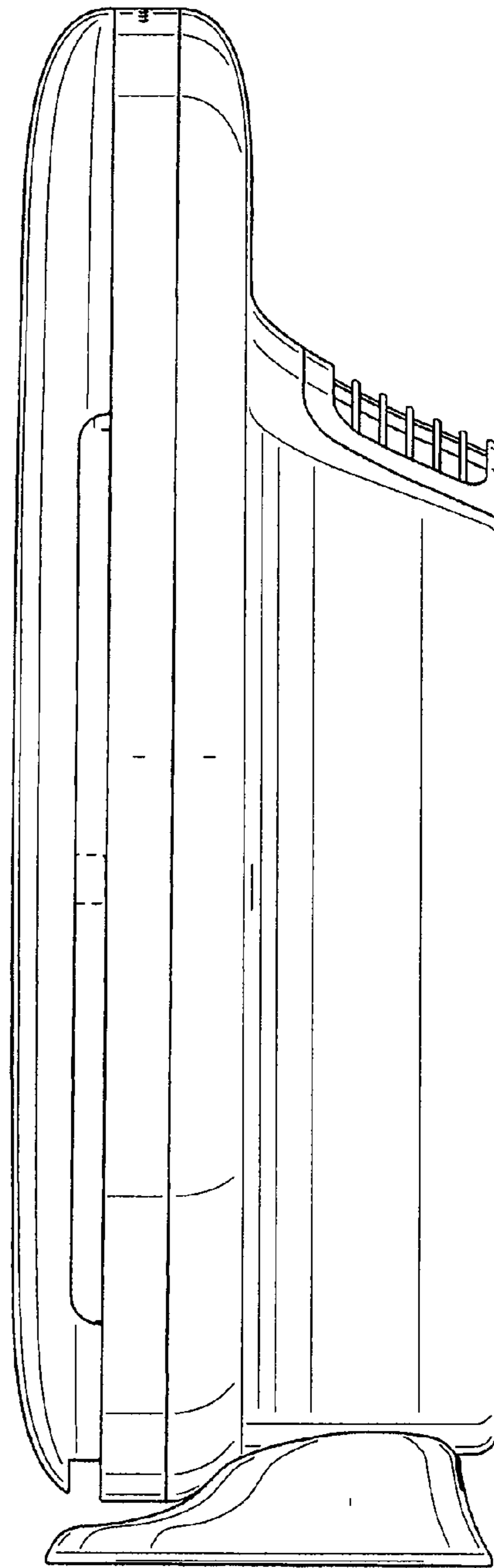

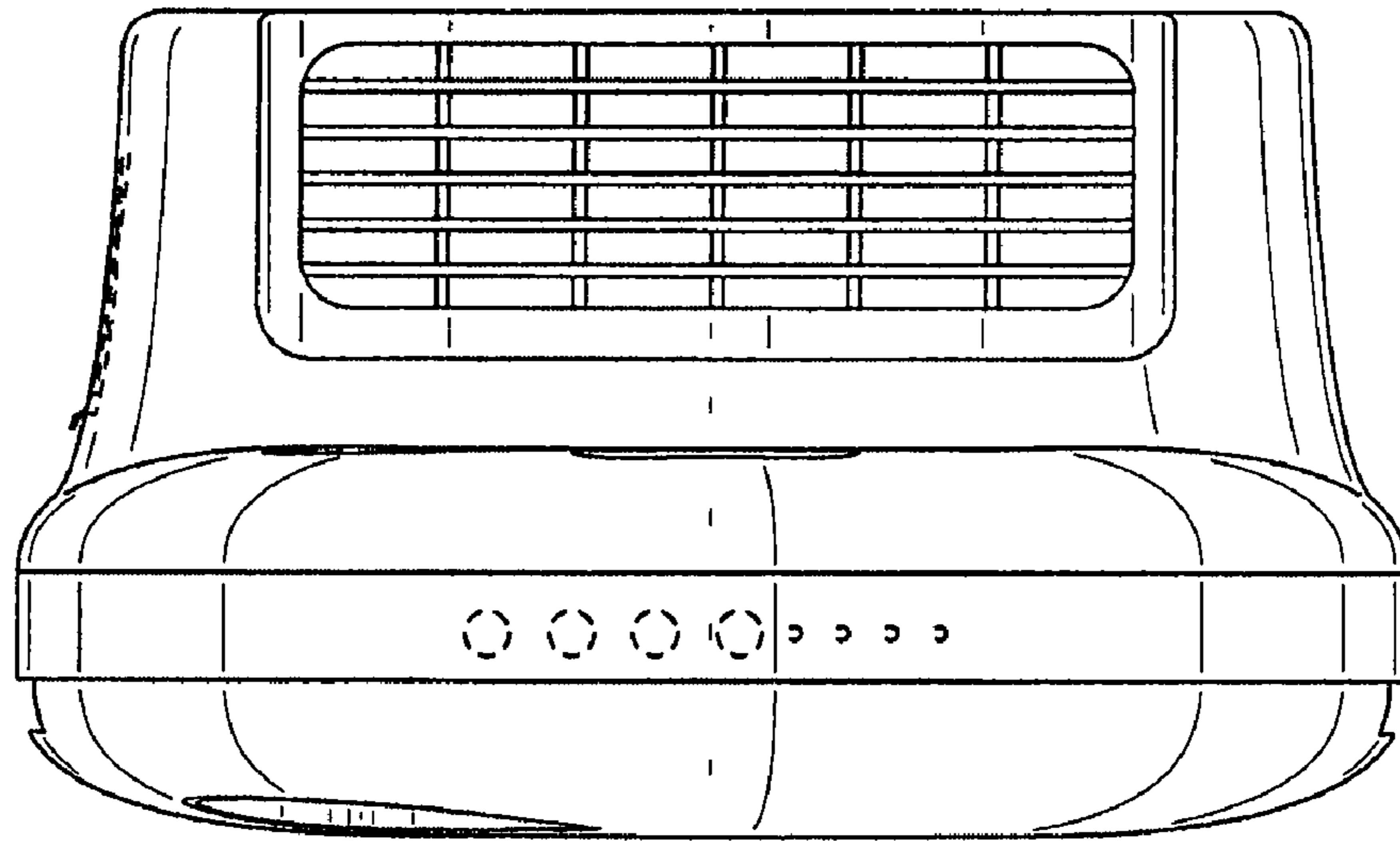

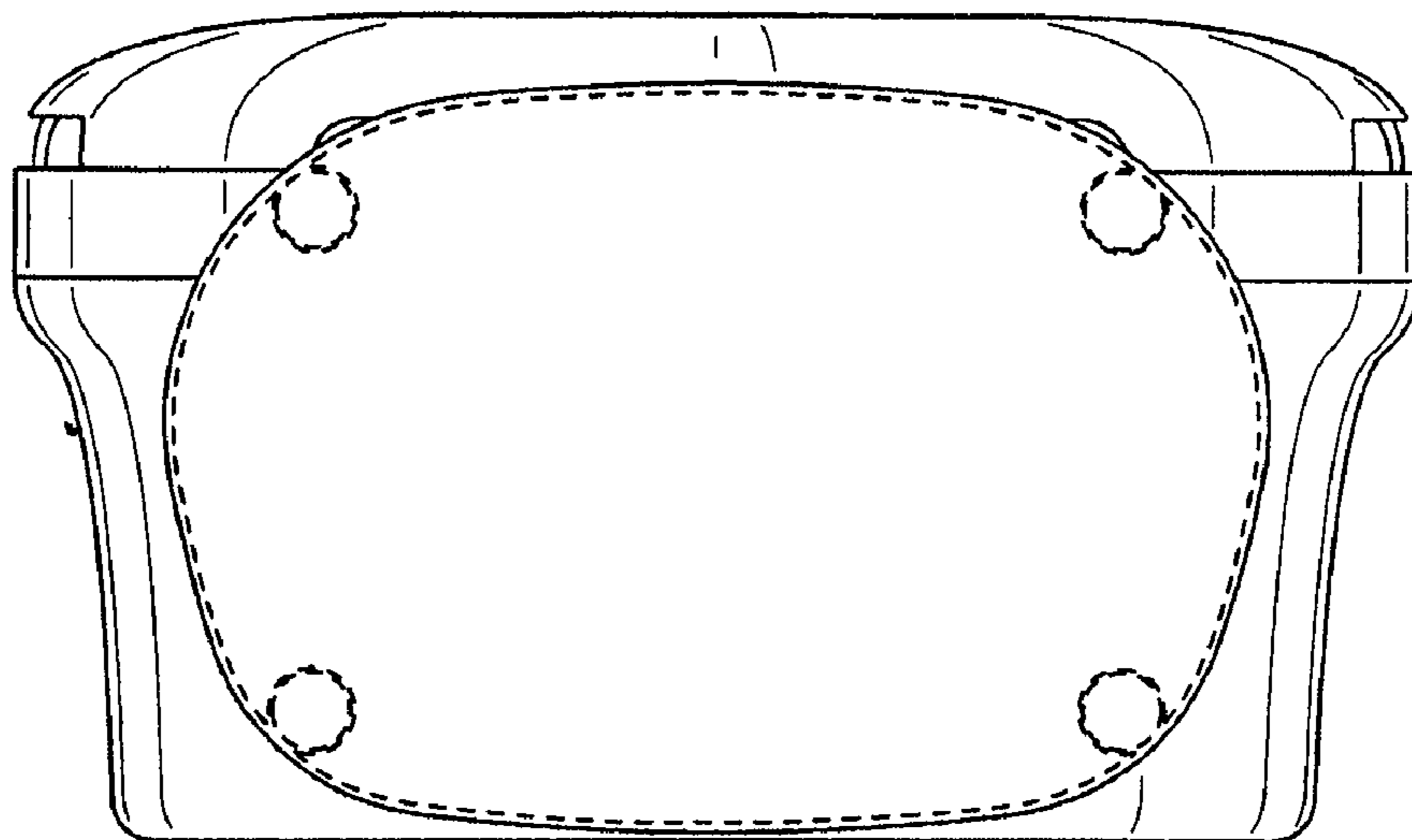
