FIG. 5 is a side view of the tongue stick of FIG. 1.

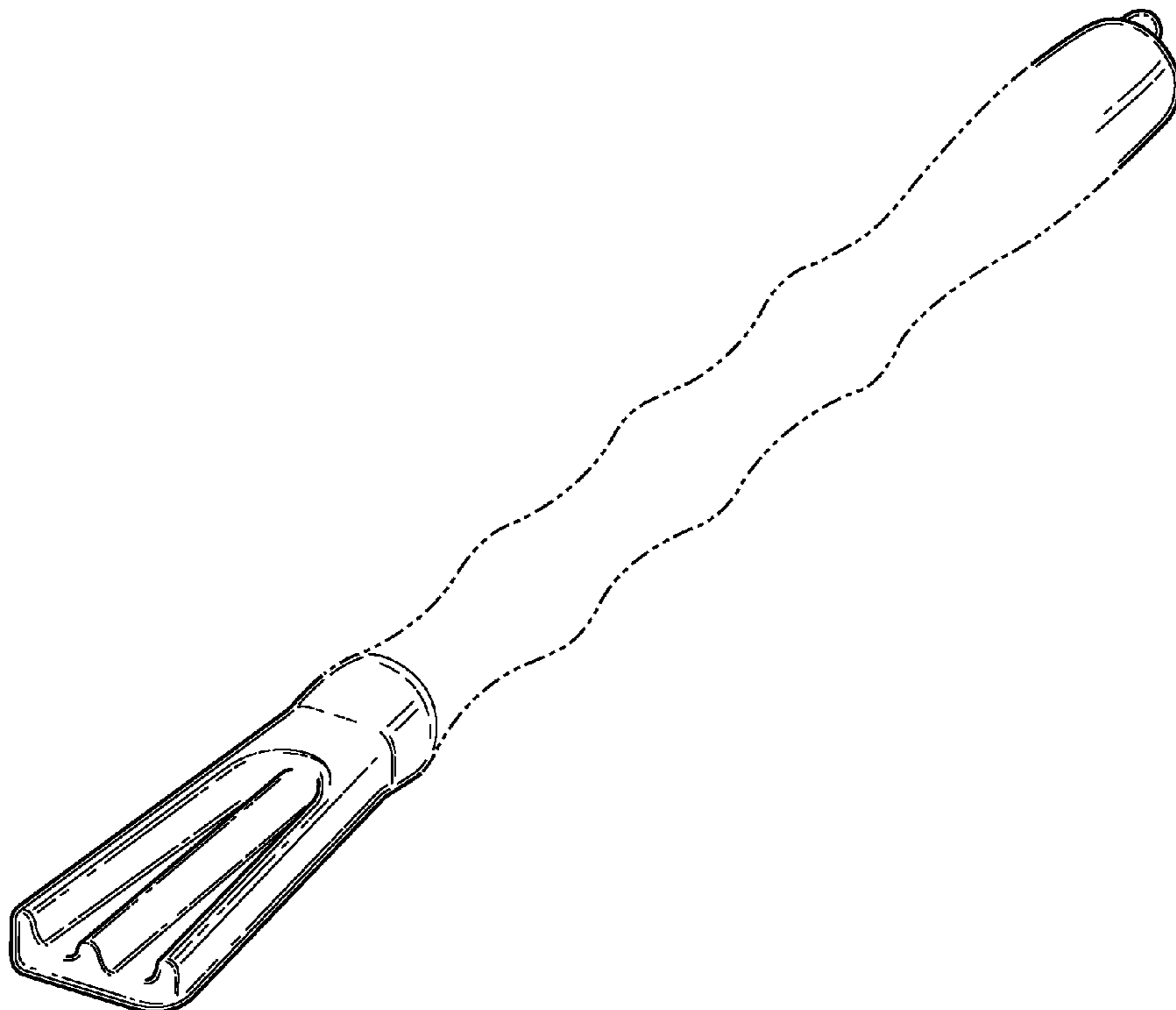
FIG. 6 is another side view of the tongue stick of FIG. 1.

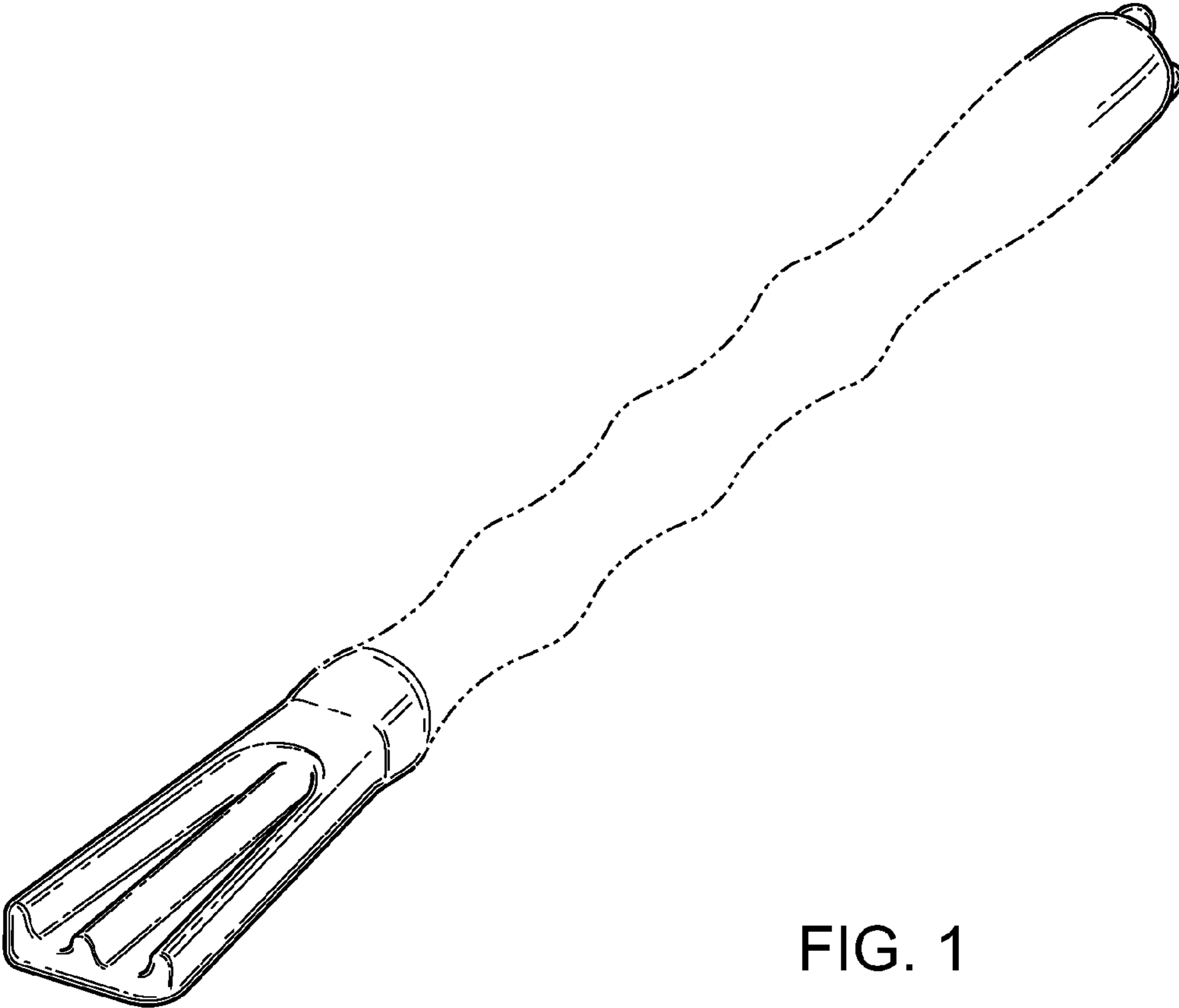

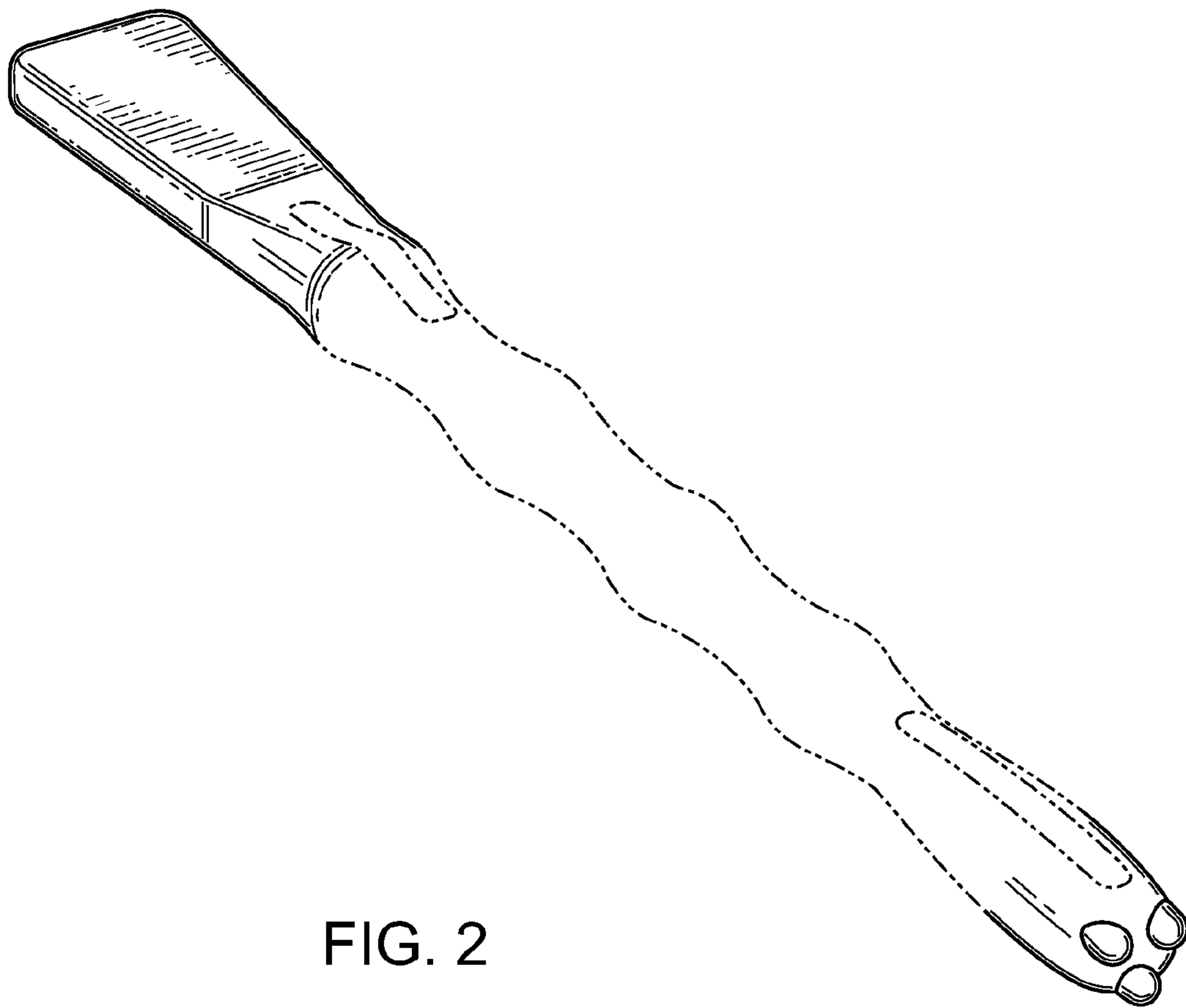

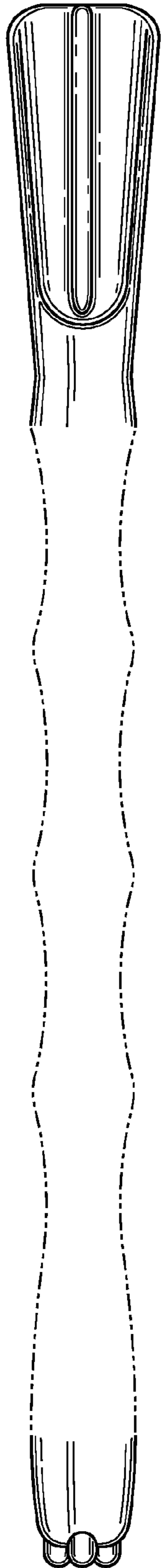

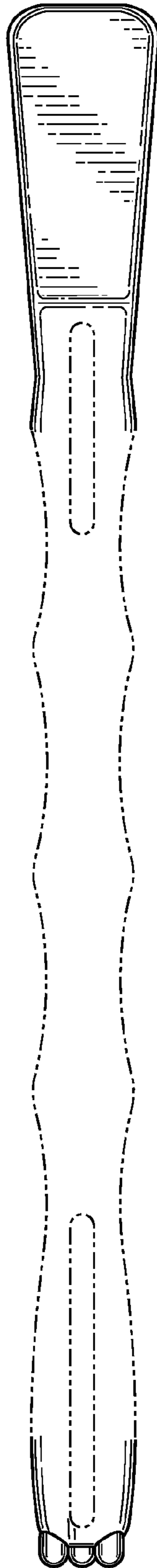

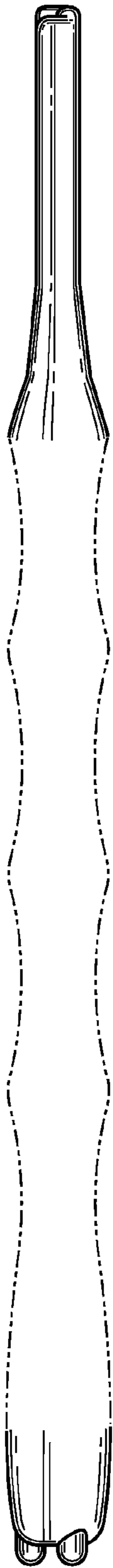

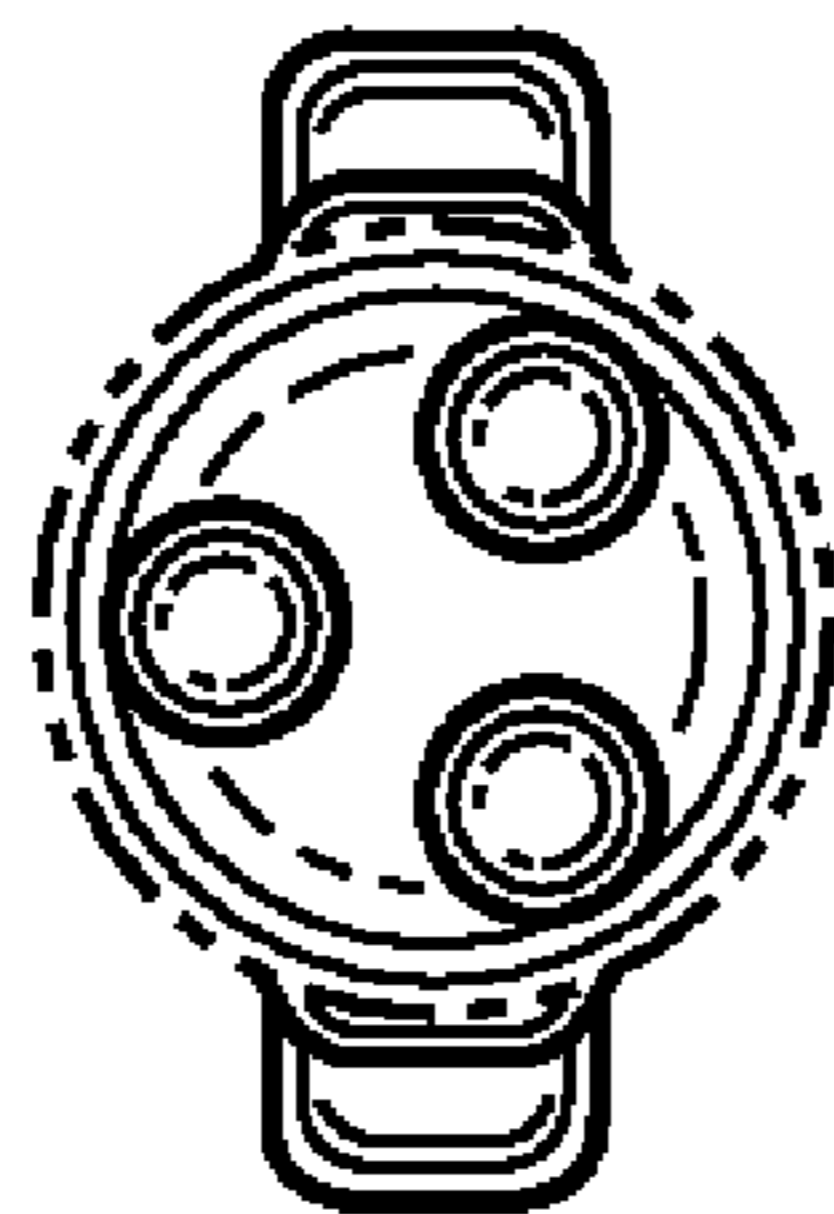
