DESCRIPTION

FIG. 1 is a bottom perspective view of a pediatric dental impression tray showing my new design;

FIG. 4 is an end elevation thereof;

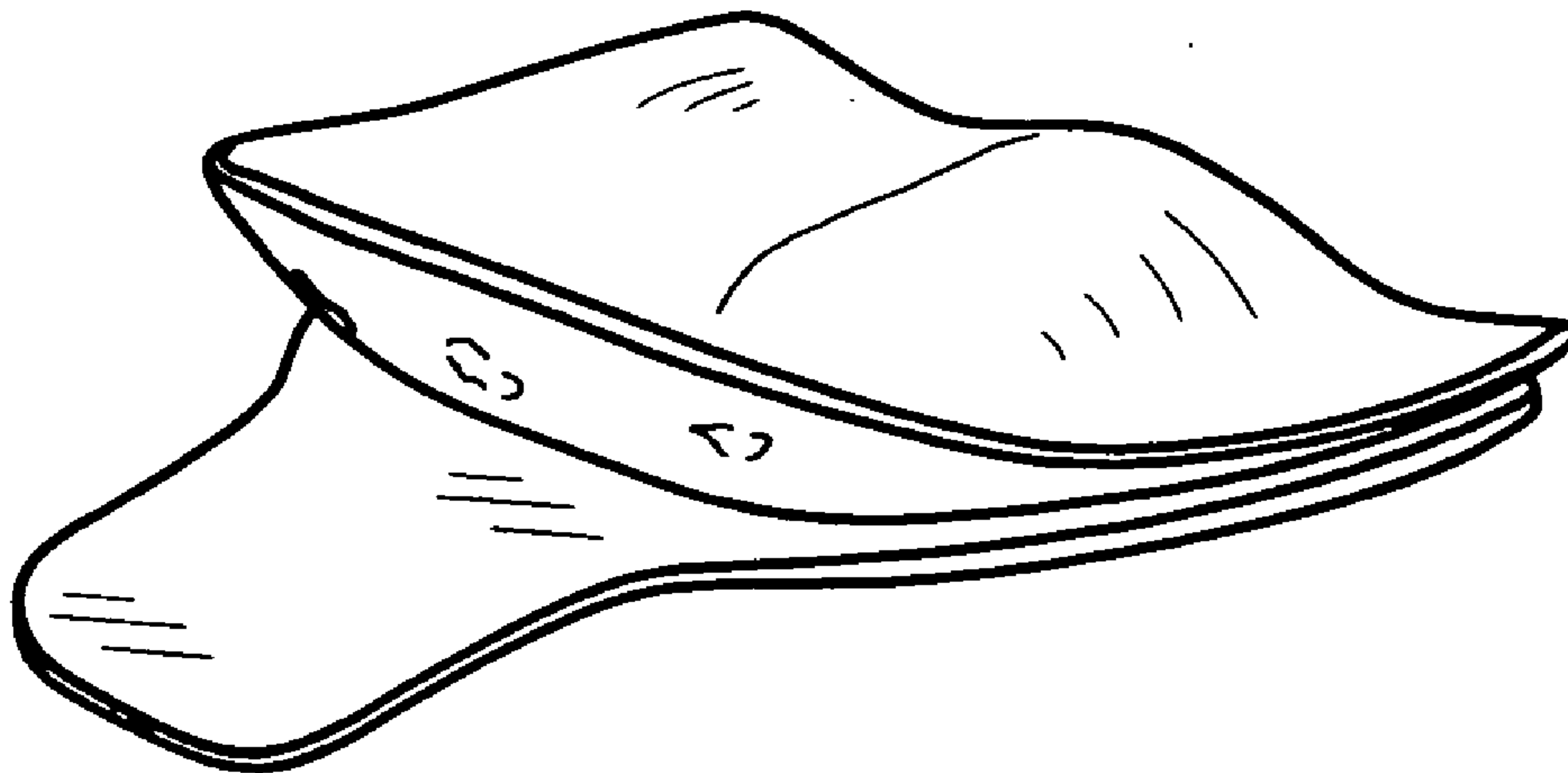
FIG. 5 is a side elevation thereof;

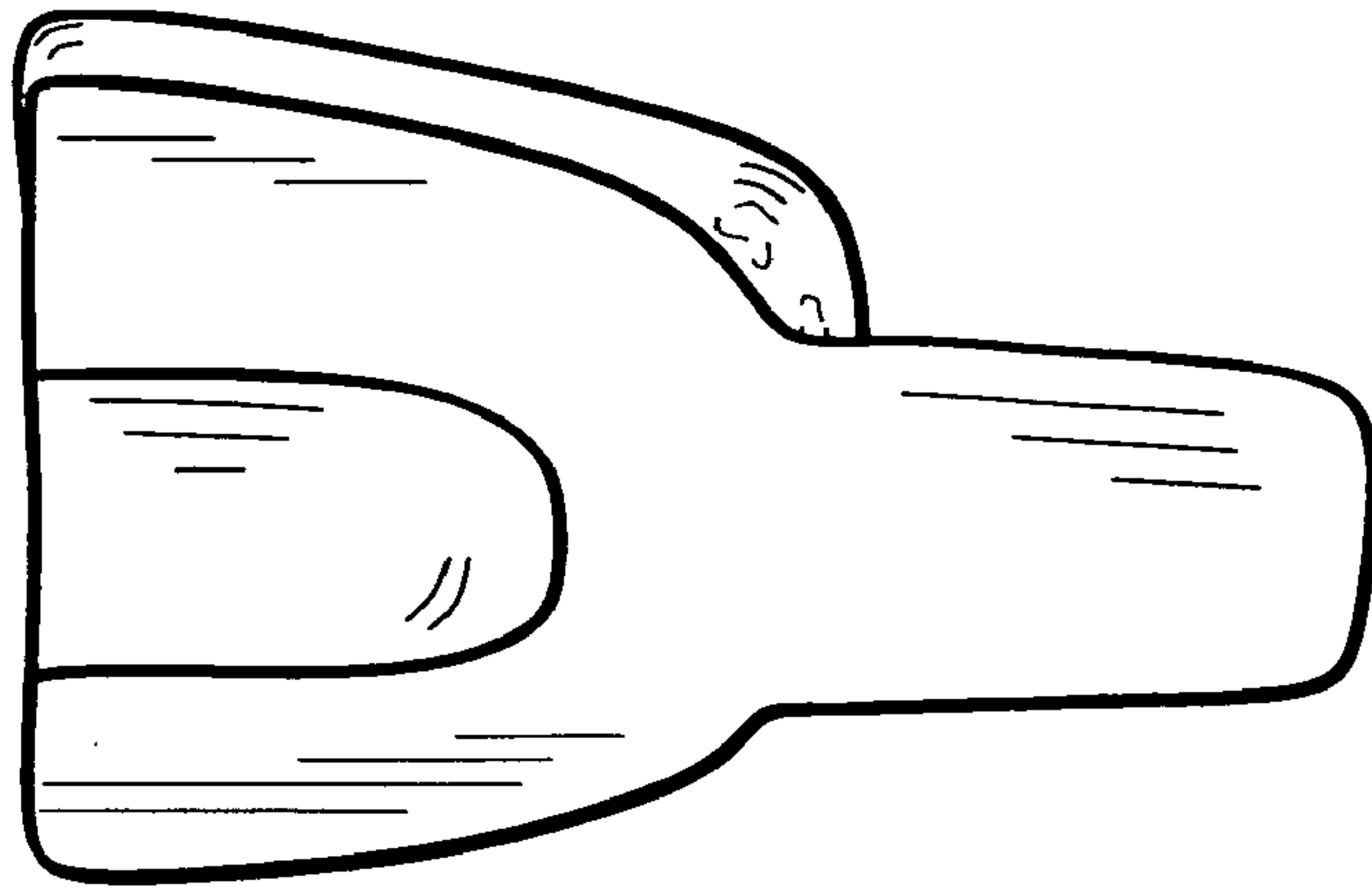

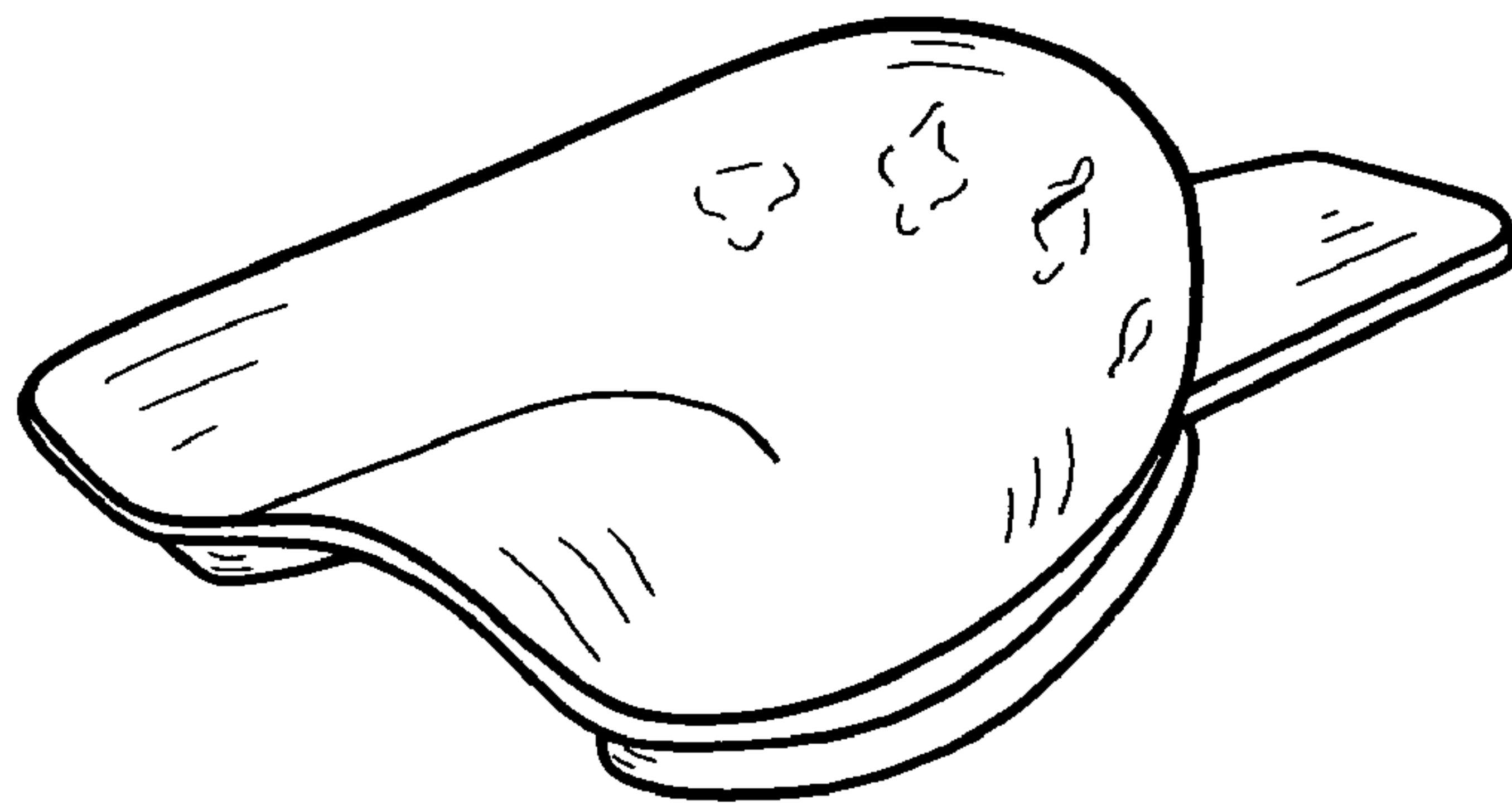

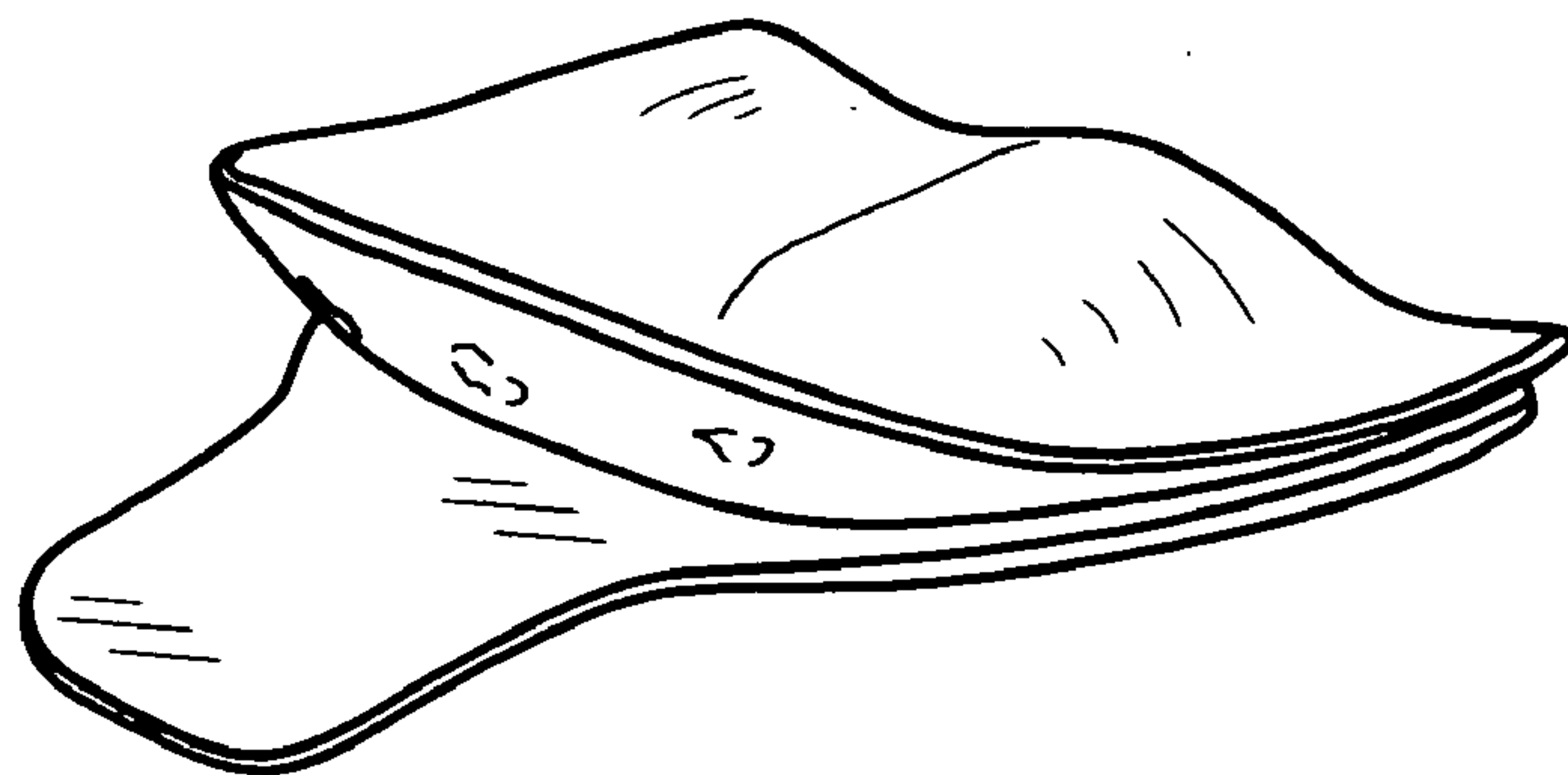

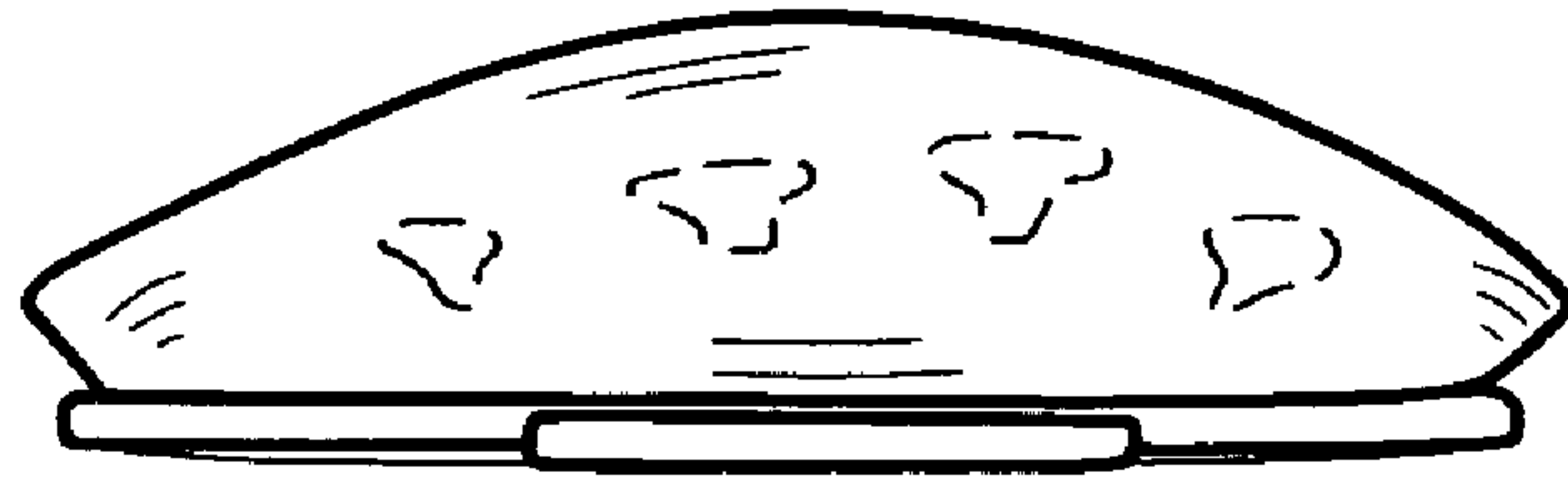

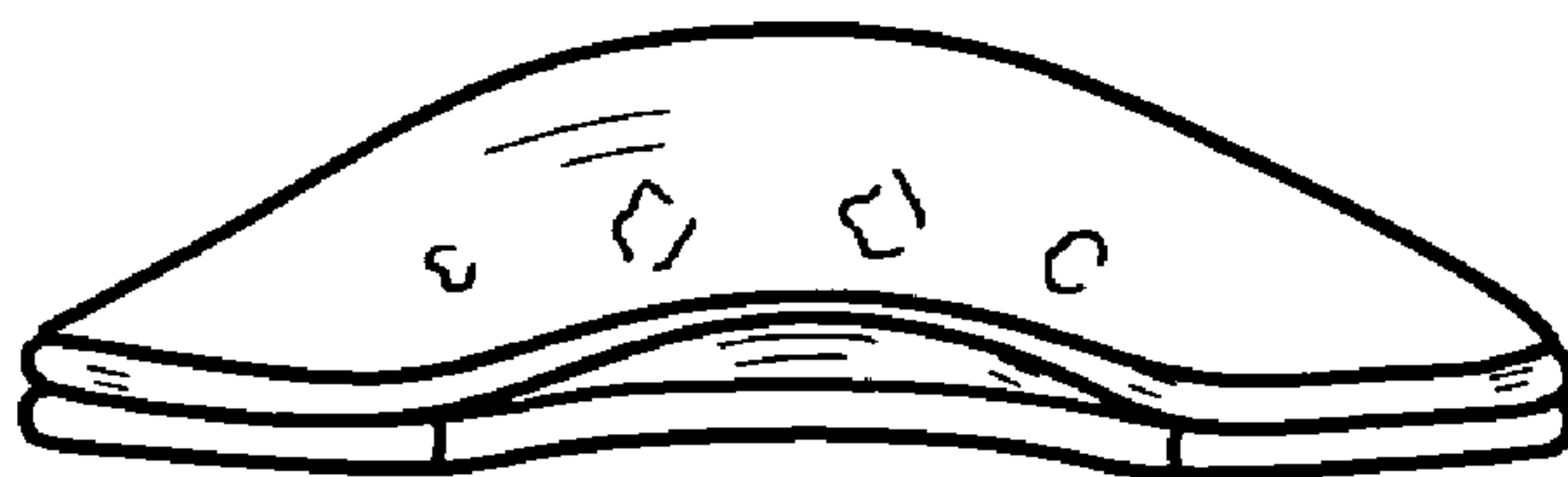

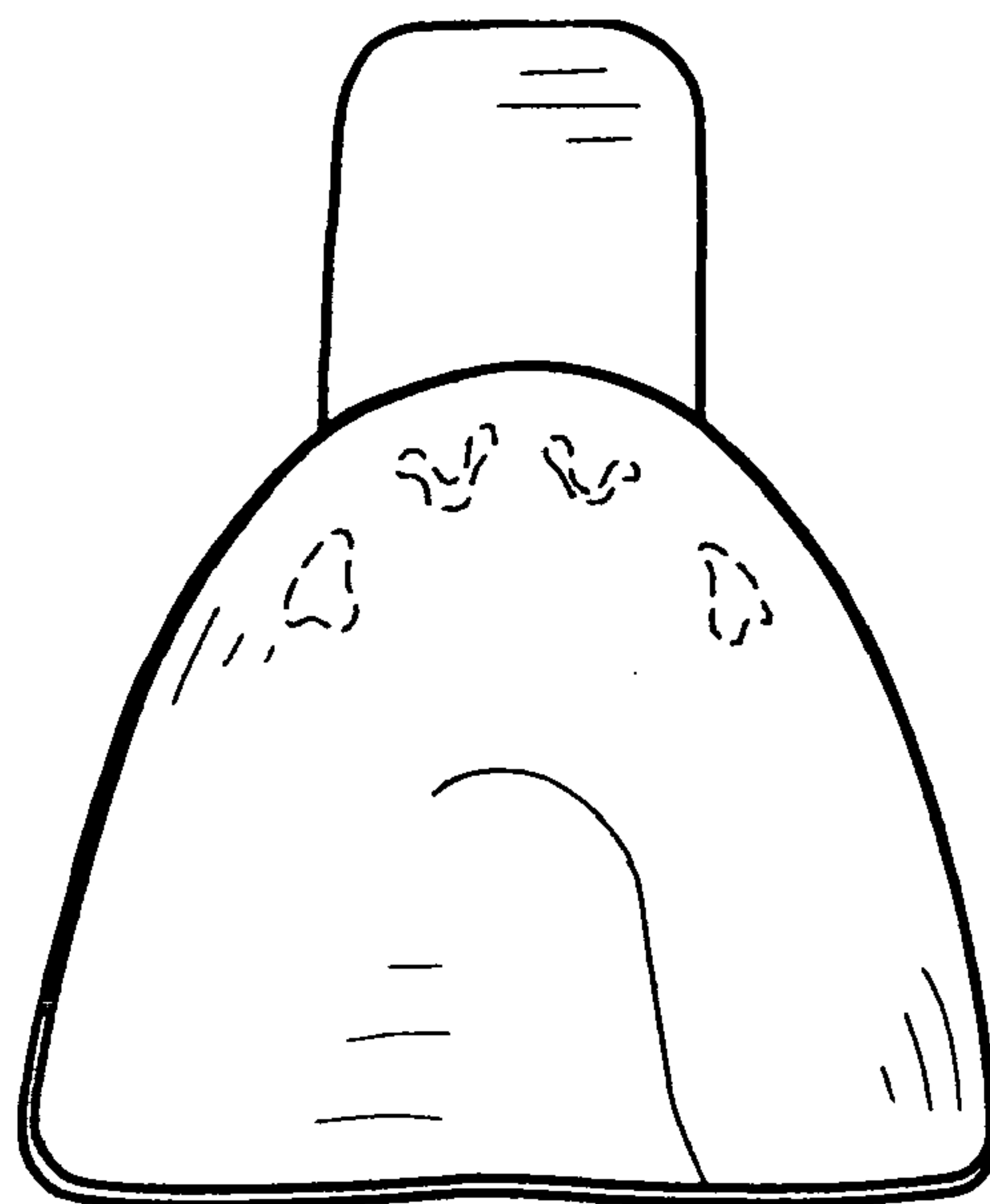

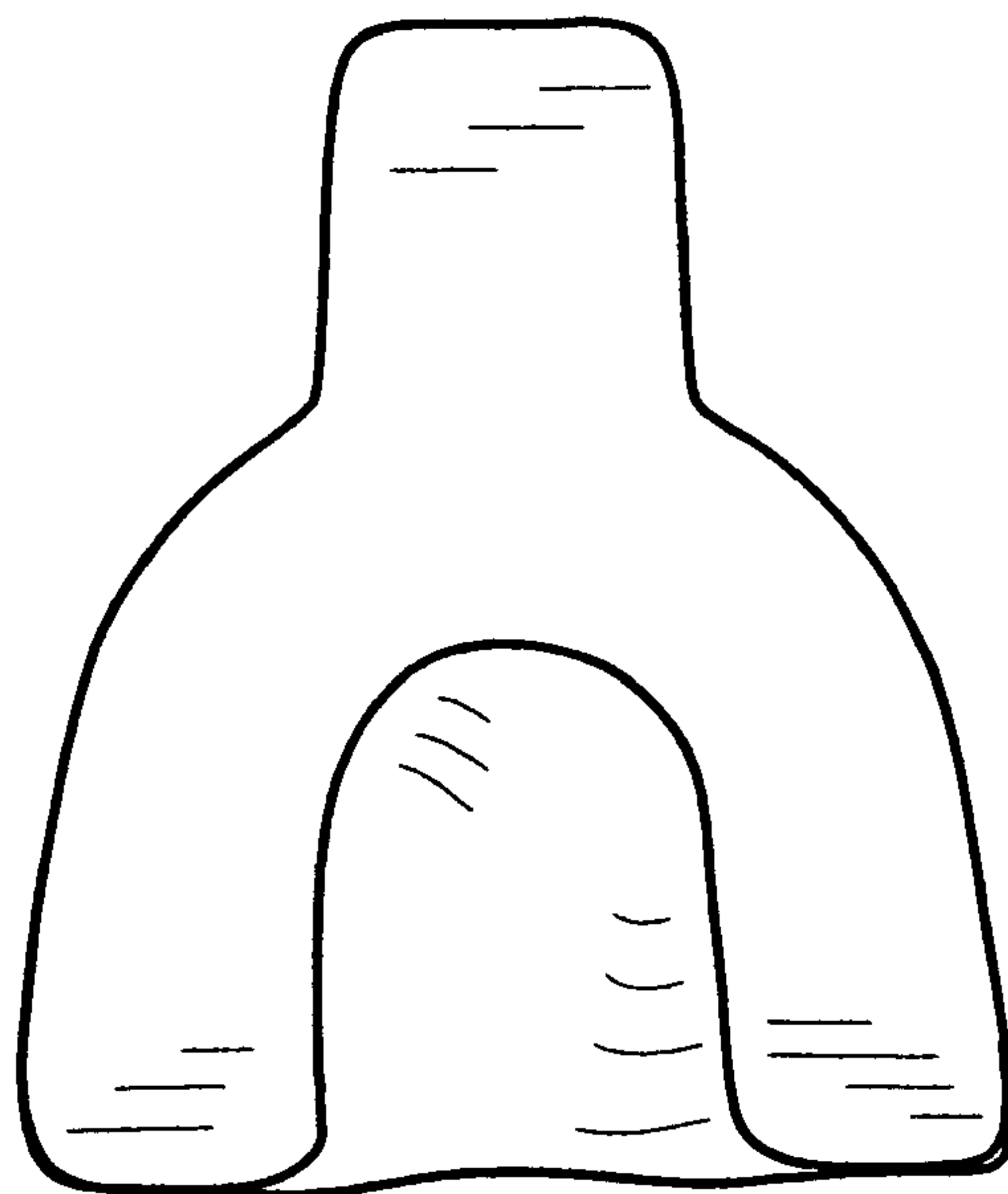
