FIG. 4 is a rear view thereof; the portions shown in broken lines form no part of the claimed invention;

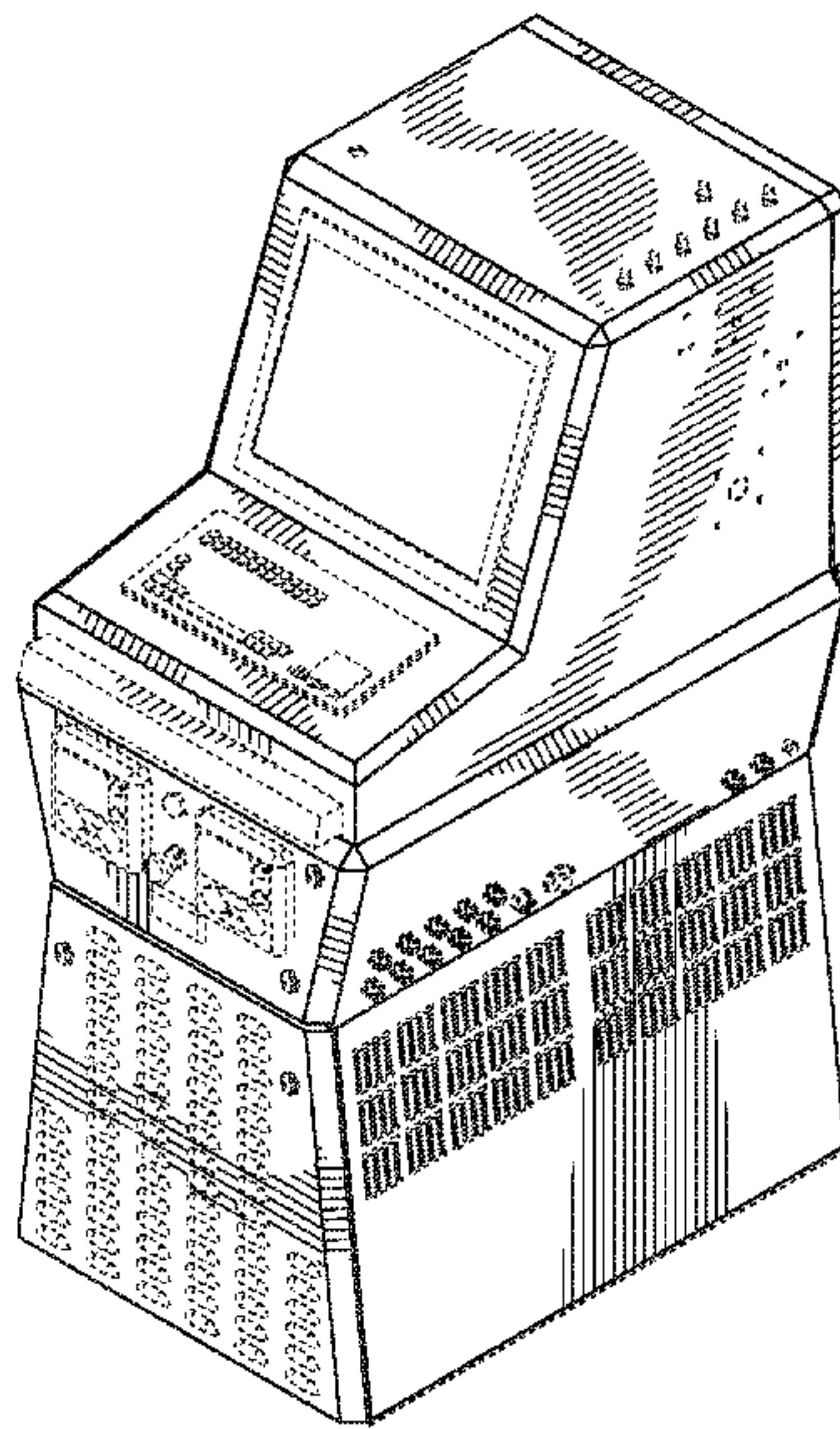
FIG. 5 is a left view thereof; the portions shown in broken lines form no part of the claimed invention;

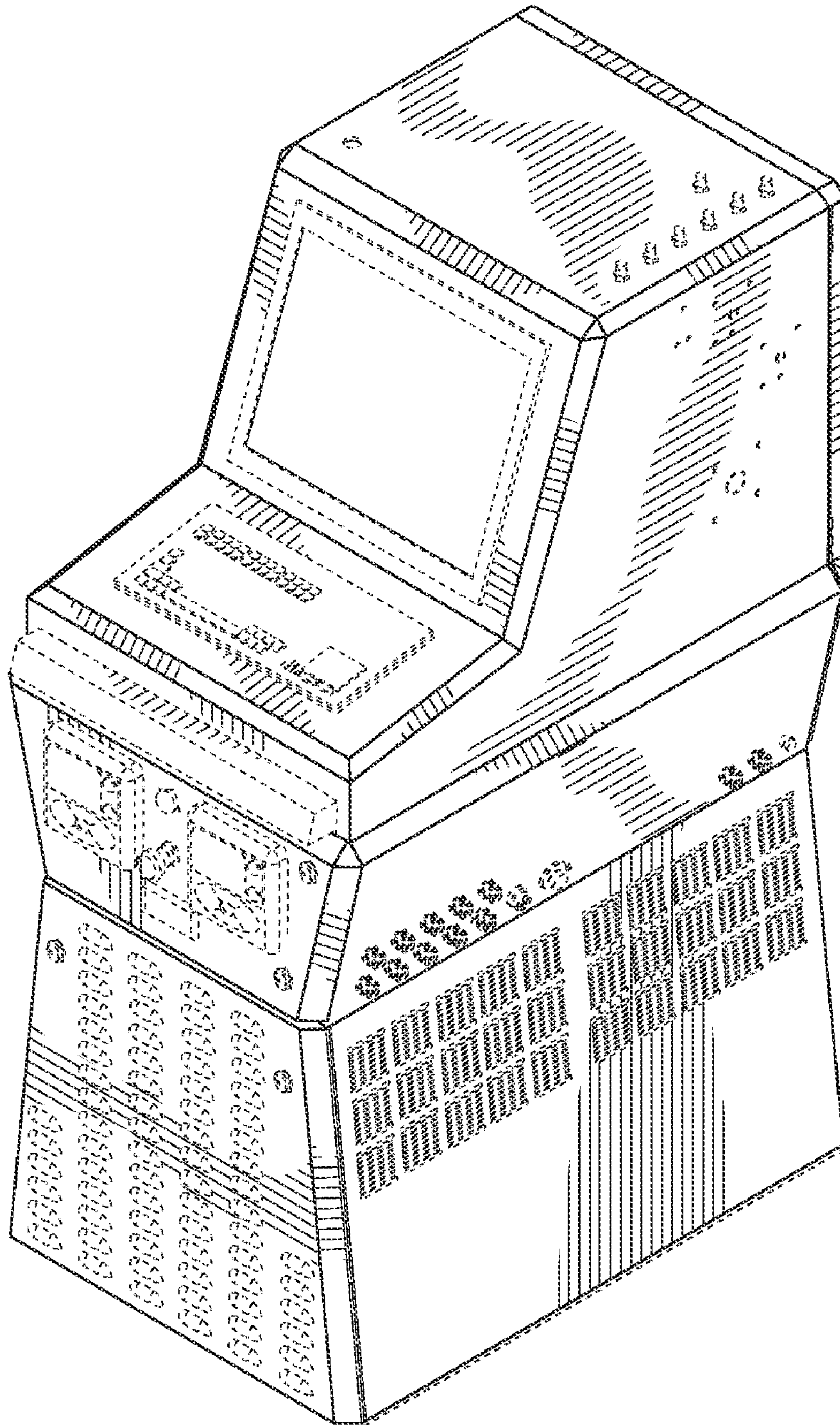

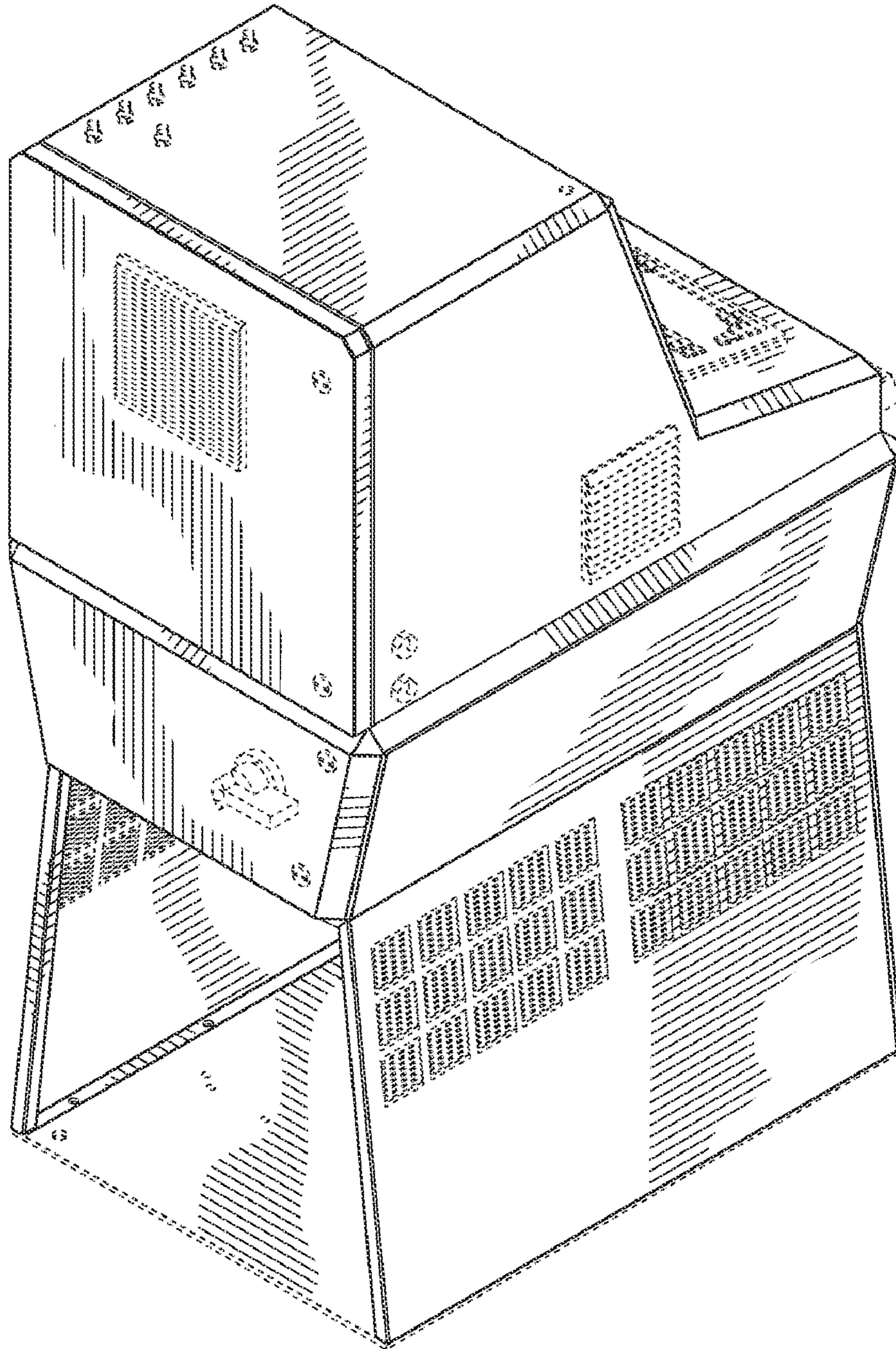

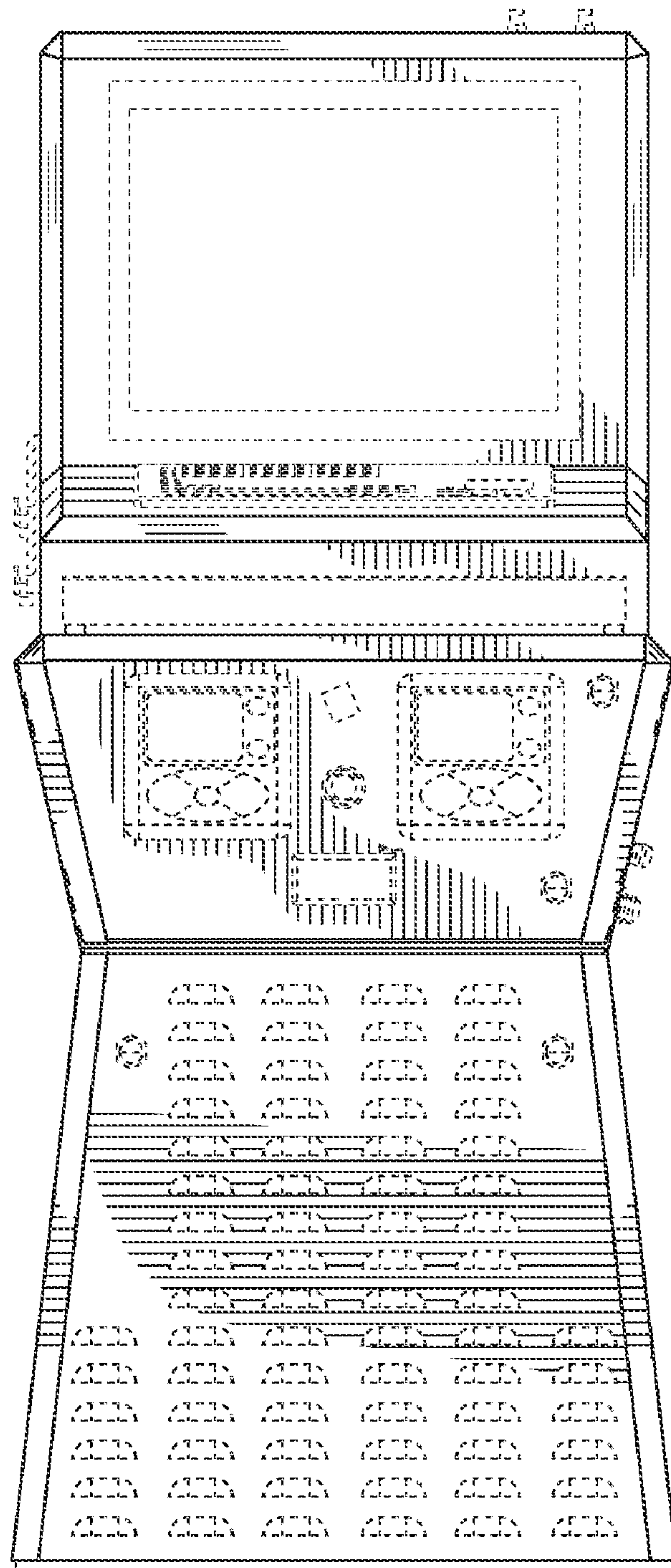

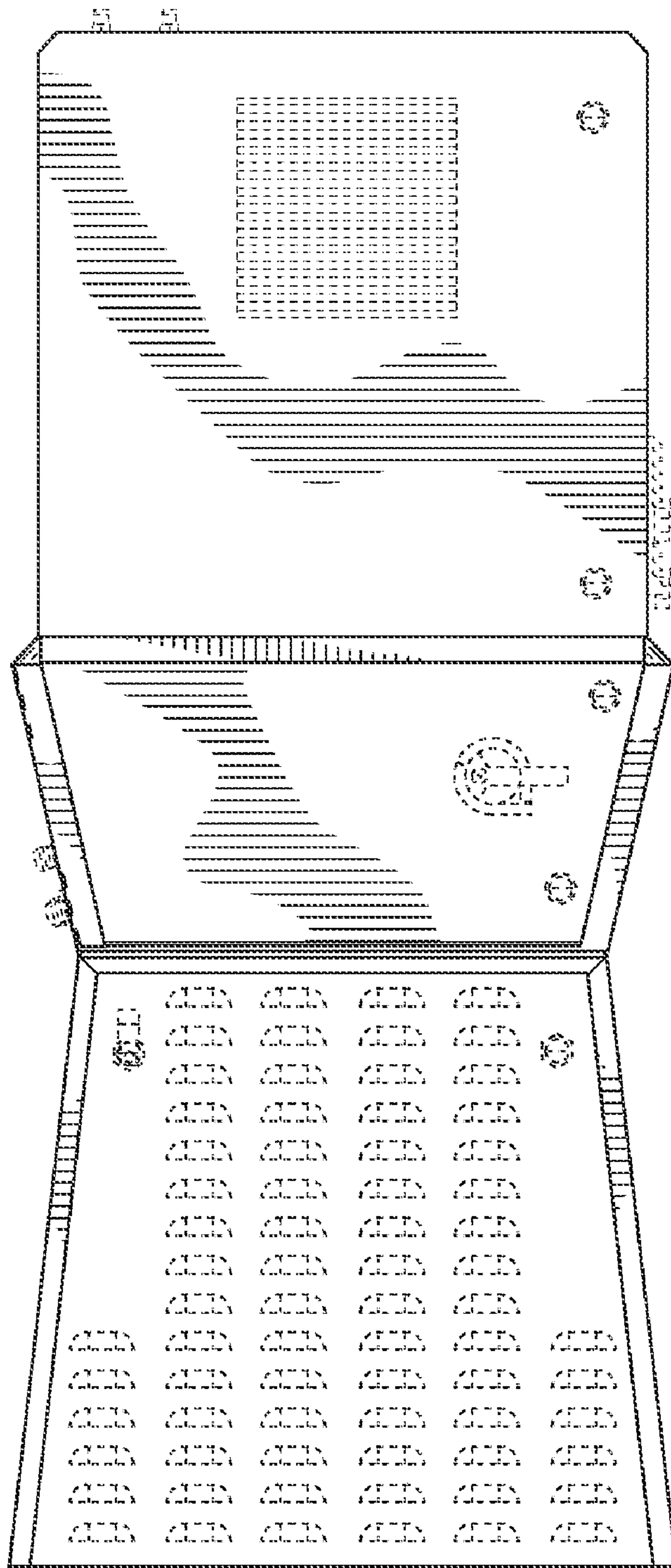

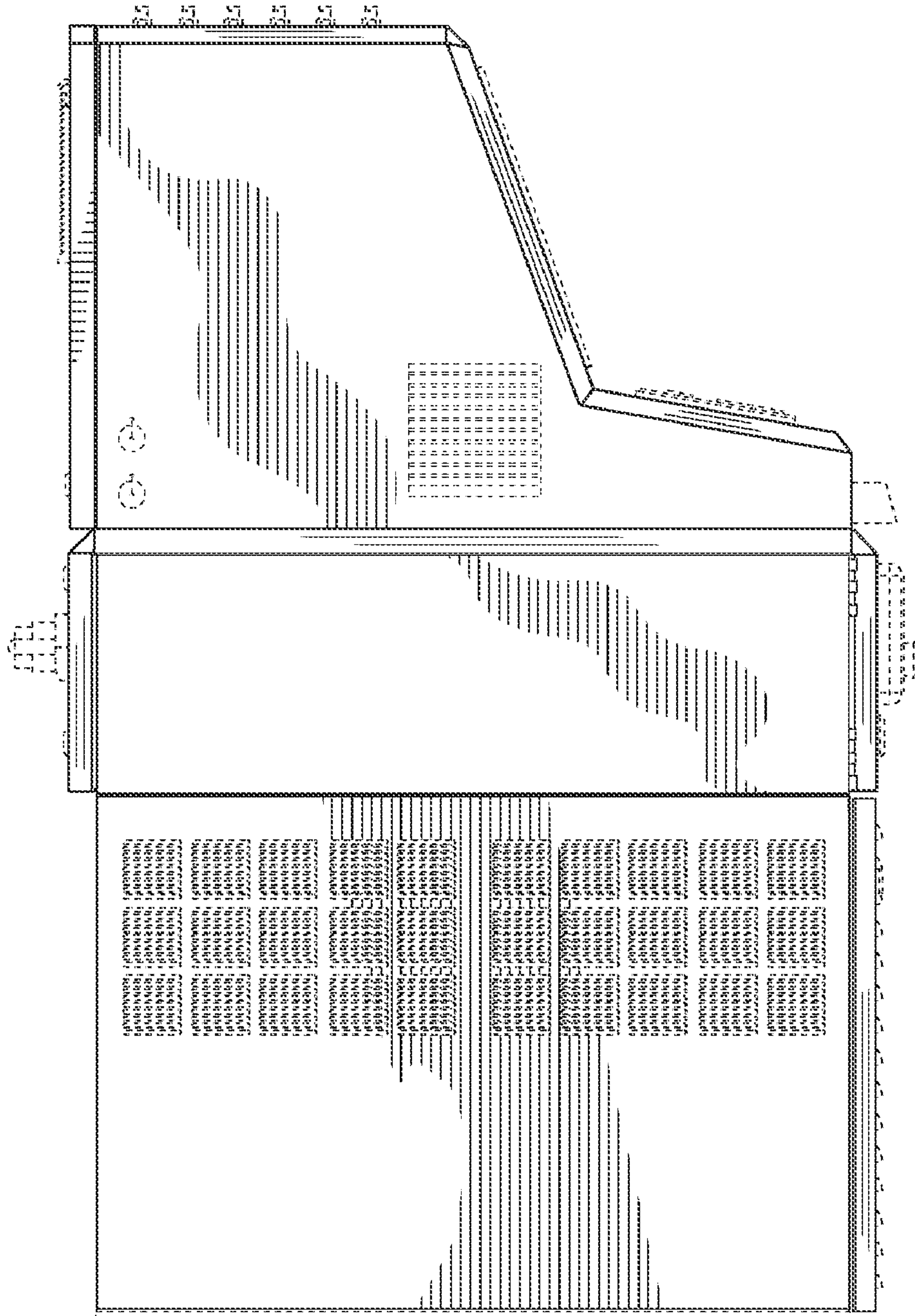

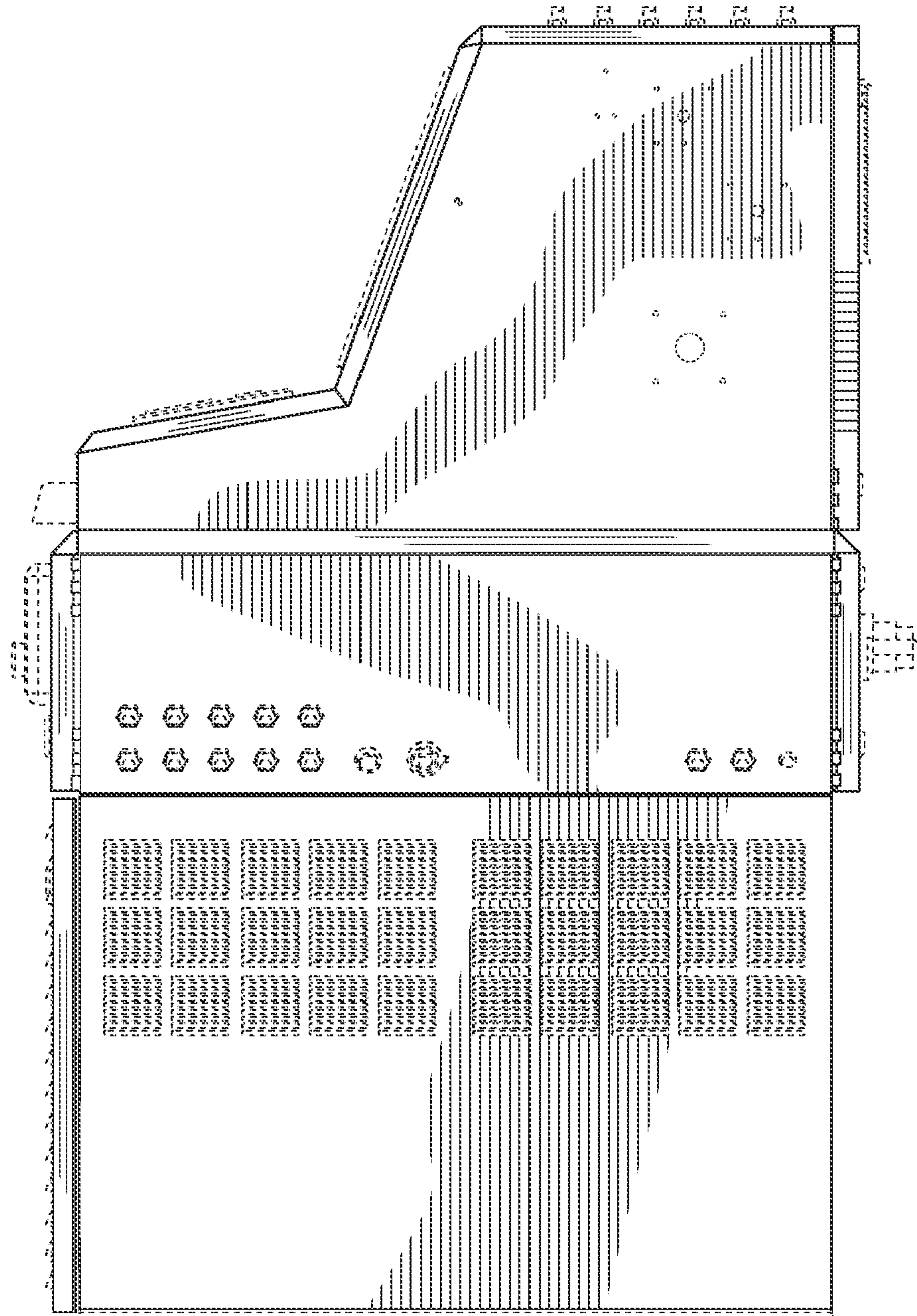

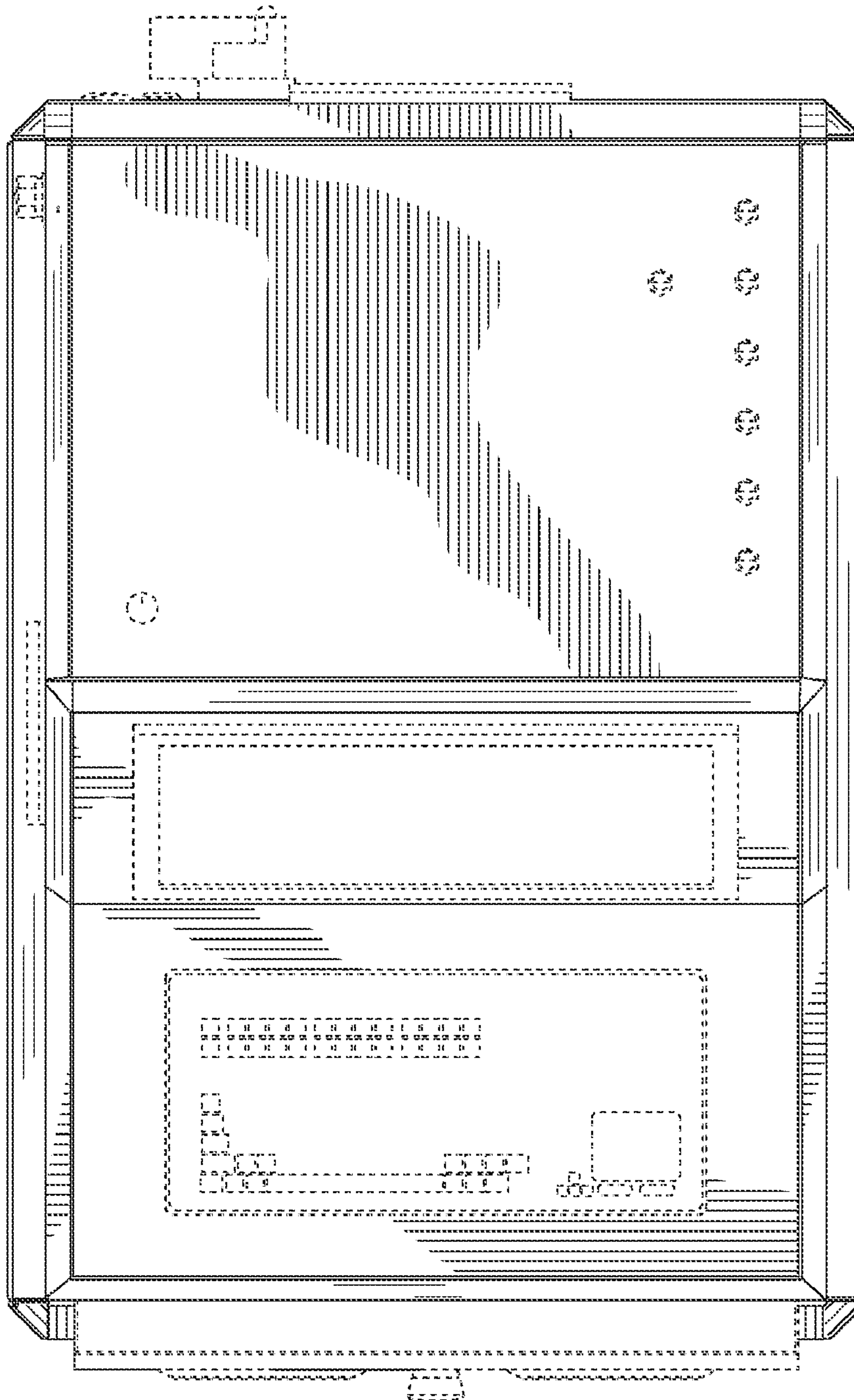

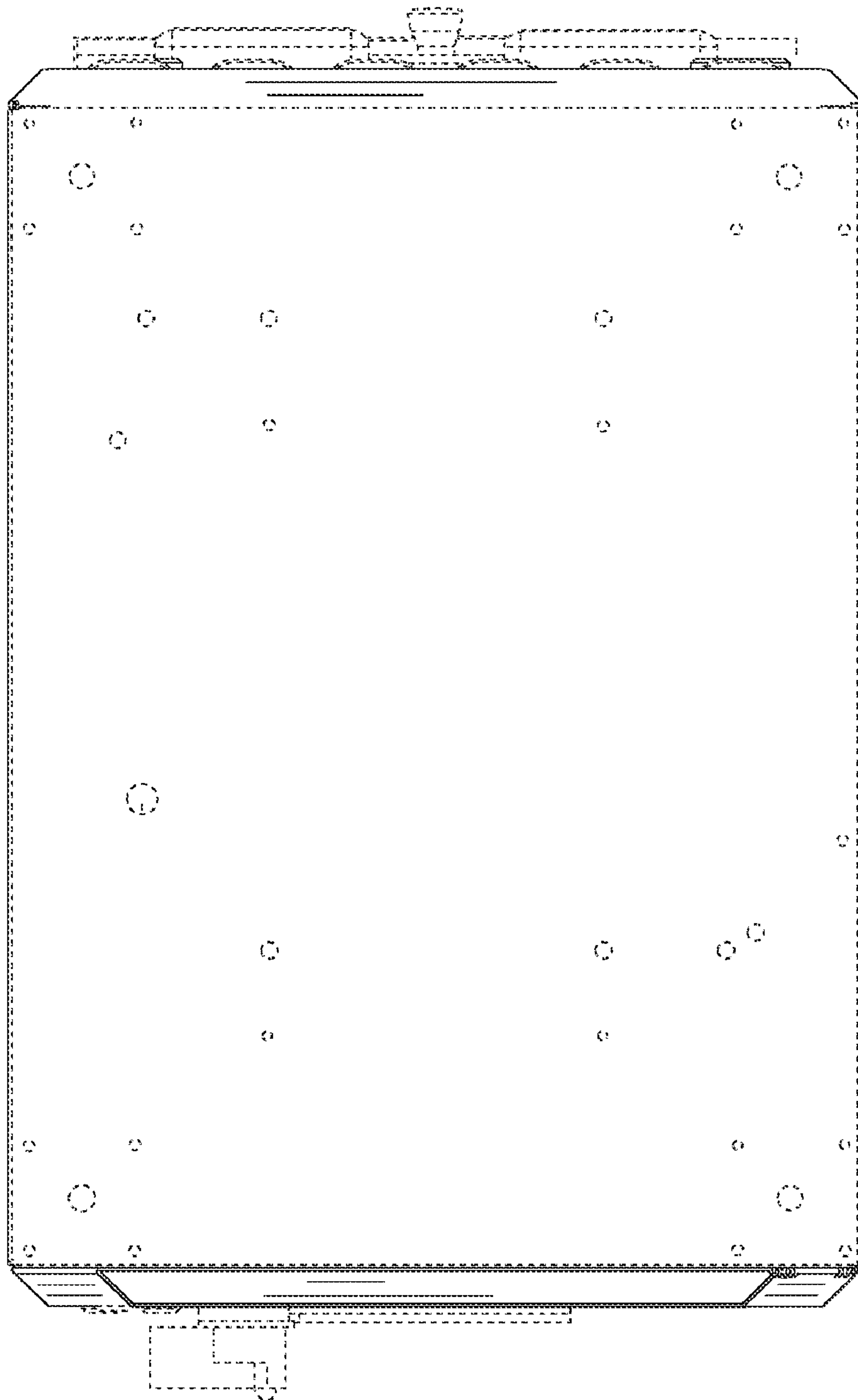
