**DESCRIPTION**

FIG. 1 is a front, top and right-side perspective view of a pet throw toy embodying my new design;

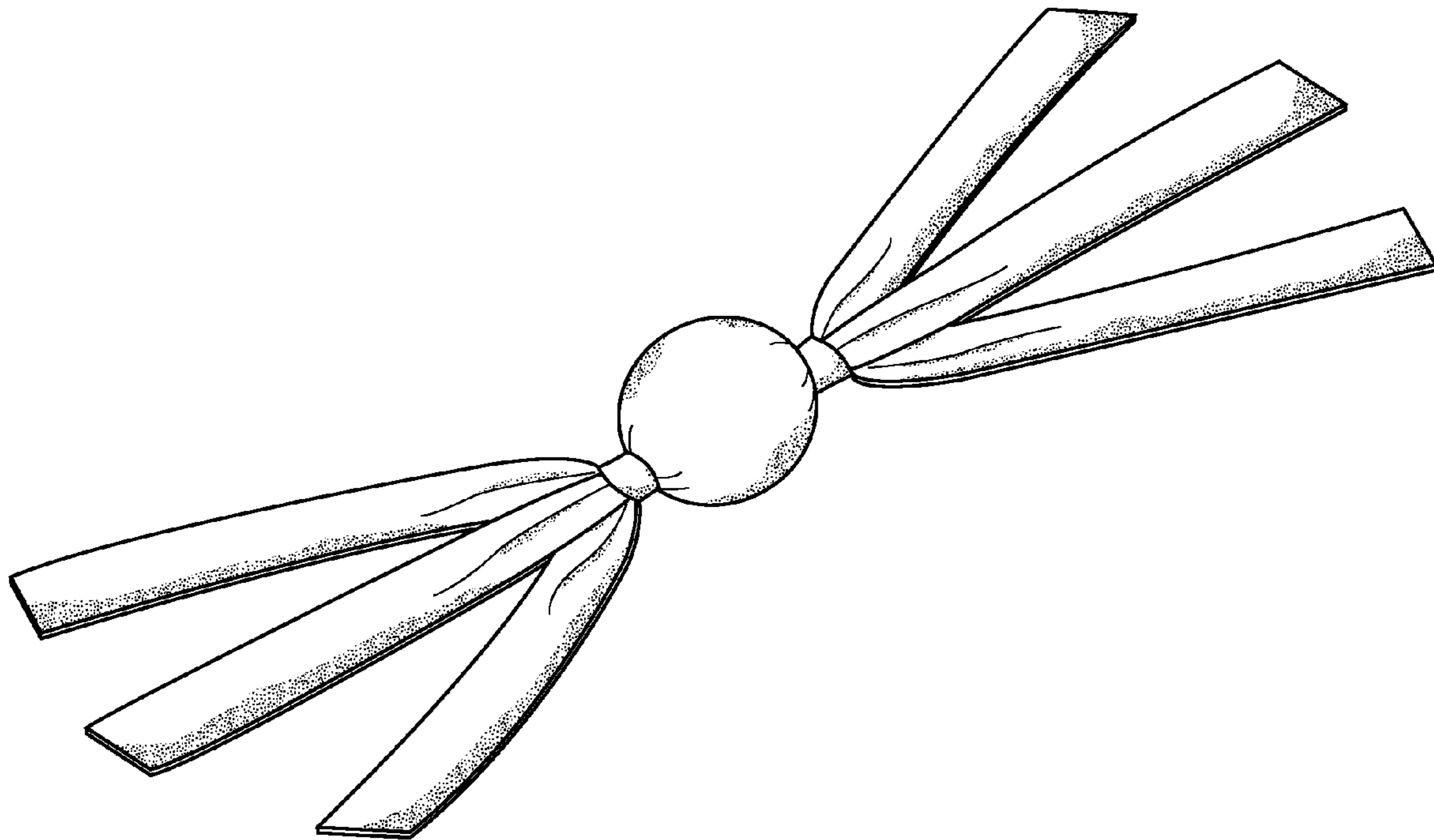

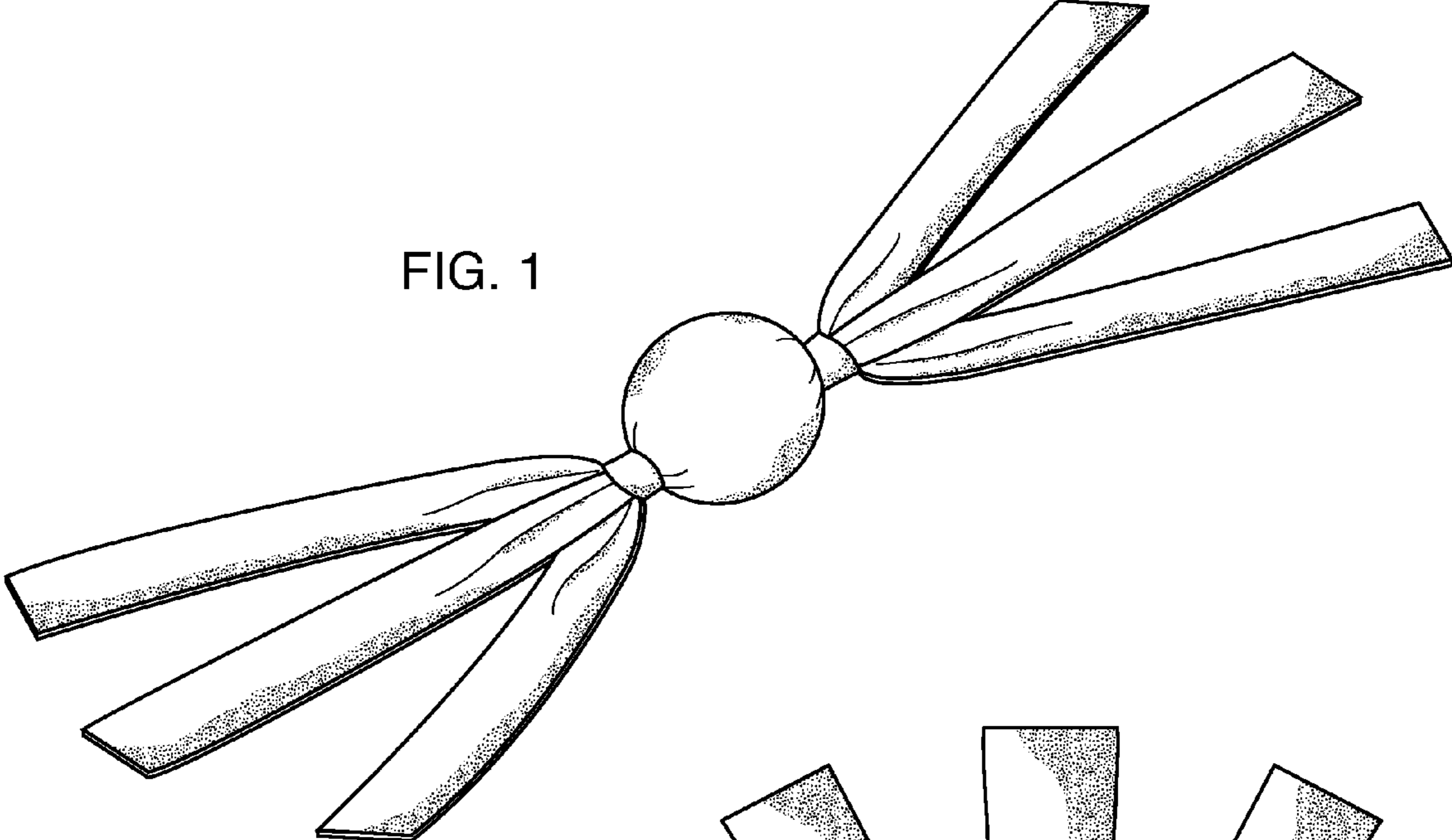
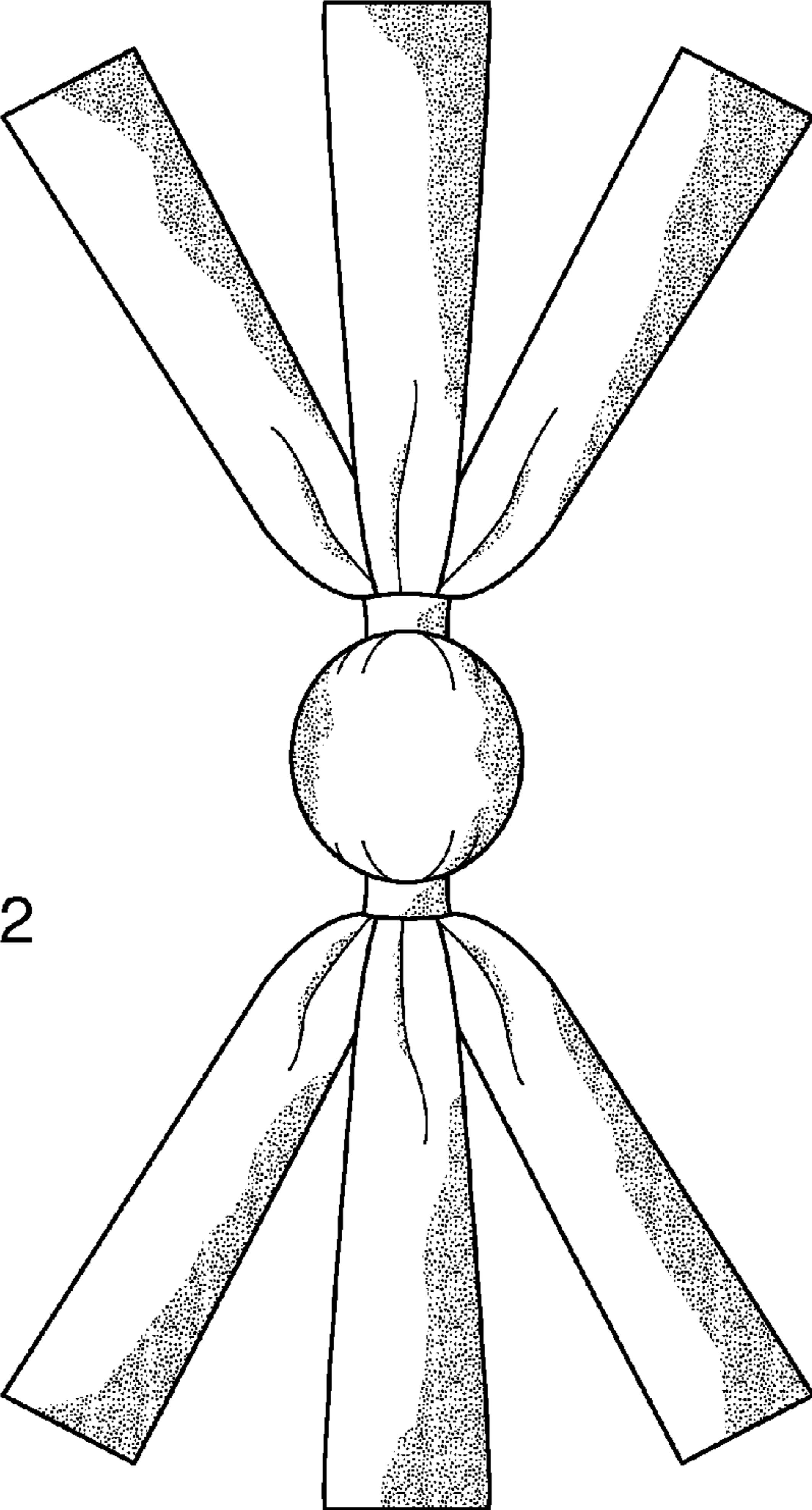

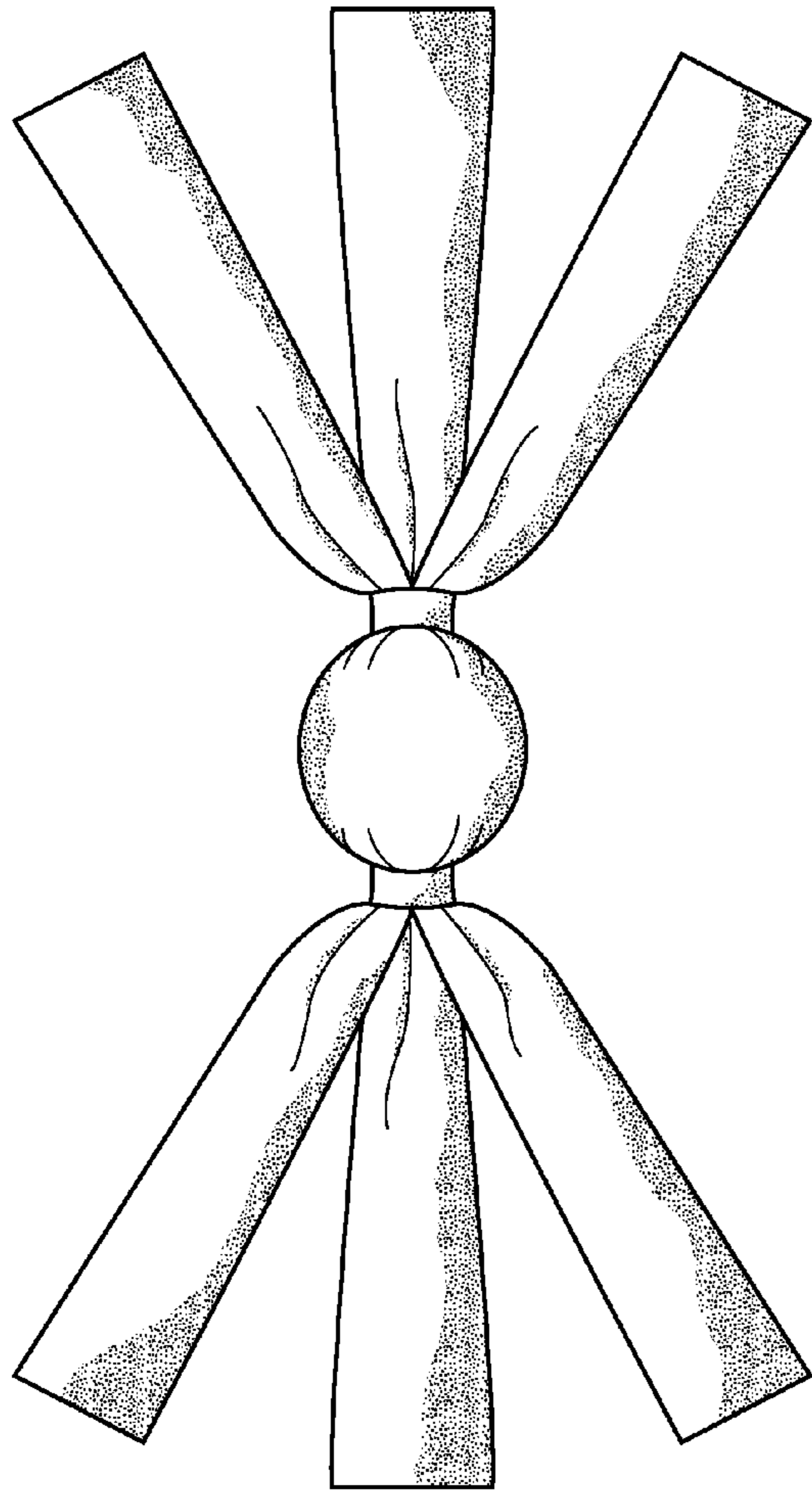

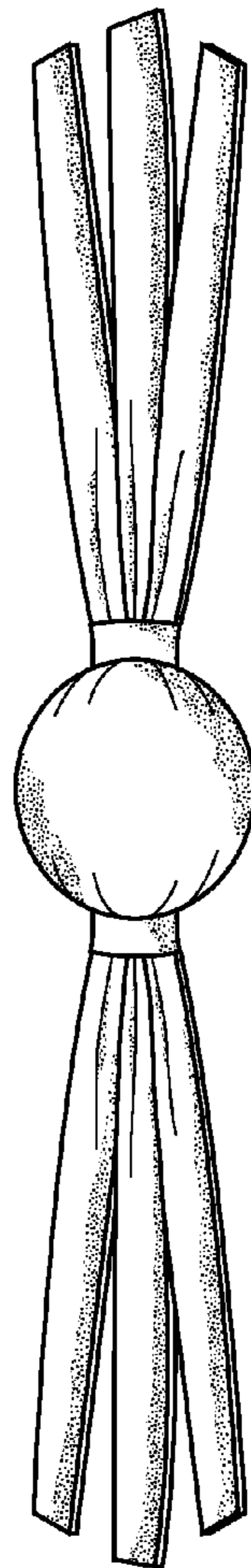

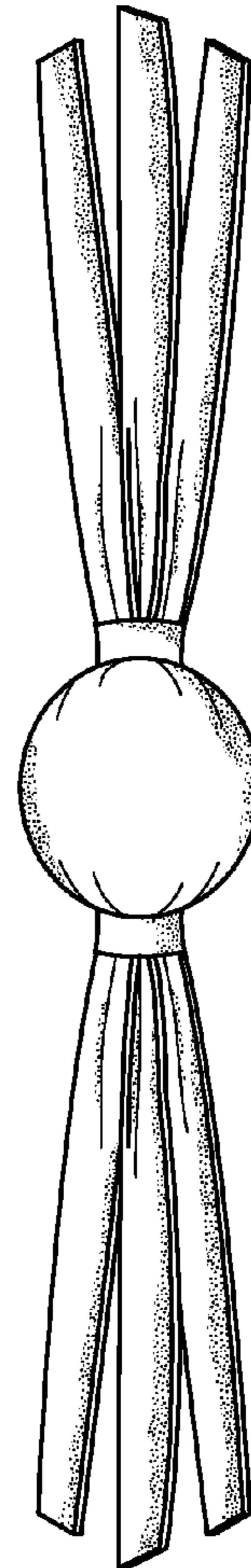

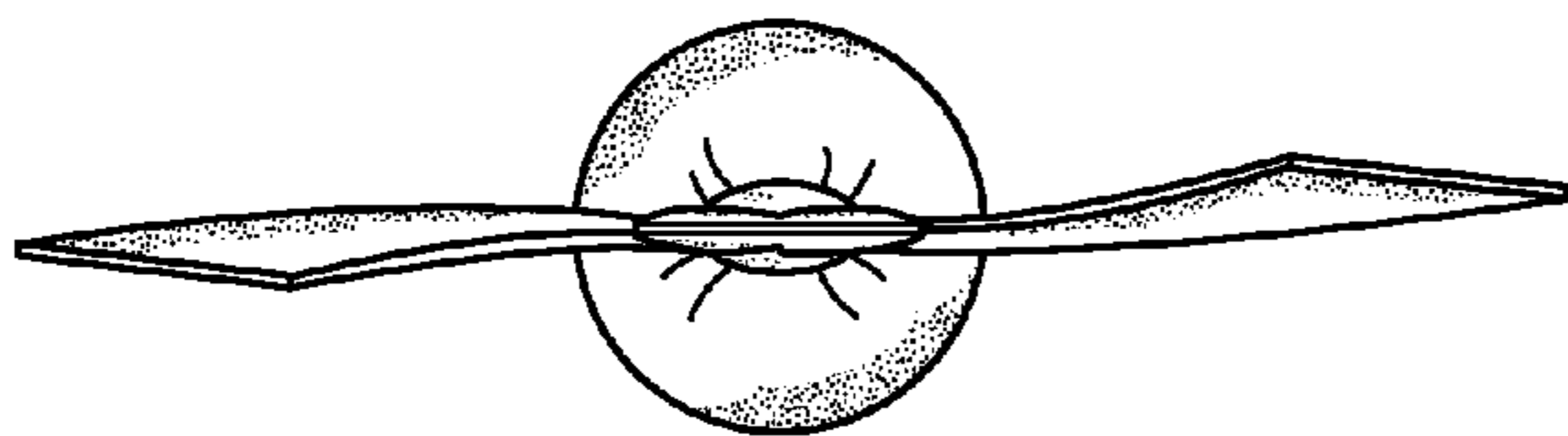

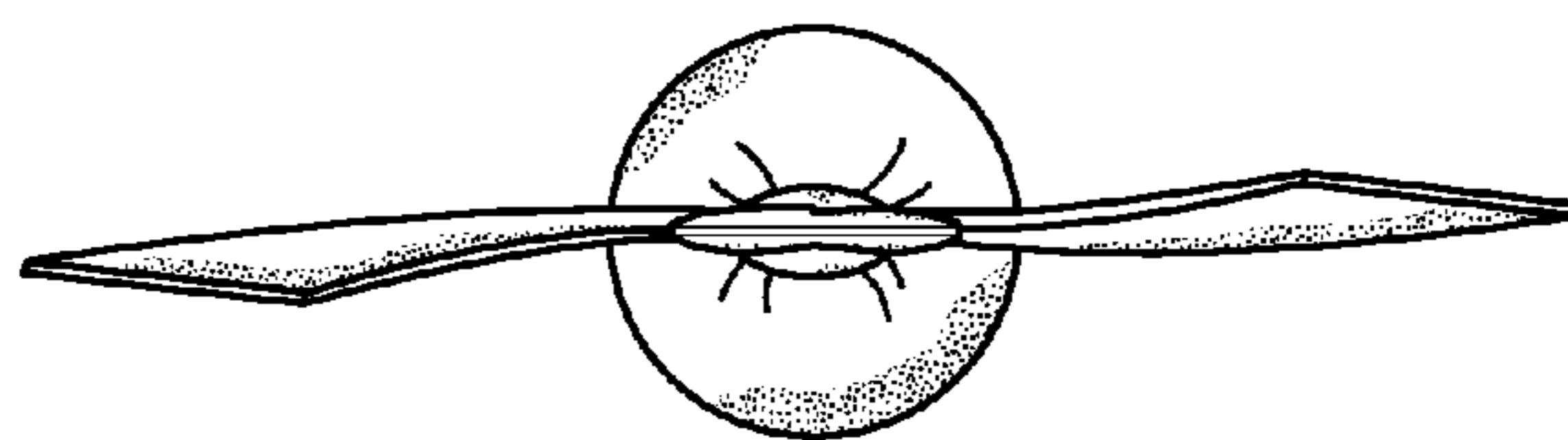
