FIG. 6 is a top elevation view of the snack food product of the present invention; and,

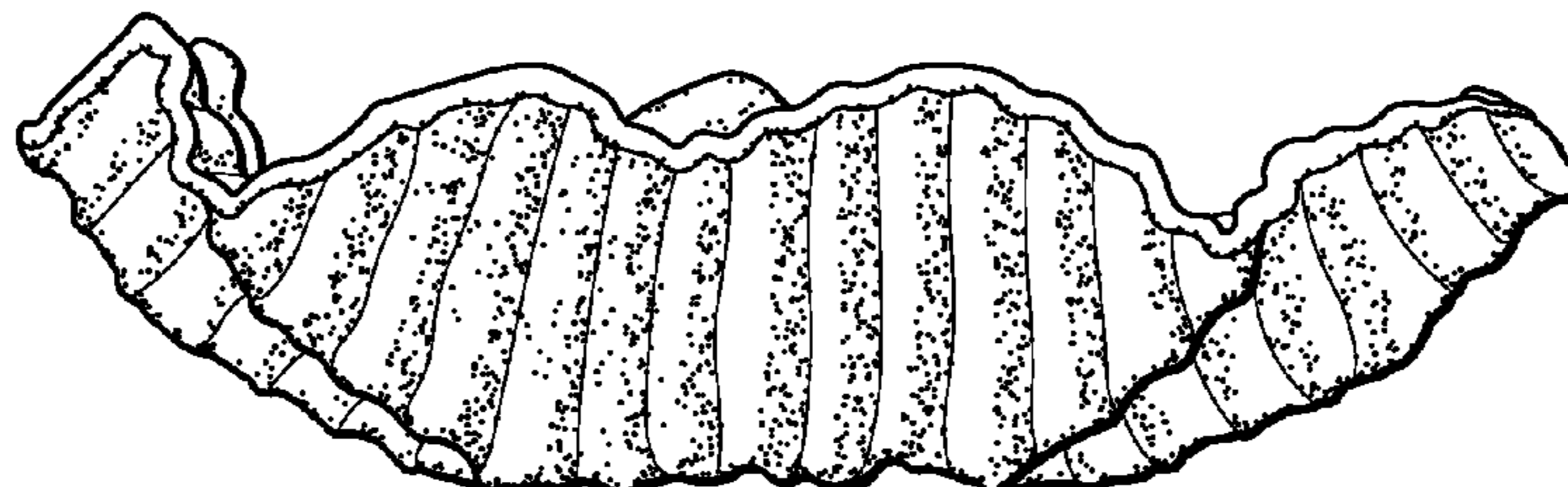
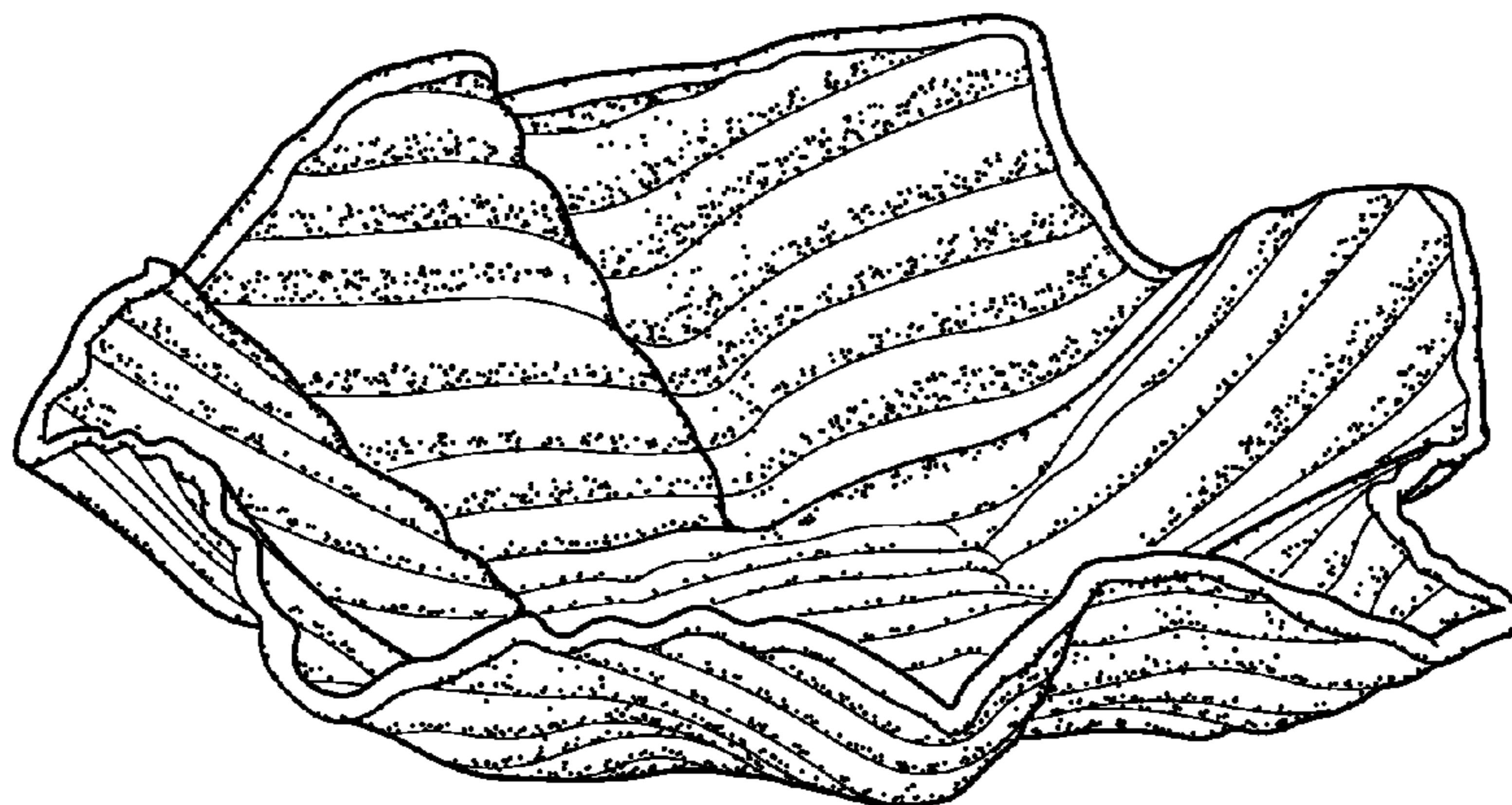
FIG. 7 is a bottom elevation view of the snack food product of the present invention.

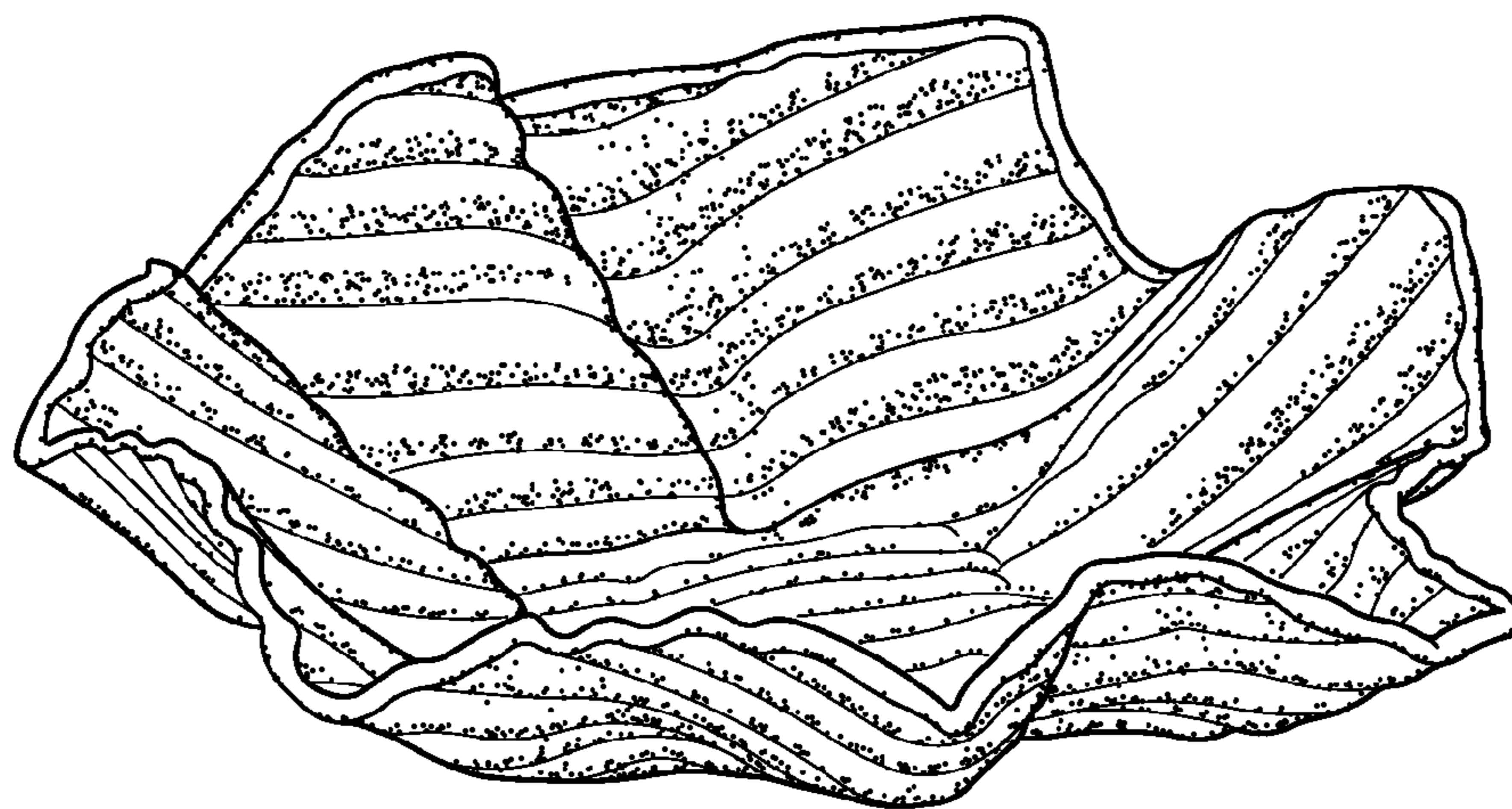

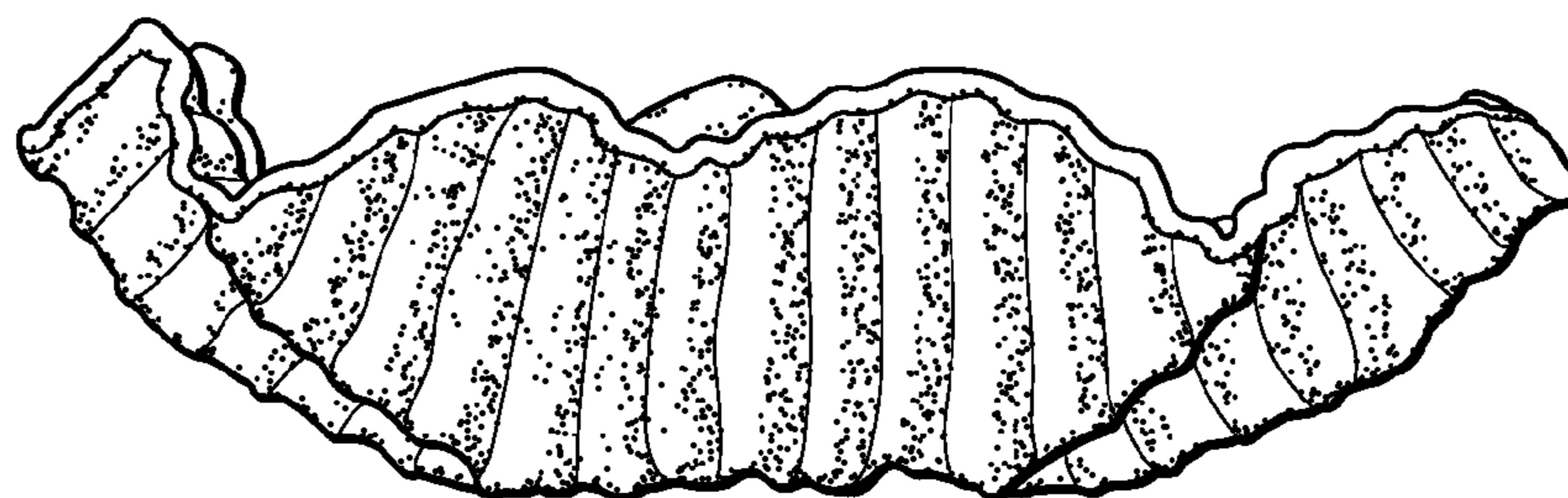

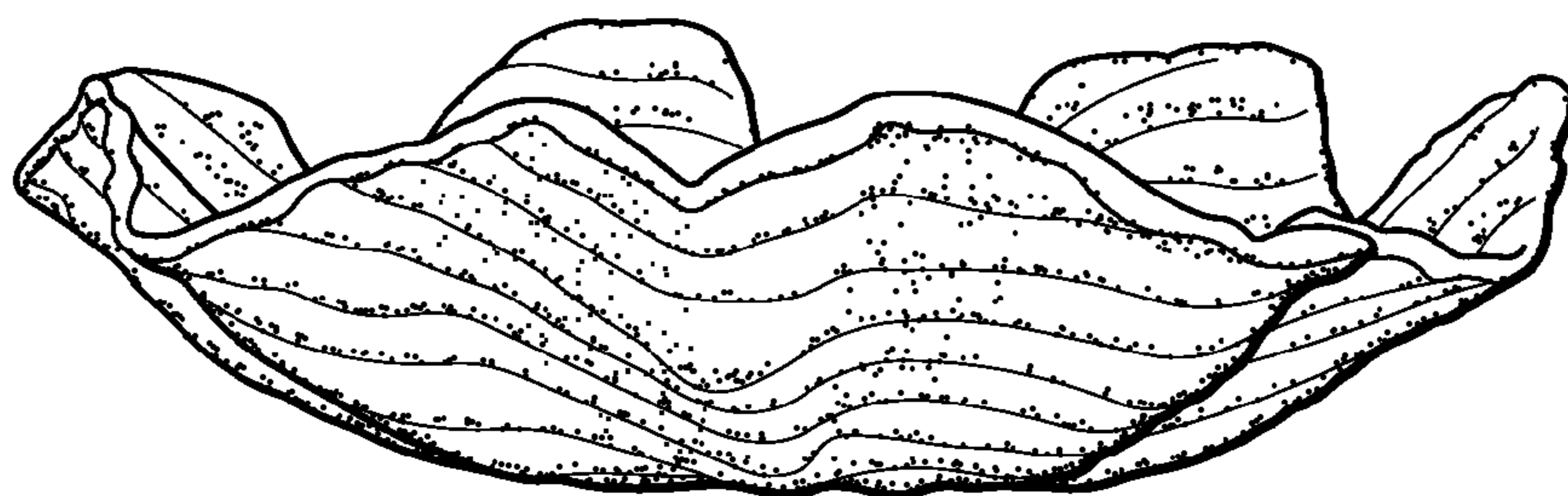

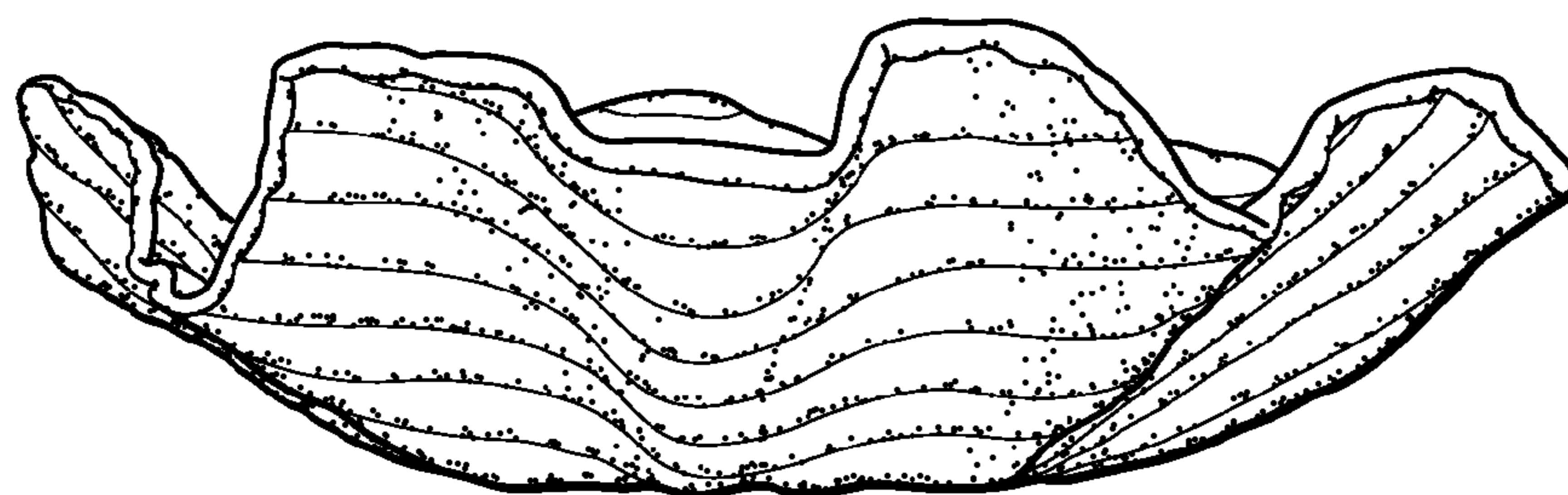

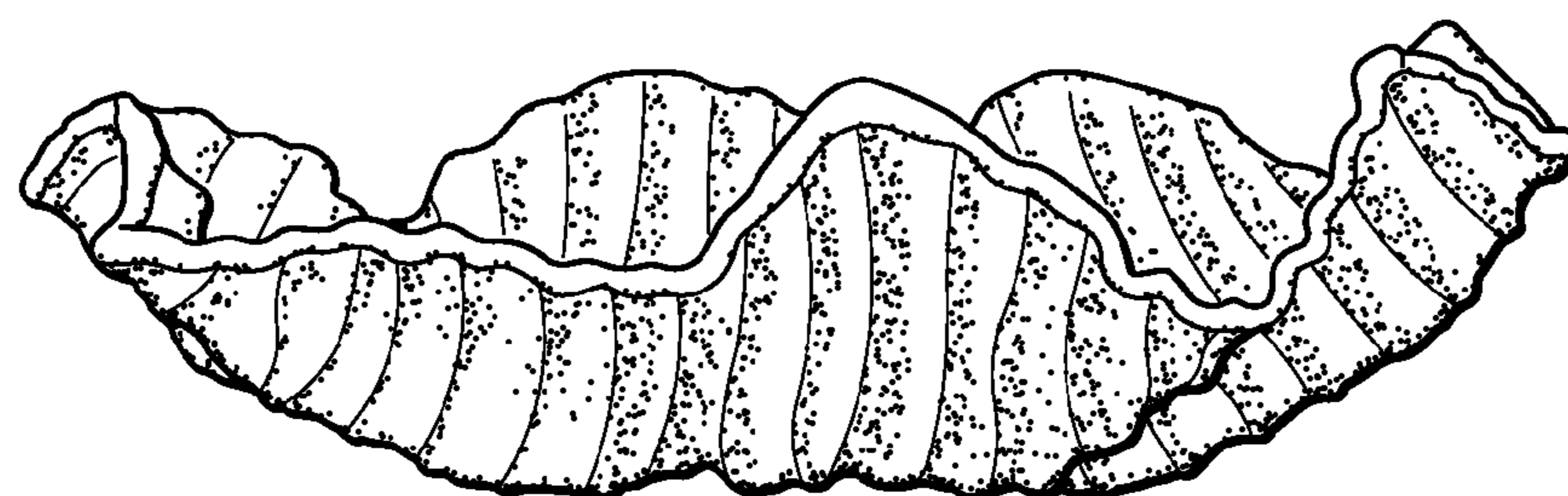

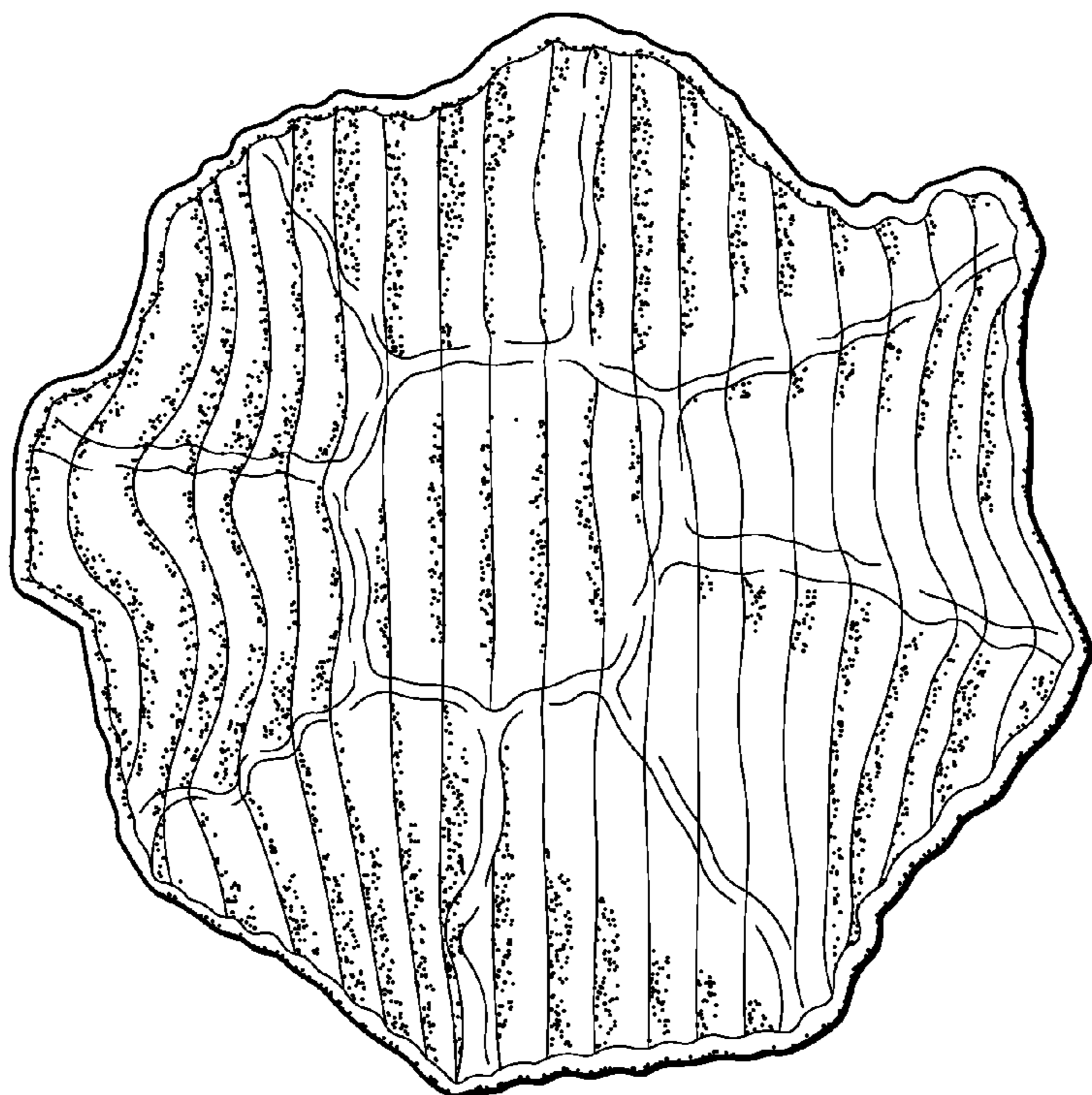

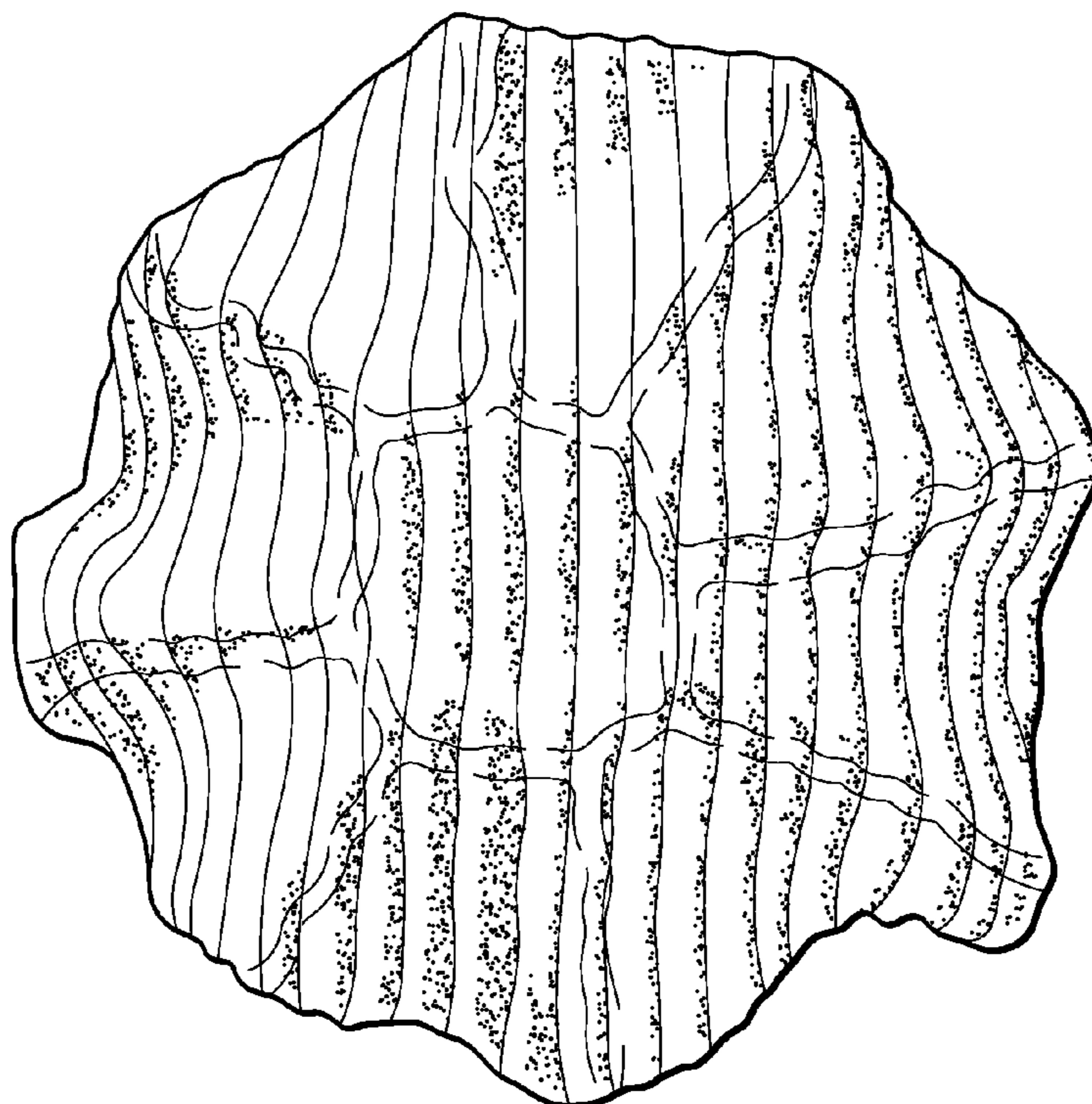
