FIG. 8 is a cross-section view of the pocket.

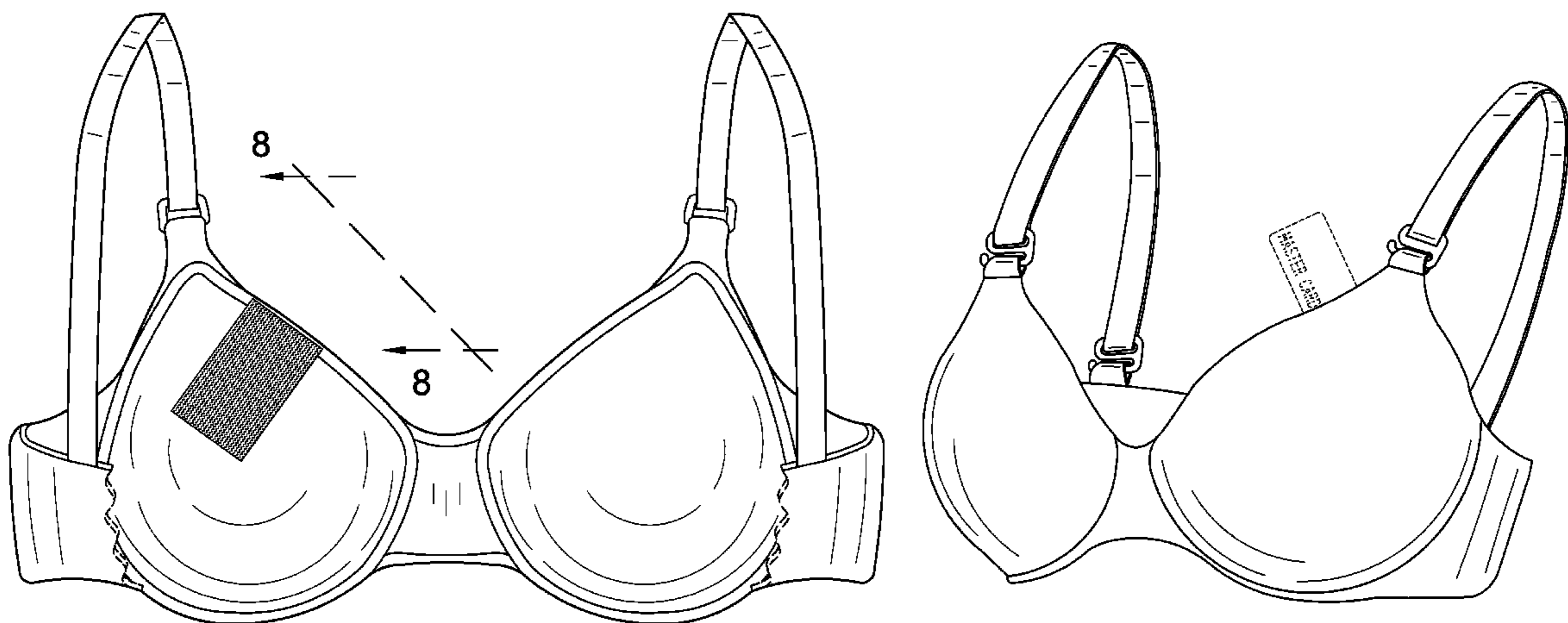

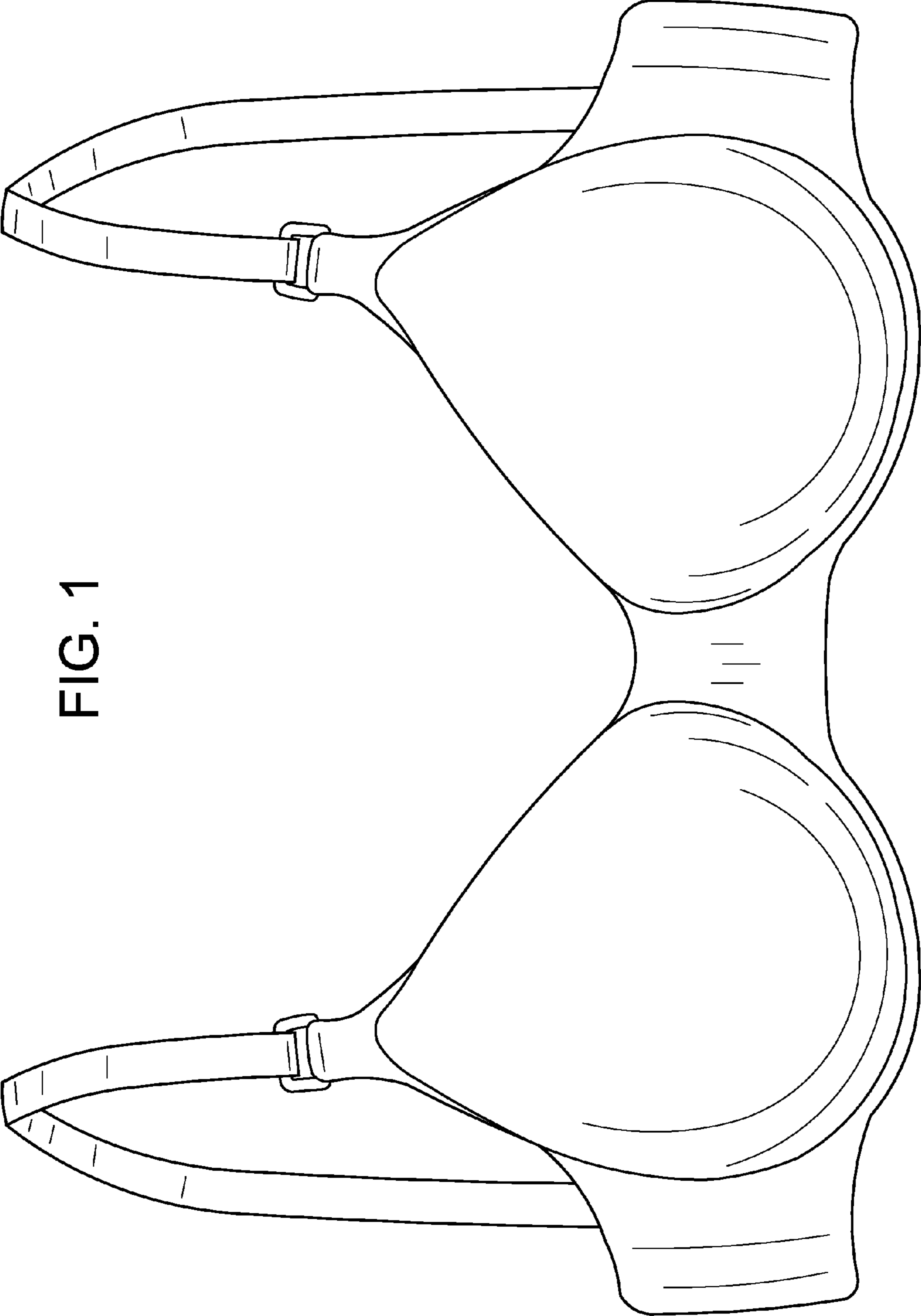

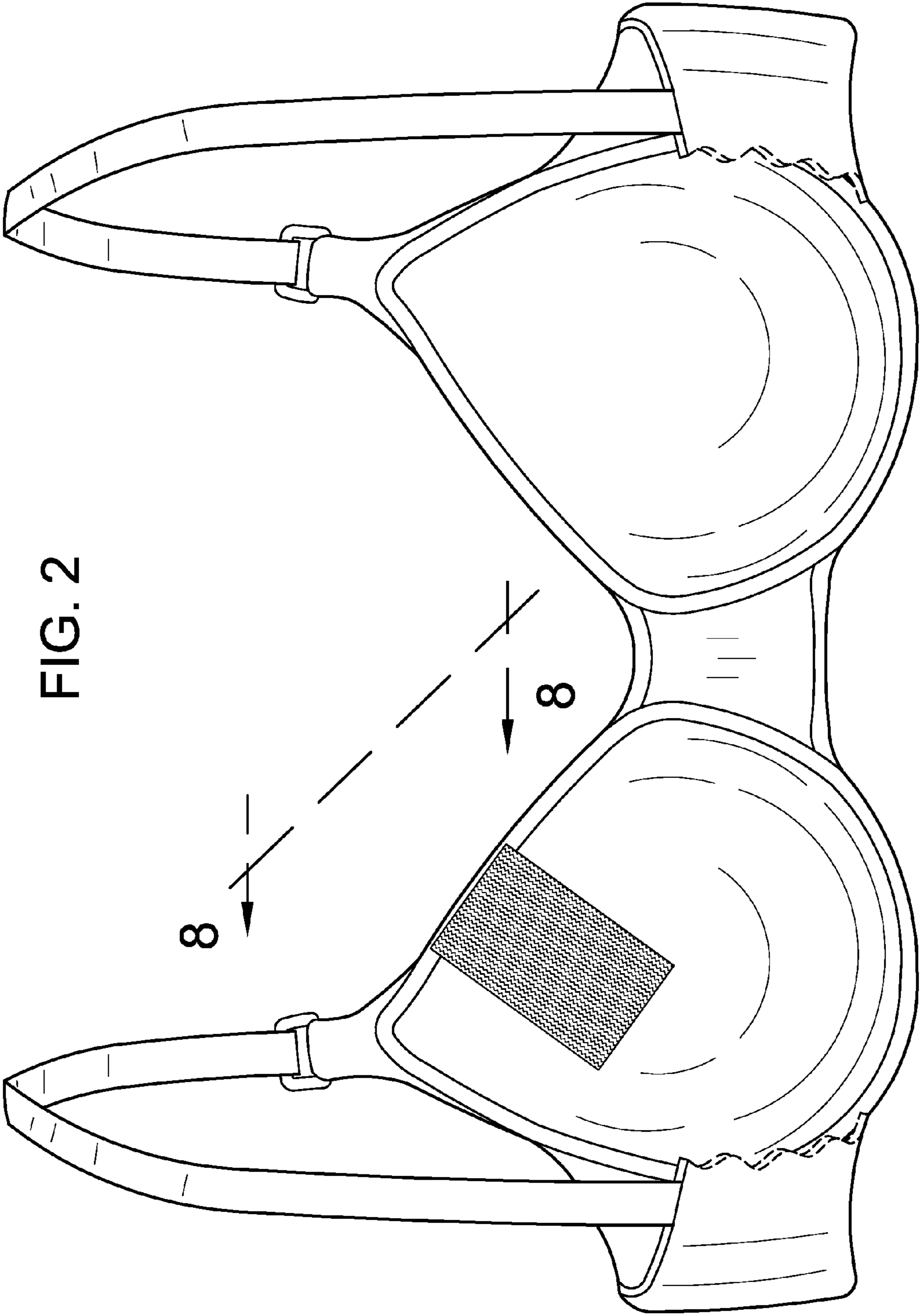
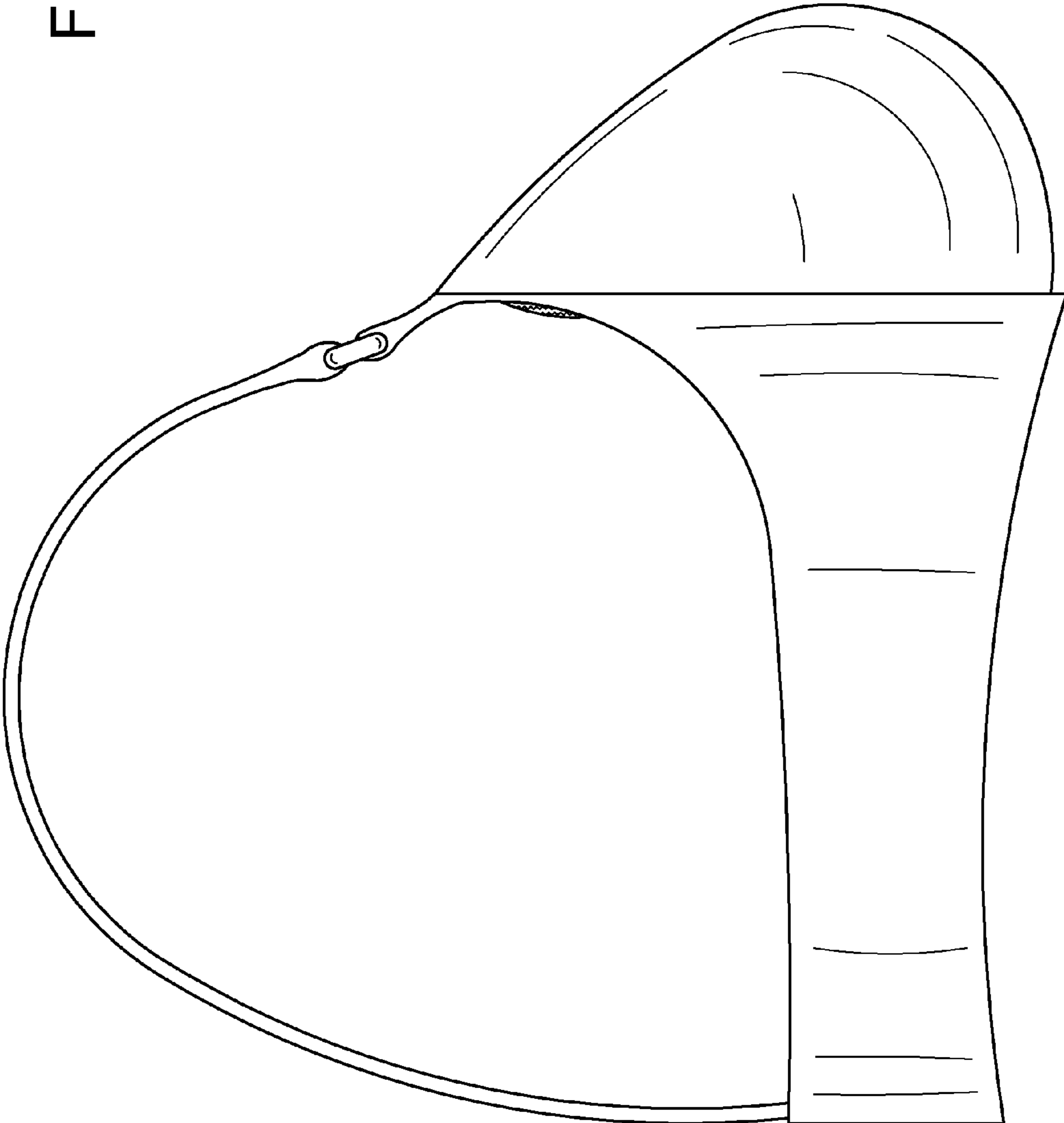

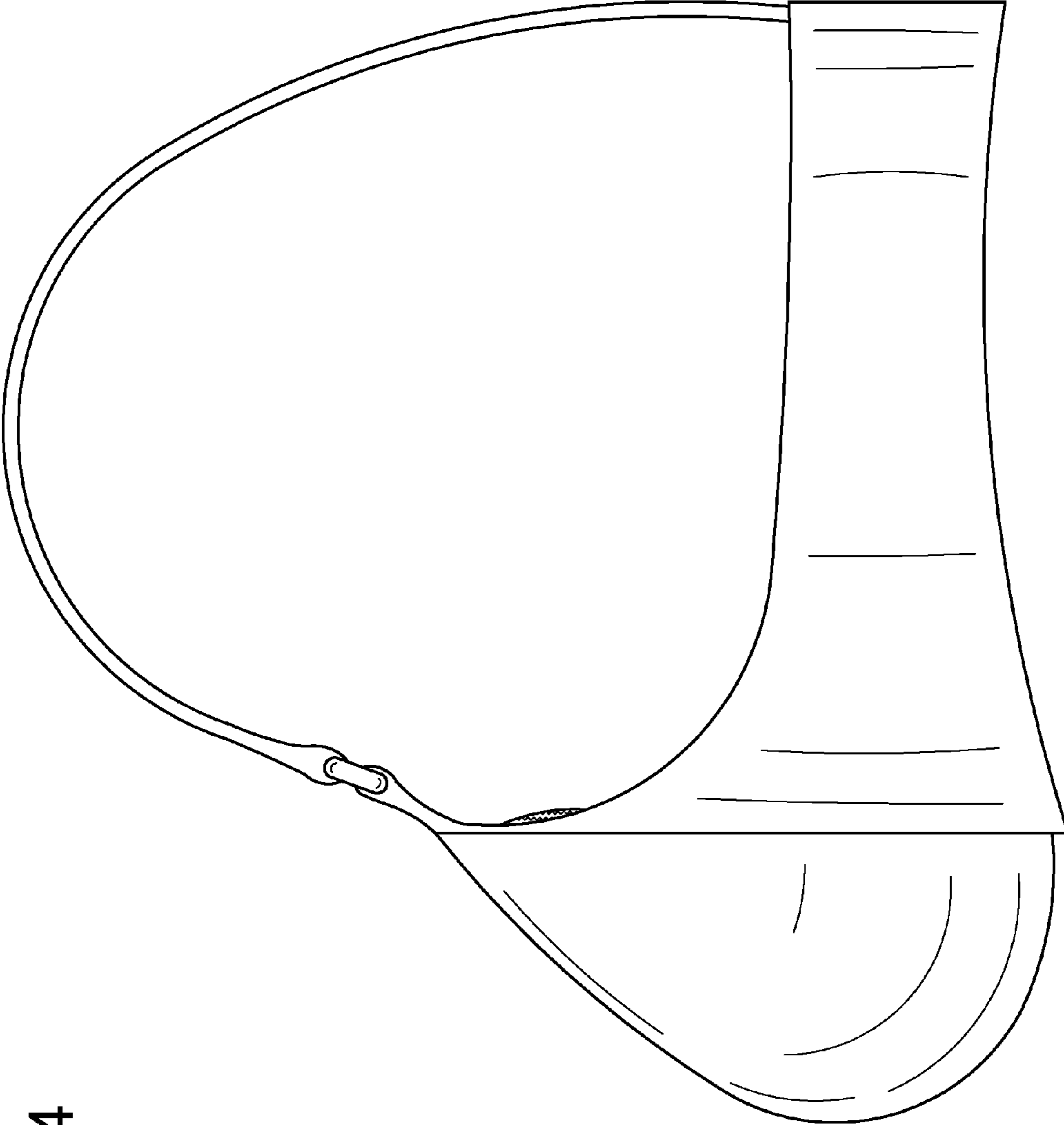

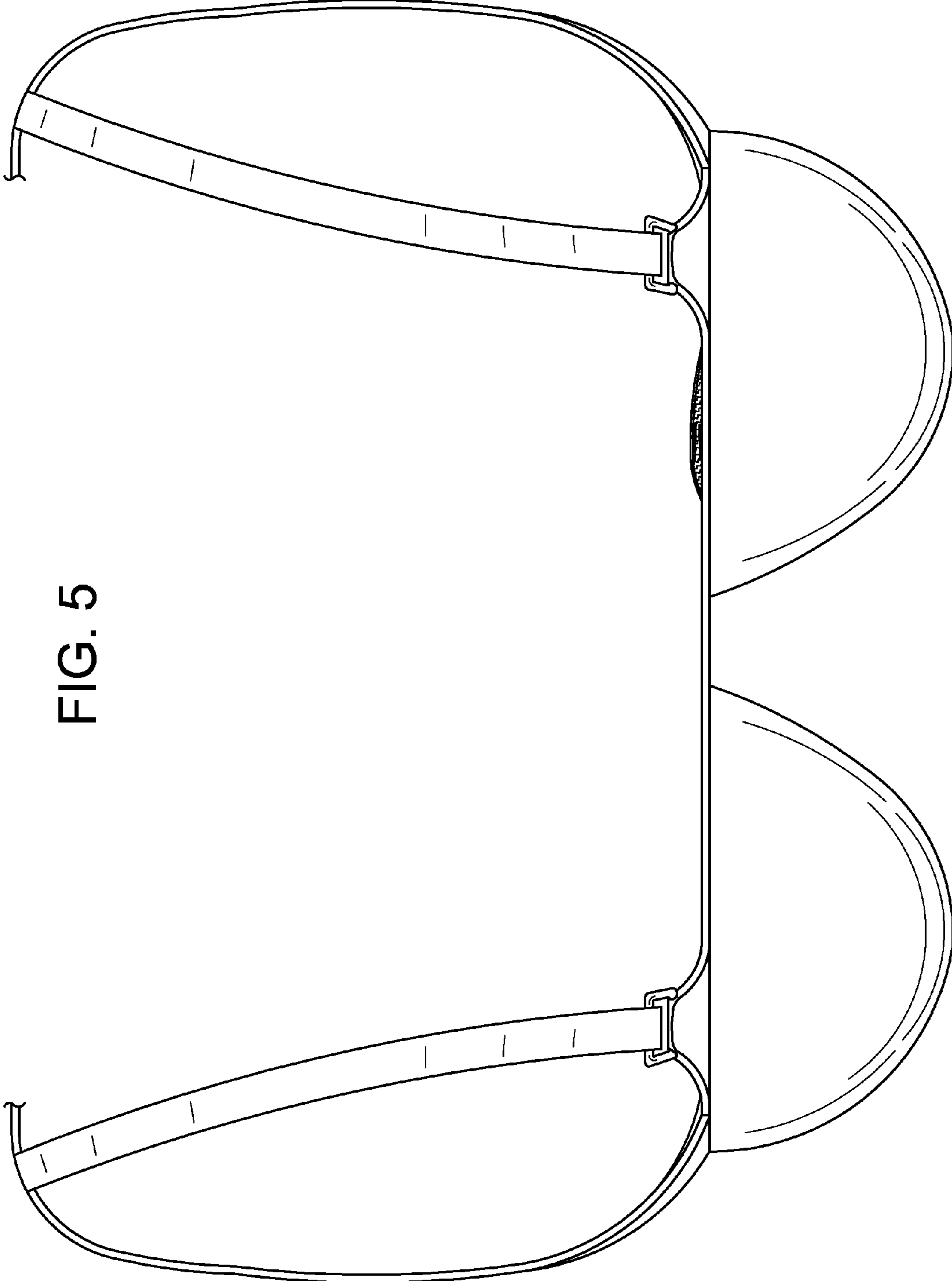

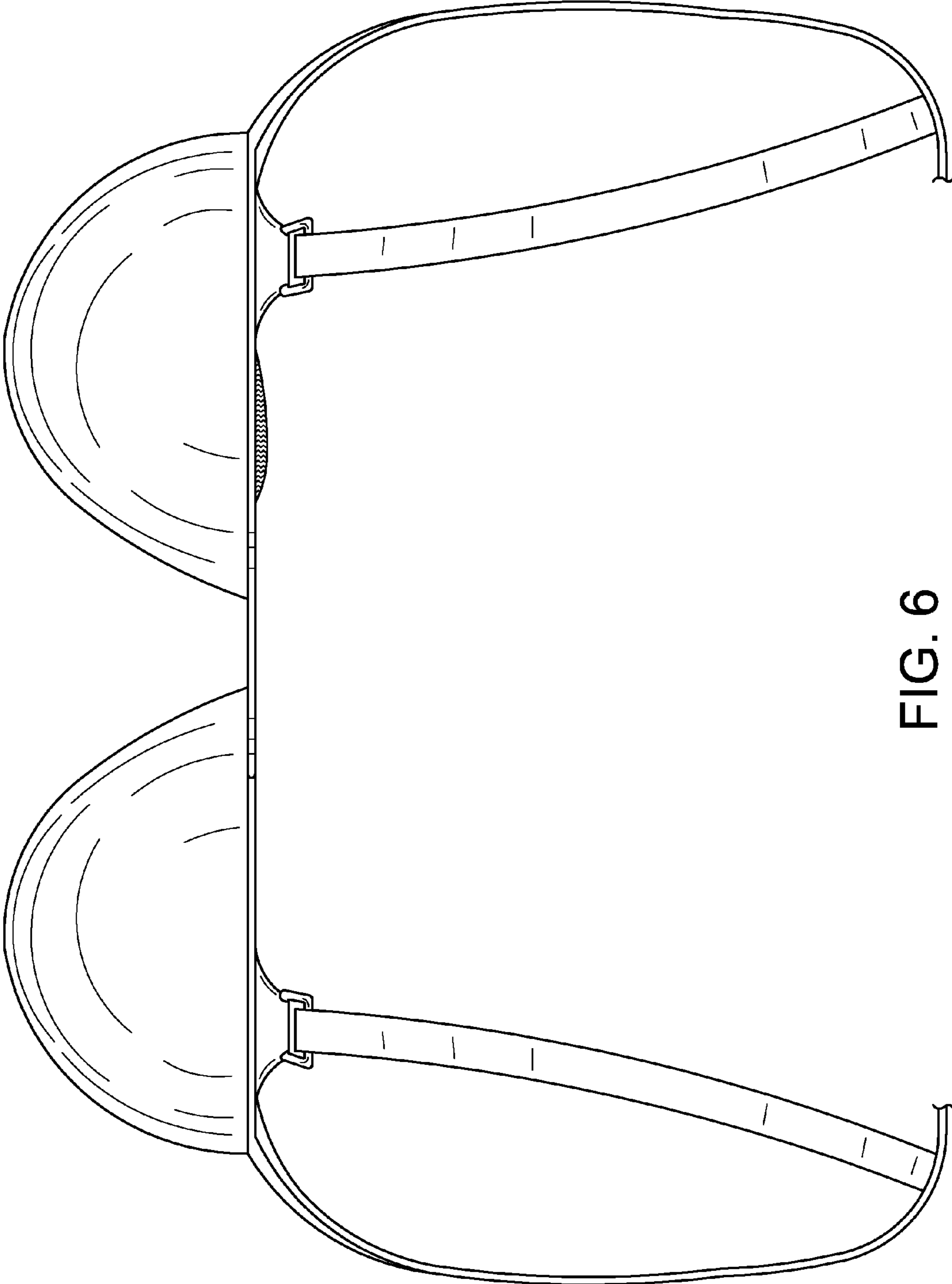

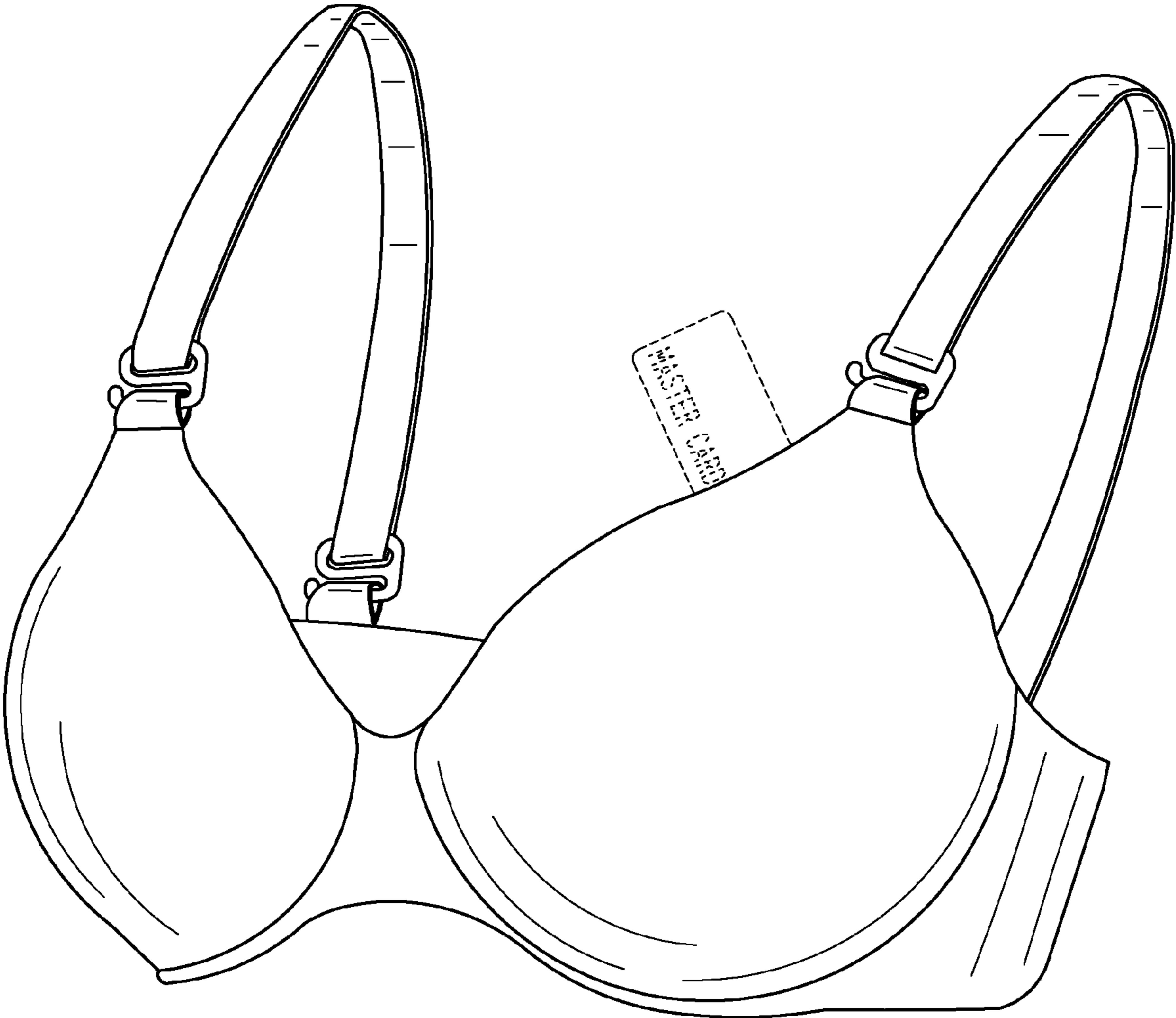

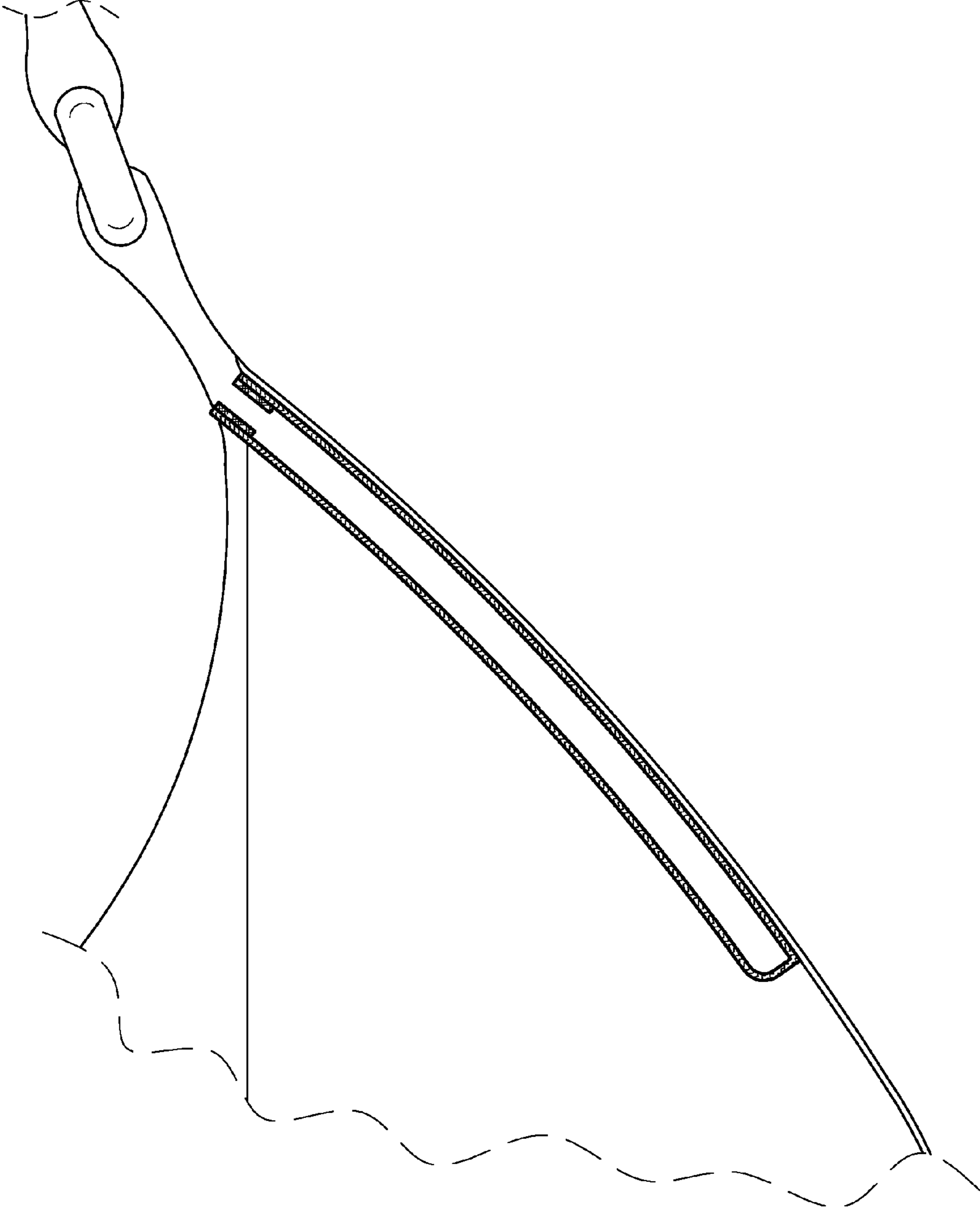
