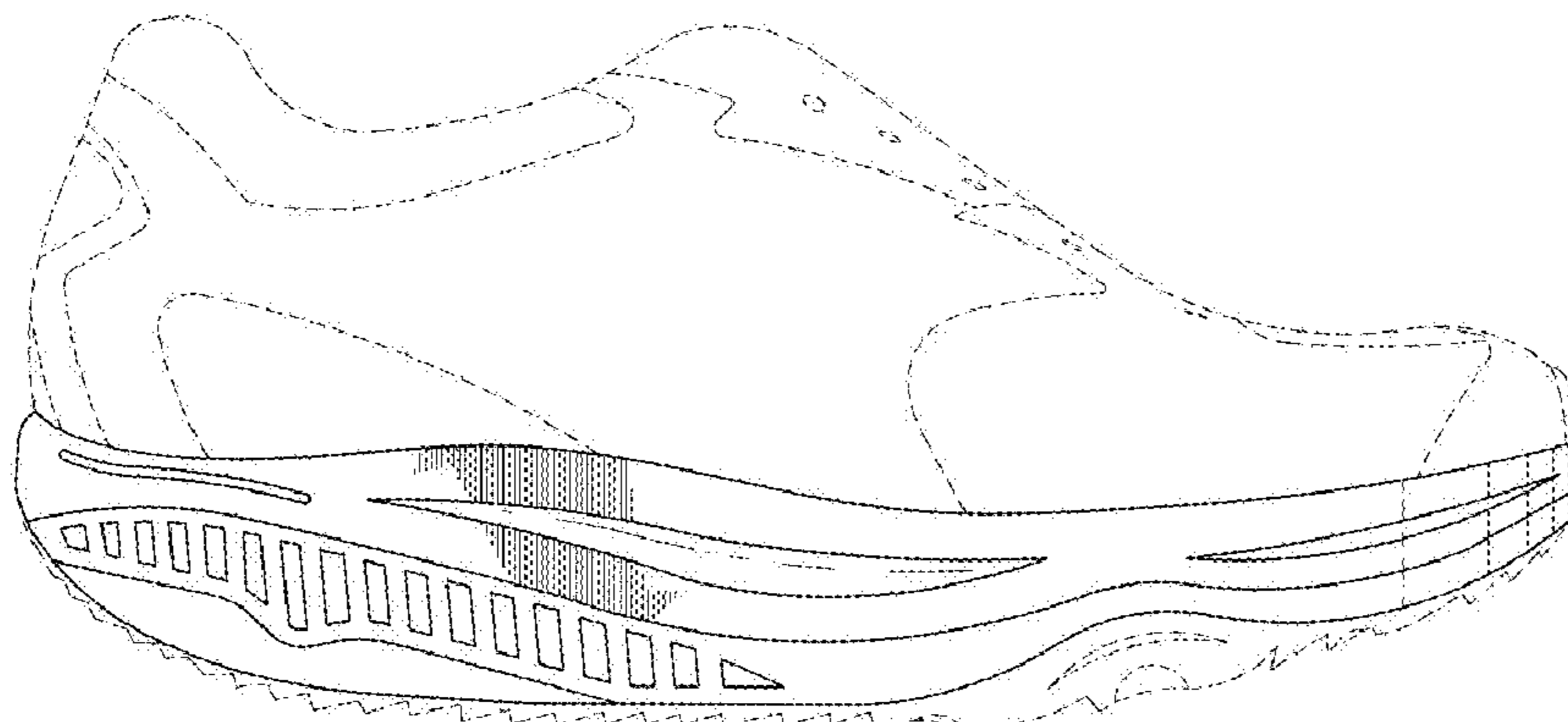
The ornamental design for a periphery of an outsole, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a periphery of an outsole embodying my new design;

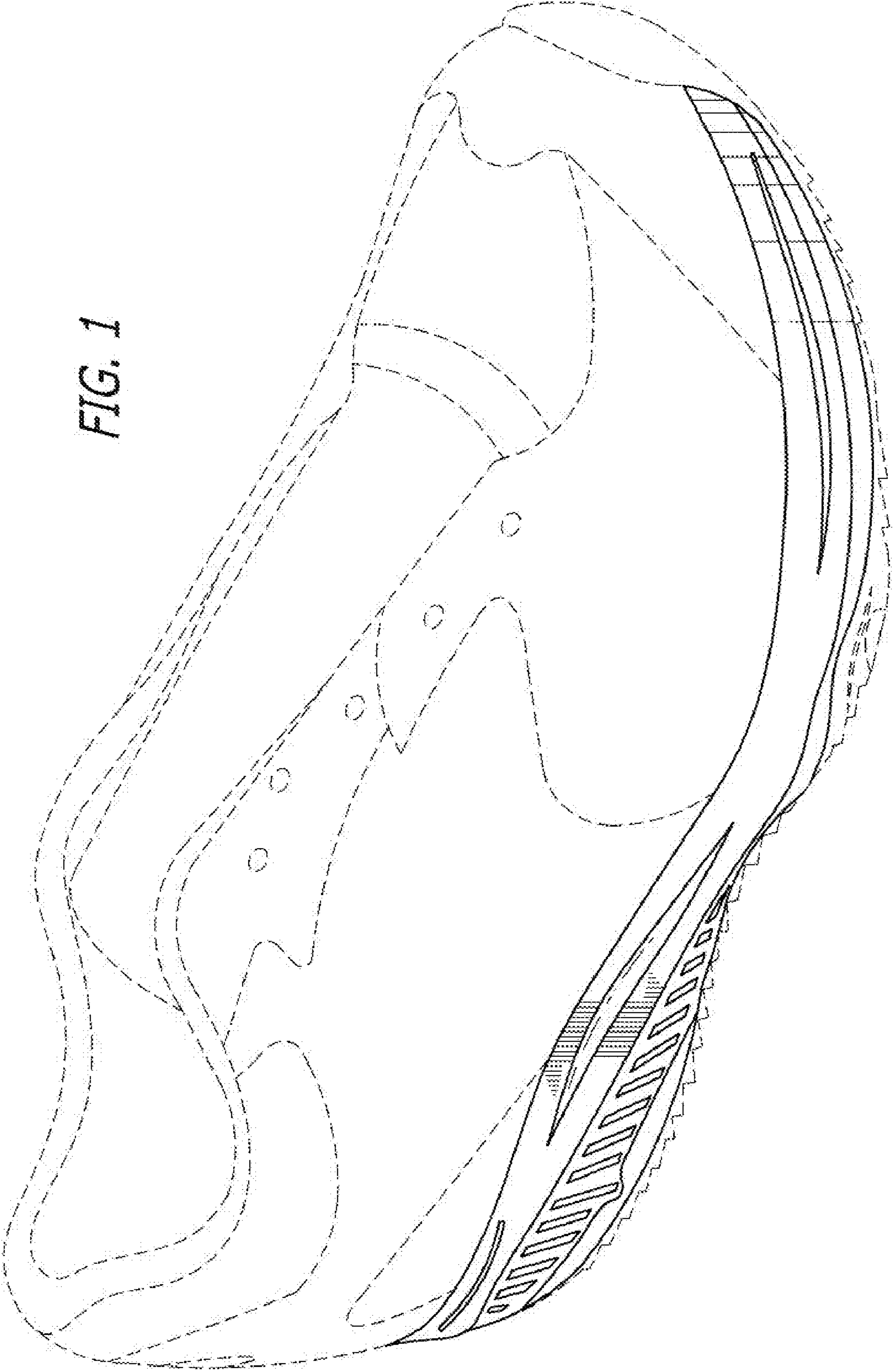
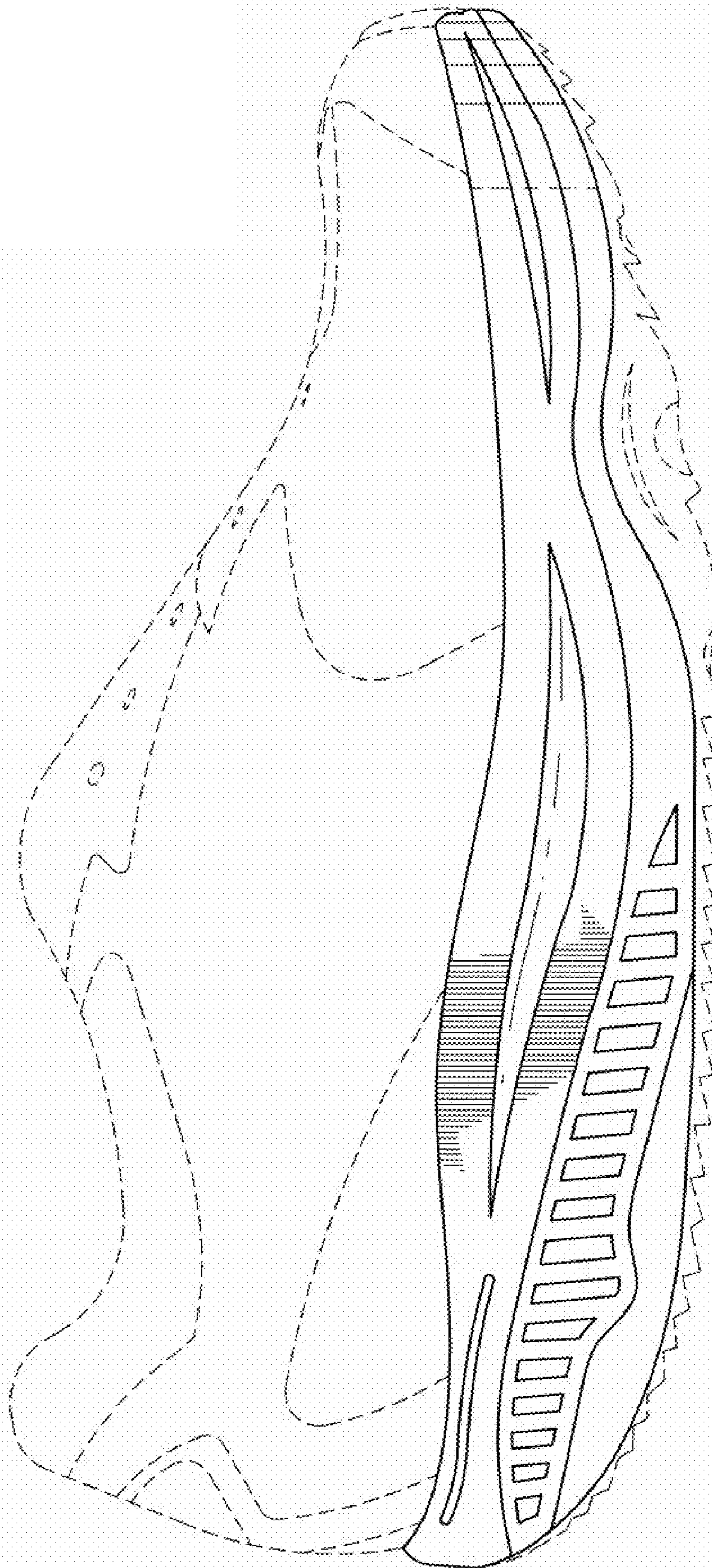

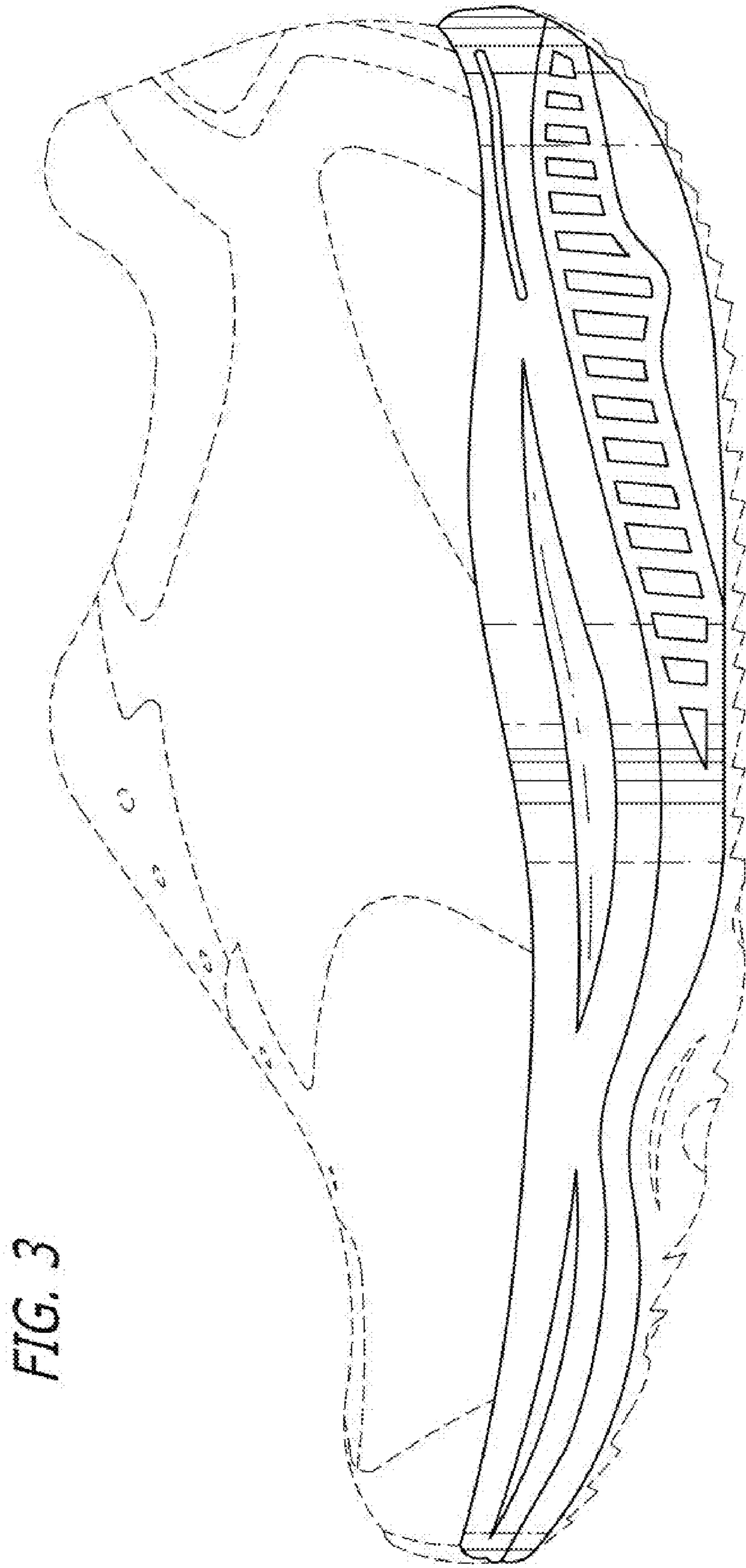

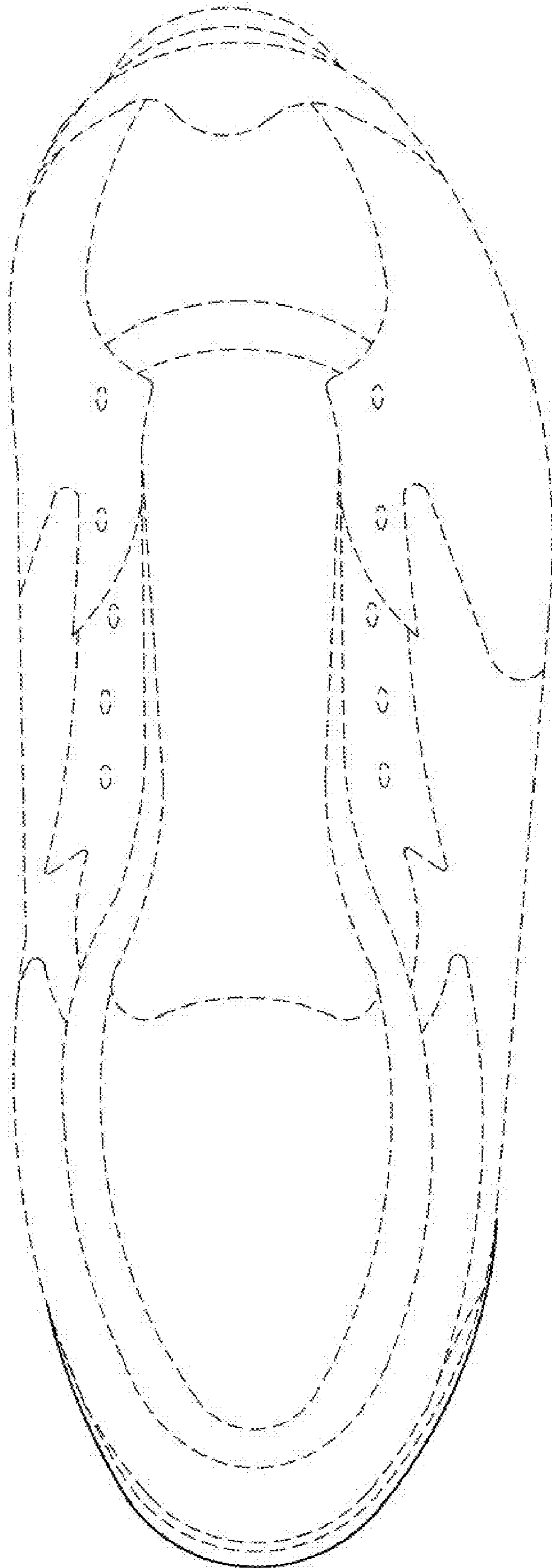

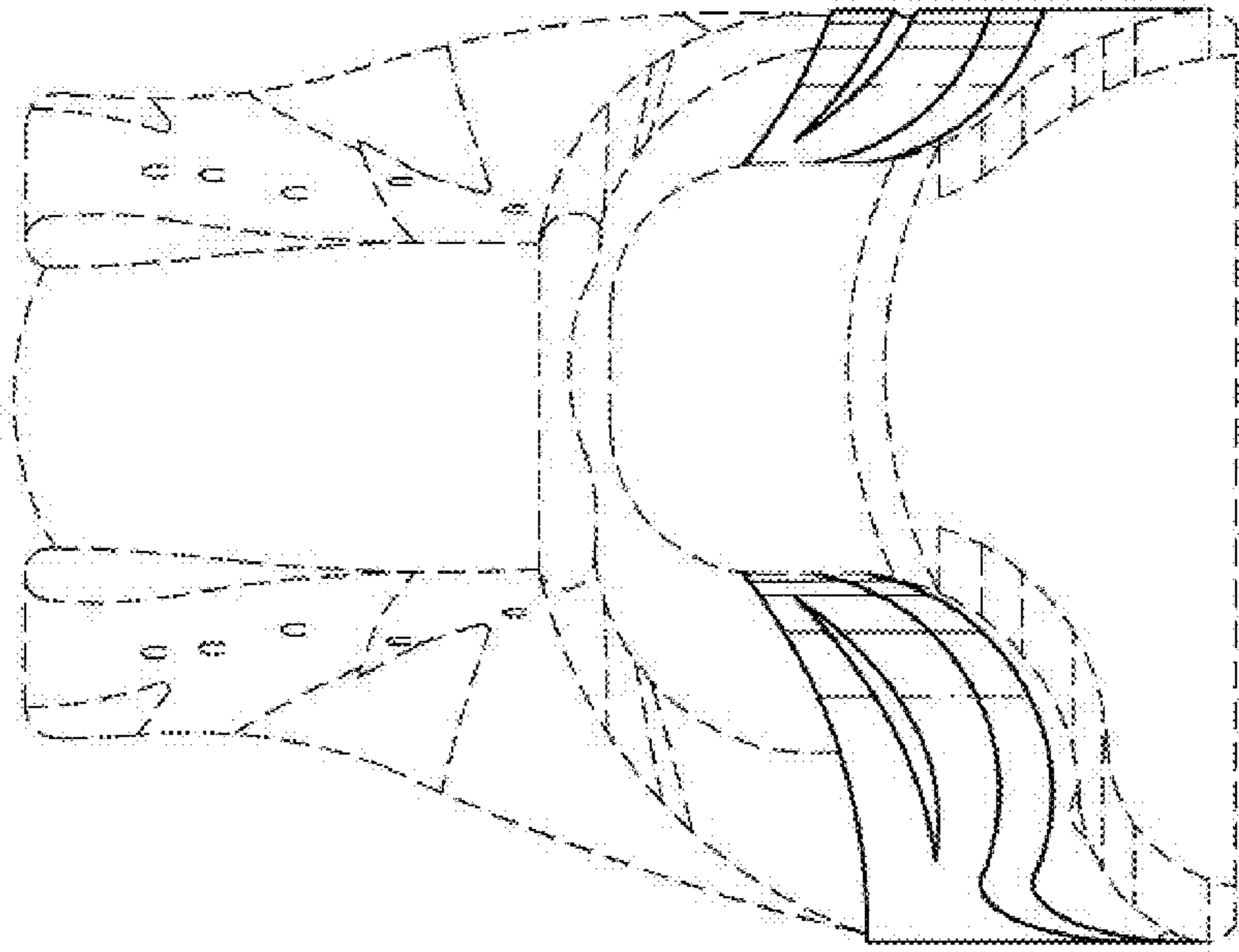
