DESCRIPTION

FIG. 1 is a front perspective view of the invention.

FIG. 2 is a top plan view of FIG. 1, the bottom plan view being a mirror image thereof.

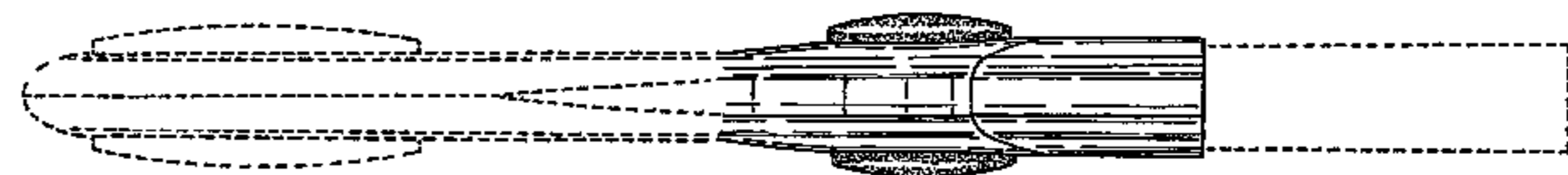
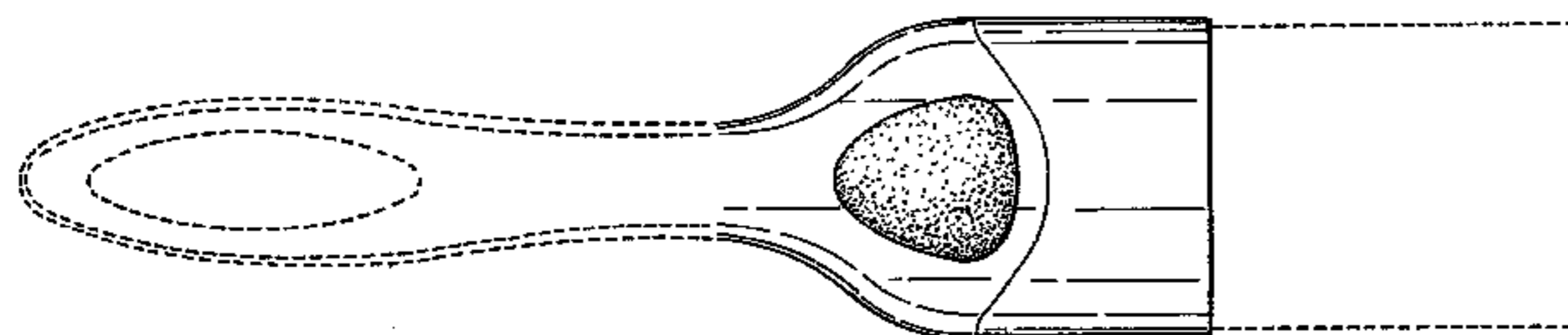
FIG. 3 is a left side elevation view of FIG. 1, the right side elevation being a mirror image thereof.

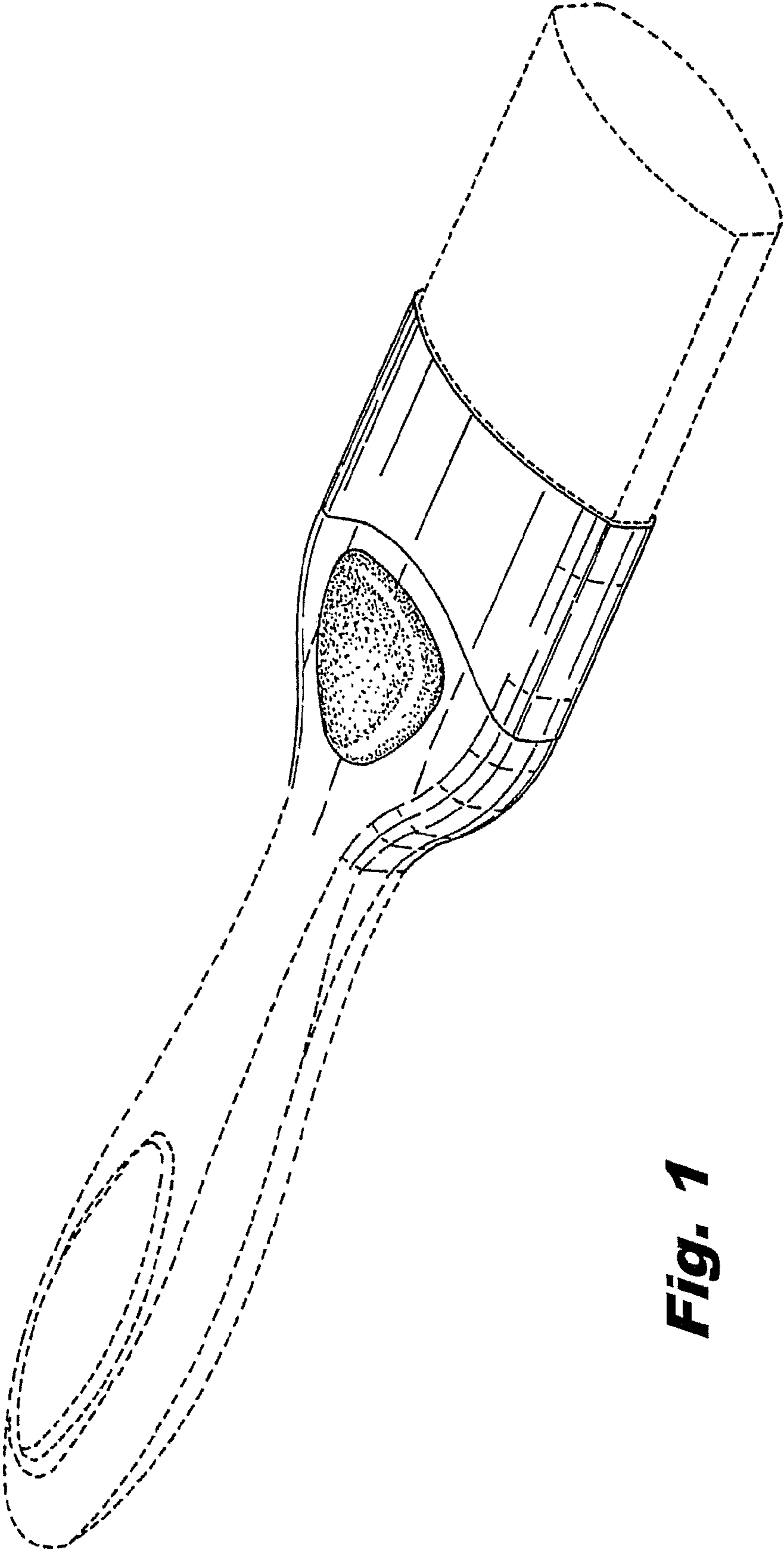

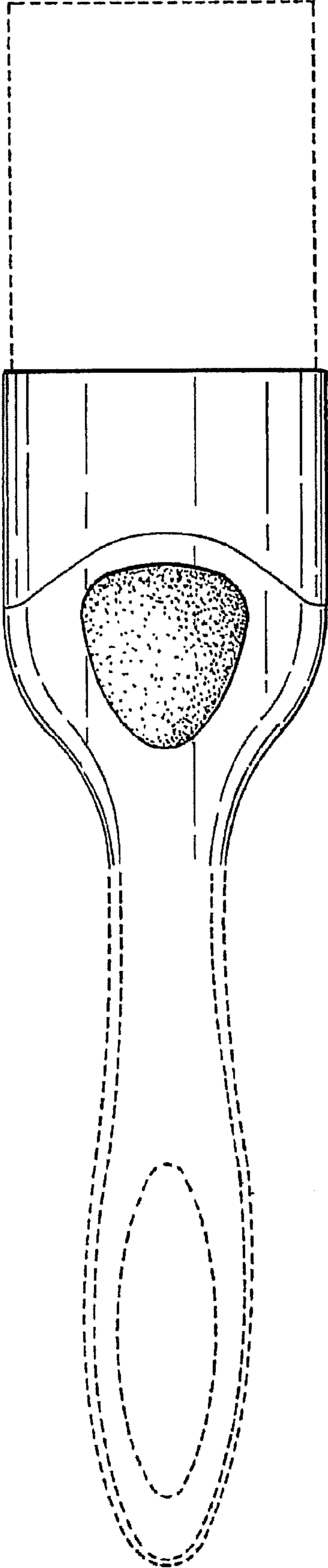

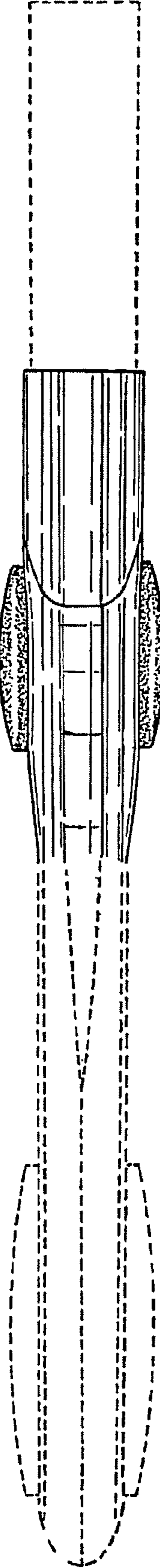

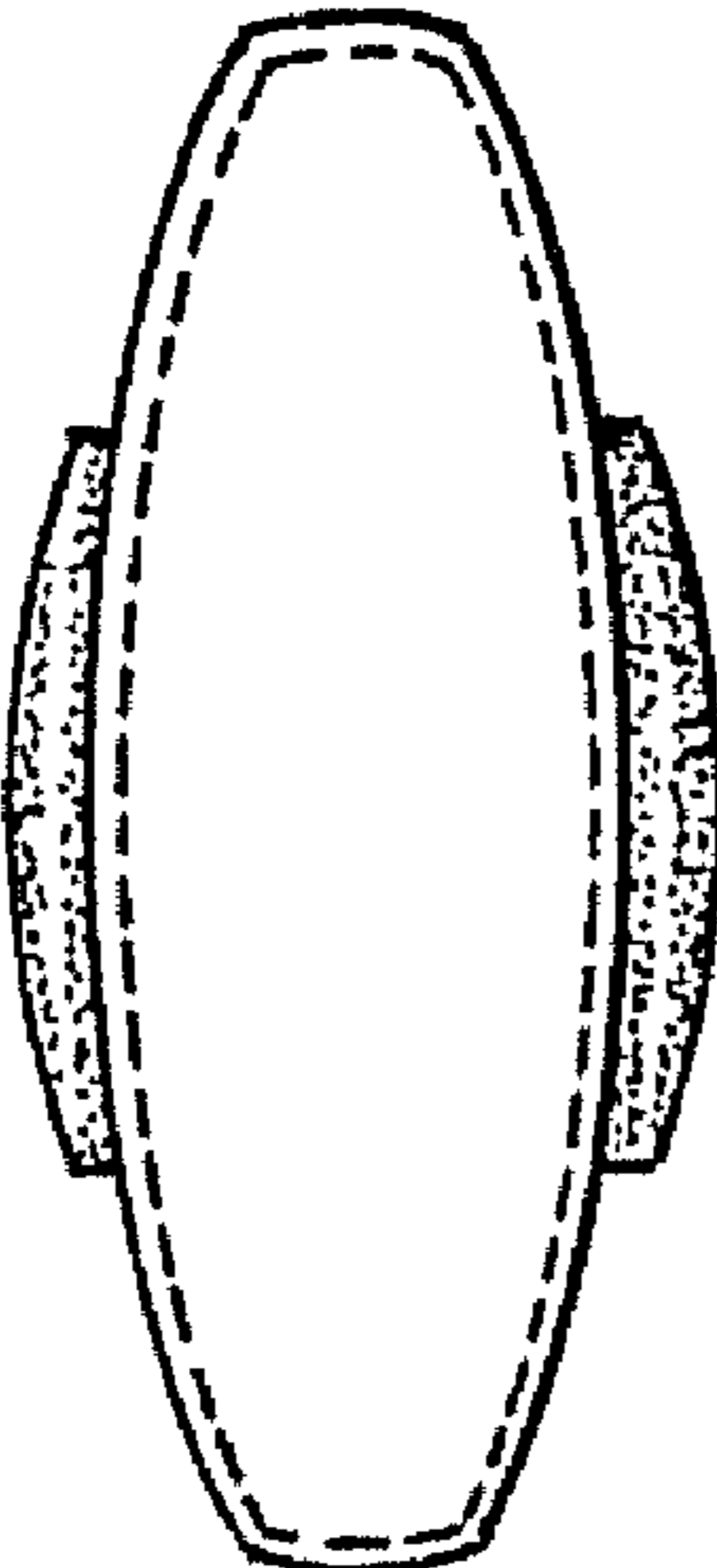

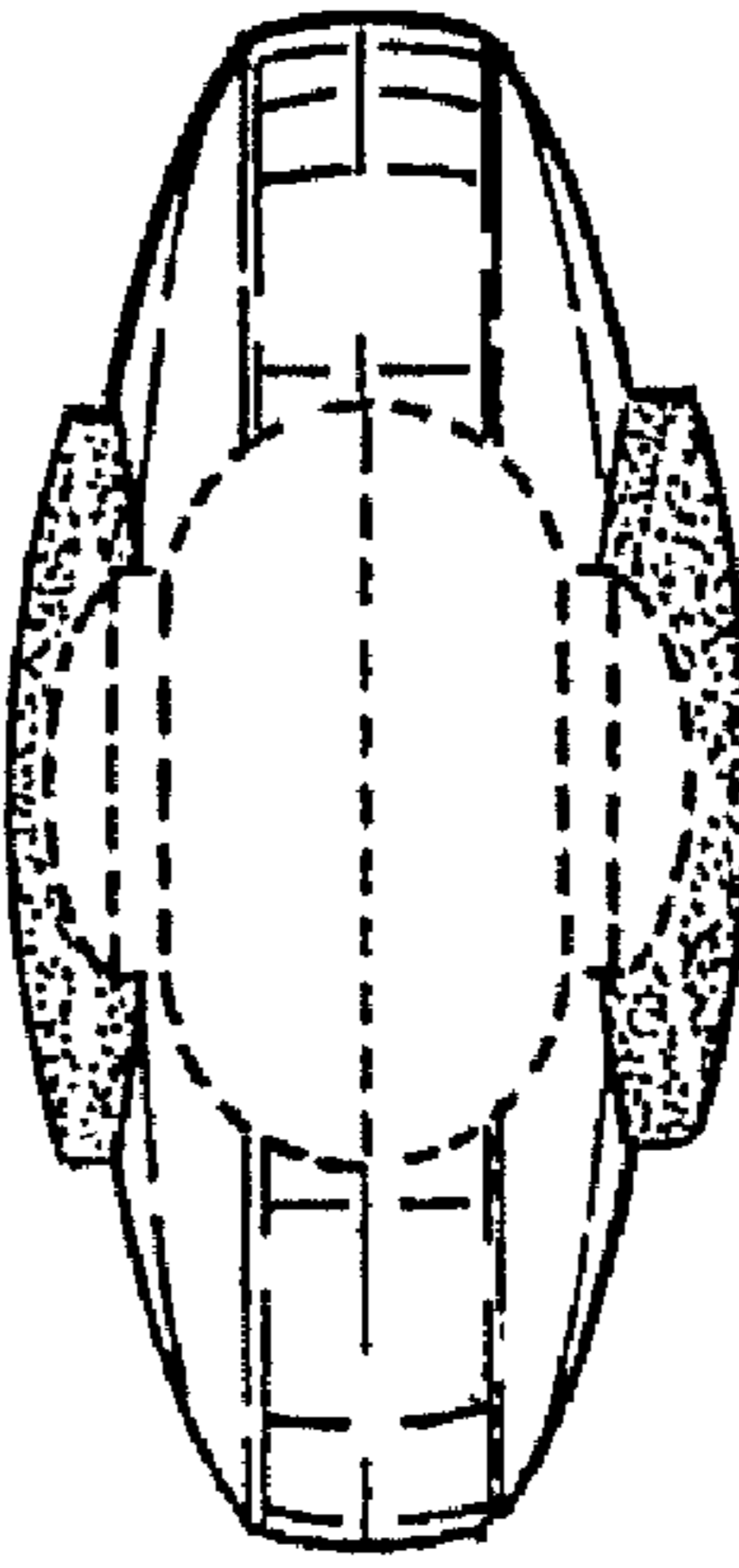
