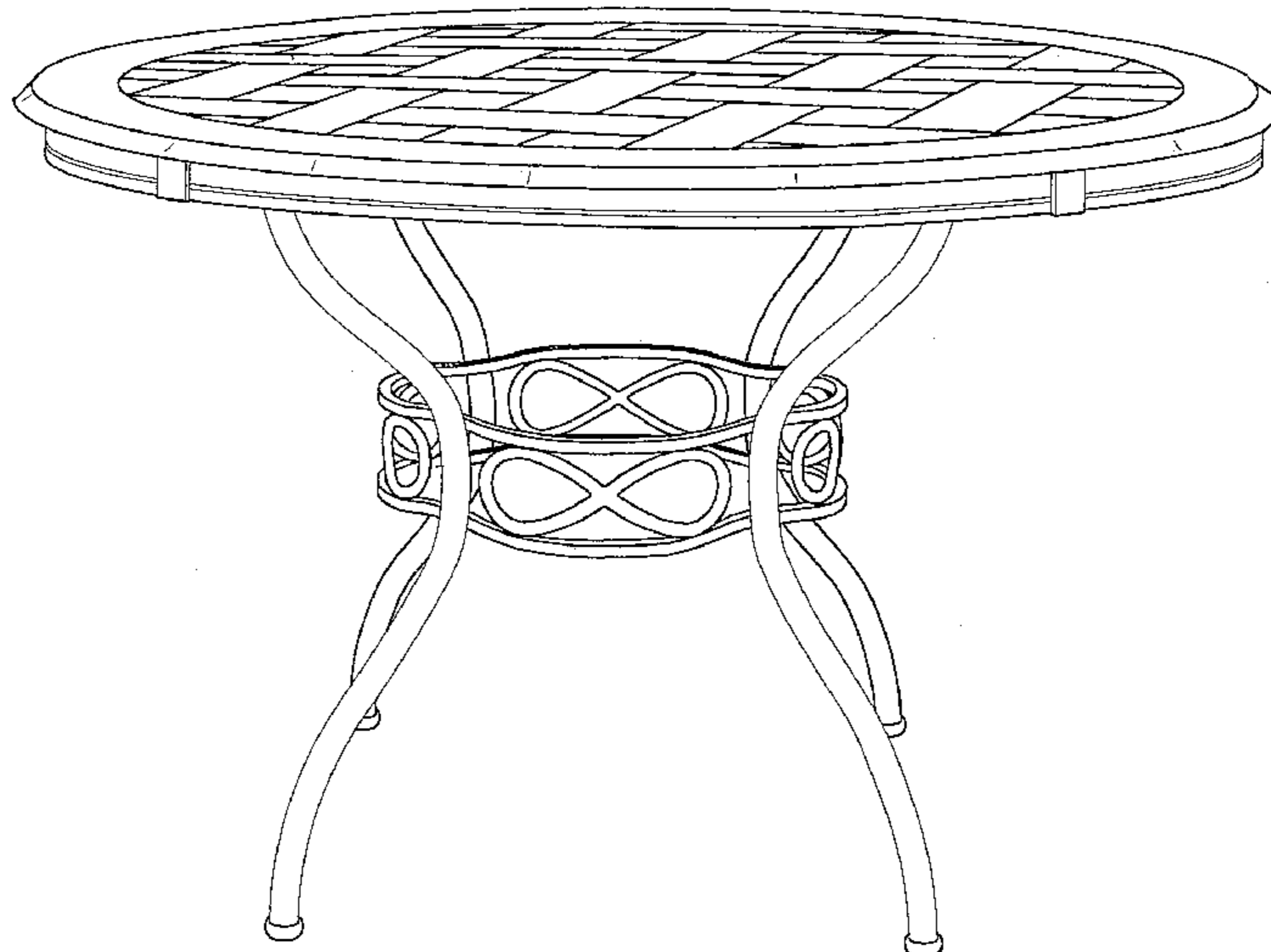
FIG. 2 is a front elevational view of a dining table according

site side being identical to this view.

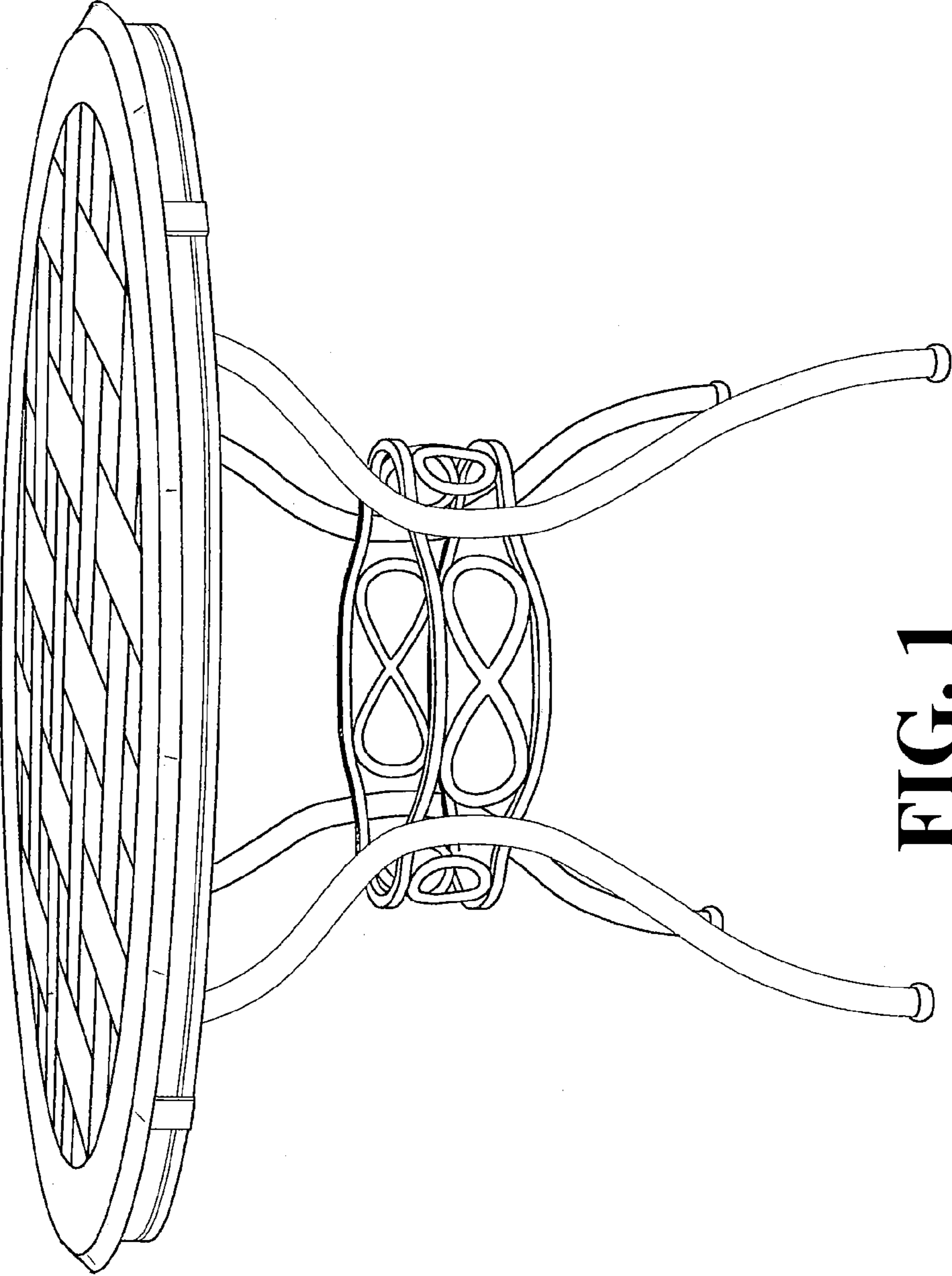
FIG. 3 is a side elevational view of a dining table according to

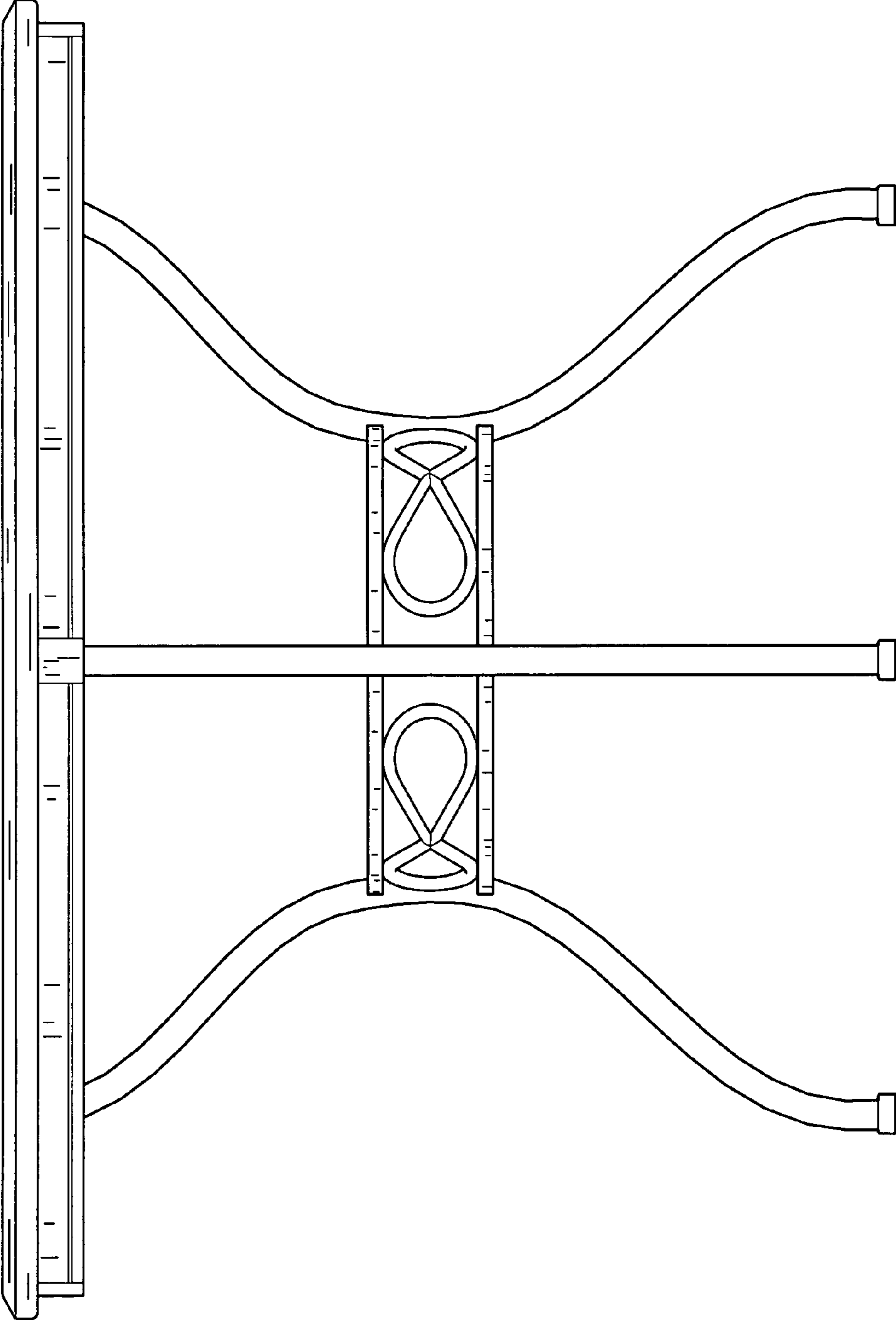

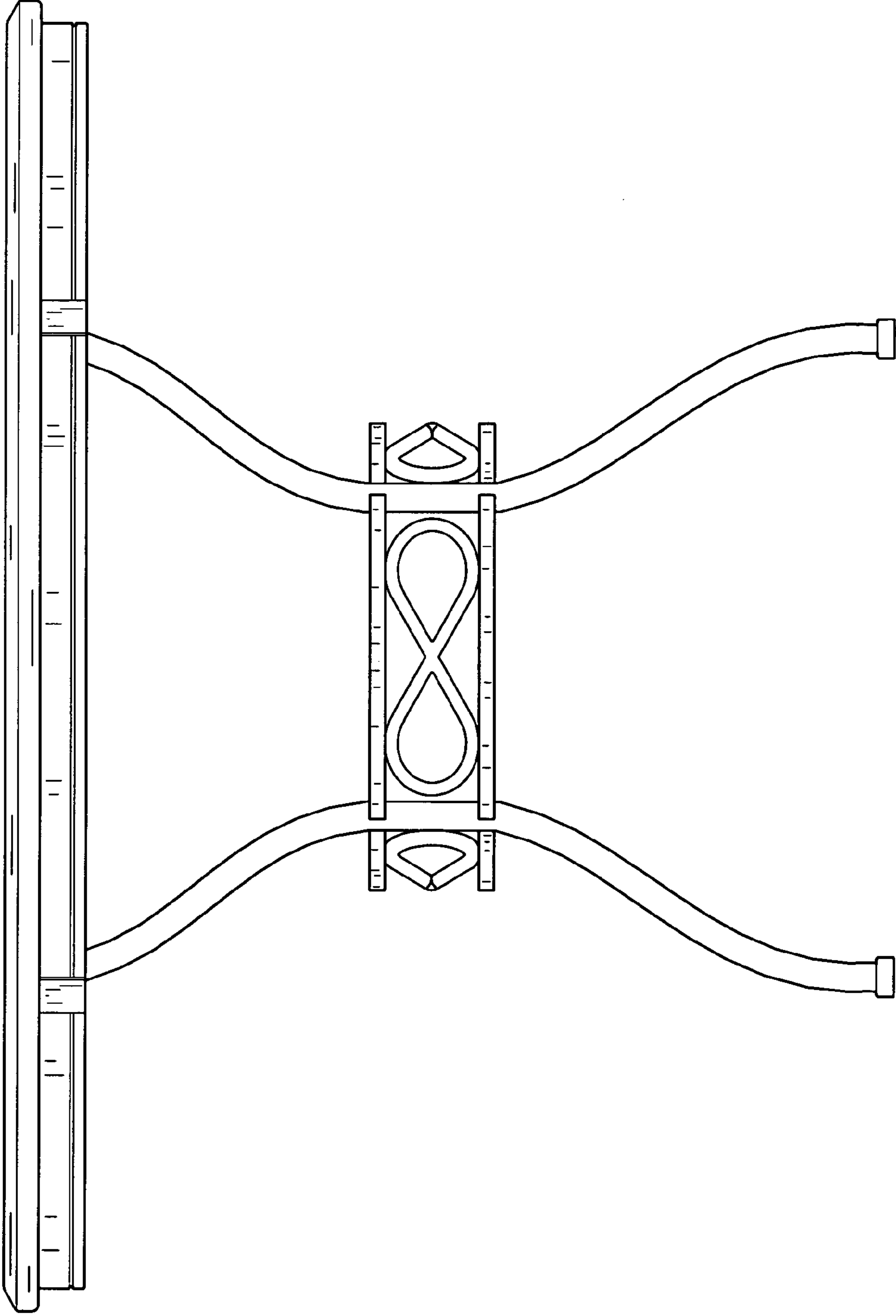

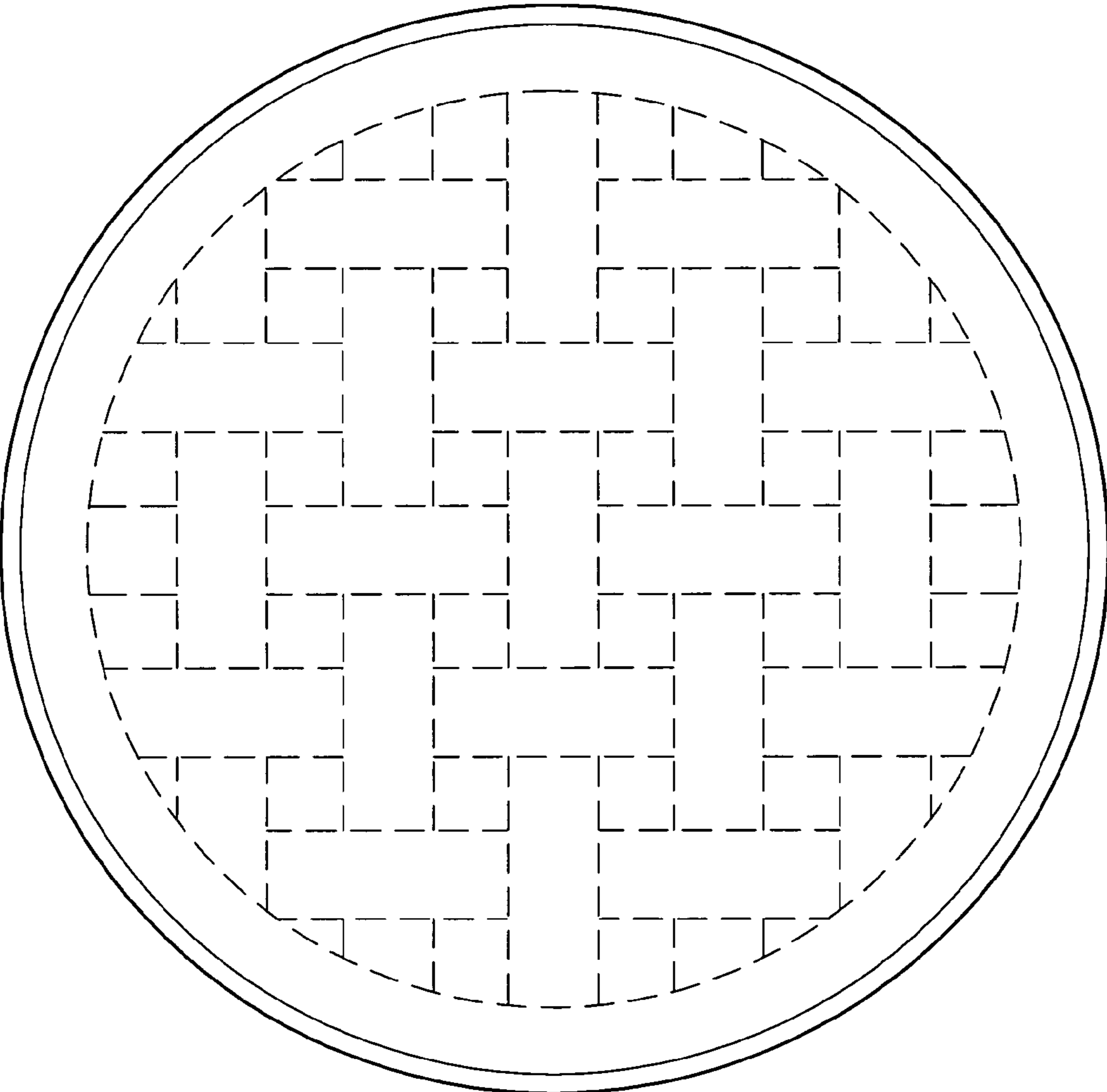
