DESCRIPTION

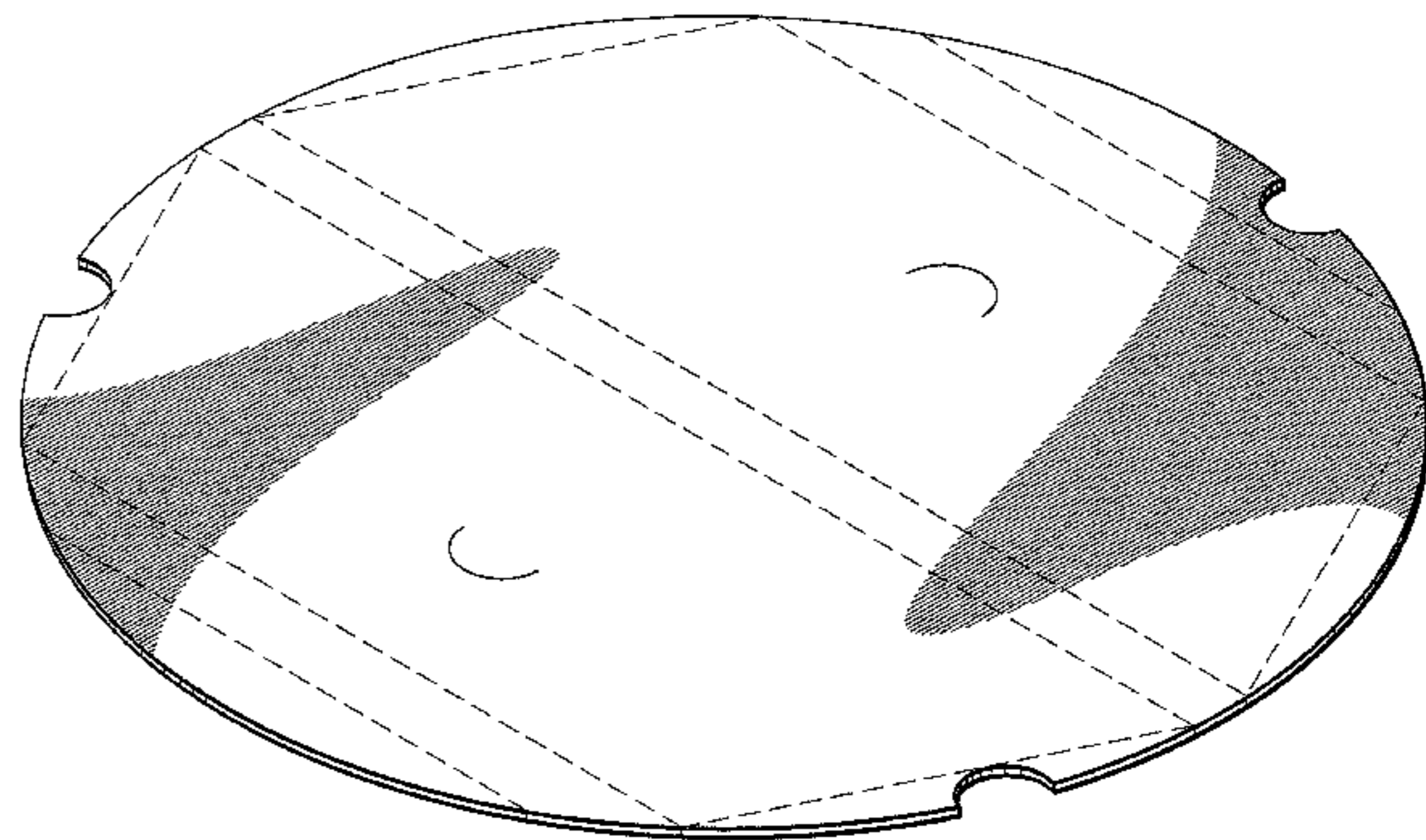
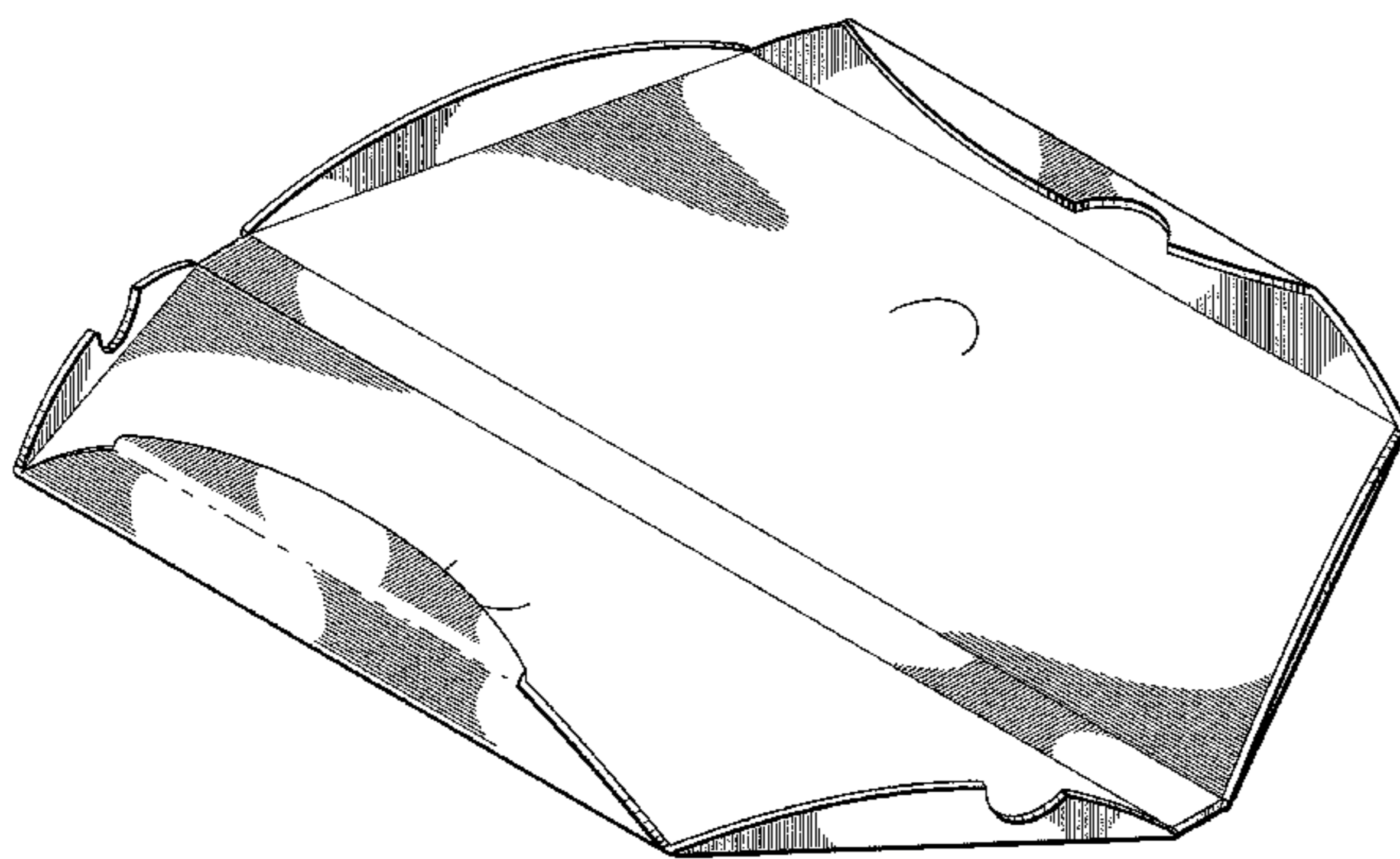
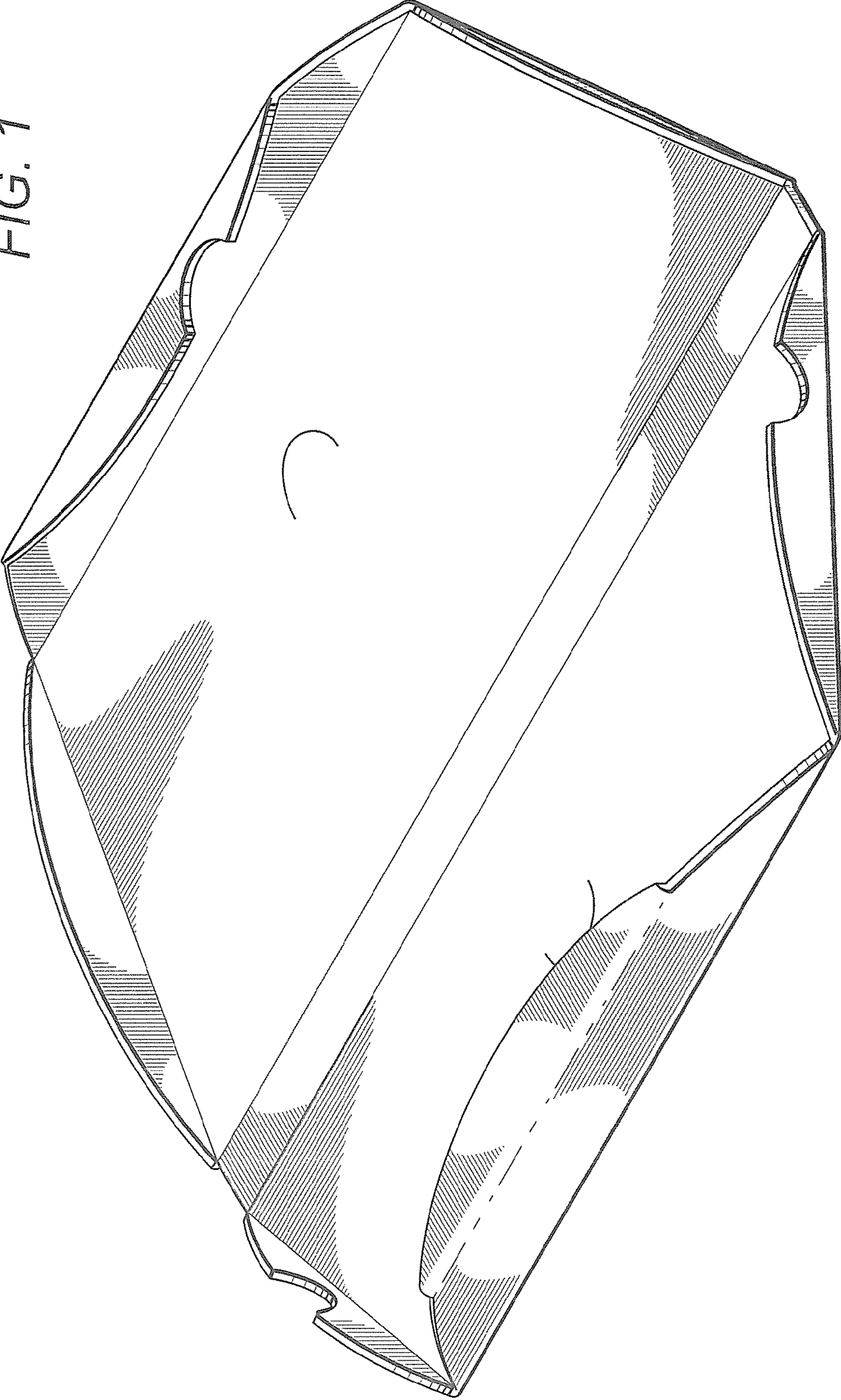

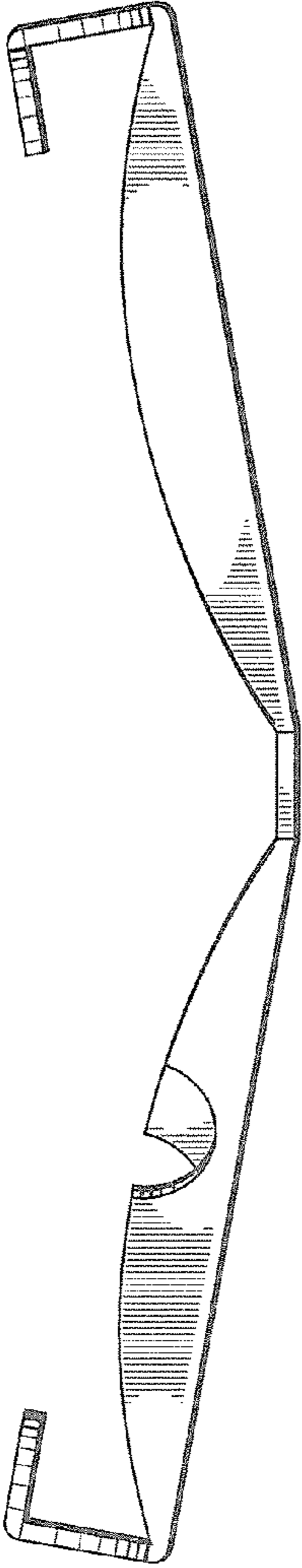

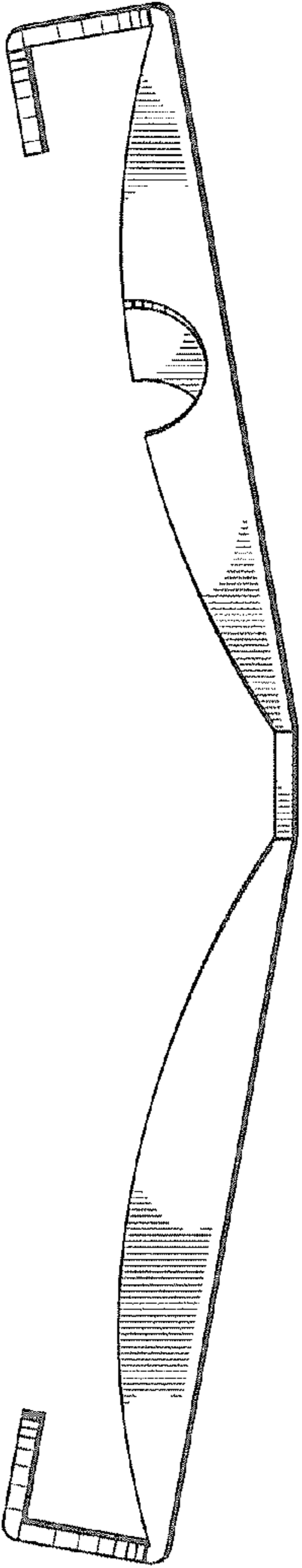

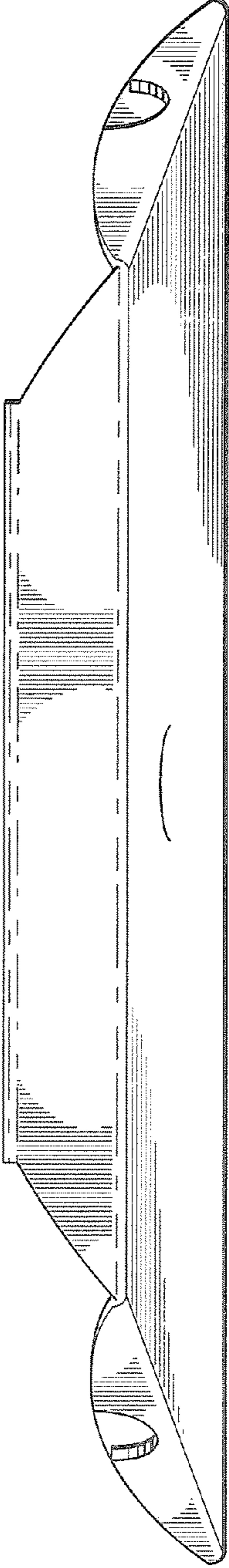

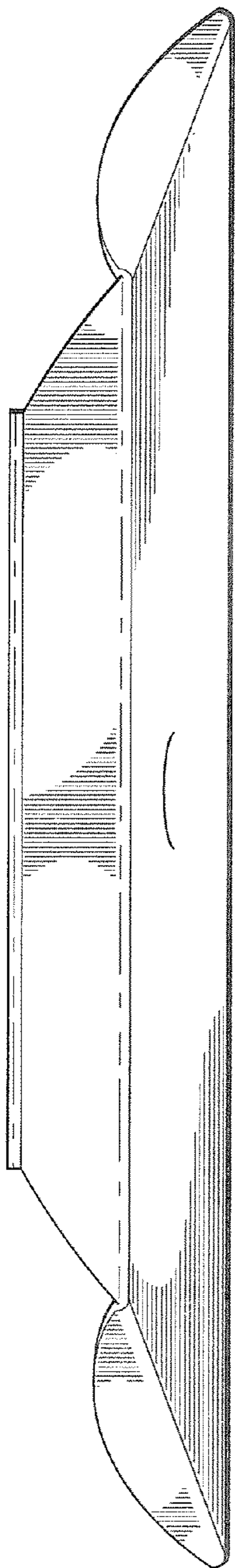

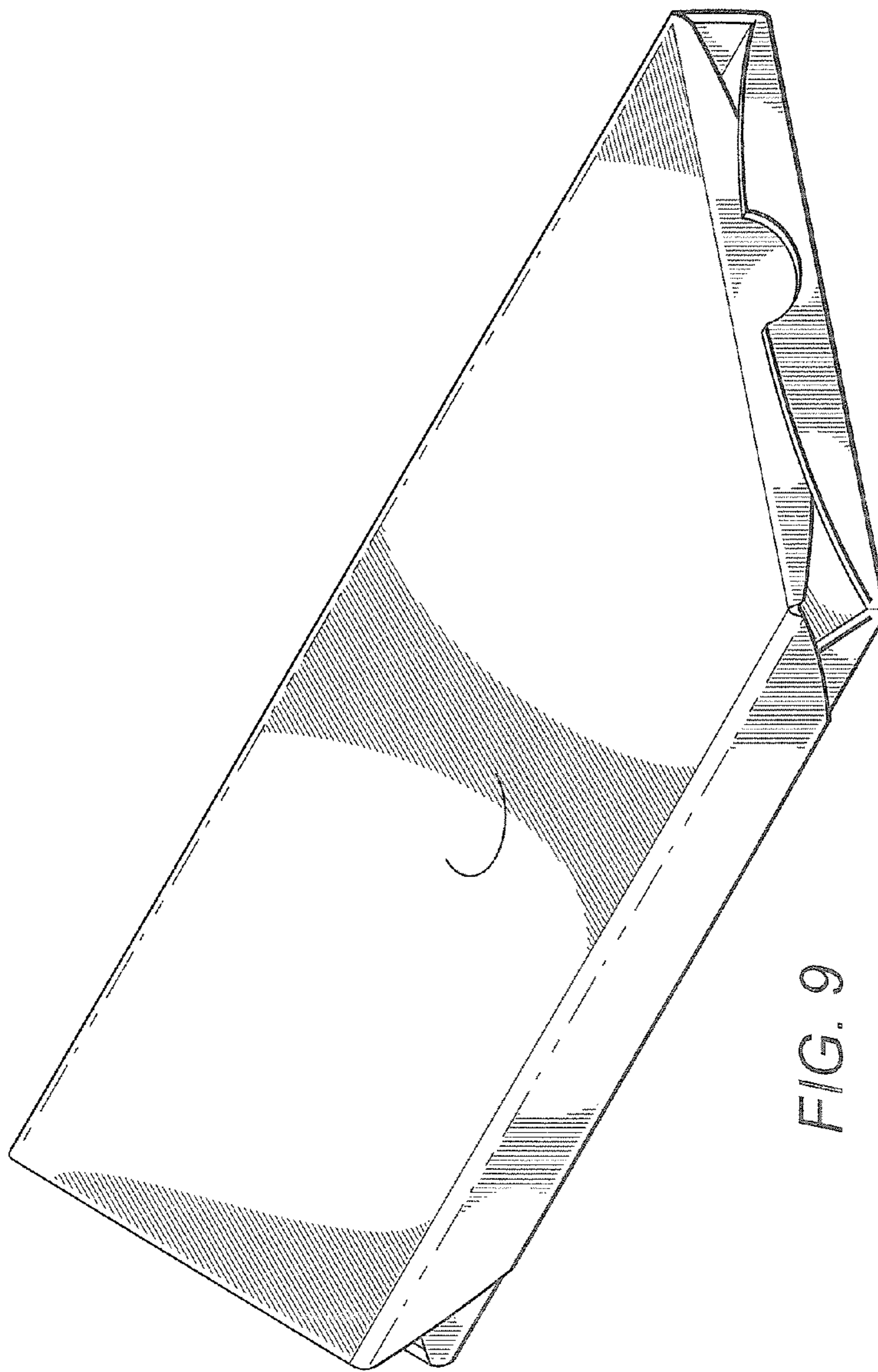

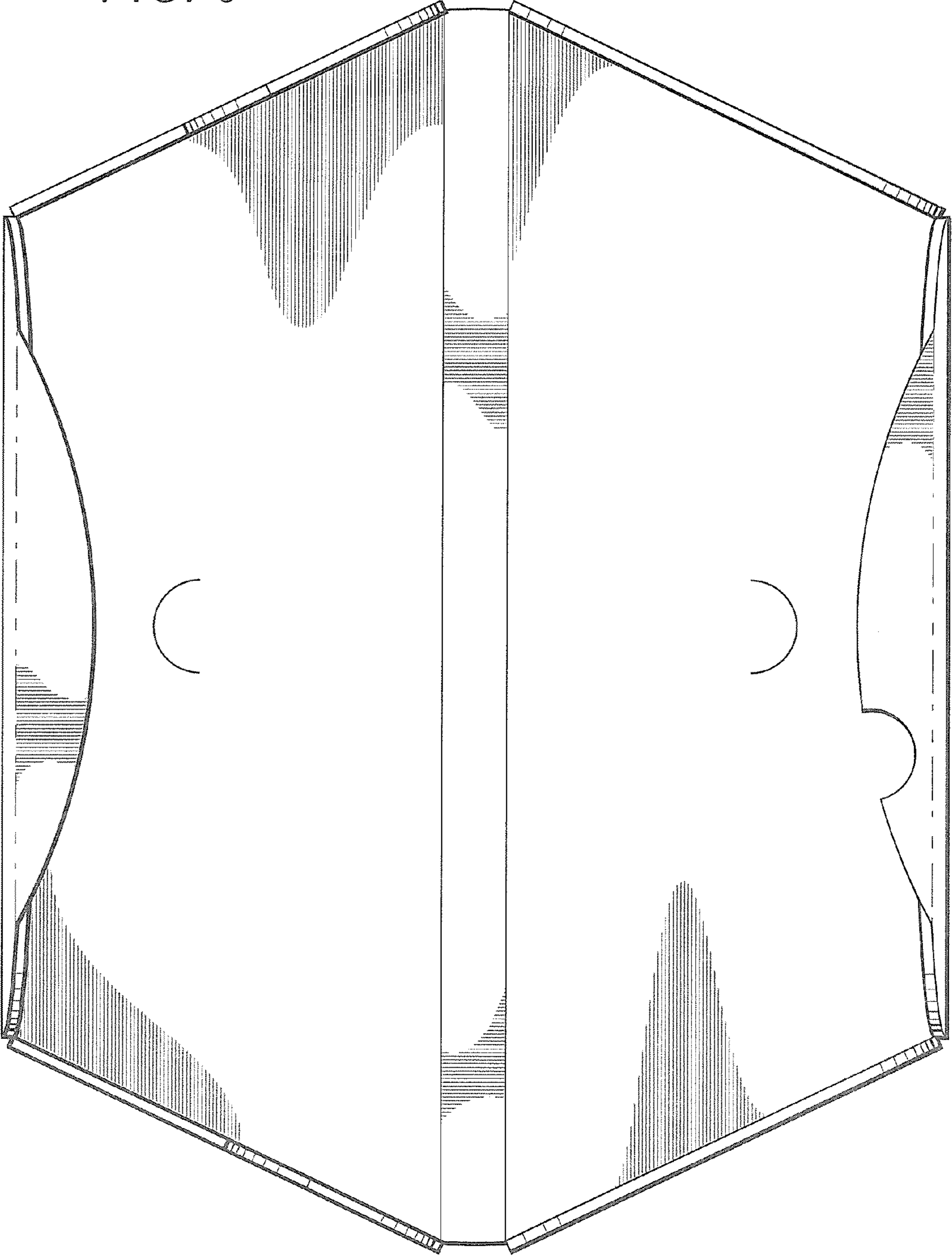

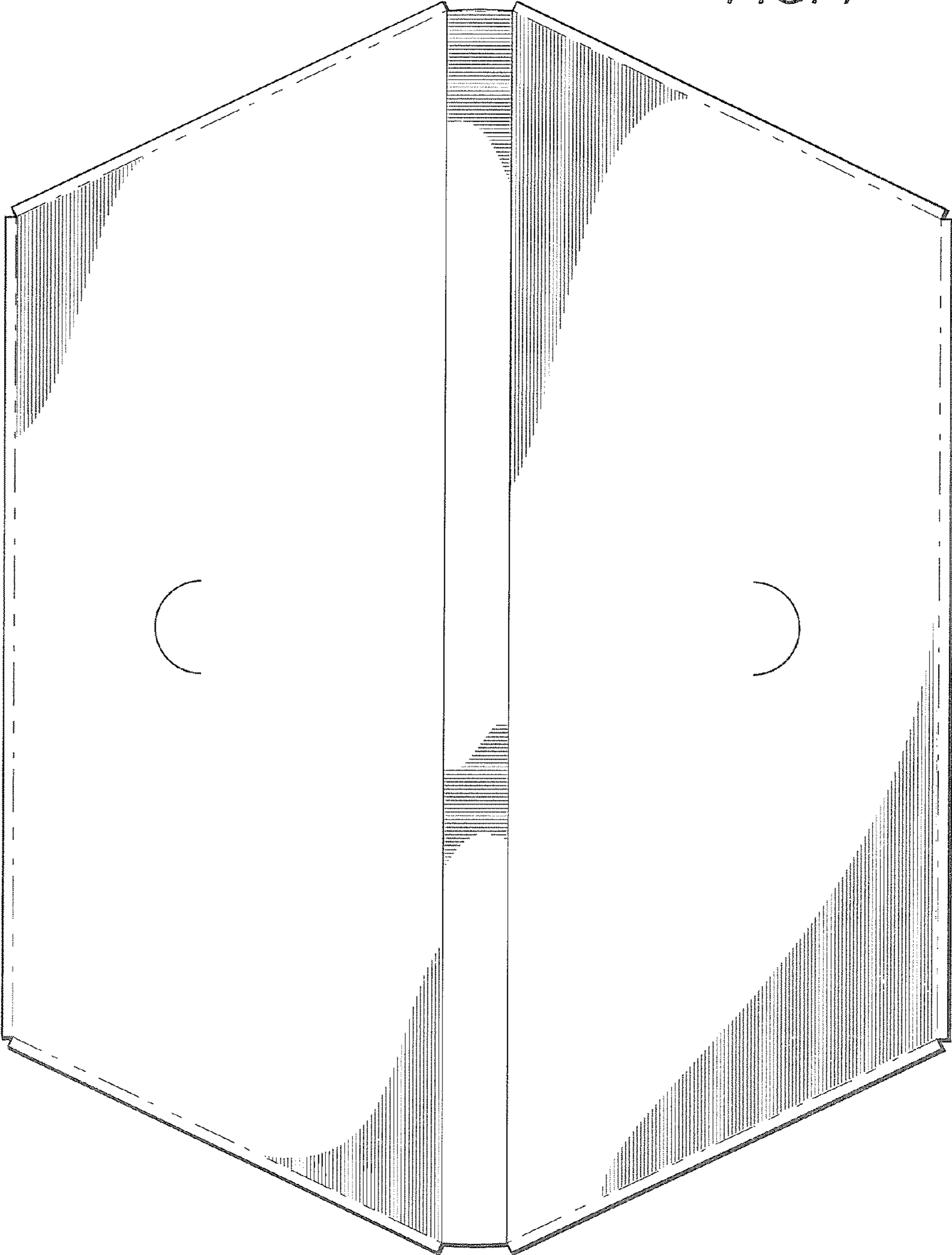
