(57) **CLAIM**

The ornamental design for a leaf rake head, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective top view of the leaf rake head.

FIG. 2 shows another perspective top view of the leaf rake head, wherein this view is rotated approximately ninety degrees relative to the view of FIG. 1.

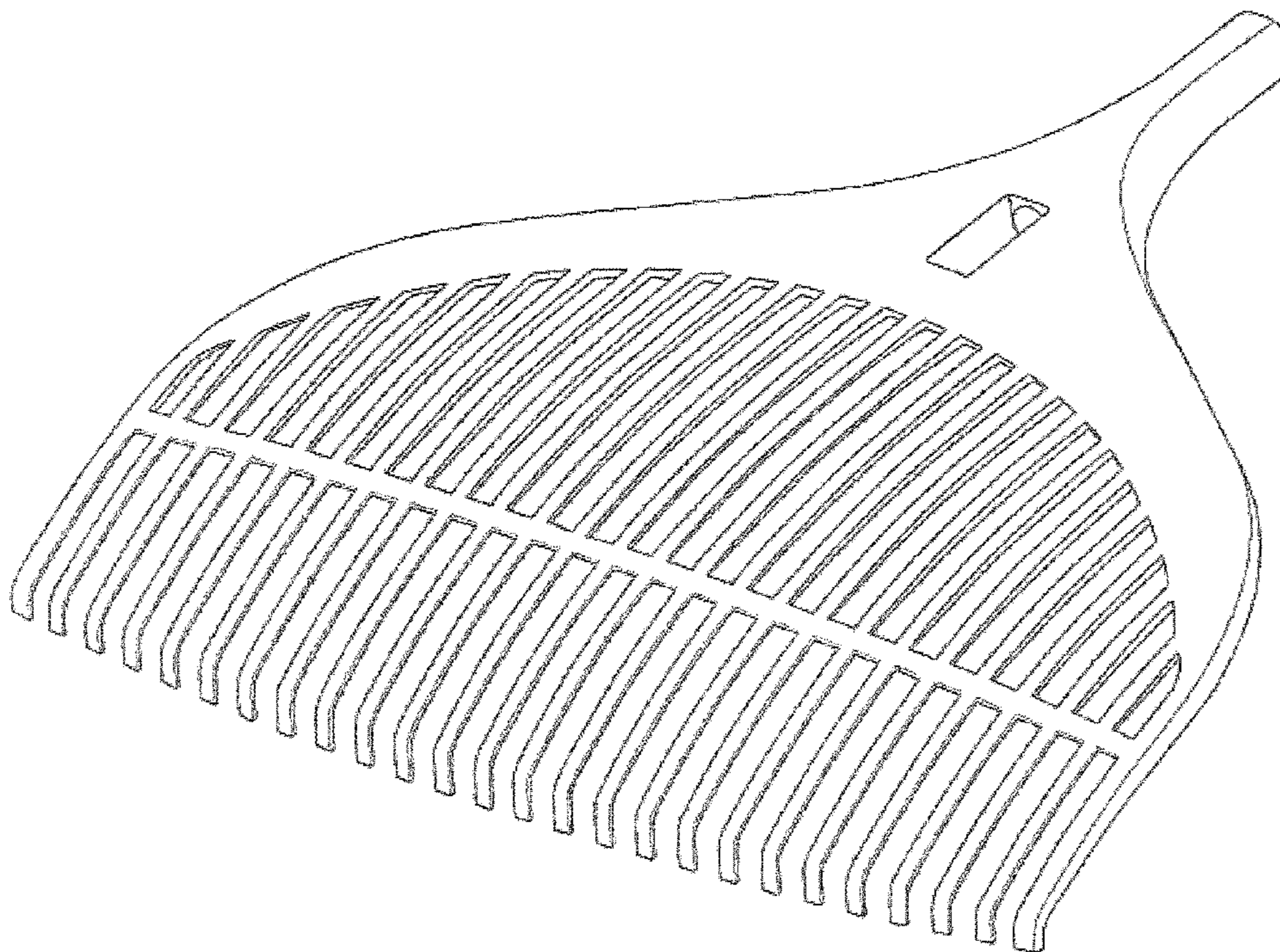
FIG. 3 is a perspective bottom view of the leaf rake head.

FIG. 4 is another perspective bottom view of the leaf rake head, wherein this view is rotated approximately 180 degrees relative to the view of FIG. 3.

FIG. 5 is a bottom view of the leaf rake head; and,

FIG. 6 is another bottom view of the leaf rake head, wherein this view is rotated approximately 180 degrees relative to the view of FIG. 5.

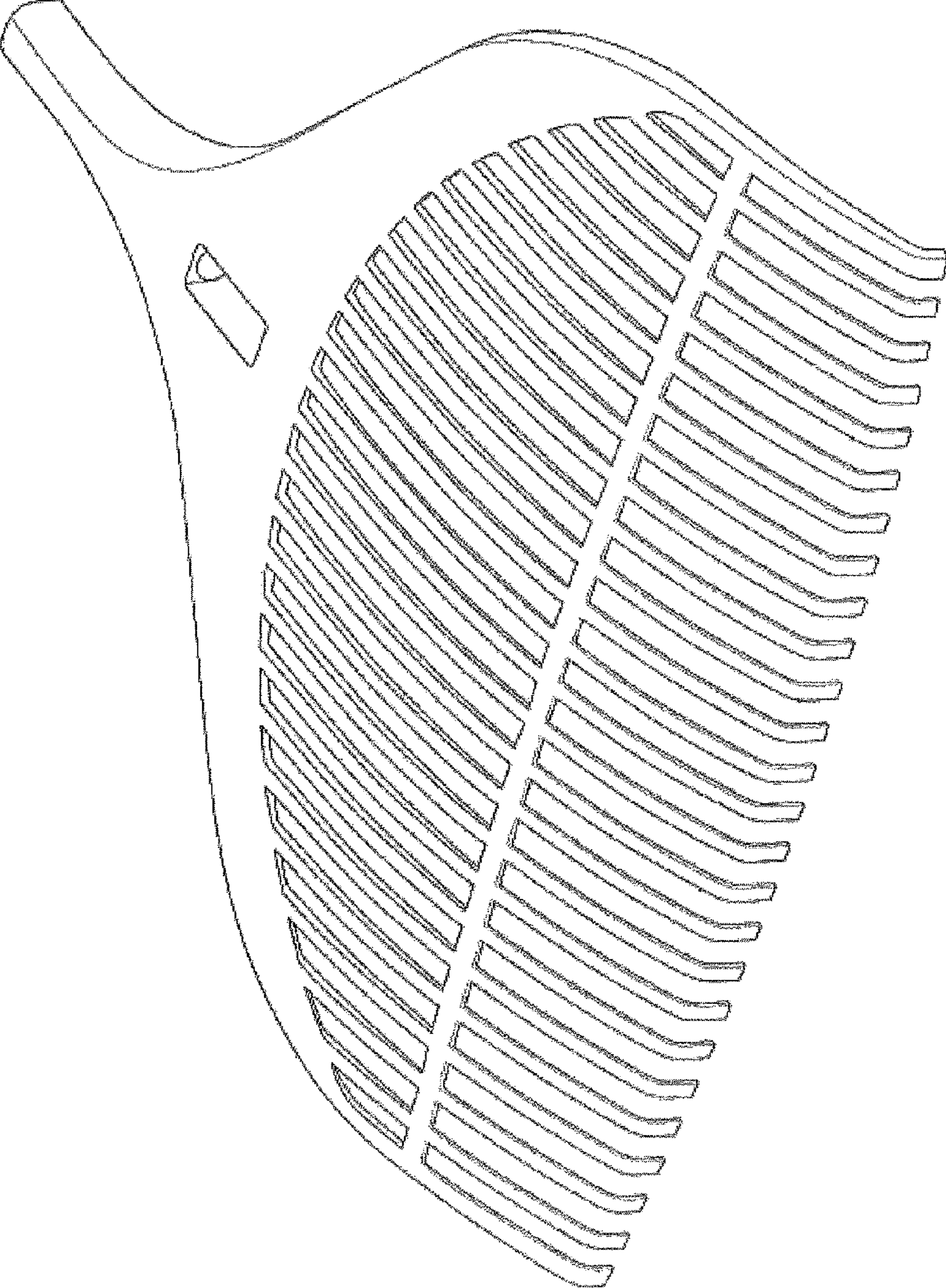

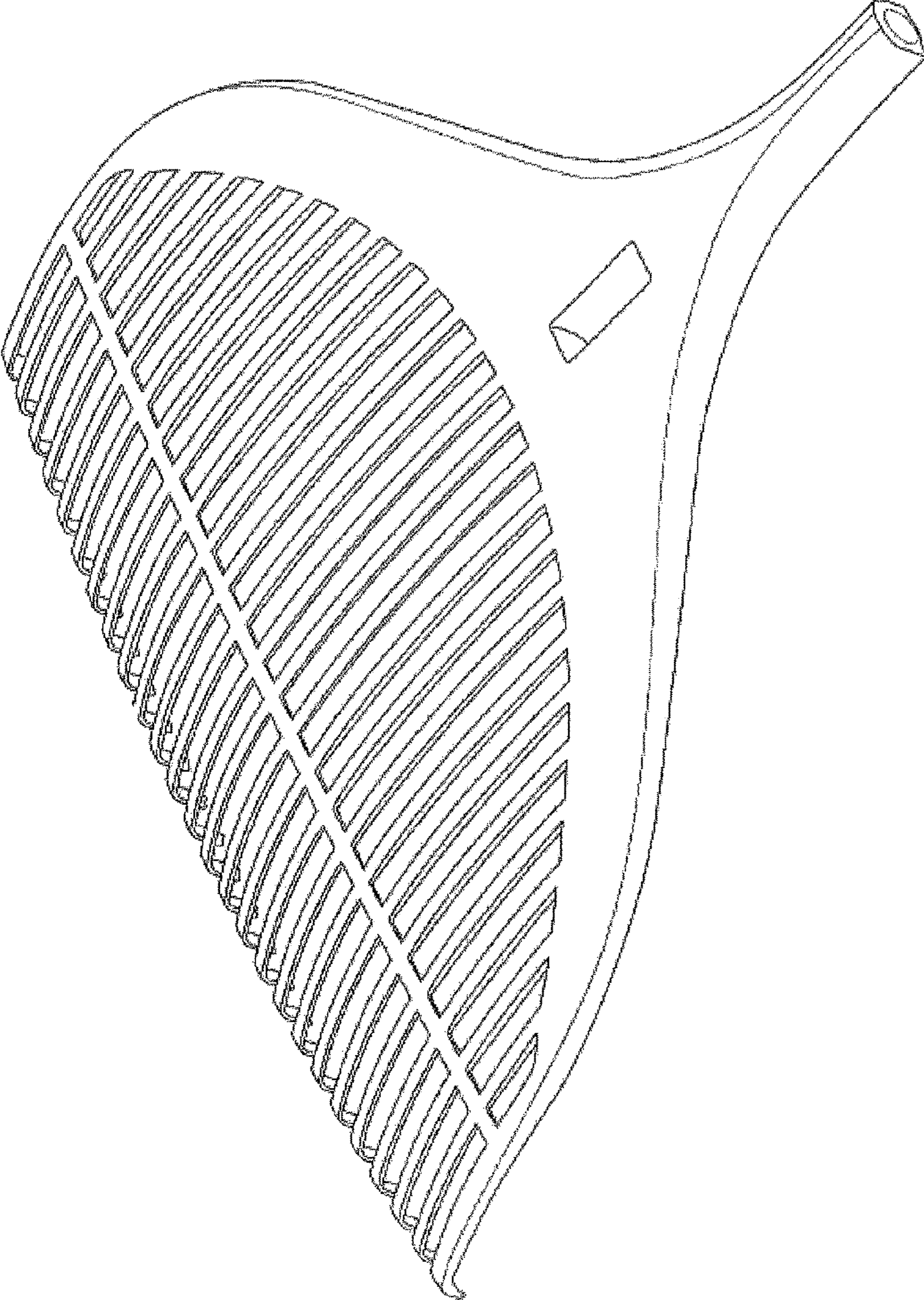

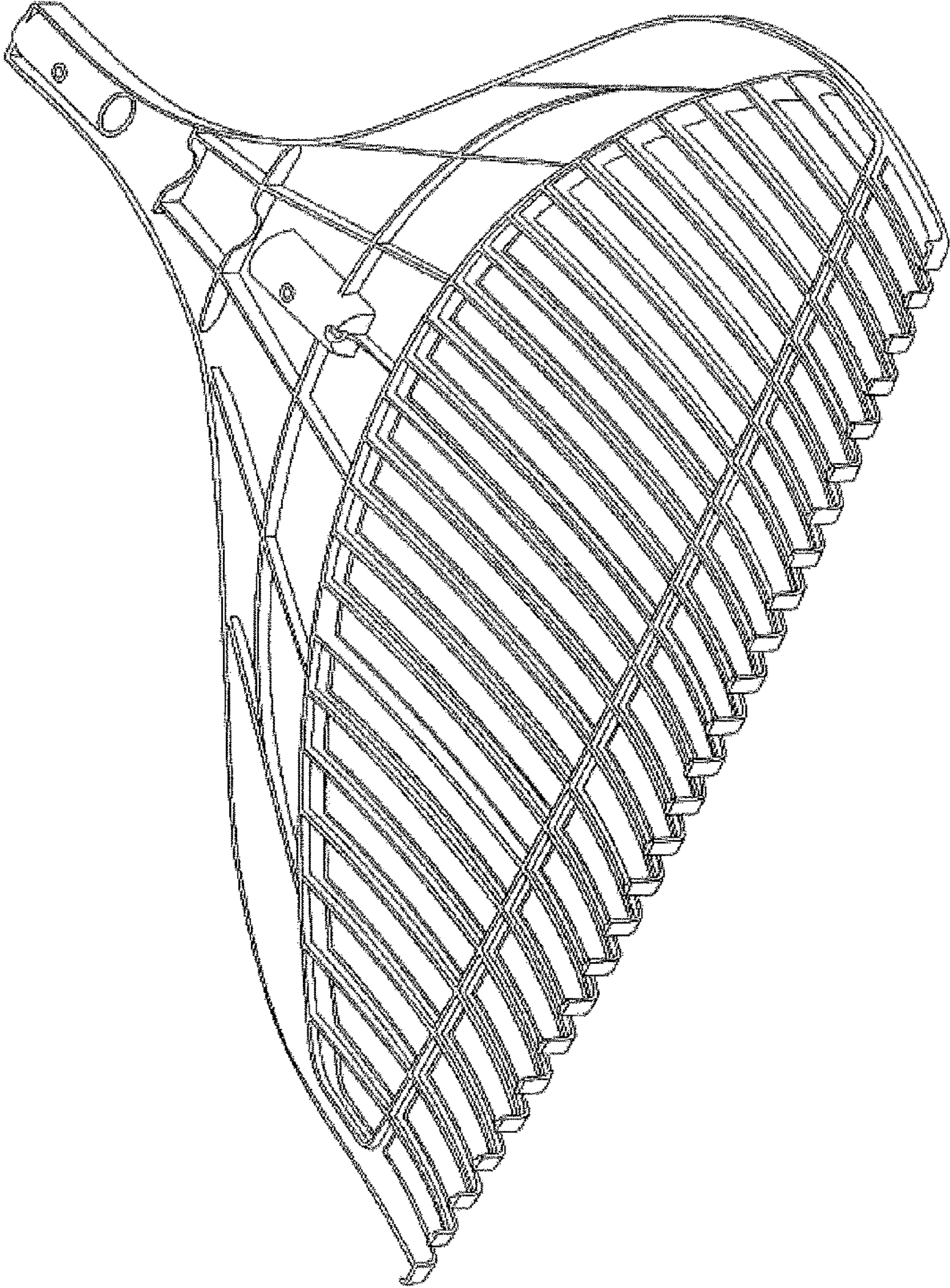

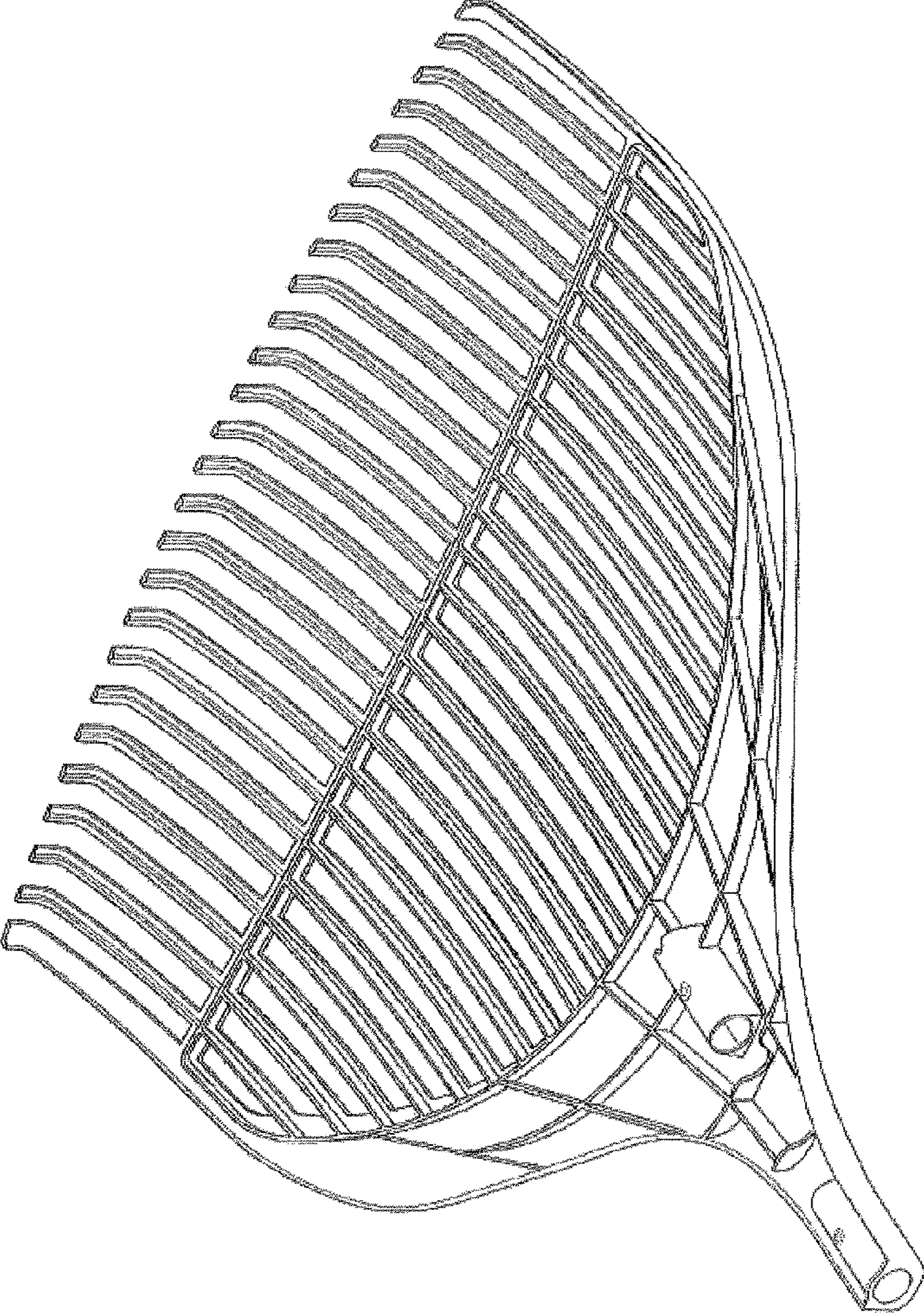

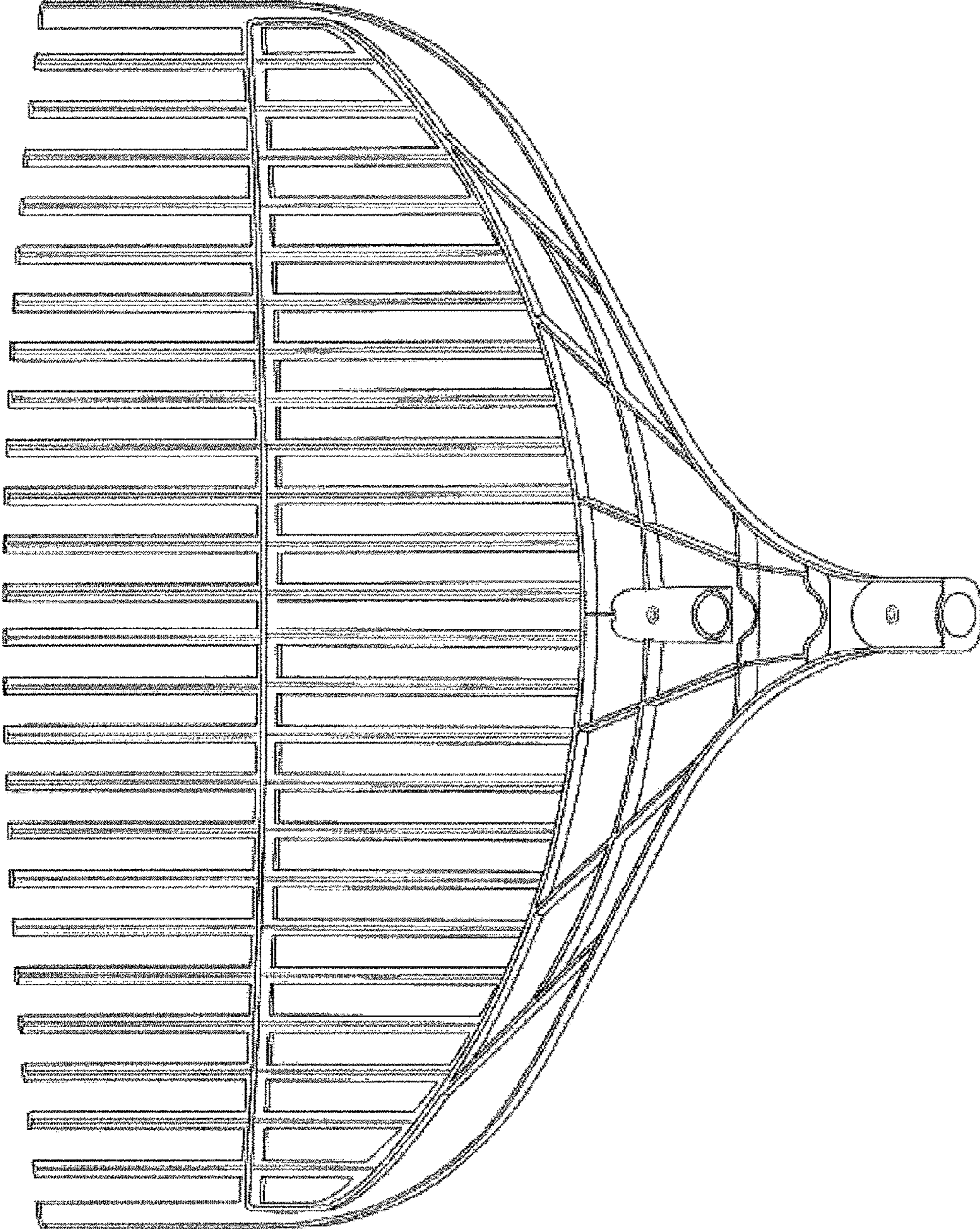

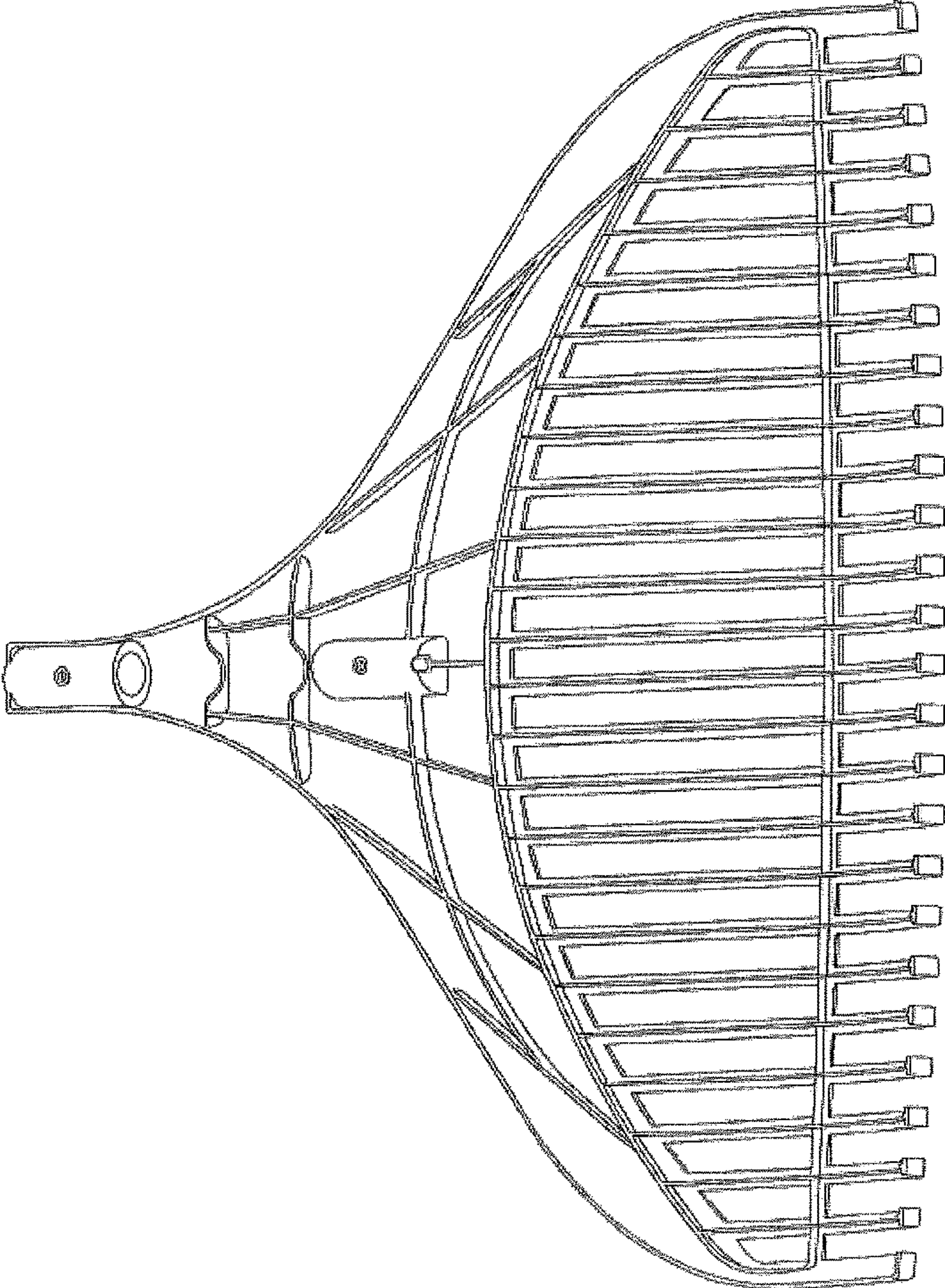
