FIG. 8 is a cross sectional view taken along line 8—8 of FIG. 6.

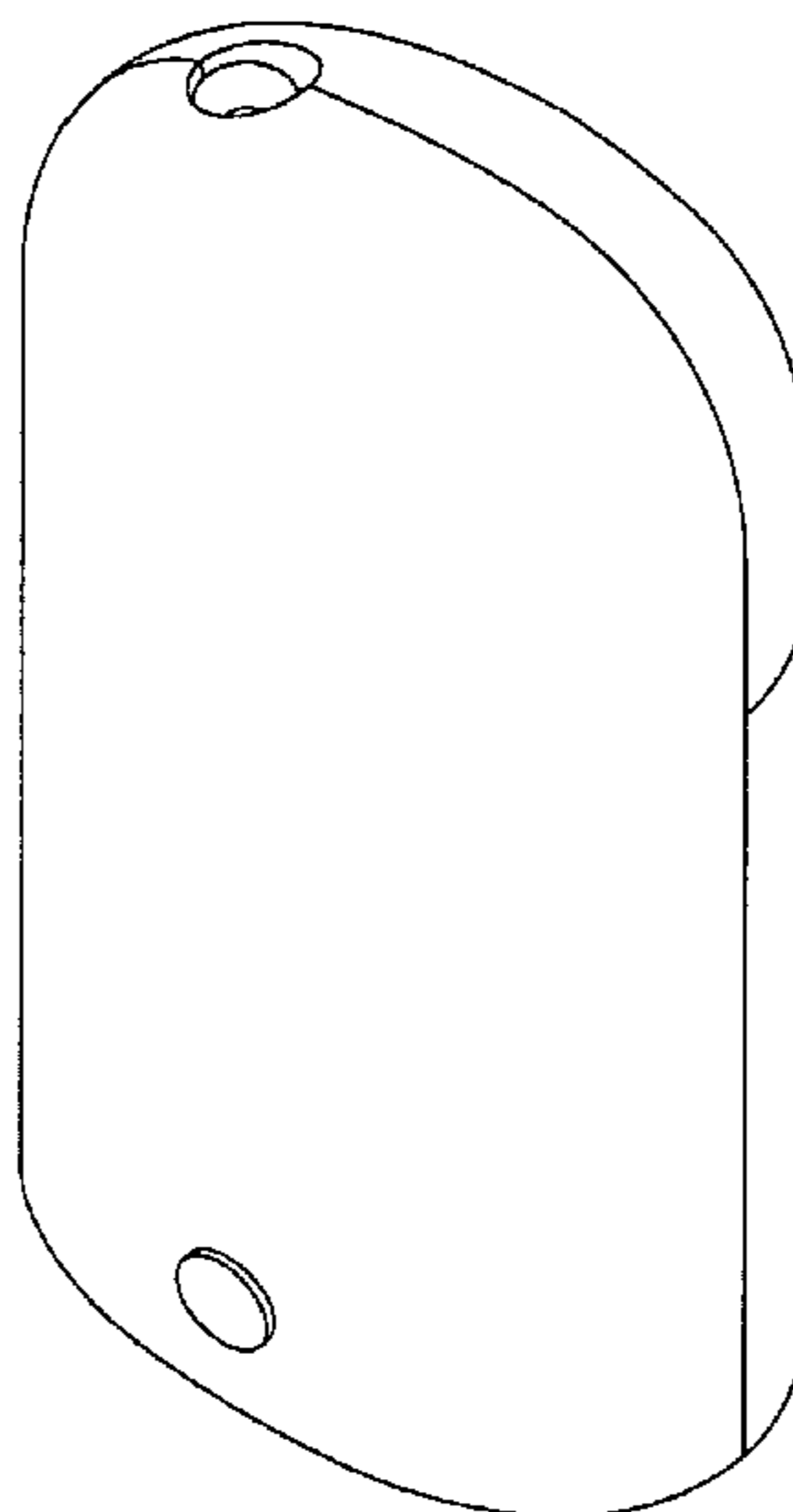
The broken lines are included for the purpose of illustrating interior portions of the spray dispenser that form no part of the claimed design.

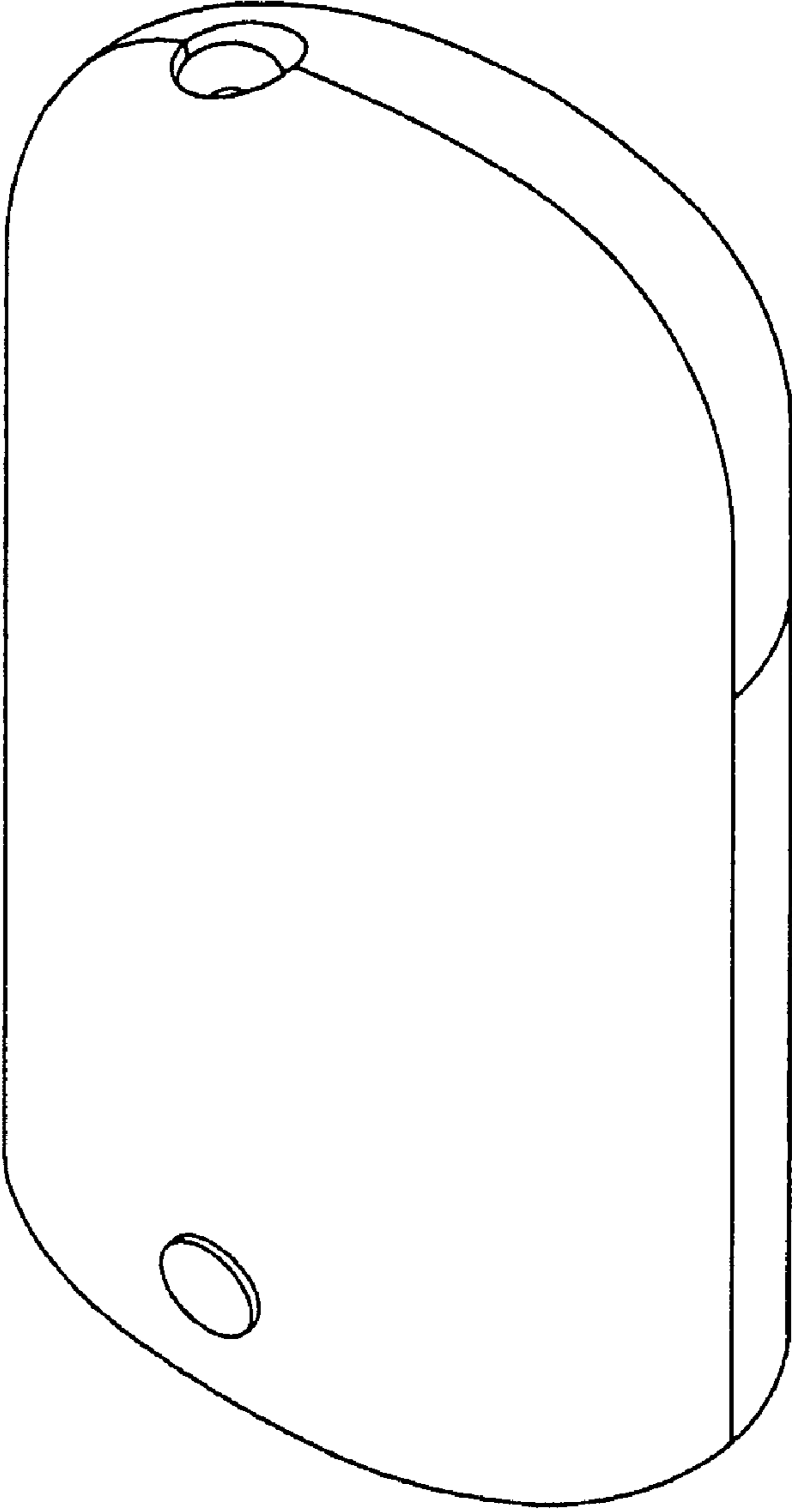

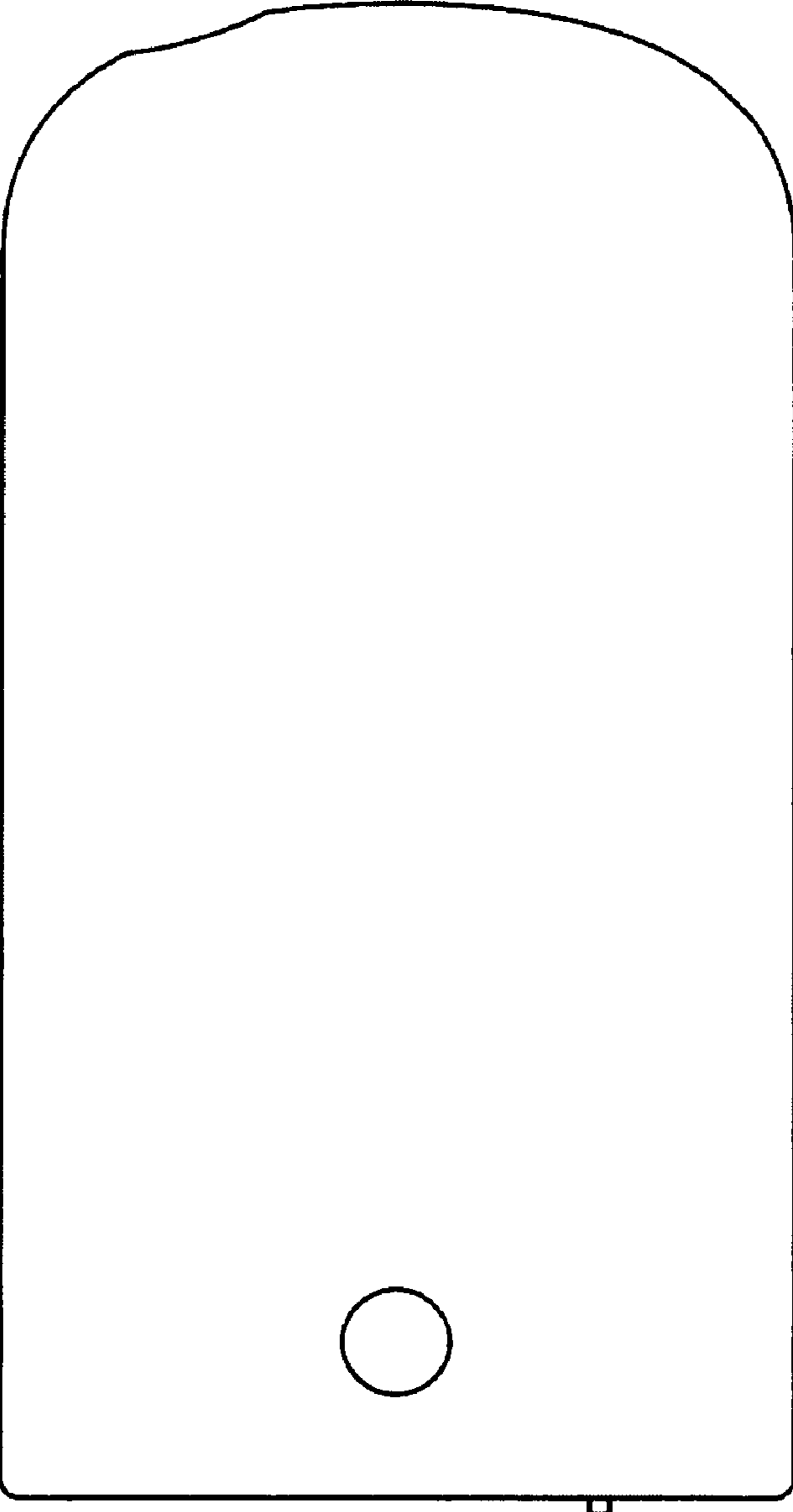

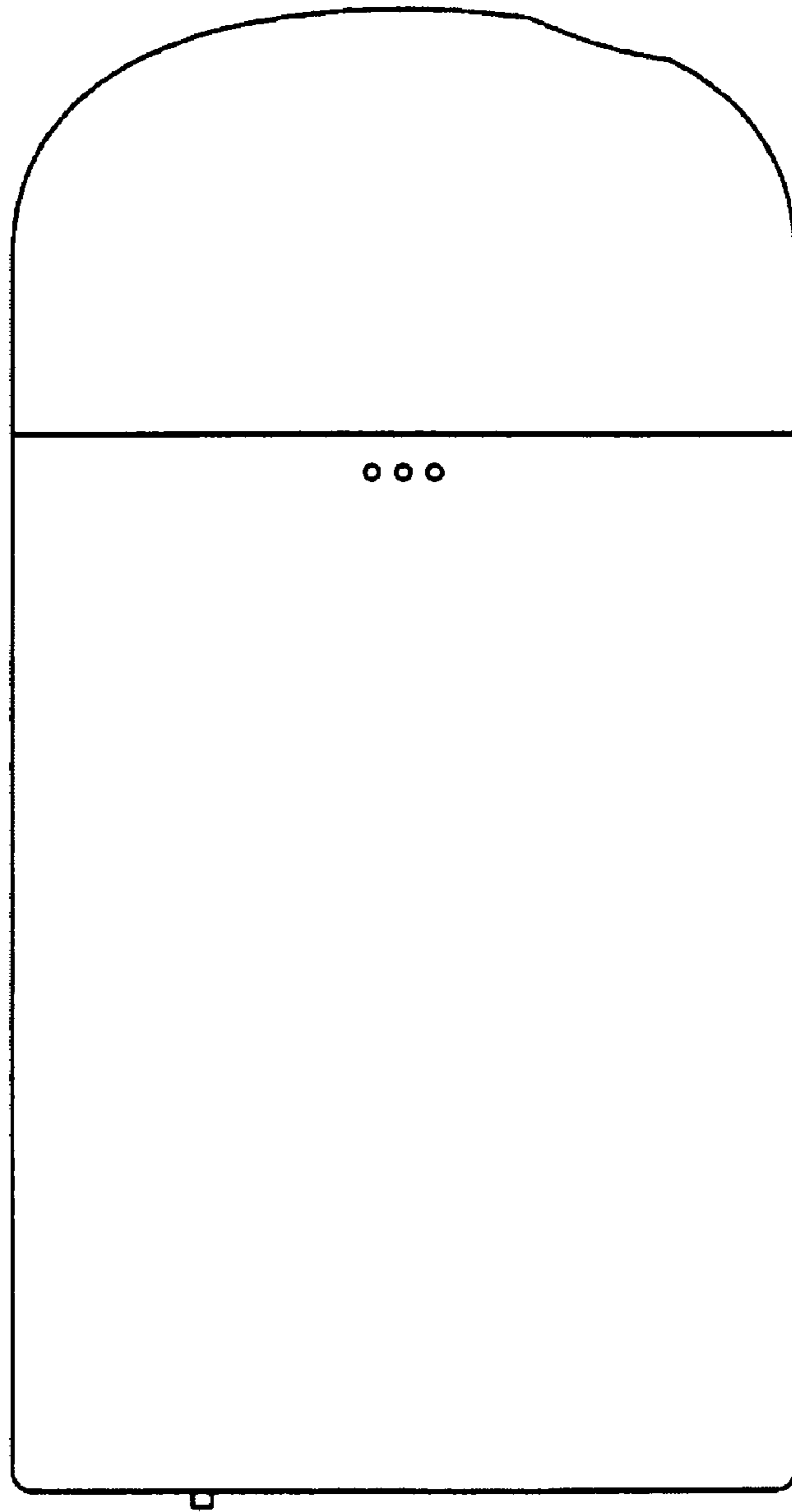

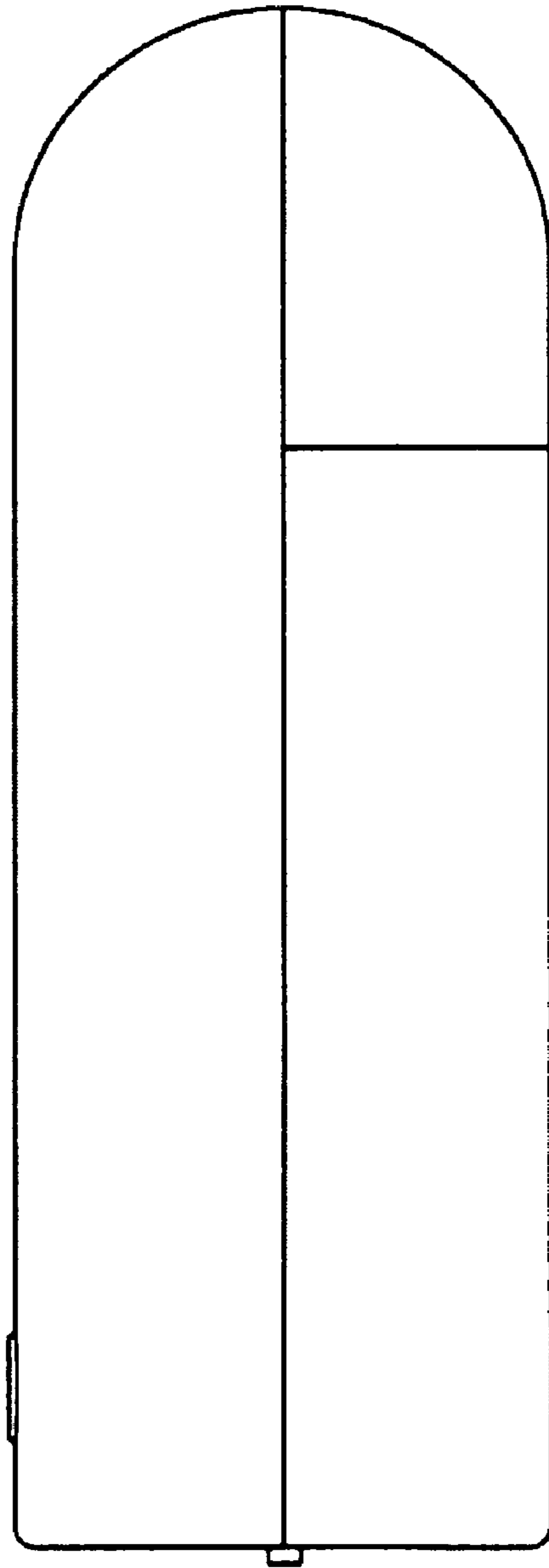

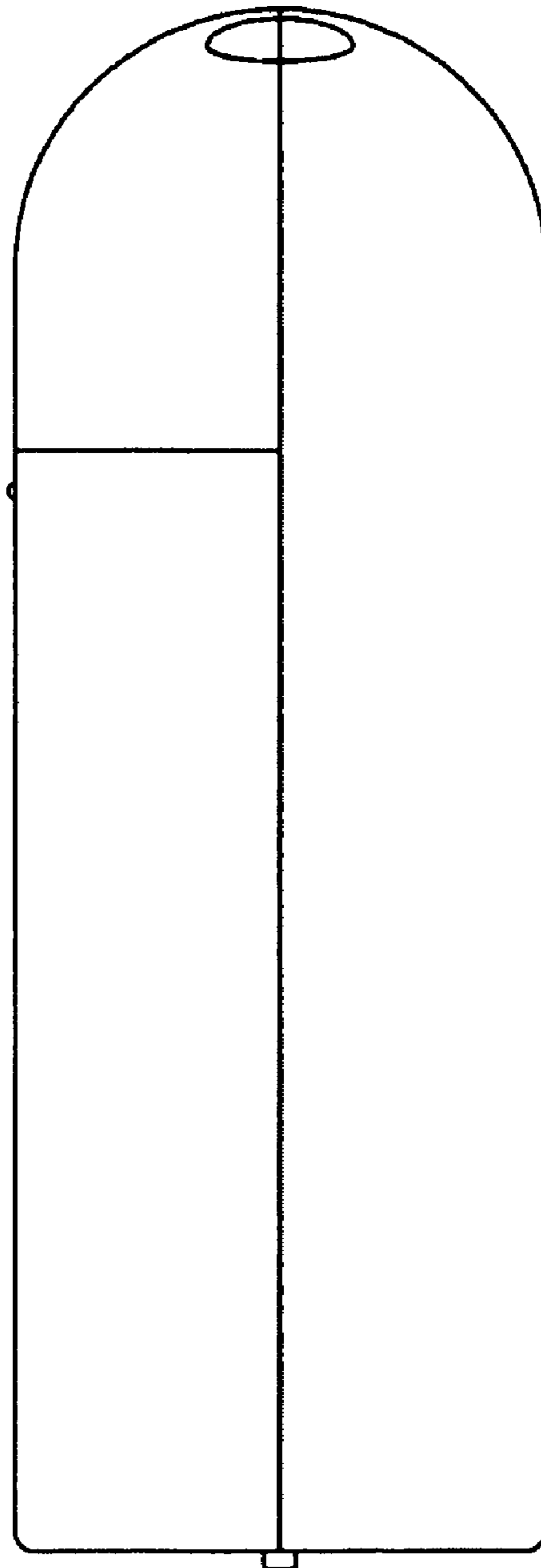

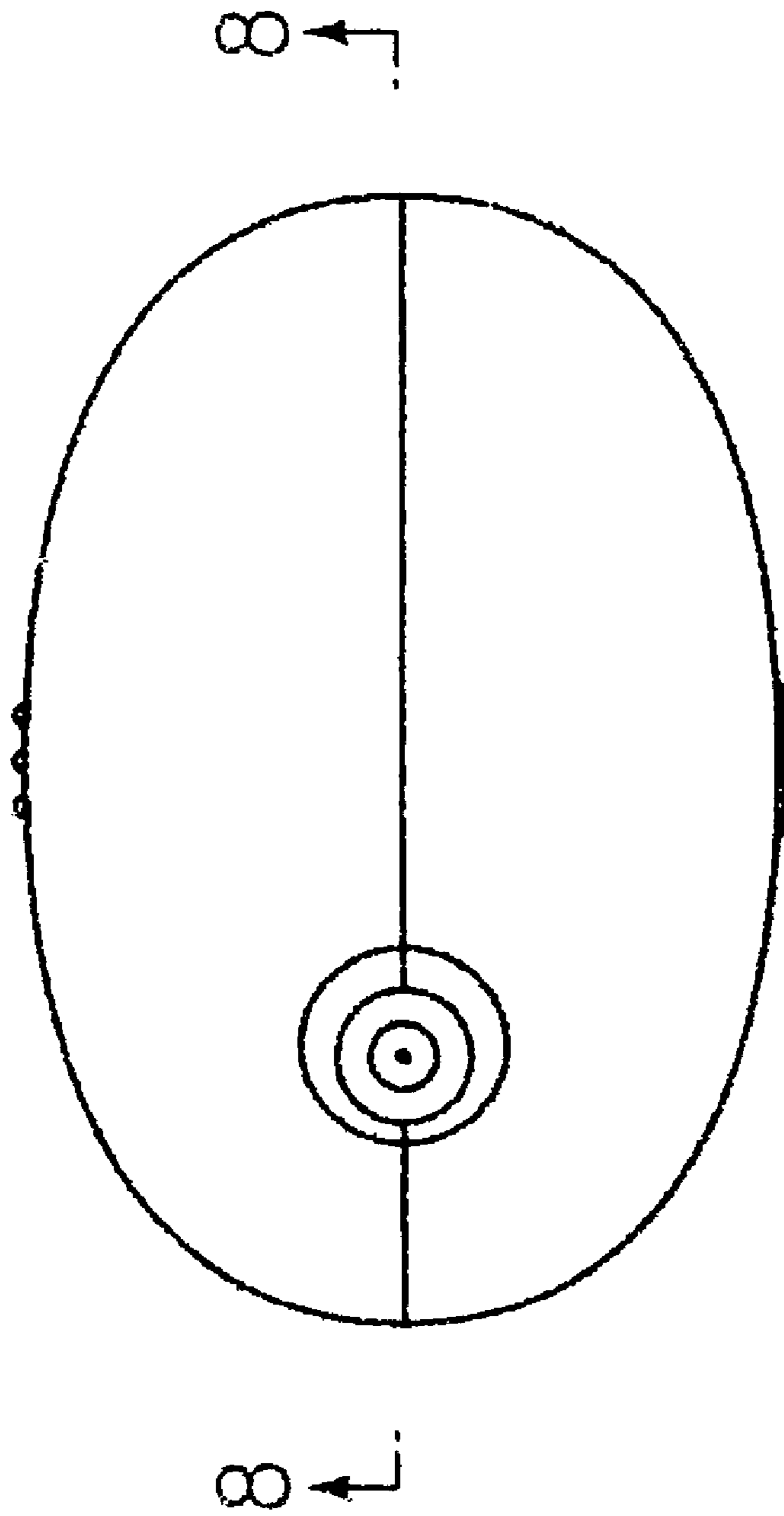

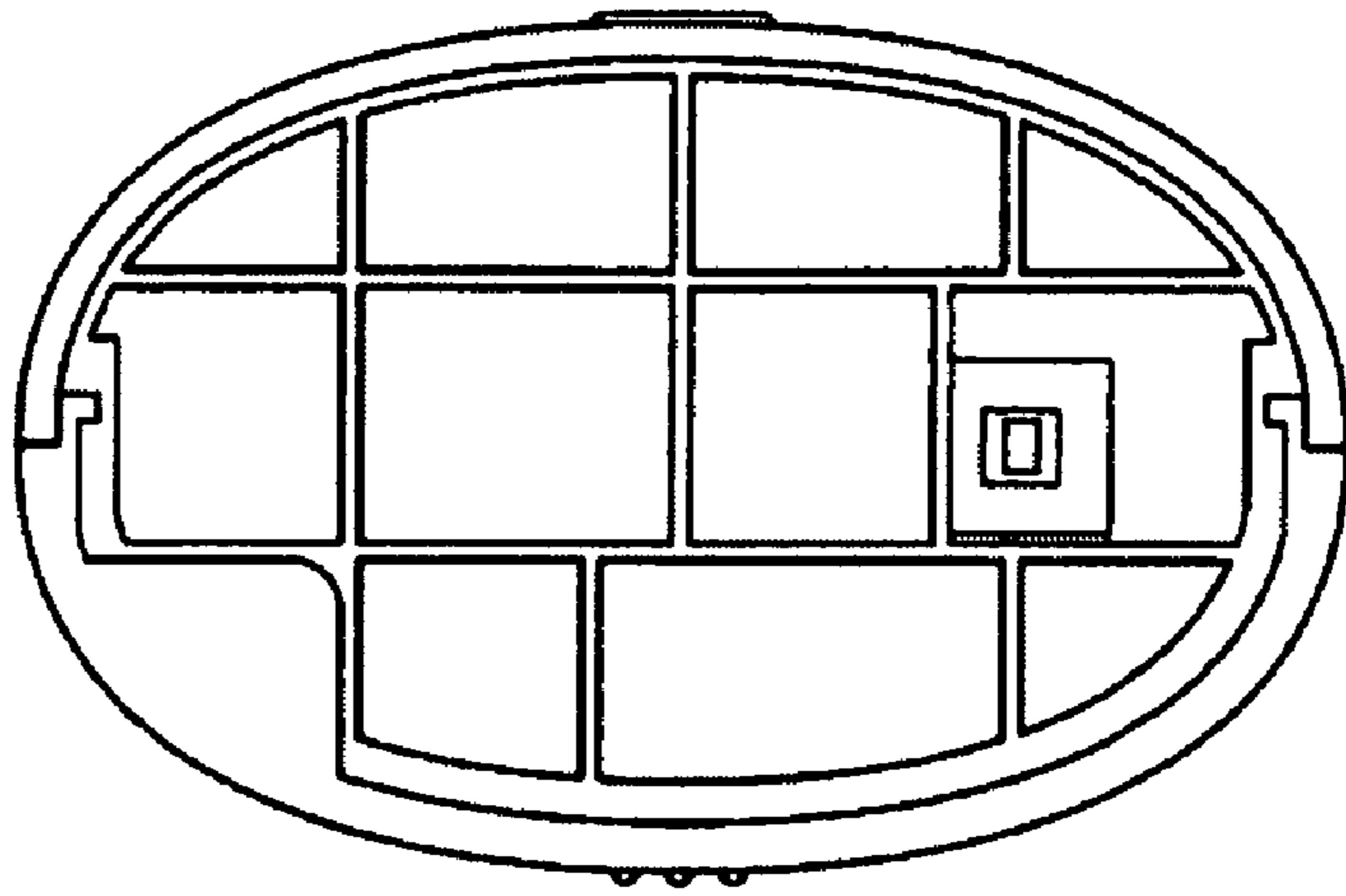

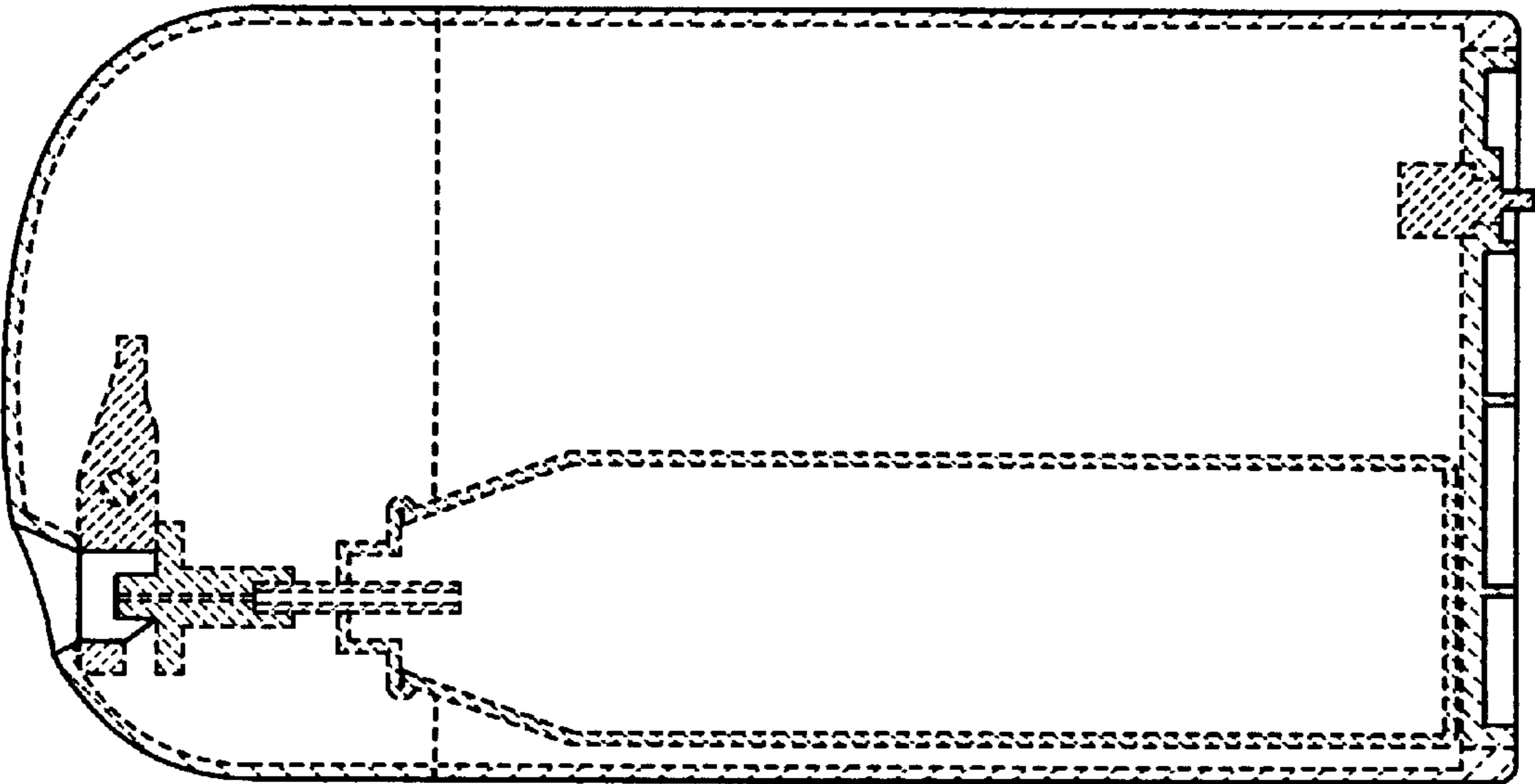
