The ornamental design for a side mirror for a vehicle, as shown and described.

DESCRIPTION

FIG. 13 is a rear view thereof;

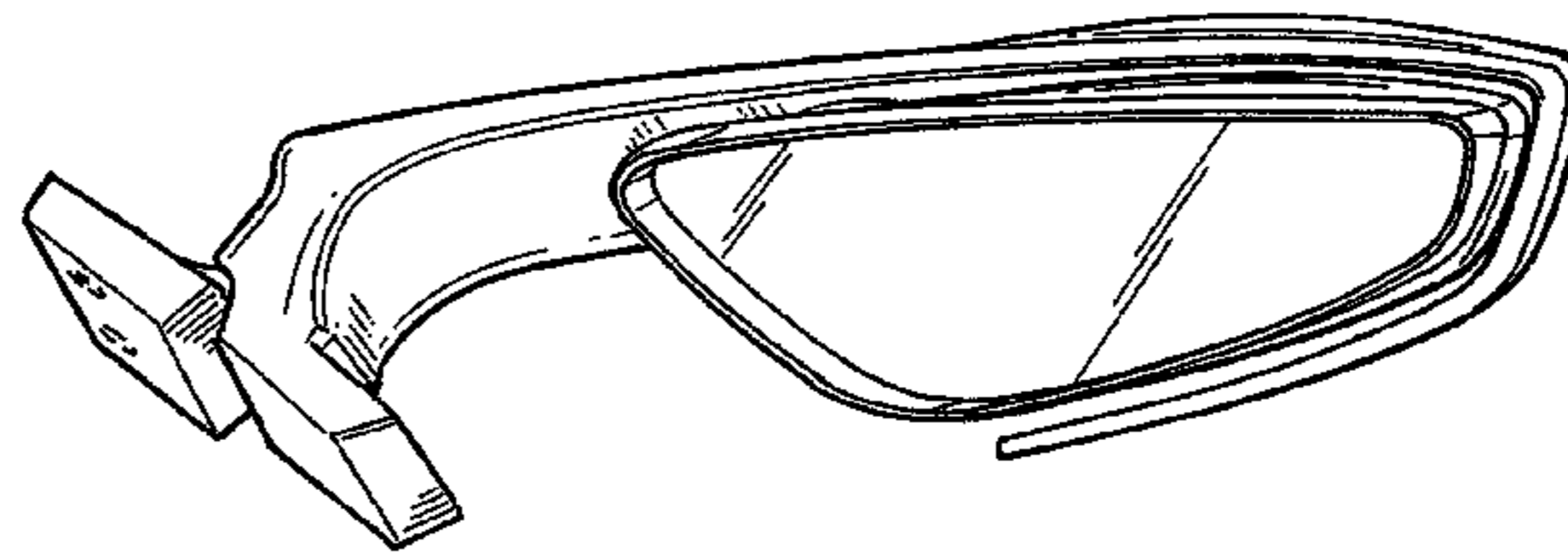
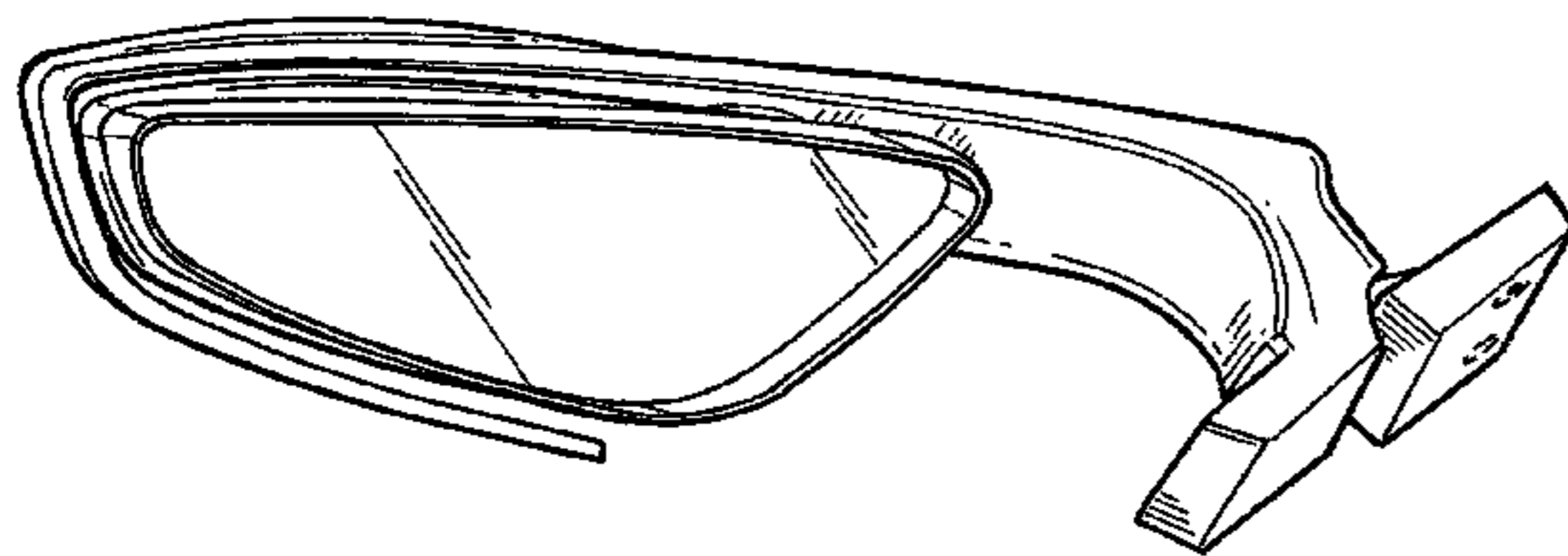
FIG. 14 is a front view thereof;

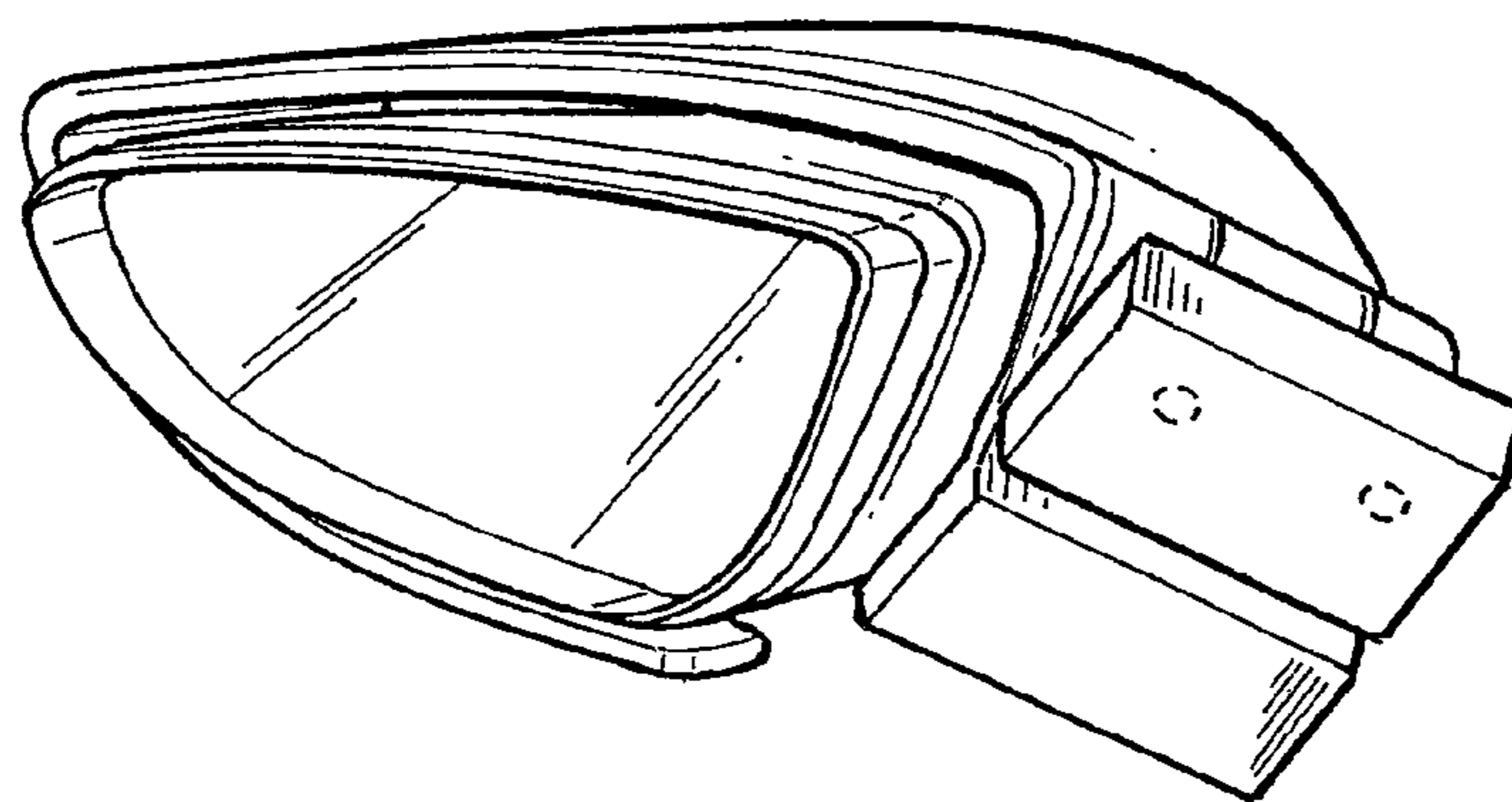

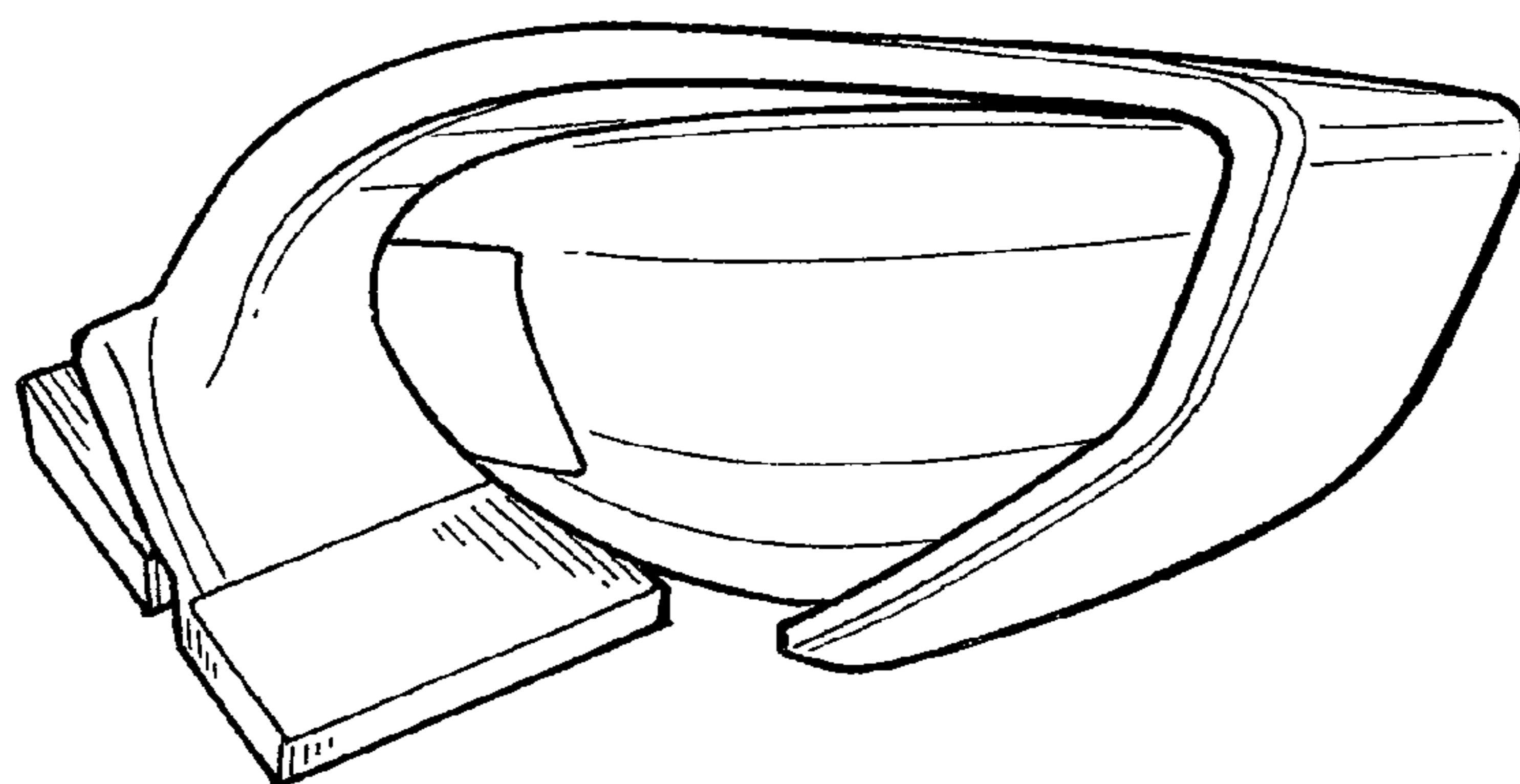

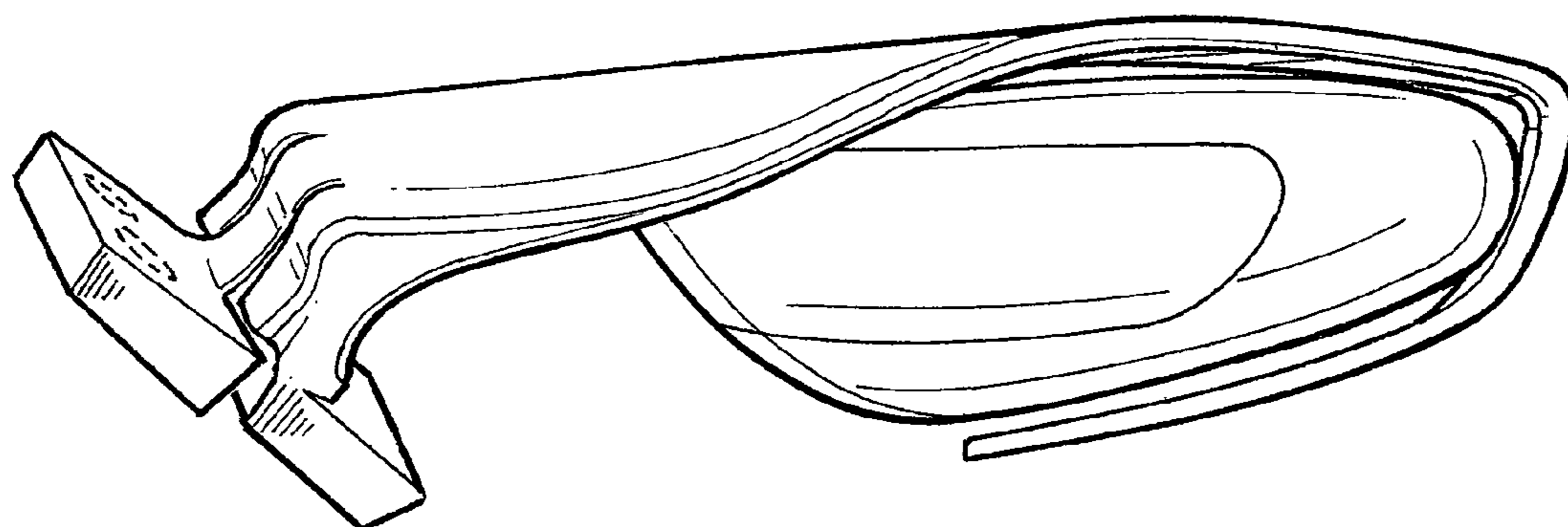

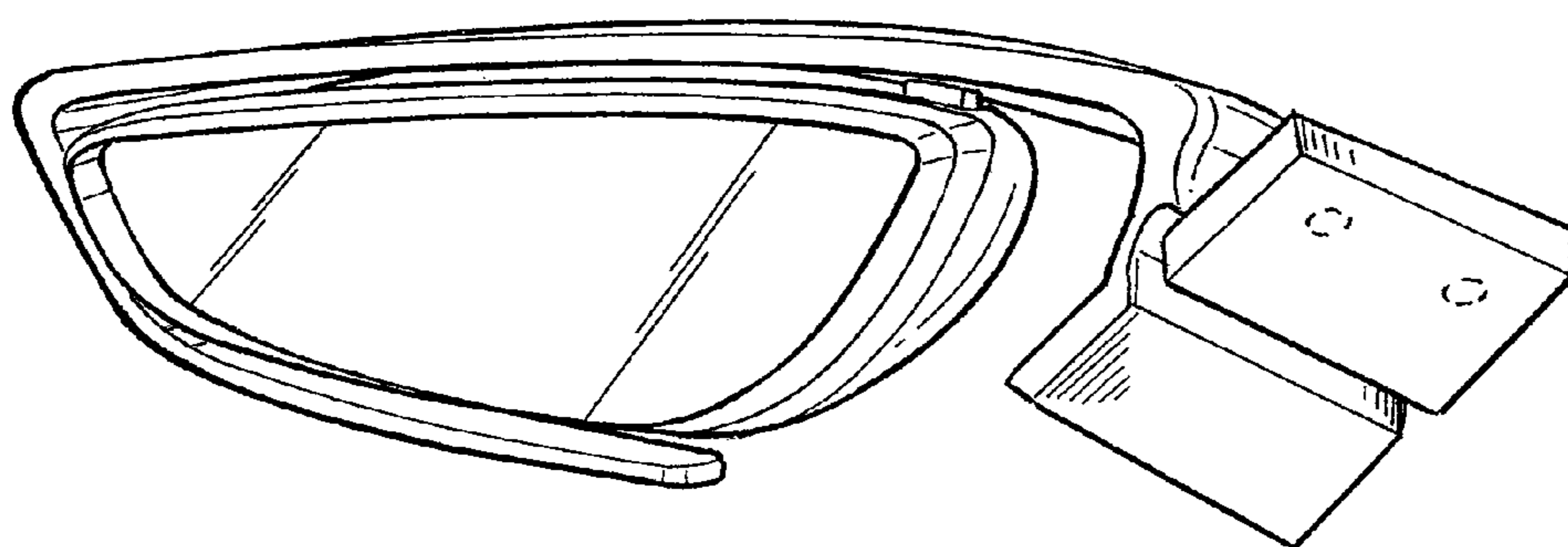

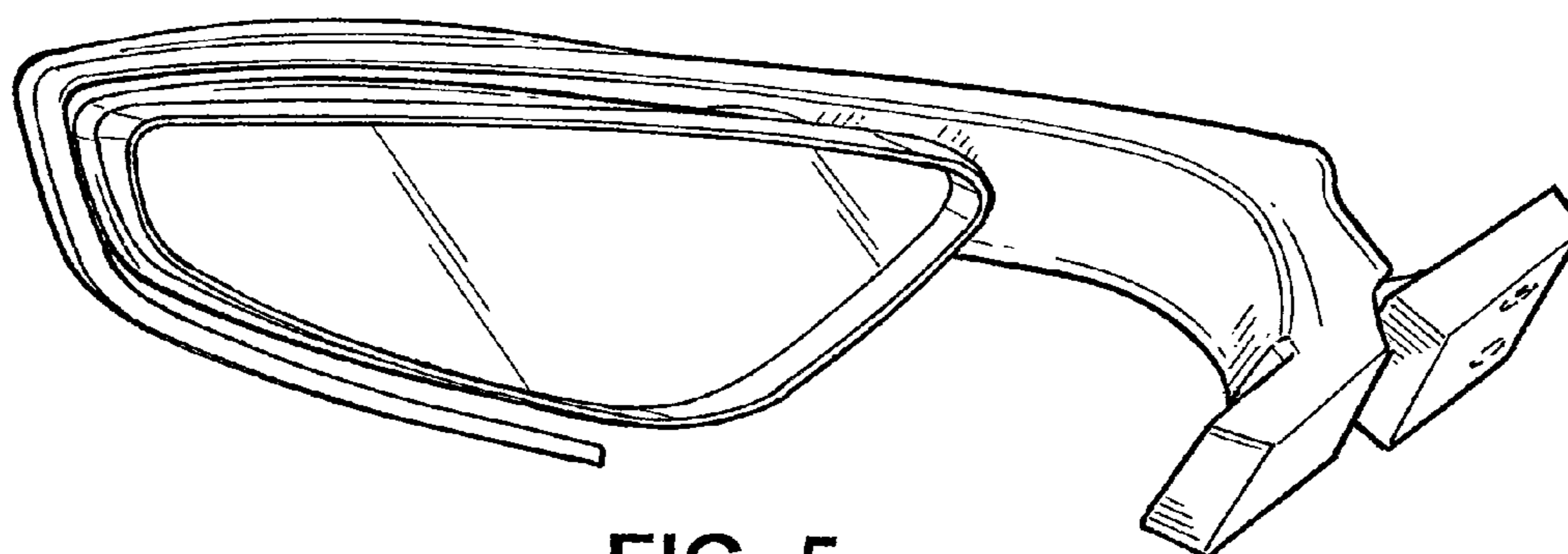

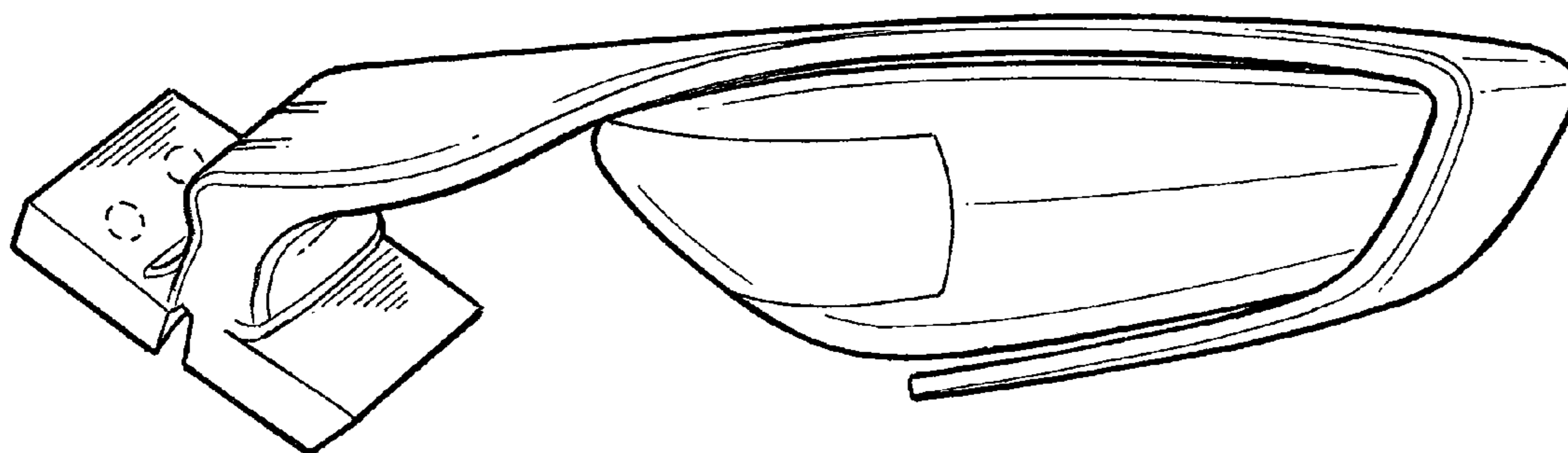

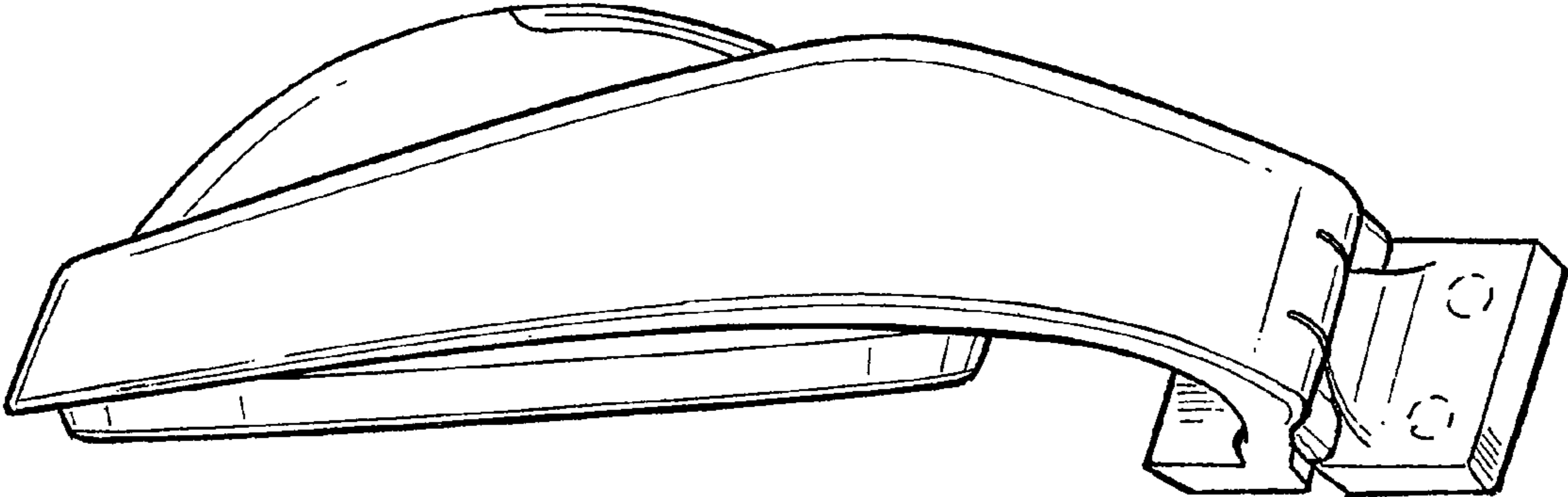

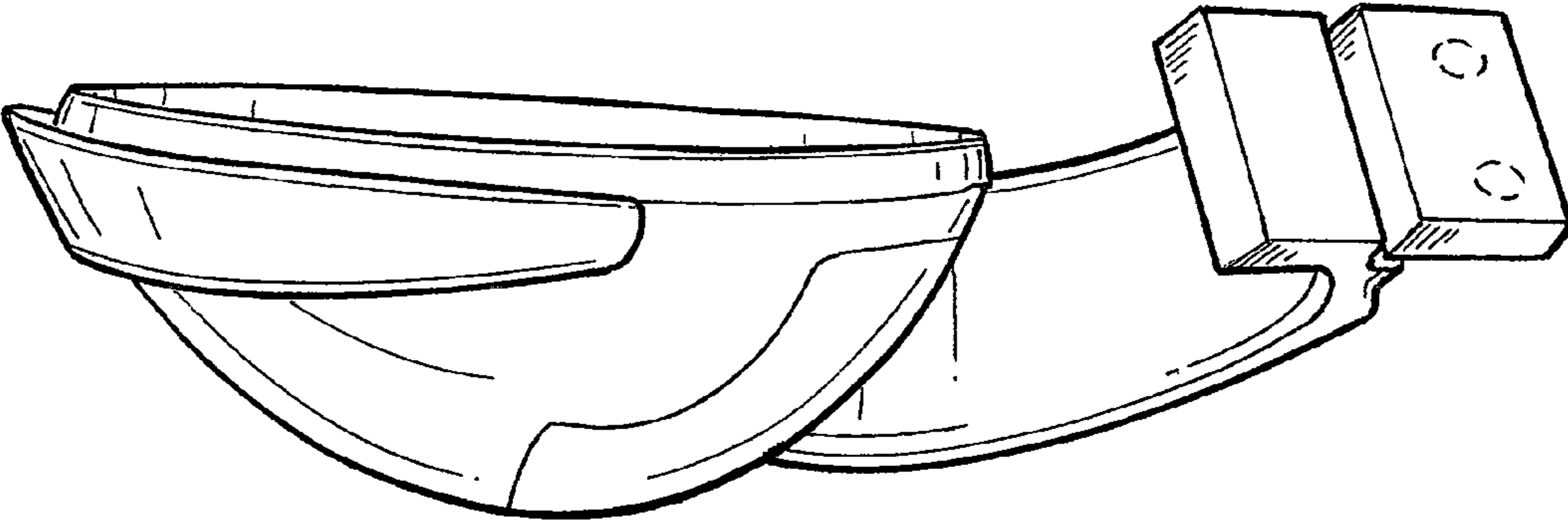

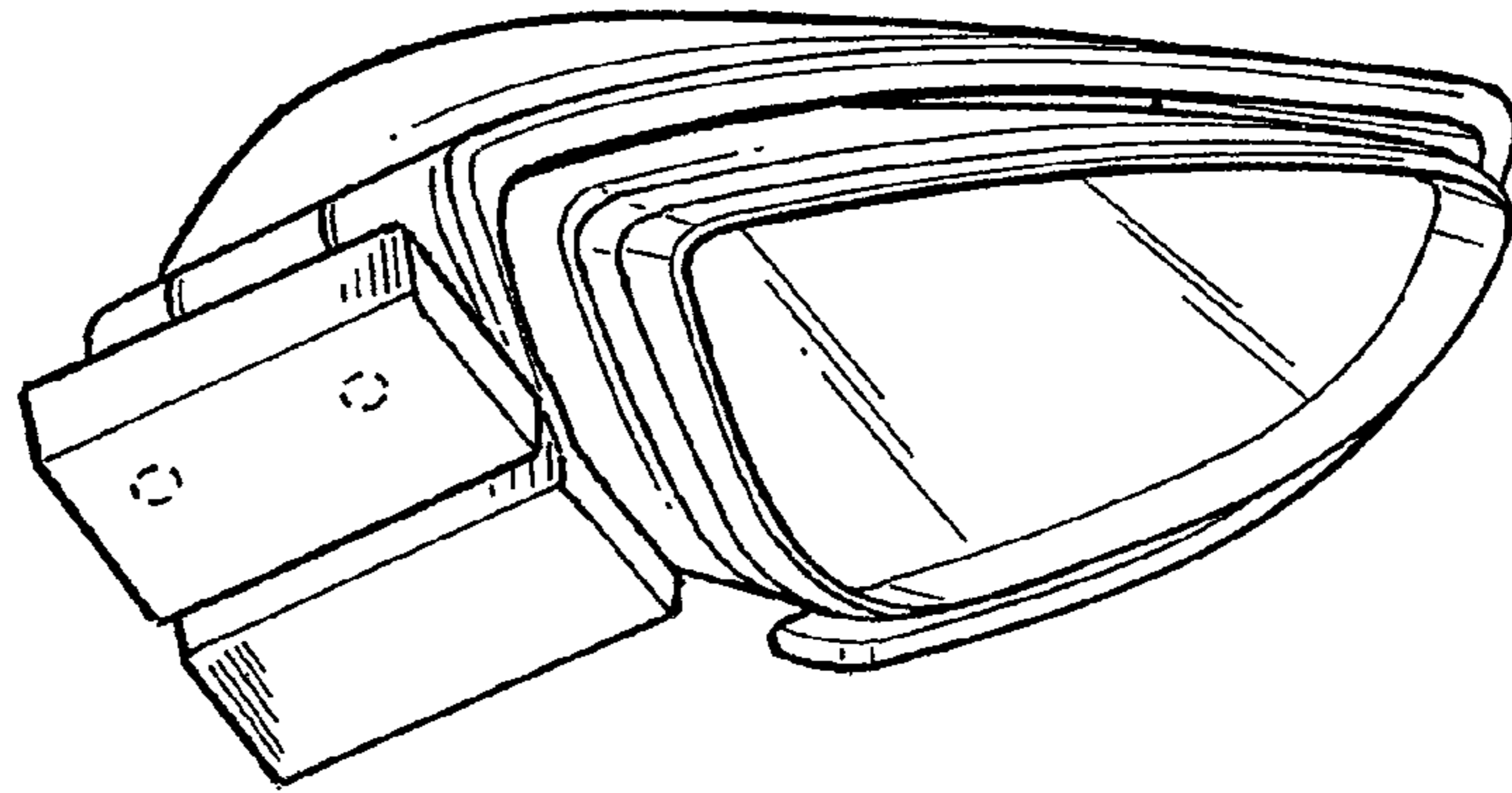

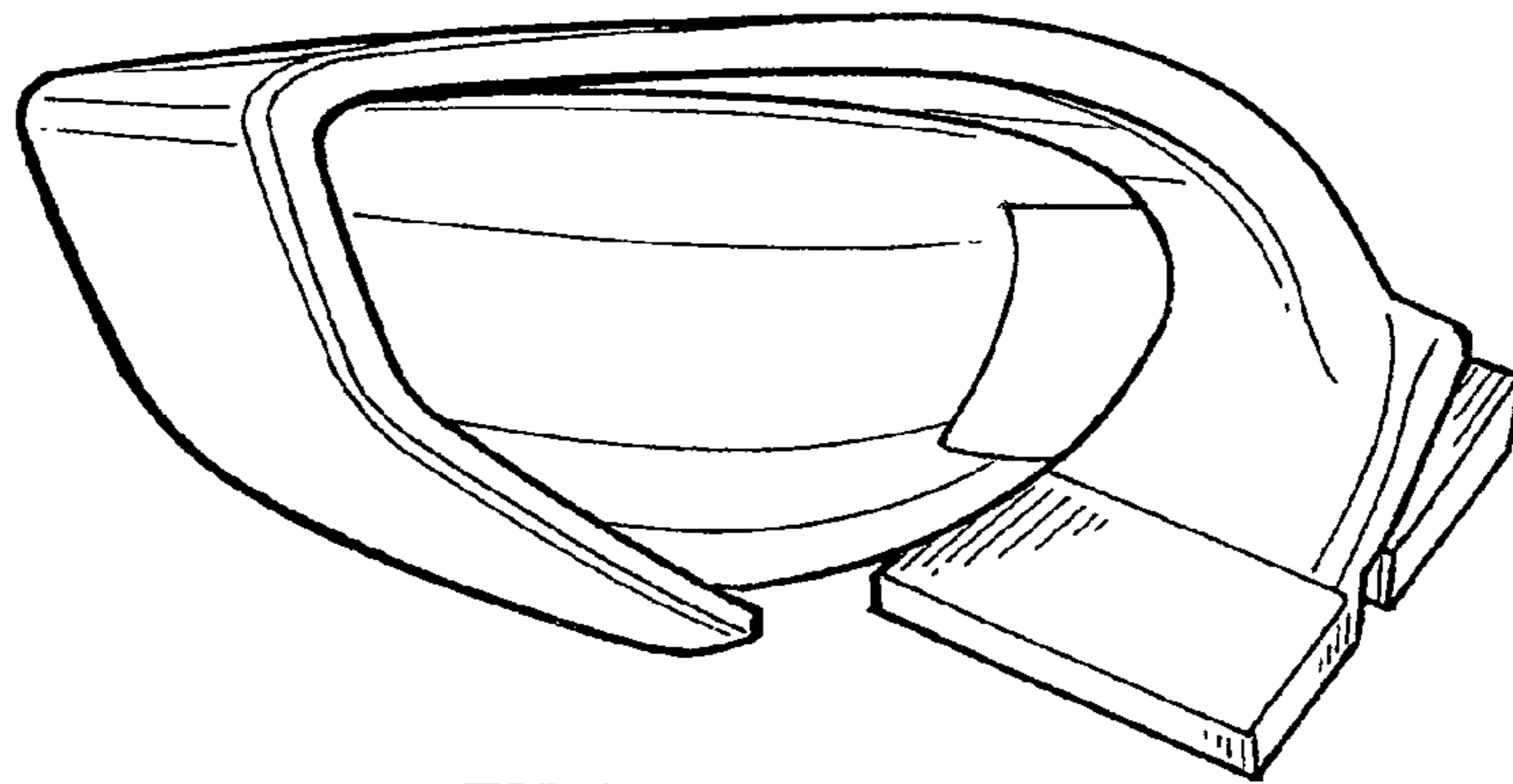

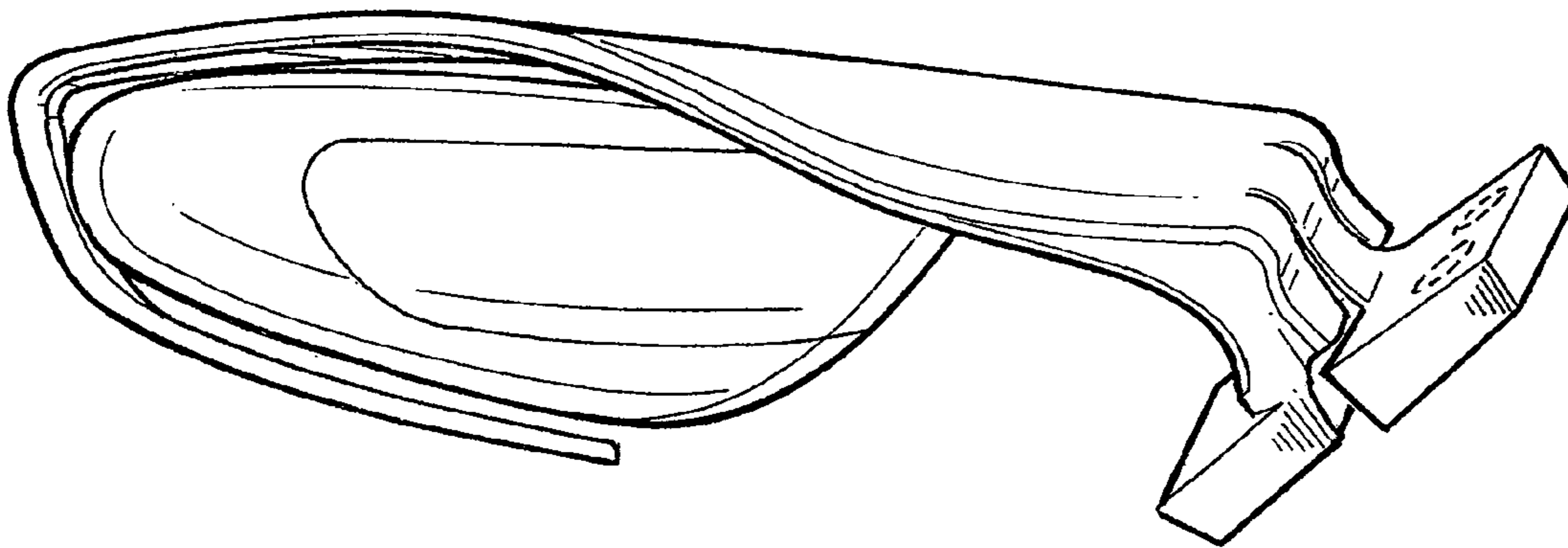

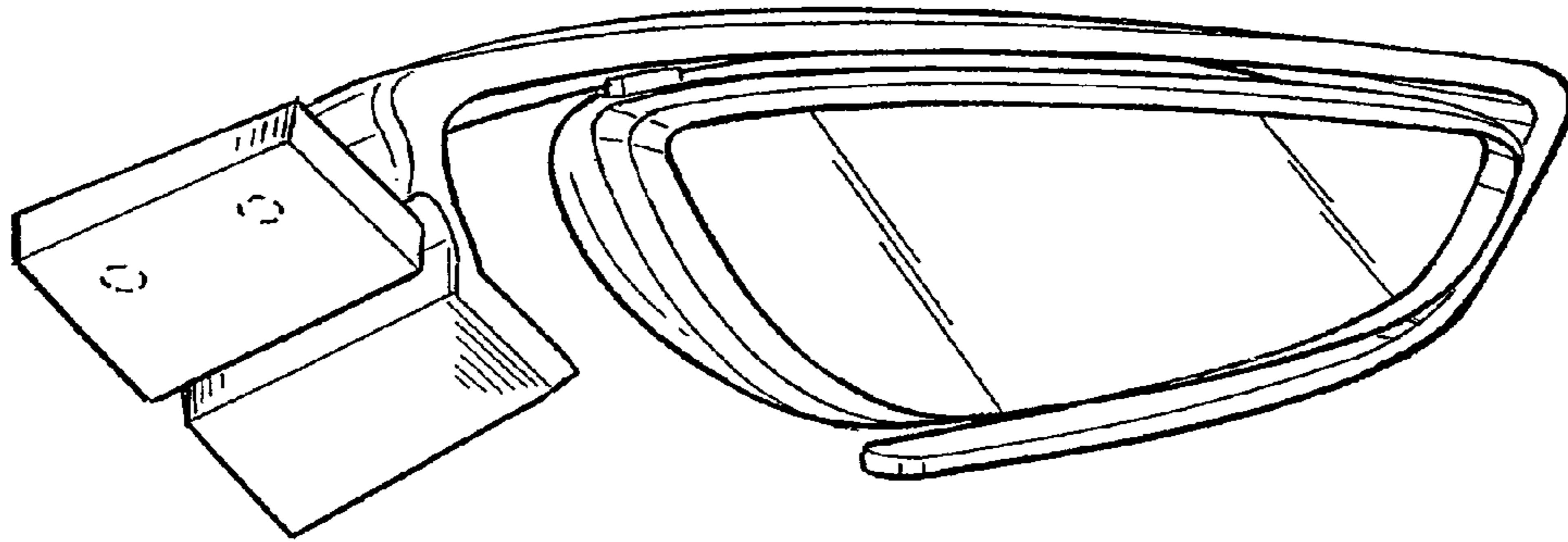

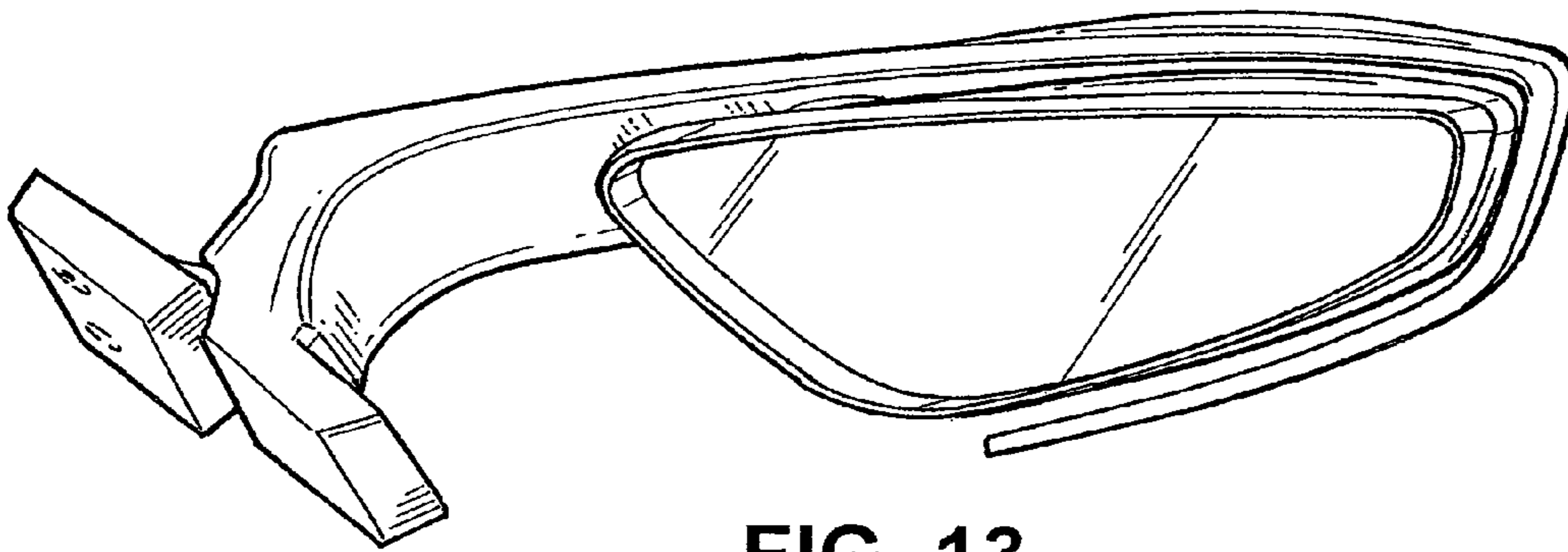

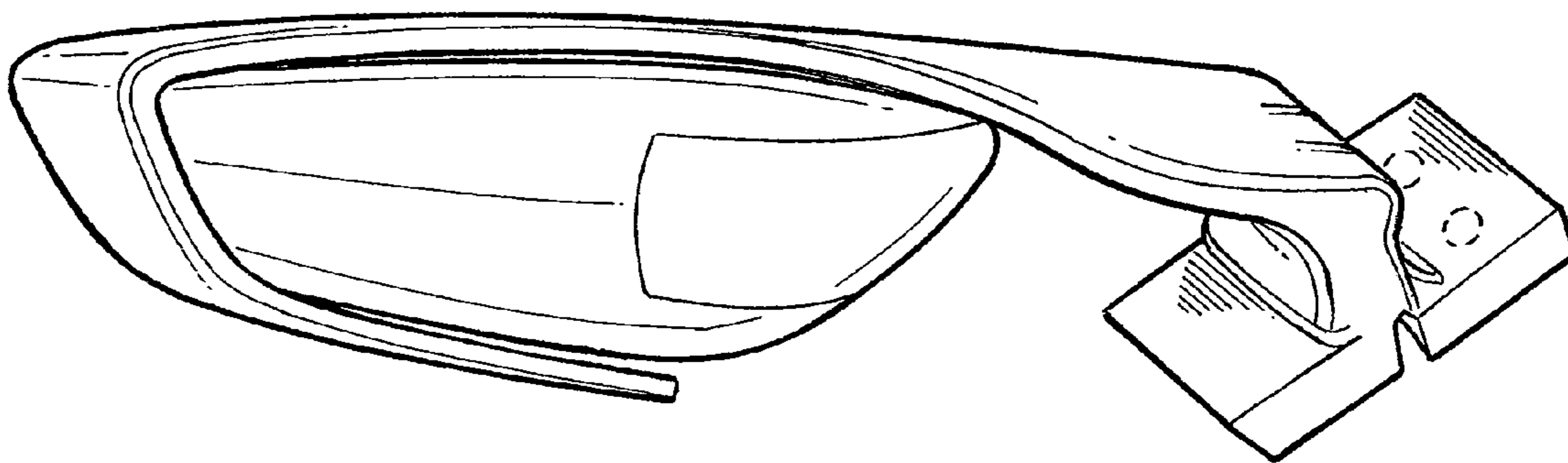

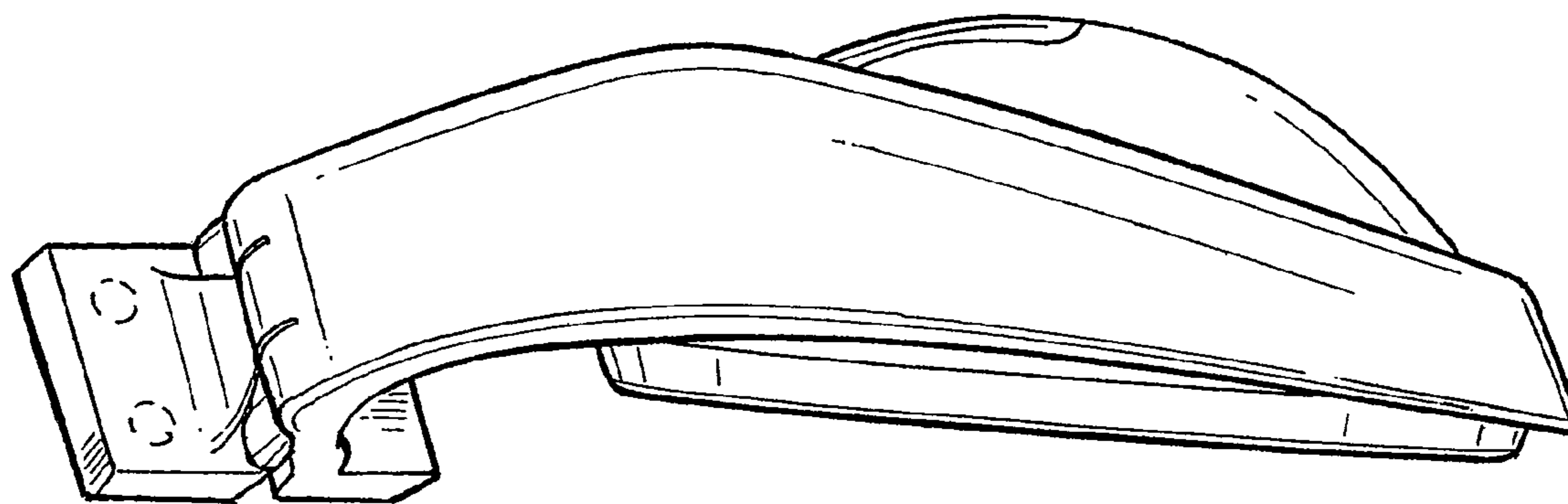

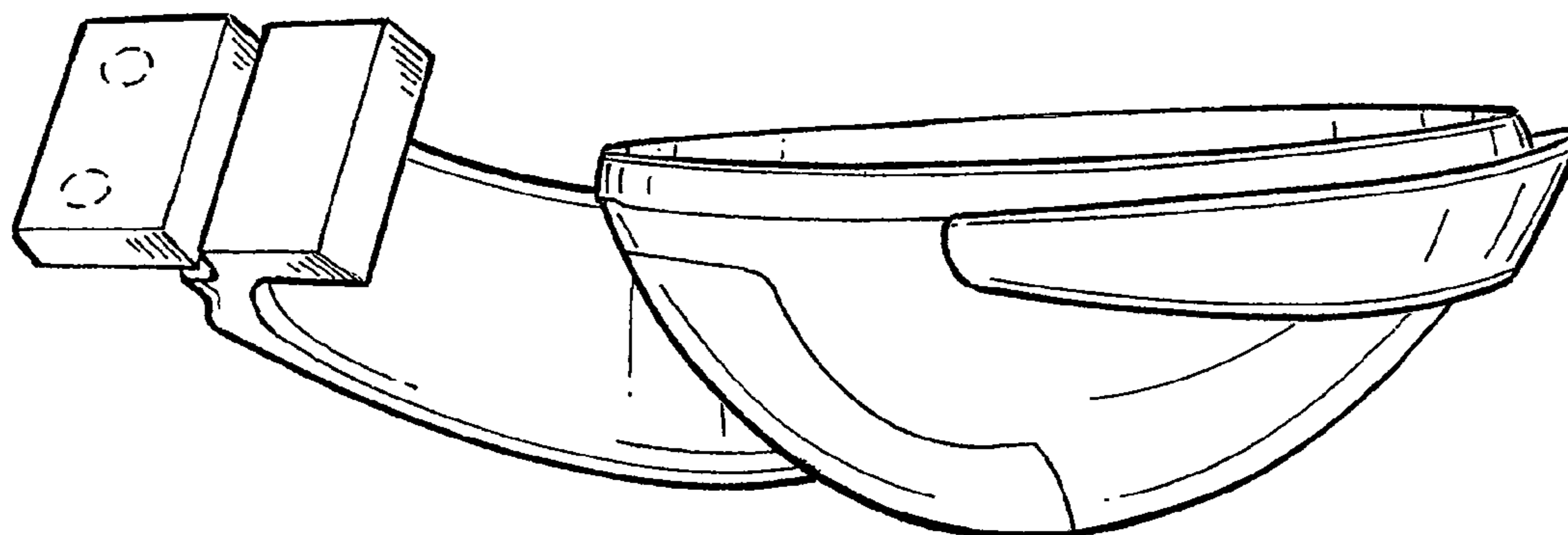
