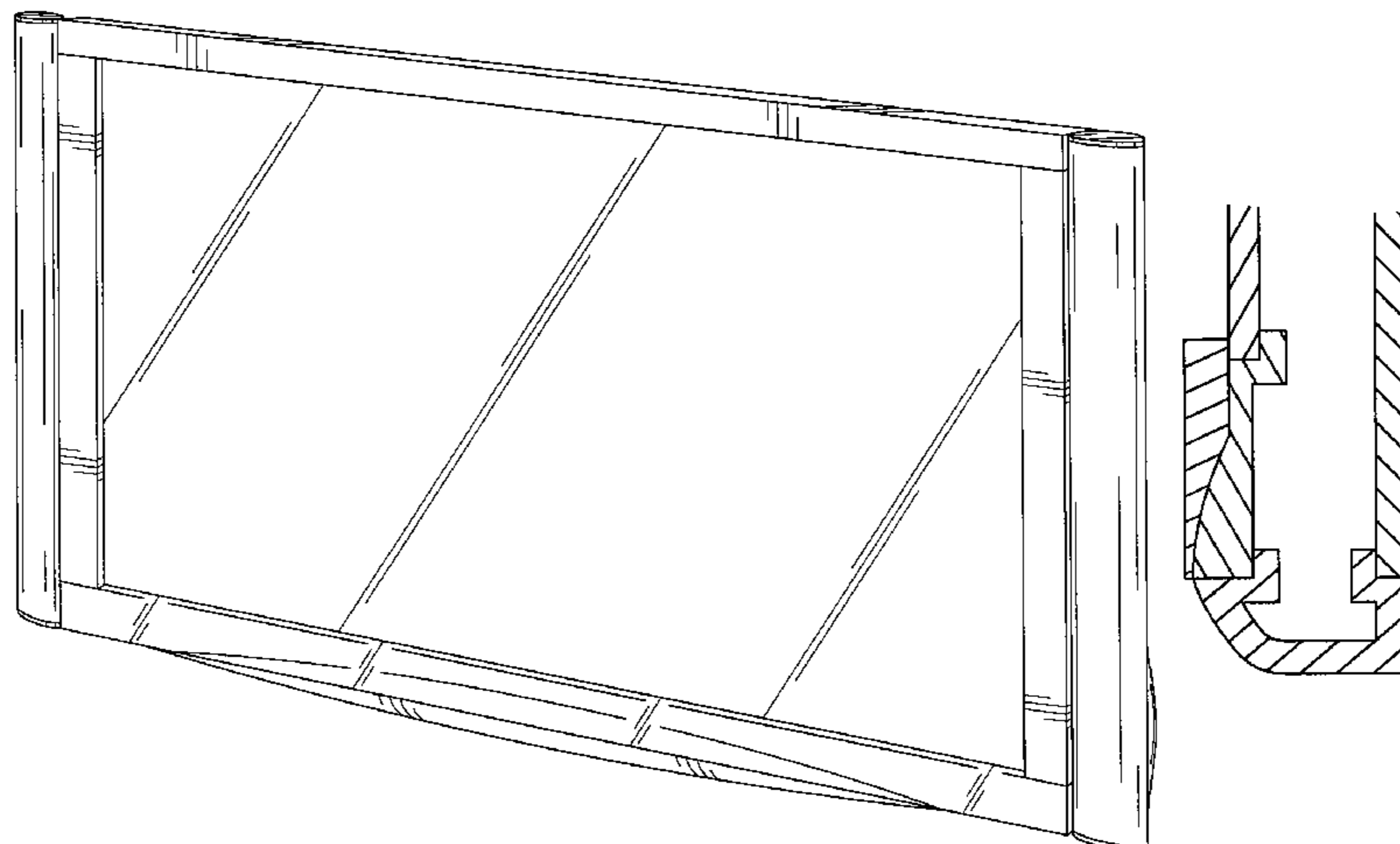
(57) **CLAIM**

I claim the ornamental design for a television receiver, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a television receiver of the present invention;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a right side view thereof, the left side view being a mirror image thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof; and,
FIG. 7 is an enlarged cross-section view taken along the line 7—7 of FIG. 2.

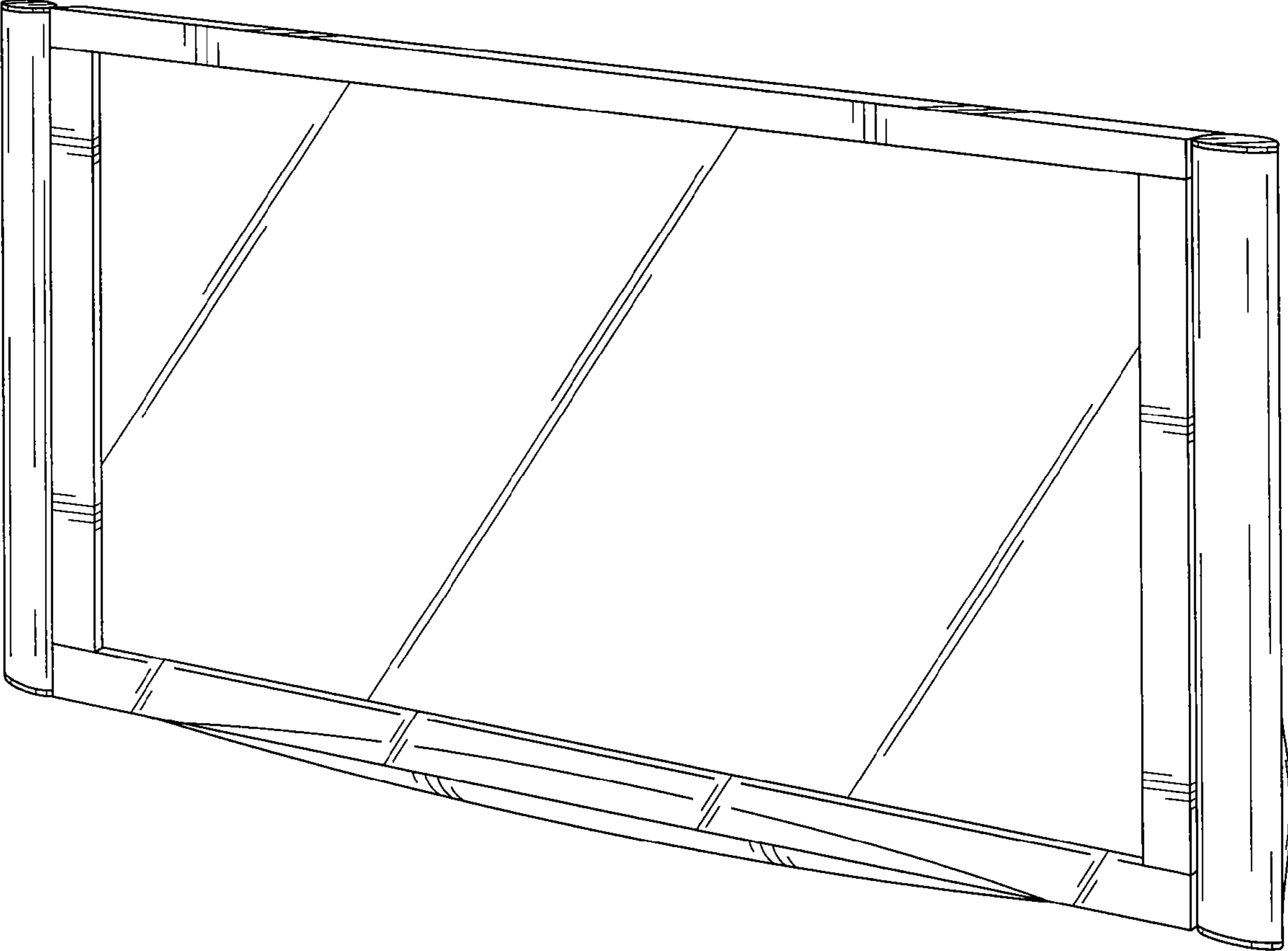

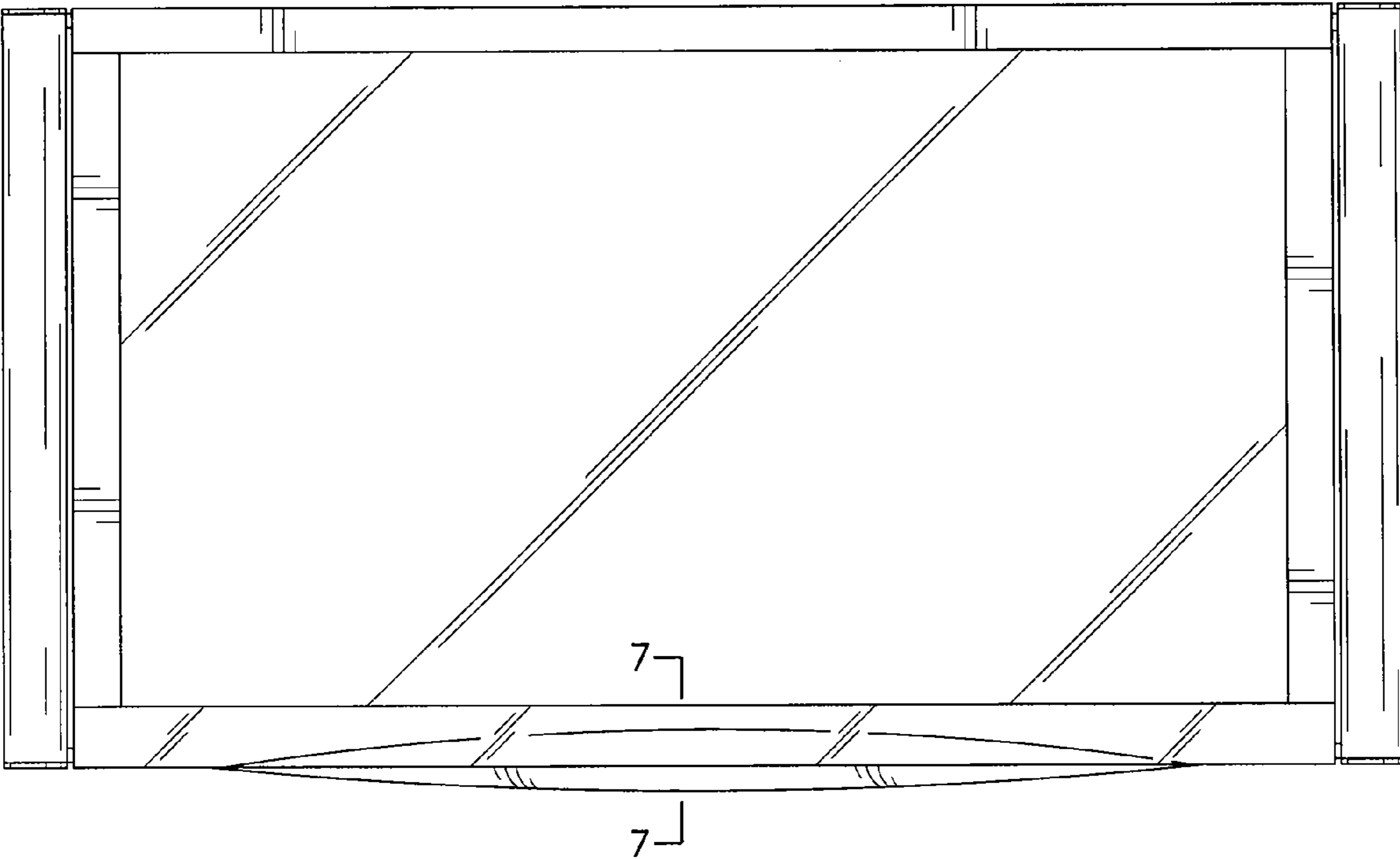

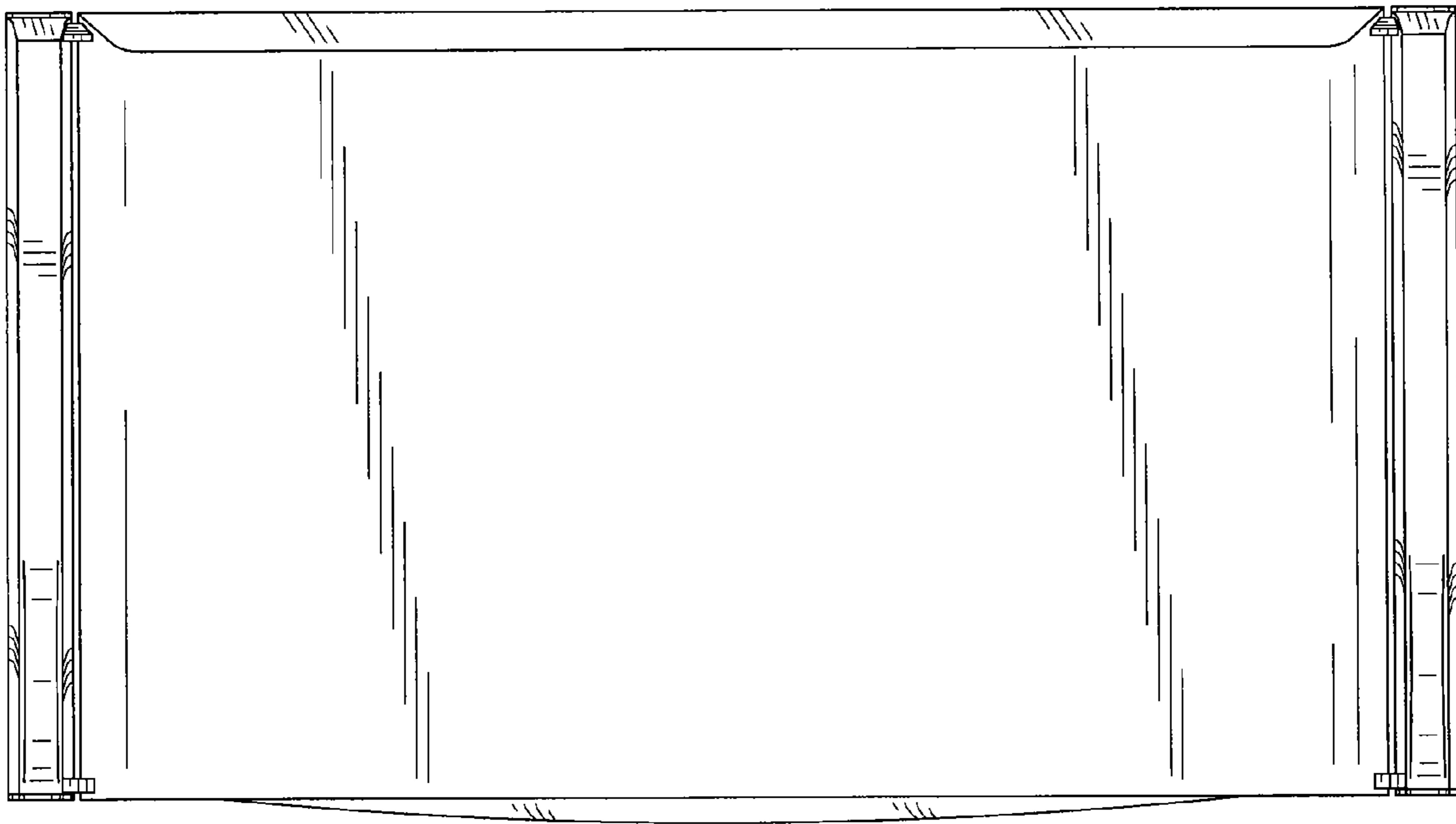

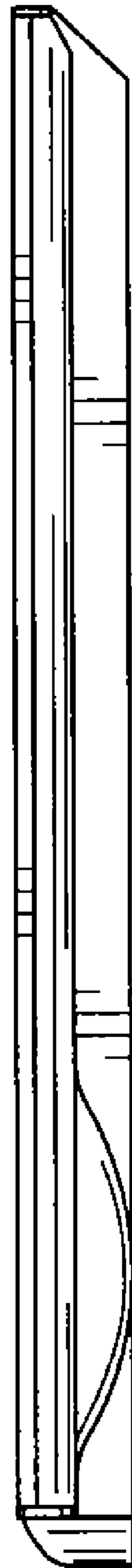

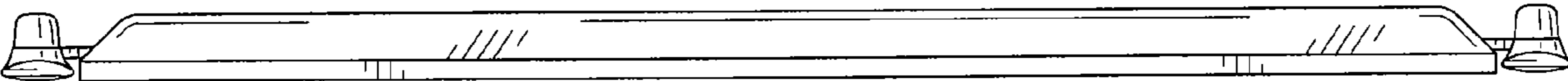

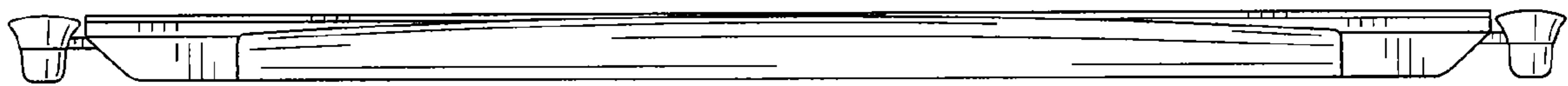
