FIG. 6 is a rear view thereof;

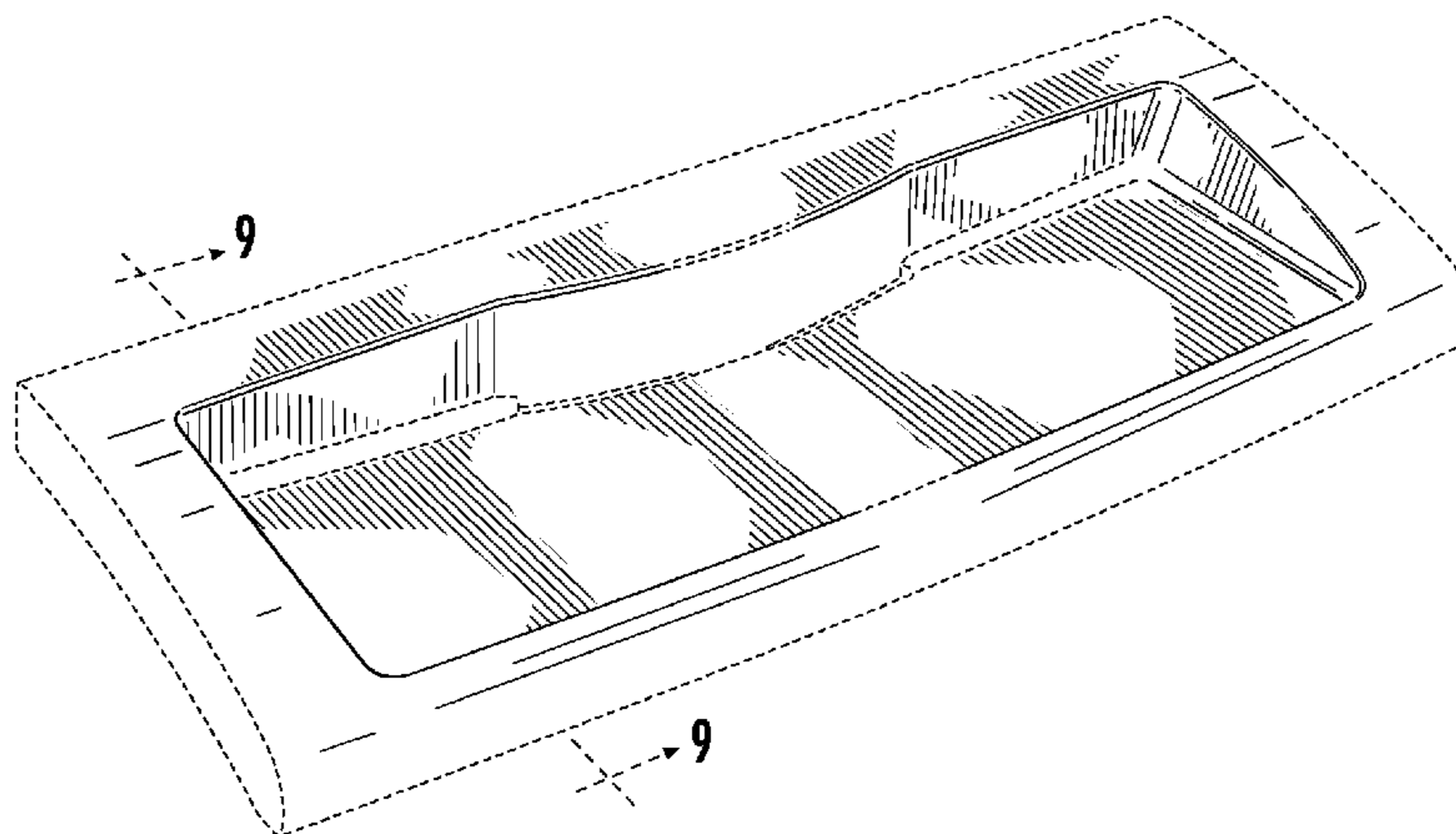
FIG. 7 is a right side view thereof;

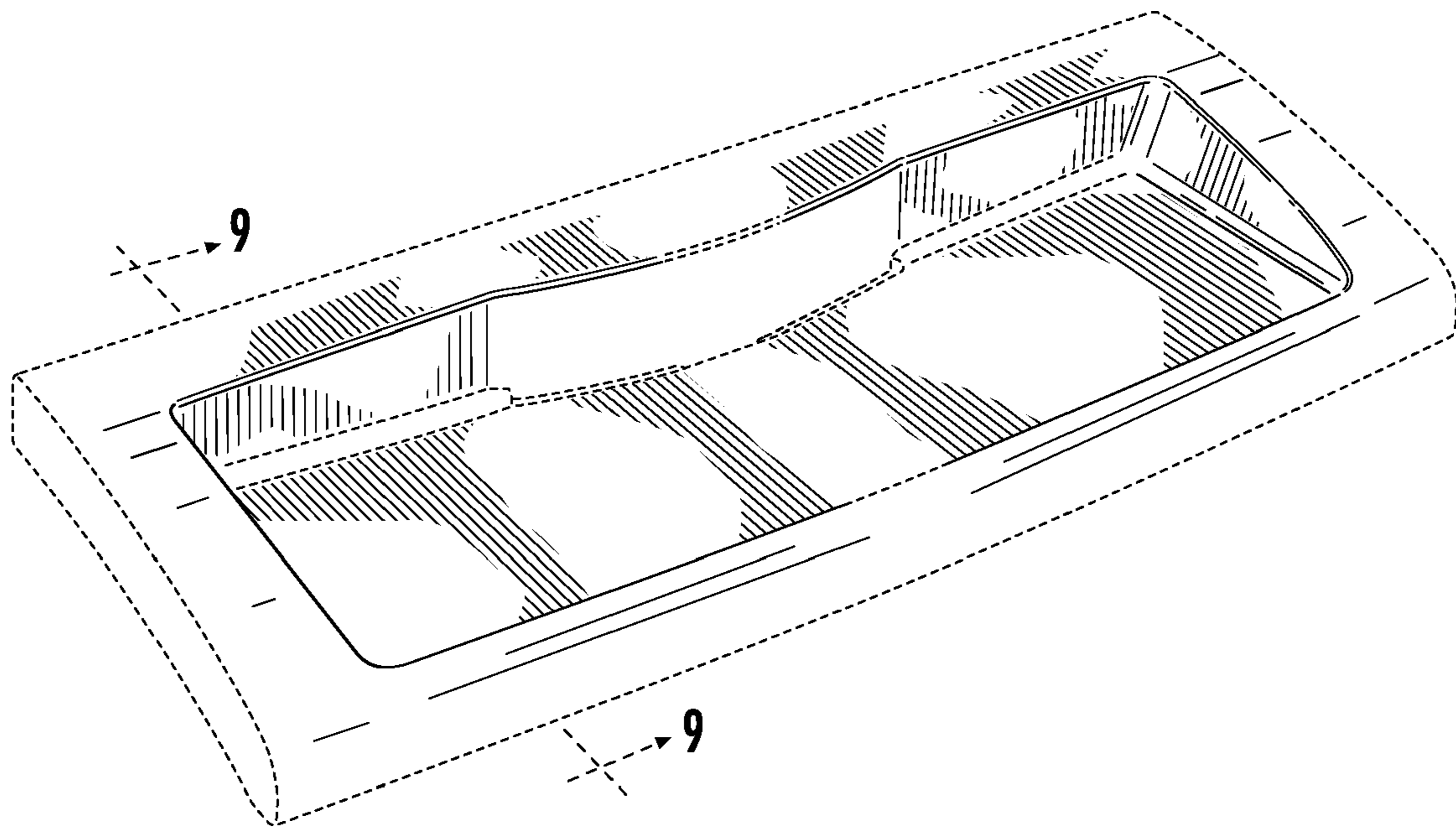
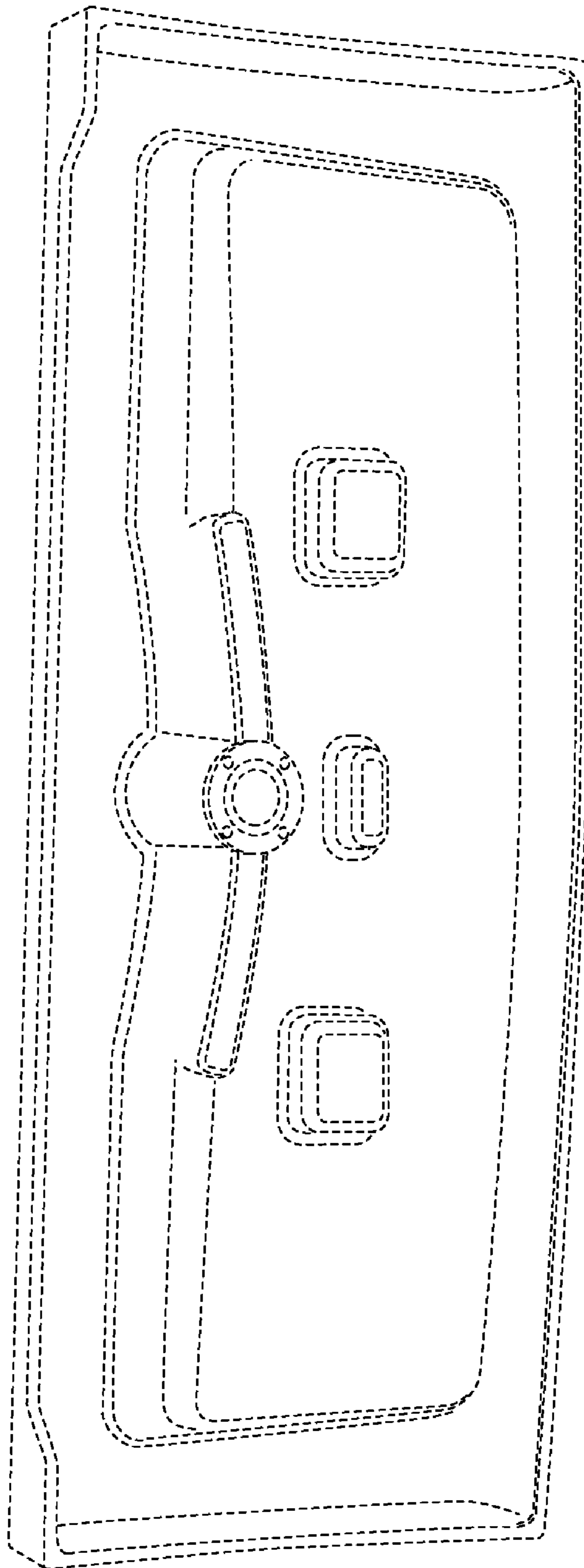

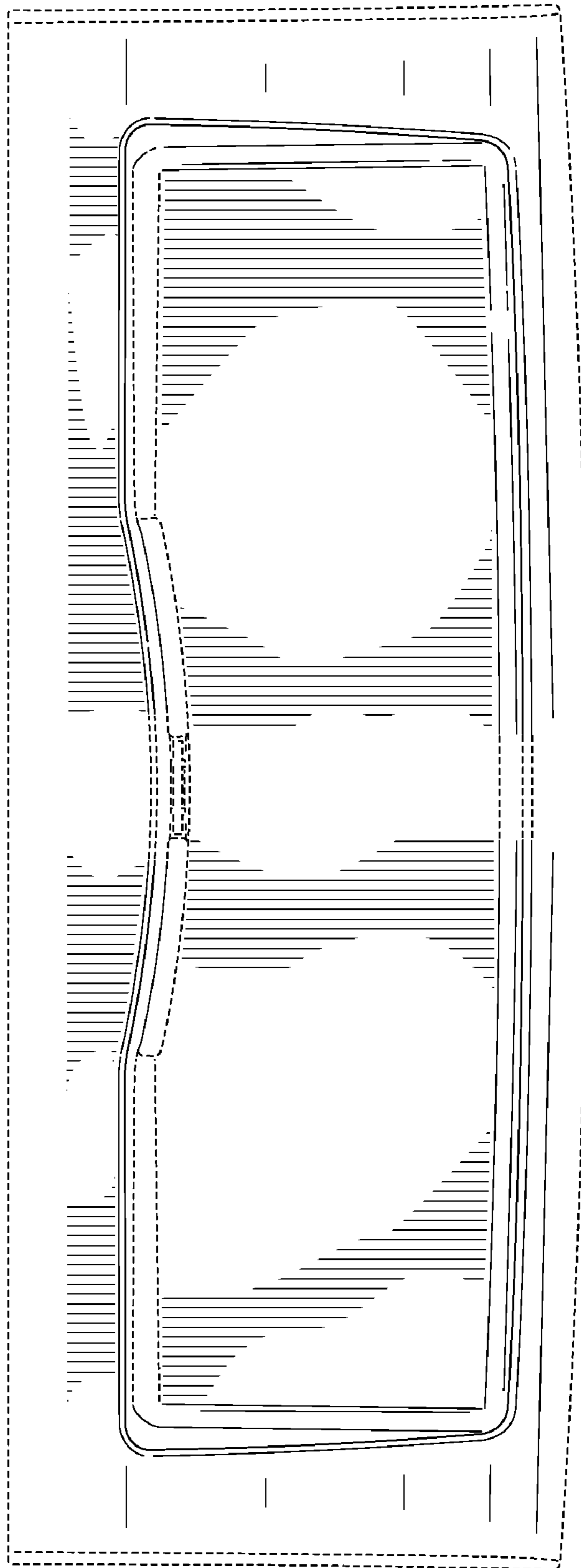

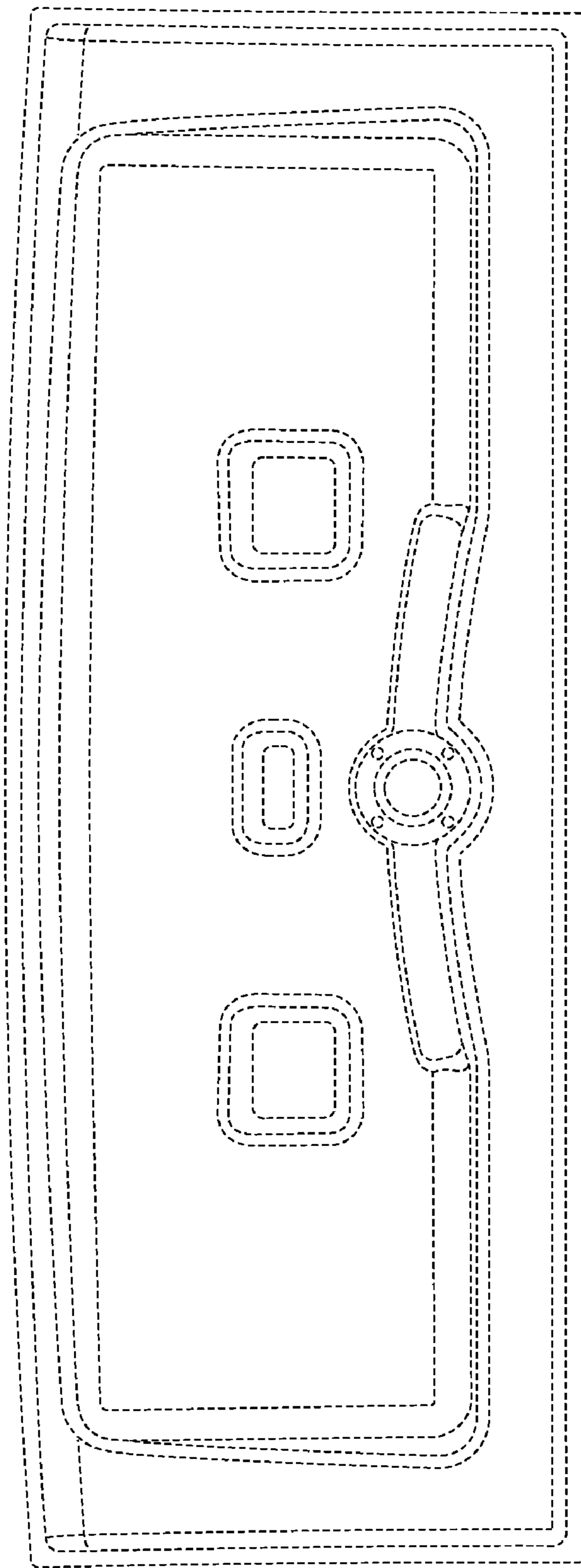

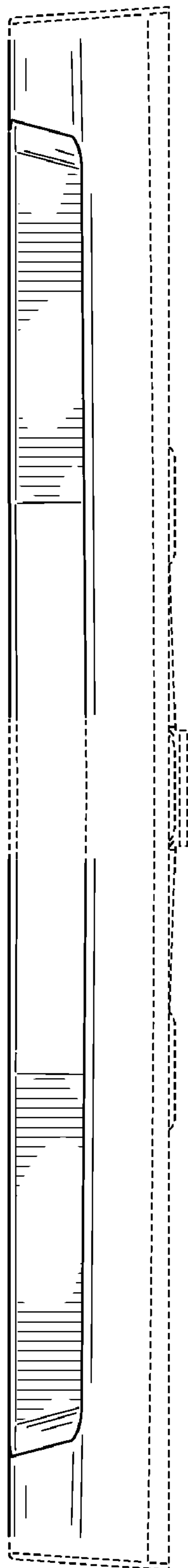

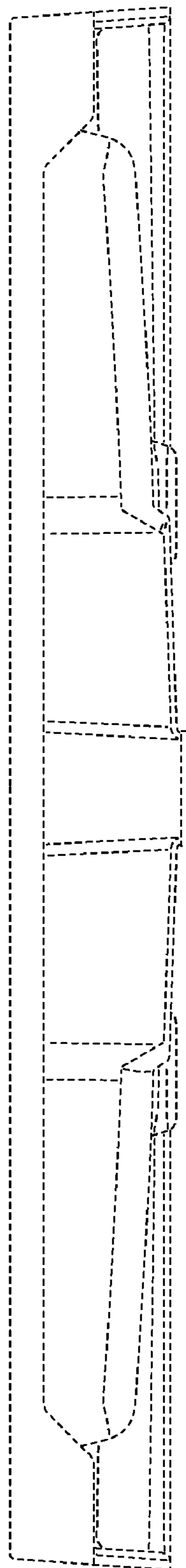
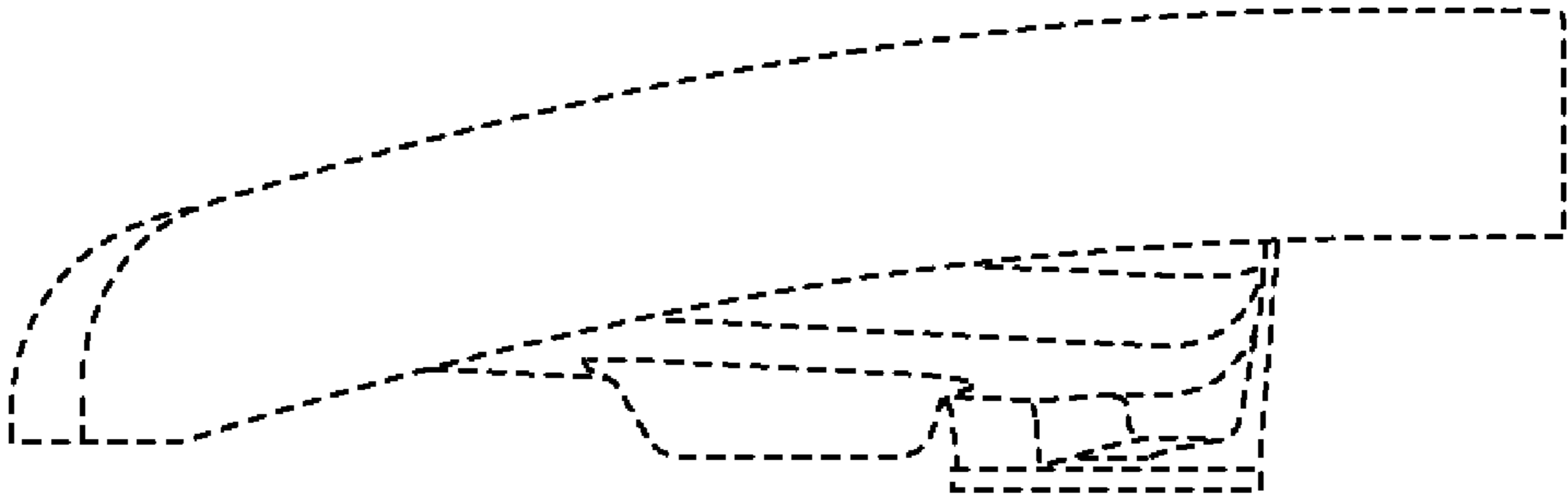
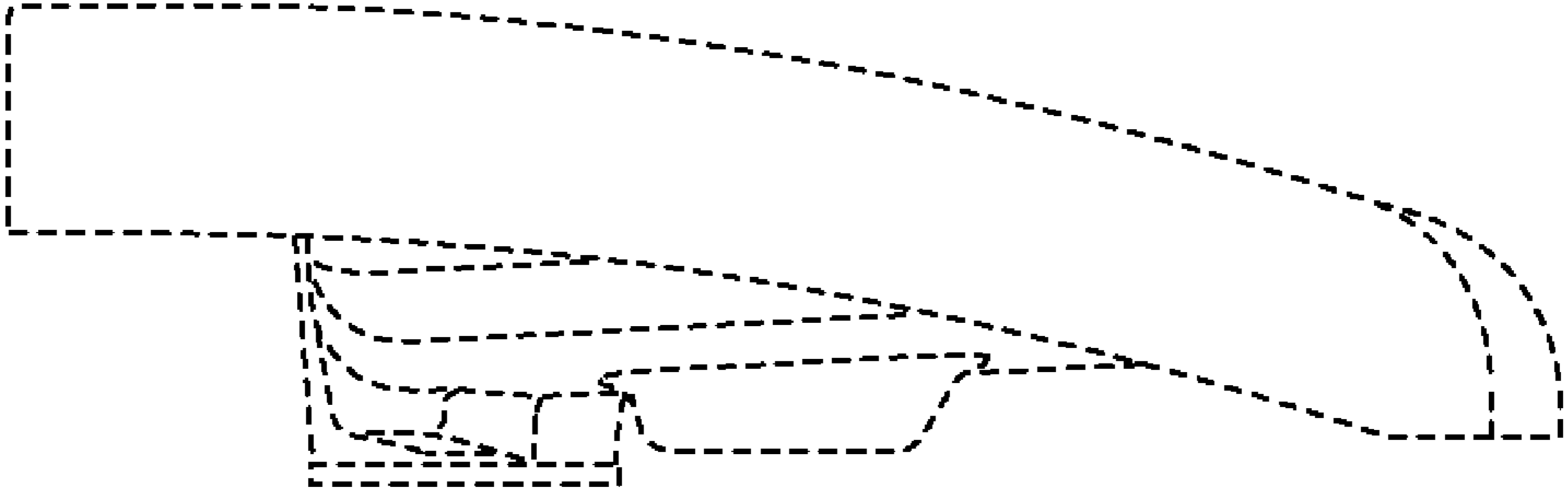

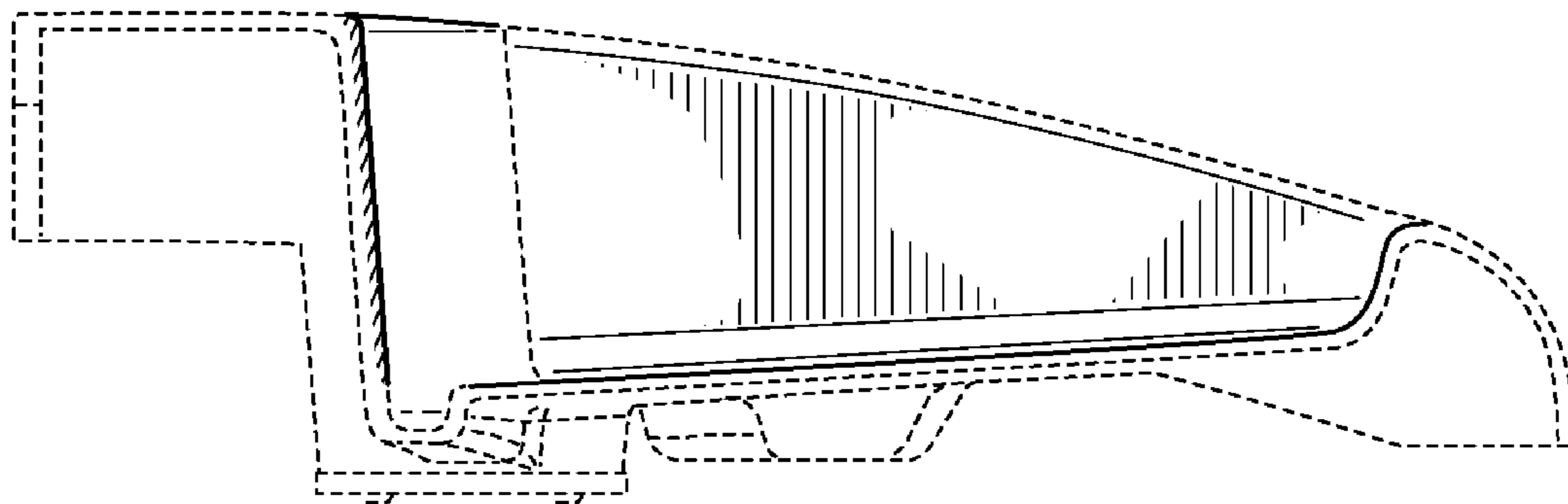
