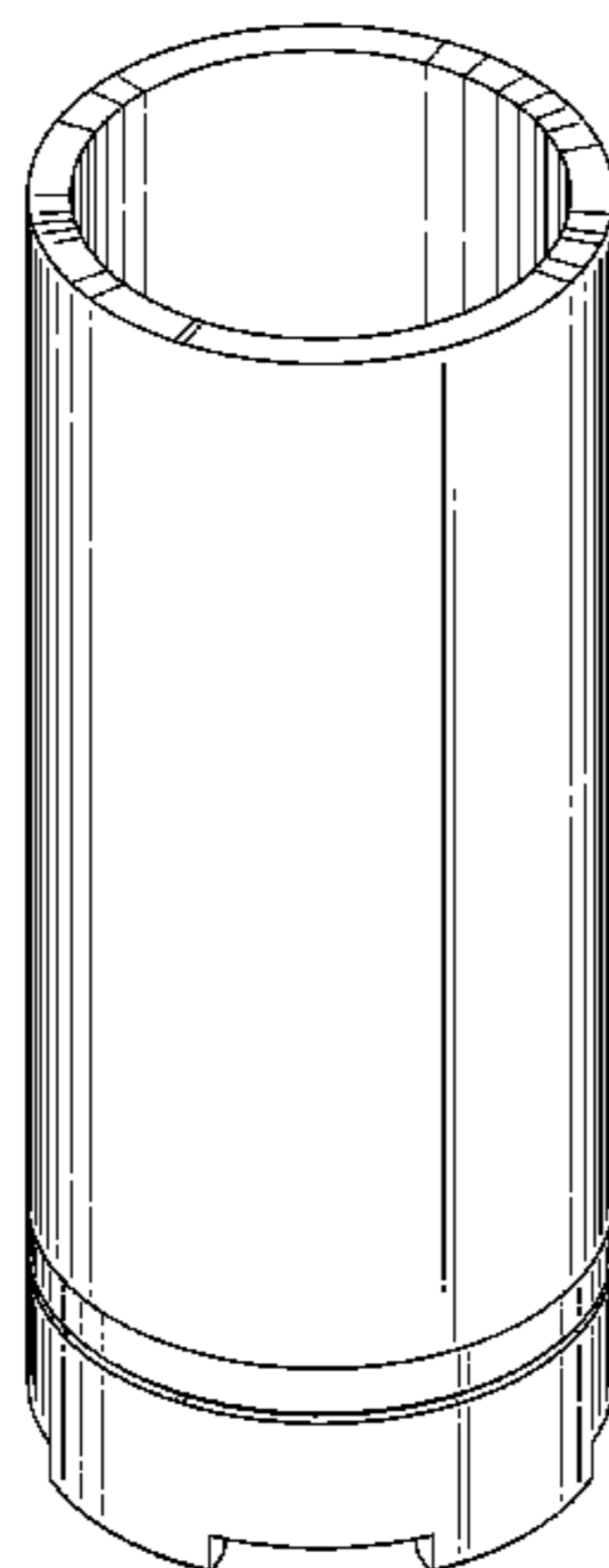
(57) **CLAIM**

The ornamental design for a candle holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an embodiment of a candle holder showing my new design;  
FIG. 2 is a front elevation view thereof, the back and side views being mirror images thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a cross sectional view along the longitudinal axis thereof;  
FIG. 6 is a front perspective view of another embodiment of a candle holder showing my new design;  
FIG. 7 is a front elevation view thereof, the back and side elevation views being mirror images thereof;  
FIG. 8 is a top plan view thereof; and,  
FIG. 9 is a bottom plan view thereof.

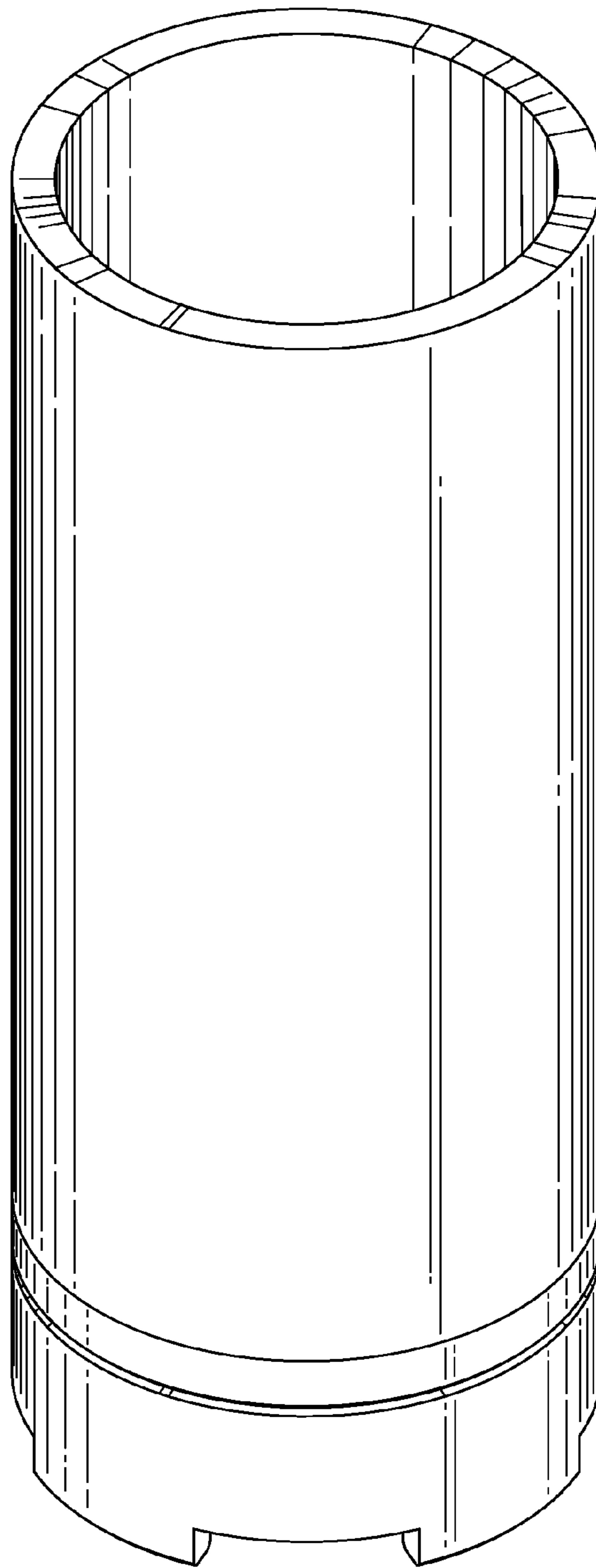

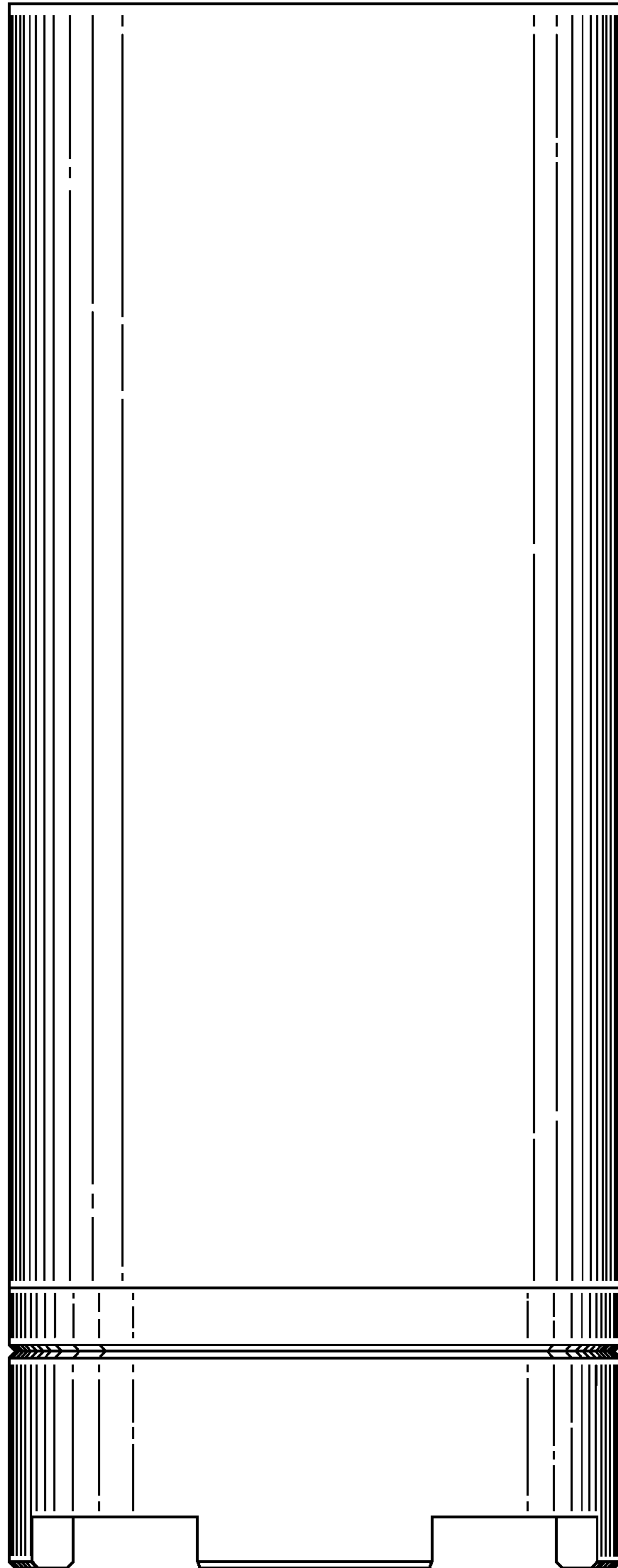

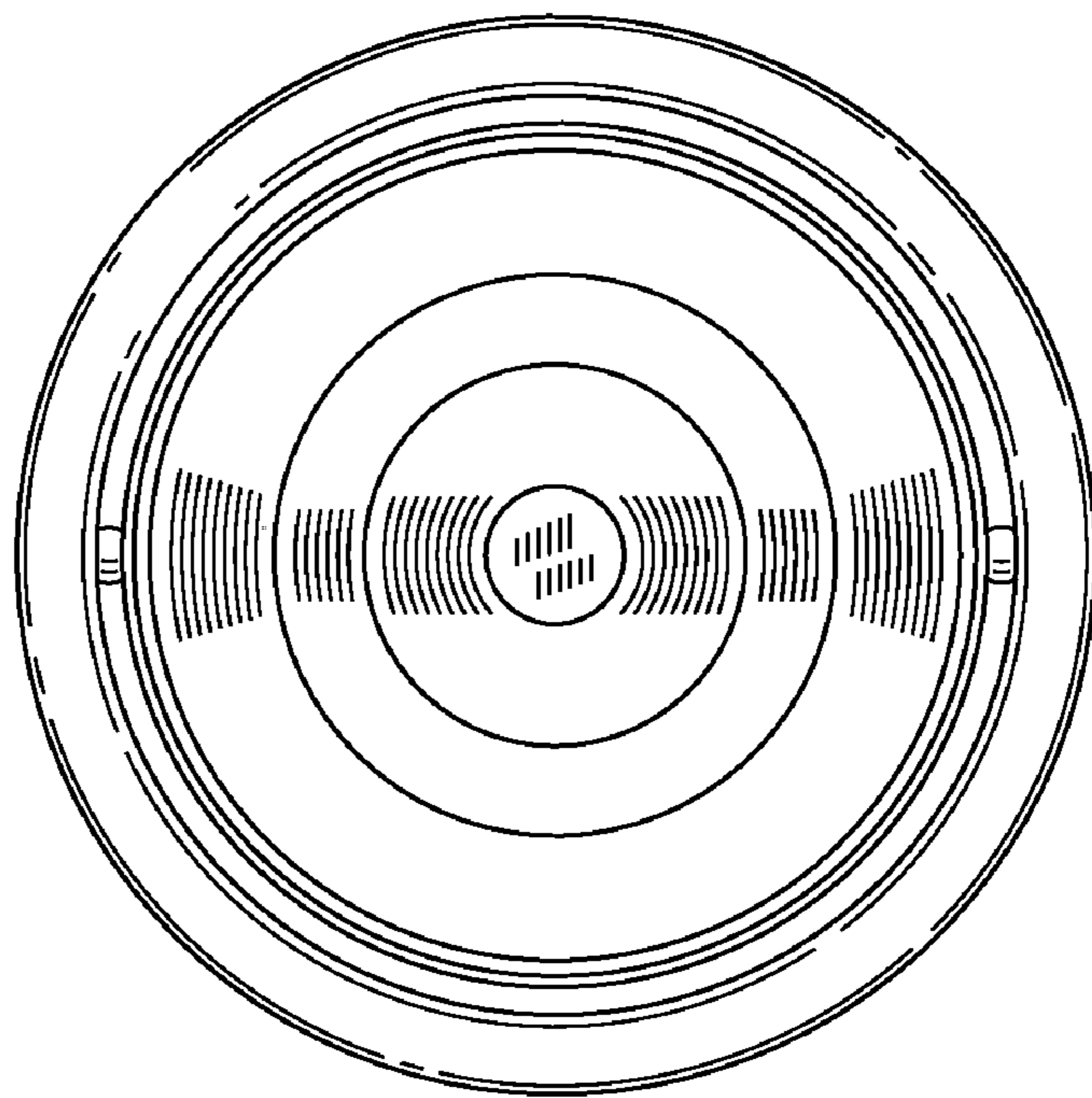

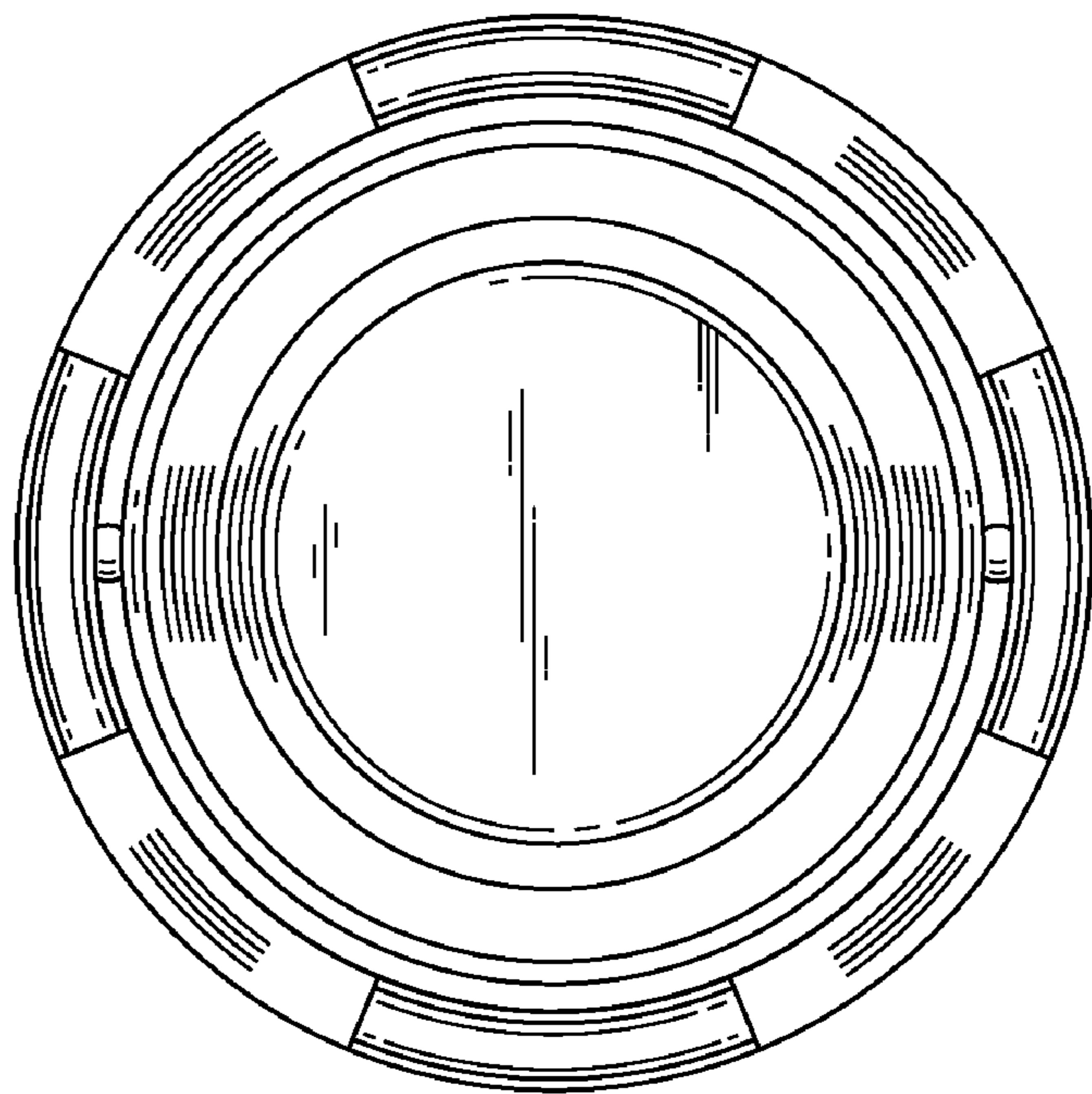

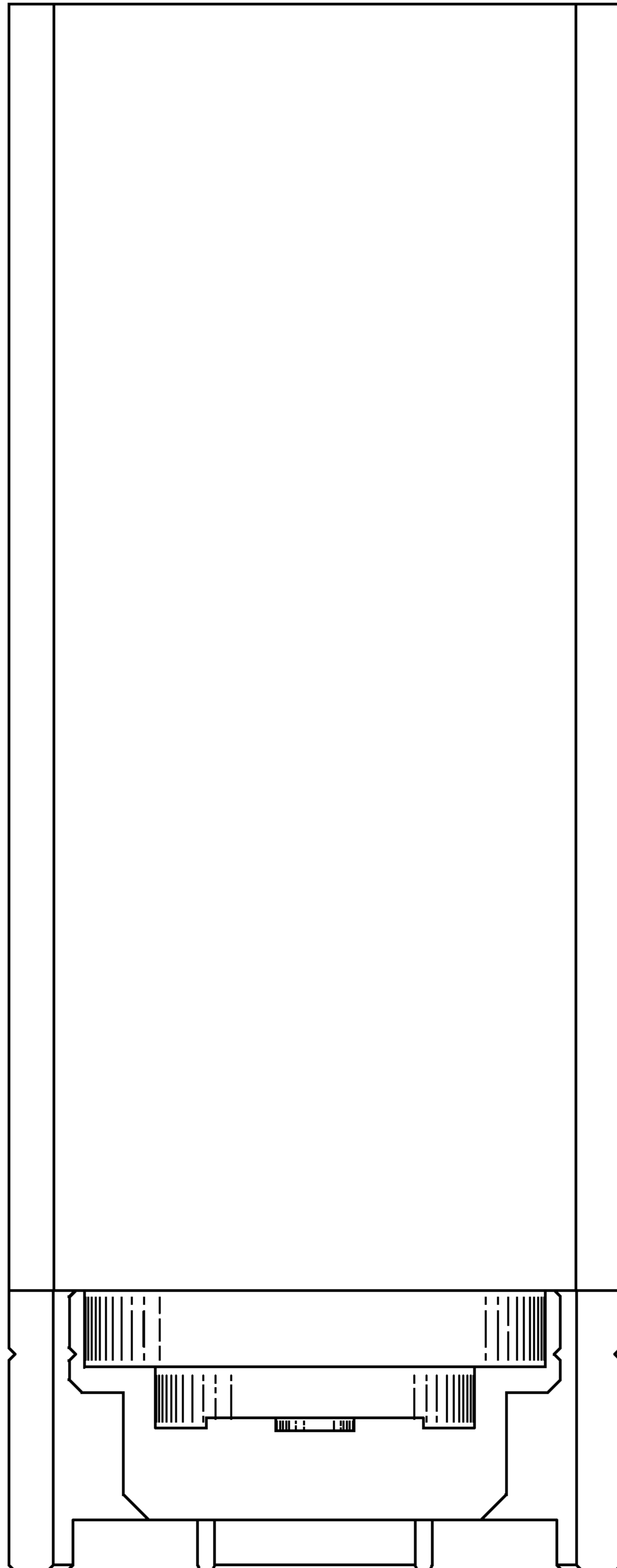

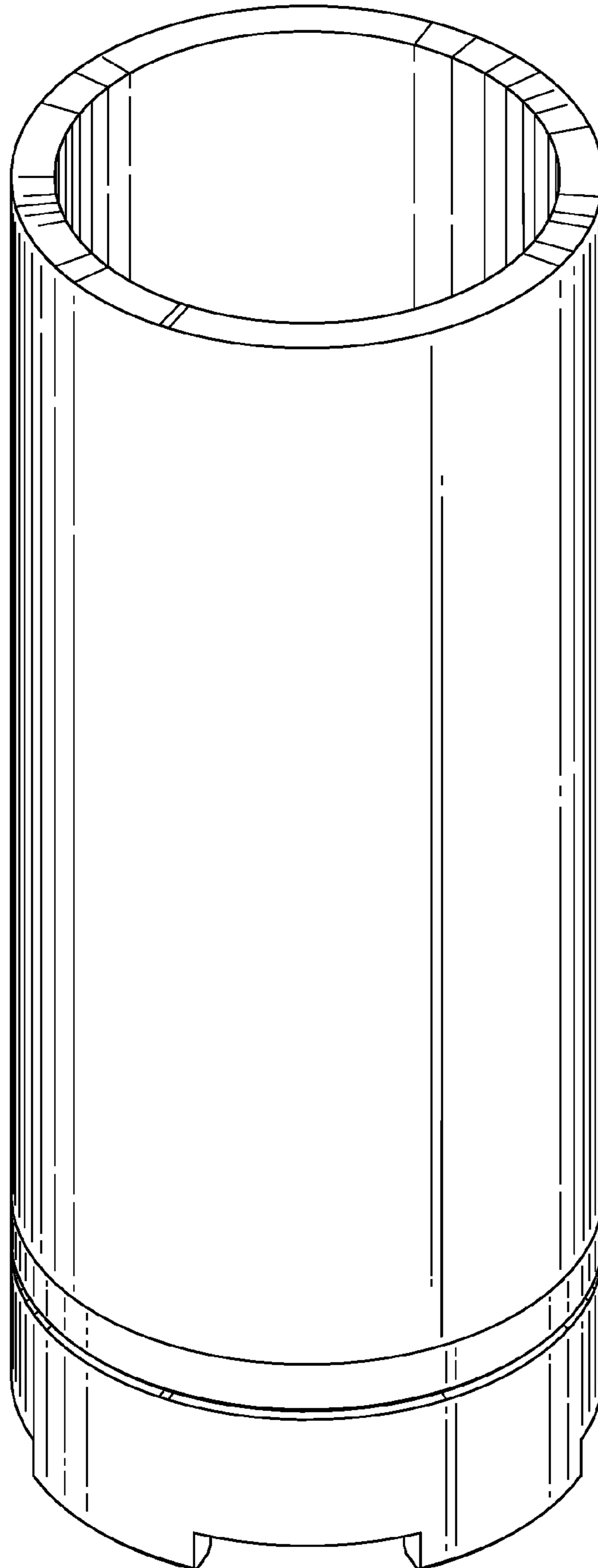

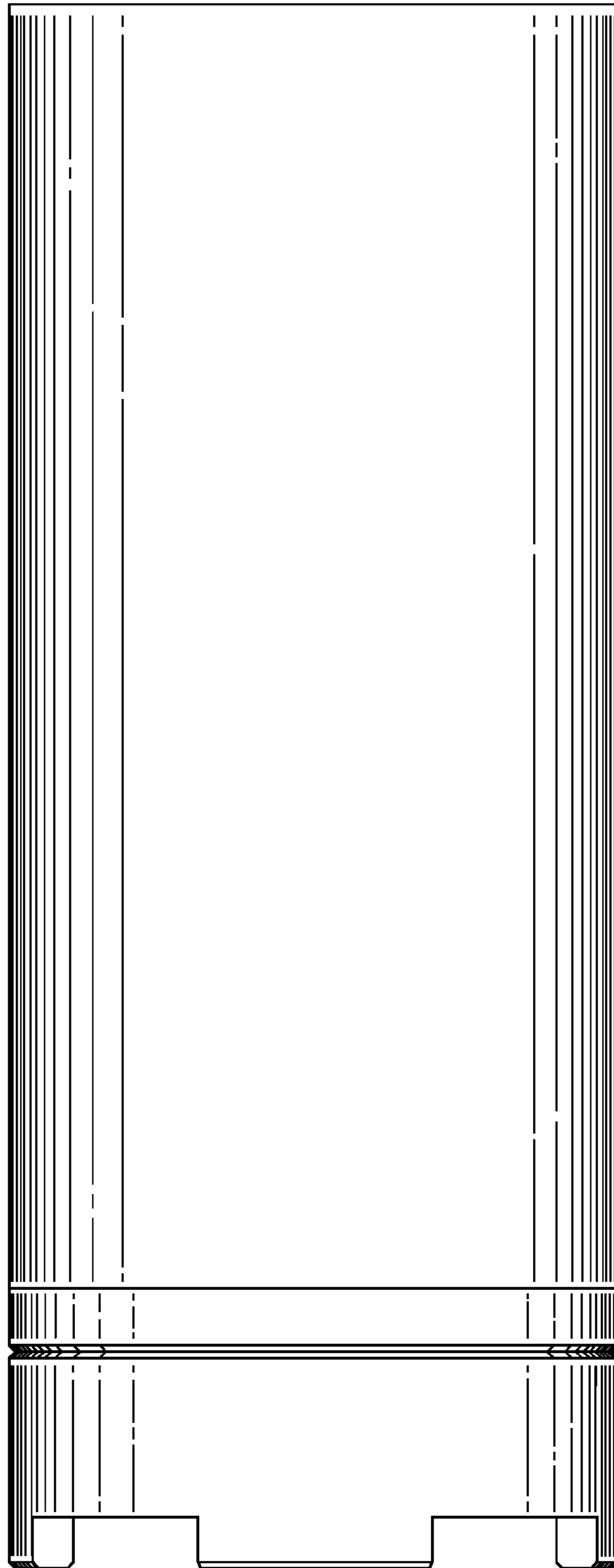

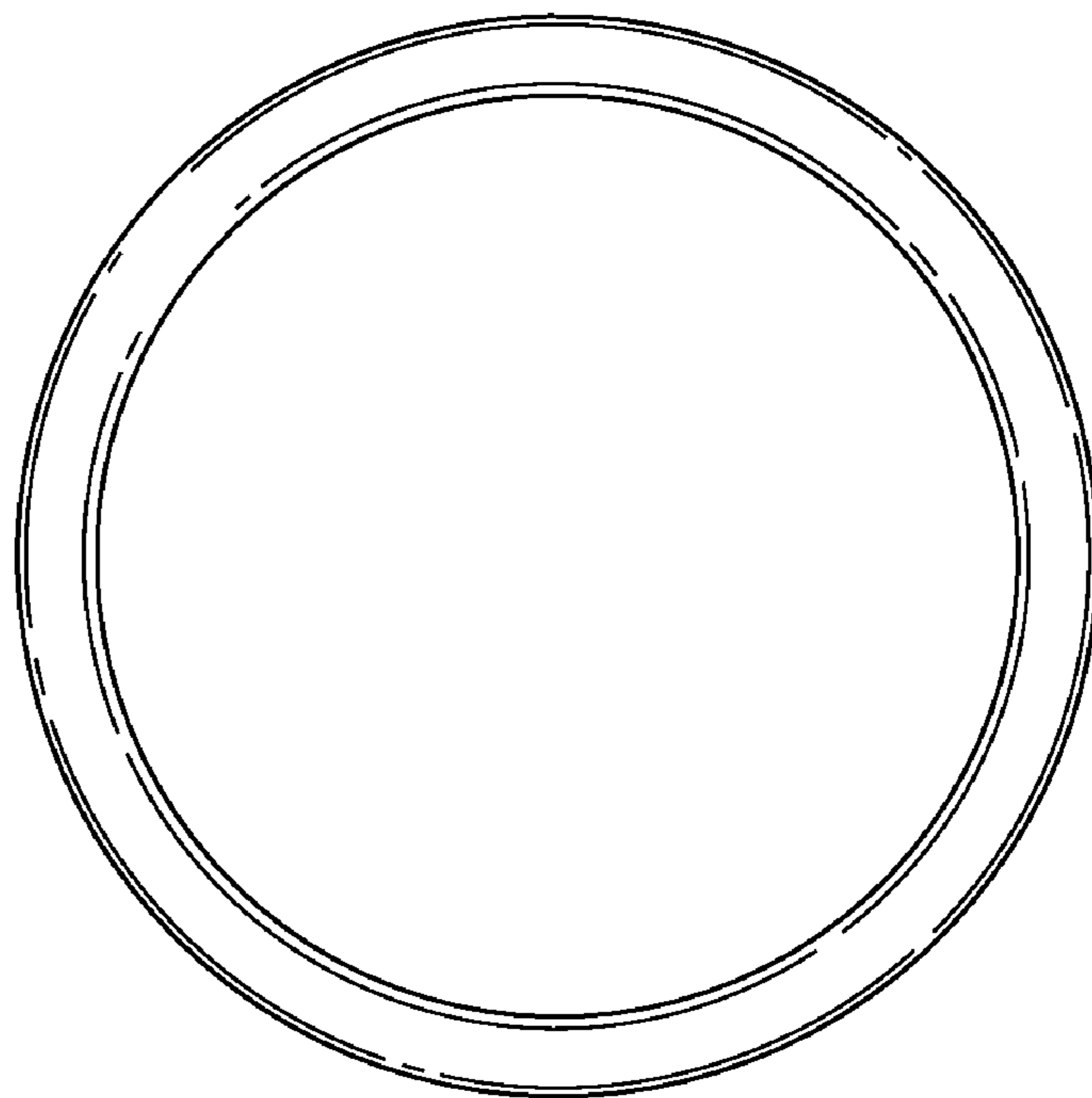
