We claim the ornamental design for a lighting apparatus, as shown.

**DESCRIPTION**

FIG. 20 is a perspective view of the fourth embodiment showing the claimed design;

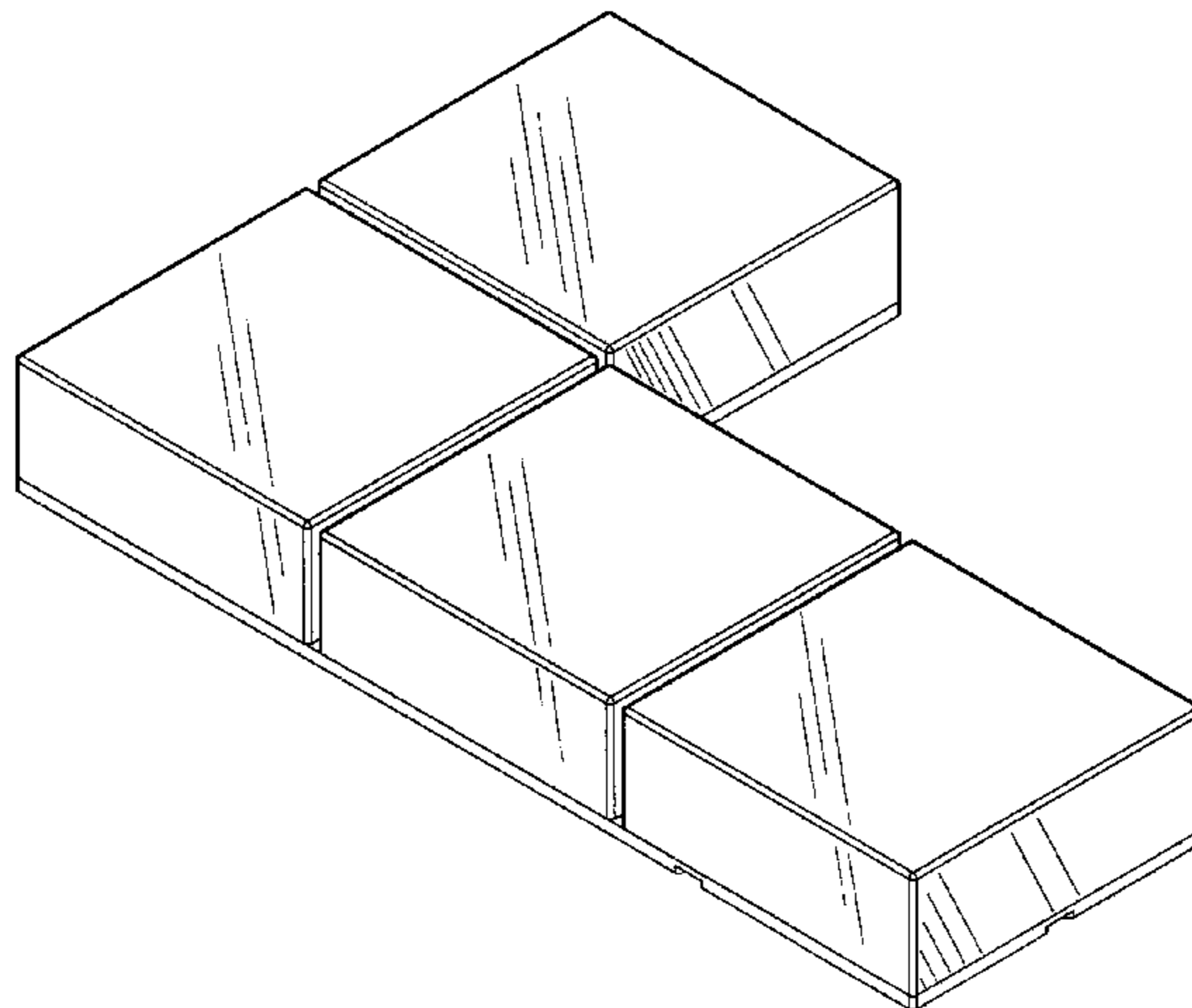
FIG. 21 is a front elevational view of FIG. 20;

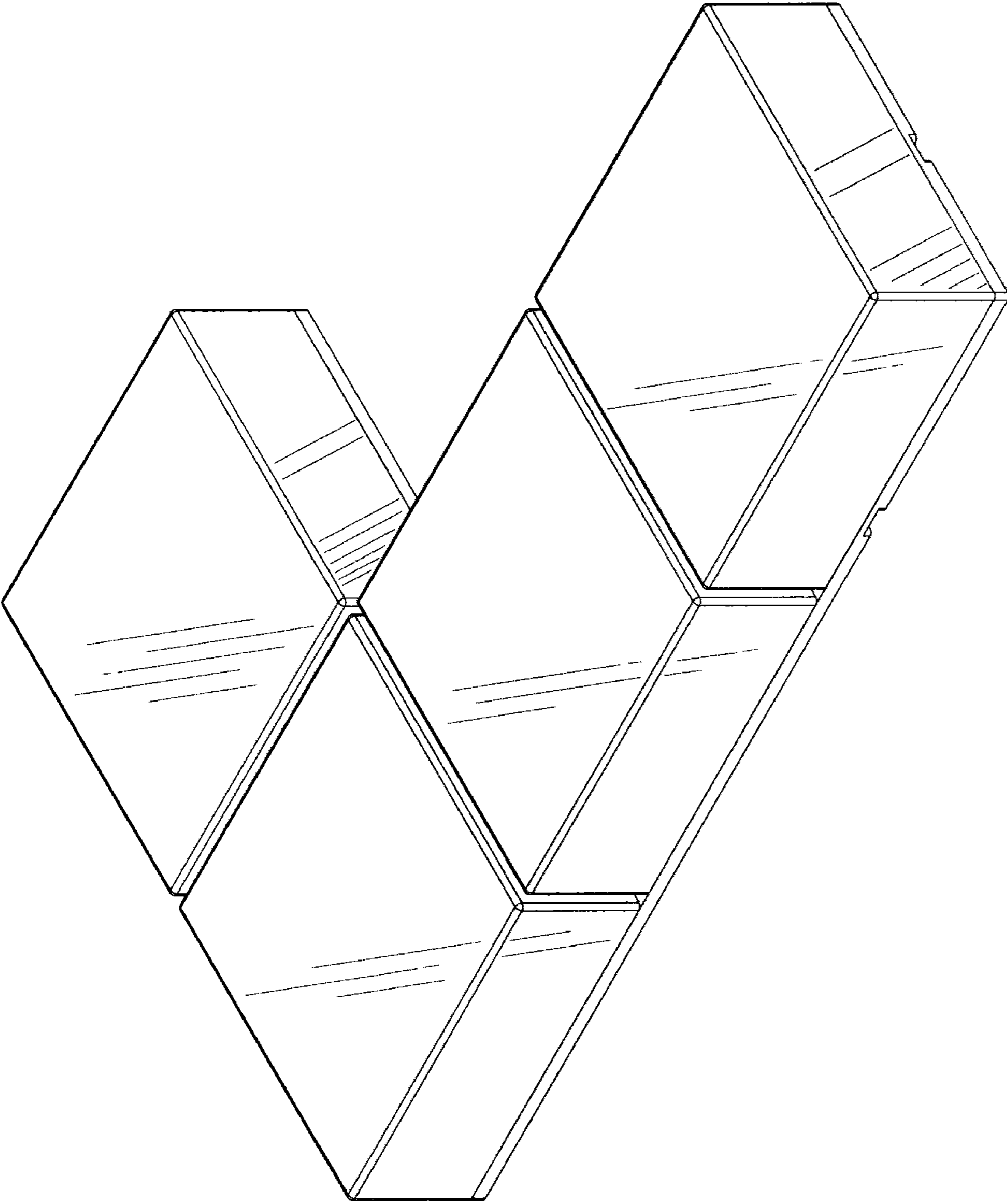

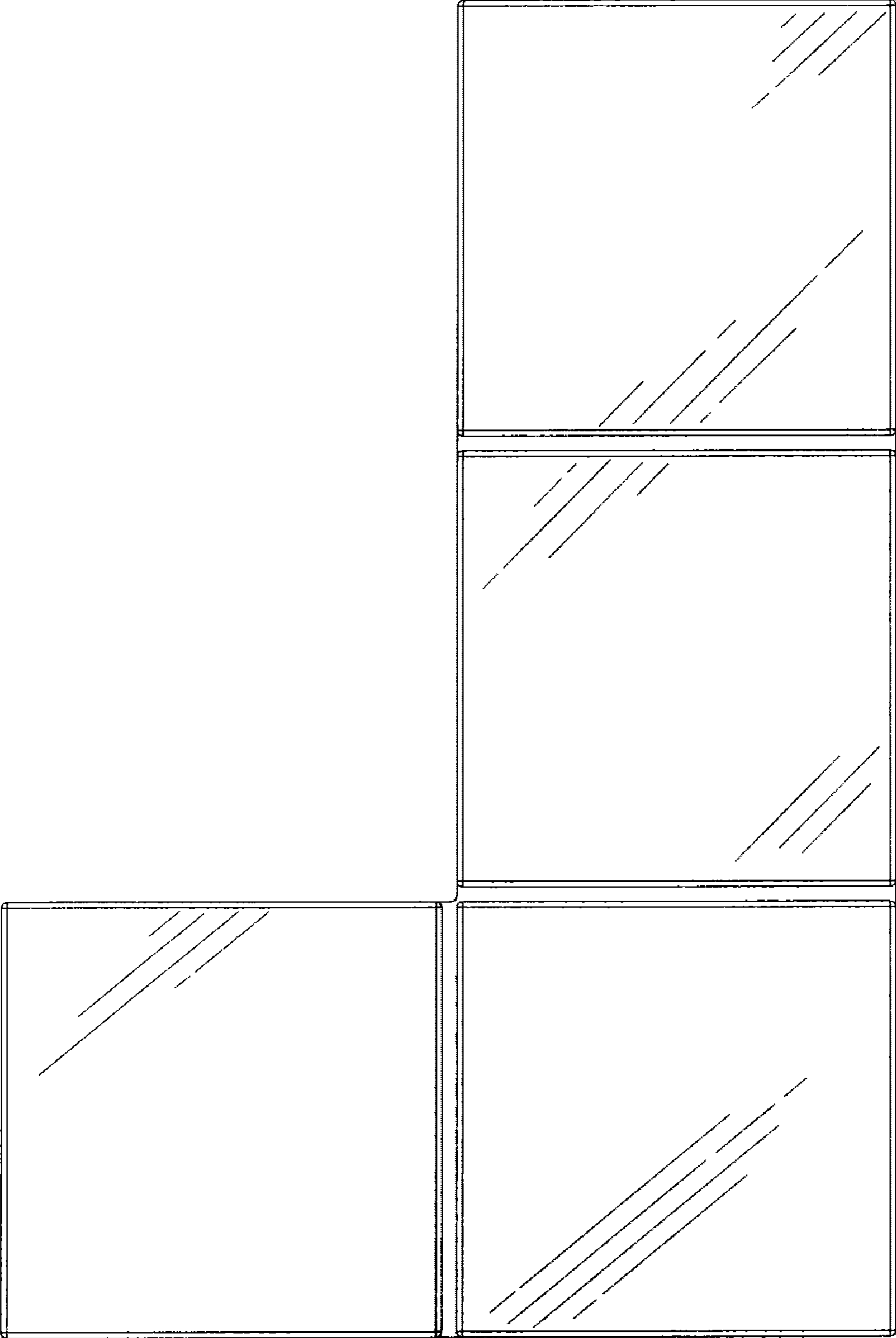

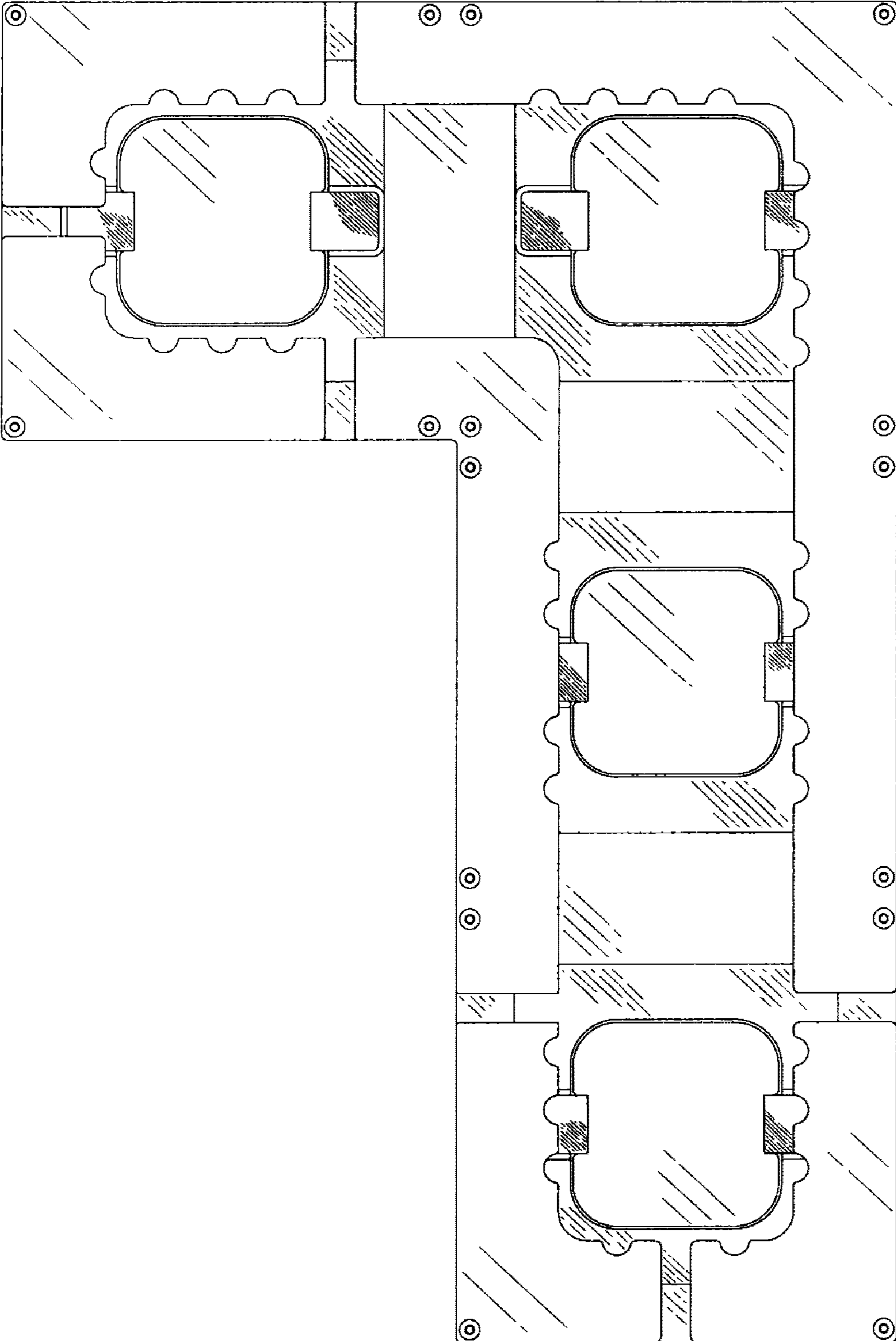

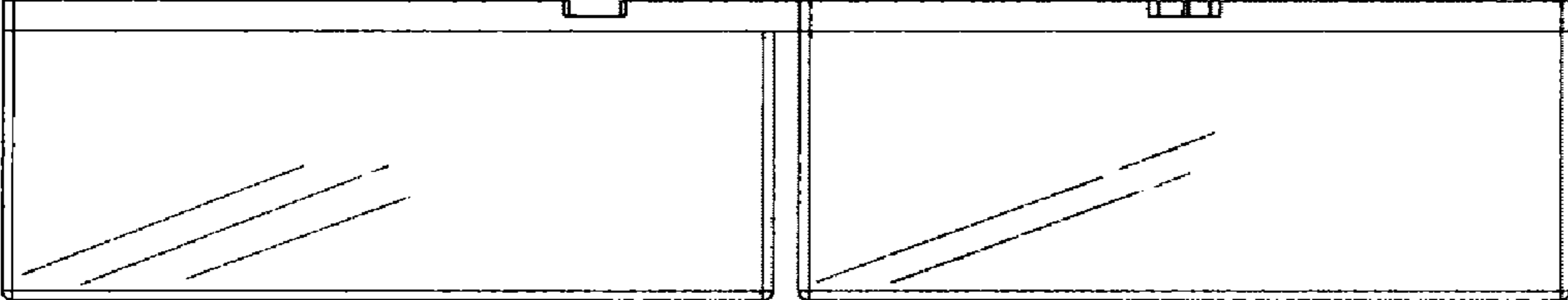

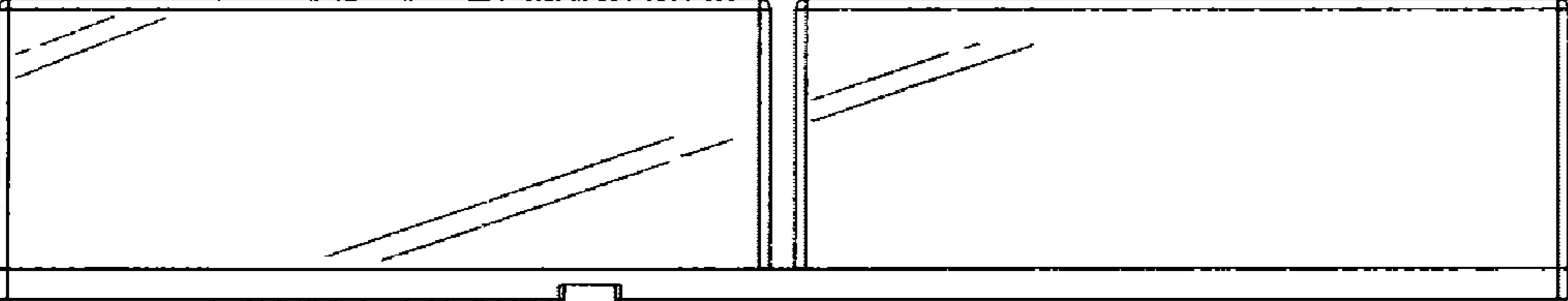

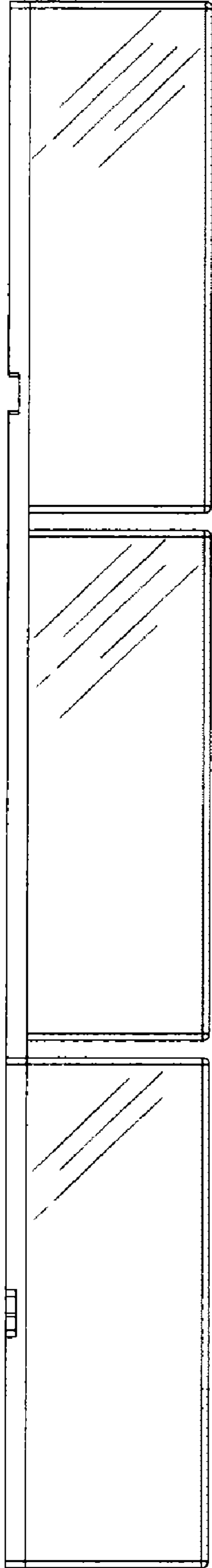

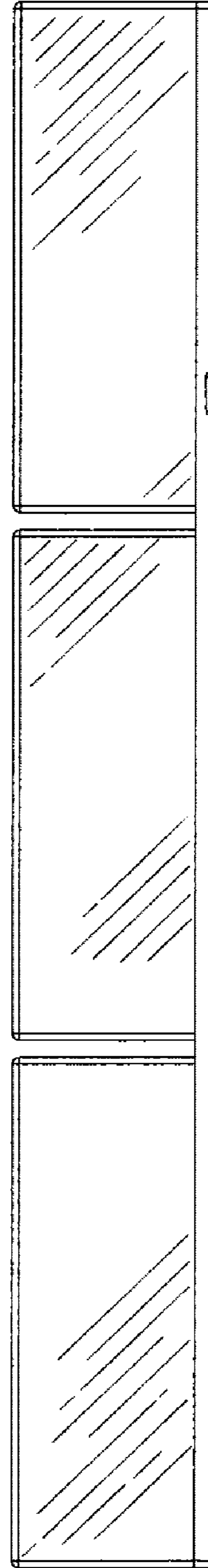

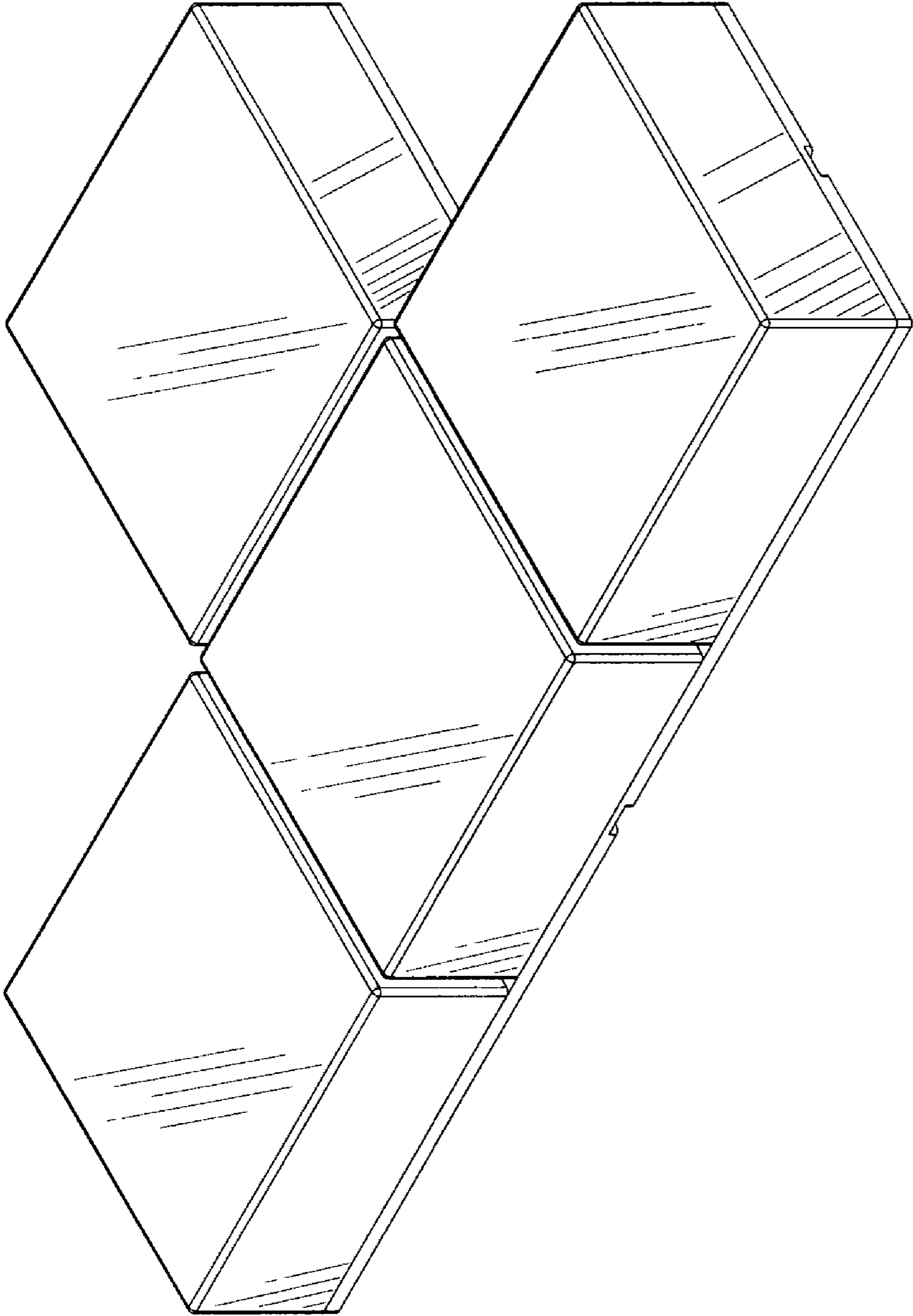

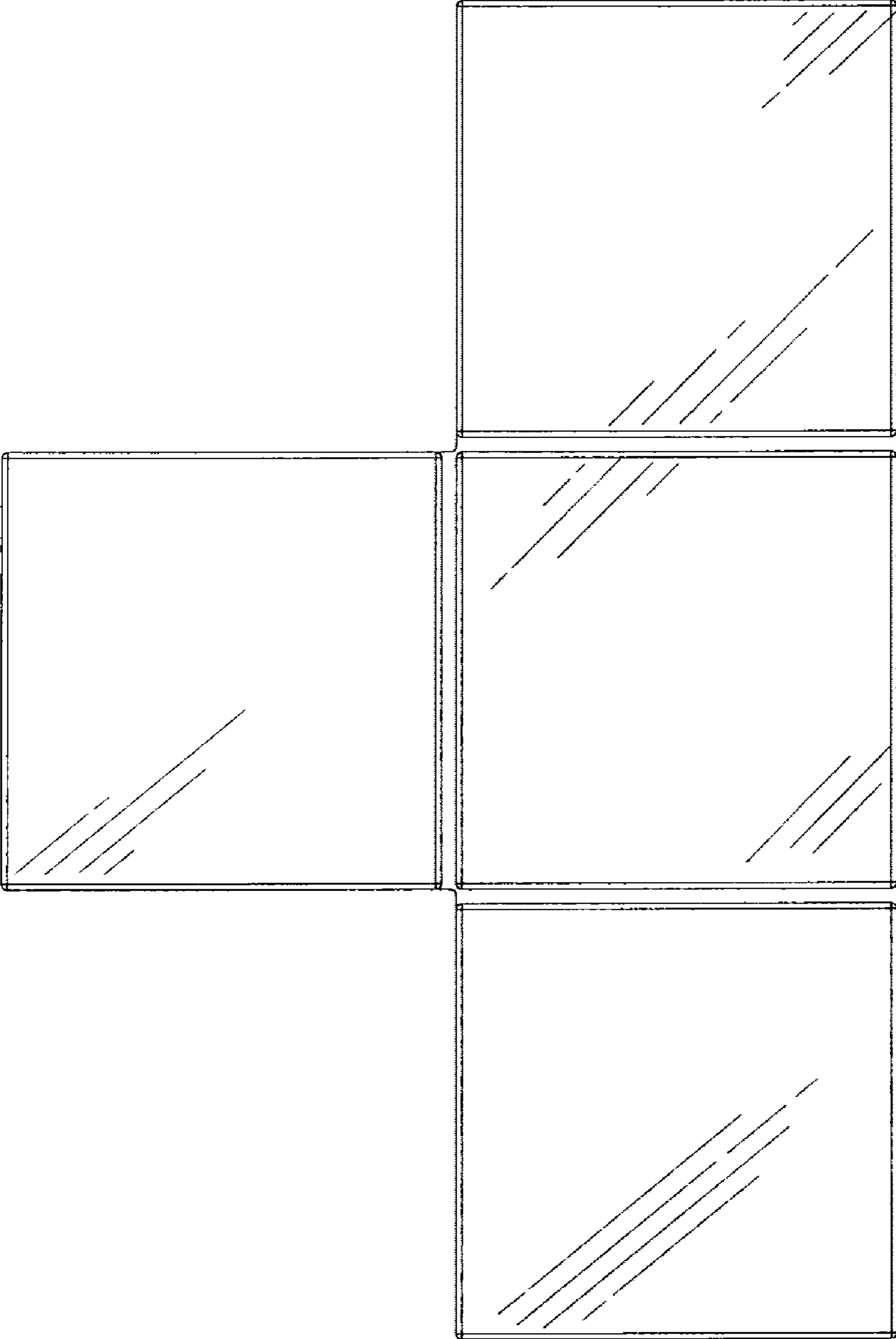

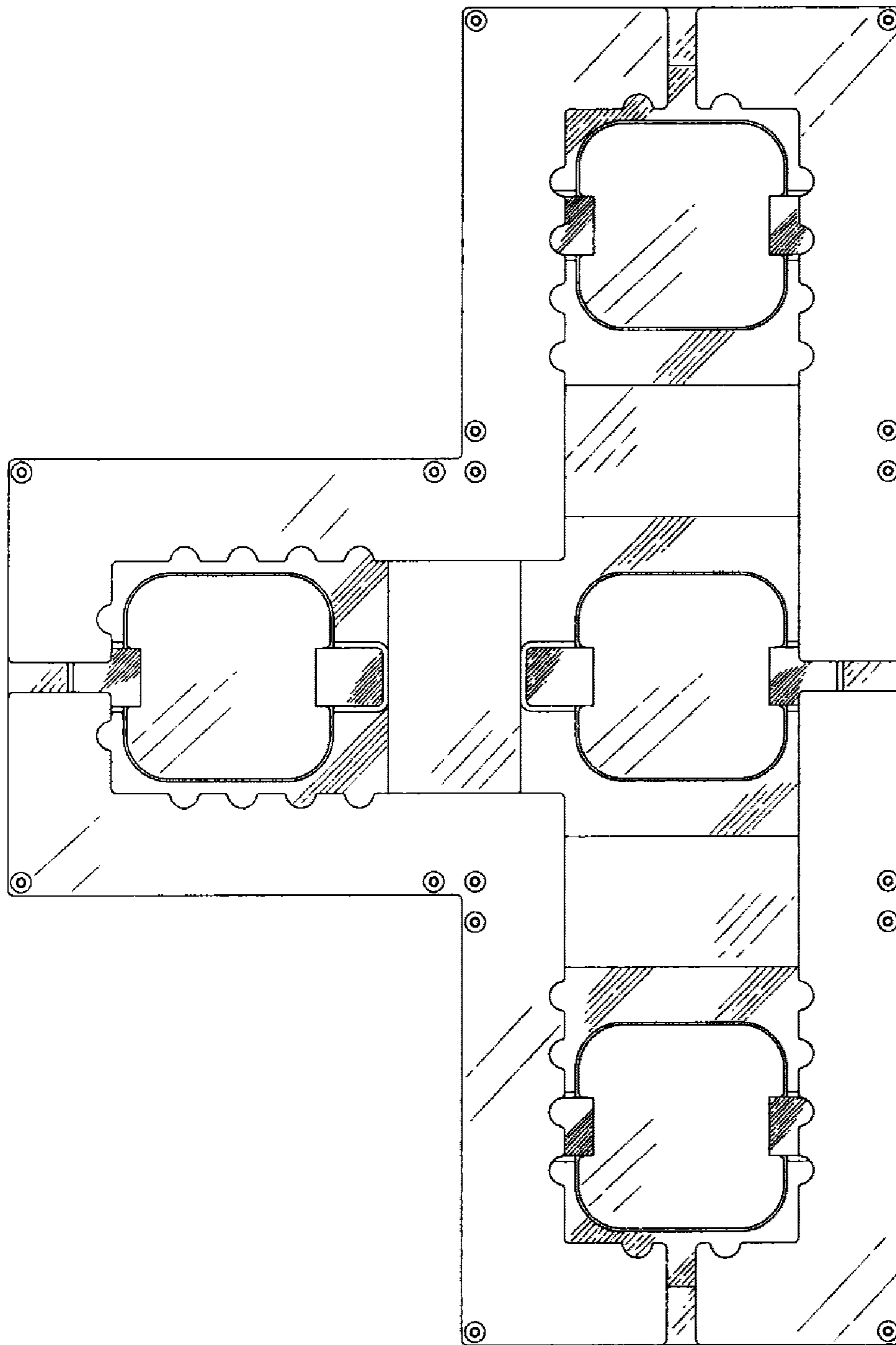

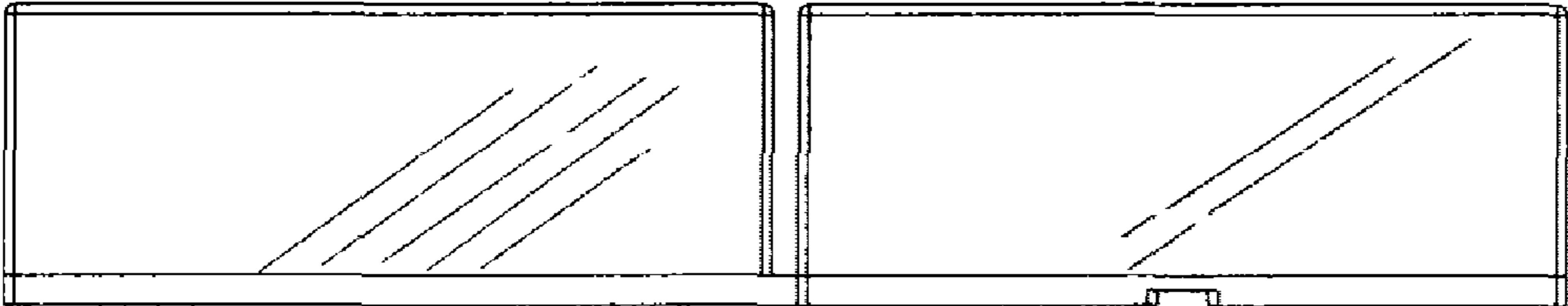

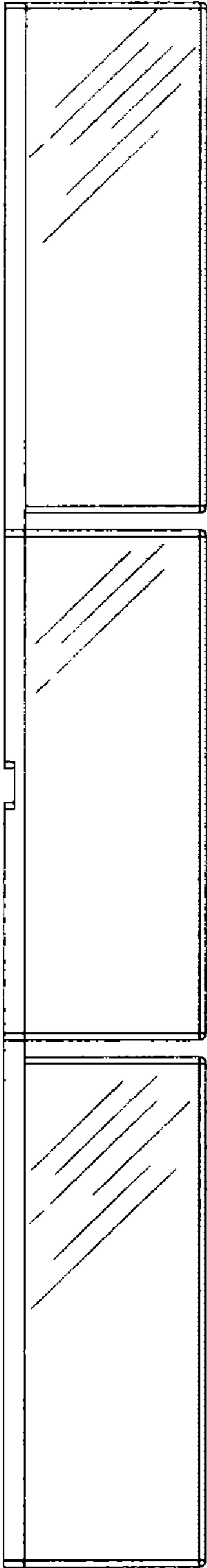

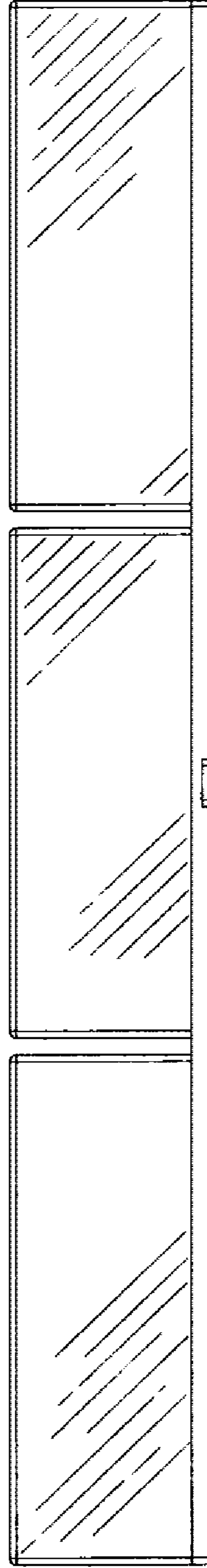

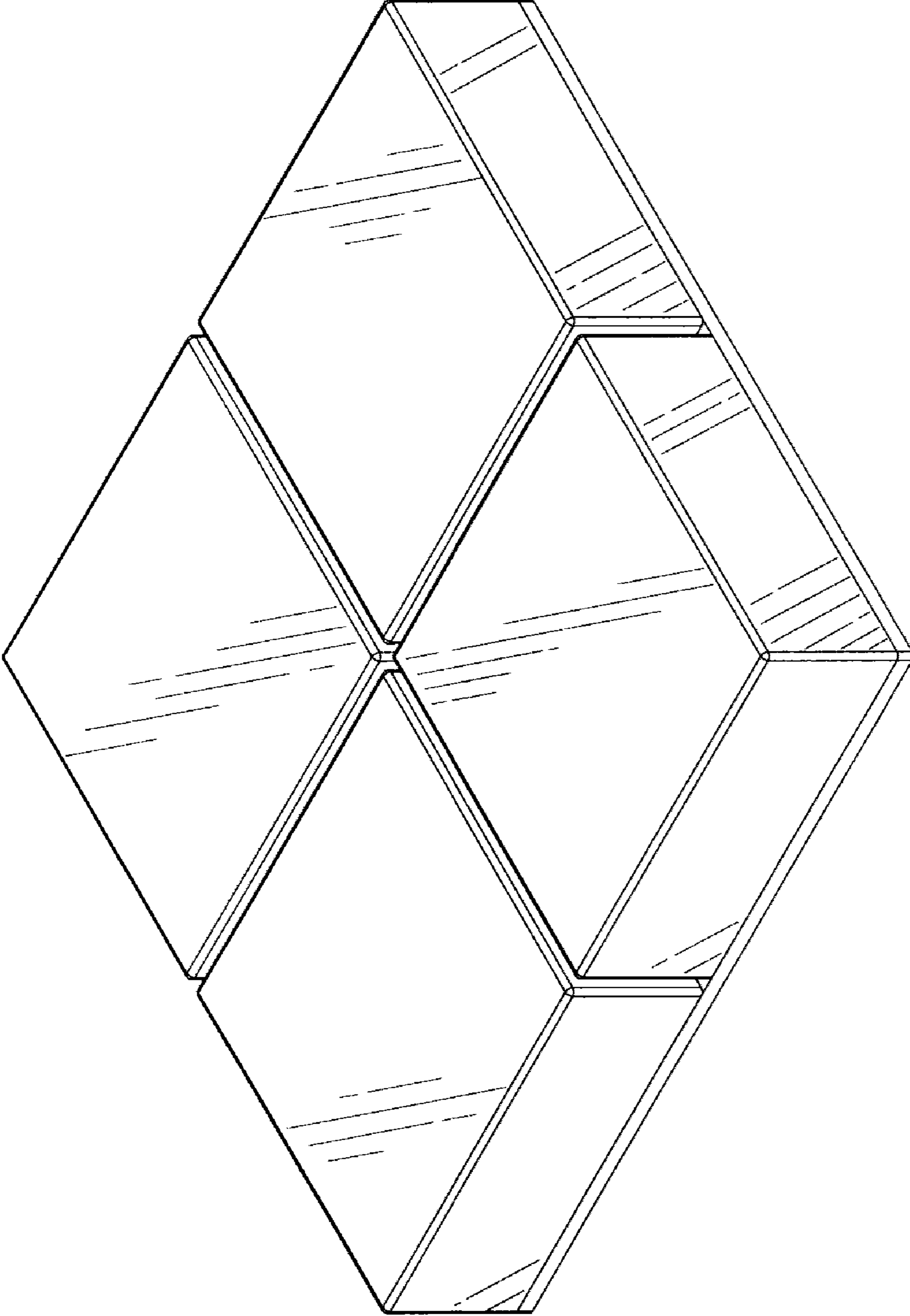

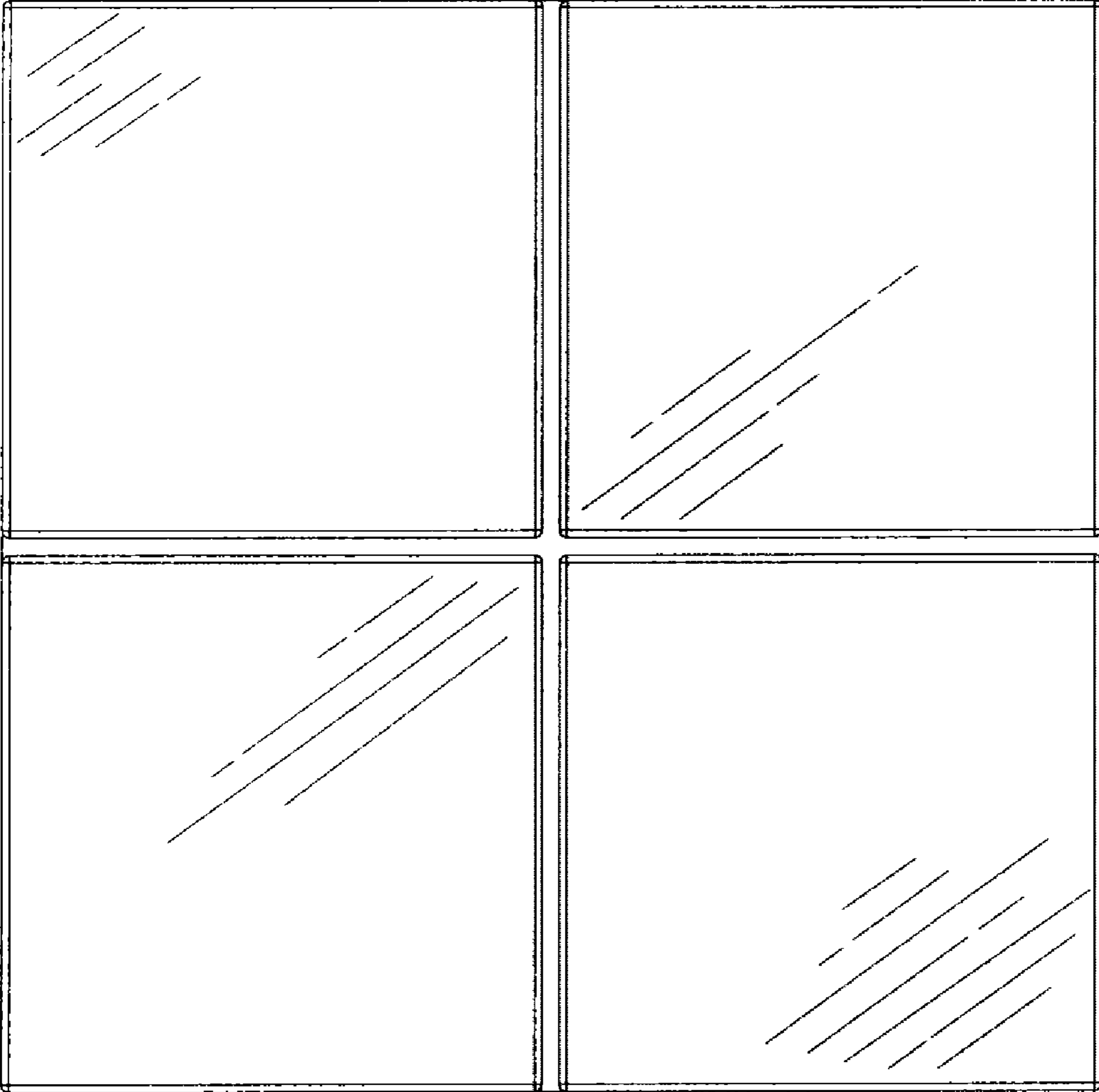

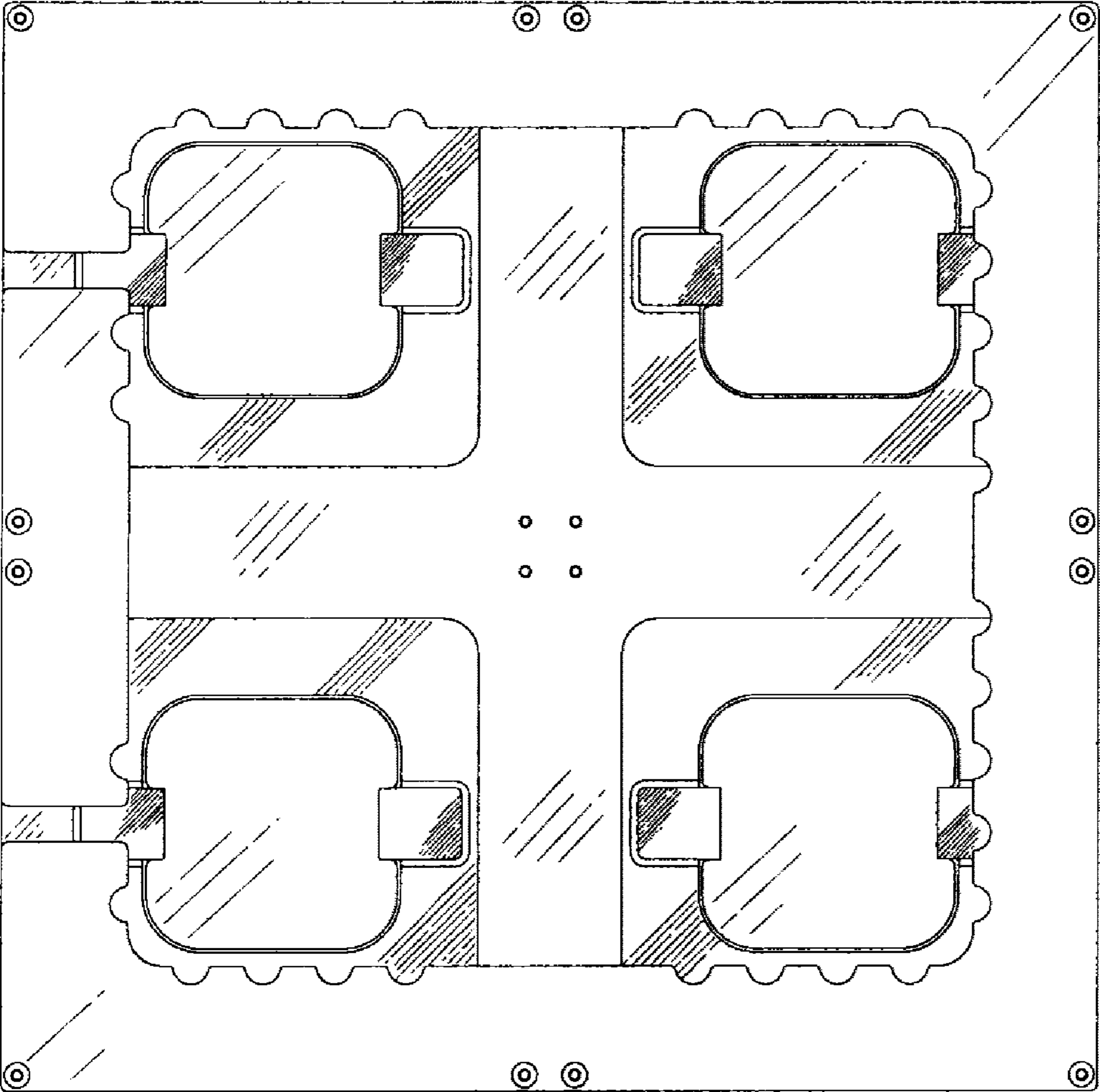

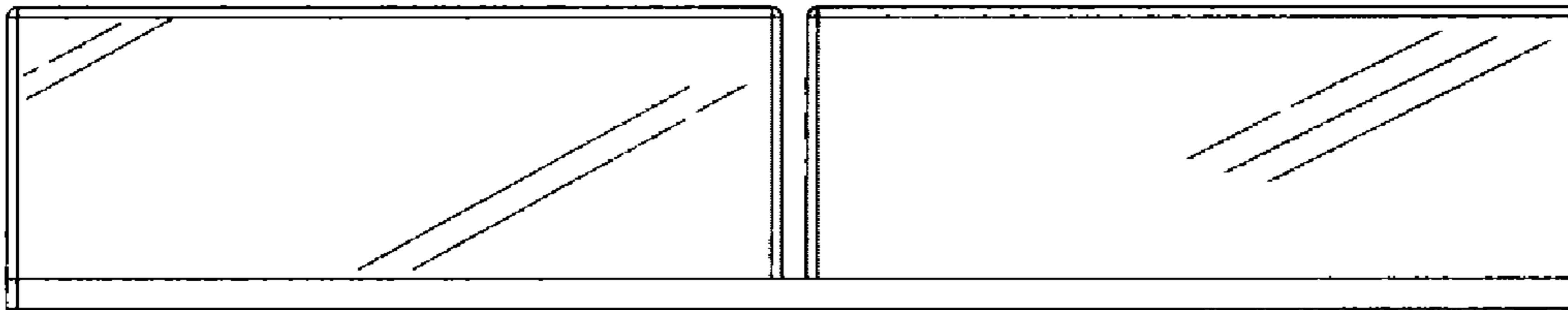

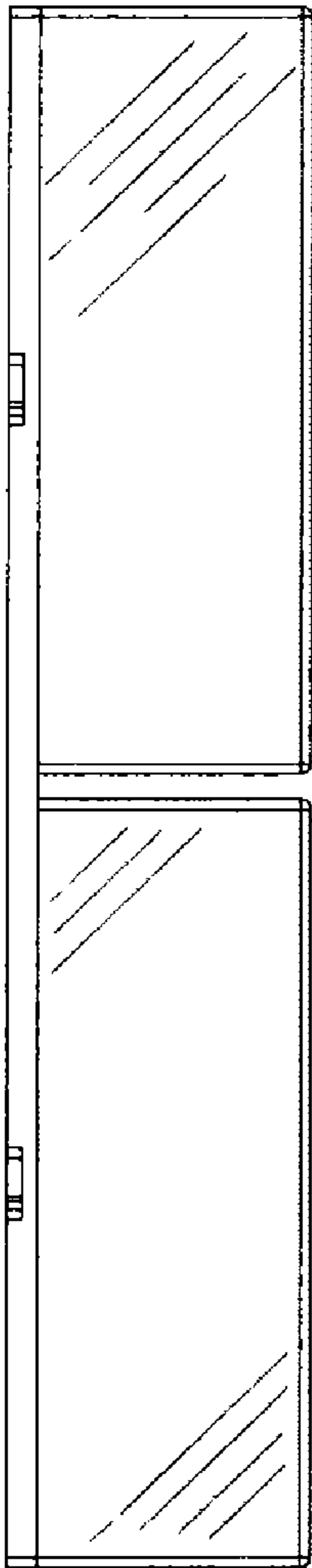

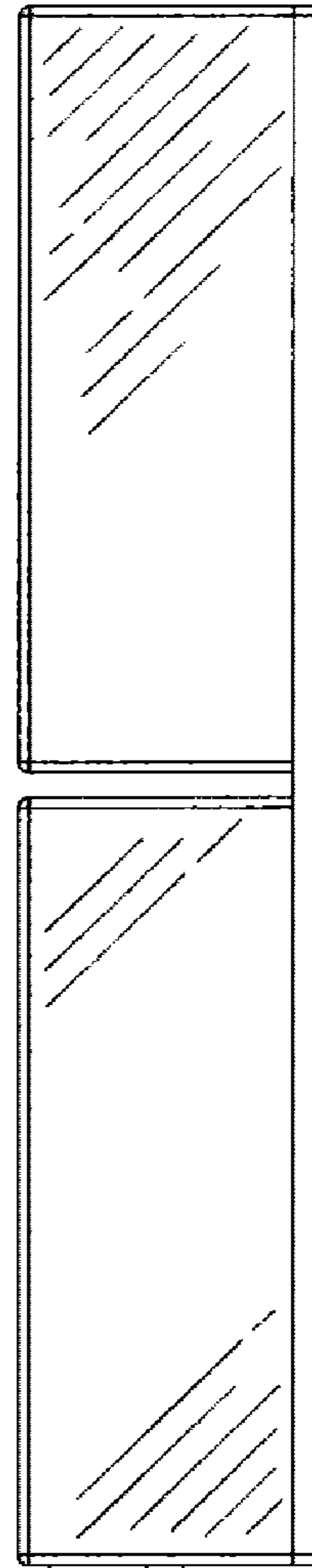

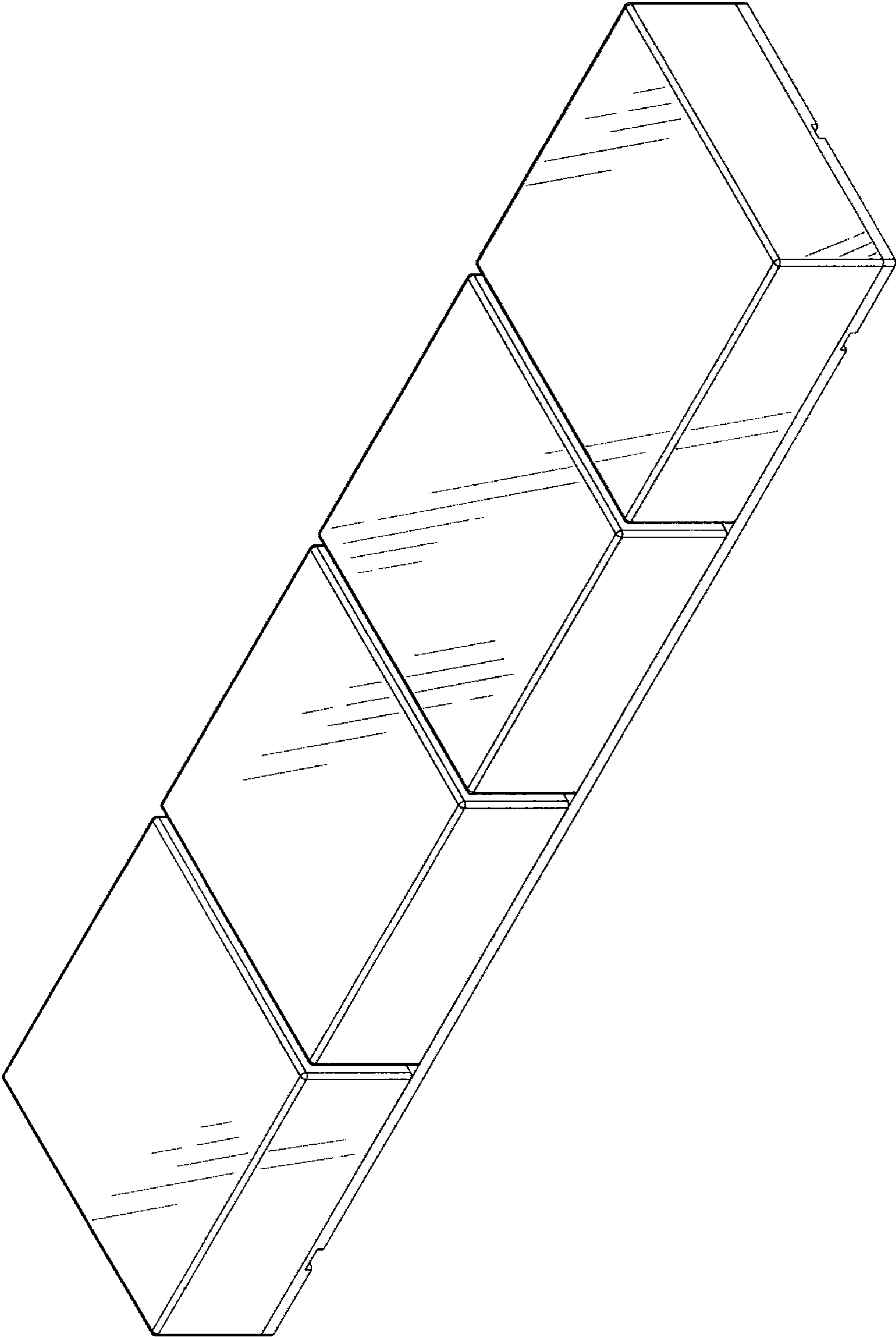

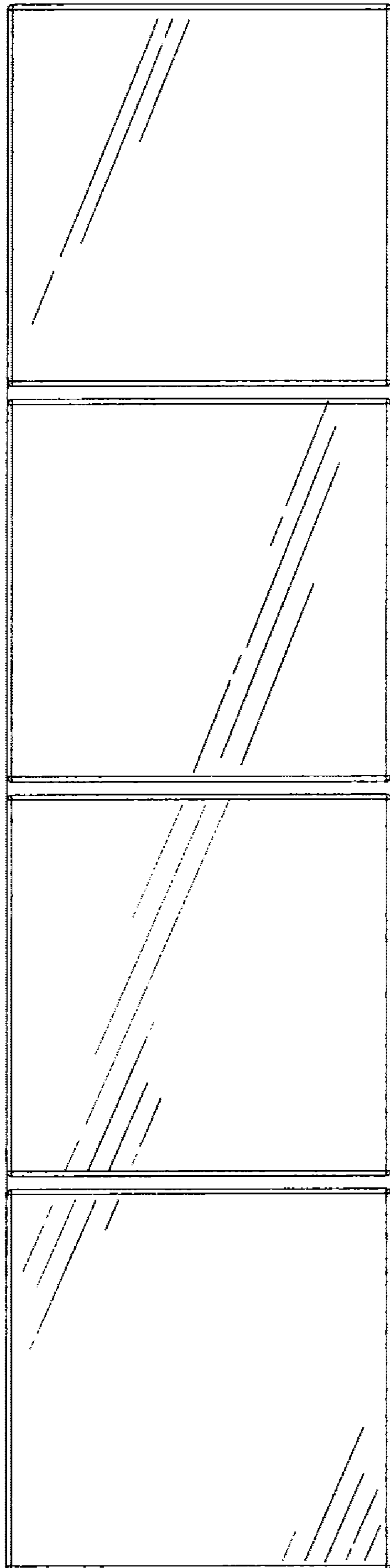

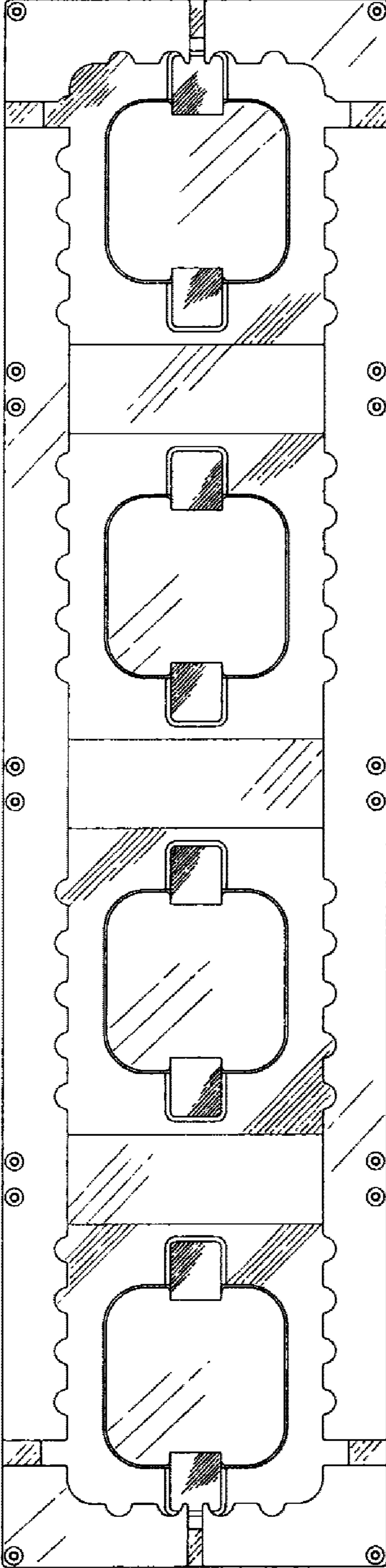

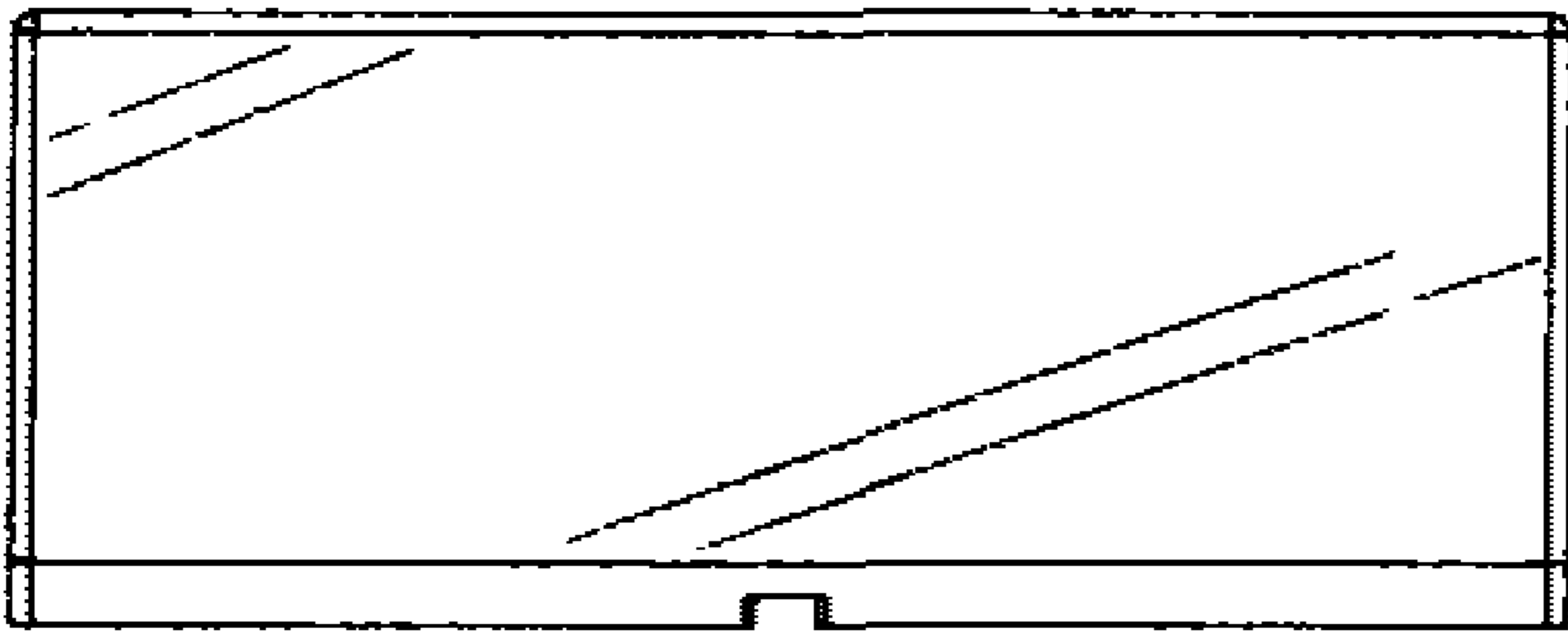

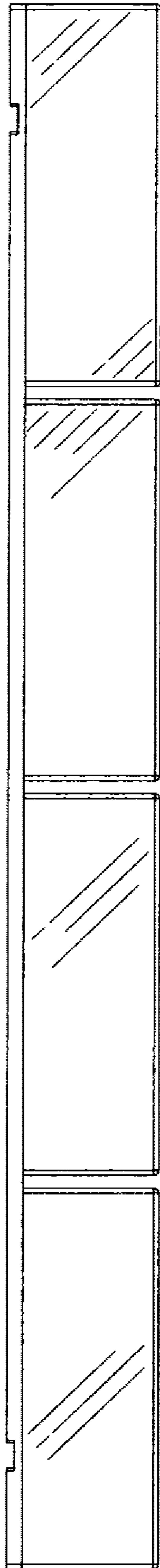
