FIG. 3 is a right side elevation view of a food wrap showing my new design;

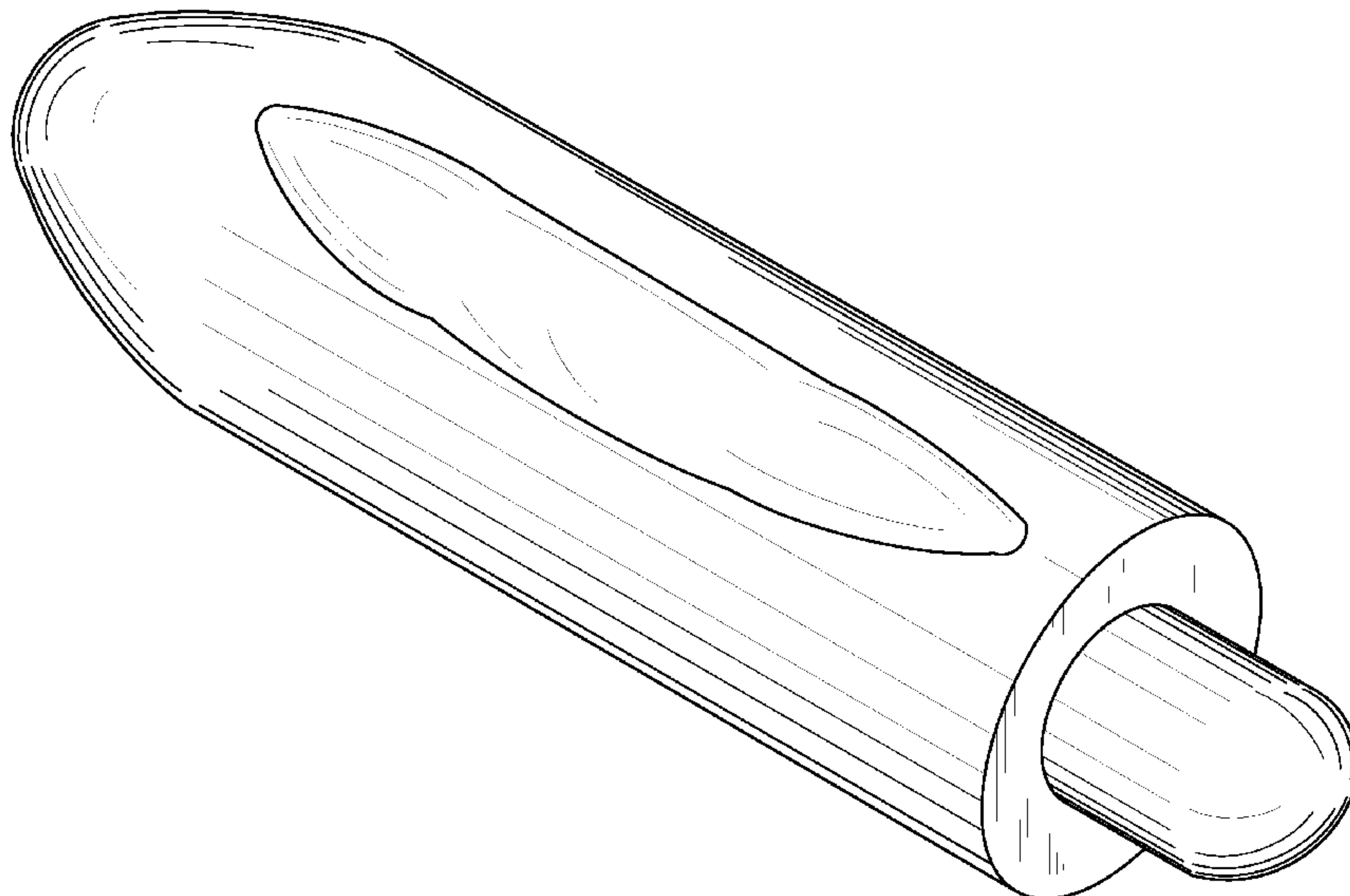
FIG. 4 is a bottom plan view of a food wrap showing my my new design;

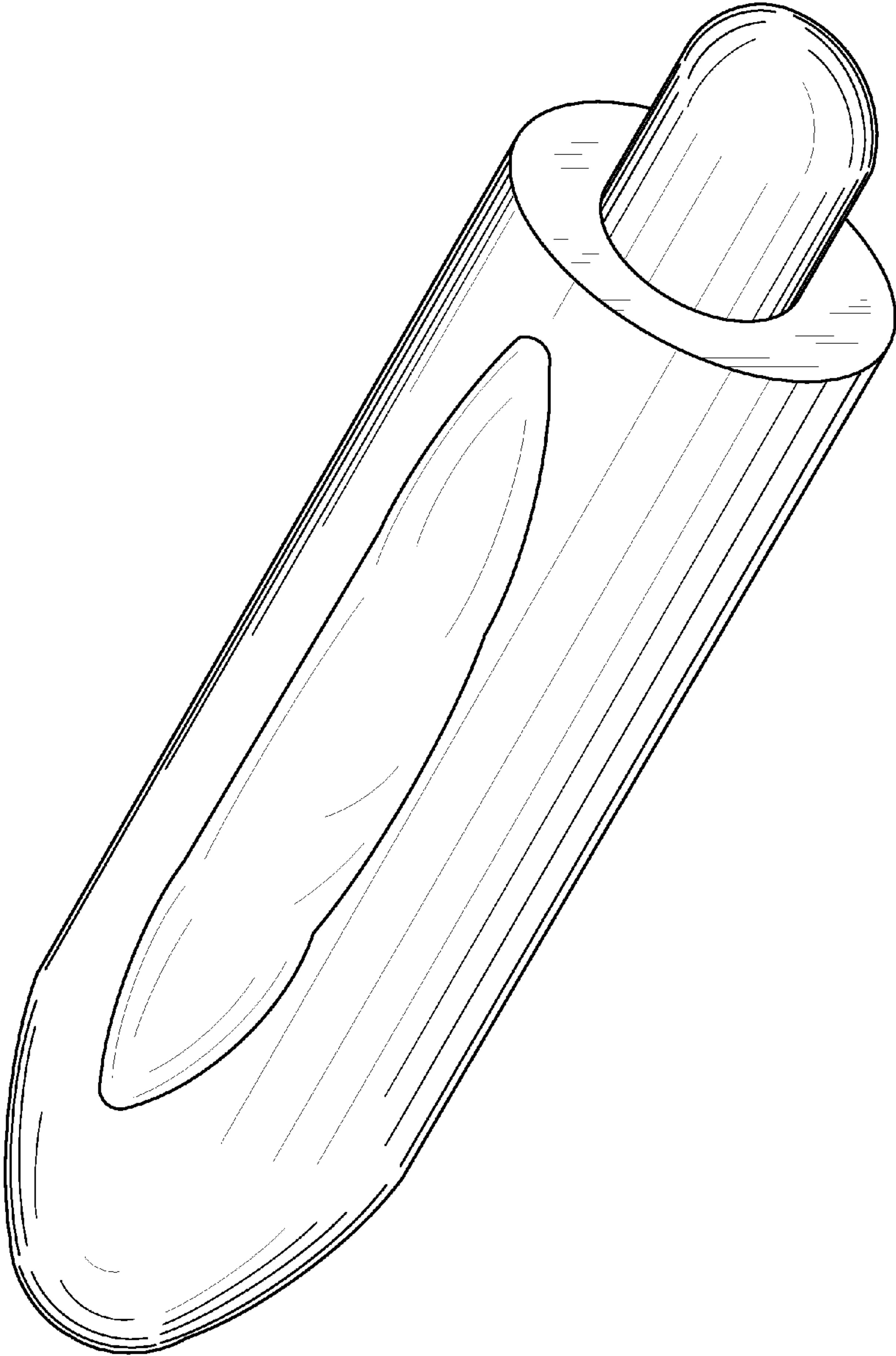

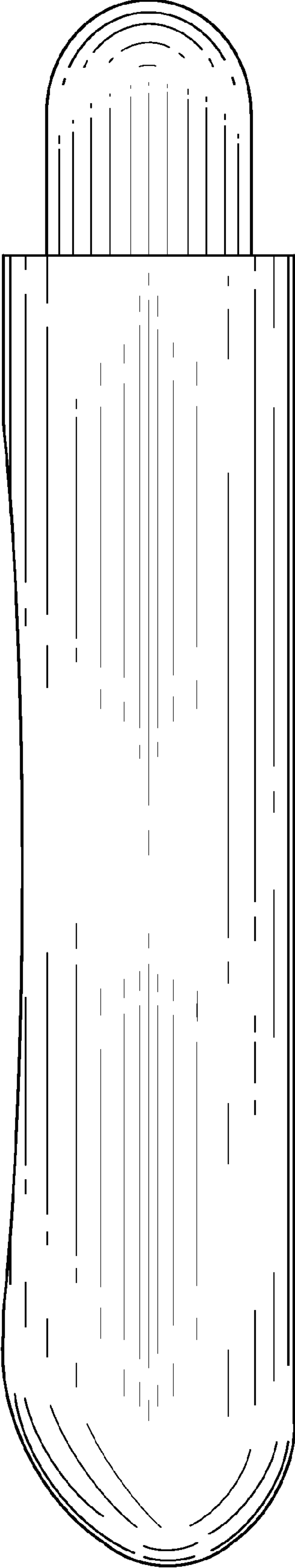

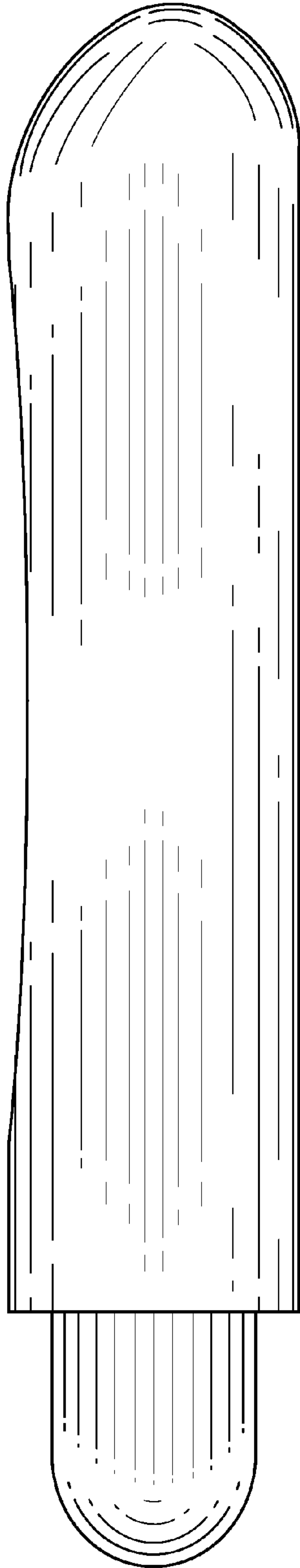

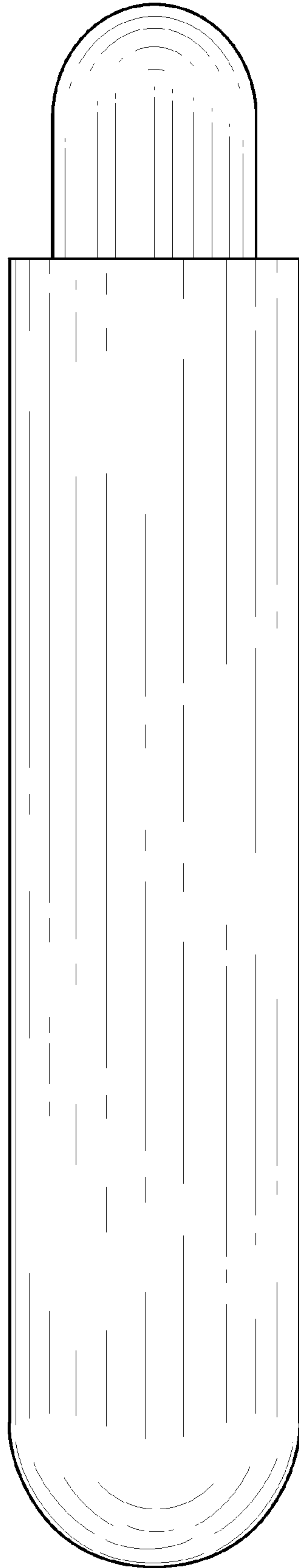

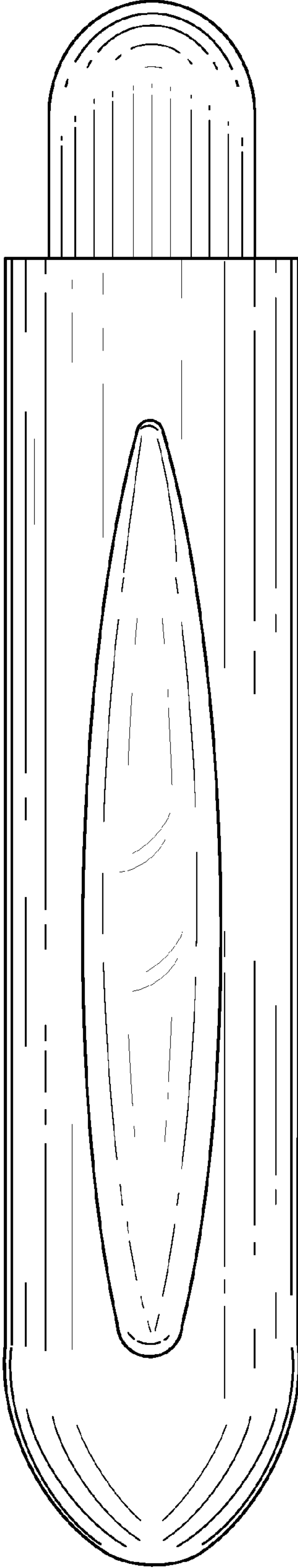

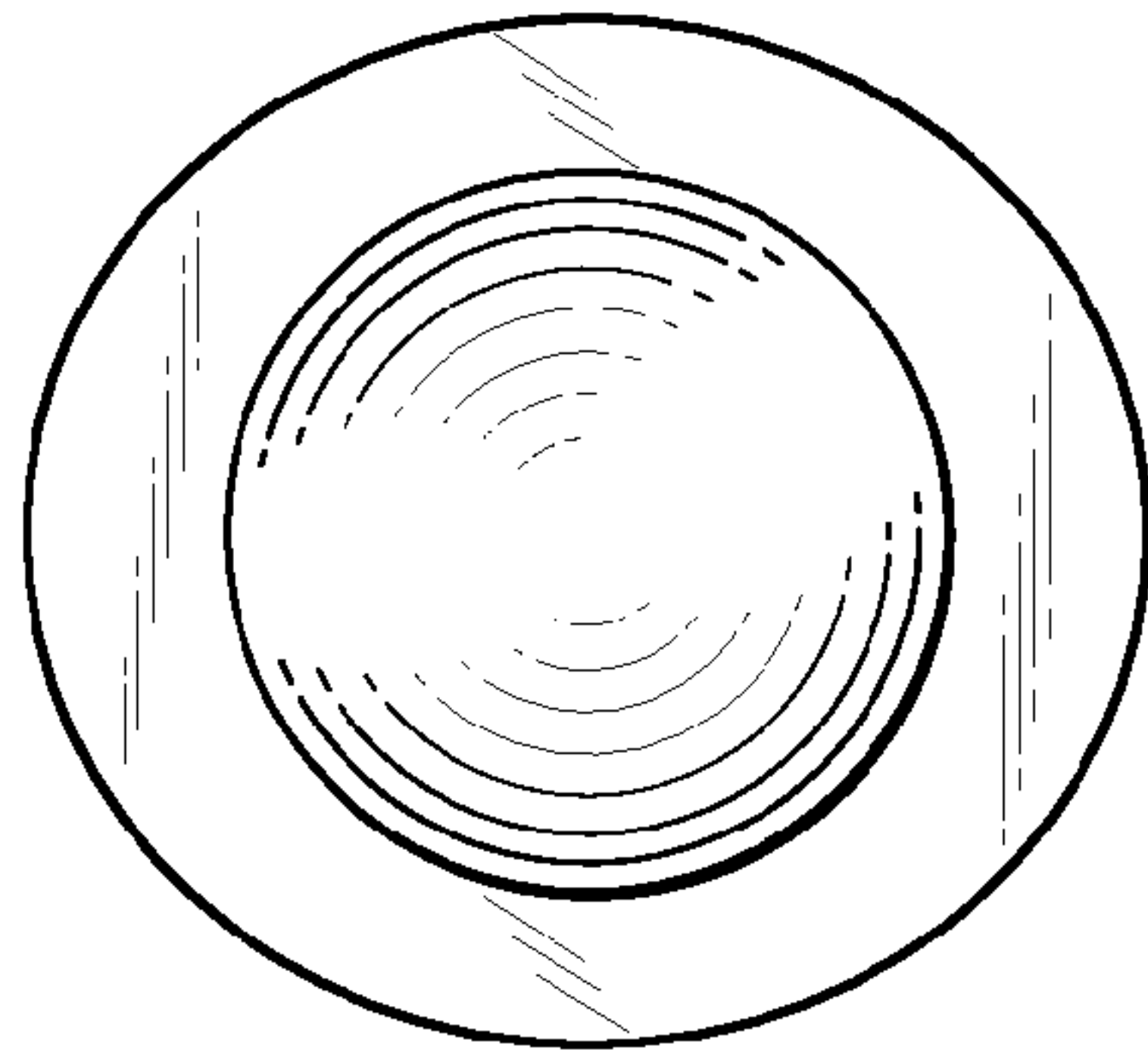

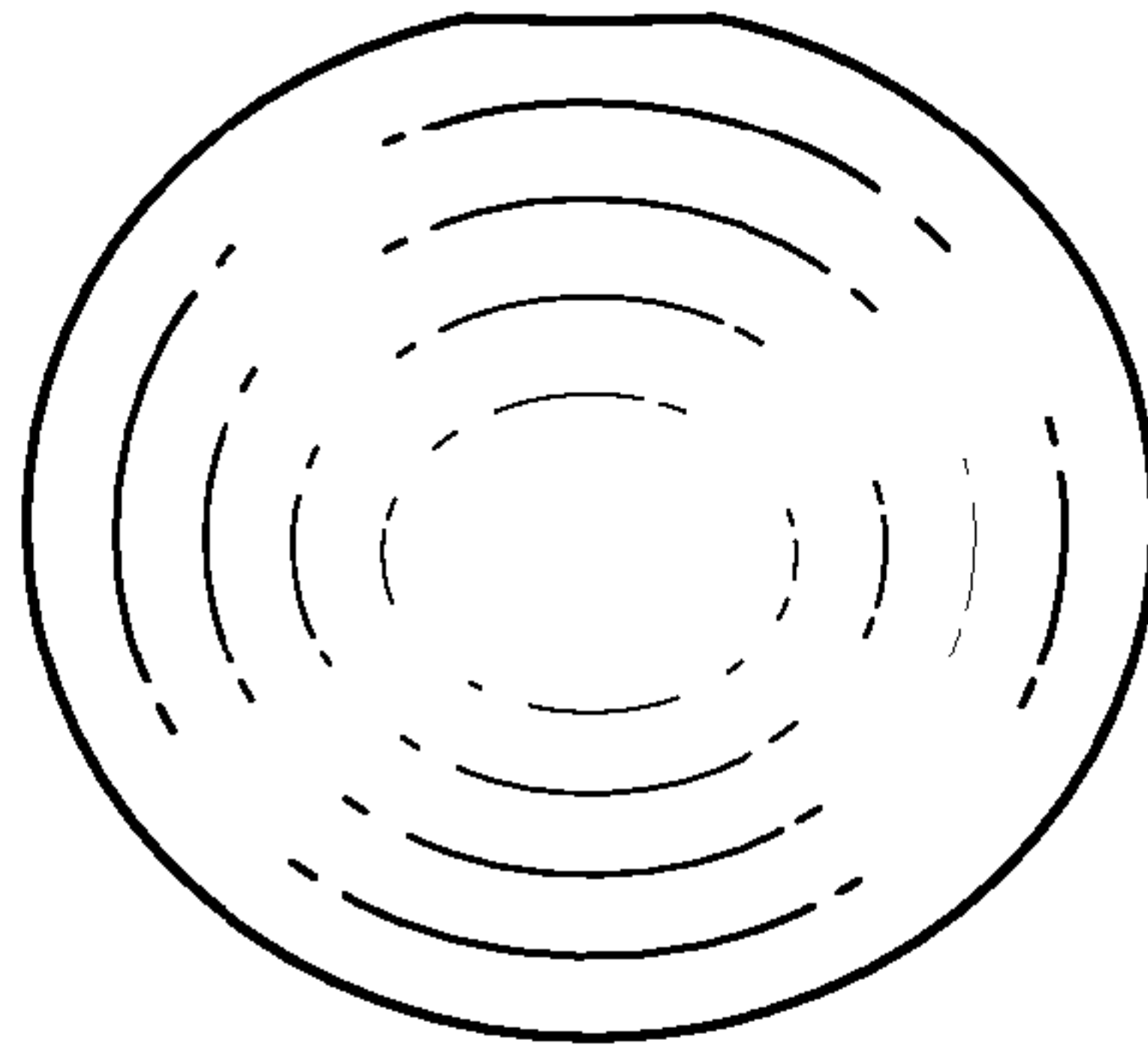
