**DESCRIPTION**

FIG. 27 is a right side elevational view thereof; and

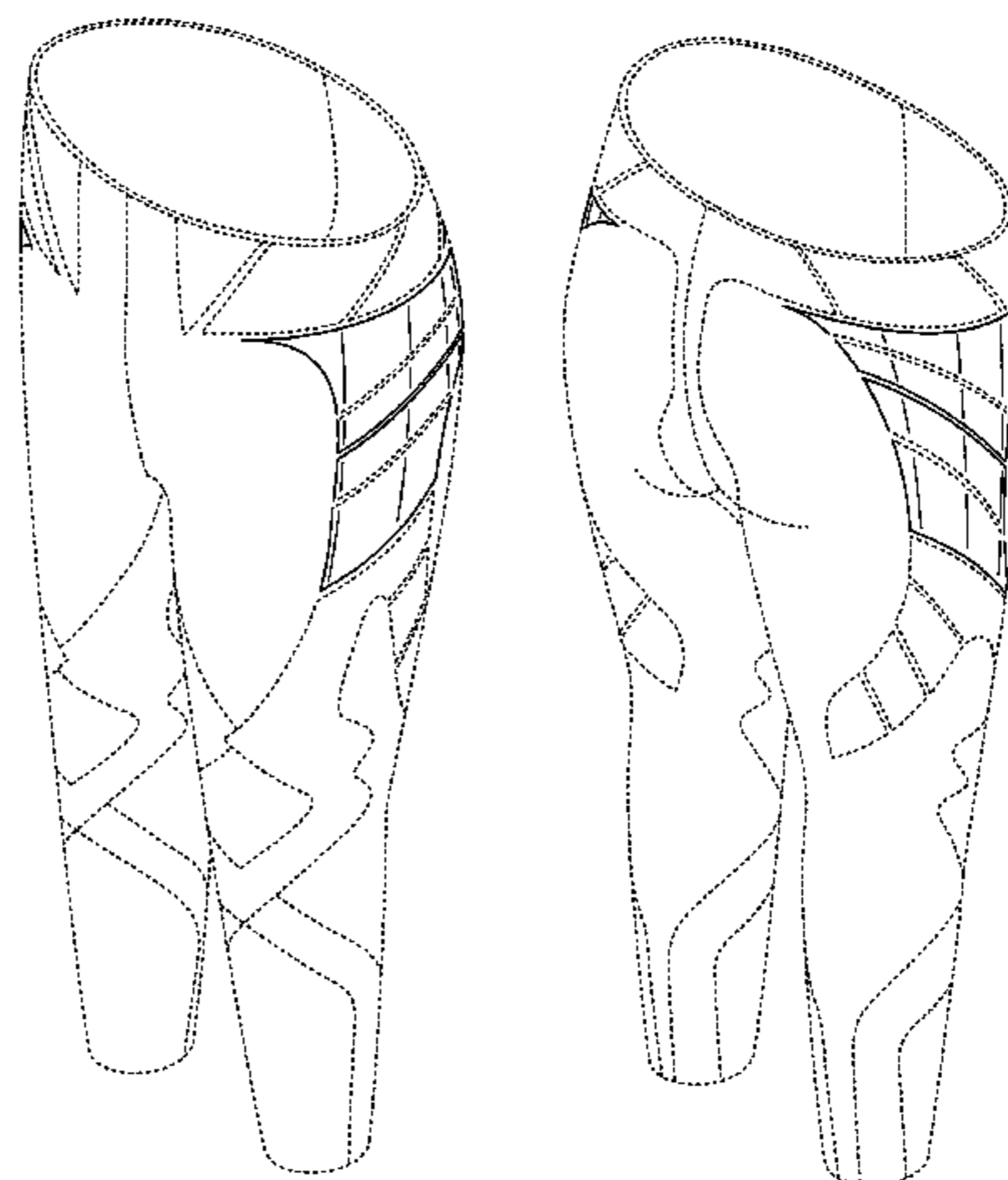
FIG. 28 is a left side elevational view thereof.

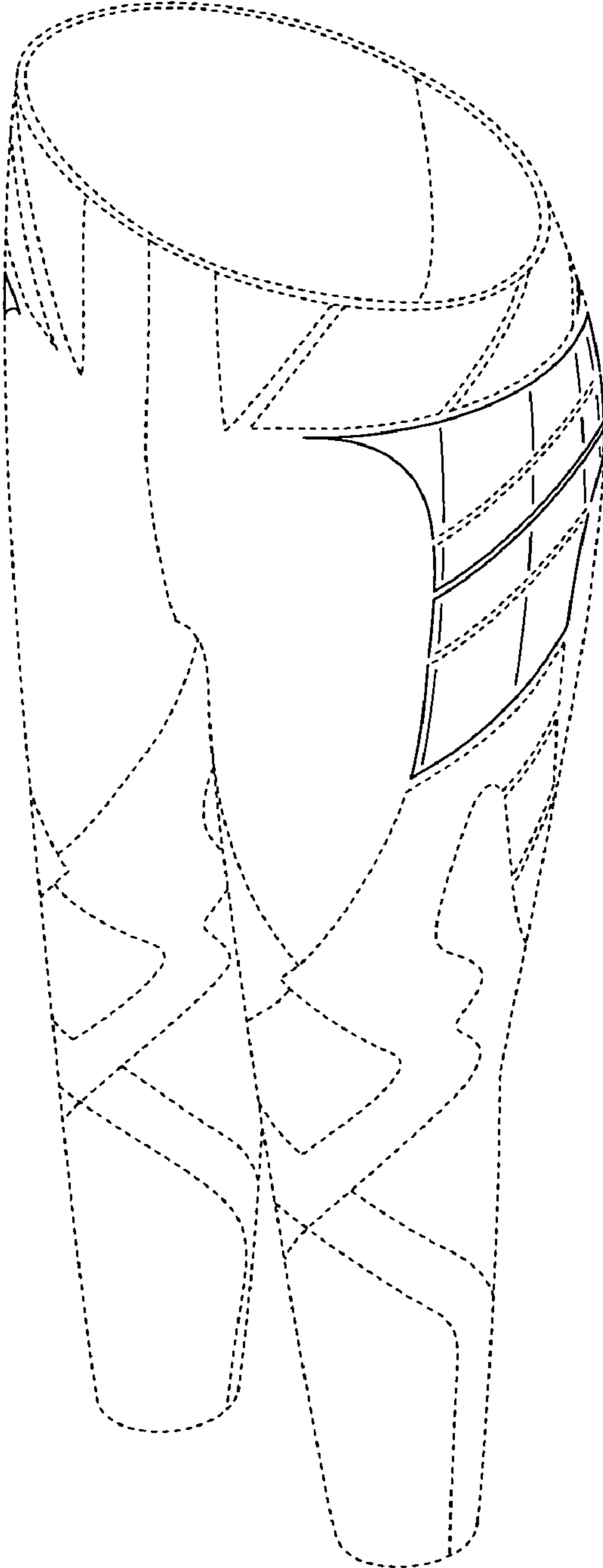

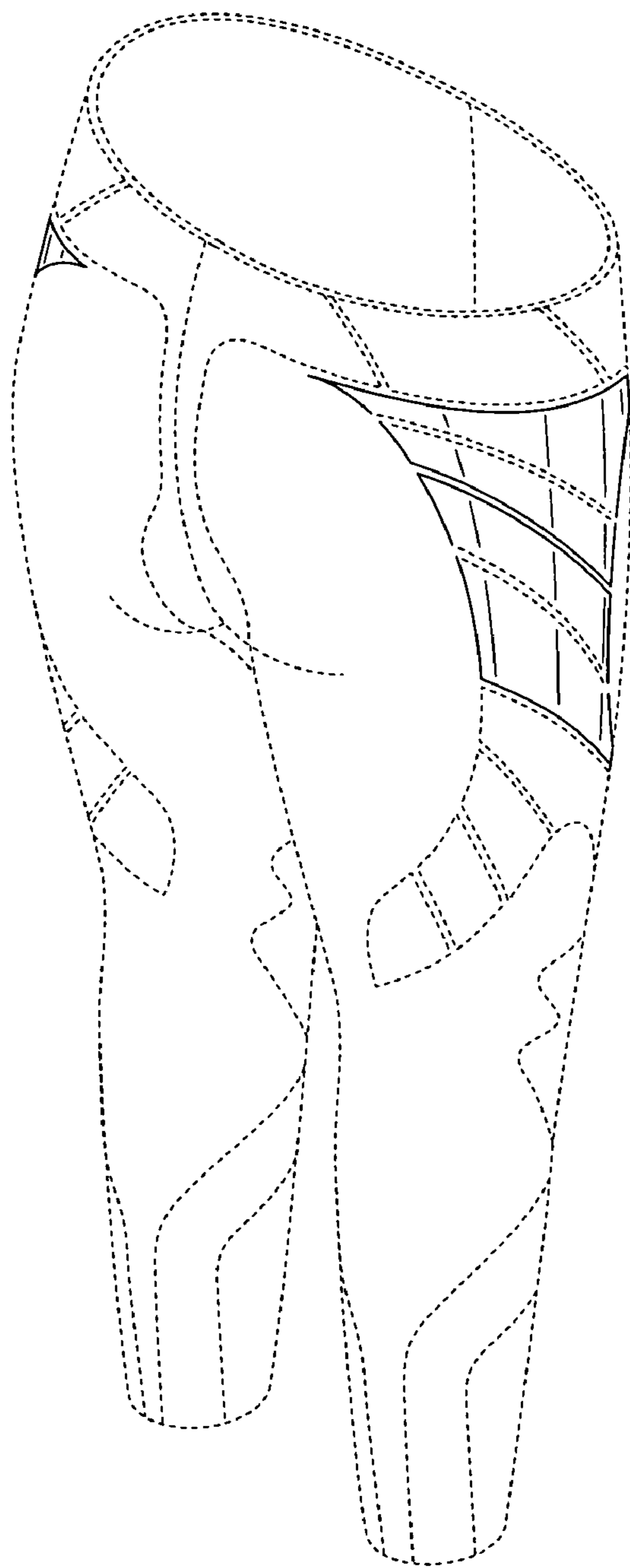

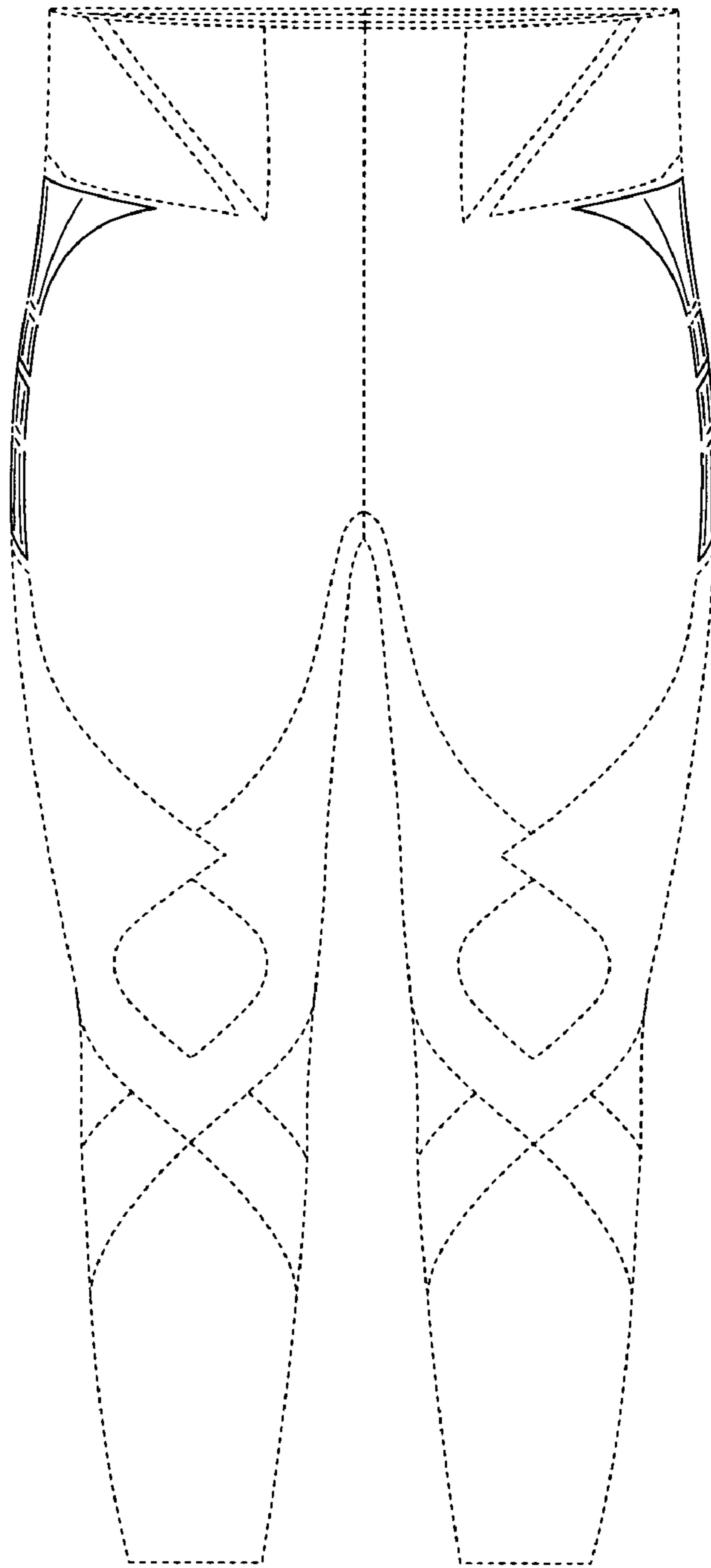

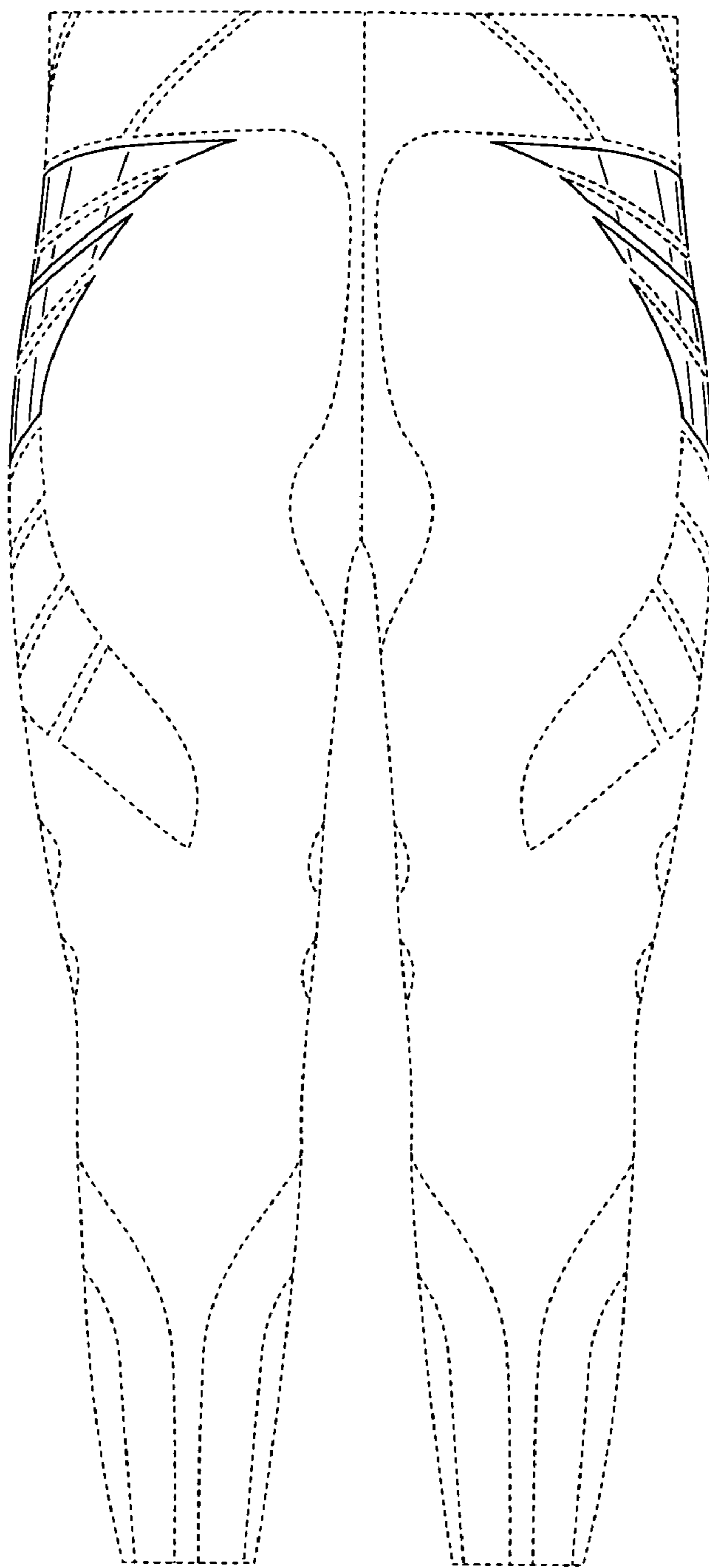
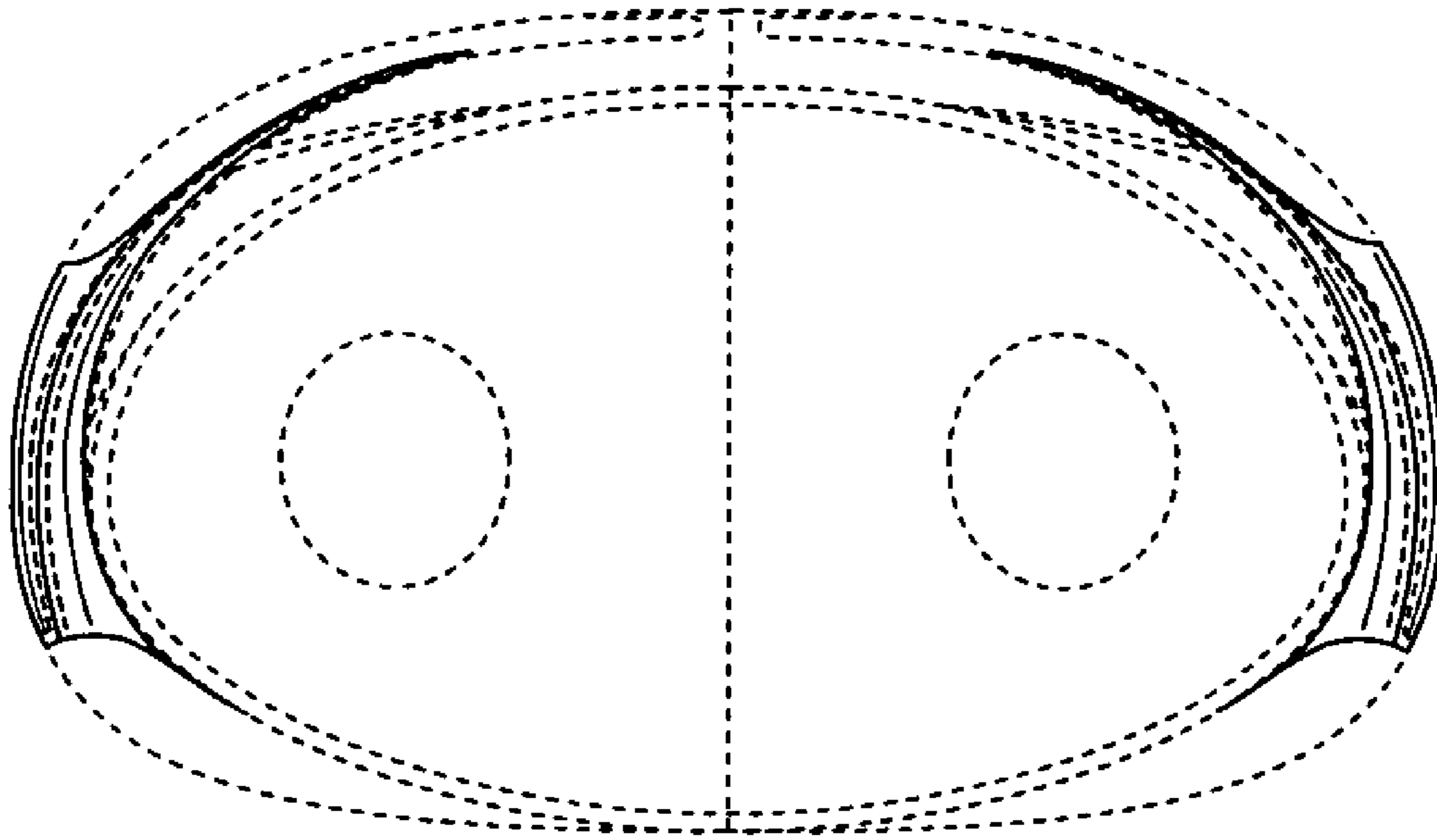
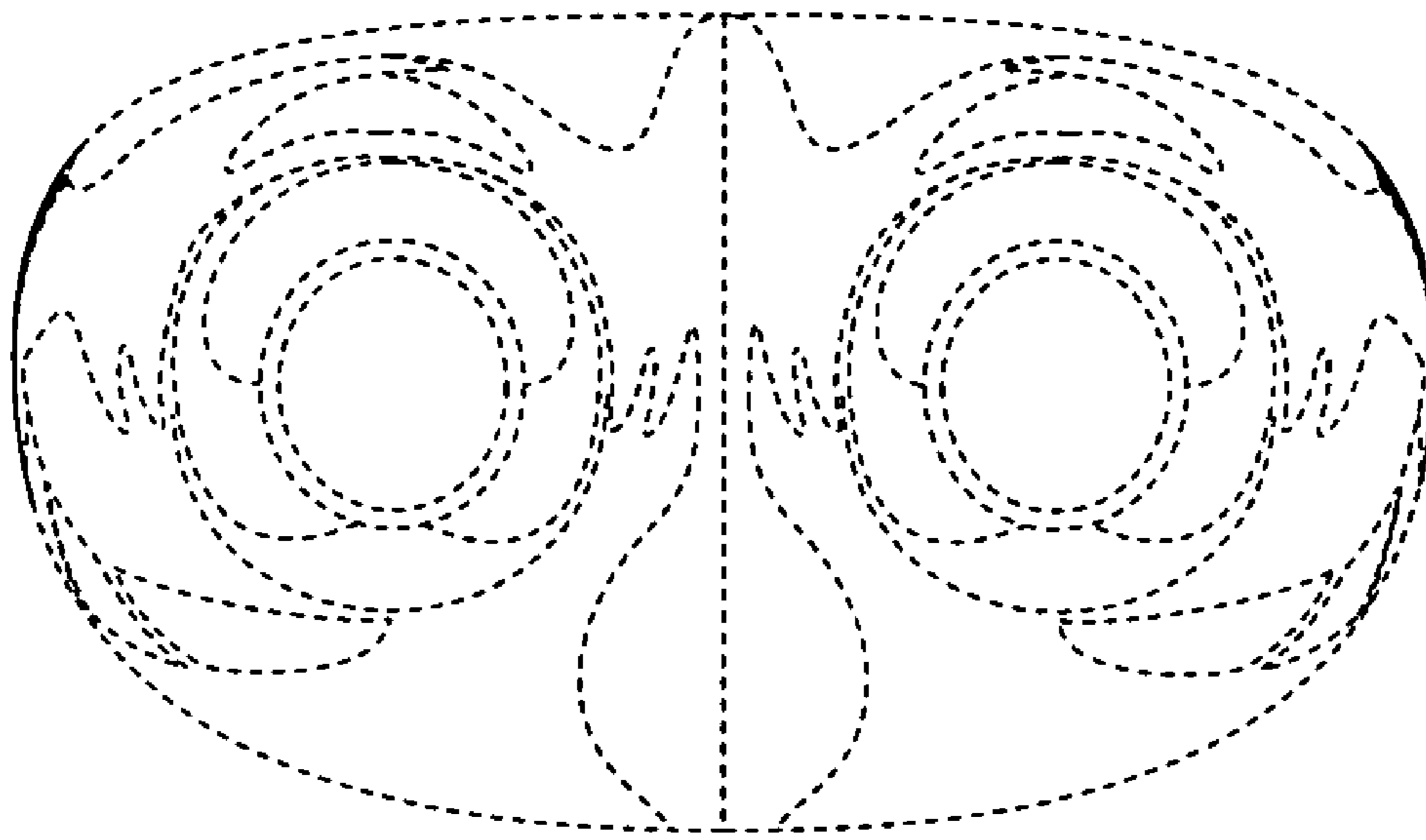

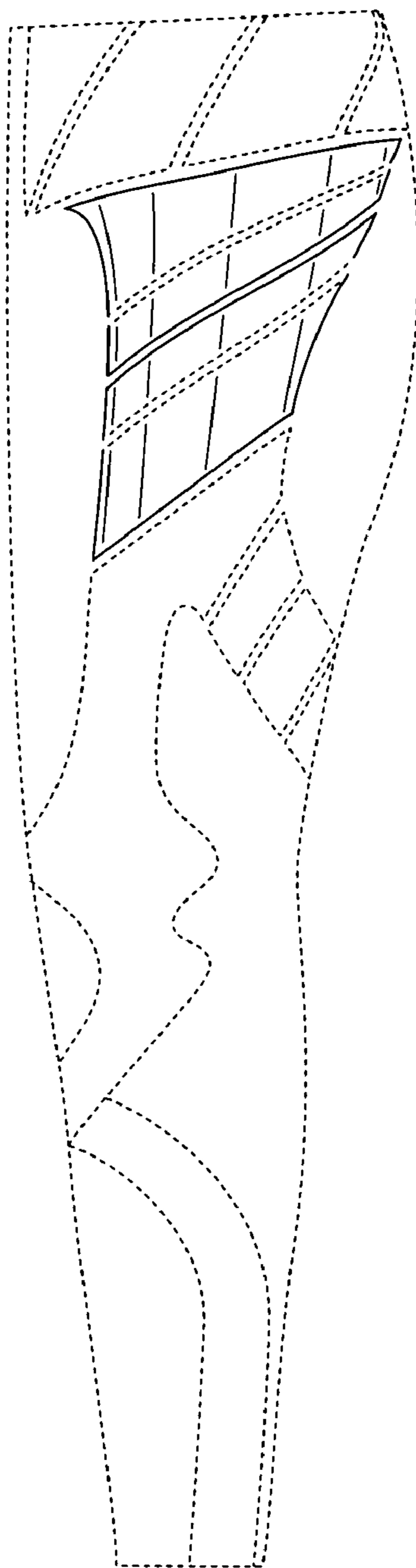

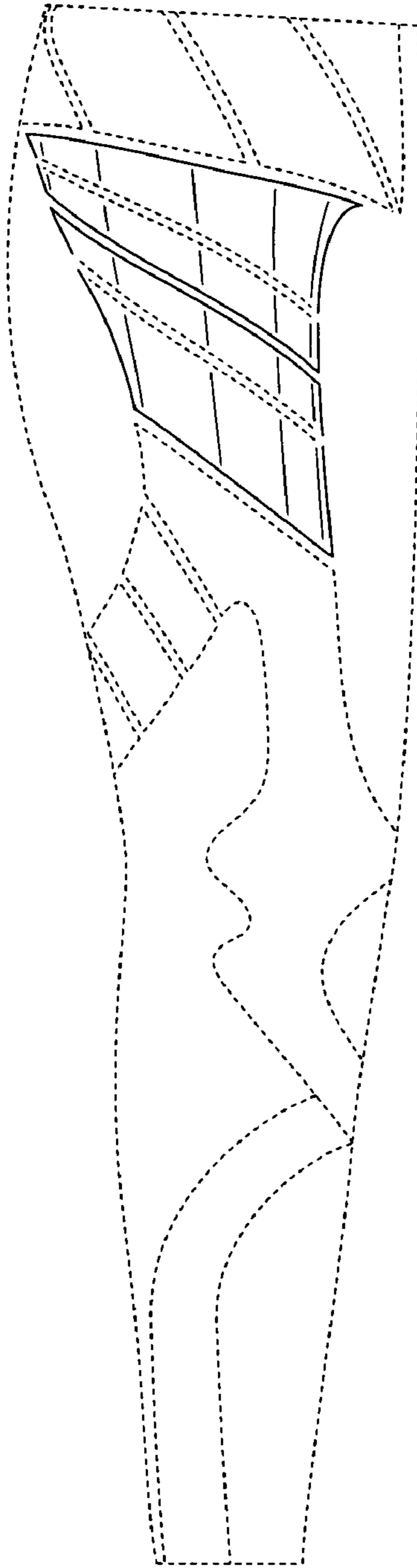

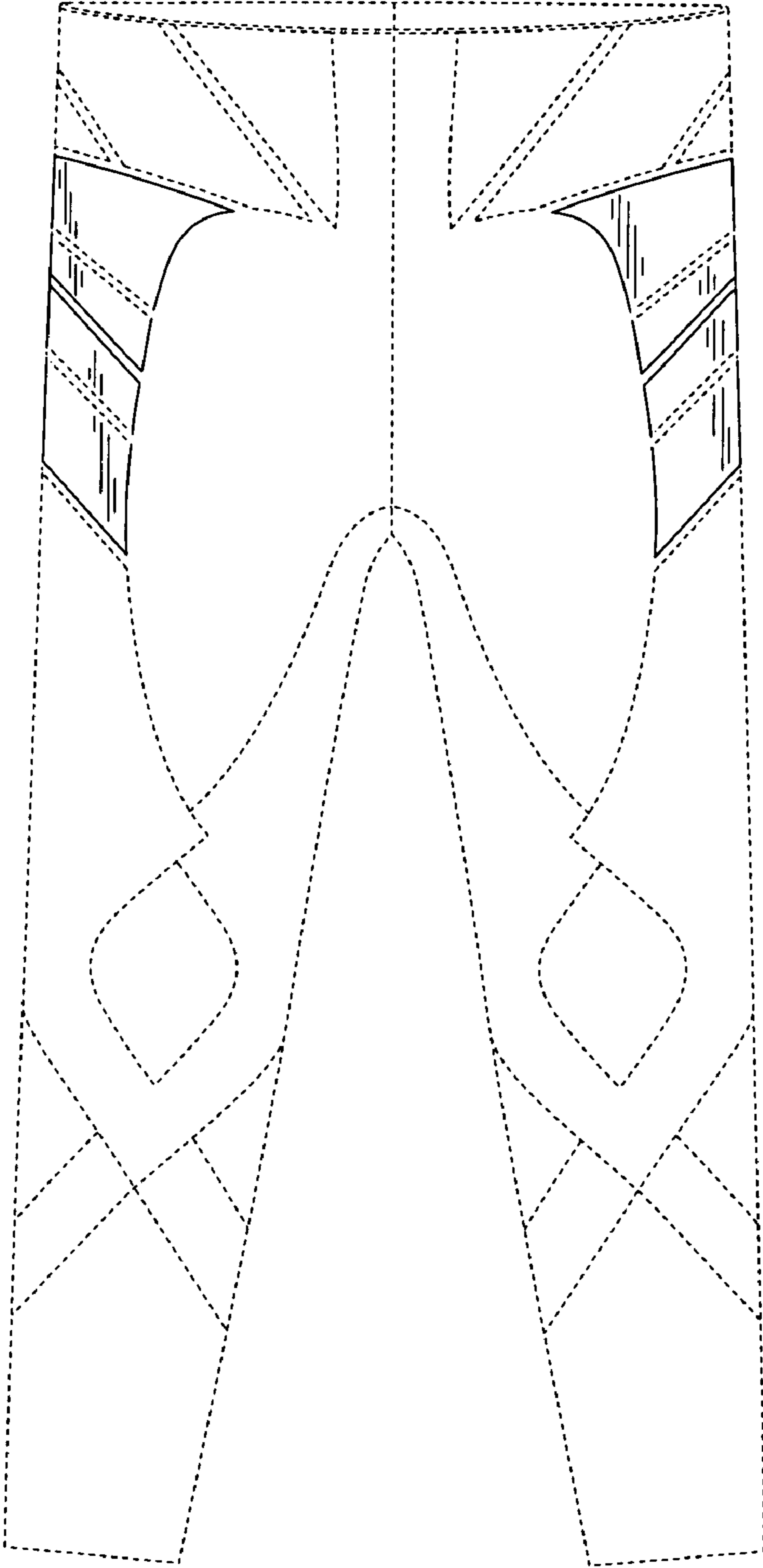

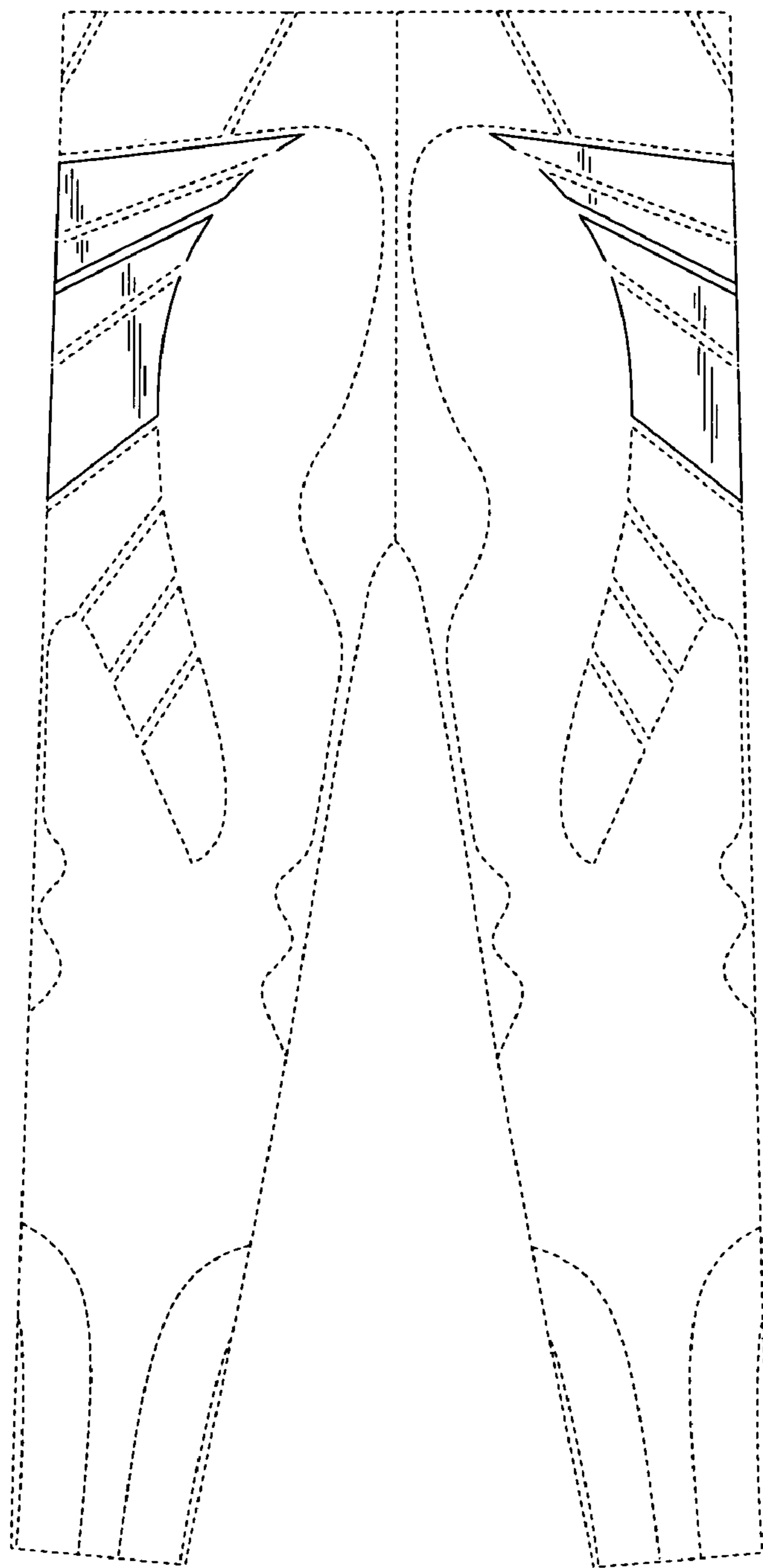
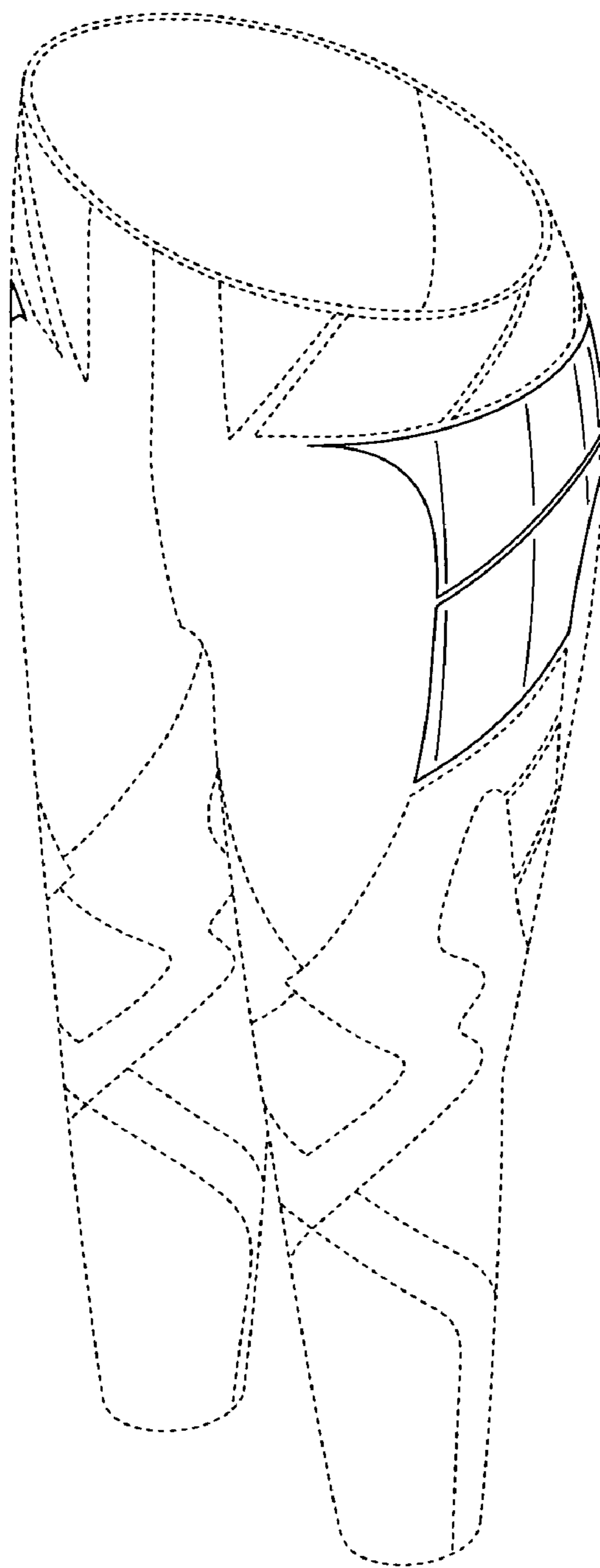


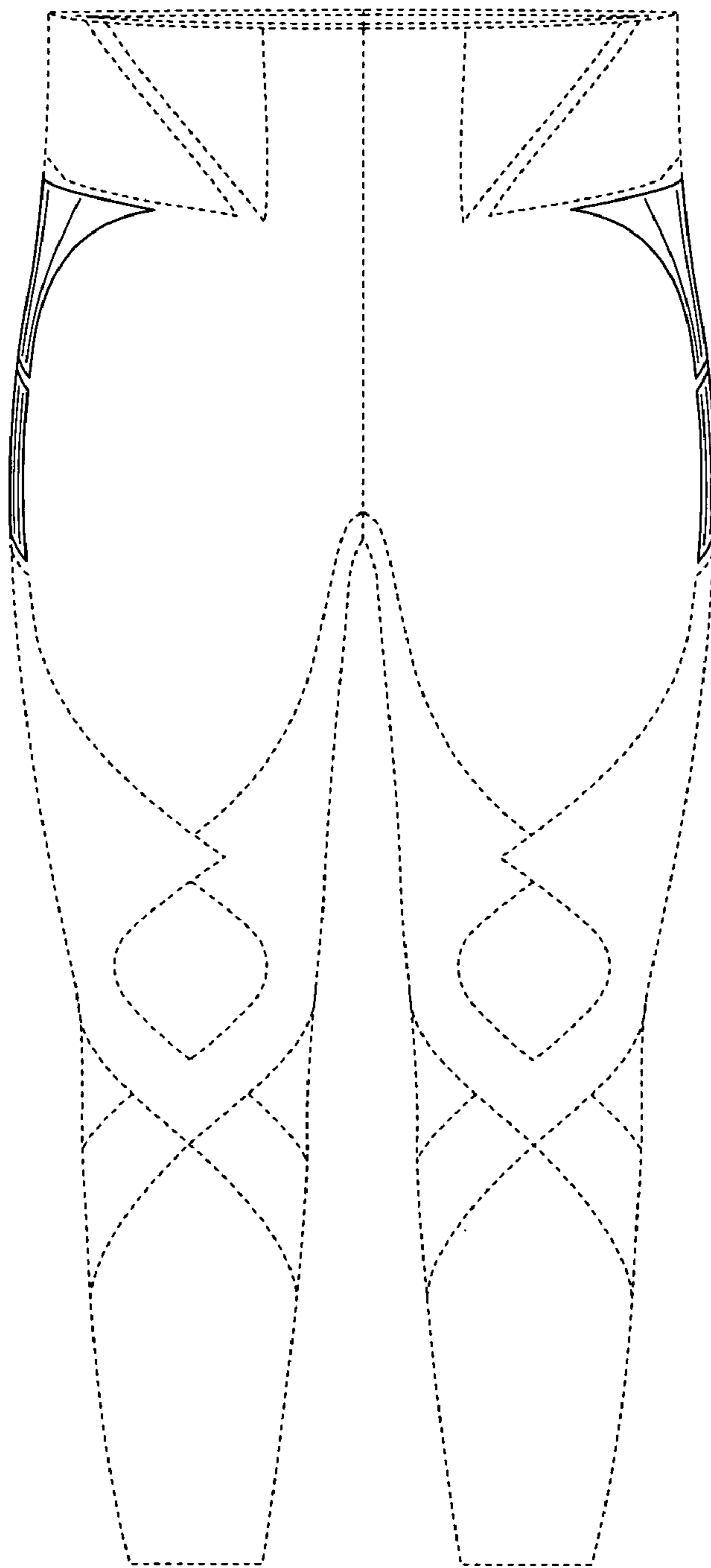

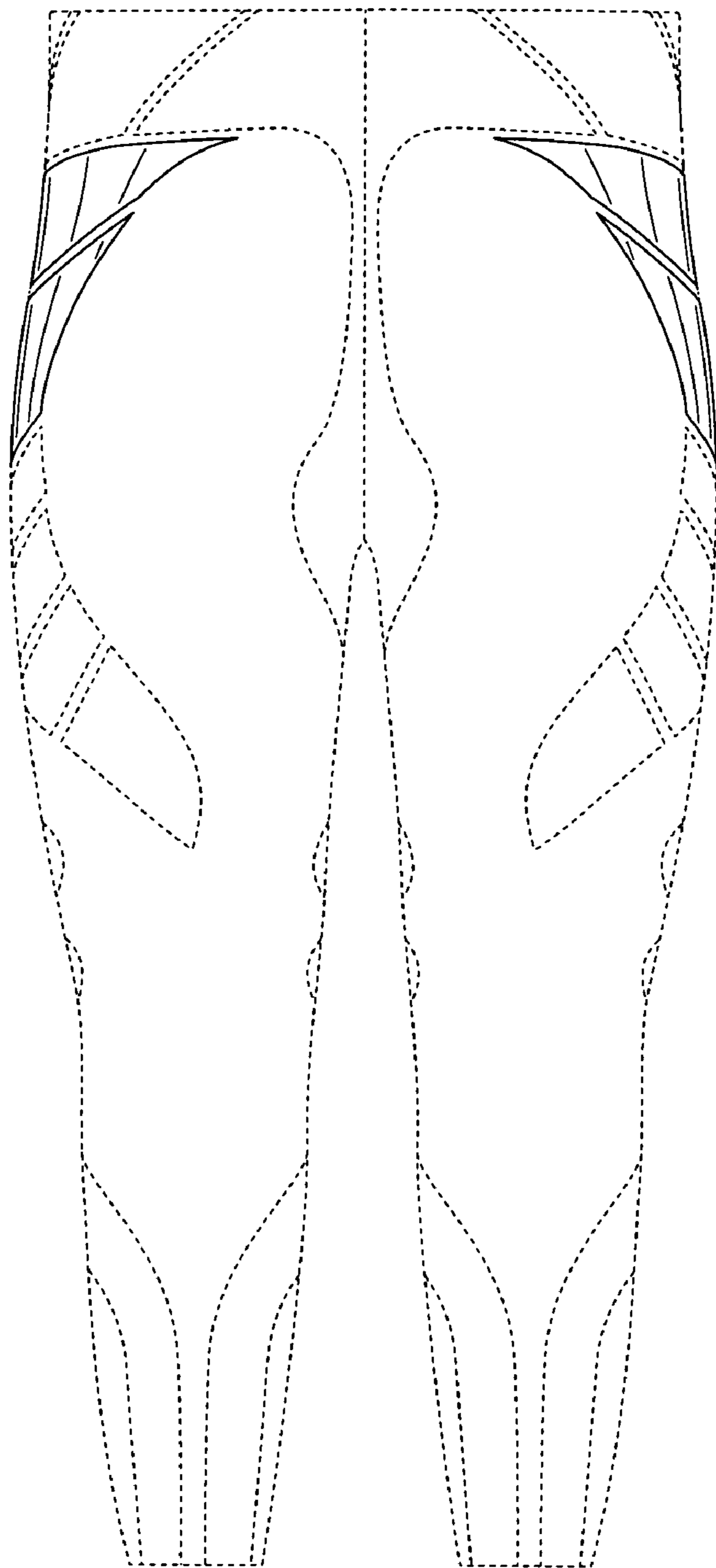

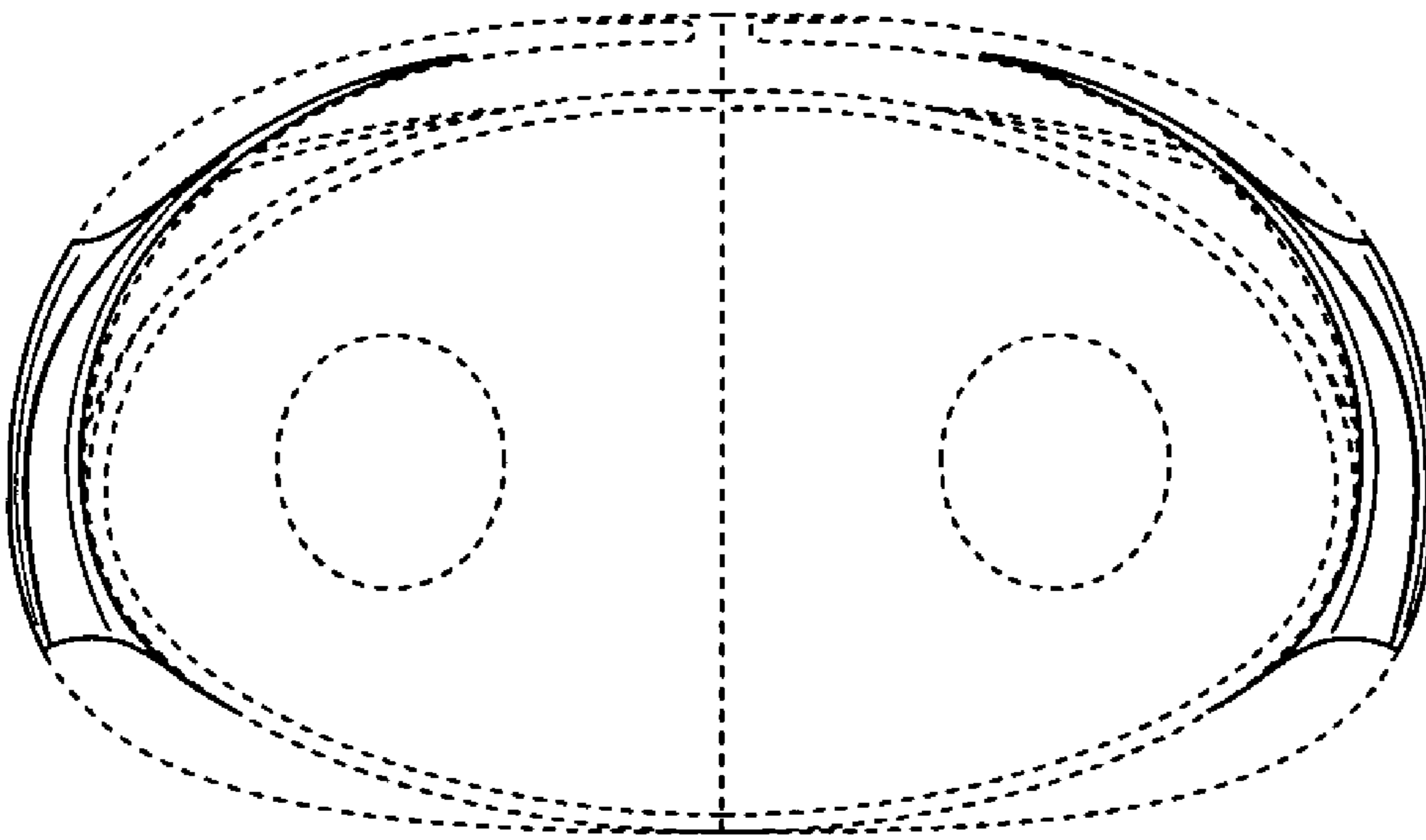

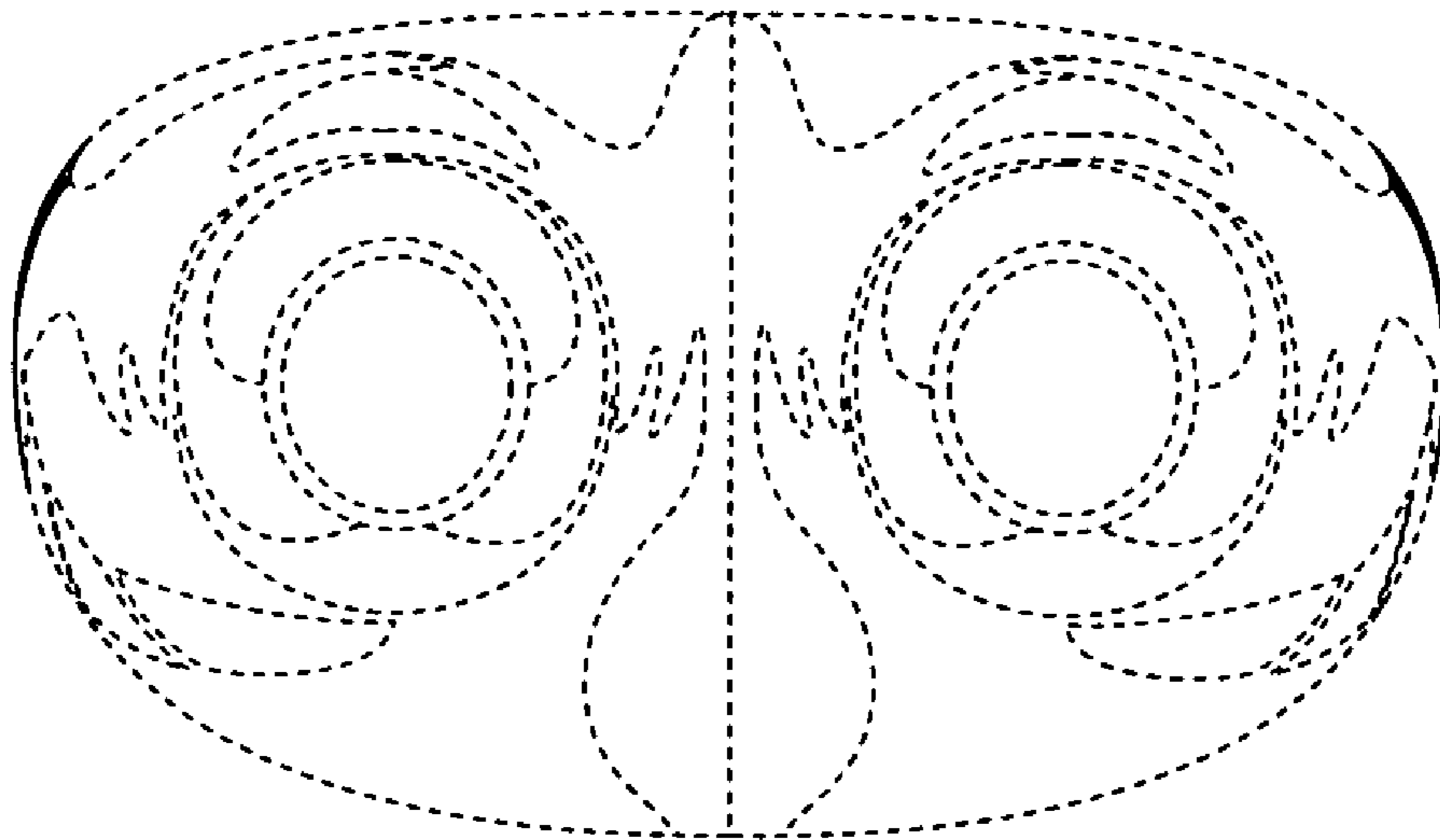

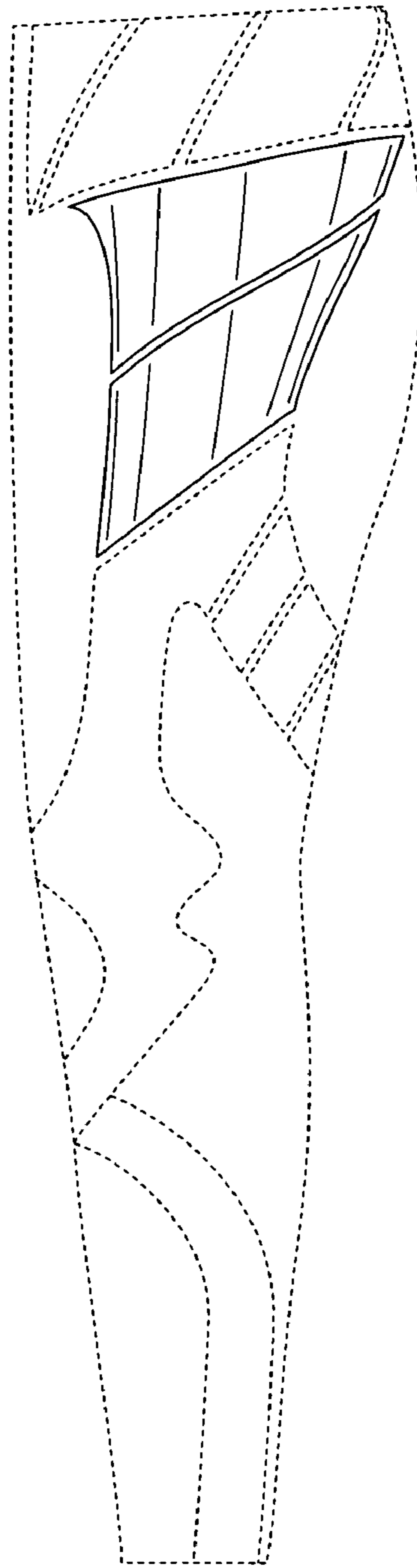

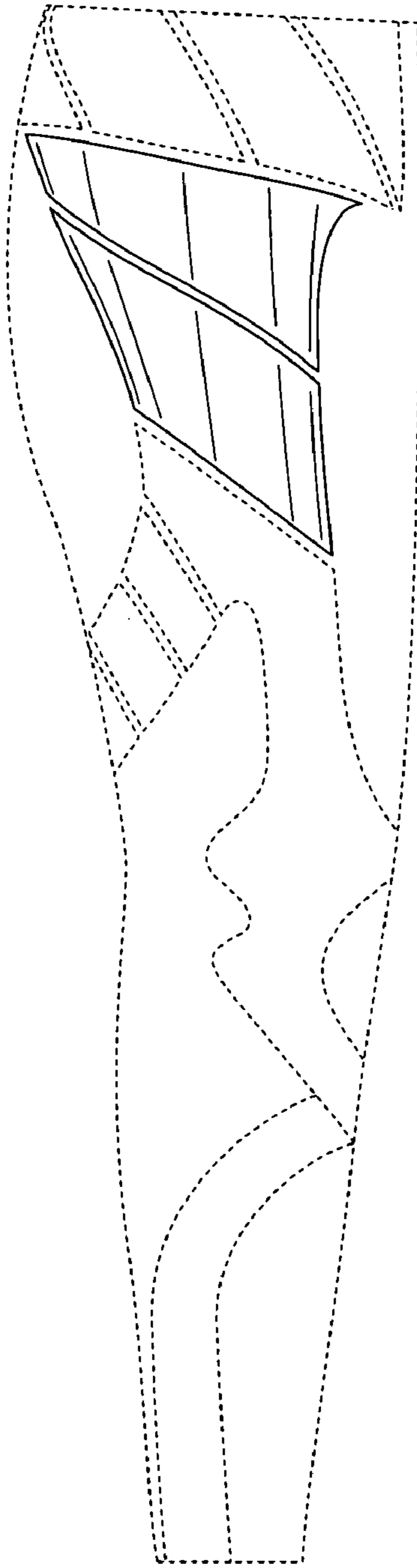

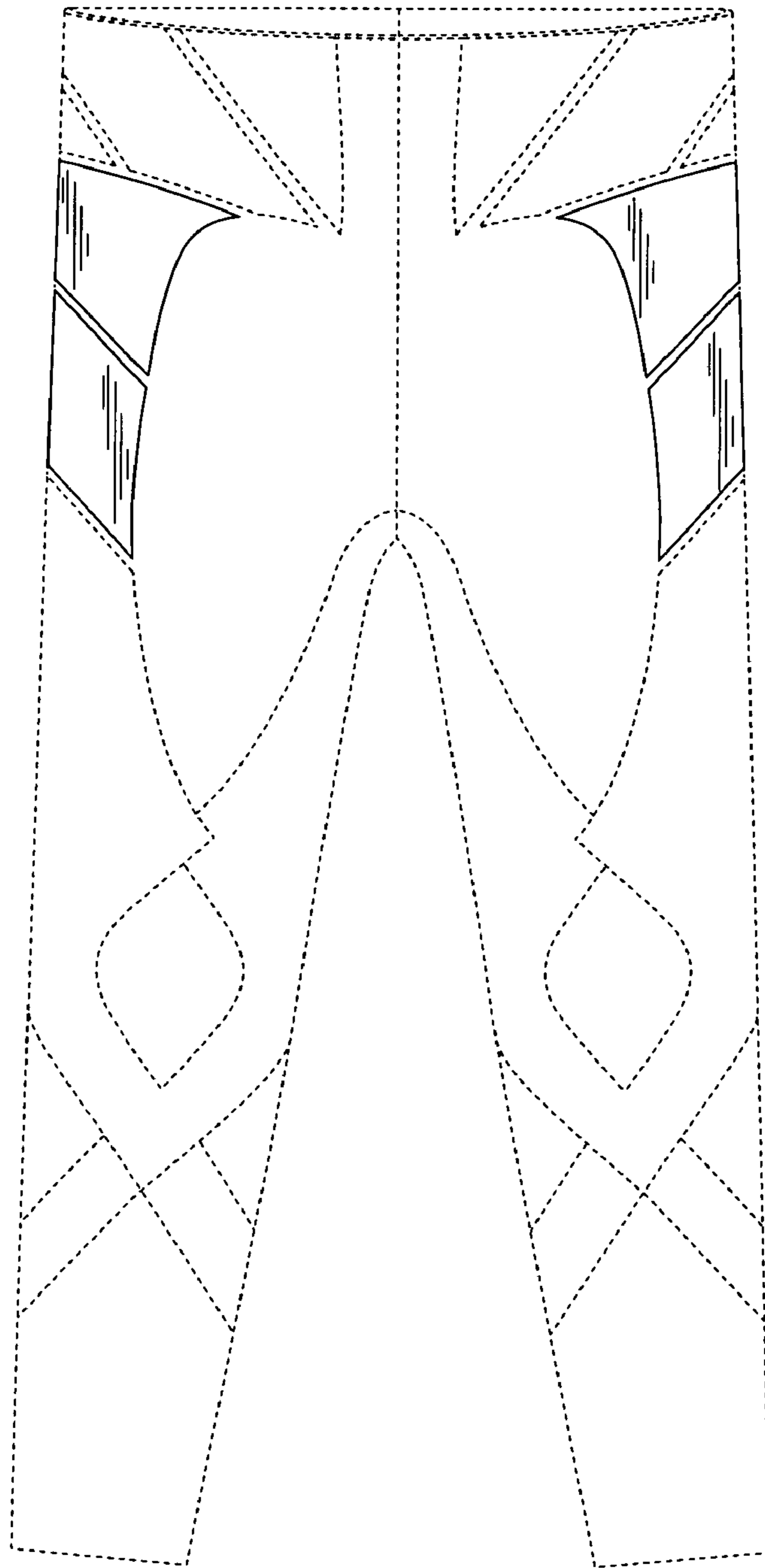

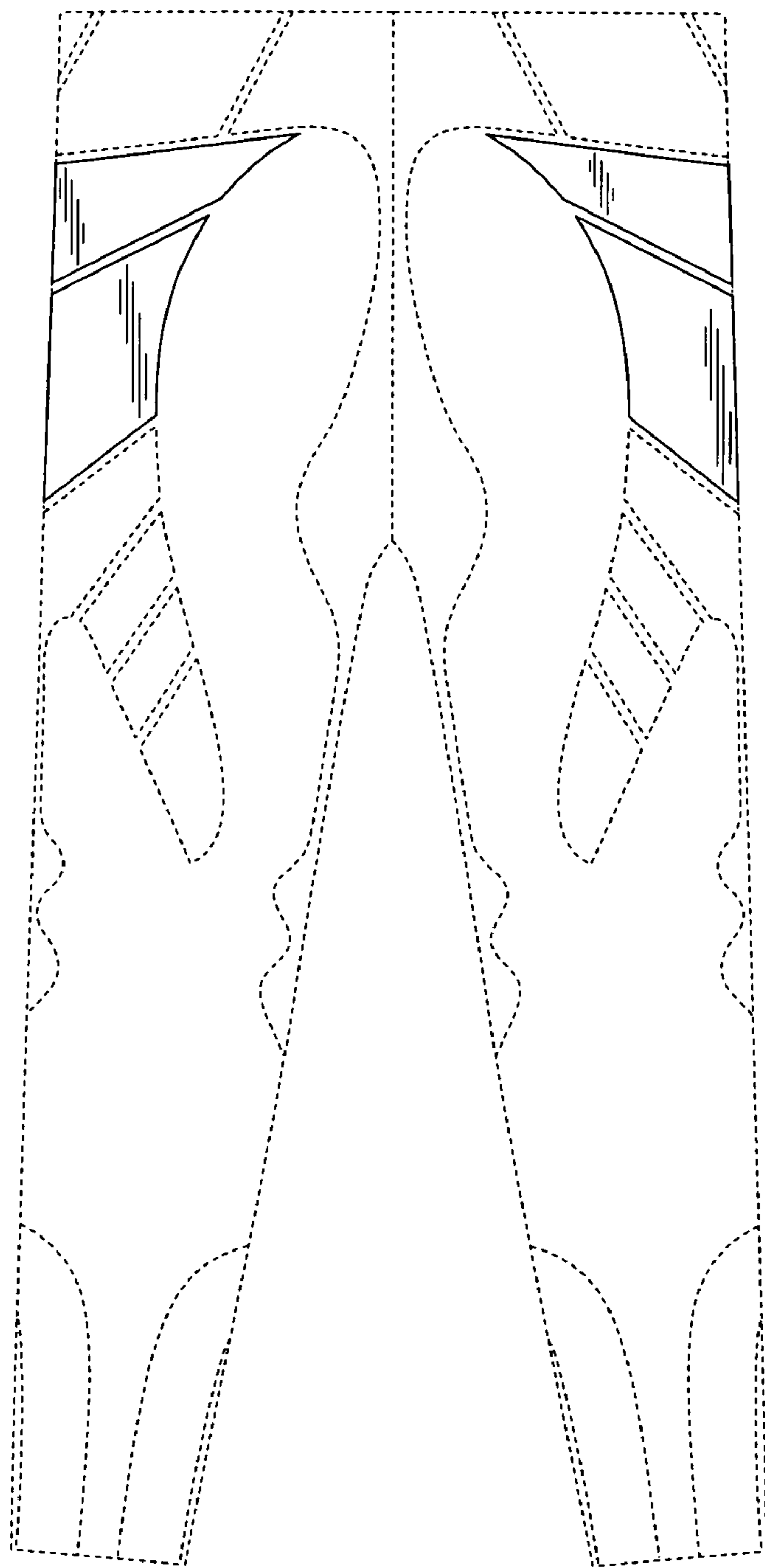

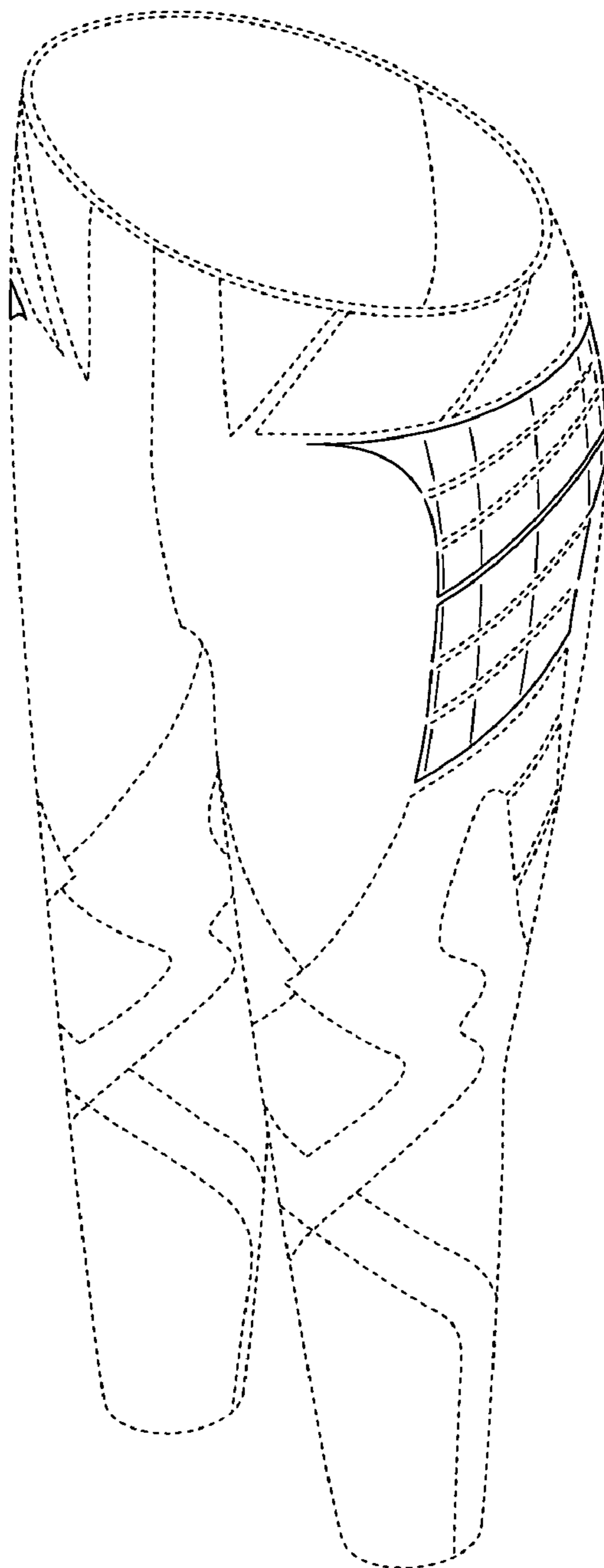

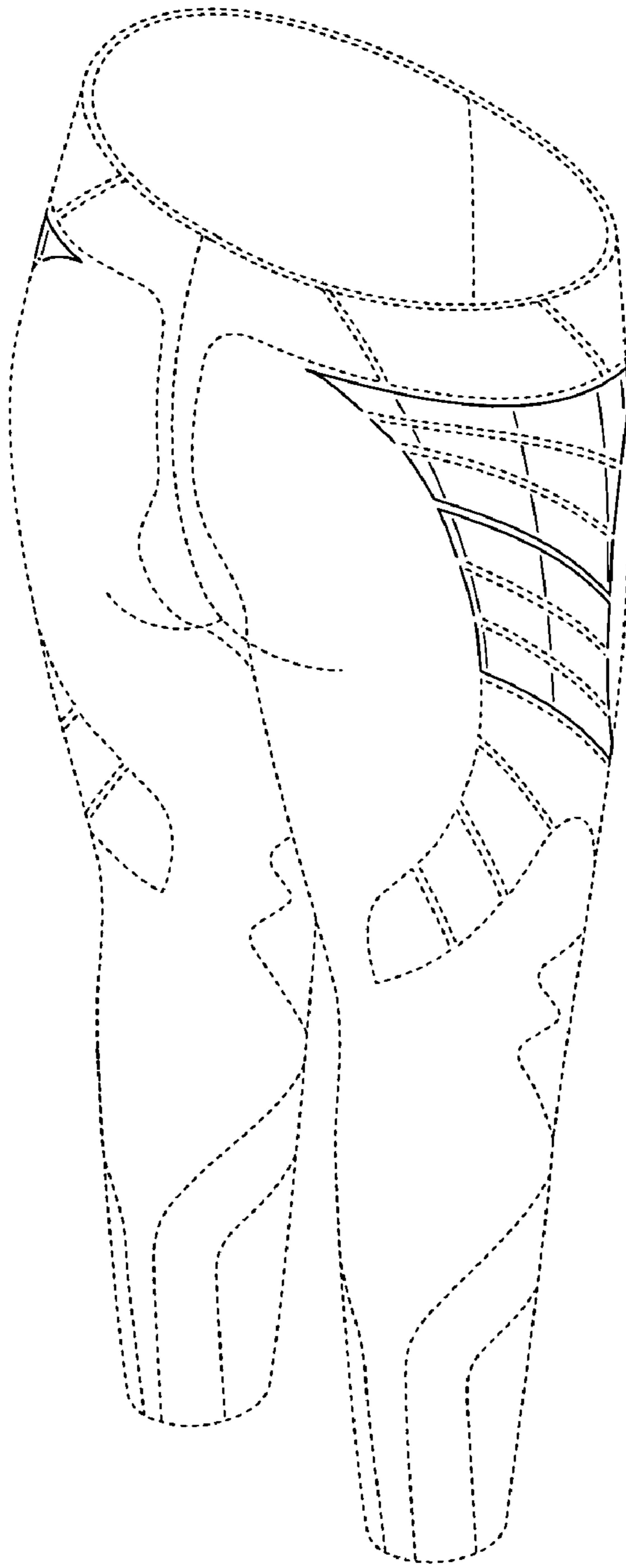

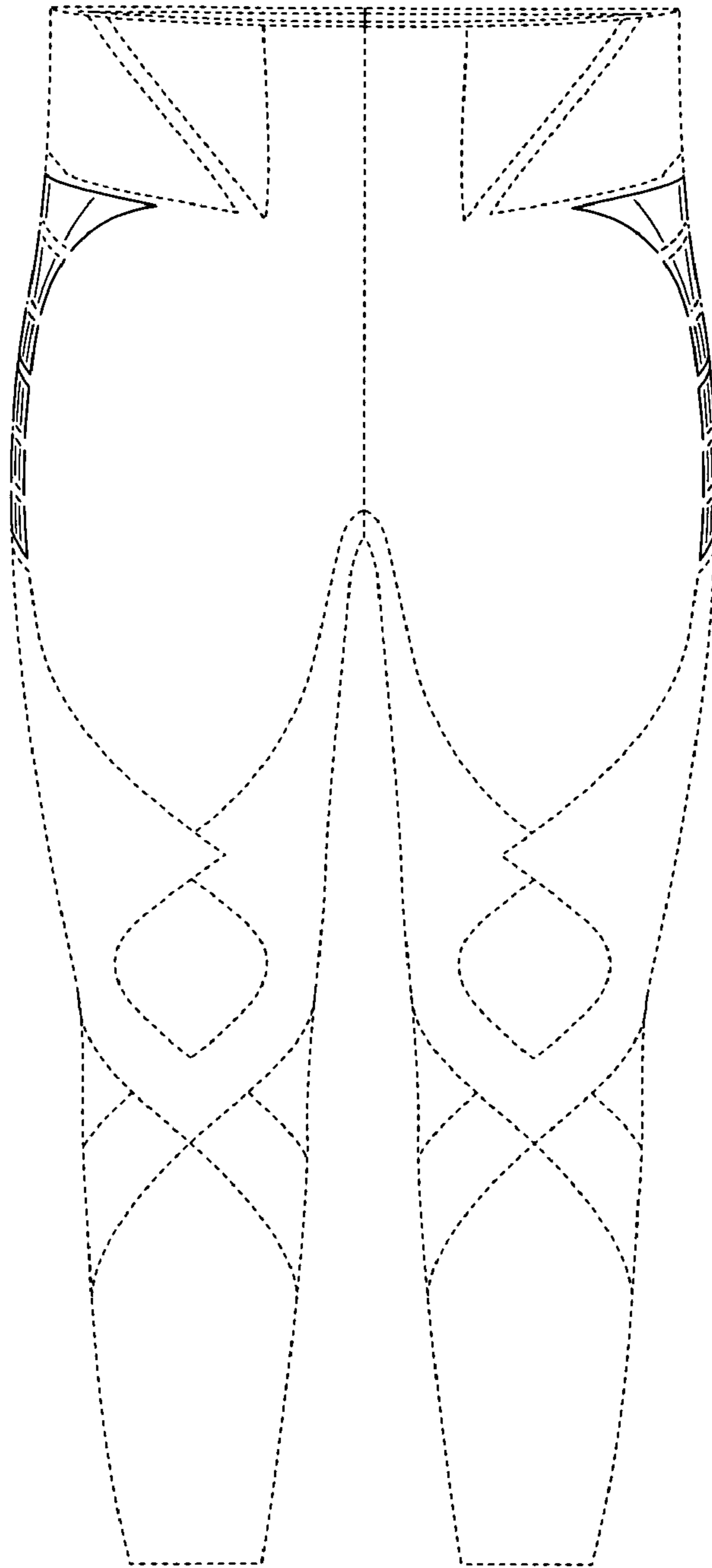

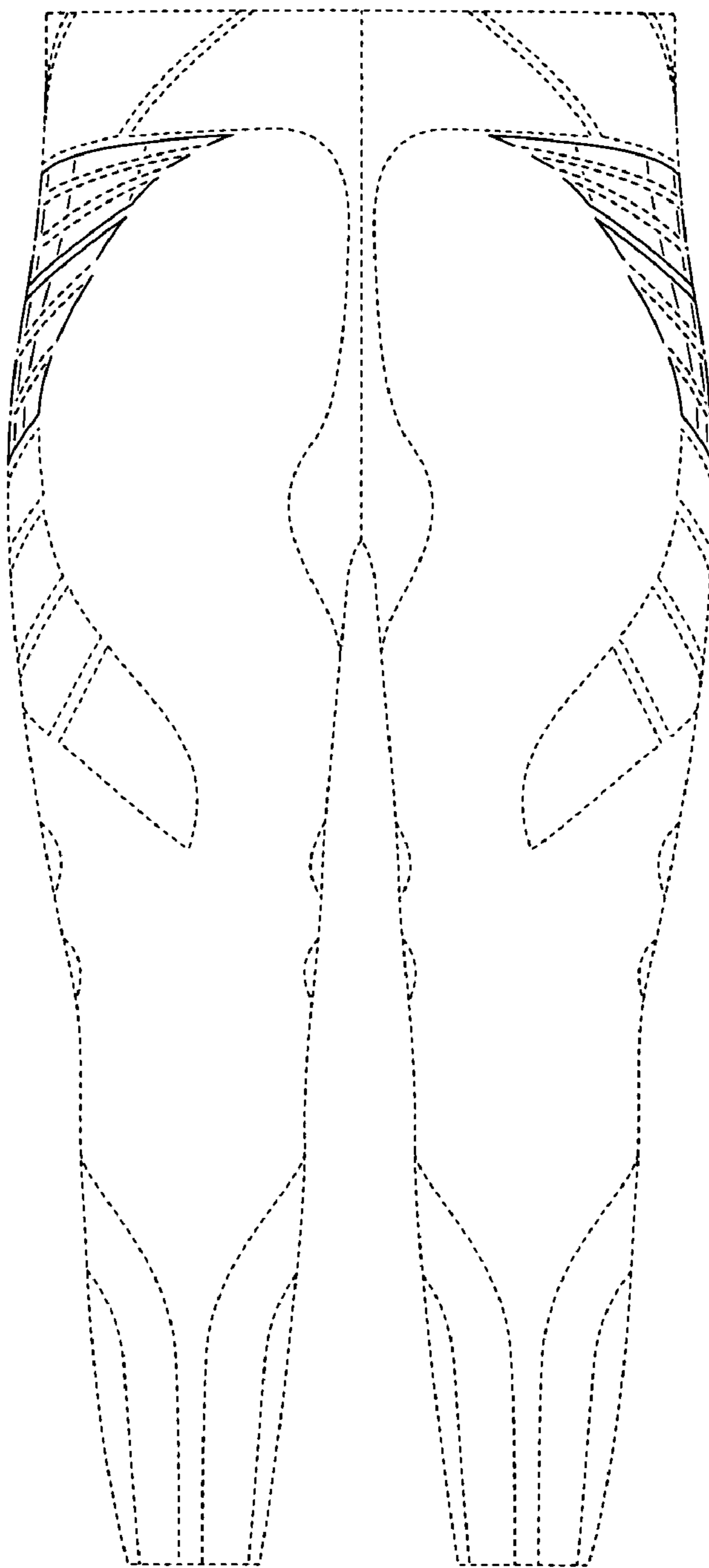
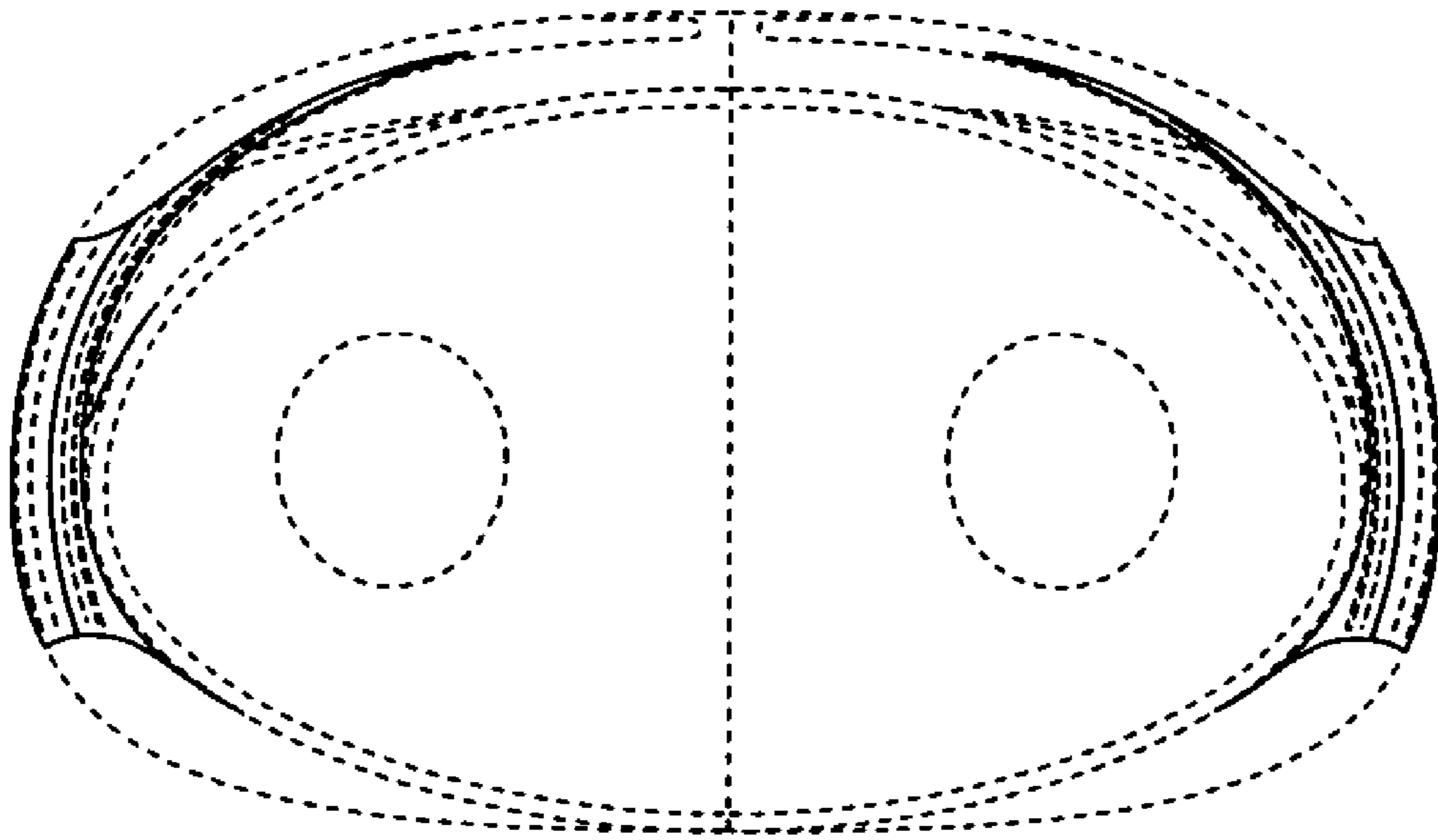
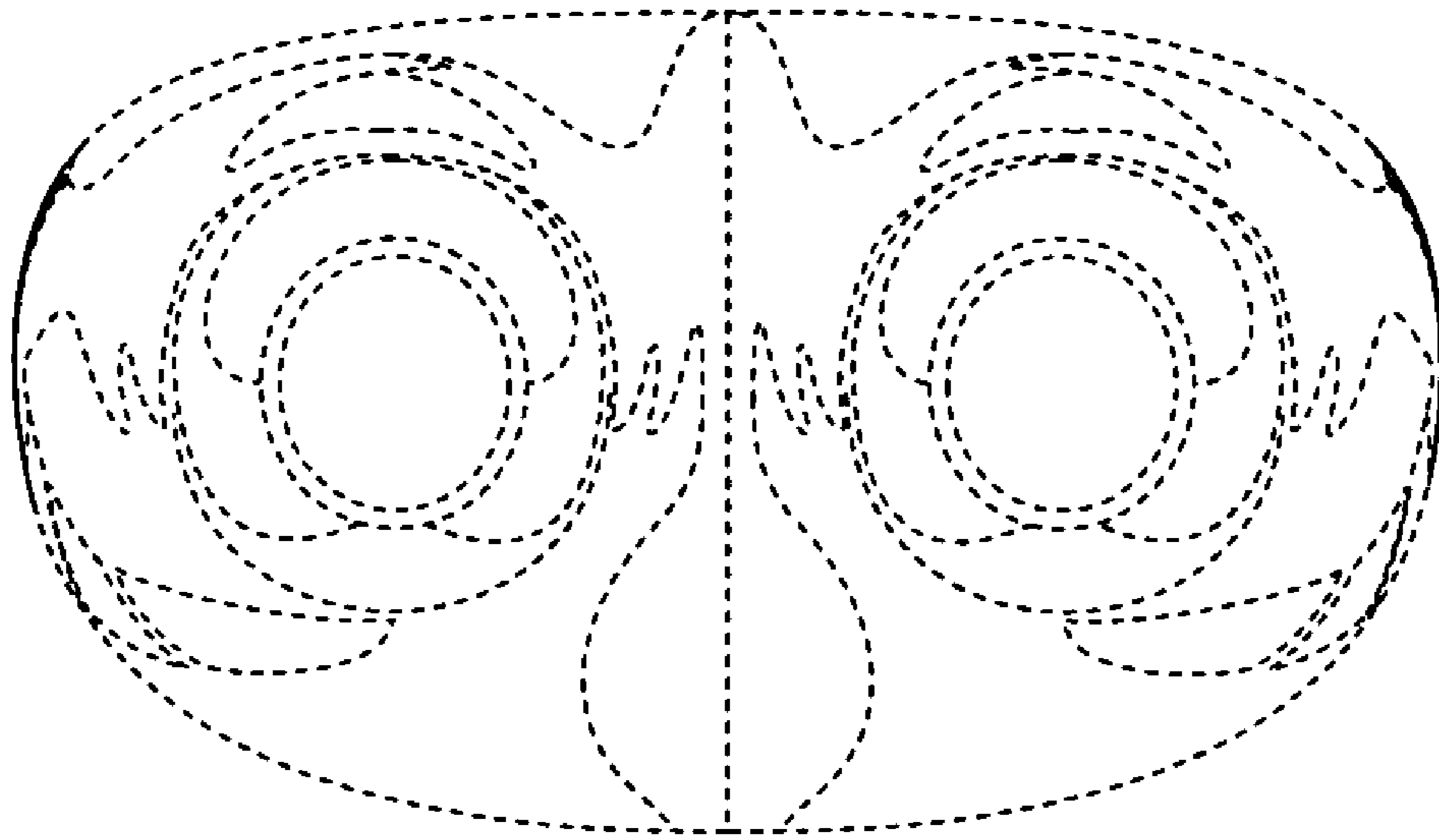

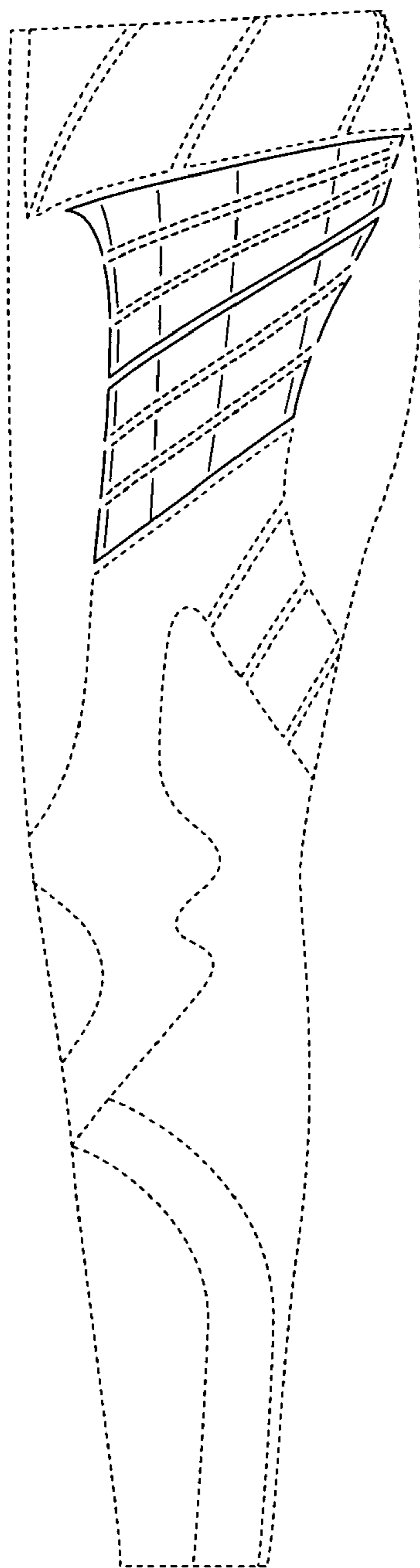

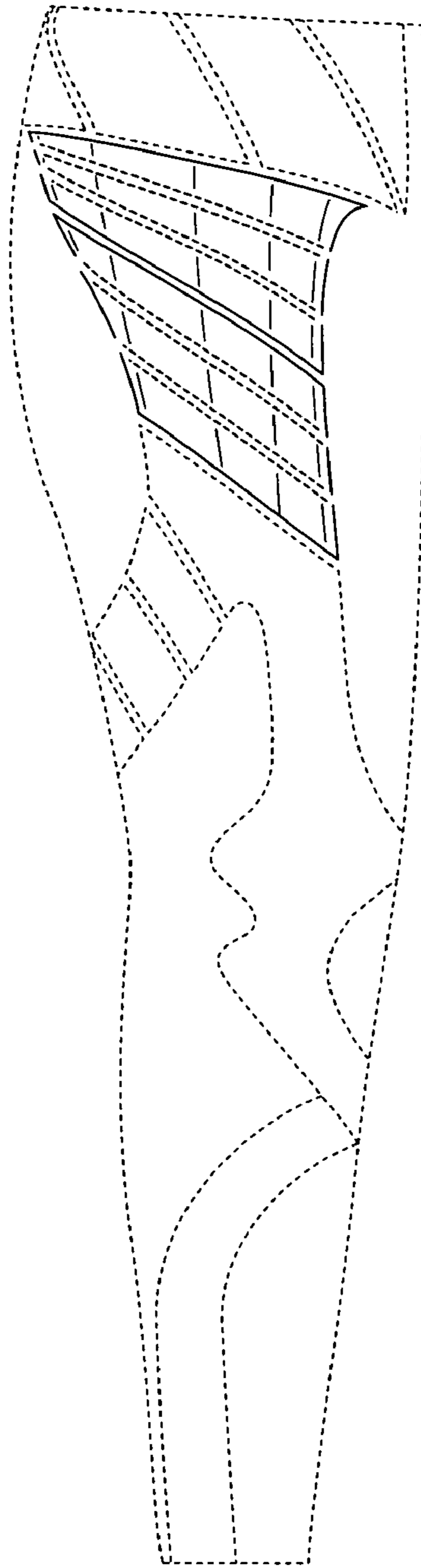

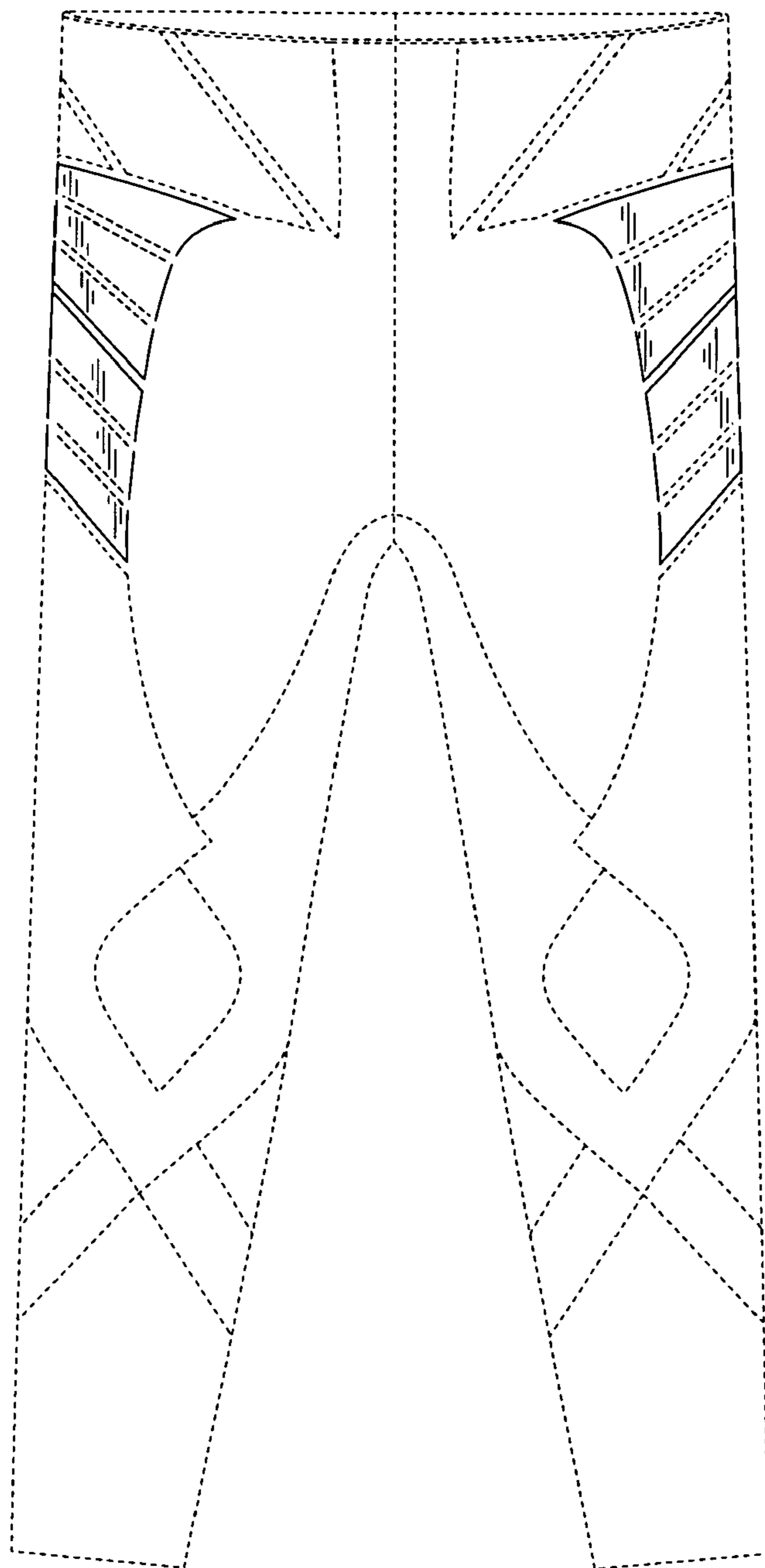
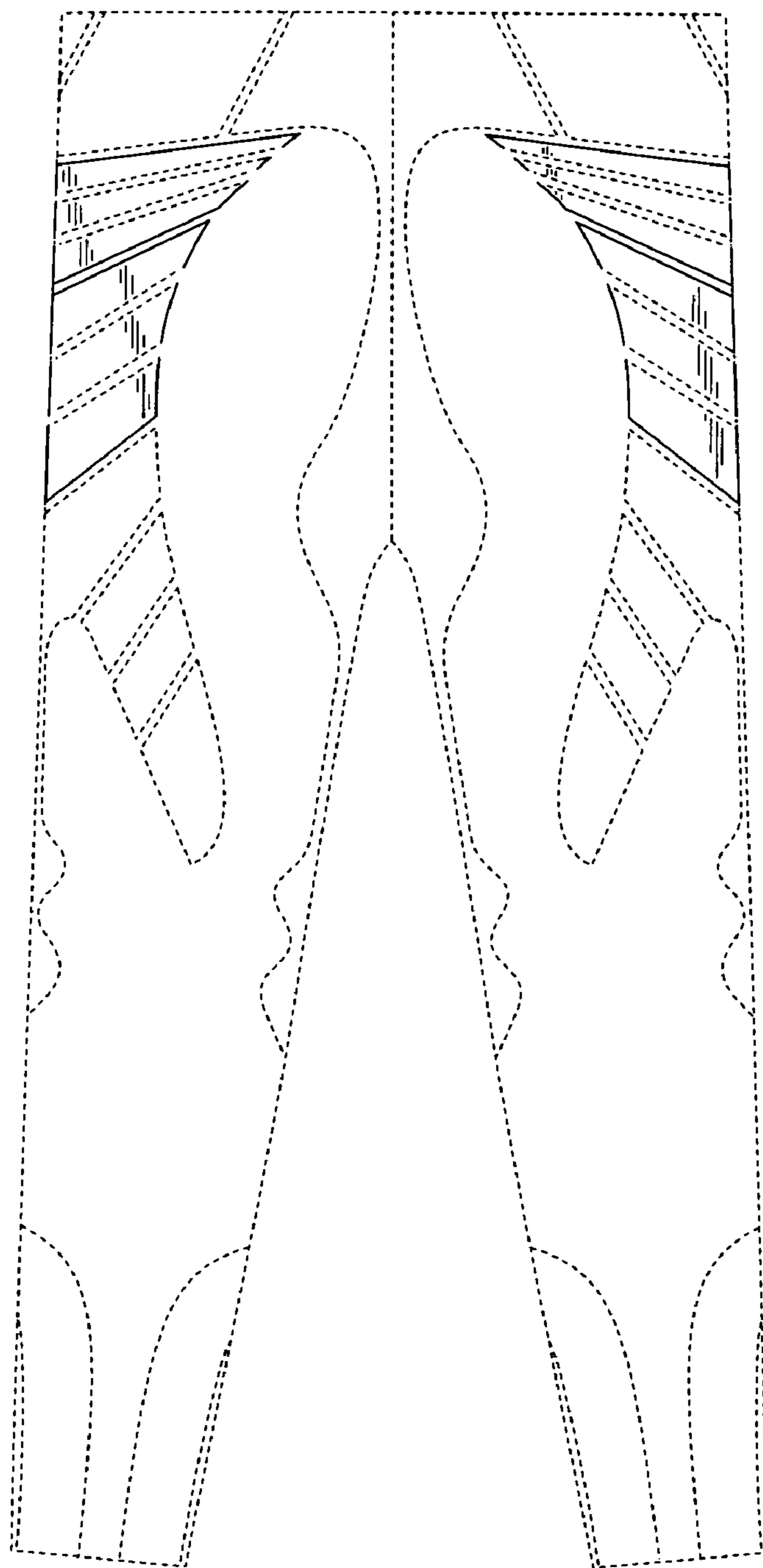
