FIG. 7 is an enlarged perspective view thereof;

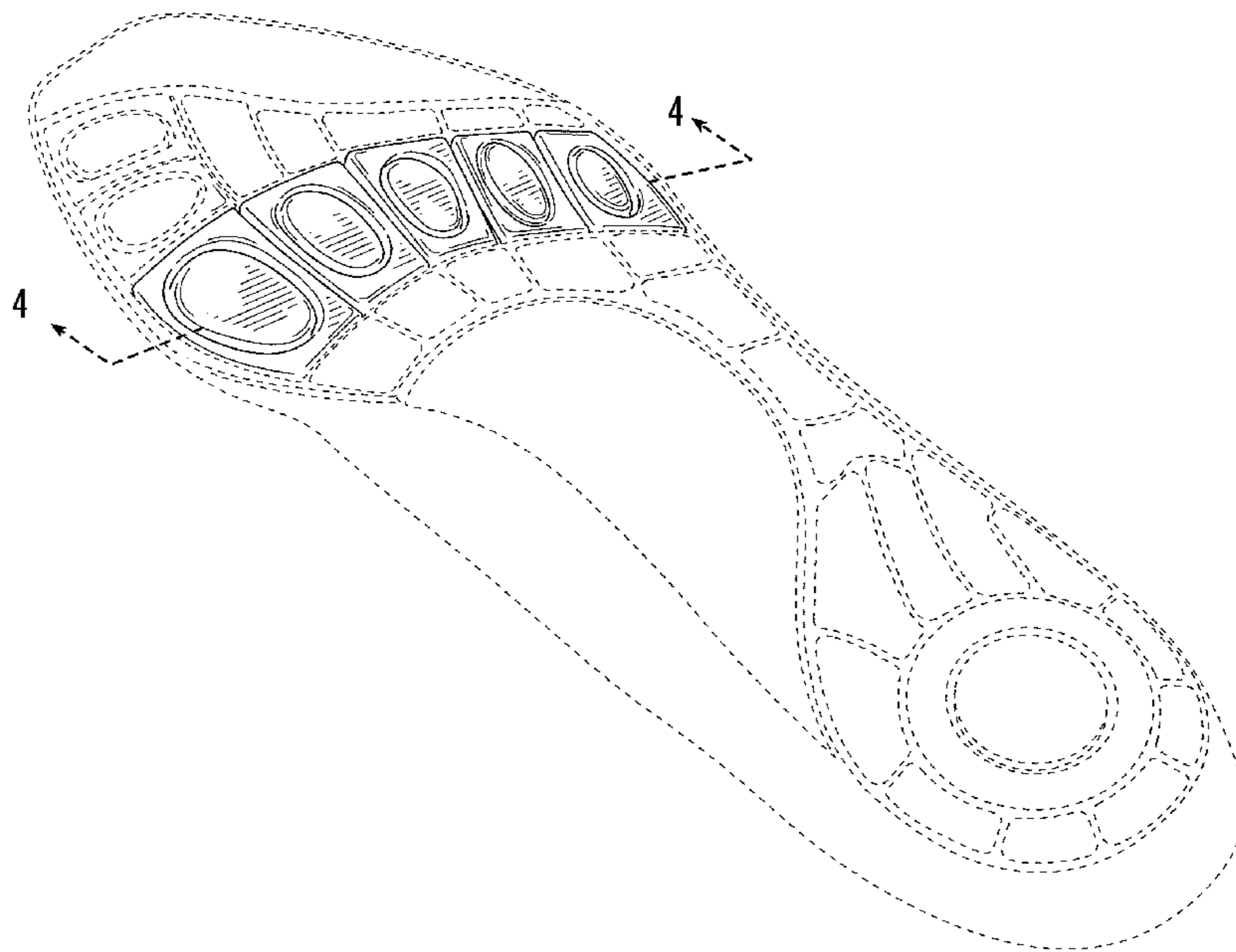
FIG. 8 is an enlarged top plan view thereof;

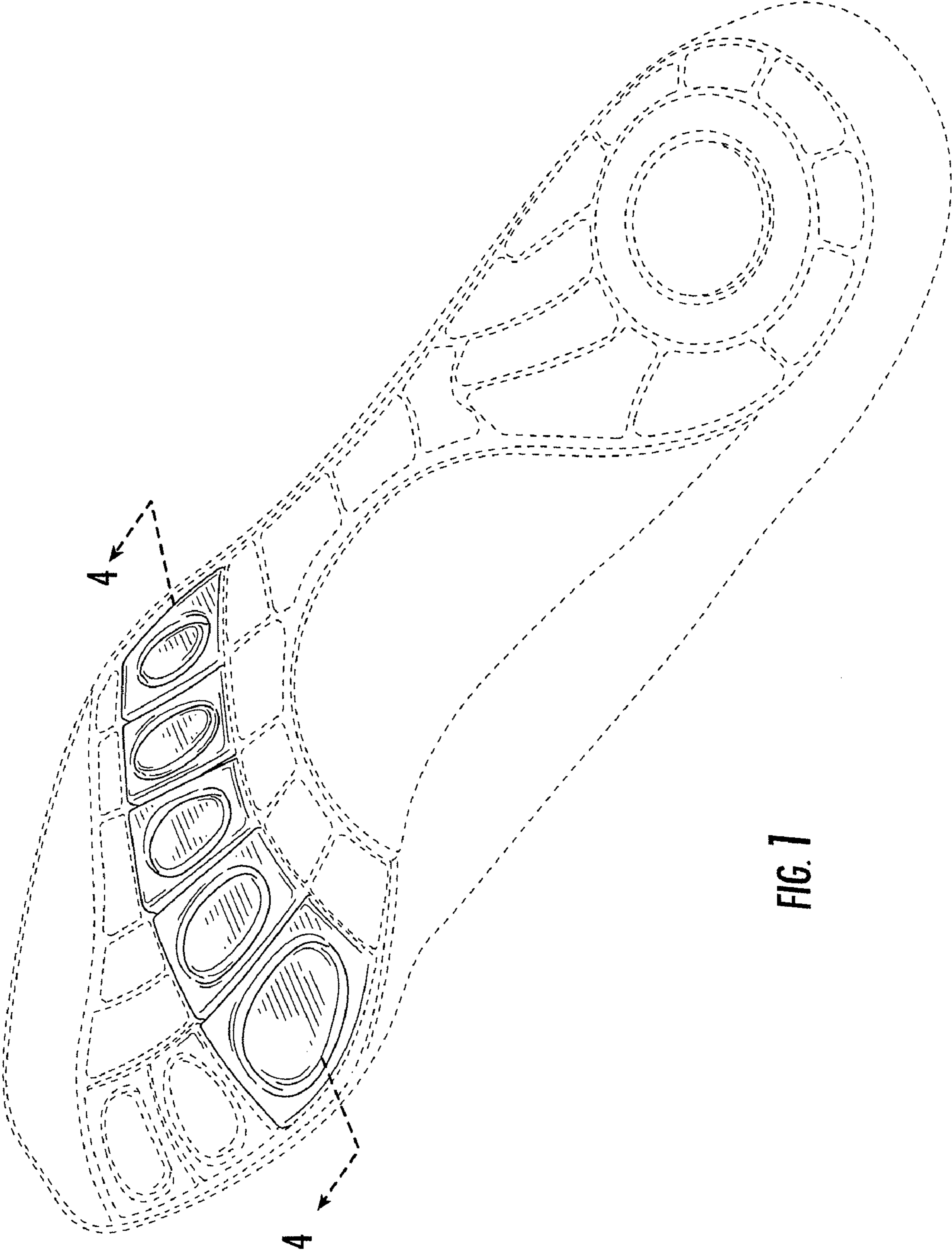
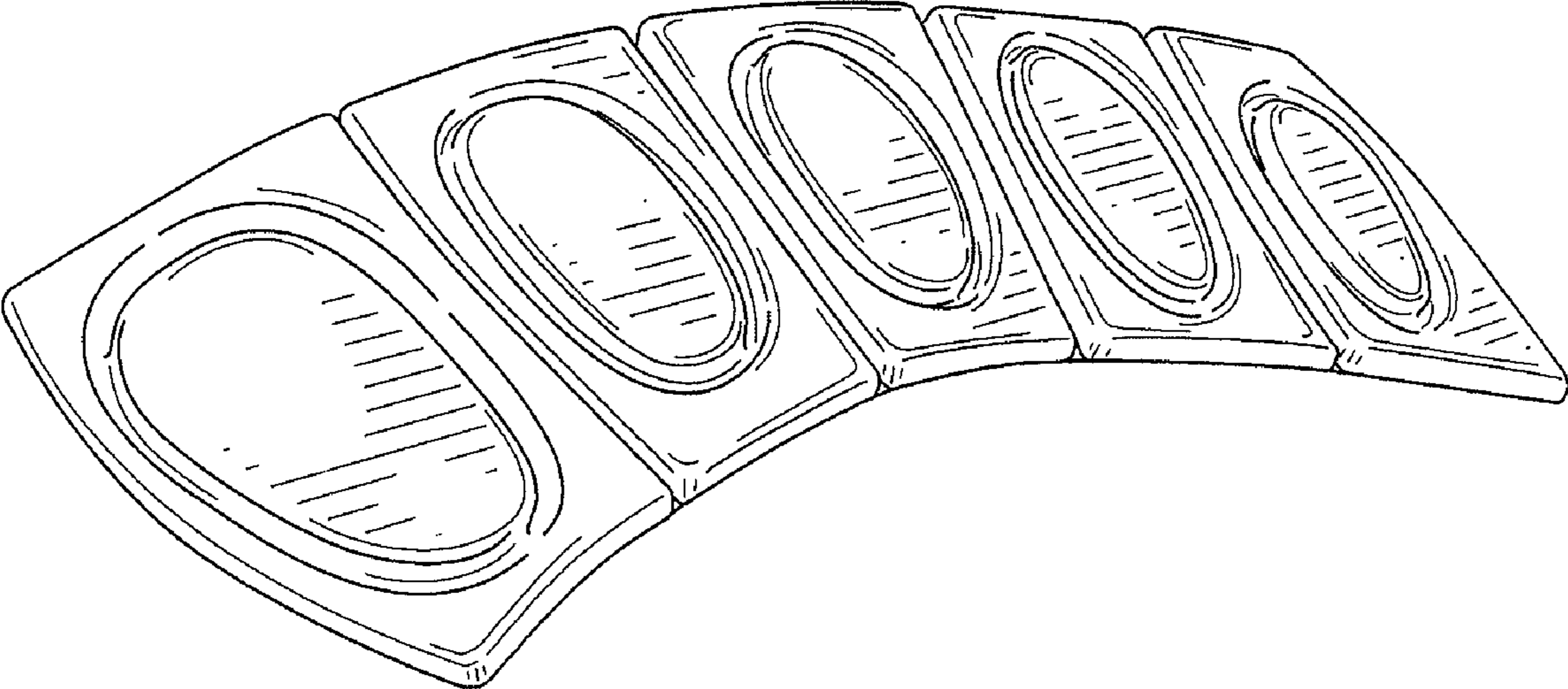

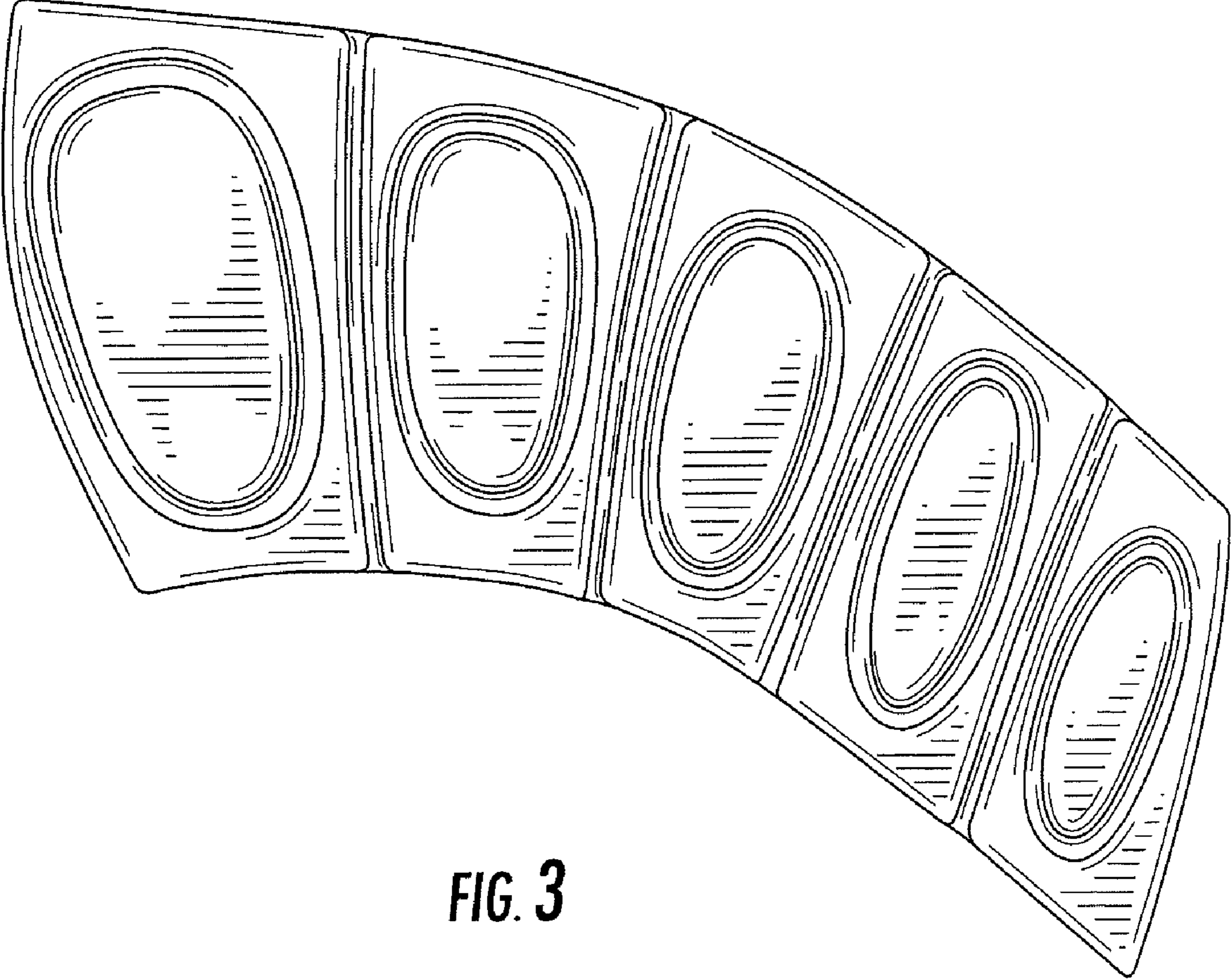

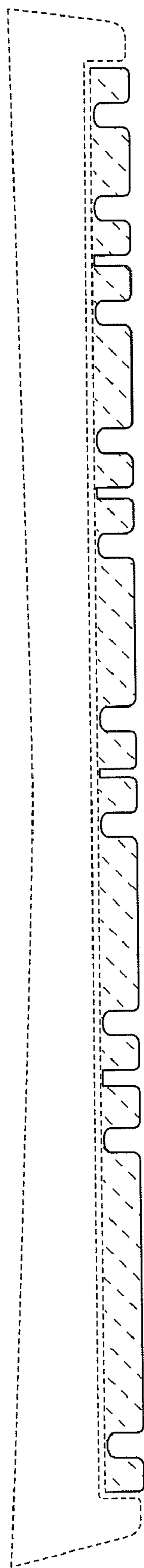

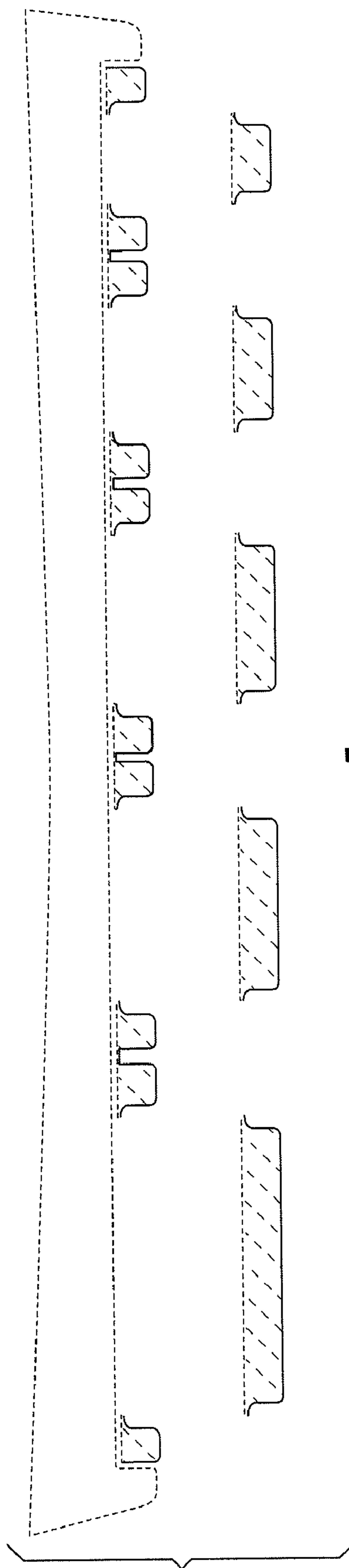

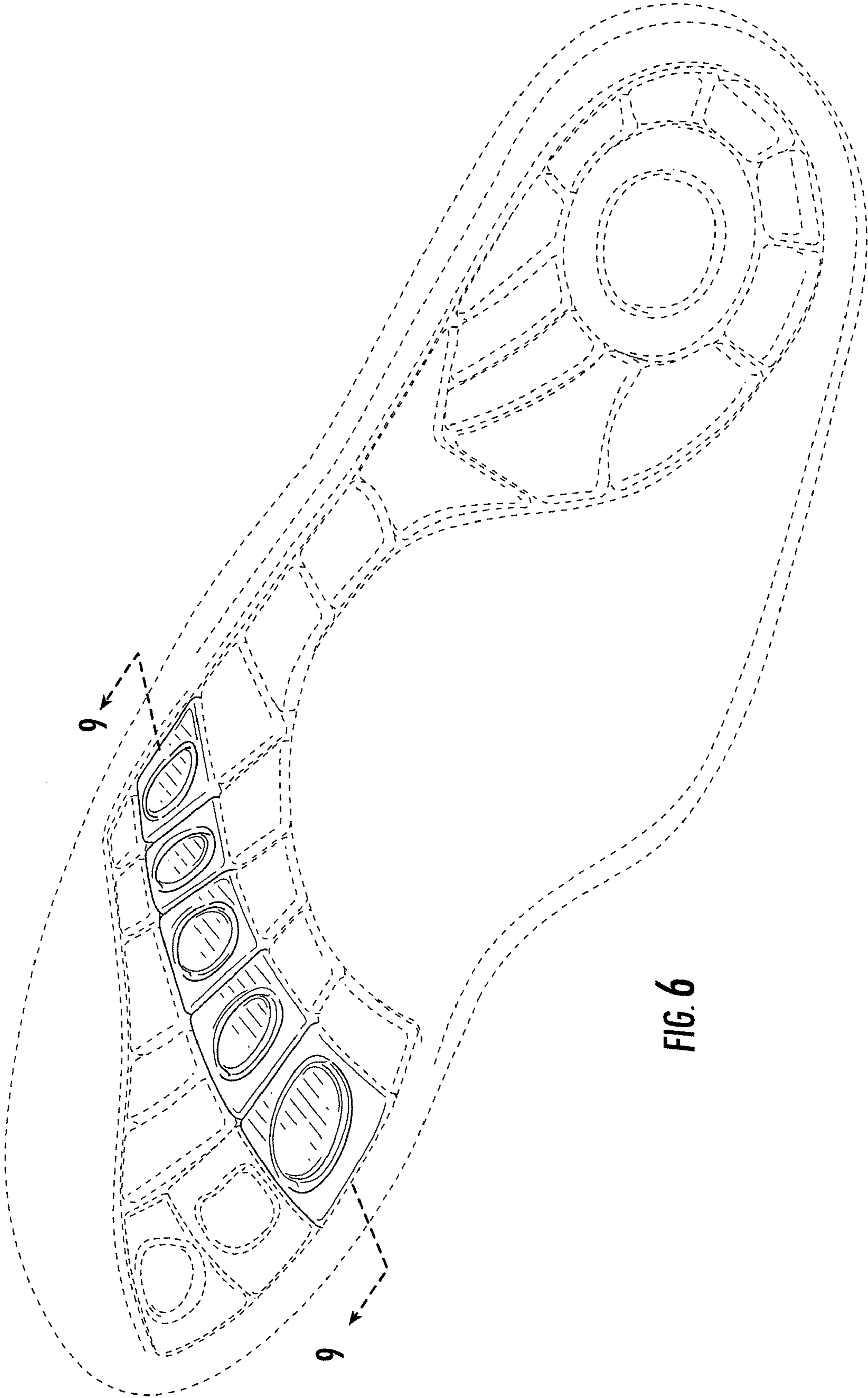
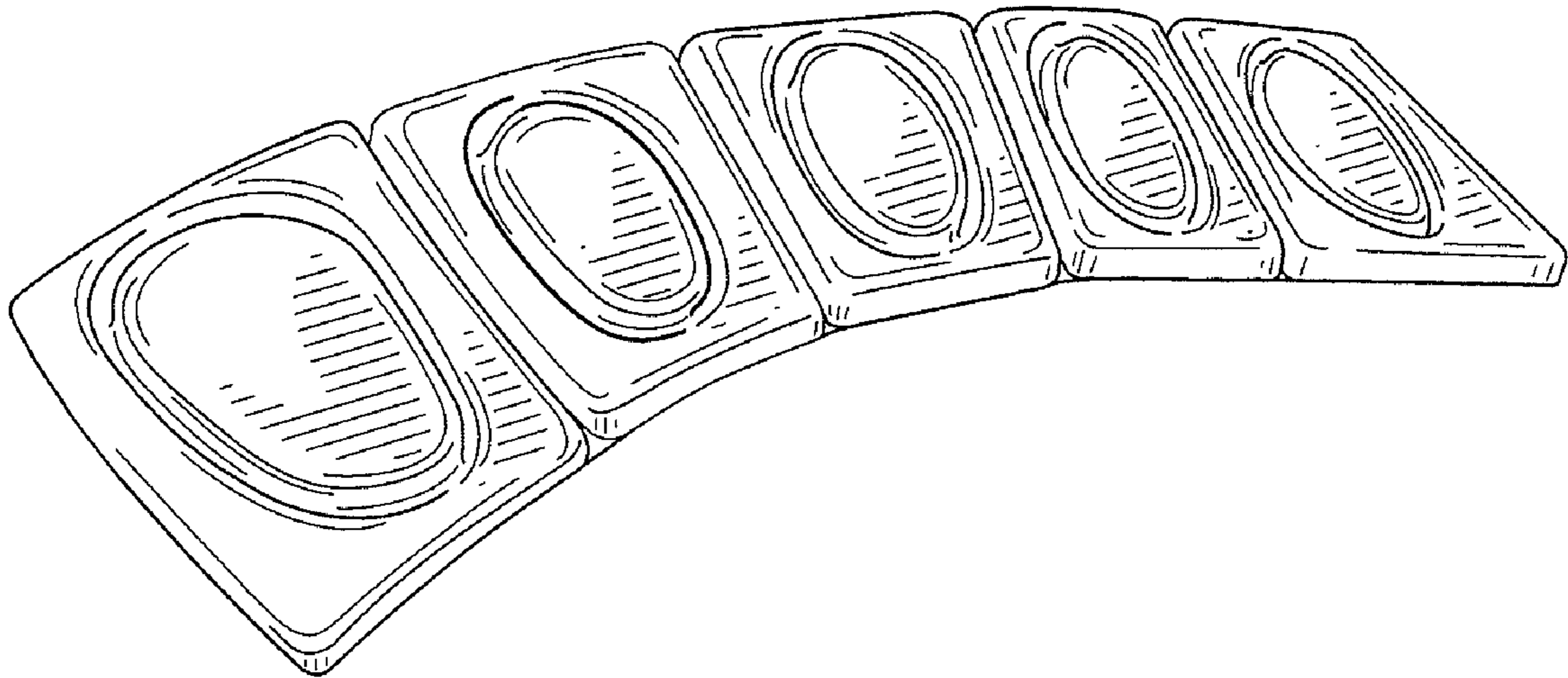
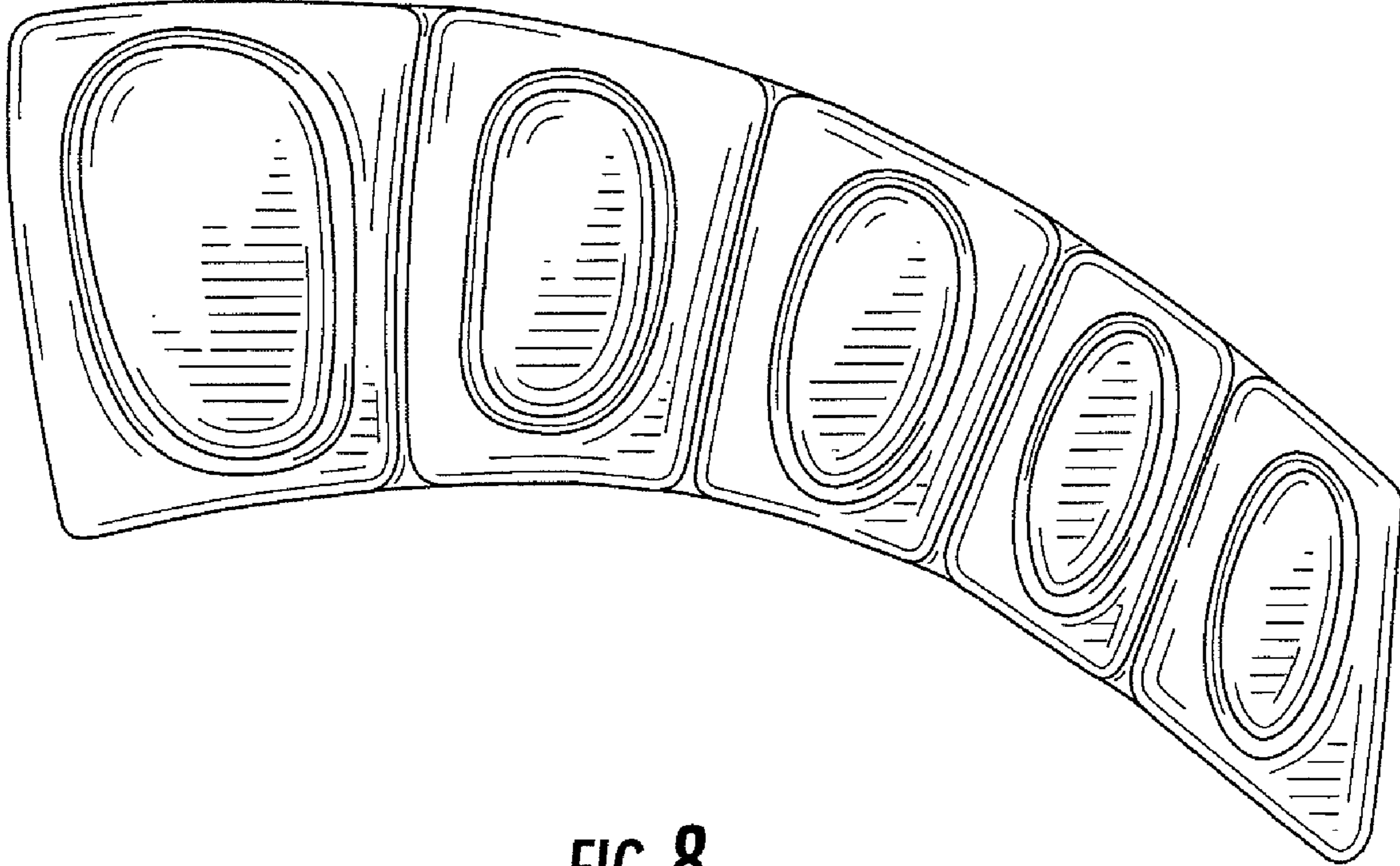

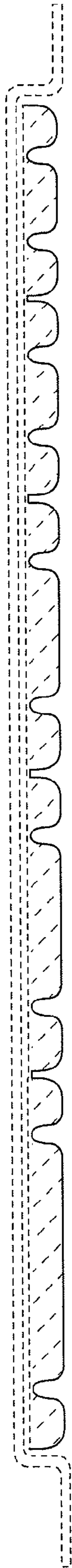

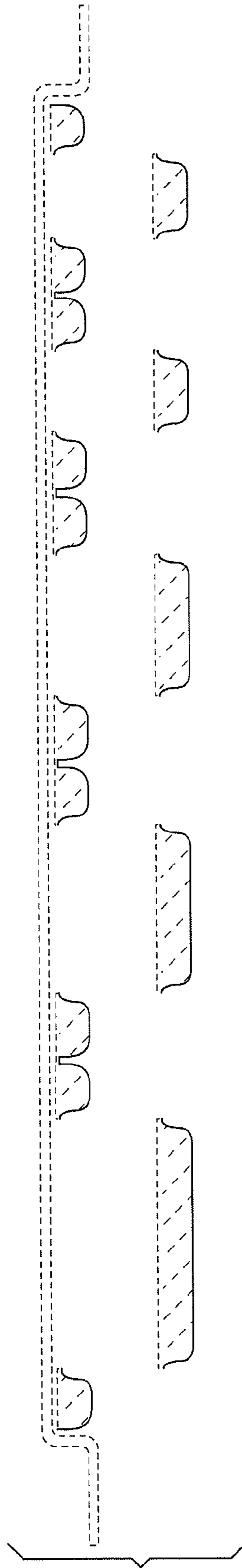
