(57) **CLAIM**

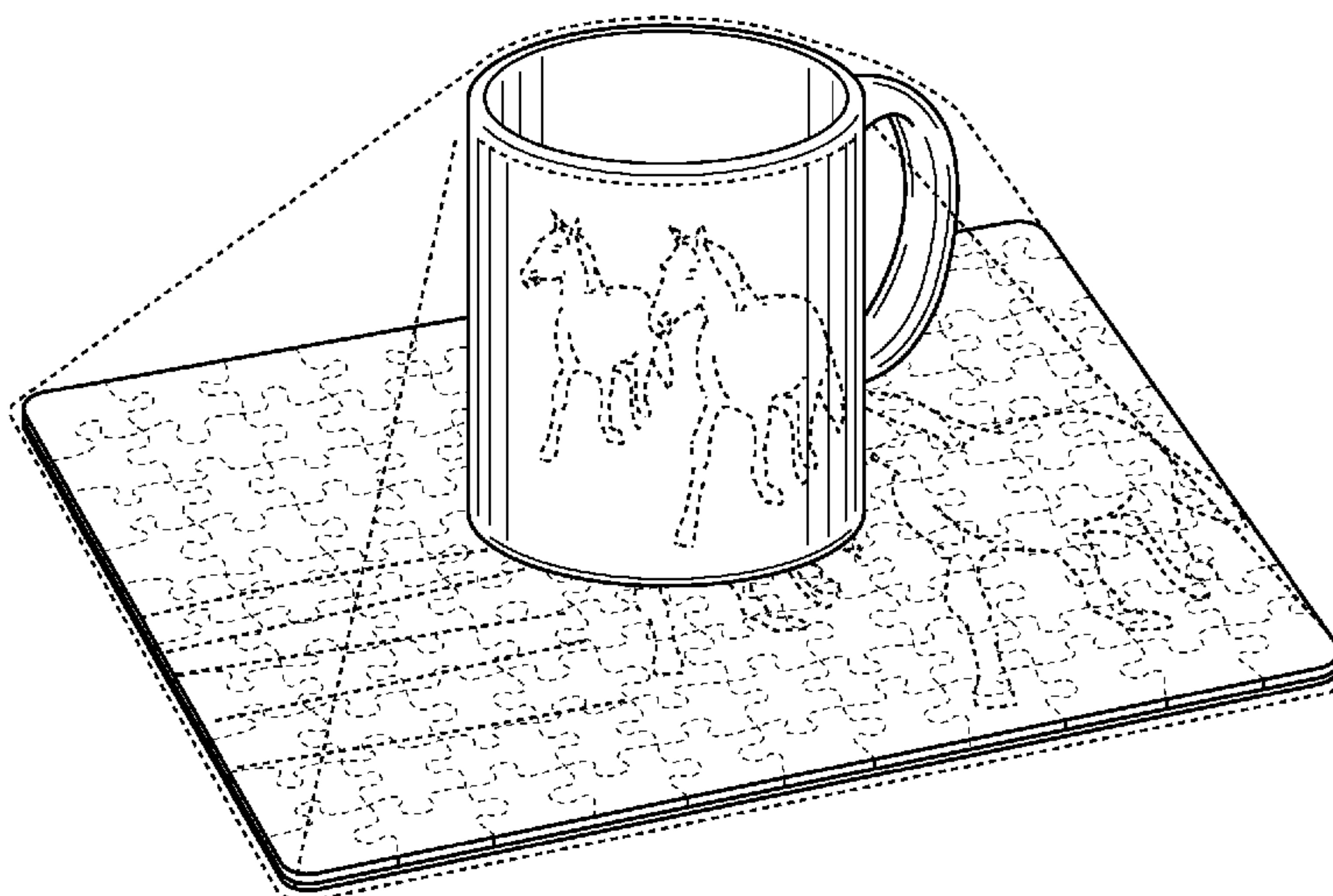
The ornamental design for a mug and jigsaw puzzle set, as shown and described.

**DESCRIPTION**

FIG. 1 is a top front right perspective view of a mug and jigsaw puzzle set showing my new design,  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is a bottom plan view thereof.

The broken line showing of shrink-wrap packaging and printed images are included for the purpose of illustration and forms no part of the claimed invention.

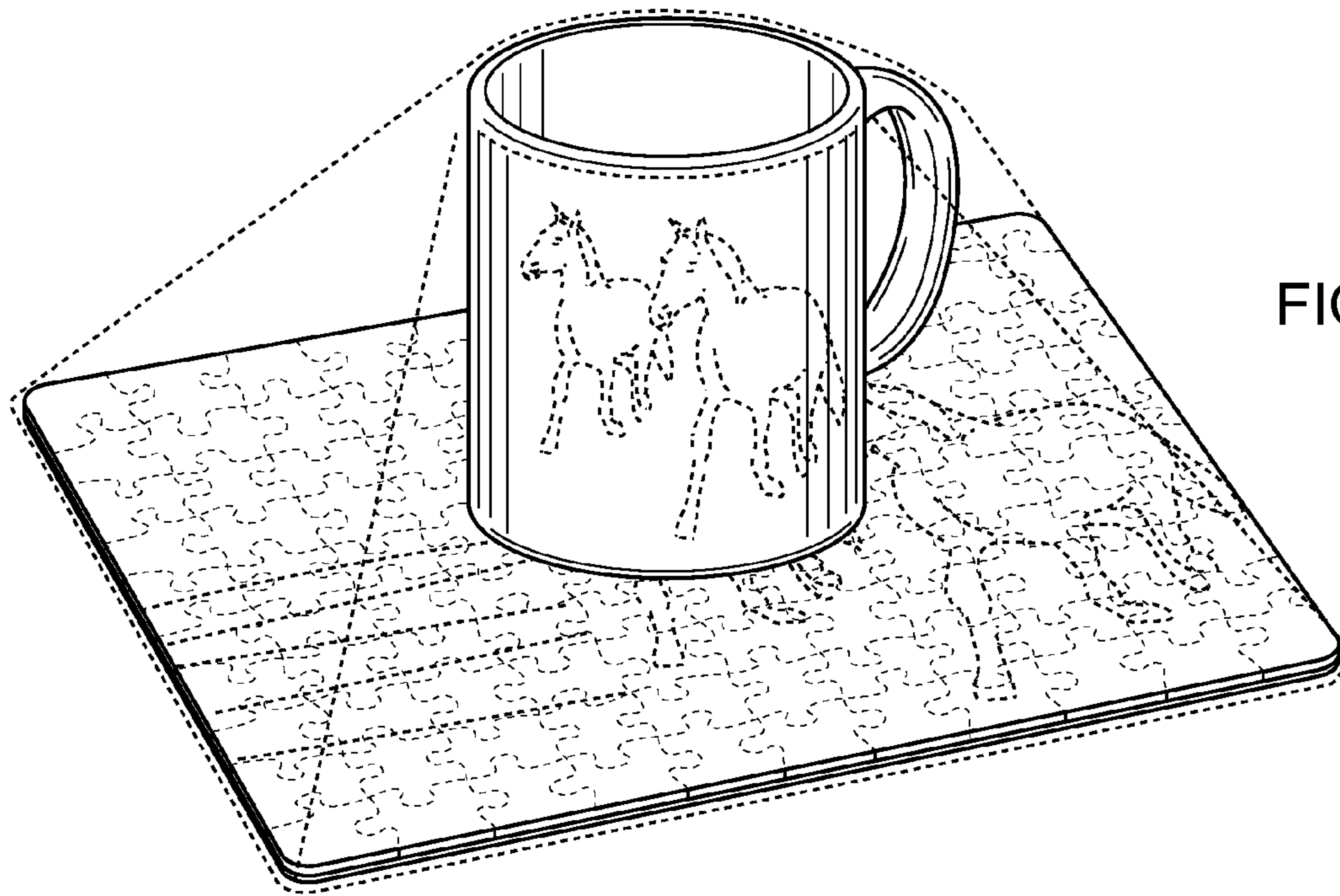

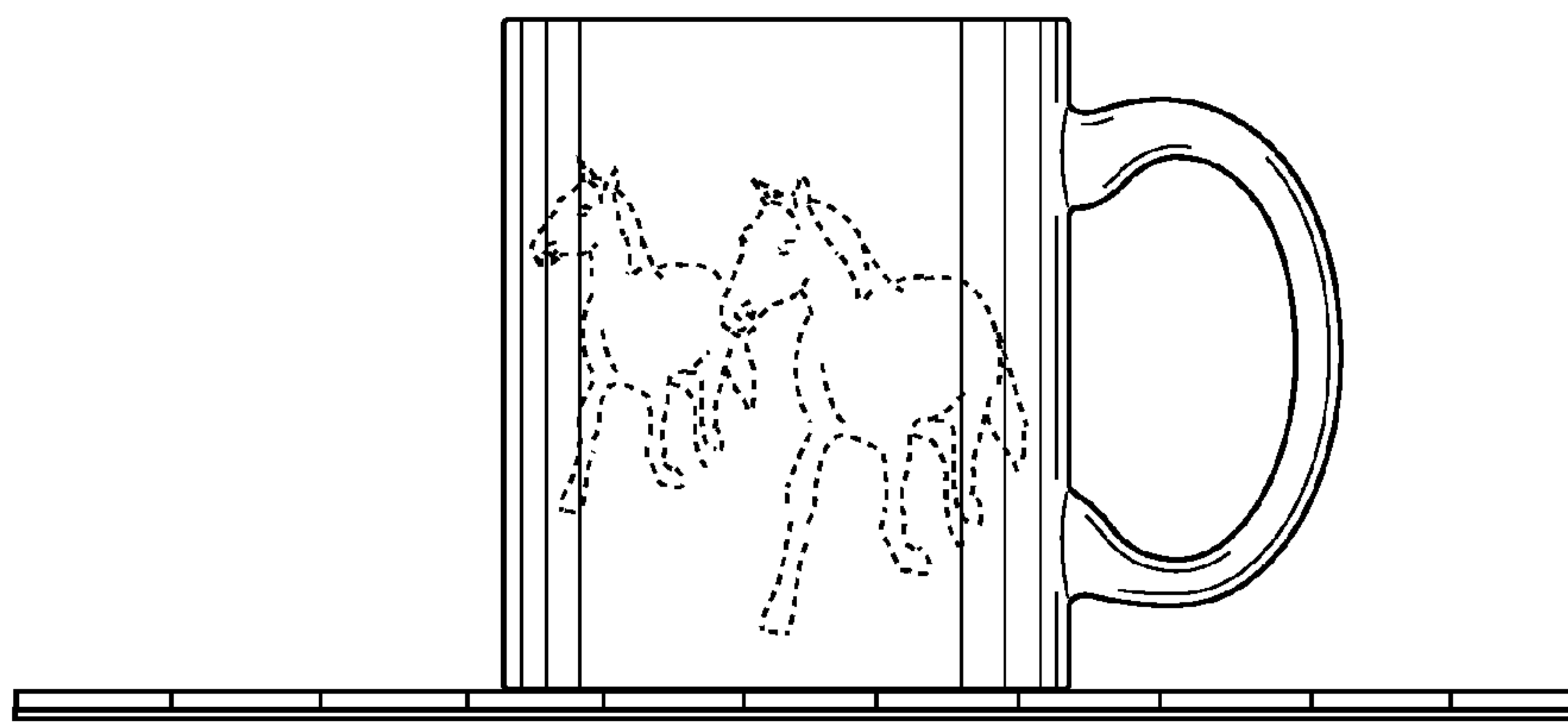

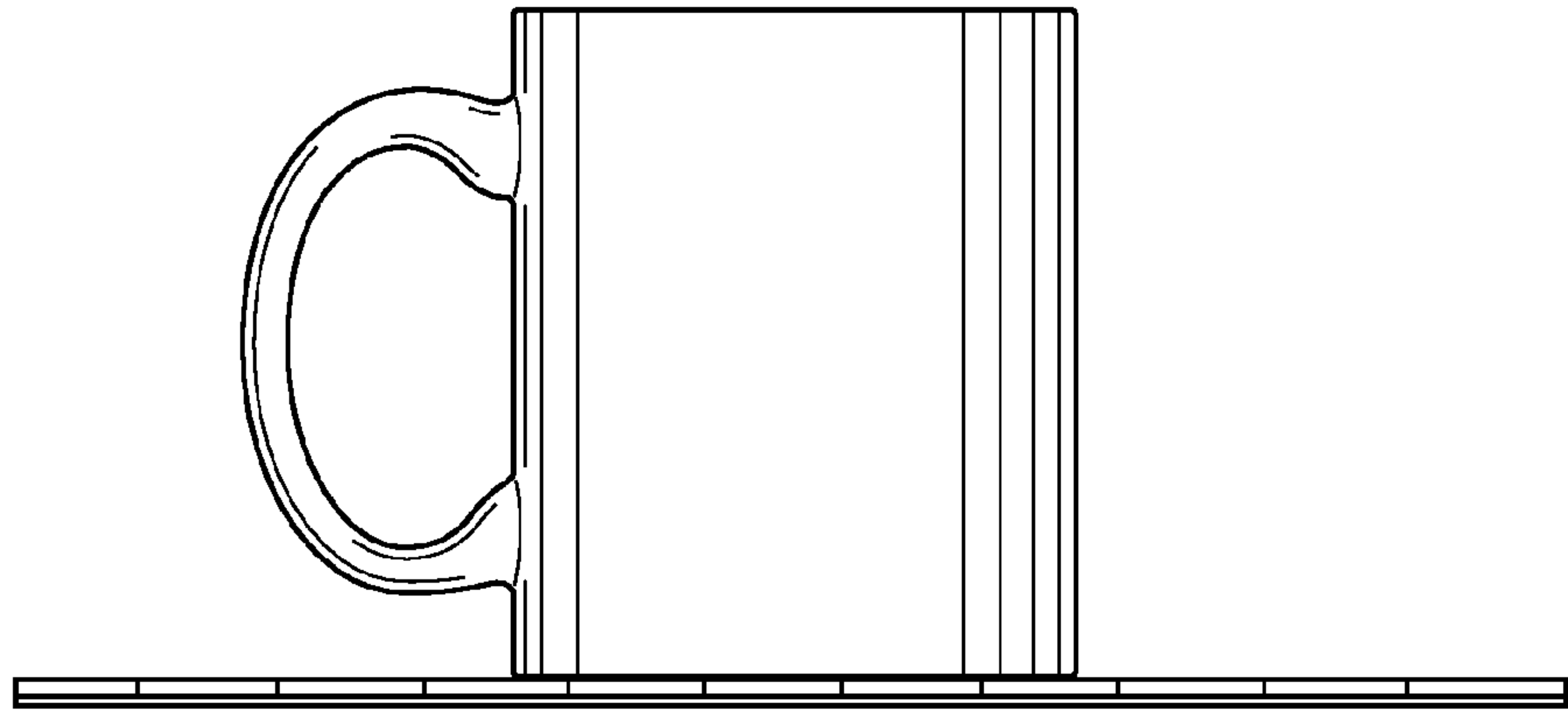

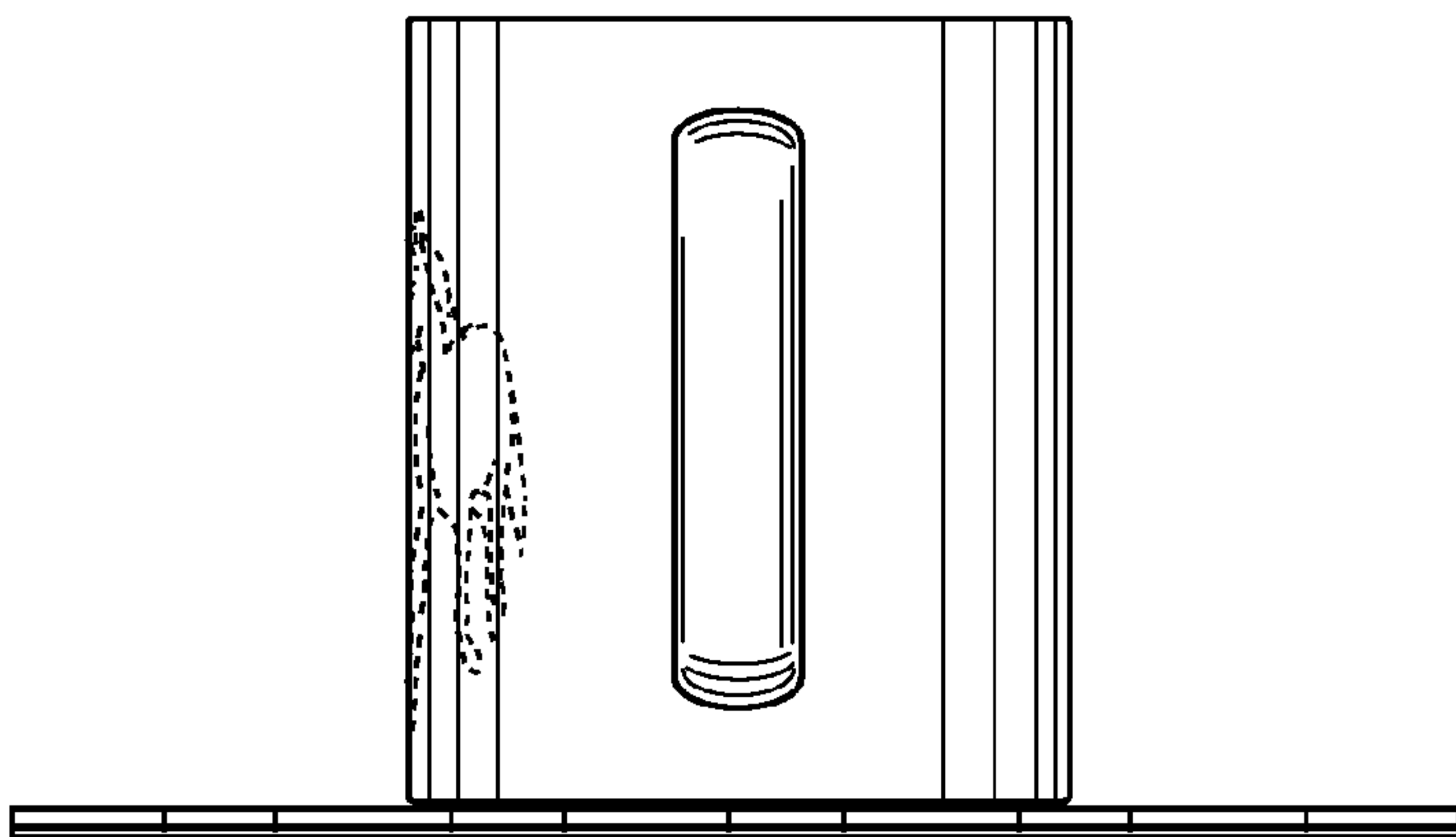

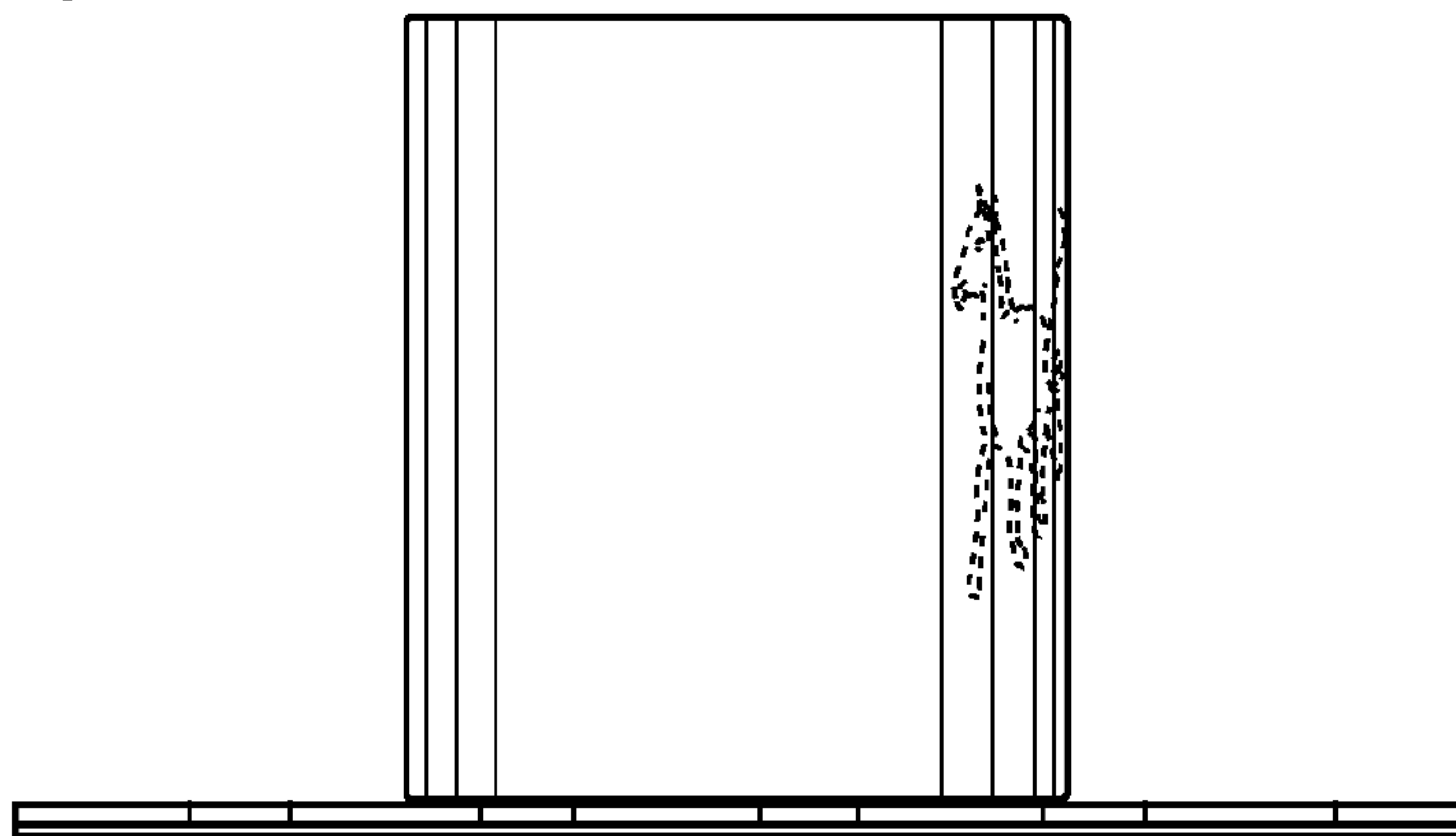

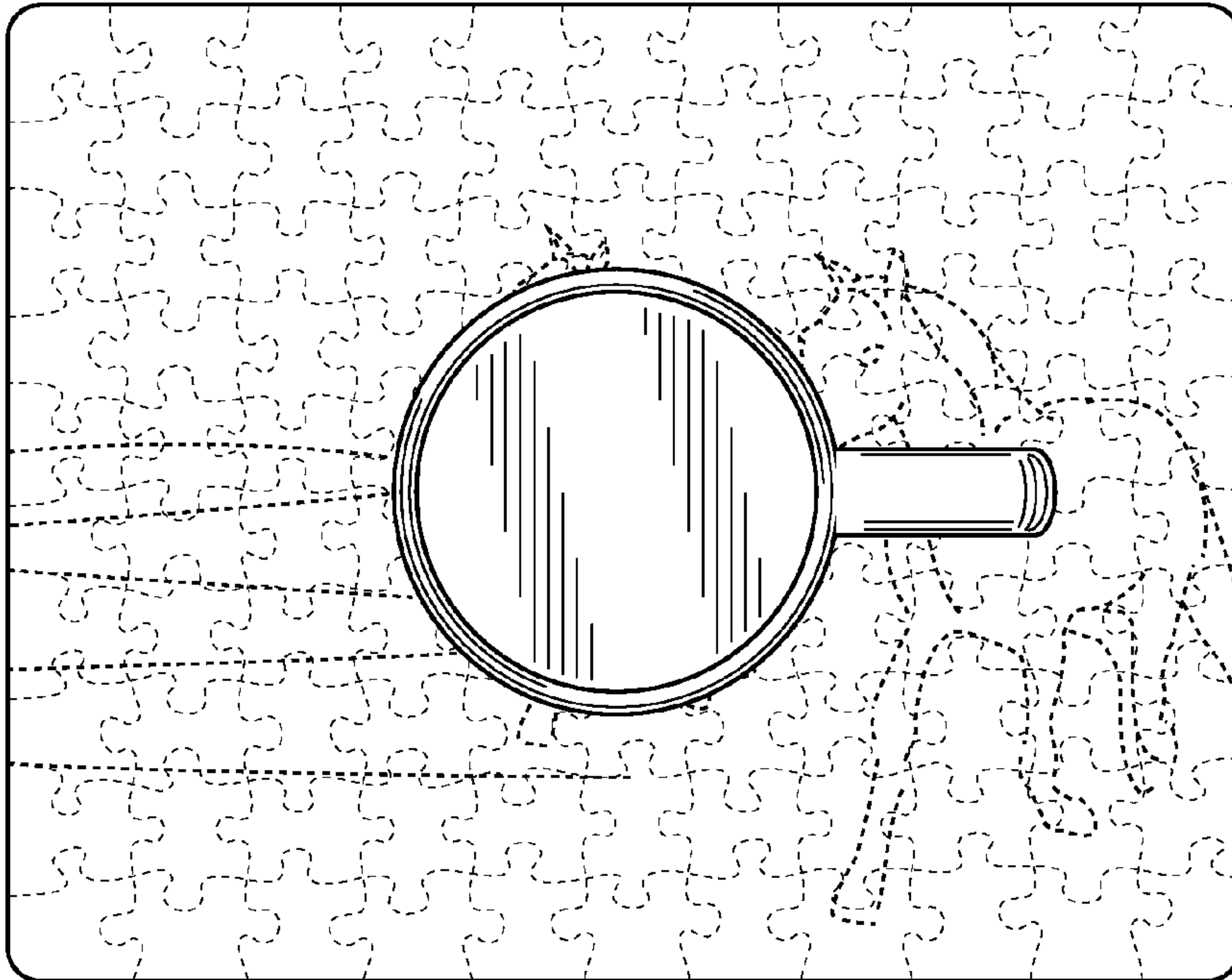

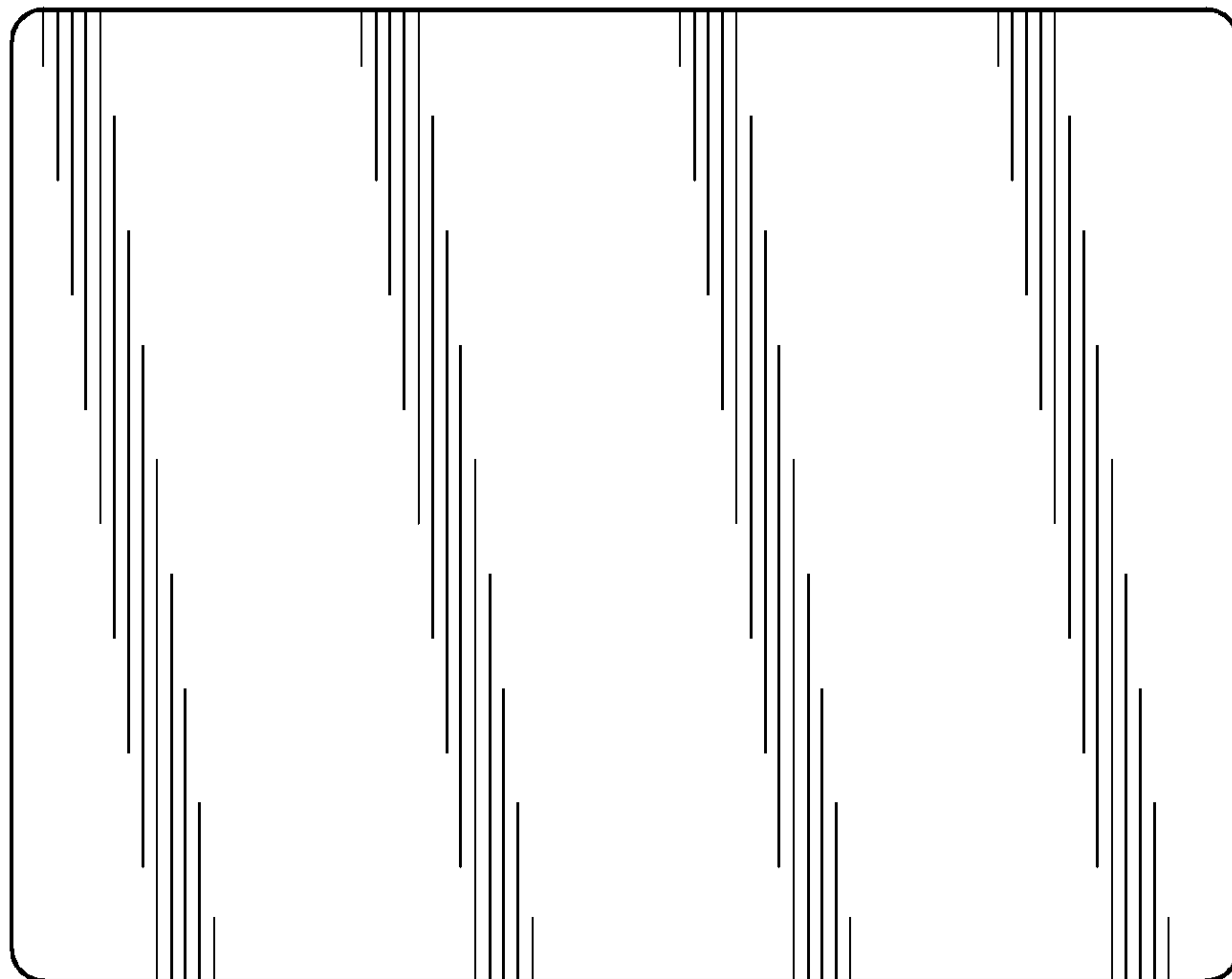
