(57) **CLAIM**

The ornamental design for a fluid product dispenser, as shown and described.

DESCRIPTION

FIG. 1 is side left view of a fluid product dispenser;

FIG. 2 is a side right view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof; and,

FIG. 5 is a top view thereof.

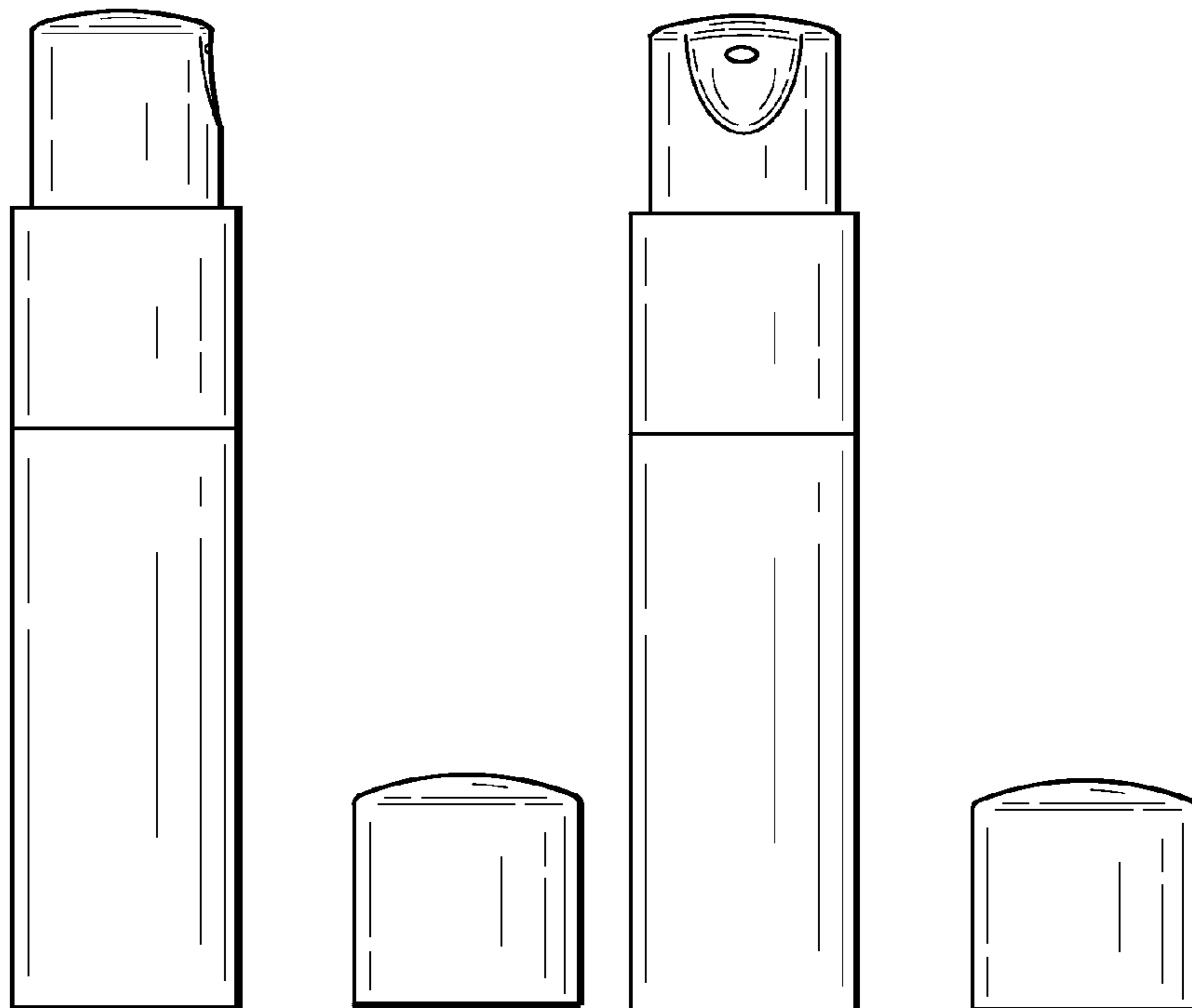

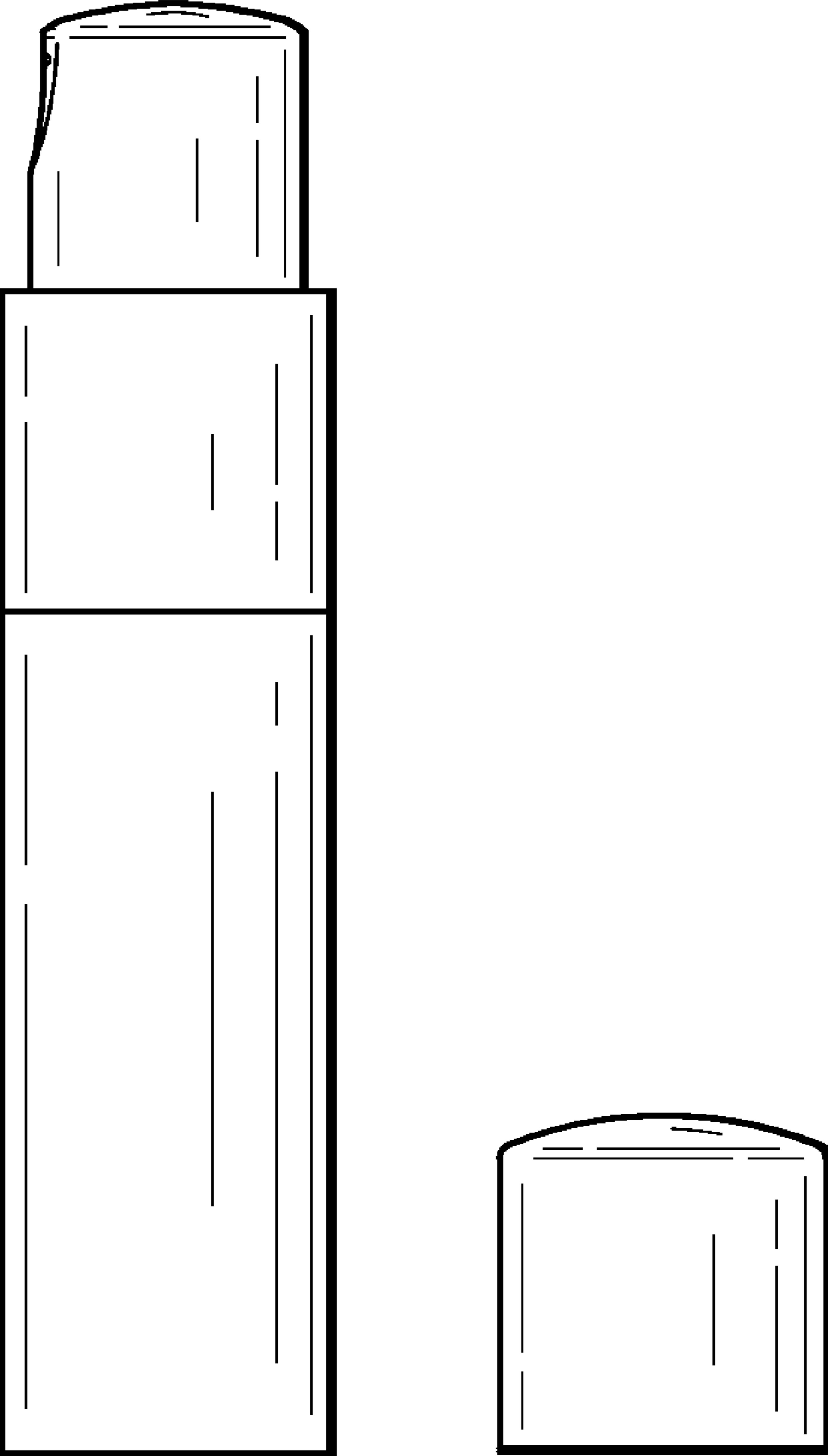

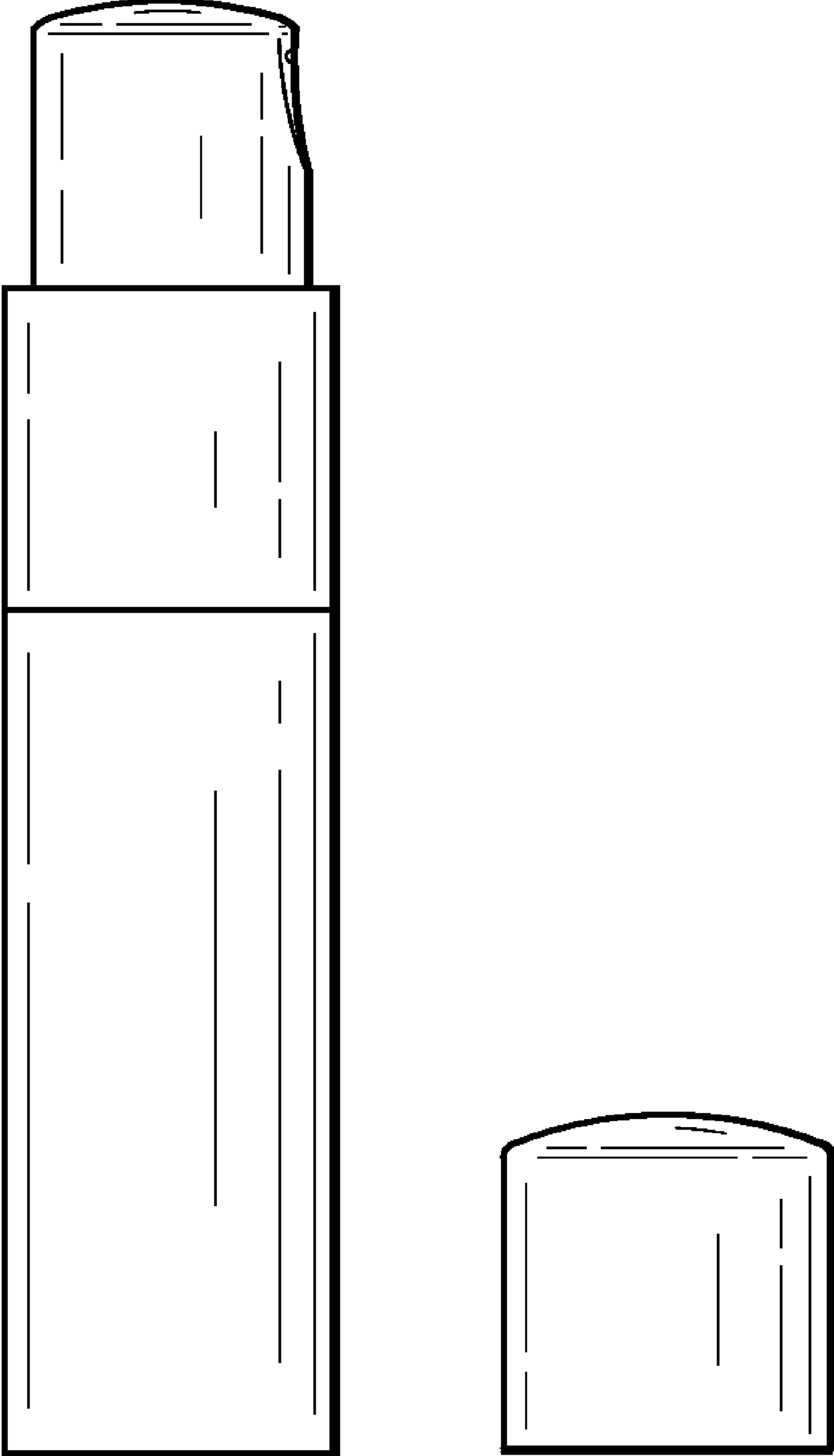

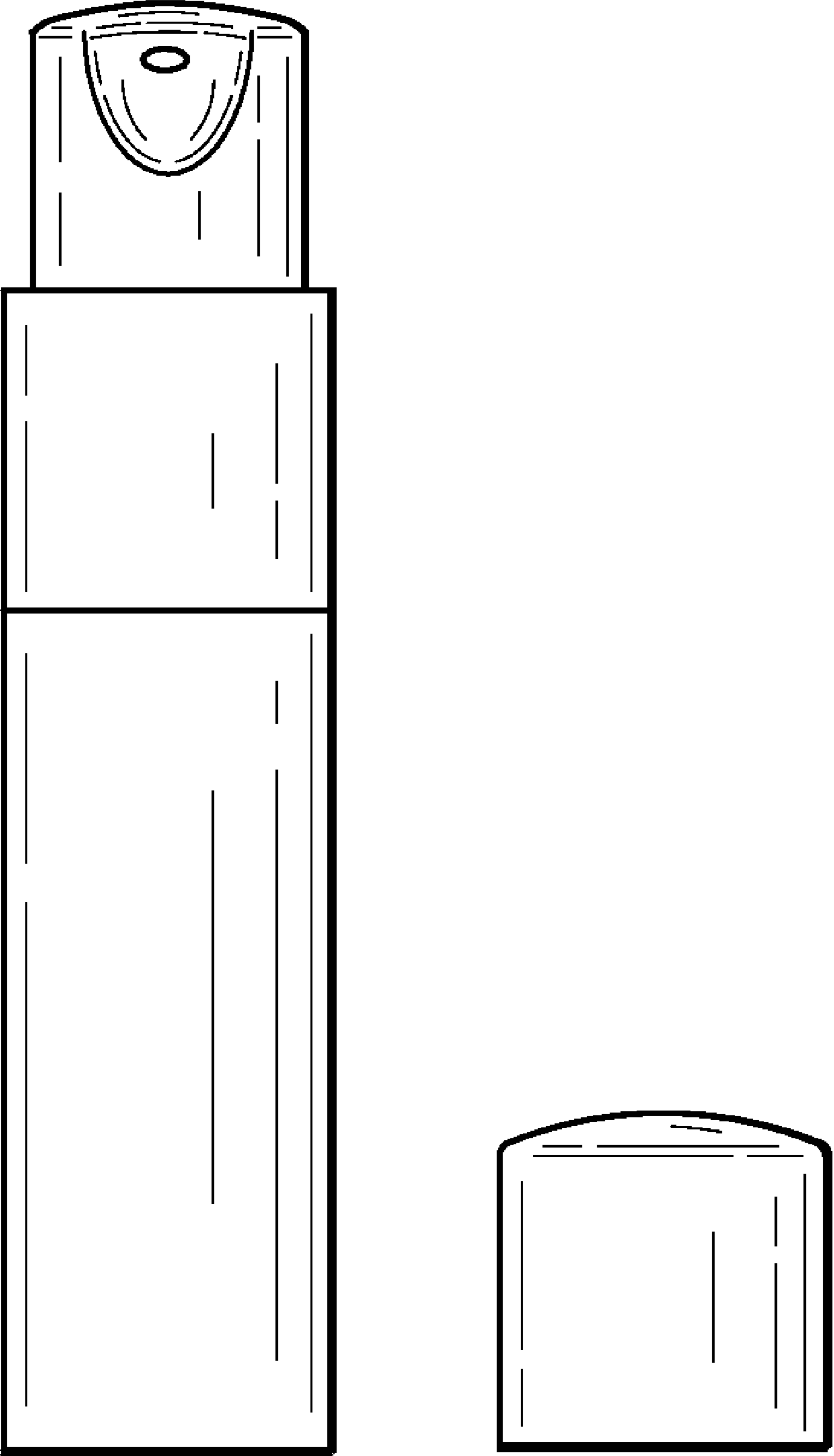

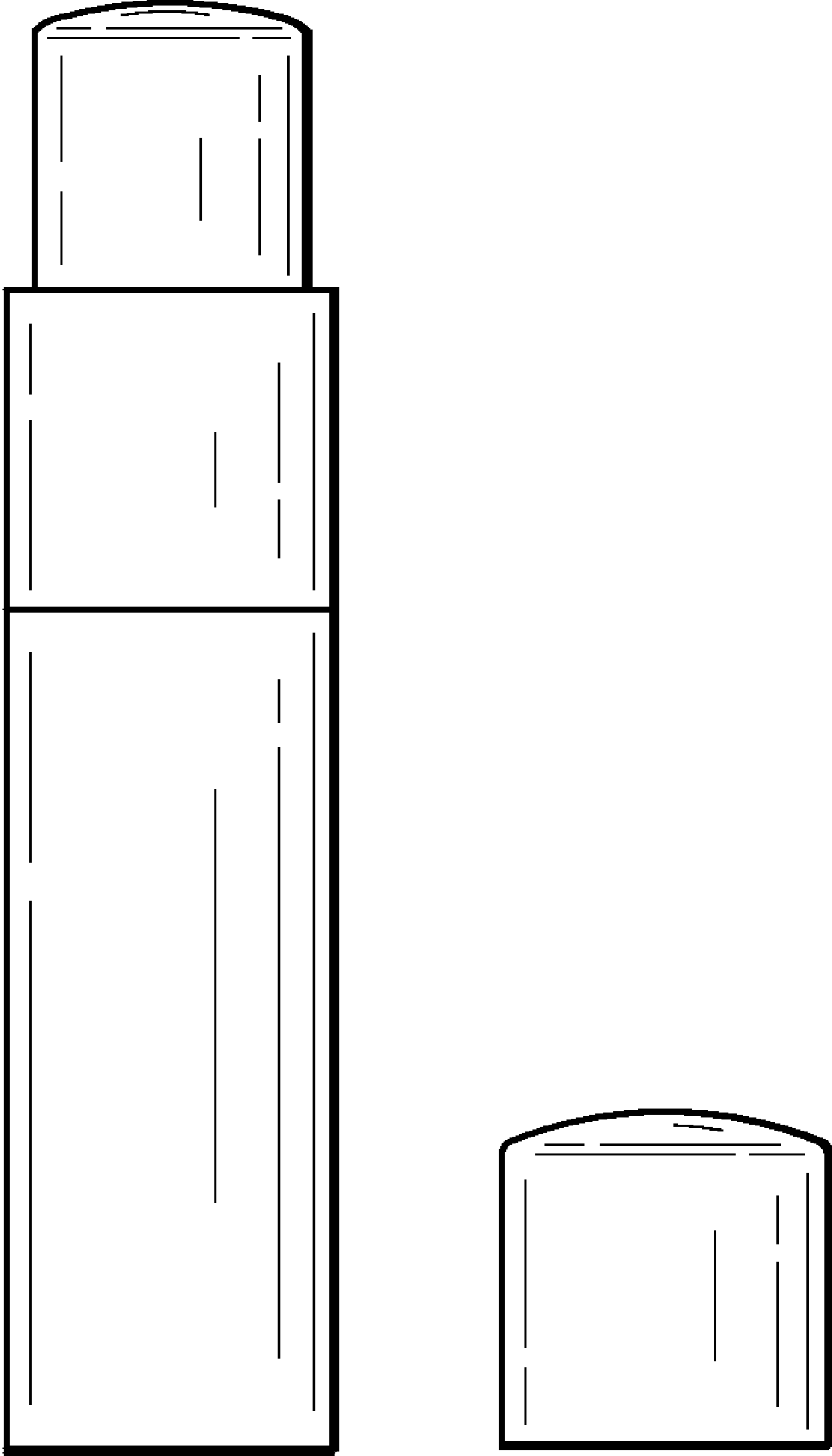
