FIG. 2 illustrates a perspective view of a combined wrist computer or wristwatch and band showing my new design;

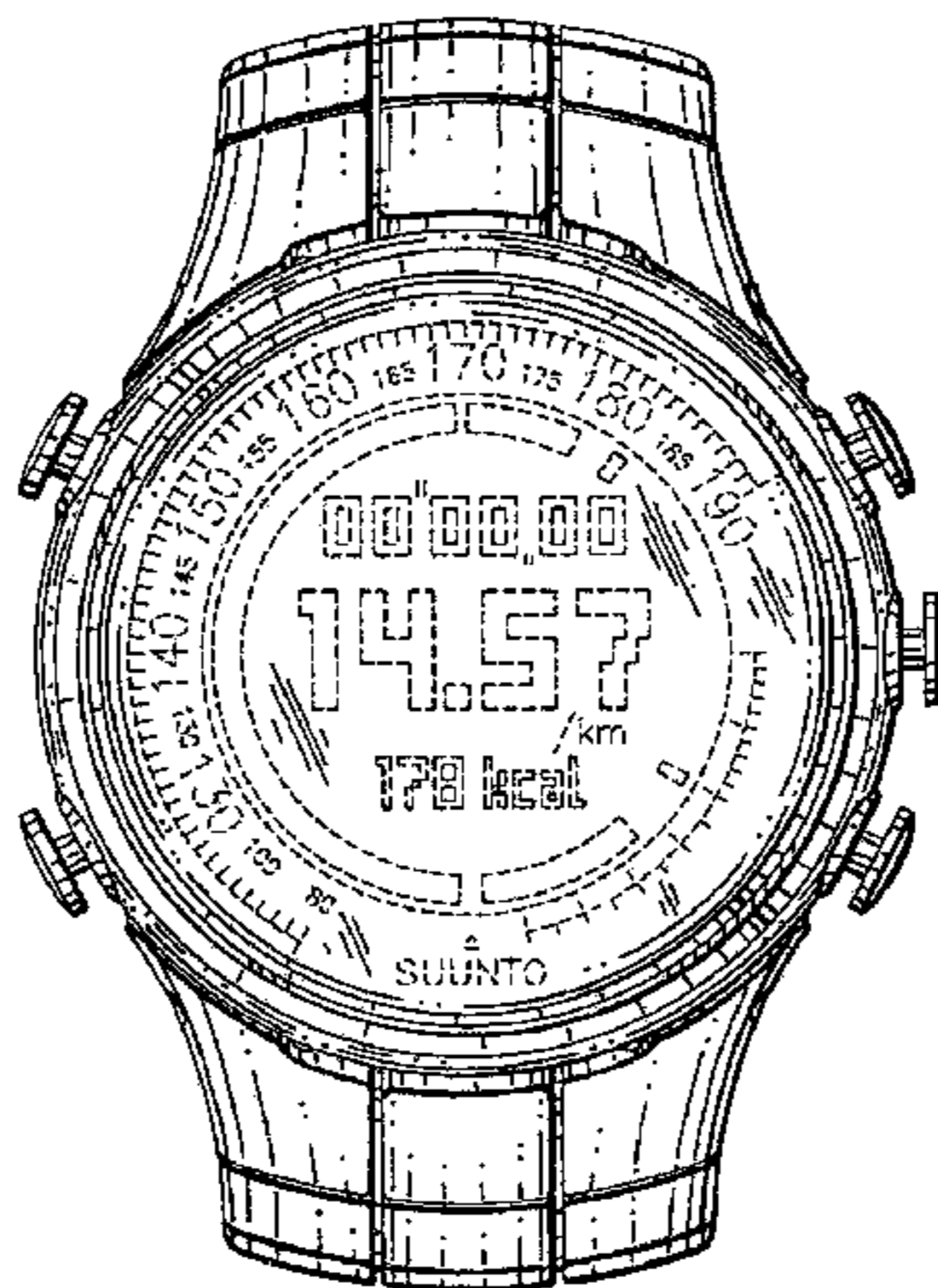
FIG. 3 illustrates a side view of a combined wrist computer or wristwatch and band showing my new design;

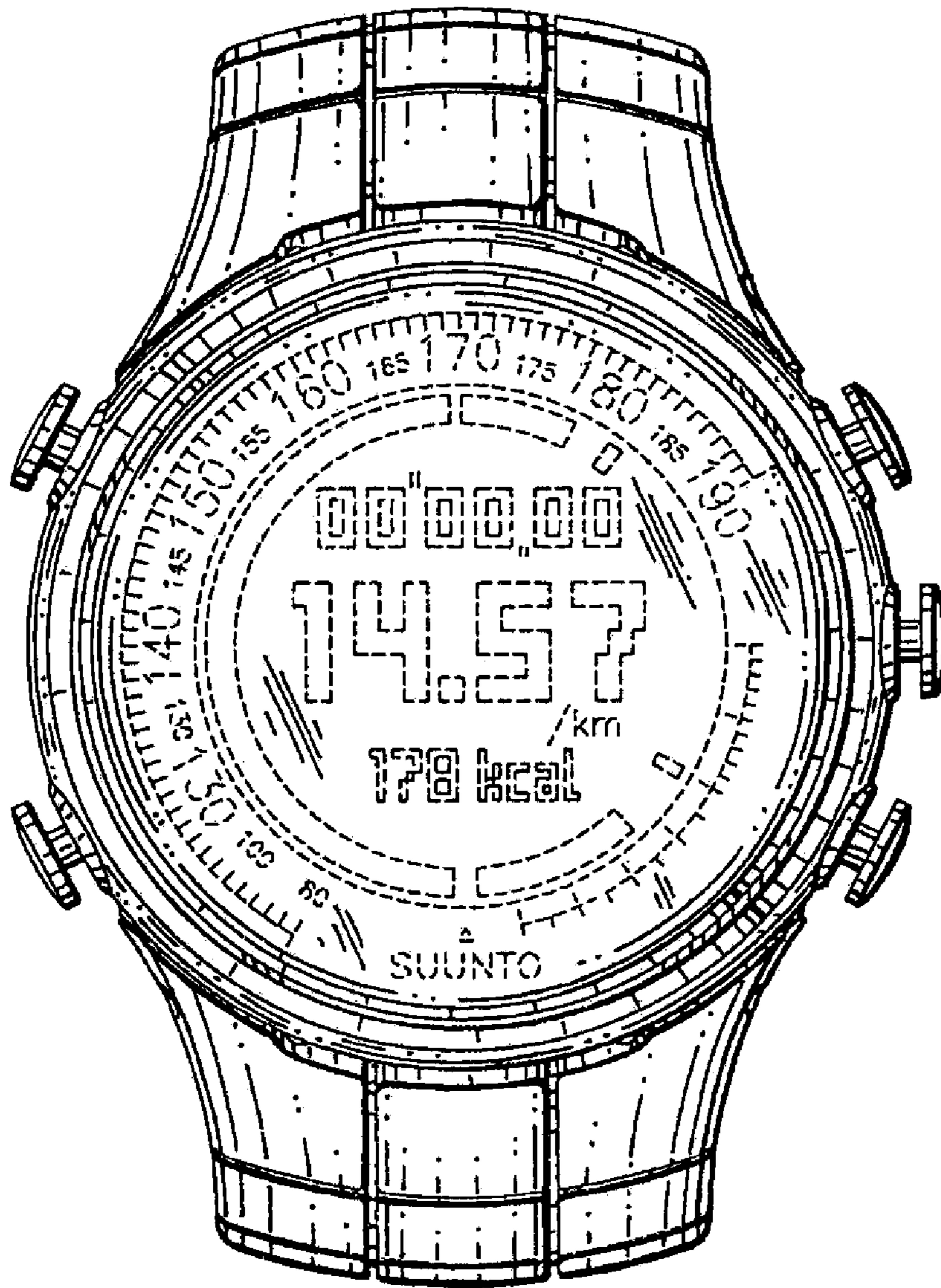

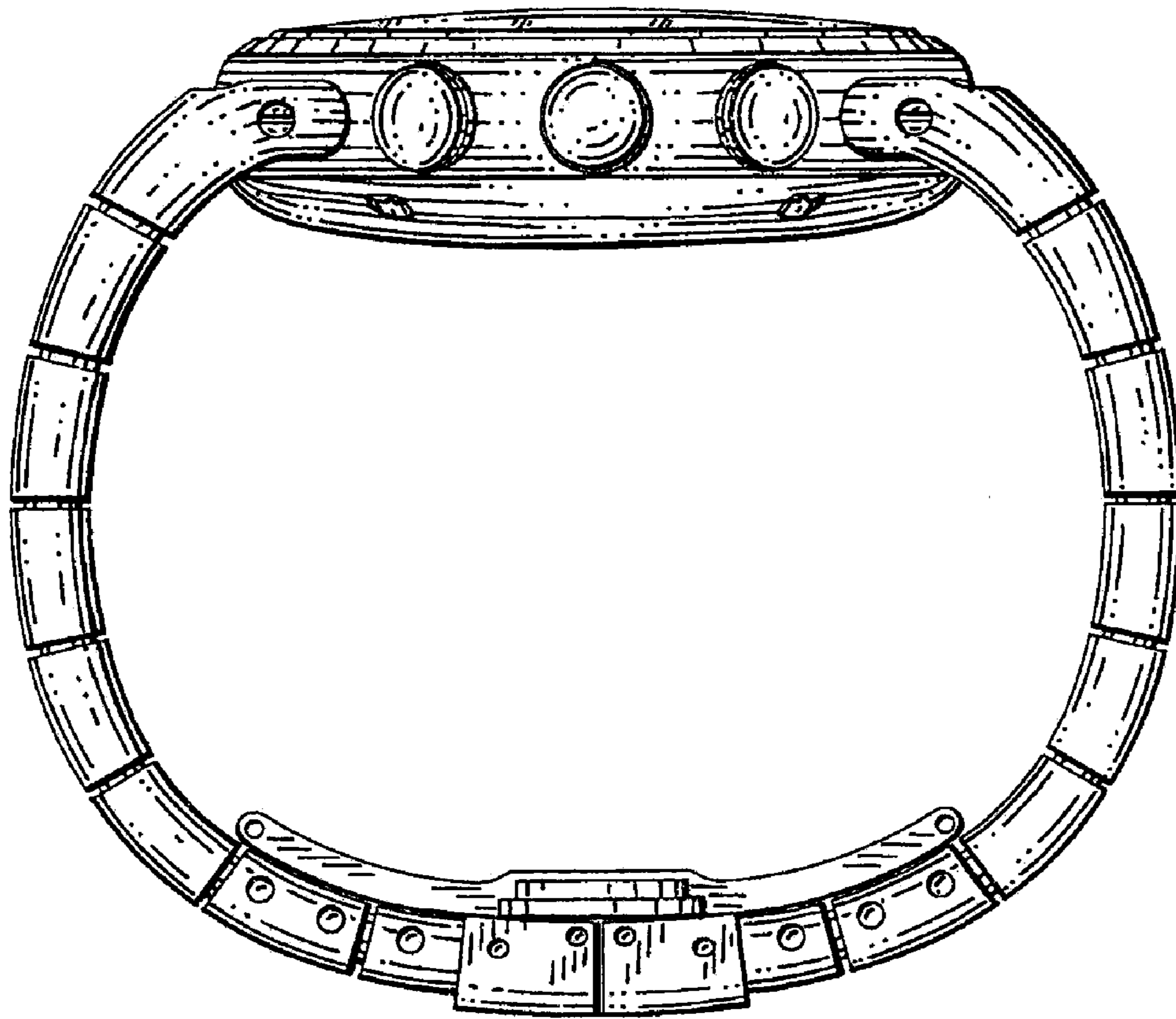

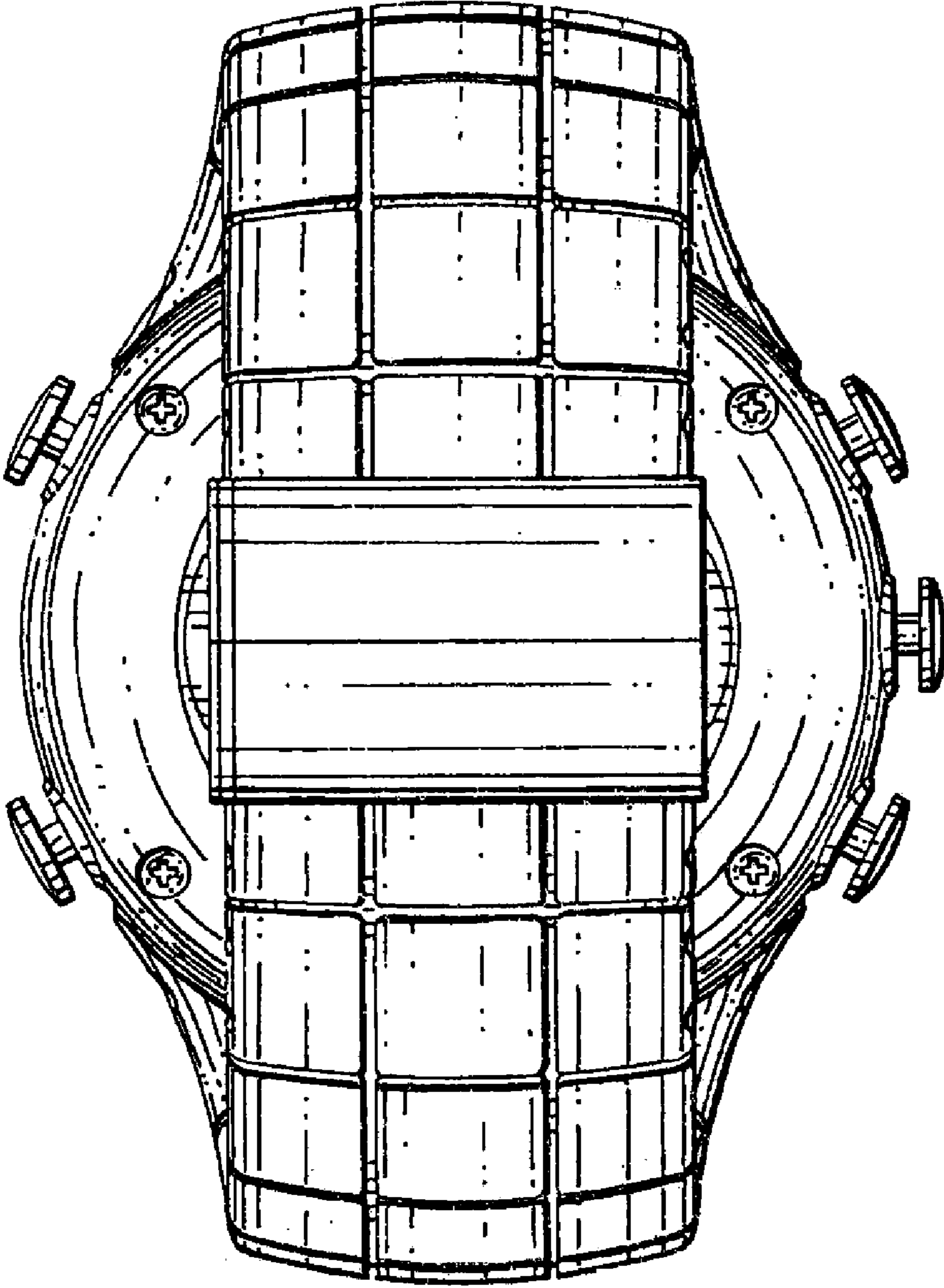

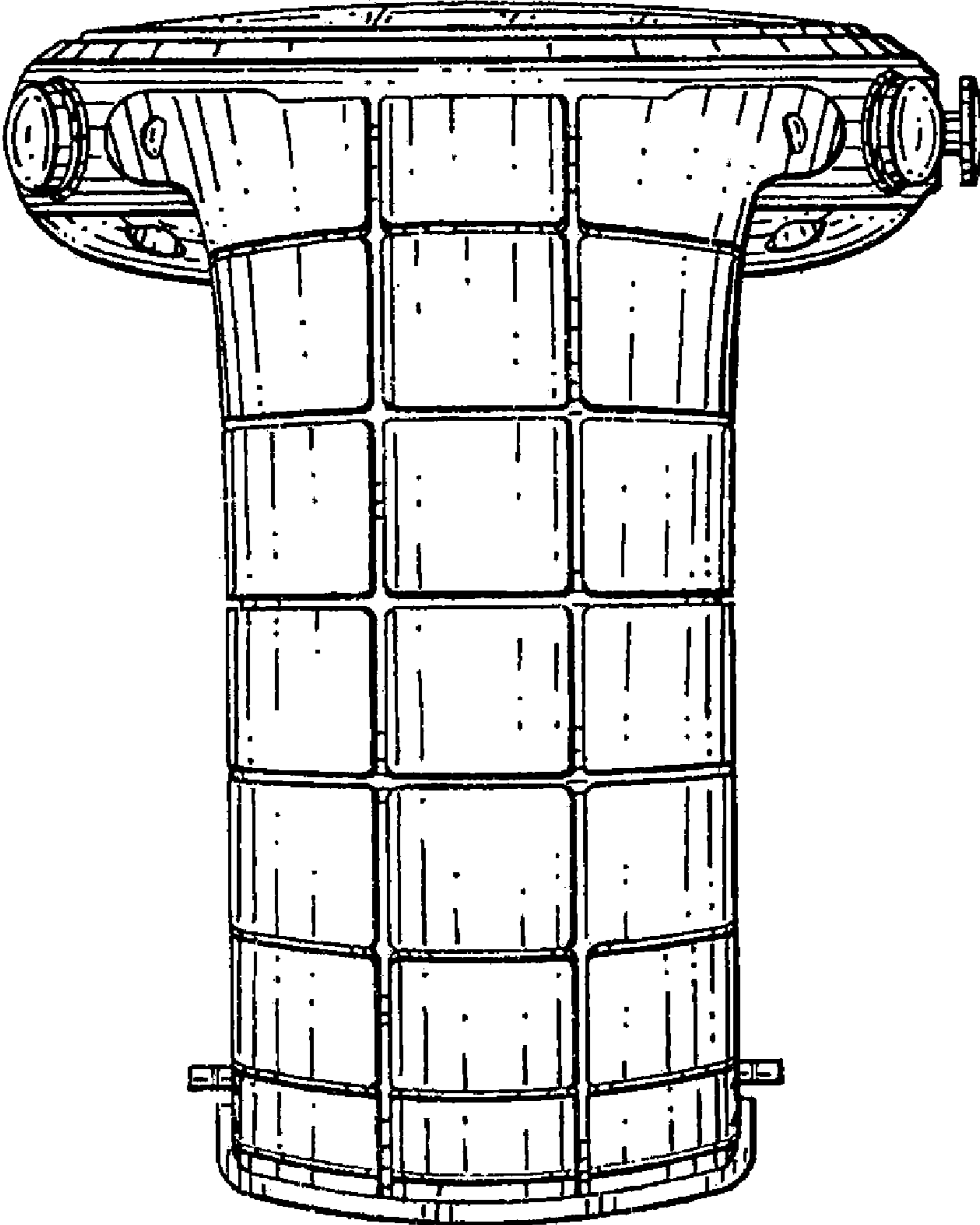
