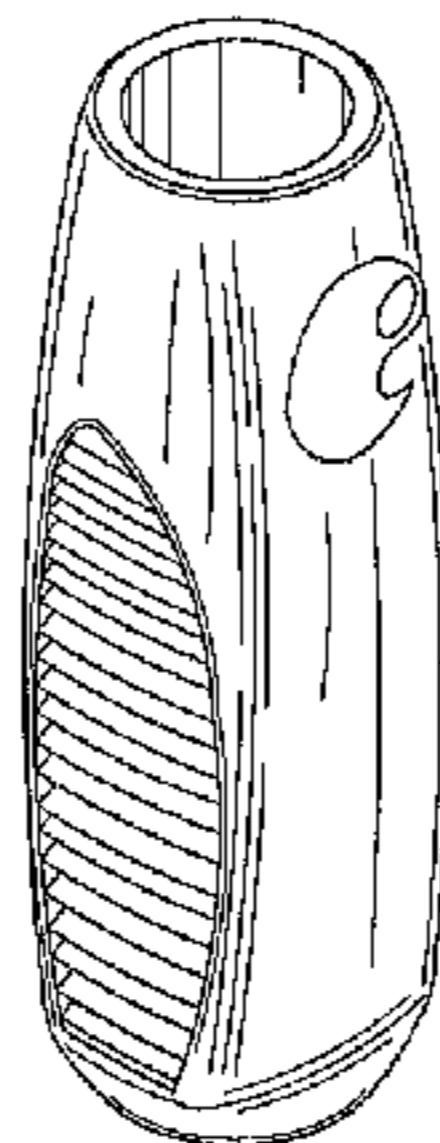
(57) **CLAIM**

FIG. 6 is another perspective view thereof.

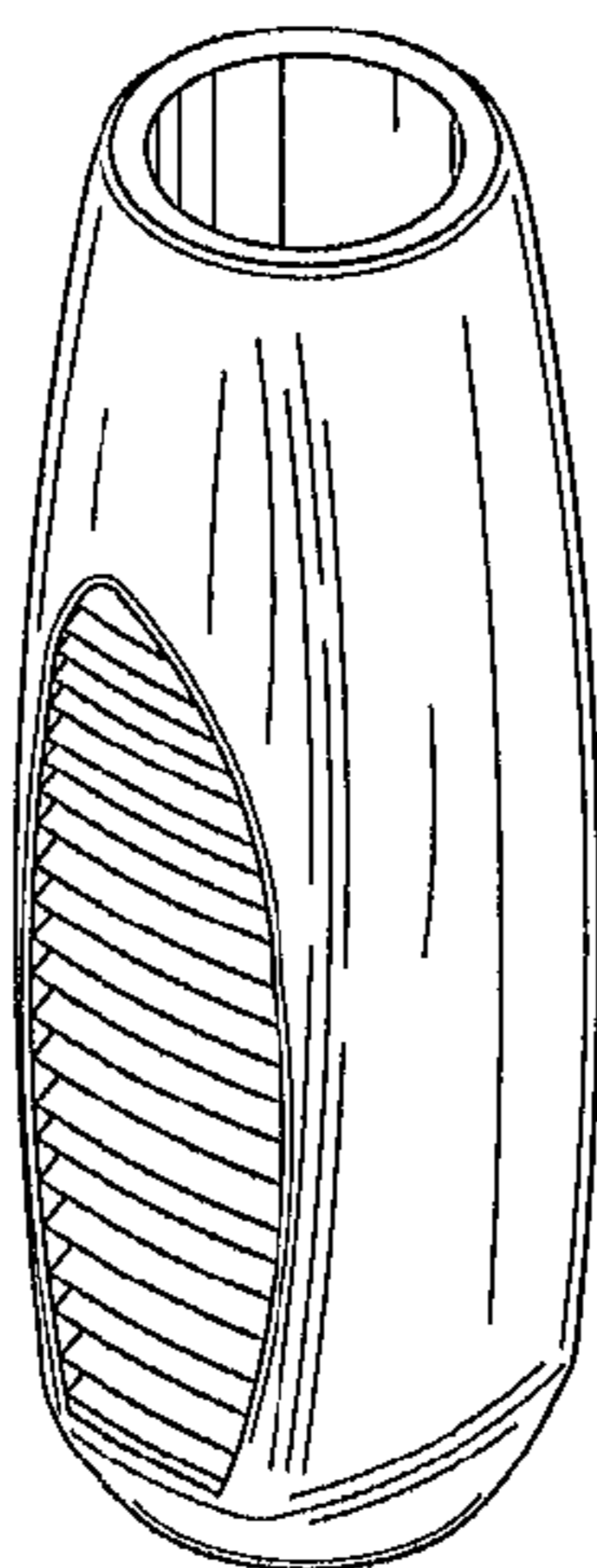

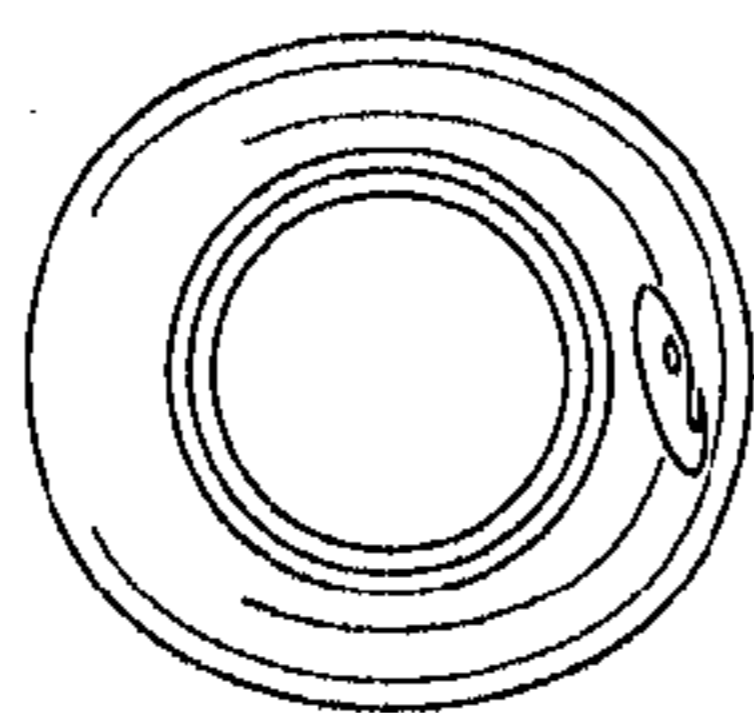

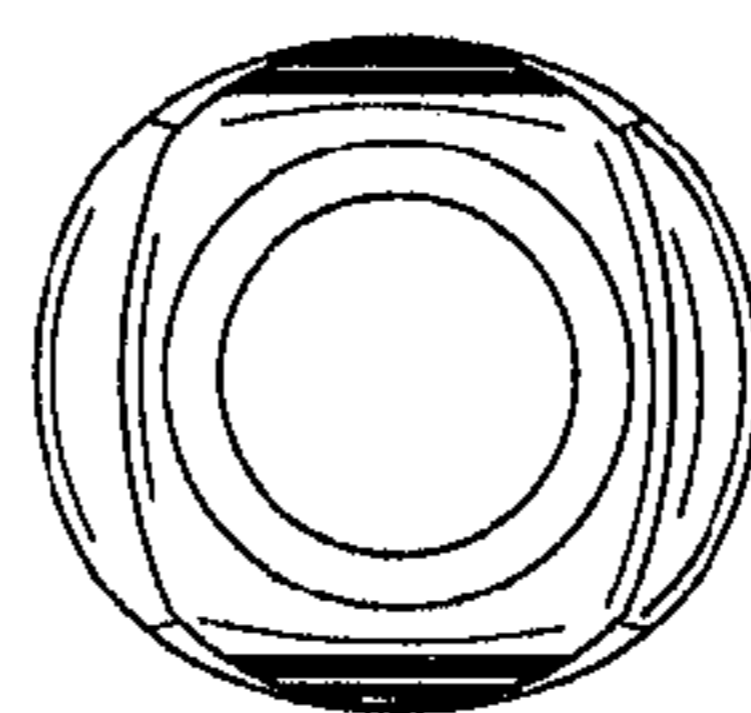

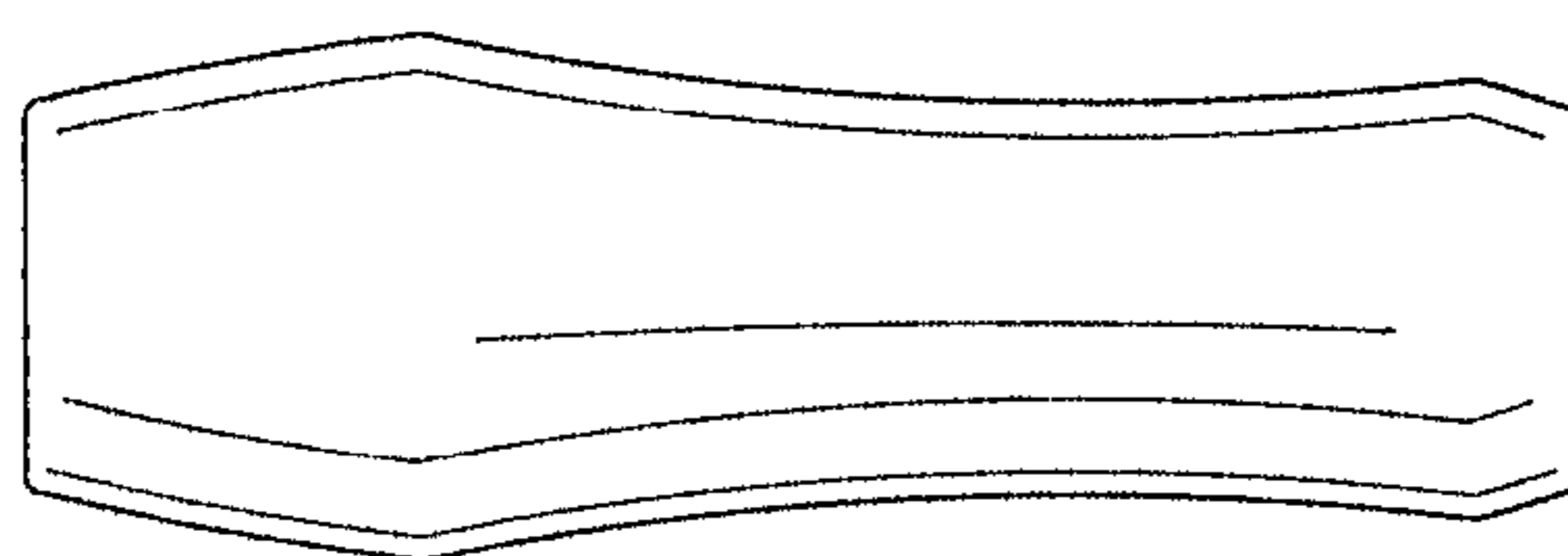

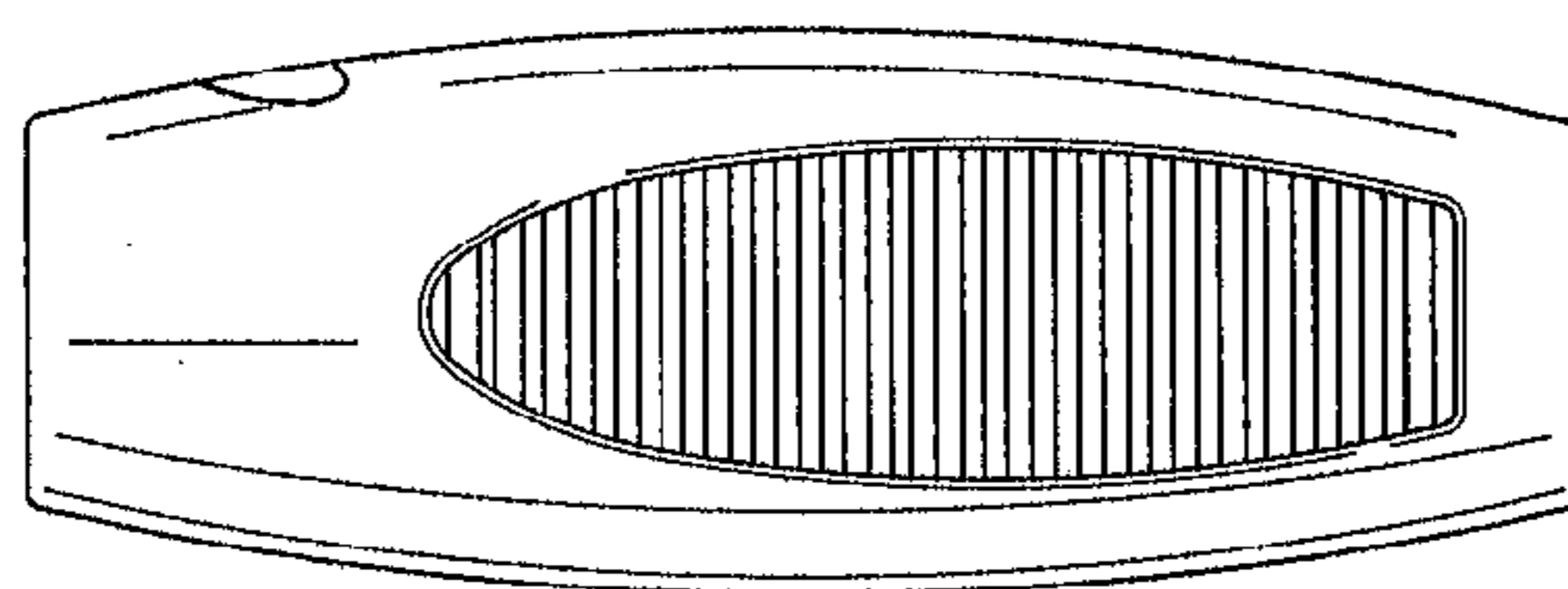

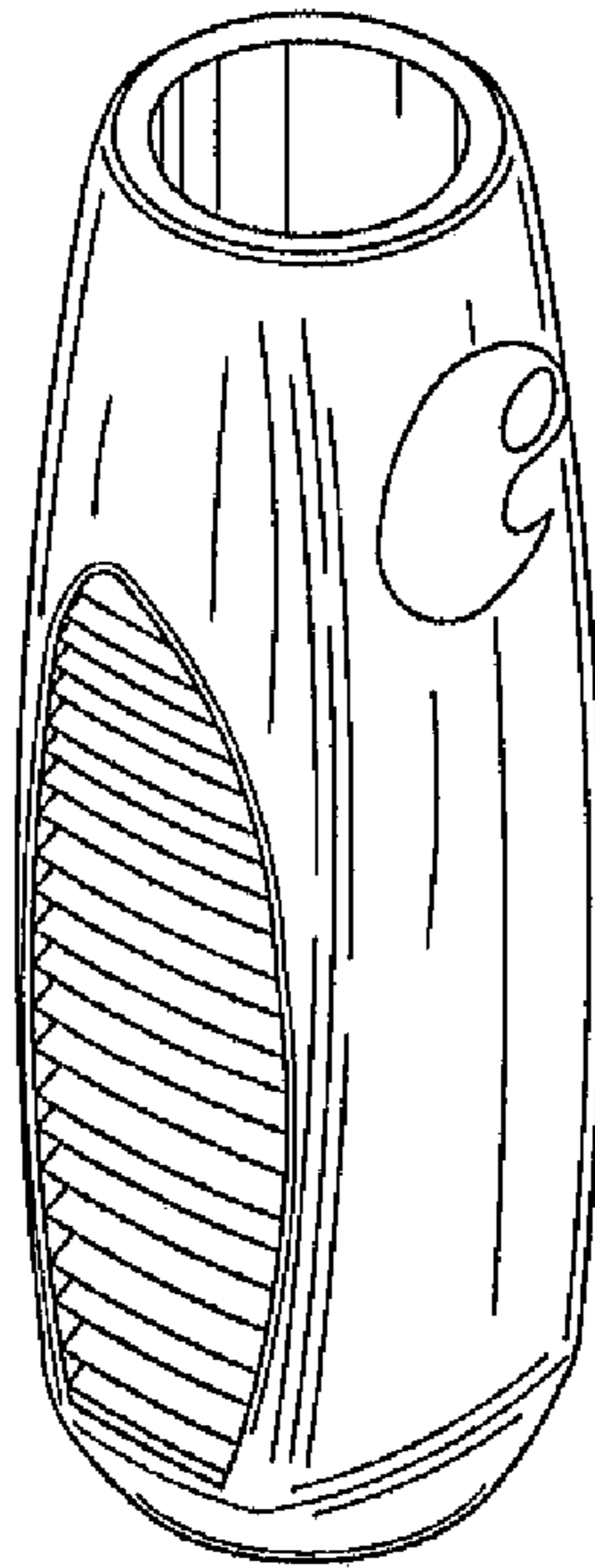
