(57) **CLAIM**

The ornamental design for a pair of earphones, as shown and described.

**DESCRIPTION**

FIG. 1 is a left front perspective view of a pair of earphones in accordance with my new design;

FIG. 2 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof, with one earphone shown separately for purposes of illustration;

FIG. 12 is a left side elevational view thereof;

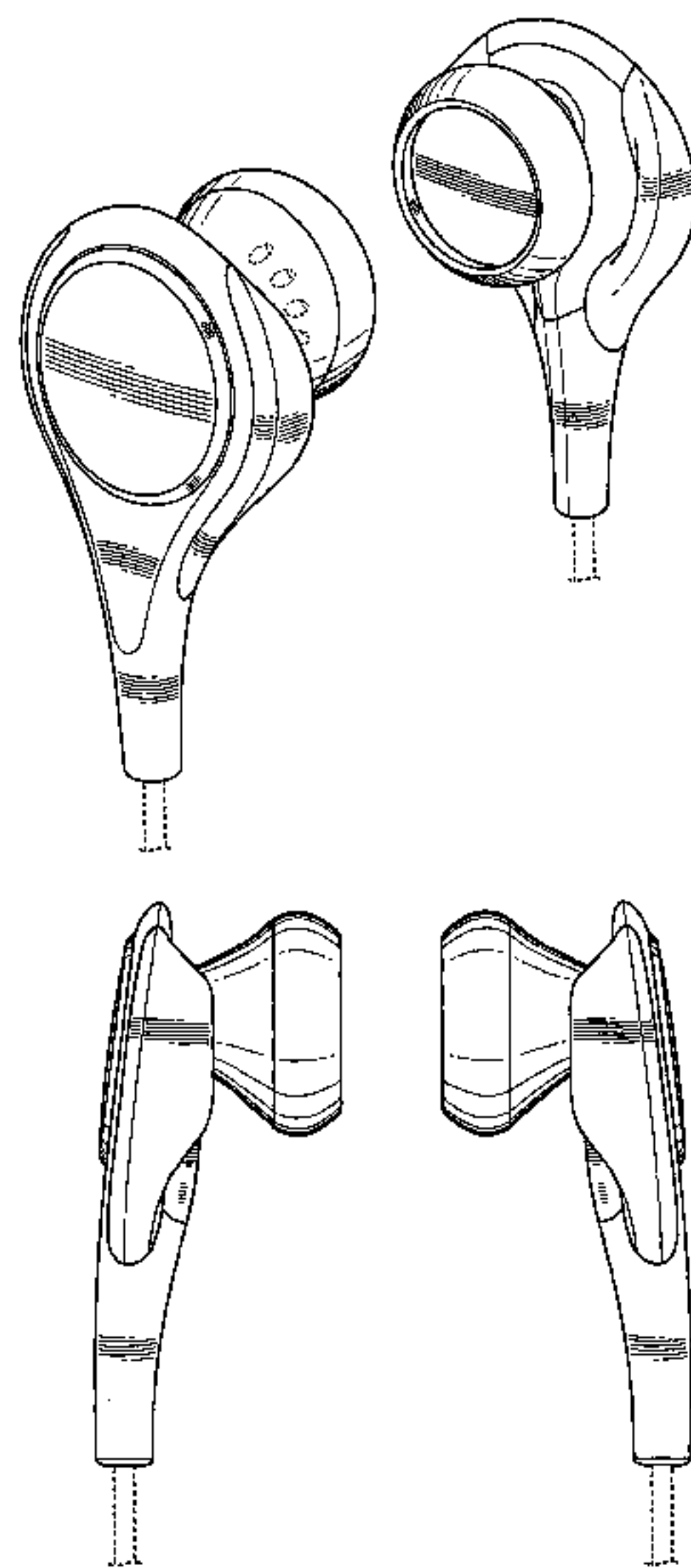
FIG. 13 is a right side elevational view thereof;

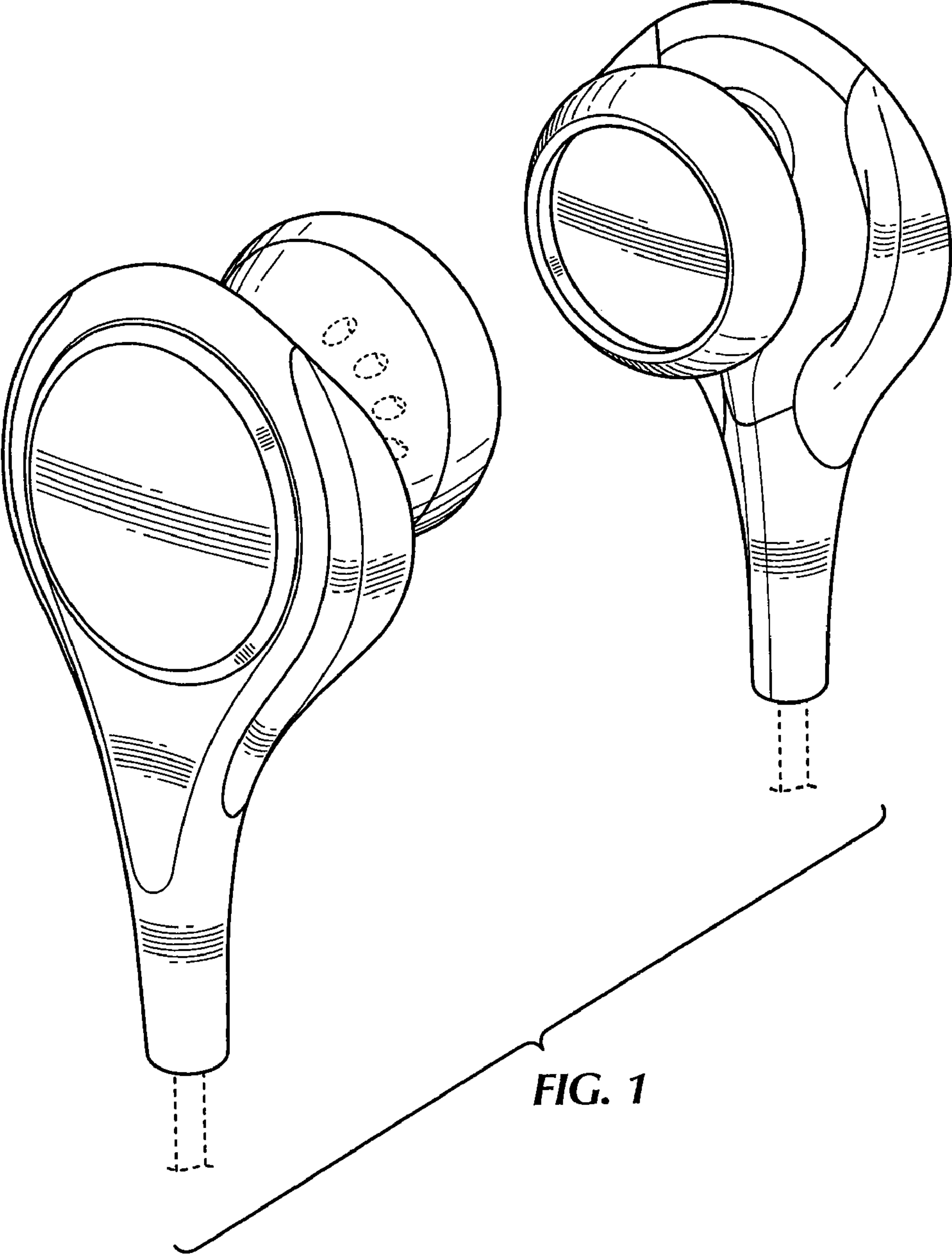
FIG. 14 is a top plan view thereof; and,

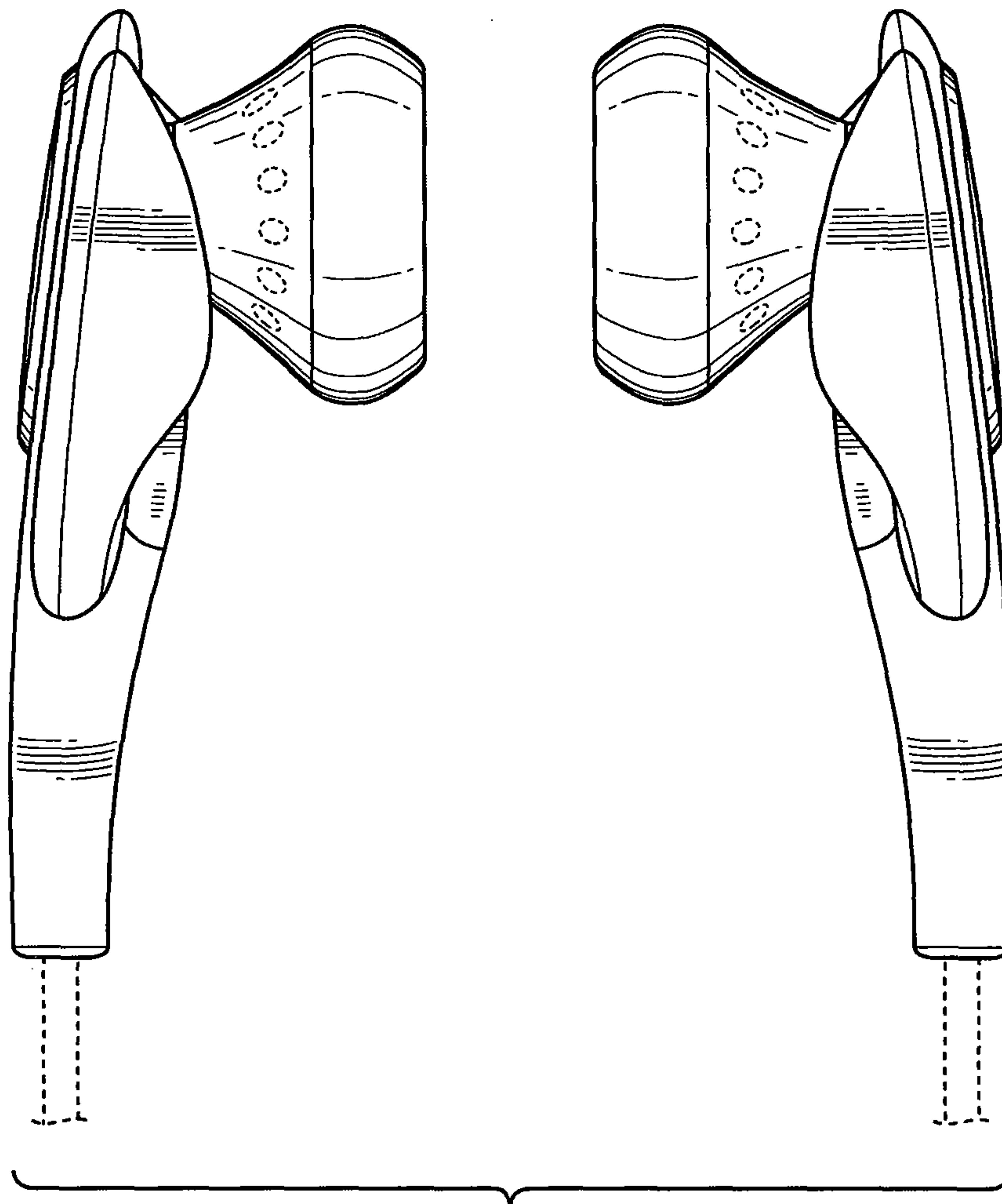

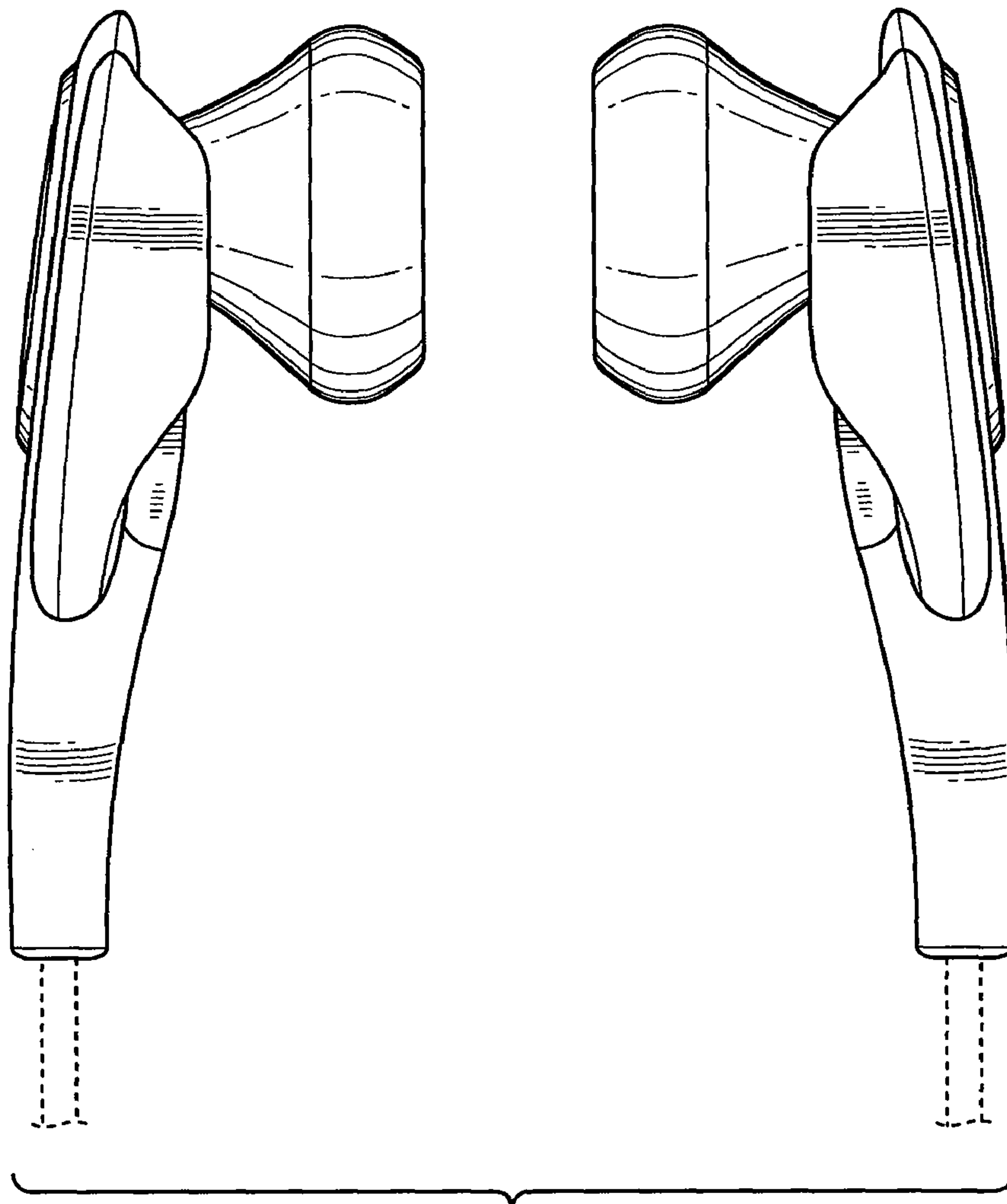
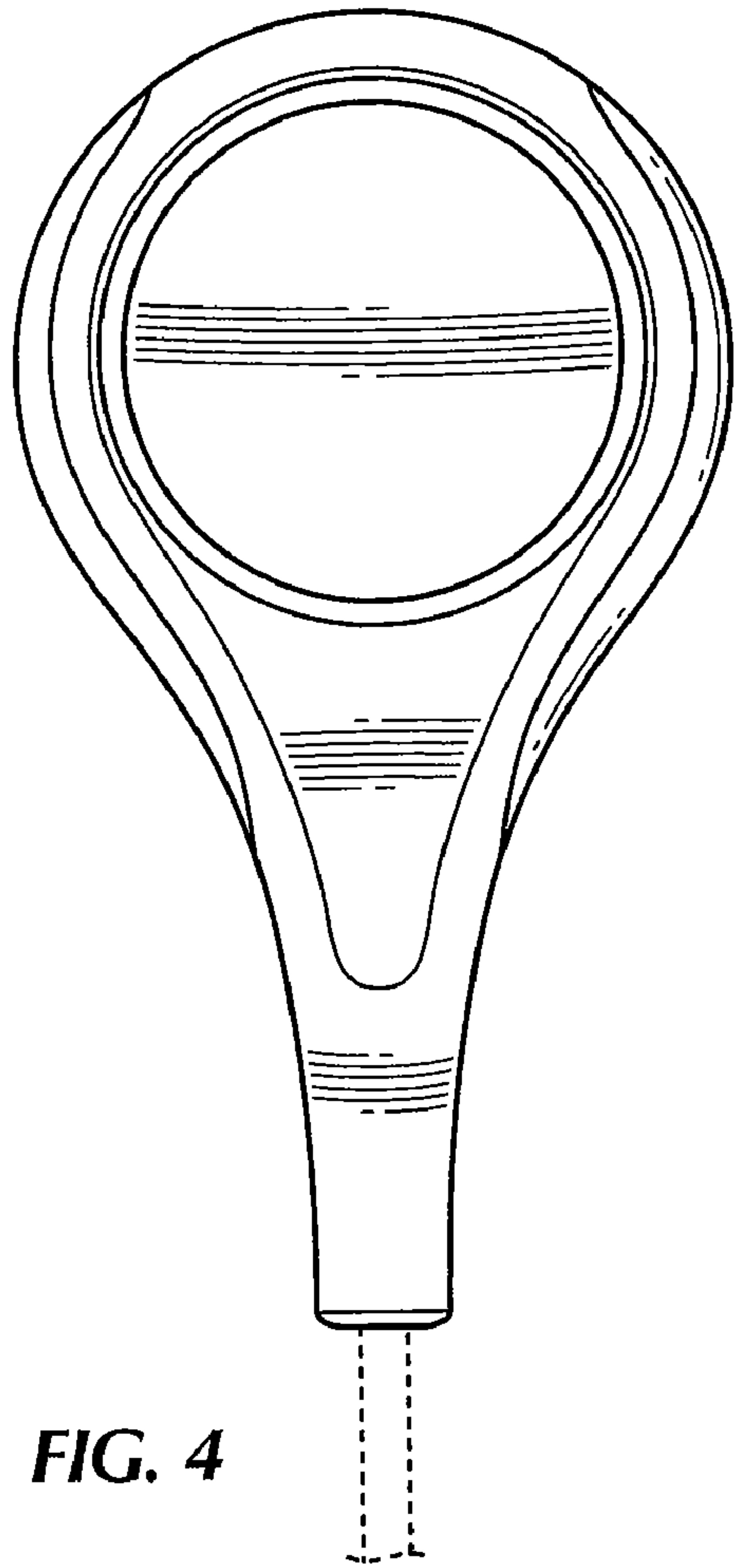
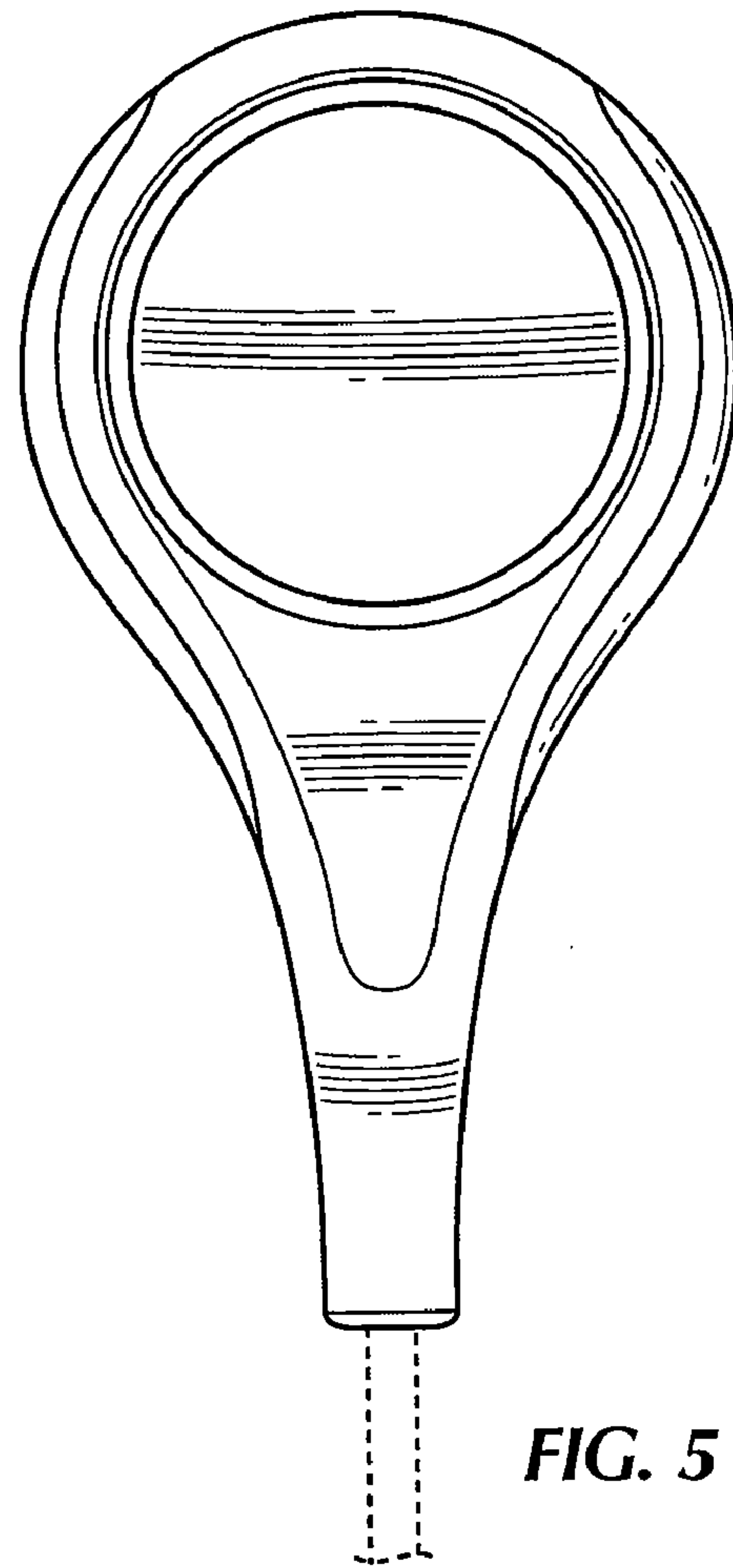

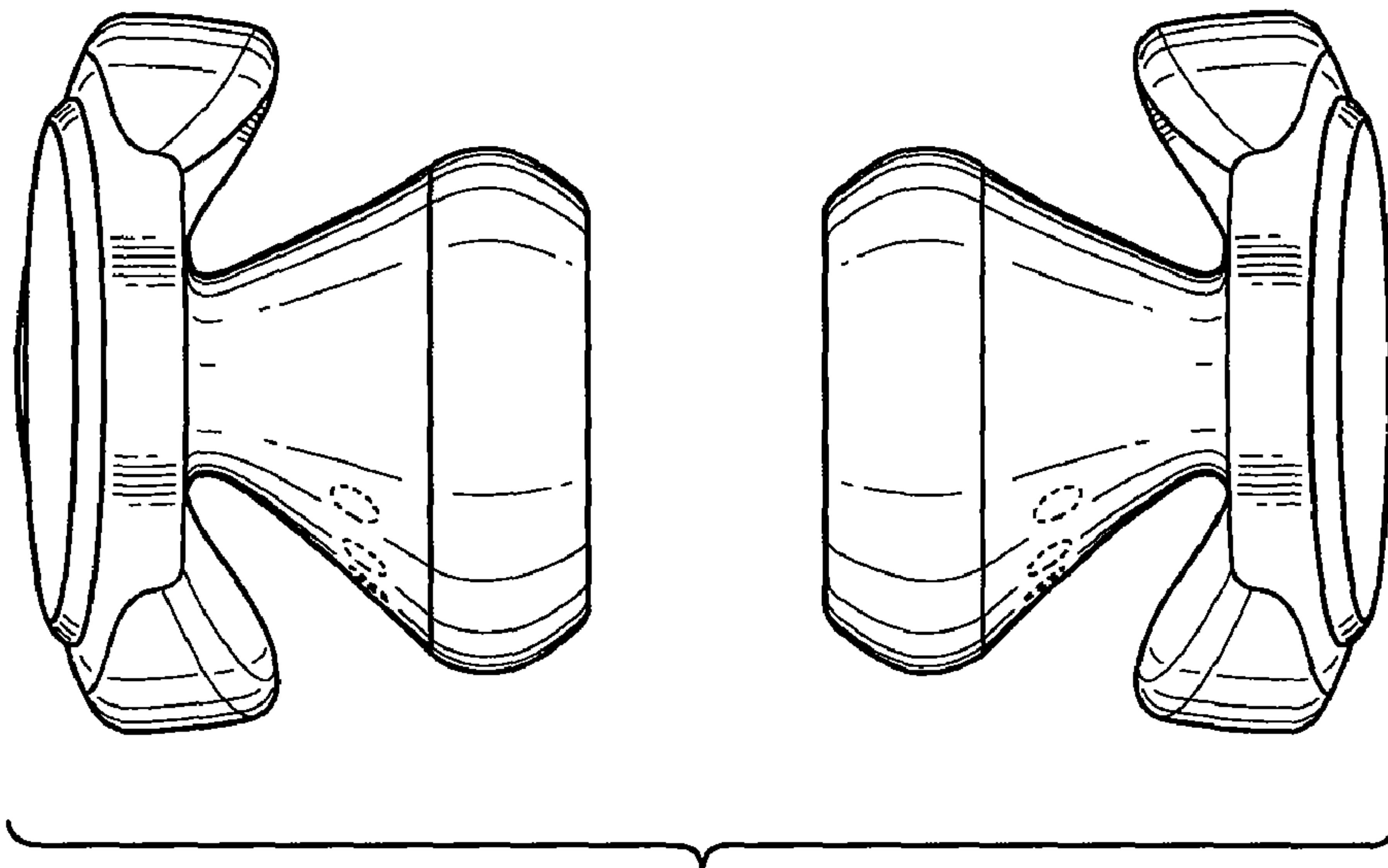

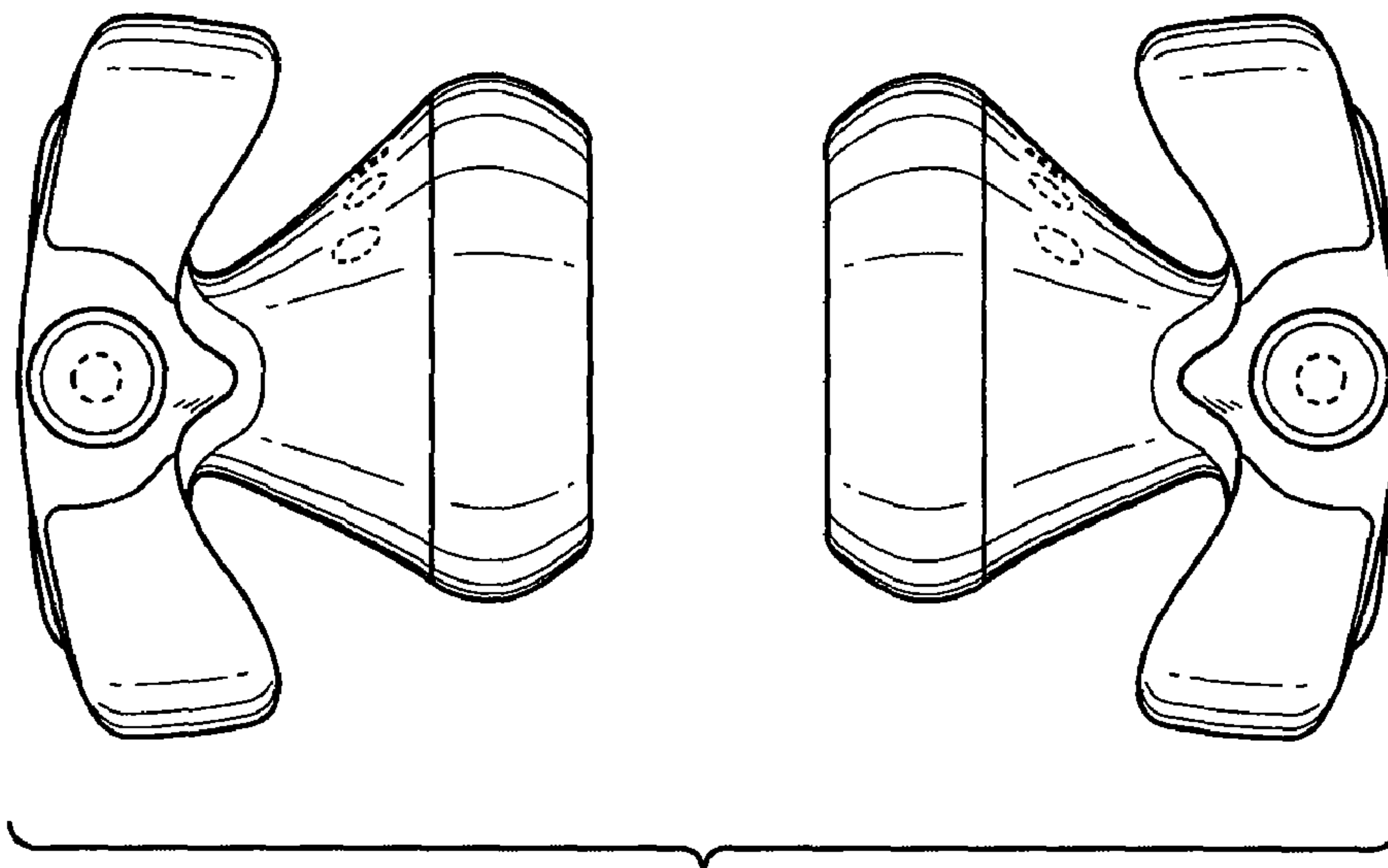
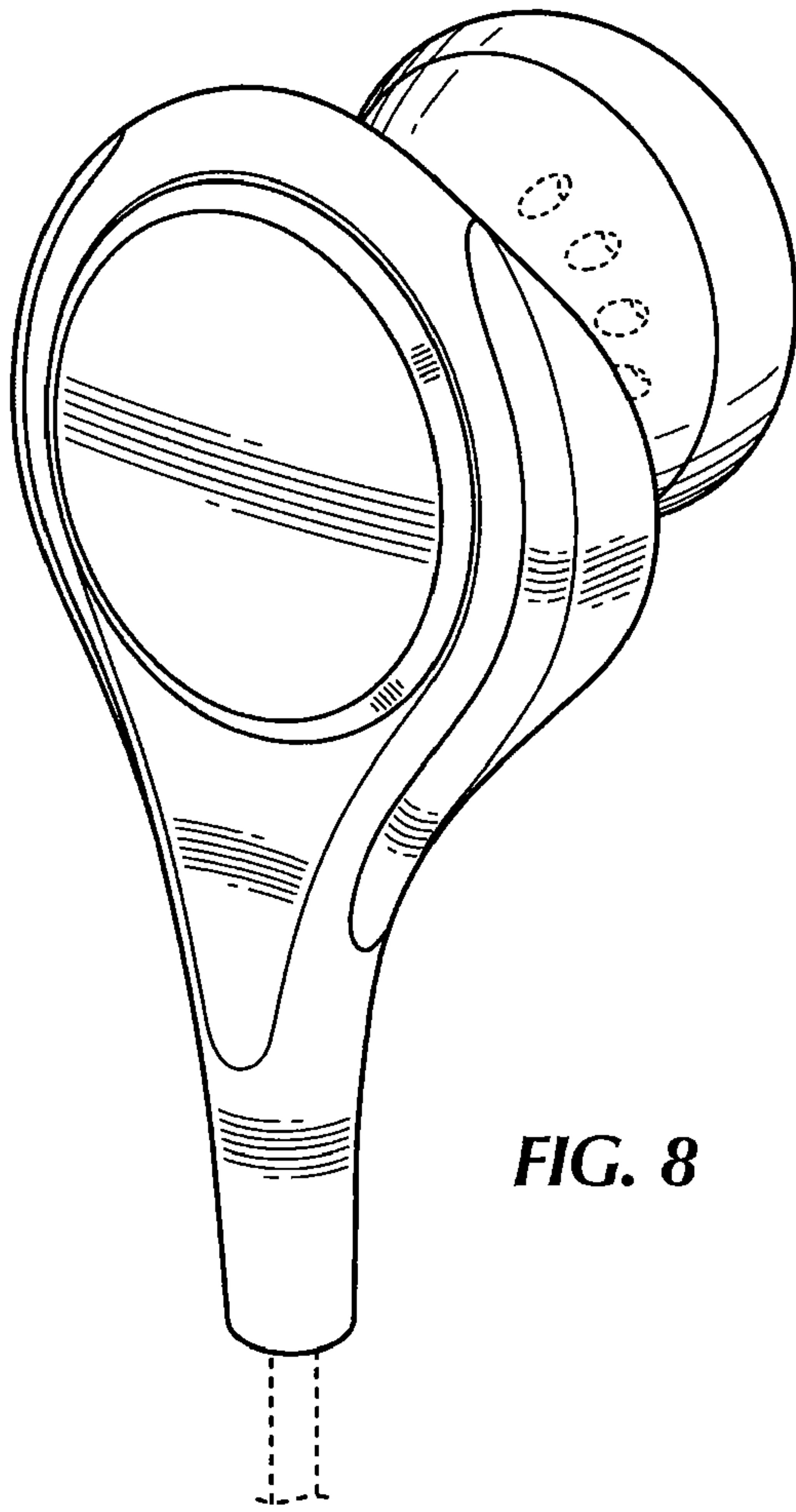
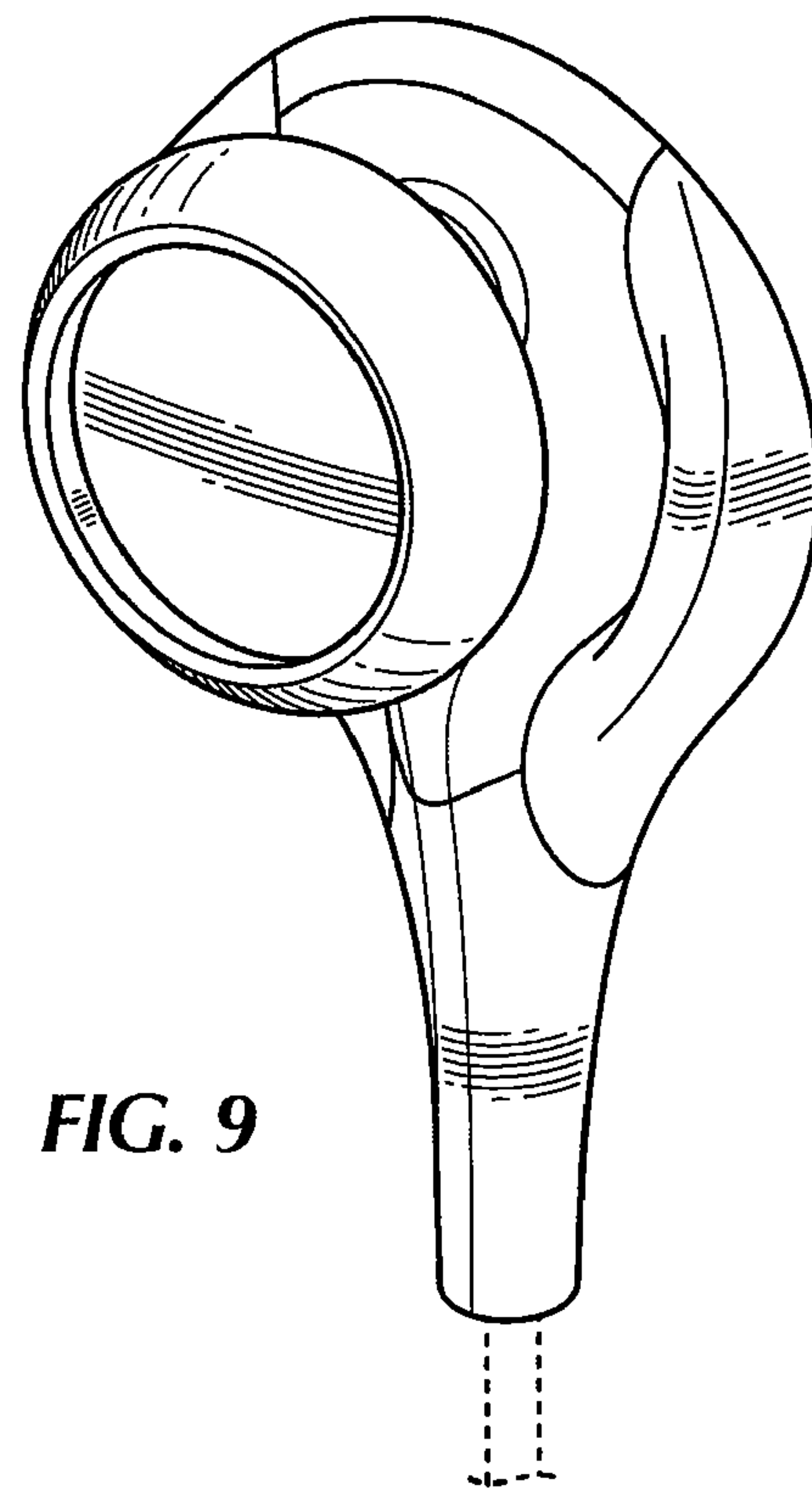


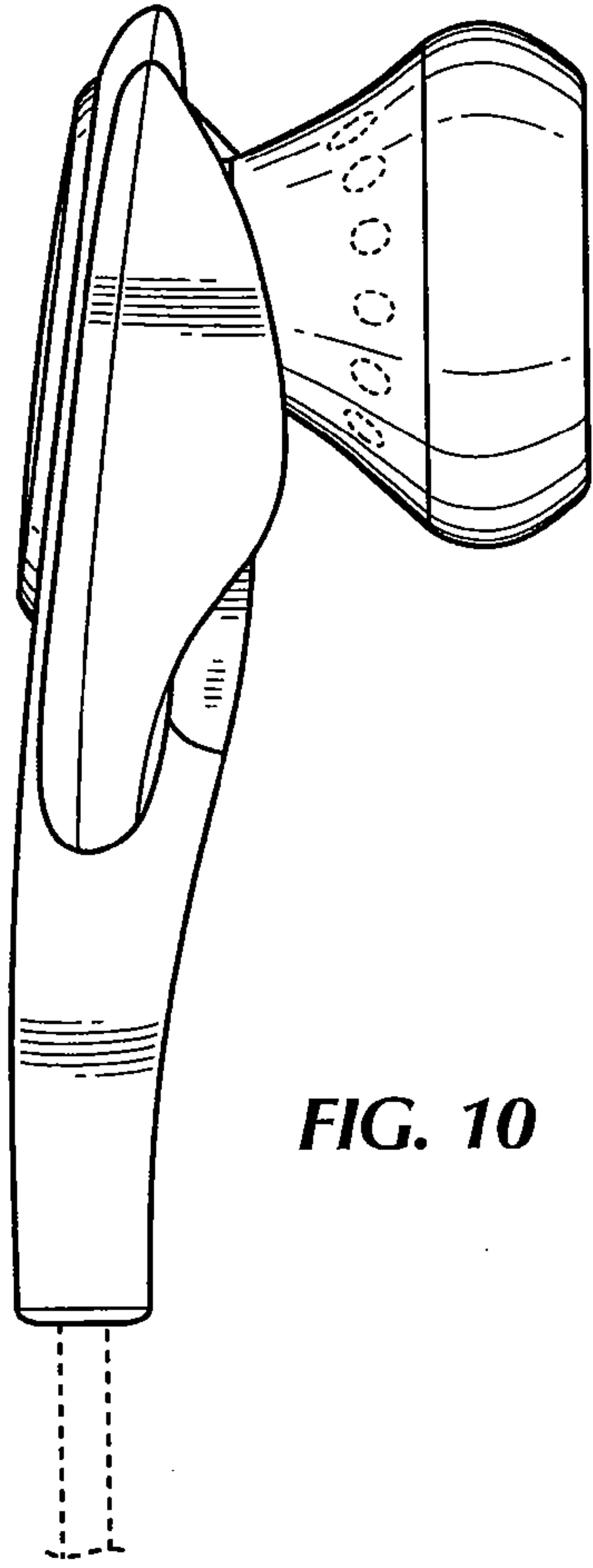

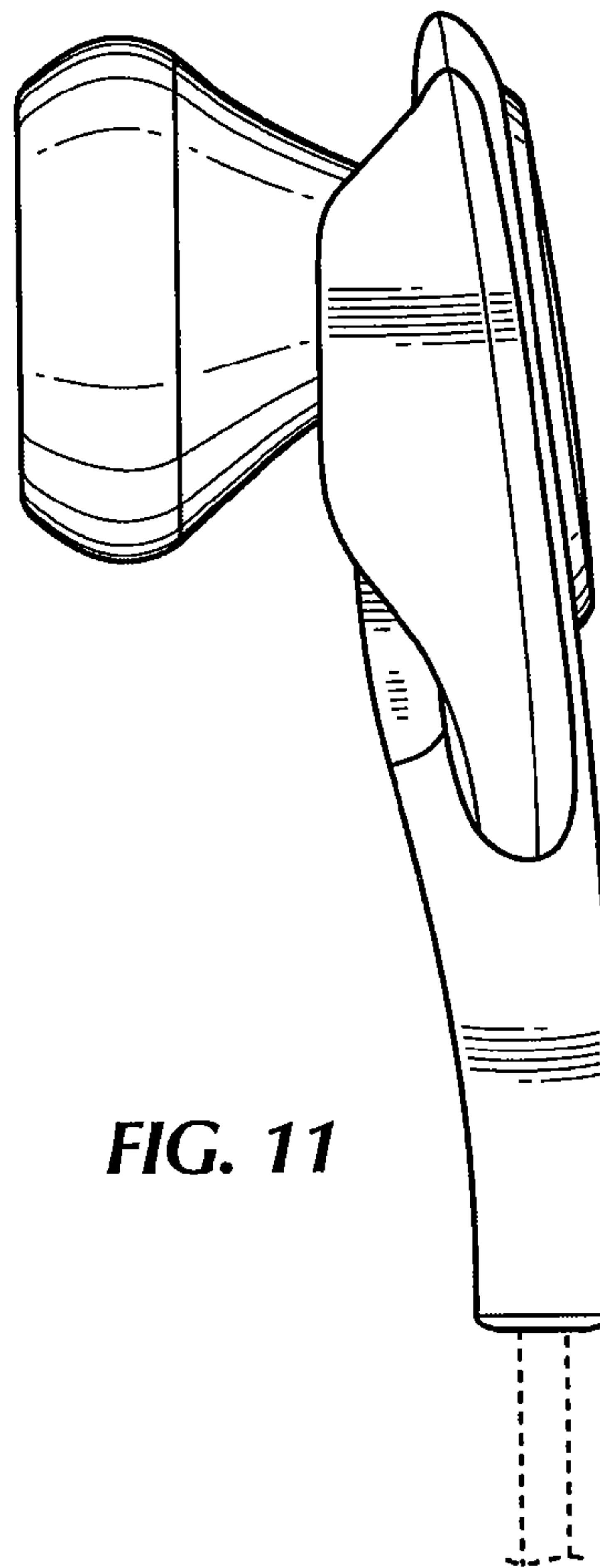

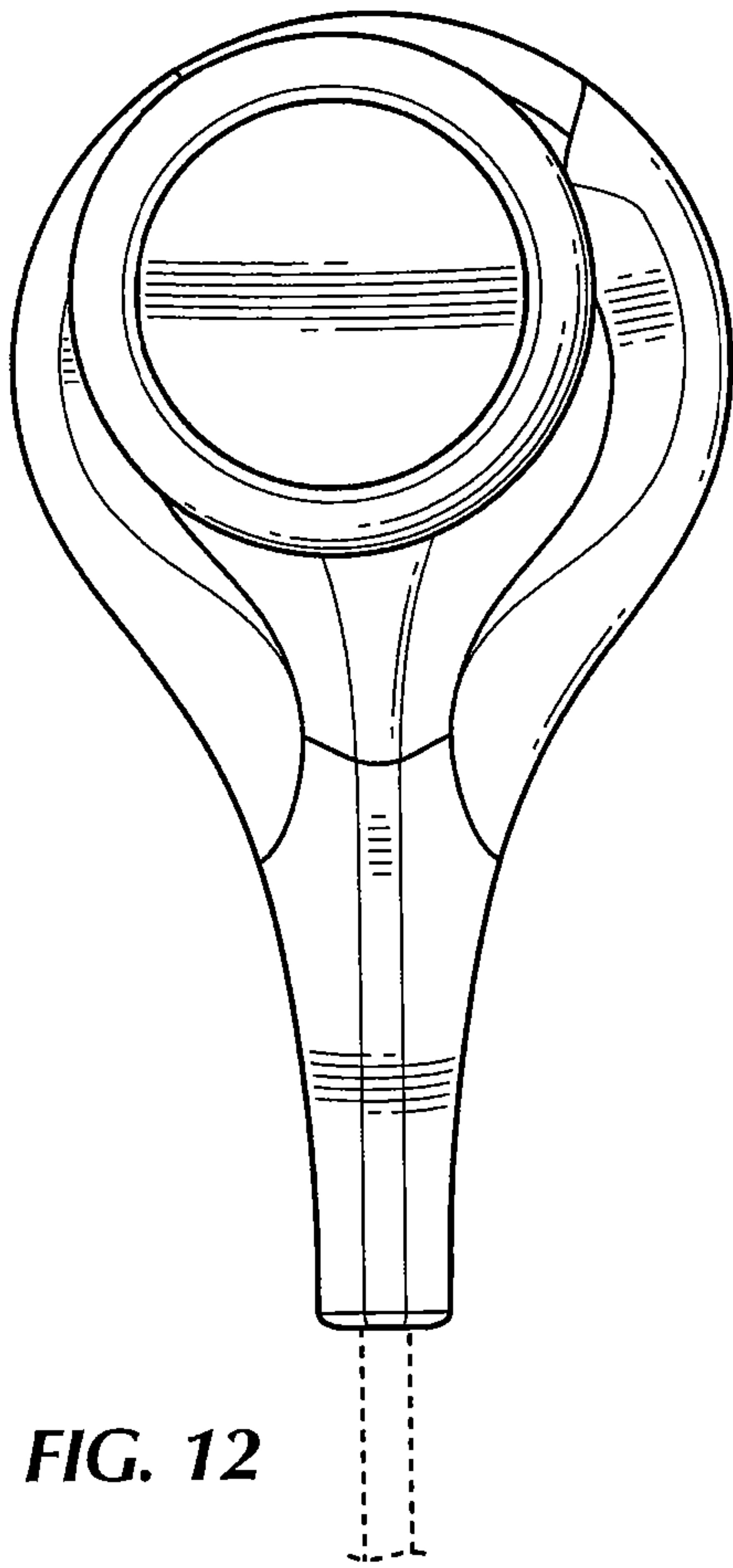

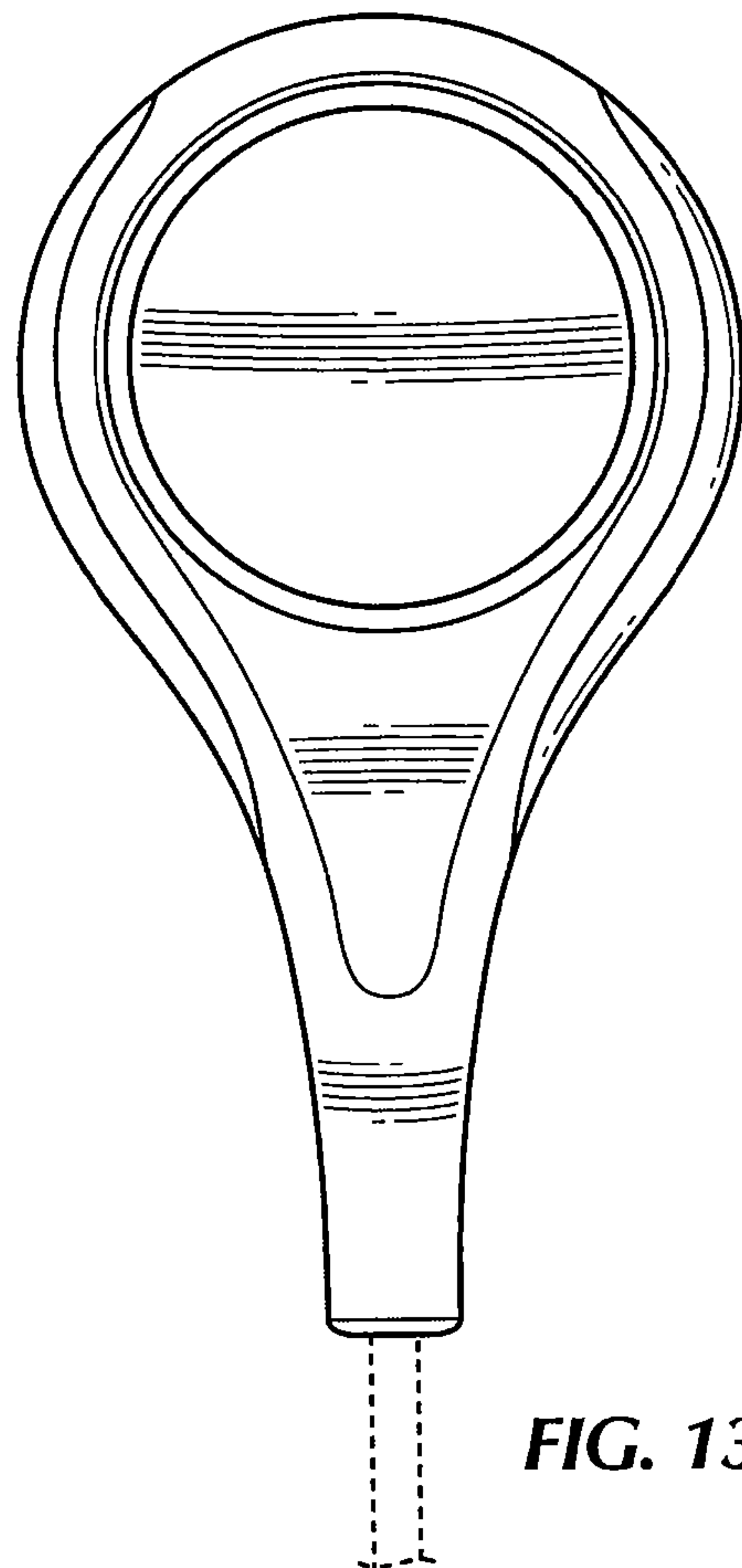

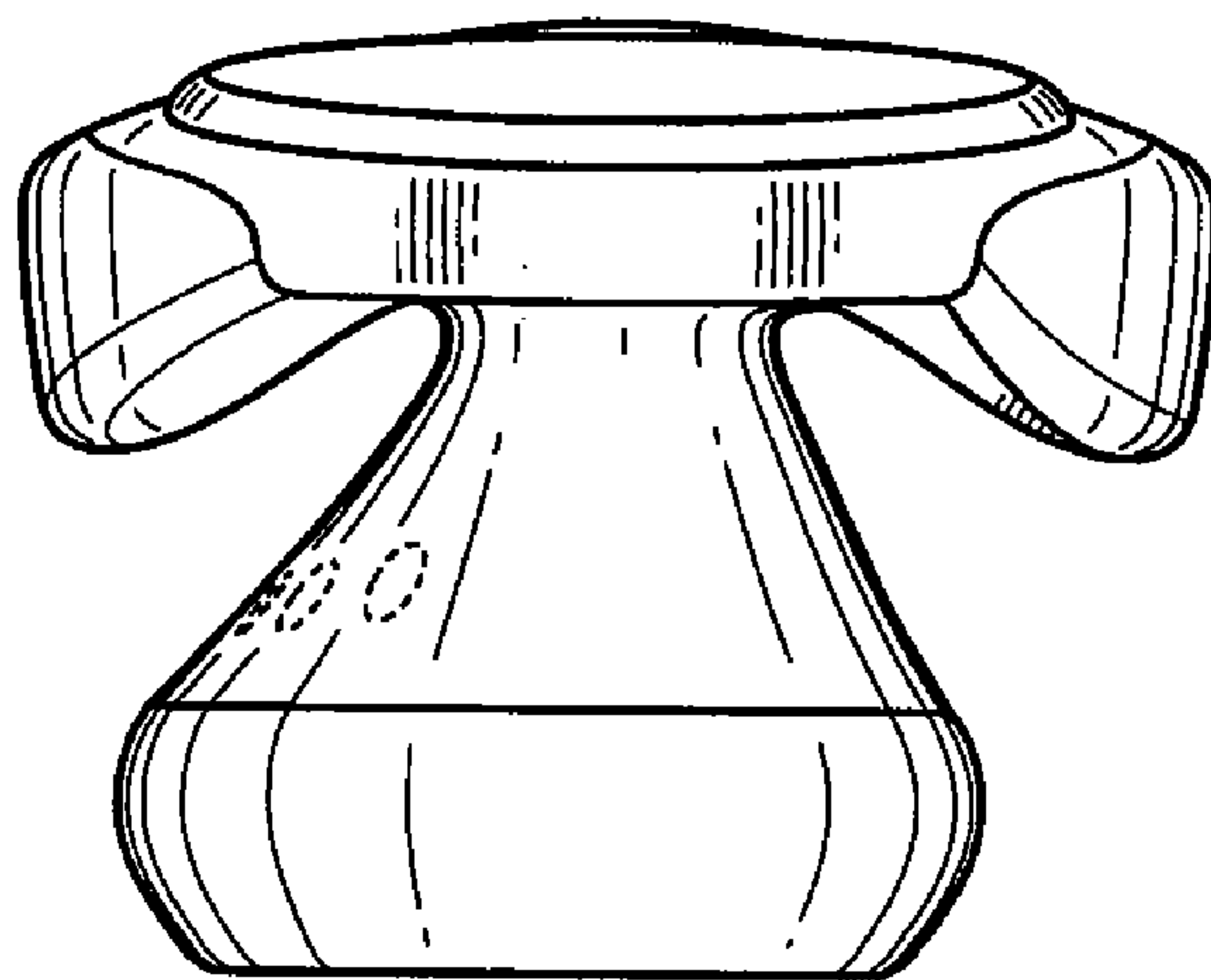




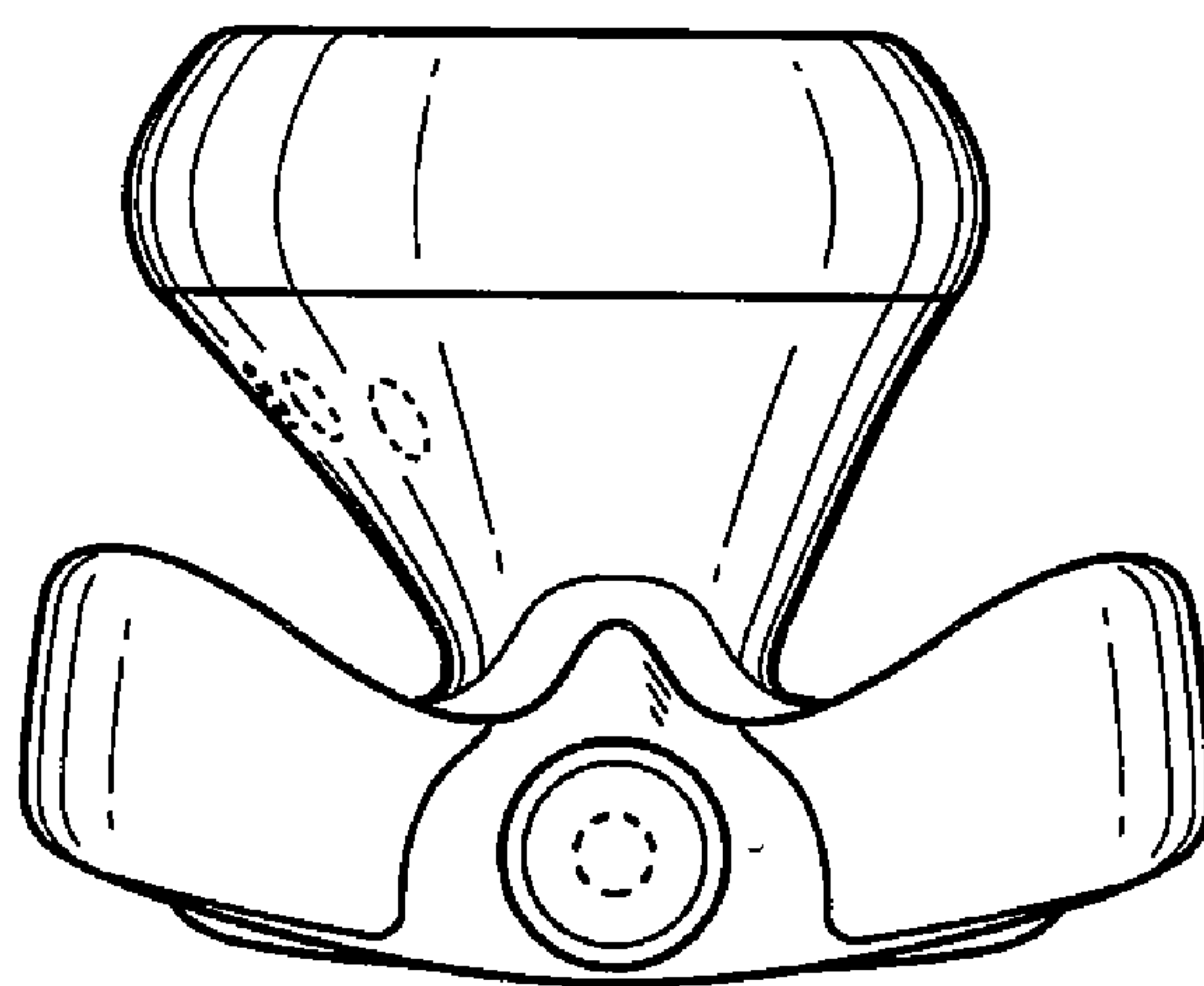
