DESCRIPTION

FIG. 1 is a front perspective view of the cell phone skin case, showing my new design;

FIG. 8 is a bottom plan view of the cell phone skin case of FIG. 1.

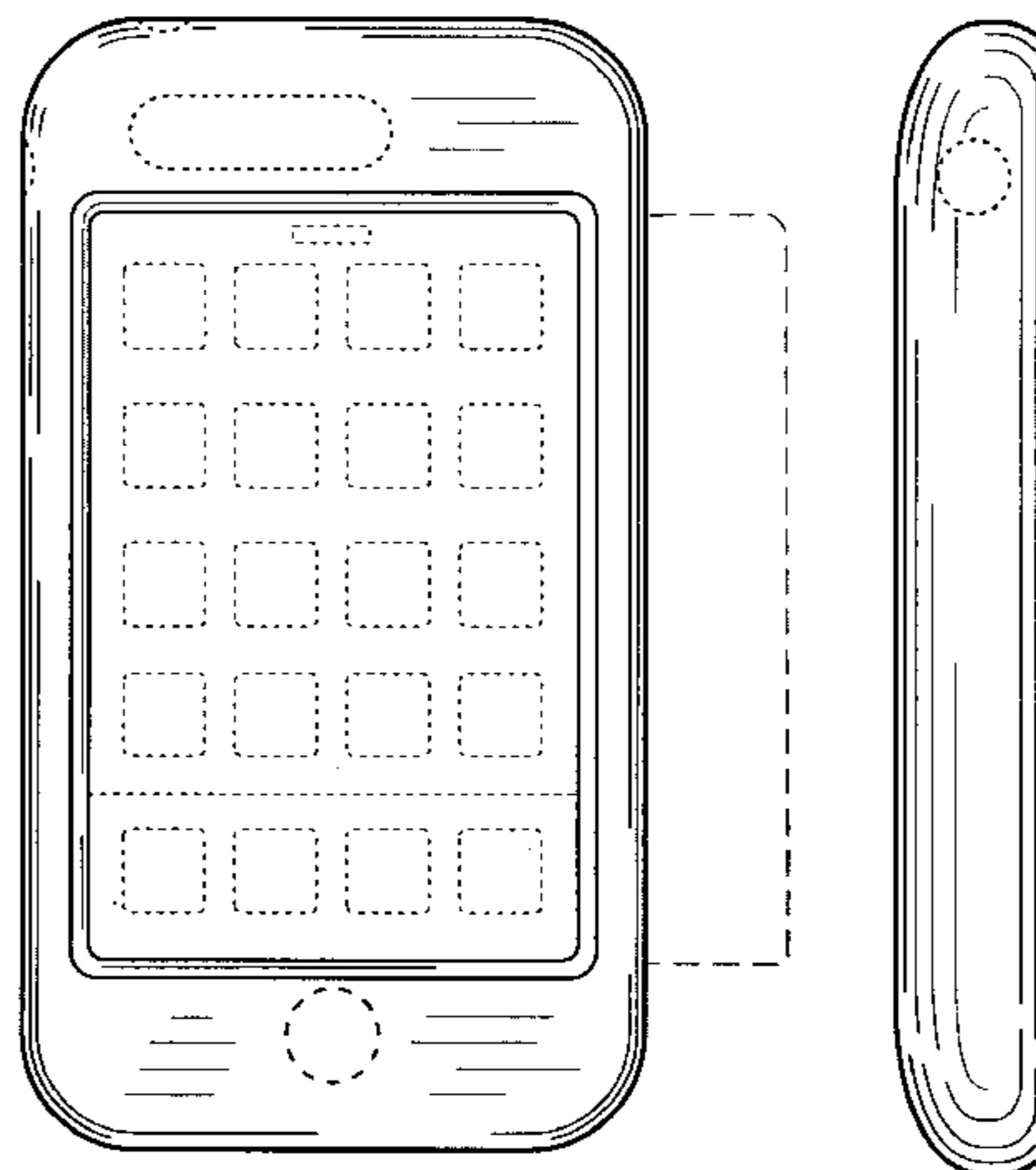

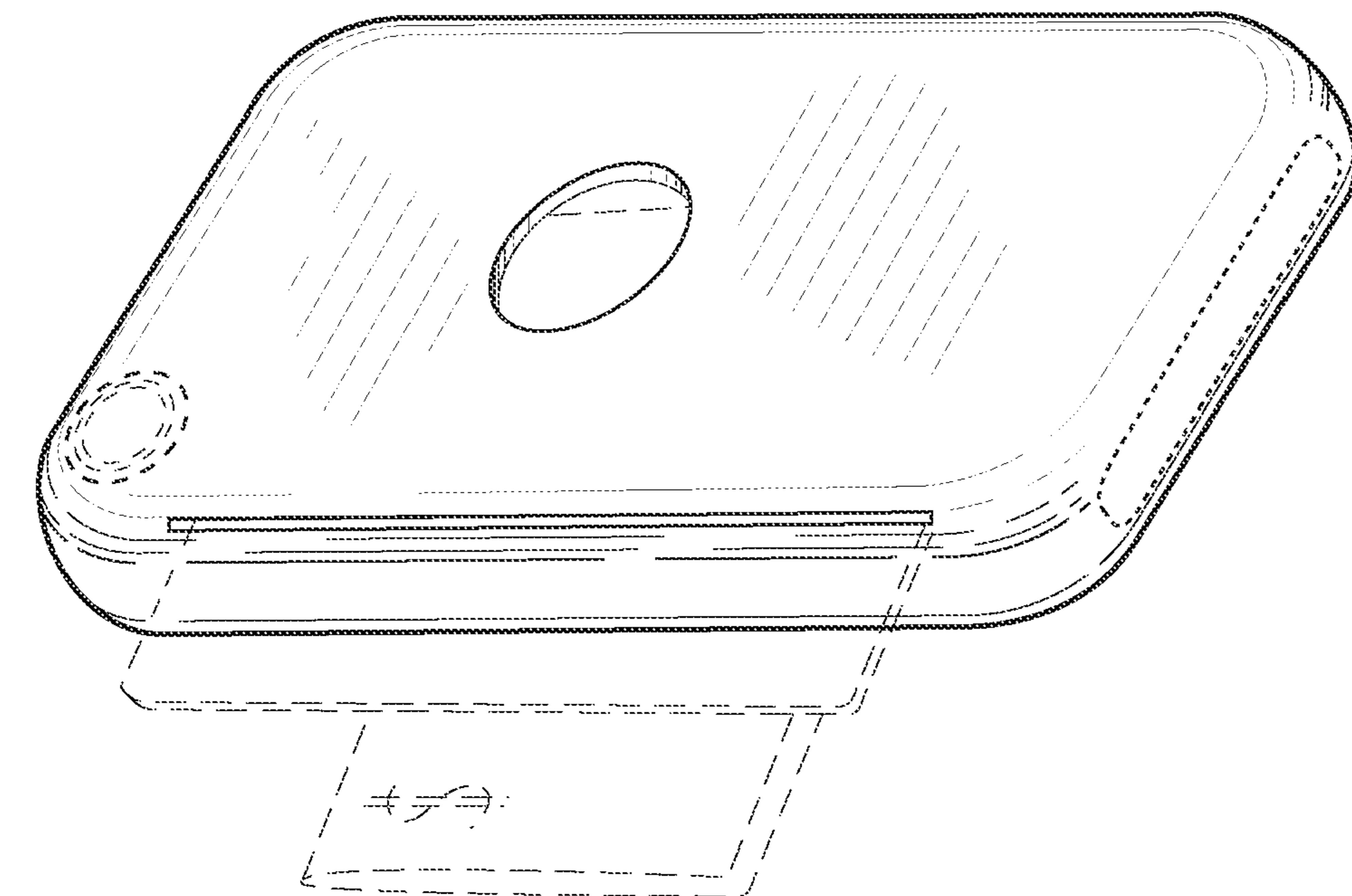

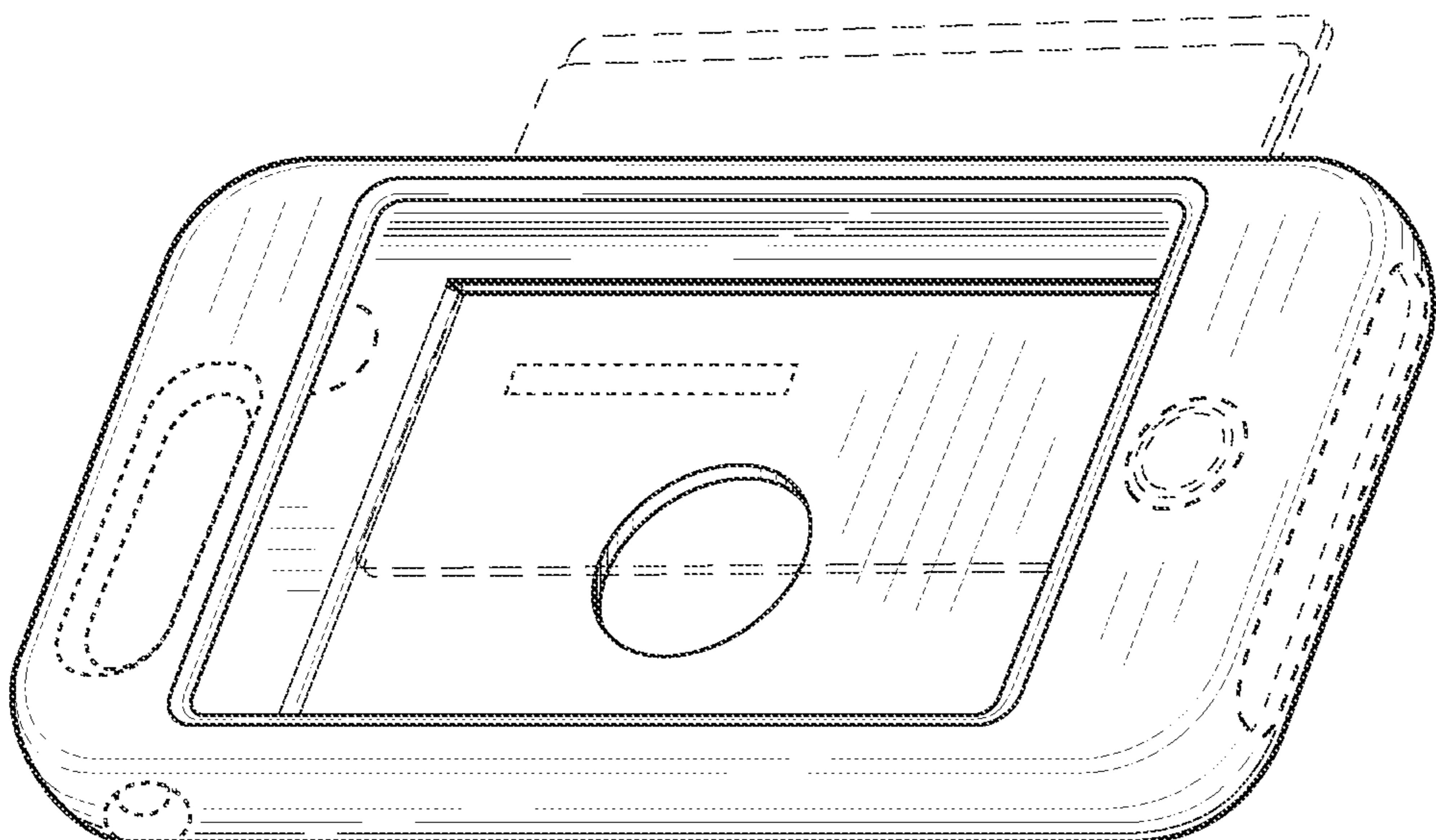

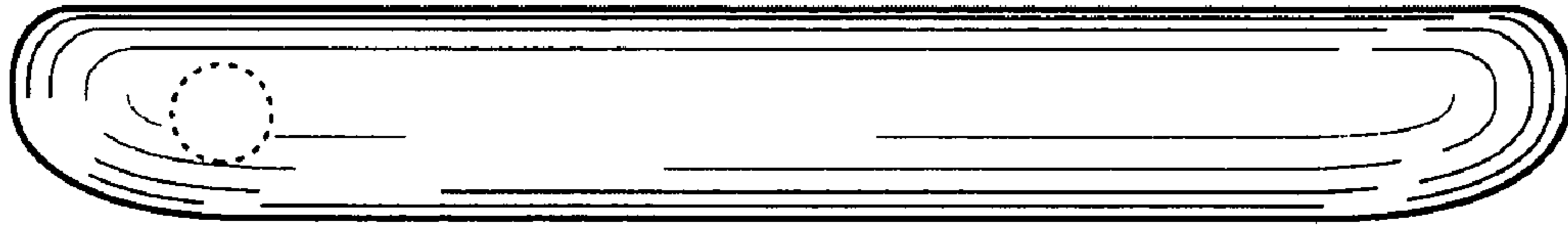

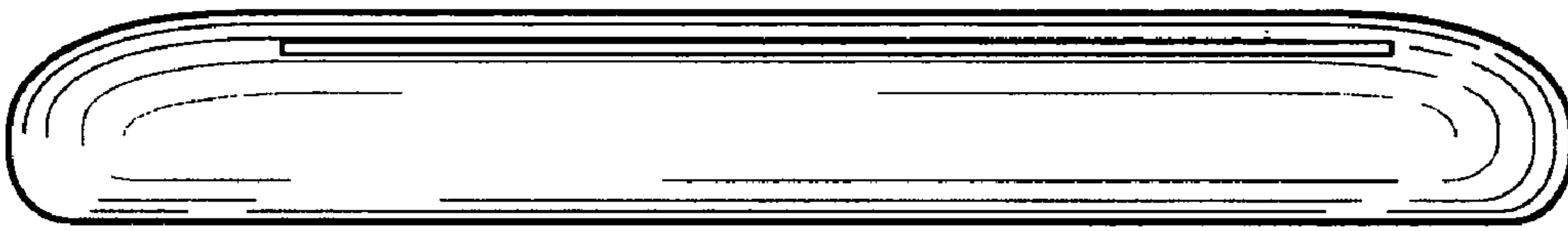

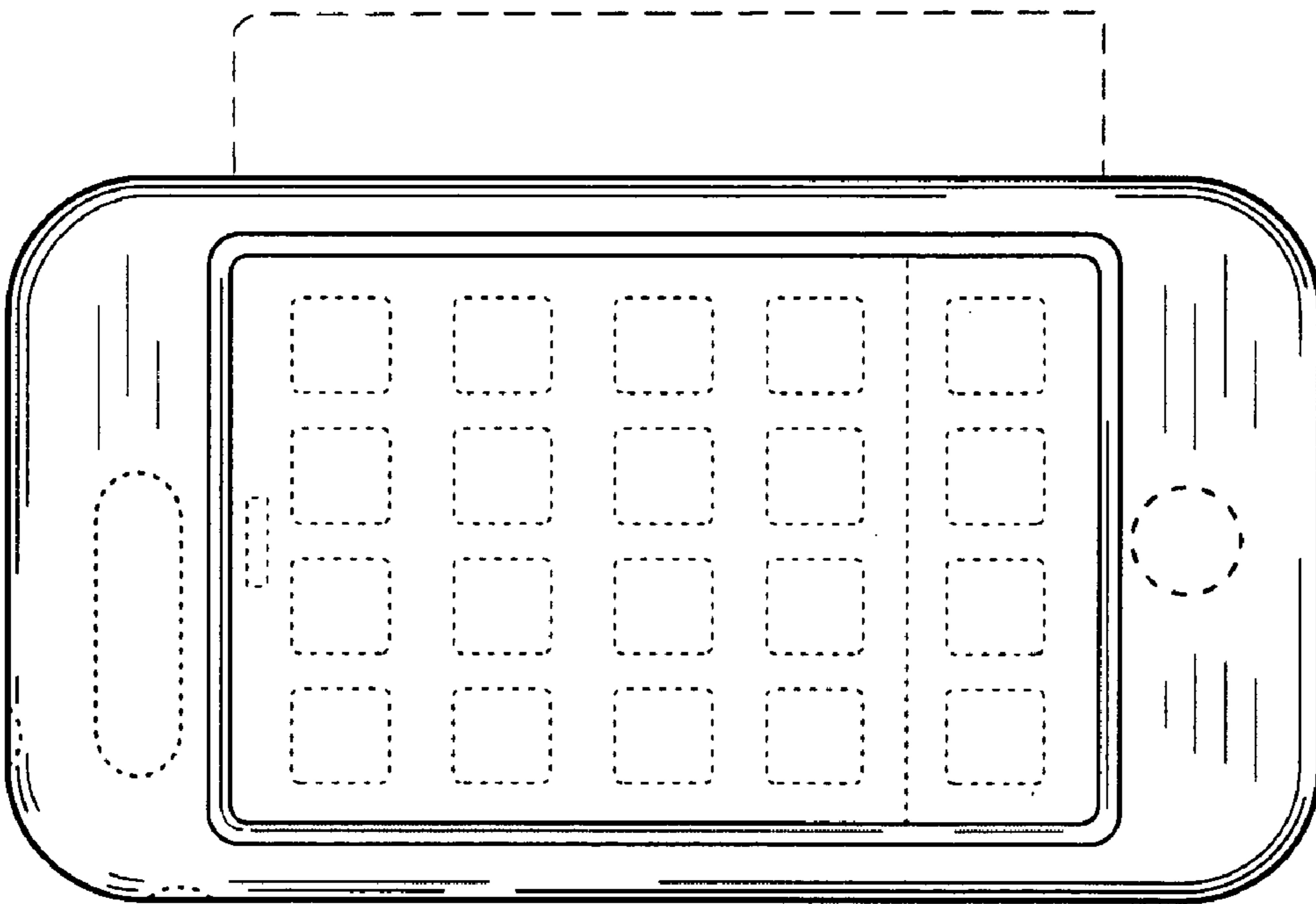

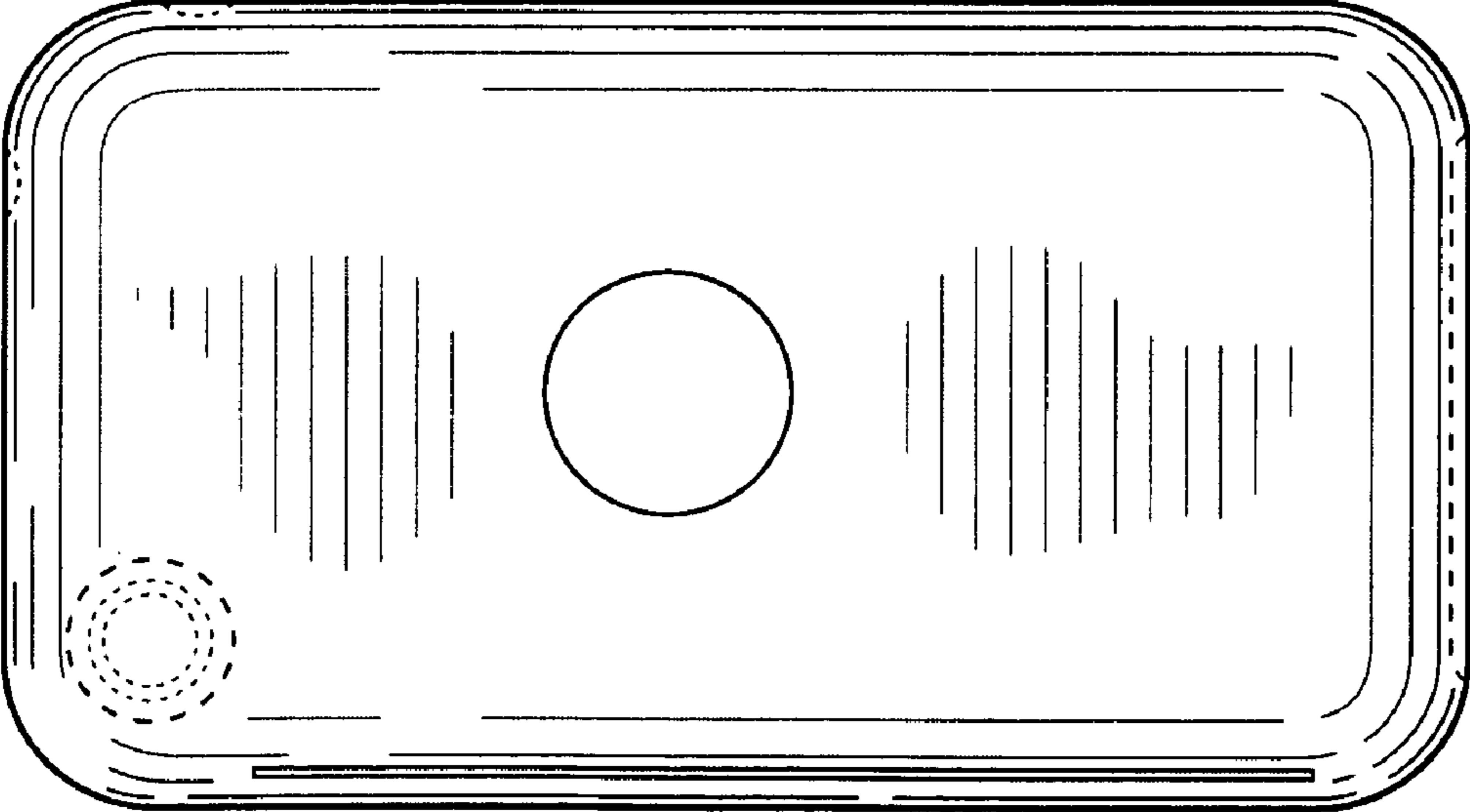

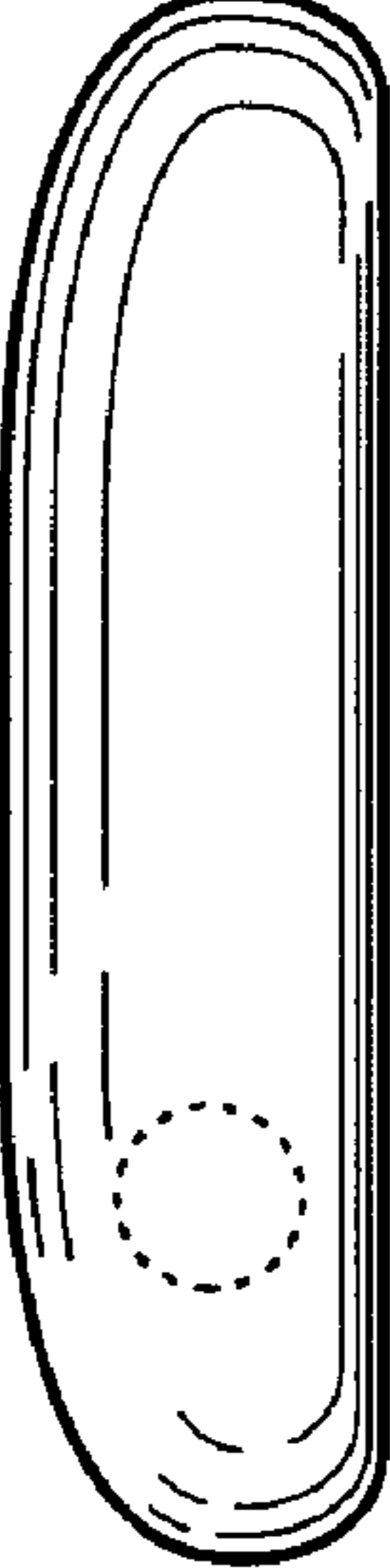

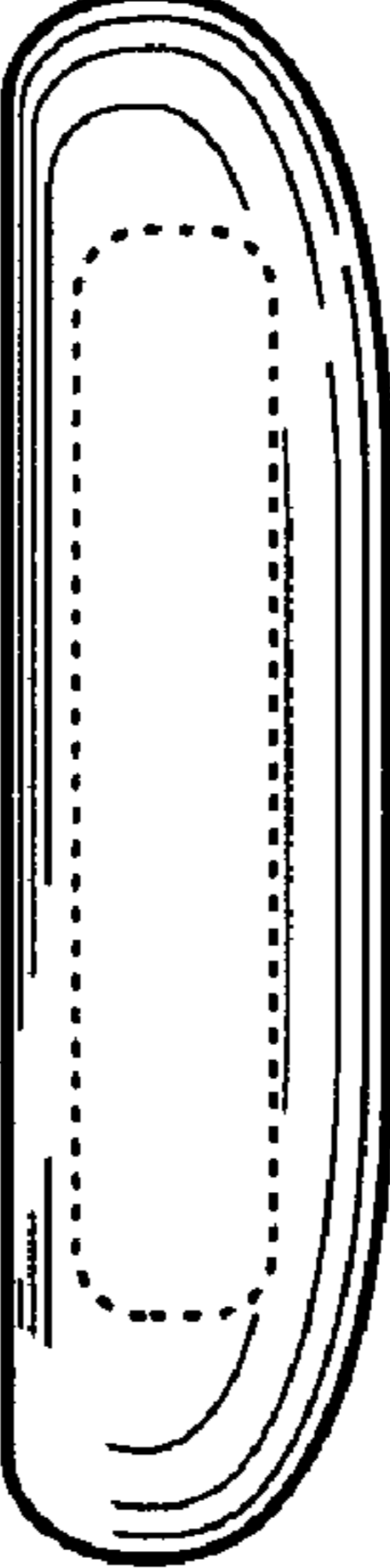
