(57) **CLAIM**

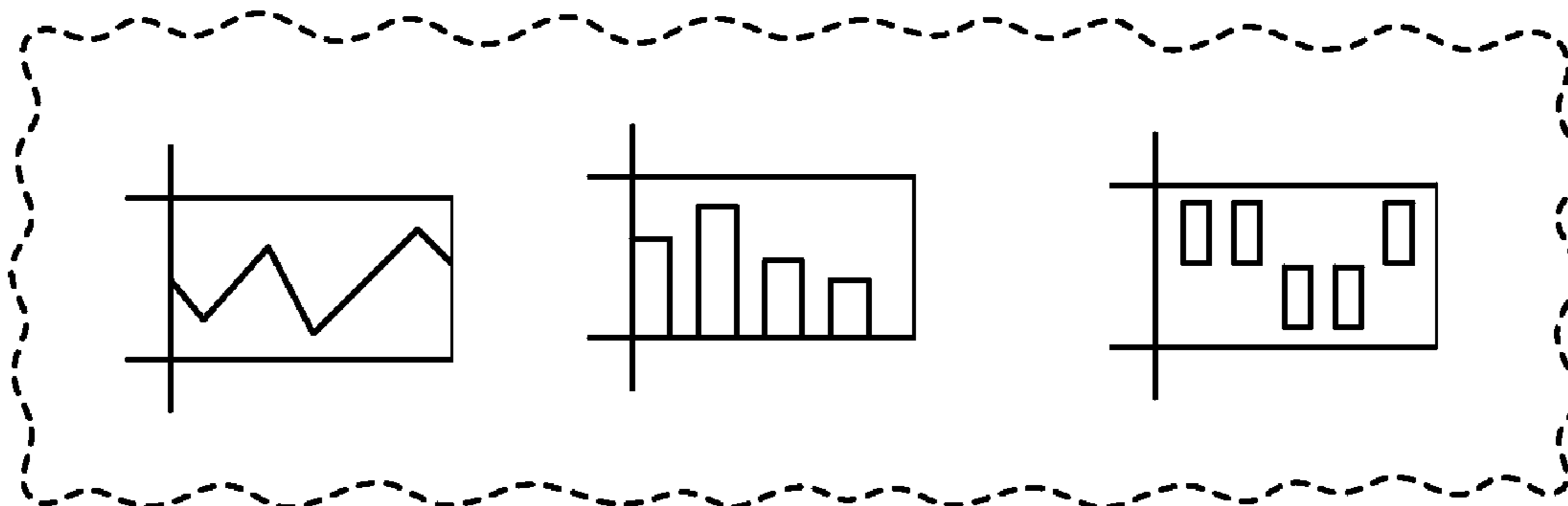
The ornamental design for a group of icons for a display screen, as shown and described.
