trated in FIG. 1;

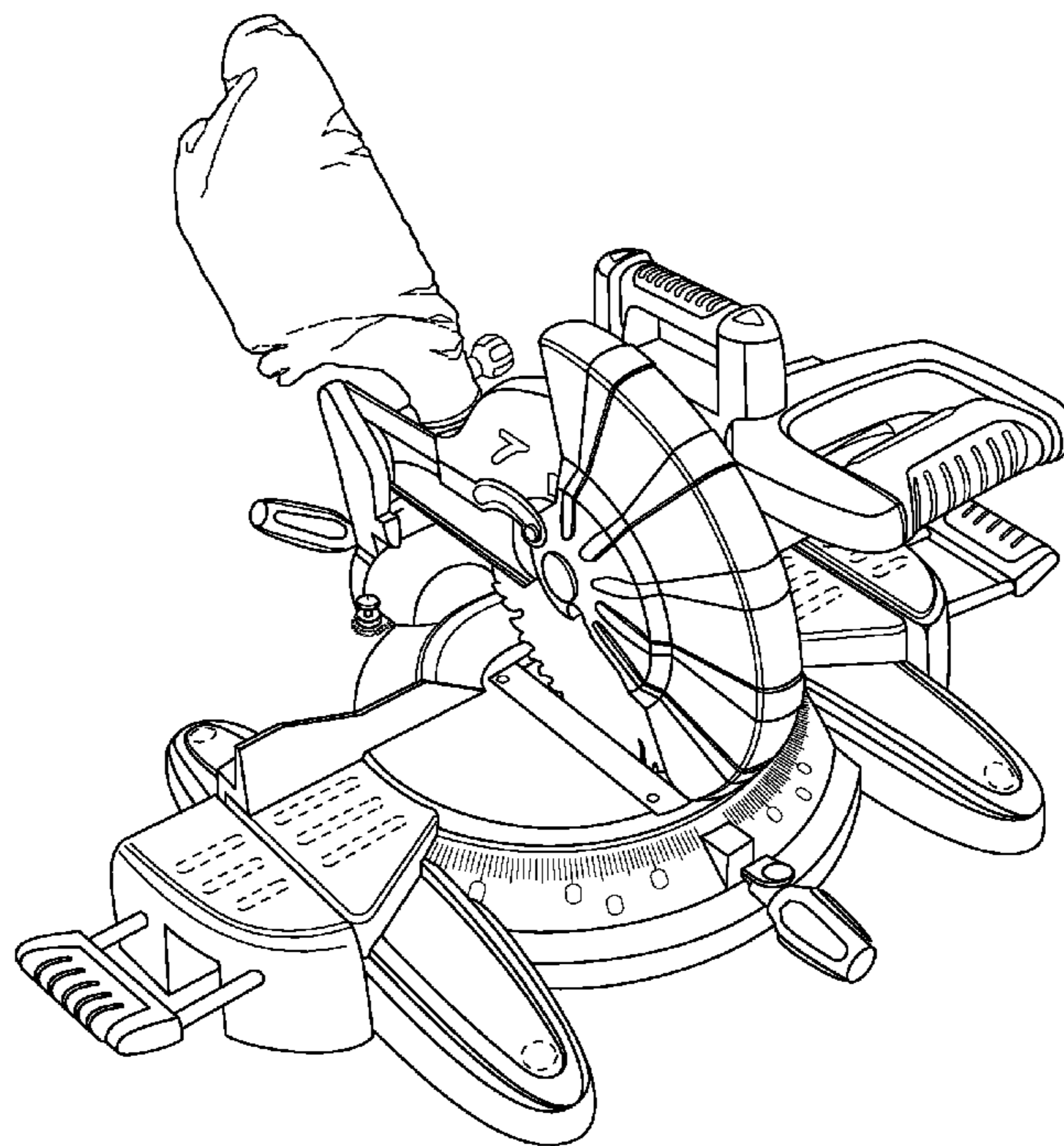
FIG. 5 is a right side view of the compound mitre saw shown

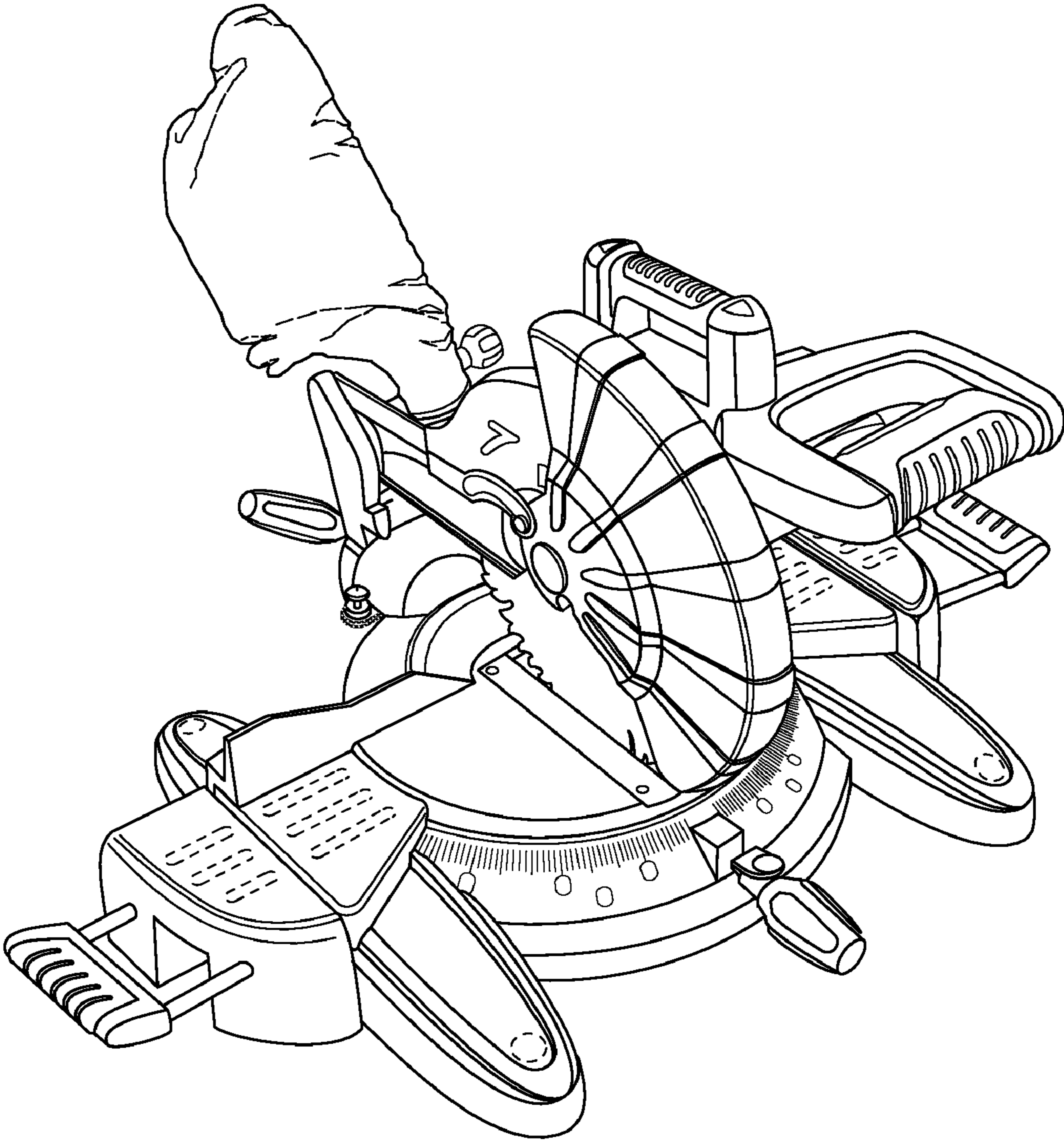

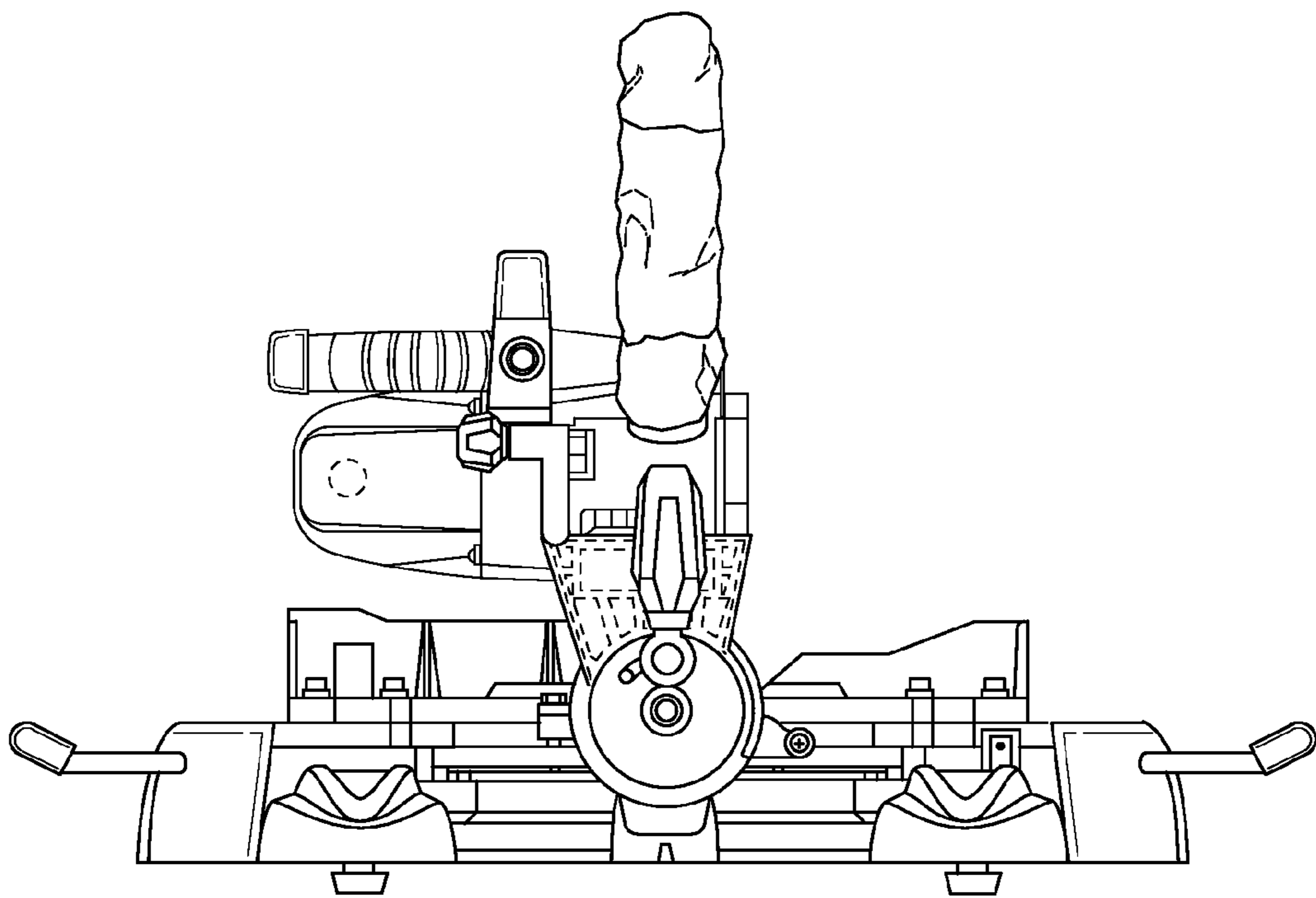

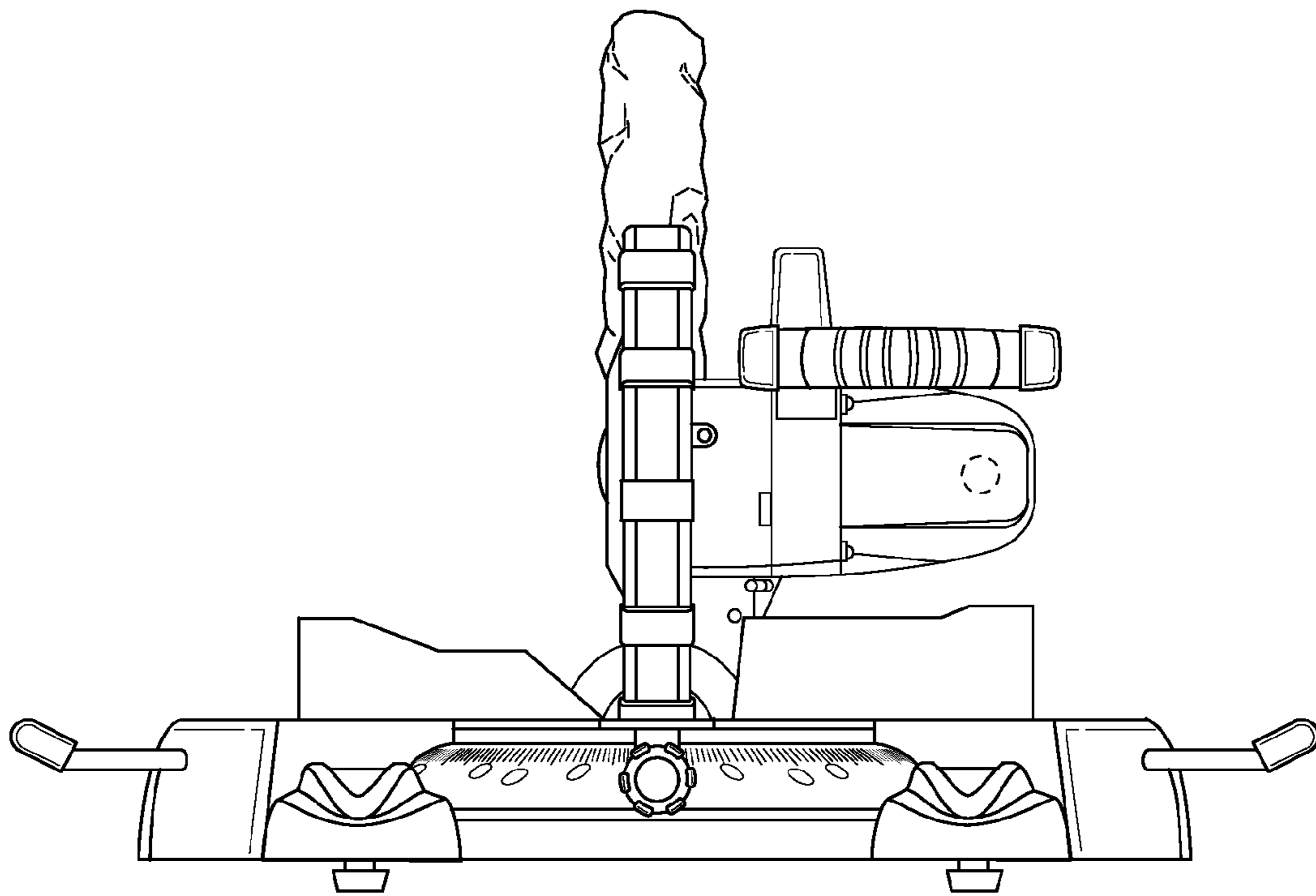

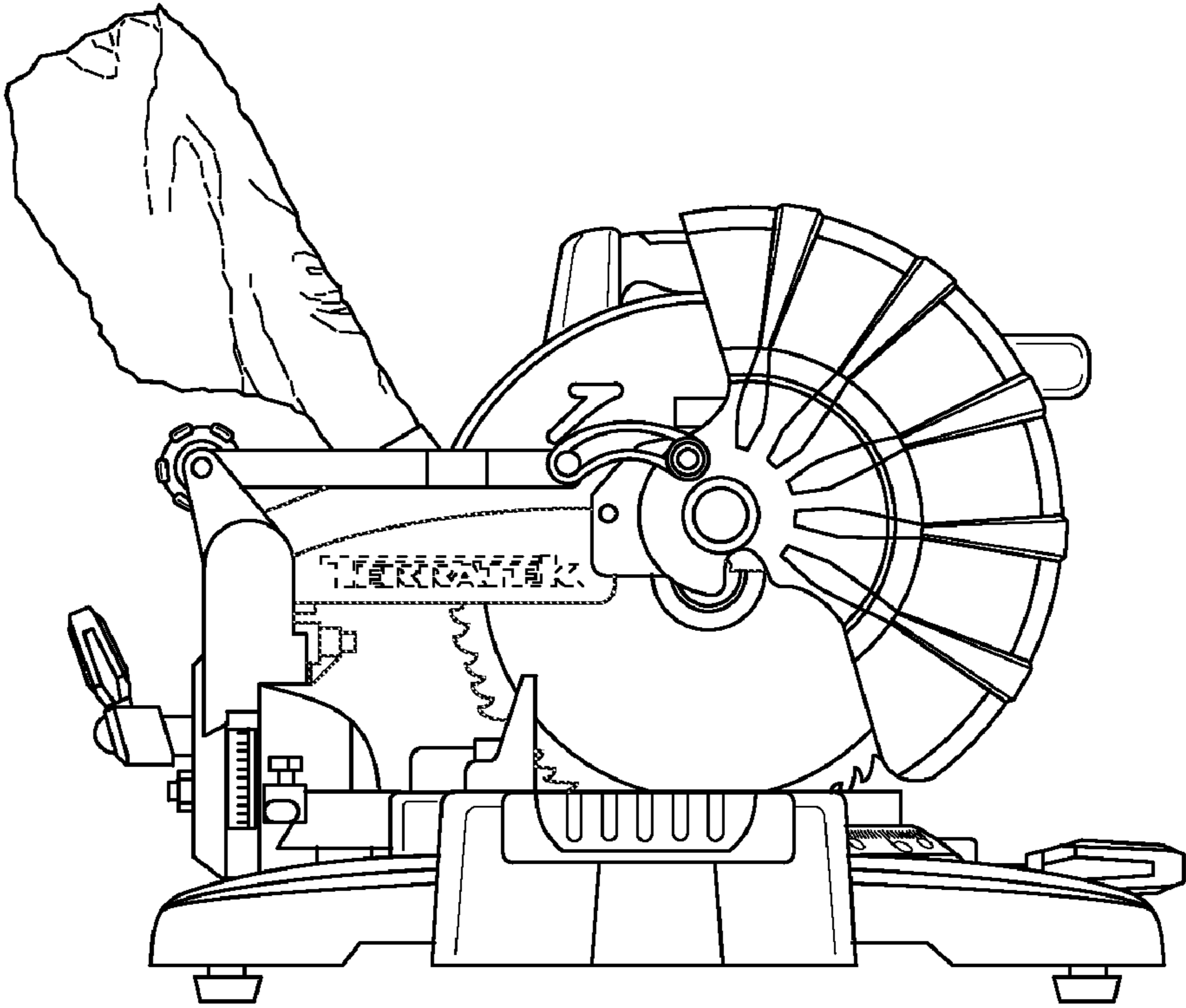

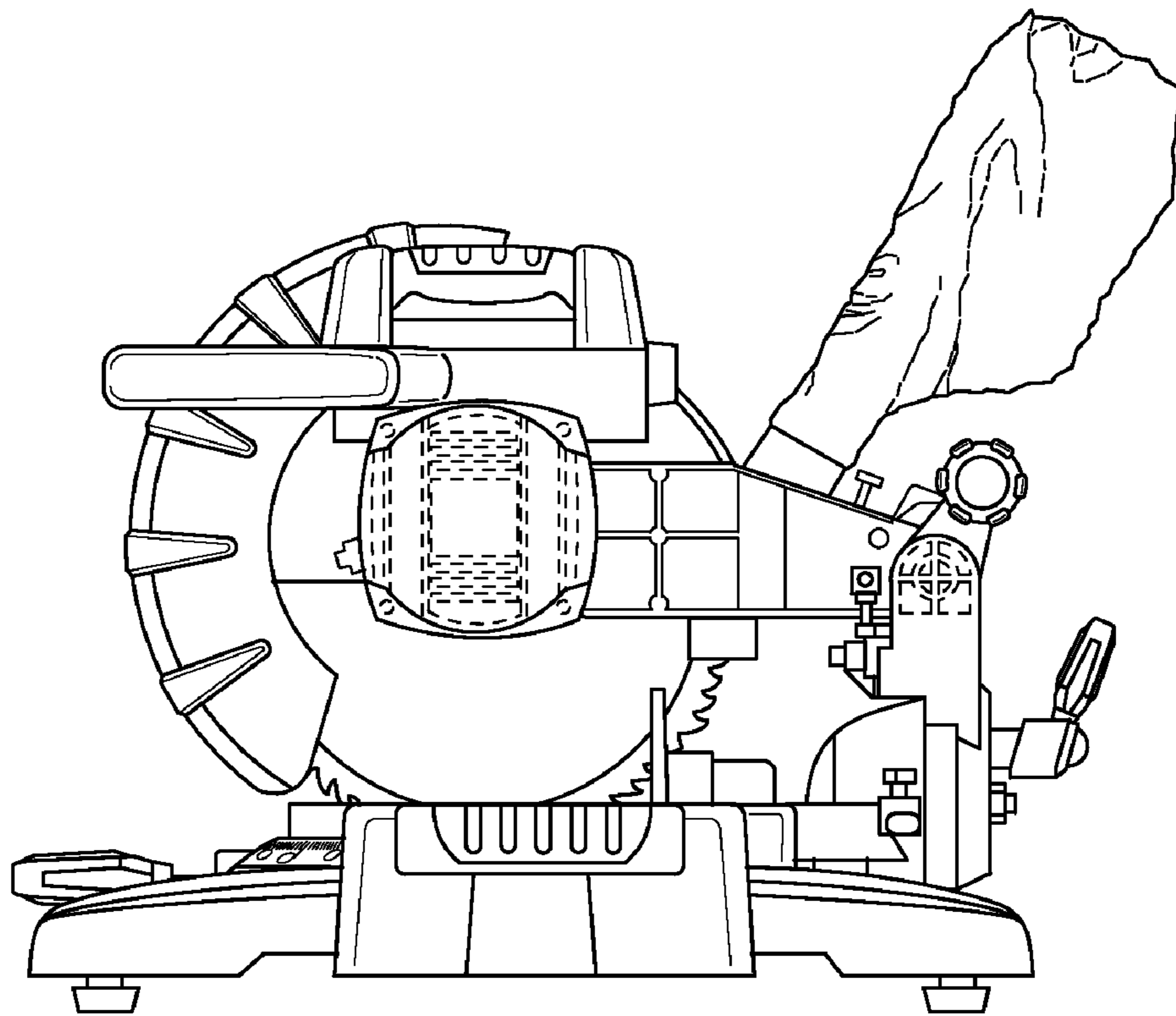

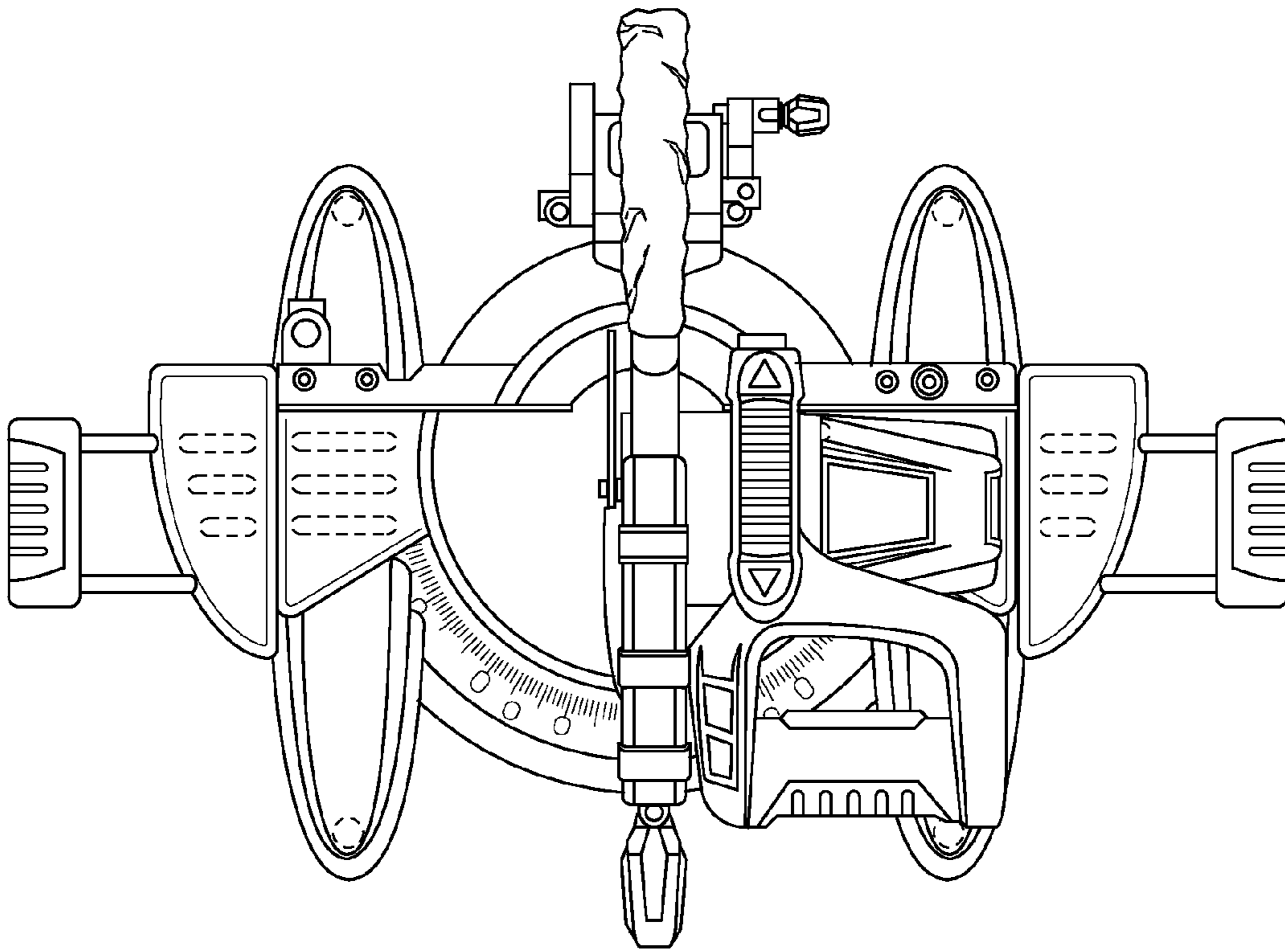

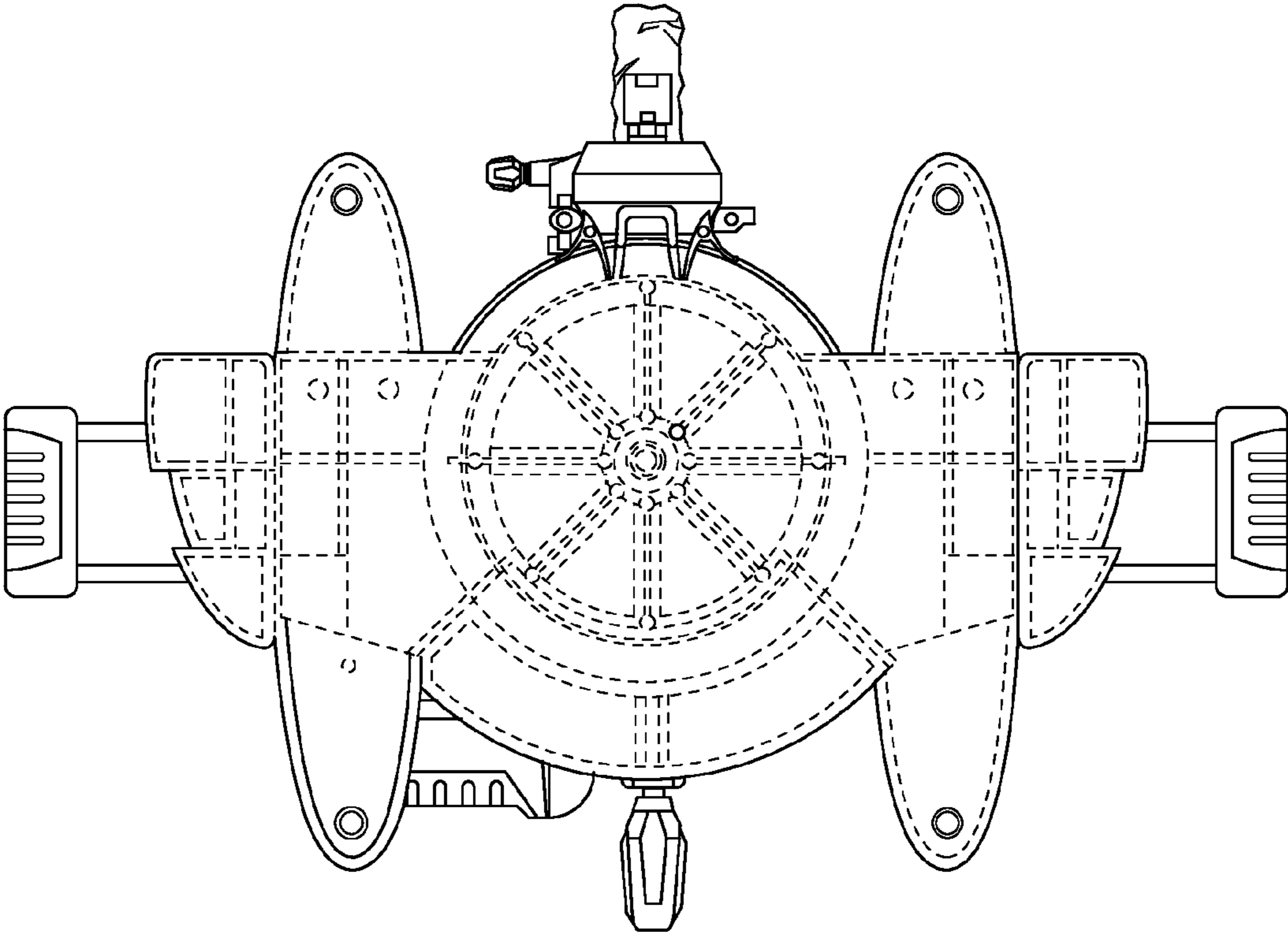
