FIG. 1 is a front, perspective view of a coin manager showing my new design;

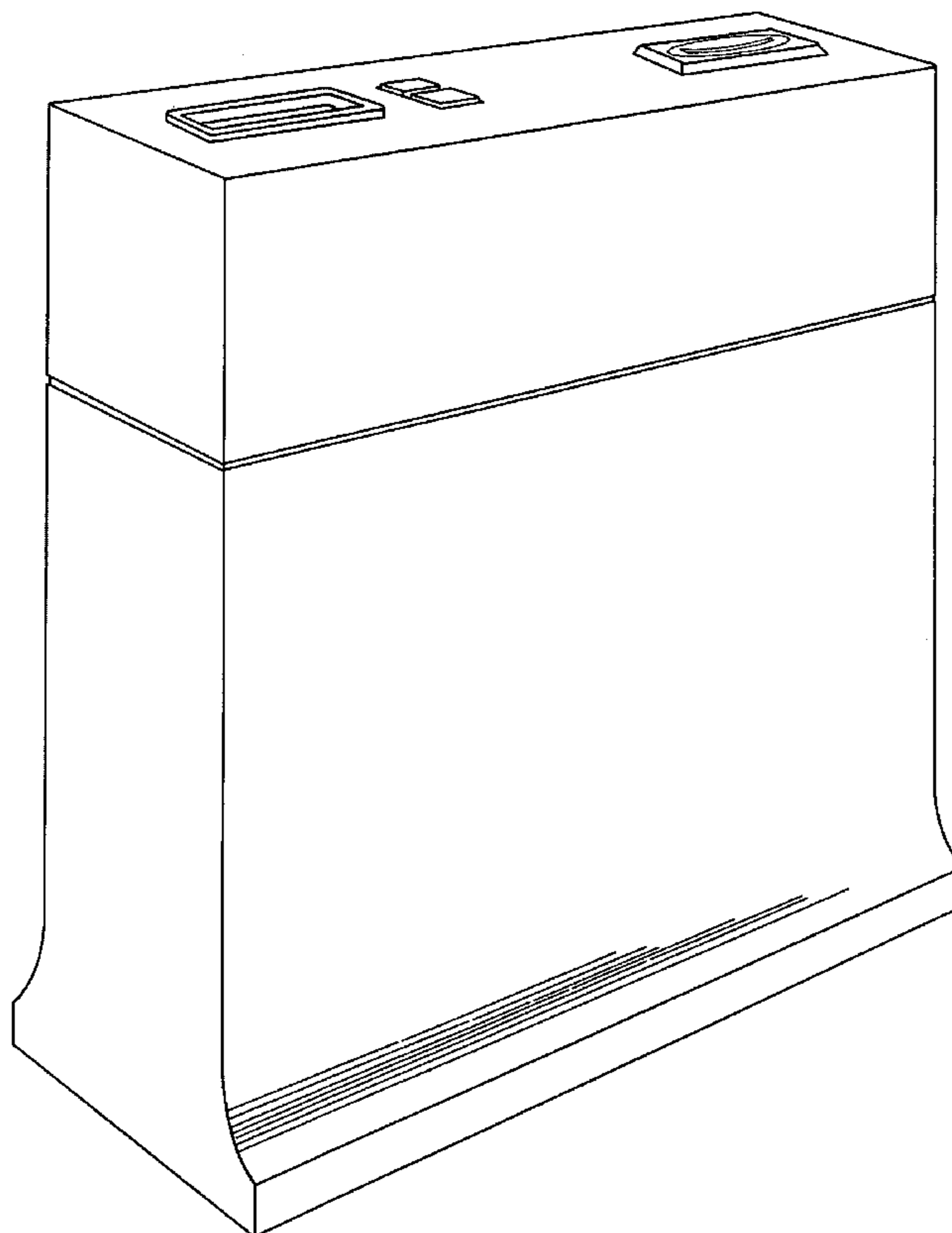
FIG. 2 is a front elevational view thereof, the rear view being the same thereof;

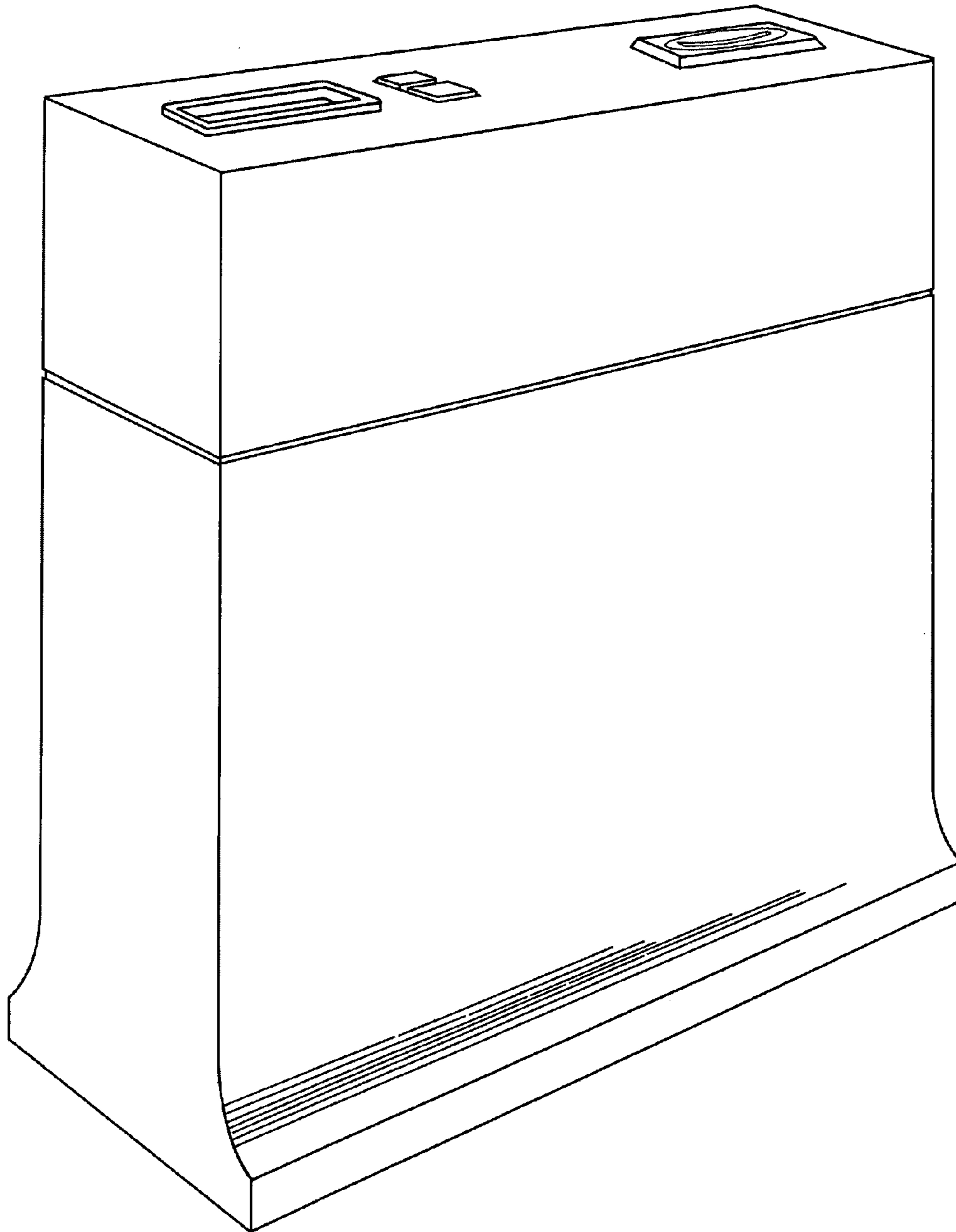

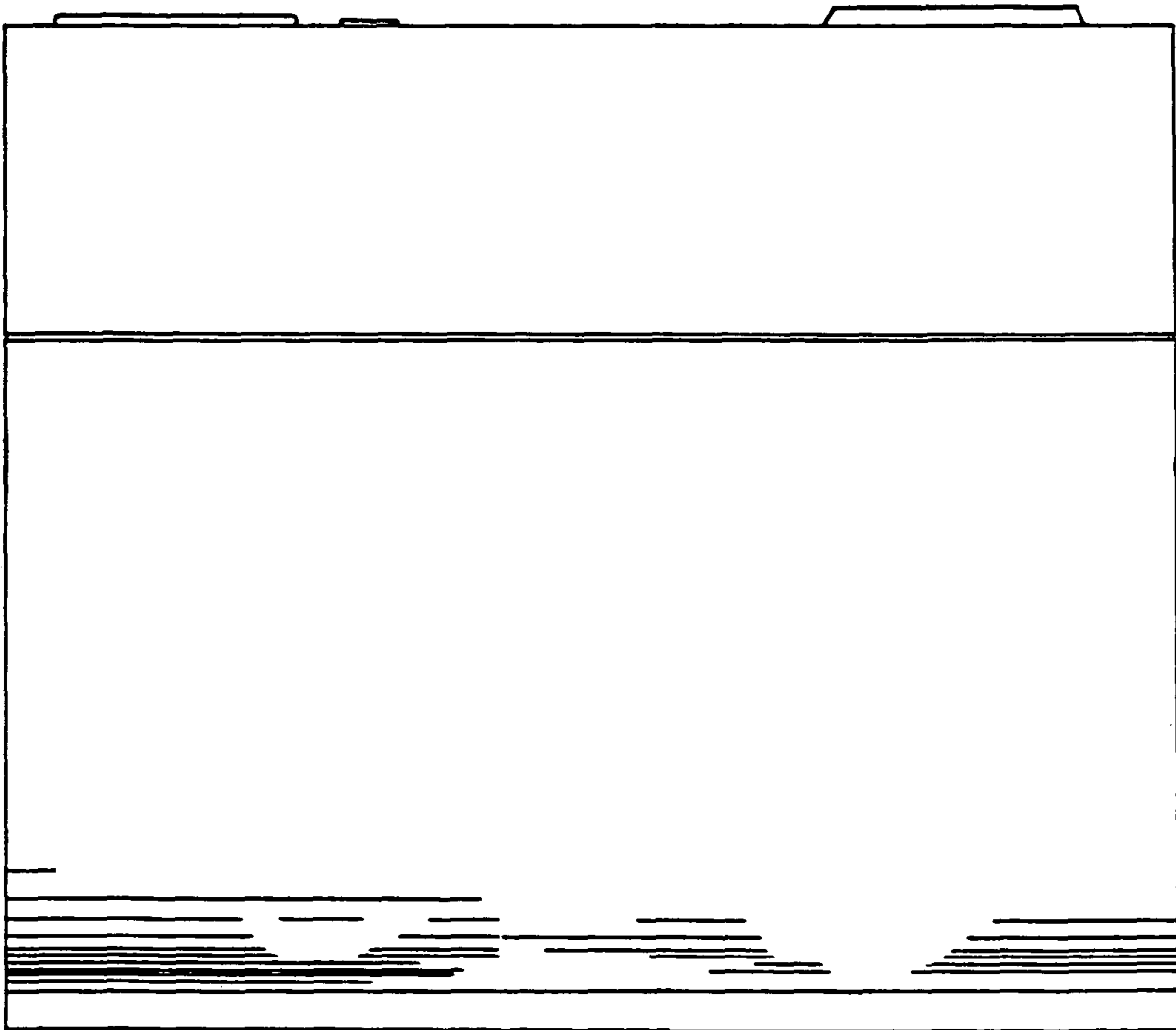

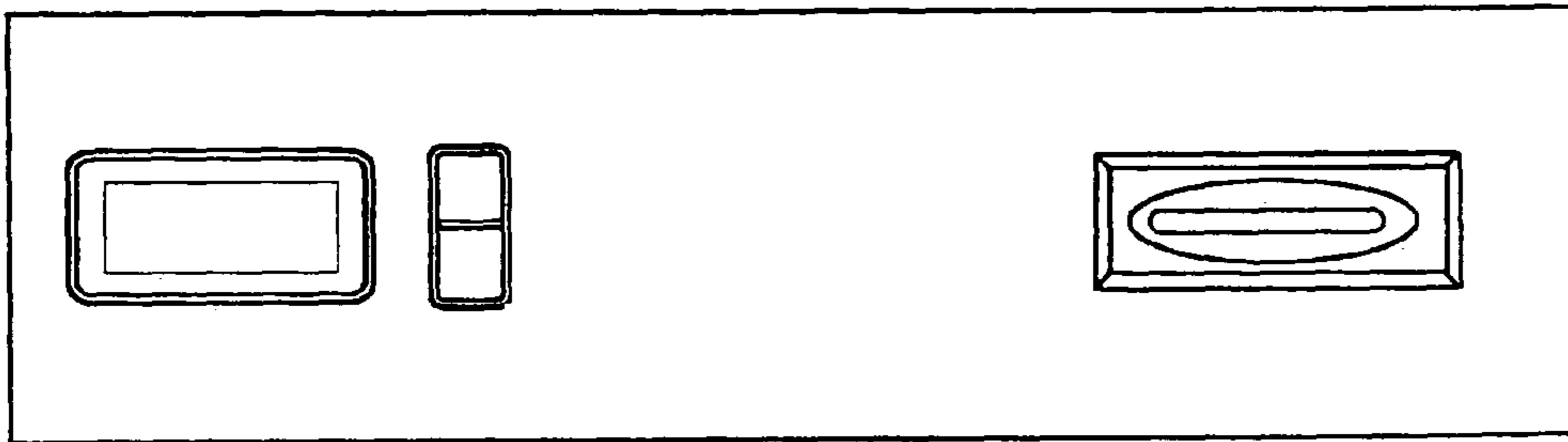

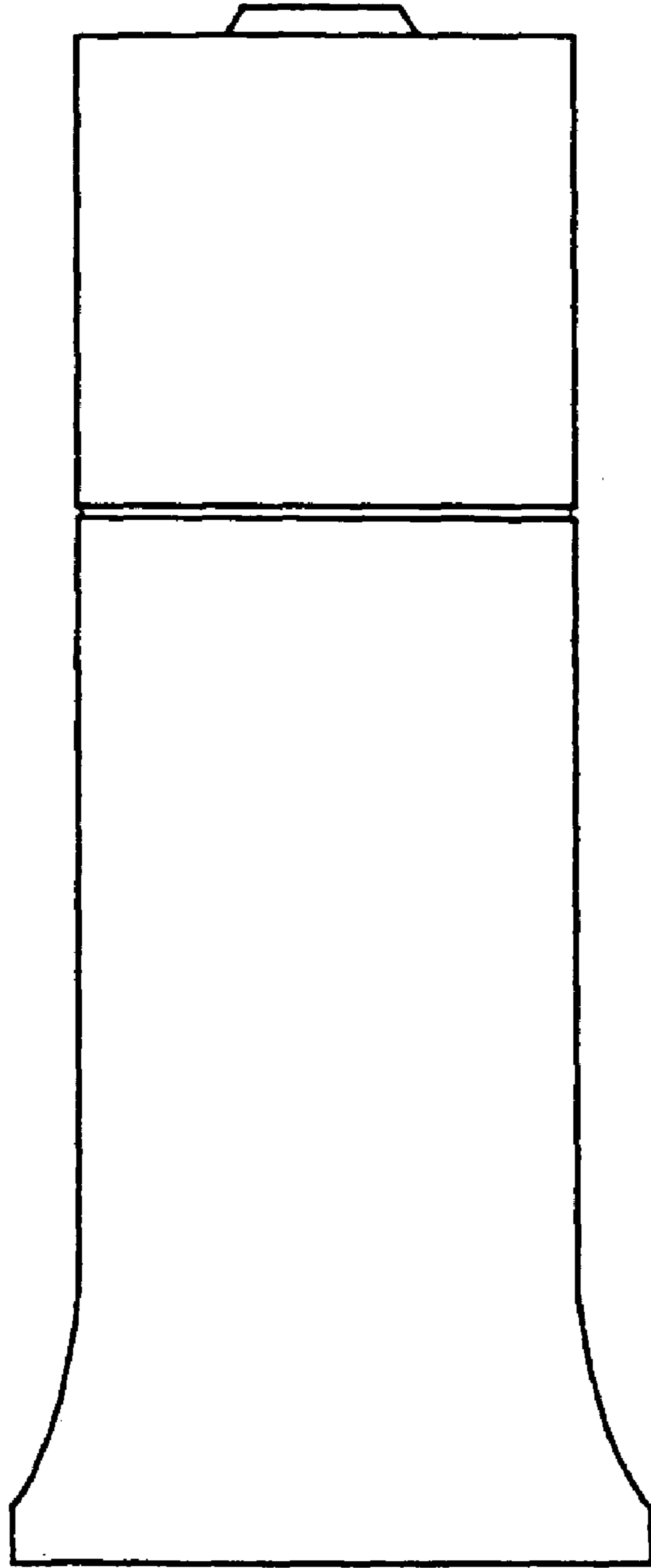

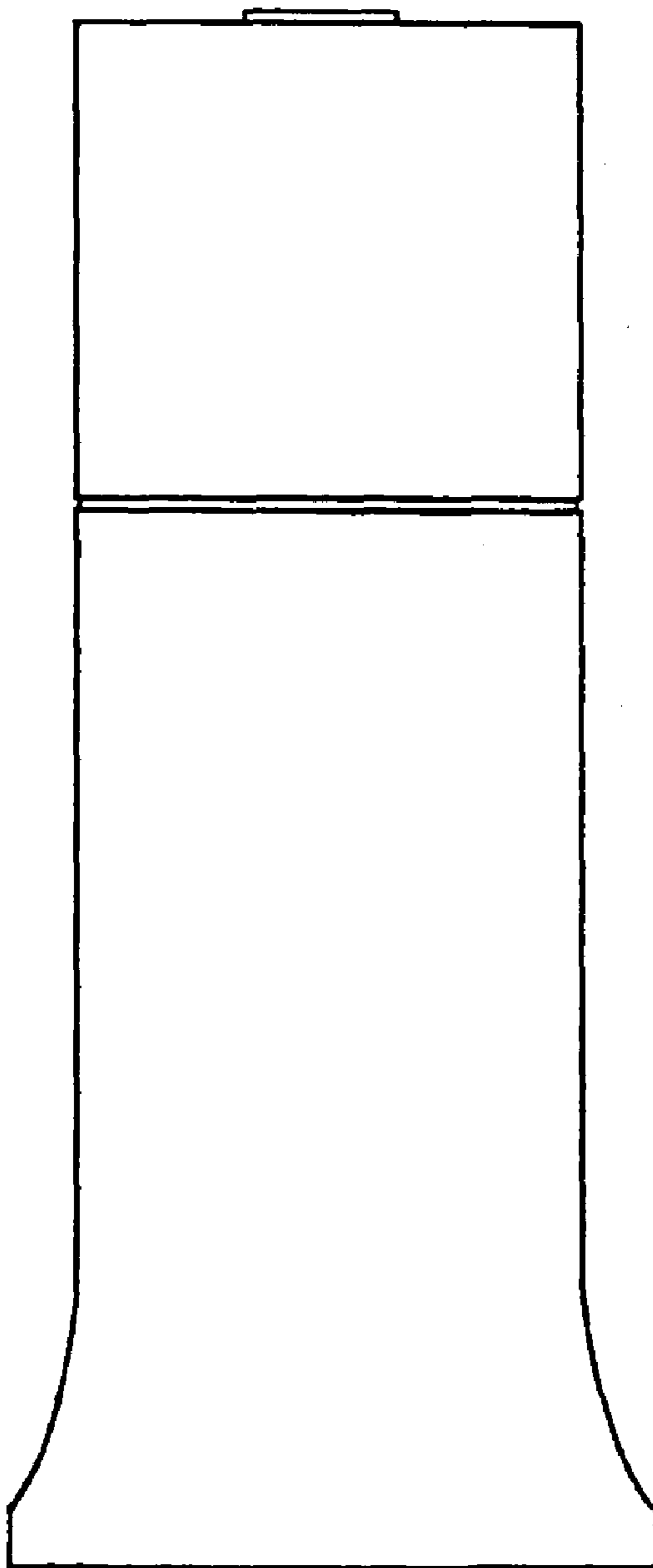
